# DUALITIES IN FRACTIONAL STATISTICS

#### A bstract

We rst reobtain in a simpler way the H aldane fractional statistics at them all equilibrium using an interpolation argument. We then show that the mean occupation number for fractional statistics is invariant to a group of duality transform ations, a nonabelian subgroup of fractional linear group.

# 1 Introduction

In the two-dimensional systems the particles are not constrained to obey the Ferm i or B ose statistics but they m ay have fractional statistics; two well known exemples are onered by the quasi-particles in the fractional quantum Halle ect and by anyons. Prompted by this, Haldane [1] stated a generalized exclusion principle that allows for intermediate statistics, though his derivation of the particle occupation number does not involve the spatial dimensionality and so, it seems to be valid for an arbitrary number of dimensions. W u [2] discussed the therm odynamics of the fractional statistics particles (geons) in the ideal gas approximation. Further developments on the therm odynam ical aspects of geons can be found in [3], [4]. In an akin paper[5] to the present one, it was shown that the distribution function for geons en bys a duality property. Quite recently, a number of authors [6], starting from an appropriate de nition for indistinguishability in the phase space, have obtained a nontrivial classical counterpart of Haldane's exclusion principle.

The purpose of this Letter is rst, to rederive, using a very simple interpolating argument, the occupation number distribution for geons at them al equilibrium. Then, based on this derivation, we show that the relation for the occupation number remains invariant under a certain number of dual transformations that organize in a group and we discuss the meaning of these dualities.

### 2 M odel

A very long time ago, when the black body radiation form ula was still under scrutiny, a simple argument based on interpolation has been put forward in [7]. The argument goes as follows: Let be " the mean energy for a radiation eld, averaged over time in a xed unit volume. Using the equality of time averages and phase spase averages one can write for the mean squares values "<sup>2</sup> of the uctuating energy that

$$\overline{\mathbf{u}^2} = \mathbf{k} \quad \frac{\mathbf{e}^{\overline{\mathbf{u}}}}{\mathbf{e} \quad \frac{1}{\mathrm{T}}} \qquad (1)$$

Empirically, the mean square value gets contributions from low frequencies (the Rayleigh-Jeans part of the spectrum), where the mean energy  $\pi = kT$ ; therefore

$$kT^{2}\frac{\partial \mathbf{T}}{\partial T} = \mathbf{T}^{2}$$

It also gets contributions from high frequencies (the W ien part of the spectrum ), where the mean energy  $\pi = h \exp (\frac{h}{kT})$ ; hence

$$kT^{2}\frac{\partial \mathbf{T}}{\partial T} = h \mathbf{T}$$

W ith the underlying assumption that the two contributions act independently and are of equal weight, relation (1) reads as

$$kT^{2}\frac{\partial \mathbf{T}}{\partial T} = \mathbf{T}h + \mathbf{T}^{2}$$

It is more convenient to use the dimensionless variables  $n = \frac{\pi}{n}, \frac{h}{kT} = that$  lead to the dimensionless variables in the dimensionless variables in the dimension of the dimension is the dimension of the dimension of

$$\frac{\mathrm{dn}}{\mathrm{d}} = \mathrm{n} + \mathrm{n}^2 \tag{5}$$

The solution is

$$n = \frac{1}{\exp(0.0)} \text{ or } = \frac{"}{\exp(0.00)}$$

This is, the P lanck law, here with  $=\frac{1}{kT}$ , merely an integration constant. This derivation emphasizes the wave-particle character of bosons.

How this reasoning can be extended for other statistics? Note that this type of interpolation works equally well for ferm ions. However, for ferm ions, as long as " < , the long wavelength (high tem perature) is negative:

$$\frac{\mathrm{d}^{\mathbf{n}}}{\mathrm{d}\mathrm{T}} = \mathbf{n}^2 \tag{7}$$

and accordingly, relation (5) must be modi ed to

$$\frac{dn}{d} = n \quad n^2 \tag{8}$$

W hen we take into account that n 1, we obtain, as solution, the Fermi distribution:

$$n = \frac{1}{\exp((0^{-1})) + 1}$$
(9)

Introducing a genuine interpolation parameter g, i.e. a parameter ranging in the [0;1] interval, one can write in a single stroke, for both ferm ions and bosons:

$$\frac{dn}{d} = n + (1 \quad 2g) n^2$$
 (10)

with the solution

$$n = \frac{1}{\exp(0.0) (1 - 2g)}$$
(11)

Note that this represents also, as a particular case, for  $g = \frac{1}{2}$ , the M axwell distribution function. The above interpolating form ula has also been obtained in Refs.8.

At thism om ent we may ask what otherm odi cations must be brought to (9) if one would allow for interm ediate statistics between B ose and Ferm i ones on one hand, relation (9) suggests a series expension in powers of mean occupation number n. This is what we might expect because an interpolating statistics presumely contains more parameters and its complete characterization needs higher moments and/or higher powers of the rst moment. On the other hand, higher order terms in (9) must be multiplied, for sure, by the factor g (g 1), that excludes for standard ferm ionic (g = 1) and bosonic (g = 0) statistics any extra term s which, obviously, do not occur in (10). Limiting ourselves to the next higher order term  $n^3$  and using again the independence and equal weights assumption (with the exception of g (g 1) factor), we arrive at

$$\frac{dn}{d} = n + (1 \quad 2g) n^2 + g (g \quad 1) n^3$$
(12)

The di erential equation can be solved by an elementary integration. To this purpose and for later reference we make the change of variable:

$$w = \frac{1 \quad ng}{n} \tag{13}$$

The di erential equation transform s to

$$\frac{\mathrm{d}w}{\mathrm{d}} = \frac{w (w+1)}{w+g} \tag{14}$$

The solution is

$$w^{g}(w+1)^{1} = e^{(0)}$$
 (15)

Form ulas (13) and (15) together gives in plicitely the mean occupation number as function of inverse temperature. The physical meaning of the parameter g can be drawn from the zero temperature limit ( ! 1):

$$n = \frac{0}{\frac{1}{g}} ||_{F}^{*} ||_{F}^{*}$$
(16)

Therefore,  $\frac{1}{g}$  represents the maximum number of particles a quatum state can accommodate. Actually, formulas (13), (15) represent exactly the particle distribution for geons at therm al equilibrium obtained by Haklane [1] from a counting argument and from equilibrium condition requirements while (16) expresses the generalized exclusion principle.

We have unfolded the derivation starting from the mean square value of the energy just to rem ind an historical argument [7]. O focurse we could have started from the mean square value of the mean number directly. It is an well-known fact that the uctuations in the number of bosons is super-poissonian:

$$\overline{n^2} = \overline{n} + \overline{n}^2 \tag{17}$$

while for ferm ions is sub-poissonian:

$$\overline{n^2} = \overline{n} \quad \overline{n}^2 \tag{18}$$

The advantage of the above derivation of fractional statistics over the standard one consists in its sim plicity. The shortcom ing lies in the fact the form ulas for n are valid only at equilibrium.

W hat are the transform ations that leave invariant the occupation number form ulas invariant, i.e. form ulas (13) and (15)? To be more speci c, we look for transform ations for w that, while preserving the substitution (13) intact, m akes relation (15), or, under the same boundary condition, the di erantial equation (14), form -invariant. An earlier derivation for such a transform ation [5] and a theoretical prejudice lead us to consider transform ations of the form :

$$we = \frac{aw + b}{cw + d}$$
(19)

They are known as transform ations belonging to the modular group SL (2,G), or the fractional linear group, where G stands for C, R or Z depending on whether the coe cients a, b, c, d are complex, real or integer, respectively. The group multiplication law may be represented by a 2 2 matrix =  $\begin{pmatrix} a & b \\ c & d \end{pmatrix}$  with unit determ inant ad-cd=1. The theoretical prejudice alluded above refers to the fact the SL (2,Z) has been found relevant for the complex conductivities in the quantum Halle ect §].

We substitute Eq. (19) into the di erential equation (14) and bok for the  $\infty e$  cients a, b, c and d that have the equation in same form. Rather long but straightforward algebra shows that, excepting the identity, there are only ve possible transform ations of type (19) that have the geon distribution form - invariant. These transform ations ( $t_k$ ) are:

The rst transform ation has also been remarked and derived in a di erent way in [5]. The others are new. Note that in some transform ations ( $t_2$  and  $t_5$ ) the coe cients must be imaginary to comply with the requirement of unit determinant ad-cb= 1.

These transform ations deserve the name of dualities because they extend the theory from weak values of the statistical parameter g 2 [0;1] to strong values of the parameter g 2 [1;1] or the other way around. Indeed, starting with a weak g 2 [0;1], transform ations  $t_1$  and  $t_4$  lead to form ulas valid on the whole real axis for g and on the range g 2 [1;1], respectively. Starting with a strong g 2 [1;1], transform ation  $t_3$  leads to form ulas valid on the range g 2 [0;1]. Transform ations  $t_2$  and  $t_5$  m ap the dom ain of validity for g (both g and g m ust be necessarily positive) into them selves. The dual distributions hold true at a tem perature scaled with a function of g, at energies below ( $t_2$  and  $t_5$ , 0) or above Ferm i level ( $t_1$ ,  $t_2$  and  $t_4$ , 0).

A distribution with a greater than unit g supports two interpretations:

(i) as a distribution for particles; a physical realization is the H ubbard m odel [9], where due to the in nite repulsion, two sites can be occupied by at most one electron.(g = 2): and

(ii) as a distribution for vacancies. For instance, the generalized exclusion principle (16) states that  $\frac{1}{g}$  is the maximum number of particles a quantum state can accomm odate; then  $\frac{1}{g}$ , where g is the dual of g under  $t_1$  would represent the minimum number of states available for one particle.

The relationships between a speci c distribution and its dual are given below

$$g n (e;g) + g n (;g) = 1;$$

(g 1) n (e;g) + (g 1) n (;g) = 1; (20.2)

The last relationship is somehow peculiar. Apparently, due to g ! 1 g transform ation, it seems to convert the distribution for ferm ions or near ferm ions  $g \frac{1}{2}$  into the distribution for bosons or near bosons  $g \frac{1}{2}$  and vice-versa, but the dual n (e;g) of n (;g) is, in this case, negative

The above dualities in pose constraints on the expansion coe cients of therm odynam ic functions. For instance, the duality (20a) leads to a vanishing zero tem perature heat capacity (R efs. 5-8). A detailed derivation and analysis of these constraints are relegated to an extended paper. Here we are content to rem ark that all ve transform ations are needed for these transform ations to close upon them selves, i.e. to form a group. We think the group property is the m ost rem arkable feature and we give below the table for the group composition law:

where  $t_0$  denotes the identity. The left multiplication corresponds to entries along column, the right multiplication to entries along rows. It is worthy to note that transform ations  $t_j$ , j = 3;4 are inverse of each other, a fact that can also be seen from rels. (20.3), (20.4)

## 3 Conclusions

To sum up, we have proved that the fractional statistics distribution is invariant to a nite, nonabelian subgroup of the fractional linear group.

We have discussed the duality in term s of transform ations that, while leaving the theory invariant, relate two dierent \coupling constant" g regimes. There exists, also, another meaning of duality in this letter, as illustrated, for instance, in relation (4), namely, the wave-particle duality. The rst term in the RHS of rel. (4) features the particle-like character of bosons and the second, the wave-like character. The fact the two terms simply add togather expresses the complementarity of the two features. In standard quantum mechanics, this duality is embodied in the usual momentum position commutator. We may wonder if the newly introduced term  $g(g \ 1)n^3$  for fractional statistics, in relation (12) signals the existence, in an analogous way, of another level of duality.

In view of the above remarks it is tempting to put forward the following conjecture: there must exist another type of duality, in the sense above, but between vortices and particles (as in som em odels for anyons [11]). The conjecture is rather speculative at the moment. We hope to return with a more rigorous statem ent in the next future.
