Theory of Collective Dynam ics in Multi-Agent Complex System s

A bstract. We discuss a crow d-based theory for describing the collective behavior in C om plex Systems comprising multi-agent populations competing for a limited resource. These systems { whose binary versions we refer to as B-A-R (B inary A gent R esource) systems { have a dynamical evolution which is determined by the aggregate action of the heterogeneous, adaptive agent population. A counting for the strong correlations between agents' strategies, yields an accurate analytic description of the system's dynam ics.

1 Introduction

C om plex System s { together with their dynam ical behavior known as C om plexity { are thought to pervade m uch of the natural, inform ational, sociological, and econom ic world [1,2]. C om plex System s are probably best de ned in term s of a list of com m on features which distinguish them from 'sim ple' system s, and from system s which are just 'com plicated' as opposed to being com plex. A list of C om plex System 'stylized facts' should include: feedback and adaptation at the m acroscopic and/or m icroscopic level, m any (but not too m any) interacting parts, non-stationarity, evolution, coupling with the environm ent, and observed dynam ics which depend upon the particular realization of the system .

C astihas argued that [1] `....a decent mathem atical form alism to describe and analyze the [so-called] El Farol Problem would go a long way toward the creation of a viable theory of com plex, adaptive system s'. The rationale behind this statement is that the El Farol Problem, which was originally proposed by Brian Arthur [3] to dem onstrate the essence of C om plexity in nancialm arkets involving m any interacting agents, incorporates the key features of a C om plex System in an everyday setting. Very brie y, the El Farol Problem concerns the collective decision-making of a group of potential bargoers (i.e. agents) who repeatedly try to predict whether they should attend a potentially overcrowded bar on a given night each week. They have no inform ation about the others' predictions. Indeed the only inform ation available to each agent is global, com prising a string of outcom es (bvercrowded' or 'undercrowded') for a lim ited num ber of previous occasions. Hence they

end up having to predict the predictions of others. No typical agent exists, since all such typical agents would then make the same decision, hence rendering their common prediction scheme useless. W ith the exception of Ref. [4], the physics literature has focused on a simplied binary form of the El FarolP roblem called the M inority G ame (MG) as introduced by Challet and Zhang [5,6].

In this paper, we present a theoretical fram ework for describing a class of C om plex System s comprising competitive multi-agent populations, which we refer to as B-A-R (B inary Agent Resource) system s. The resulting C row d-Anticrow d theory is not limited to M G-like gam es, even though we focus on M G-like gam es in order to demonstrate the accuracy of the approach. The theory is built around the correlations or 'crow ding' in strategy-space. Since the theory only makes fairly modest assumptions about a speci c gam e's dynam ical behavior, it can describe the dynam ics in a wide variety of system s comprising competitive populations [7].





Fig.1. Schematic representation of B-A-R (Binary Agent Resource) system. At timestep t, each agent decides between action 1 and action +1 based on the predictions of the S strategies that he possesses. A total of n $_1$ [t] agents choose

1, and n_{+1} [t] choose + 1. Agents may be subject to some underlying network structure which may be static or evolving, and ordered or disordered (see Refs. [7,8]). The agents' actions are aggregated, and a global outcom e 0 or 1 is assigned. Strategies are rewarded/penalized one virtual point according to whether their predicted action would have been a winning/losing action.

2 B-A-R (Binary Agent Resource) System s

Figure 1 sum marizes the generic form of the B-A-R (Binary Agent Resource) system under consideration. At timestep t, each agent (e.g. a bar custom er, a commuter, or a market agent) decides whether to enter a gam e where the choices are action +1 (e.g. attend the bar, take route A, or buy) and action

1 (e.g. go hom e, take route B, or sell). The global information available to the agents is a common memory of the most recent m outcomes, which are represented as either 0 (e.g. bar attendance below seating capacity L) or 1 (e.g. bar attendance above seating capacity L). Hence this outcome history is represented by a binary bit-string of length m. For general m, there will be $P = 2^m$ possible history bit-strings. These history bit-strings can alternatively be represented in decimal form : = f0;1;:::;P 1g. For m = 2, for example, = 0 corresponds to 00, = 1 corresponds to 01 etc. A strategy consists of a predicted action, 1 or + 1, for each possible history bit-string. Hence there are $2^{P=2^m}$ possible strategies.



F ig.2. Strategy Space for m = 2, together with some example strategies (left). The strategy space shown is known as the Full Strategy Space (FSS) and contains all possible permutations of the actions 1 and +1 for each history. There are 2^{2^m} strategies in the FSS. The 2^m dimensional hypercube (right) show sall 2^{2^m} strategies in the FSS at its vertices. The shaded strategies form a Reduced Strategy Space RSS. There are $22^m = 2P$ strategies in the RSS. The grey shaded line connects two strategies with a Hamm ing distance separation of 4.

Figure 2 shows the m = 2 strategy space from Figure 1.A strategy is a set of instructions to describe what action an agent should take, given any particular history . The strategy space is the set of strategies from which agents are allocated their strategies. The strategy space shown is known as the Full Strategy Space (FSS) and contains all possible permutations of the actions 1 and +1 for each history. As such there are 2^{2^m} strategies in this space. 0 ne can choose a subset of 2^{2^m} strategies, called a R educed Strategy Space

(RSS), such that any pairw ithin this subset has one of the follow ing two characteristics: (i) Anti-correlated. For example, any two agents using the (m = 2)strategies (1; 1;+1;+1) and (+1;+1; 1; 1) respectively, would take the opposite action irrespective of the sequence of previous outcomes and hence the history. Their net e ect on the excess dem and D[t] = n_{+1} [t] n_{-1} [t] (which is an important quantity in a socio-economic setting such as a nancial market) therefore cancels out at each timestep, regardless of the history. Hence they will not contribute to uctuations in D[t]. (ii) Uncorrelated. For example, any two agents using the strategies (1; 1; 1; 1) and (1; 1;+1;+1) respectively, would take the opposite action for two of the four histories, and the same action for the remaining two histories. If the histories occur equally often, the actions of the two agents will be uncorrelated on average. Note that the strategies in the RSS can be labeled by $R = f1;2; :::; 2P = 2.2^m$ g.

The strategy allocation among agents can be described in terms of a tensor describing the distribution of strategies among the N individual agents. This strategy allocation is typically xed from the beginning of the game, hence acting as a quenched disorder in the system. The rank of the tensor is given by the number of strategies S that each agent holds. We note that a single Imacrostate' corresponds to many possible Imacrostates' describing the specific partitions of strategies among the agents. Hence the present C row d-Anticrow d theory retained at the level of a given , describes the set of all games which belong to that same Imacrostate. We also note that although I is not symmetric, it can be made so since the agents do not distinguish between the order in which the two strategies are picked. G iven this, we will henceforth focus on S = 2 and consider the symmetrized version of the strategy allocation matrix given by $=\frac{1}{2}(+1)$.

3 Crowd-Anticrowd Form alism

Consider an arbitrary timestep t during a num of the game. We will focus on evaluating the excess dem and' D [t] D [5 [t]; [t]] = n_{+1} [t] n 1 [t], although any other function of n_{+1} [t] and n 1 [t] can be evaluated in a similar way. Here <u>S</u>[t] is the 2P -dimensional score-vector whose R'th component is the virtual point score for strategy R. [Strategies gain/bæ one virtual point at each timestep, according to whether their predicted action would have been a winning/bsing action]. The current history is [t]. The standard deviation of D [t] for this given nun, corresponds to a time-average for a given realization of and a given set of initial conditions. Sum ming over the RSS, we have: D [S [t]; [t]] = $\sum_{R=1}^{2P} a_R^{[t]} n_R^{S[t]}$. The quantity $a_R^{[t]} = 1$ is the action predicted by strategy R in response to the history bit-string at time t. The quantity $n_{p}^{S[t]}$ is the num ber of agents using strategy R at time t. We use the

notation hX [t]i_t to denote a time-average over the variable X [t] for a given . Hence

where we have used the property that $a_R^{[t]}$ and $n_R^{\underline{S}[t]}$ are uncorrelated. We now consider the special case in which all histories are visited equally on average: even if this situation does not hold for a speci c , it may indeed hold once the averaging over has also been taken. For example, in the M inority G am e all histories are visited equally at smallm and a given . If we take the additional average over all , then the sam e is also true for large m. Under the property of equal histories:

where we have used the exact result that $a_R^{[t]} = a_R^{[t]}$ for all [t], and the approximation $n_R^{\underline{S}[t]}_{t} = n_R^{\underline{S}[t]}_{t}$. This approximation is reasonable for a competitive game since there is typically no a priori best strategy: if the strategies are distributed fairly evenly among the agents, this then in plies that the average number playing each strategy is approximately equal and hence $n_R^{\underline{S}[t]}_{t} = n_R^{\underline{S}[t]}_{t}$. In the event that all histories are not equally visited over time, even after averaging over all , it may still happen that the system 's dynamics is restricted to equal visits to some subset of histories. In this case one can then carry out the averagings in this form alism can be carried out with appropriate frequency weightings for each history. In fact, any non-ergodic dynam ics can be incorporated if one knows the appropriate history path [8].

The variance of the excess dem and D [t] is given by

U sing the identities $\underline{a_R} \ \underline{a_R}^\circ = P$ (fully correlated), $\underline{a_R} \ \underline{a_R}^\circ = P$ (fully anticorrelated), and $\underline{a_R} \ \underline{a_R}^\circ = 0$ (fully uncorrelated) where $\underline{a_R}$ is a vector of dimension P with components $\underline{a_R}^{[t]}$ for [t] = 1;2;:::;P, we obtain

The values of $n_R^{\underline{S}[t]}$ and $n_{\overline{R}}^{\underline{S}[t]}$ for each R will depend on the precise form of . The ensemble-average over all possible realizations of the strategy allocation matrix is denoted by h:::i .U sing the notation 2 = 2, yields

It is straightforward to obtain analogous expressions for the variances in n_{+1} [t] and n_{-1} [t].

Equation (6) provides us with an expression for the time-averaged uctuations. Some form of approximation must be introduced in order to reduce Equation (6) to explicit analytic expressions. It turns out that Equation (6) can be manipulated in a variety of ways, depending on the level of approxim ation that one is prepared to make. The precise form of any resulting analytic expression will depend on the details of the approximations made. A dopting one such approach which is well-suited to the low m regime, we start by relabelling the strategies. Speci cally, the sum in Equation (6) is re-written to be over a virtual point ranking K as opposed to R.Consider the variation in points for a given strategy, as a function of time for a given realization of . The ranking (i.e. label) of a given strategy in terms of virtual-points score will typically change in time since the individual strategies have a variation in virtual-points which also varies in time. For the M inority G ame, this variation is quite rapid in the low m regime of interest, since there are many m ore agents than available strategies { hence any strategy em erging as the instantaneously highest-scoring, will im m ediately get played by m any agents and therefore be likely to lose on the next tim e-step. M ore general gam es involving competition within a multi-agent population, will typically generate

a similar ecology of strategy-scores with no all-time winner. This implies that the specie cidentity of the K 'th highest-scoring strategy' changes frequently in time. It also implies that $n_R^{\underline{S},[t]}$ varies considerably in time. Therefore in order to proceed, we shift the focus onto the time-evolution of the highest-scoring strategy, second highest-scoring strategy etc. This should have a much smoother time-evolution than the time-evolution for a given strategy. In the case that the strategies all start o with zero points, the anticorrelated strategies appear as the mirror-image, i.e. S_K [t] = $S_{\overline{K}}$ [t]. The label K is used to denote the rank in terms of strategy score, i.e. K = 1 is the highest scoring strategy position etc. with

assuming no strategy-ties. Given that $S_R = S_{\overline{R}}$ (i.e. all strategy scores start o at zero), then we know that $S_K = S_{\overline{K}}$. Equation (6) can hence be rewritten exactly as

Since in the system s of interest the agents are typically playing their highestscoring strategies, then the relevant quantity in determ ining how m any agents will instantanously play a given strategy, is a know ledge of its relative ranking { not the actual value of its virtual points score. This suggests that the quantities $n_{K}^{\underline{S},[t]}$ and $n_{\overline{K}}^{\underline{S},[t]}$ will uctuate relatively little in time, and that we should now develop the problem in terms of time-averaged values. We can rewrite the number of agents playing the strategy in position K at any timestep t, in terms of some constant value n_{K} plus a uctuating term $n_{K}^{\underline{S},[t]} = n_{K} + "_{K}$ [t]. We assume that one can choose a suitable constant n_{K} such that the uctuation "_K [t] represents a sm all noise term . Hence,

assuming the noise terms have averaged out to be small. The averaging over can now be taken inside the sum. Each term can then be rewritten exactly using the joint probability distribution for n_K and $n_{\overline{K}}$, which we shall call P (n_K ; $n_{\overline{K}}$). Hence

We now look at Equation (10) in the limiting case where the averaging over the quenched disorder matrix is dominated by matrices which are nearly

at. This will be a good approximation in the 'crowded' limit of small m in which there are many more agents than available strategies, since the standard deviation of an element in (i.e. the standard deviation in bin-size) is then much smaller than the mean bin-size. The probability distribution P (n_K ; $n_{\overline{K}}$) will then be sharply peaked around the n_K and $n_{\overline{K}}$ values given by the mean values for a at quenched-disorder matrix. We label these mean values as $\overline{n_K}$ and $\overline{n_{\overline{K}}}$. Hence P (n_K ; $n_{\overline{K}}$) = n_K ; $\overline{n_K}$; $\overline{n_{\overline{K}}}$; $\overline{n_{\overline{K}}}$ and so

There is a very simple interpretation of Equation (11). It represents the sum of the variances for each C row d-Anticrow d pair. For a given strategy K there is an anticorrelated strategy \overline{K} . The $\overline{n_K}$ agents using strategy K are doing the opposite of the $\overline{n_K}$ agents using strategy \overline{K} irrespective of the history bit-string. Hence the elective group-size for each C row d-Anticrow d pair is $n_K^{\text{eff}} = \overline{n_K}$ is represents the net step-size d of the C row d-Anticrow d pair in a random -walk contribution to the total variance. Hence, the net contribution by this C row d-Anticrow d pair to the variance is given by



where p = q = 1=2 for a random walk. Since all the strong correlations have been included (i.e. anti-correlations) it can therefore be assumed that the separate C rowd-Anticrowd pairs execute random walks which are uncorrelated with respect to each other. Recall the properties of the RSS - all the remaining strategies are uncorrelated.] Hence the total variance is given by the sum of the individual variances,

which corresponds exactly to E quation (11). If strategy-ties occur frequently, then one has to be m ore careful about evaluating $\overline{n_K}$ since its value m ay be a ected by the tie-breaking rule. We will show elsewhere that this becomes quite in portant in the case of very small m in the presence of network connections [8] - this is because very small m naturally leads to crowding in strategy space and hence mean-reverting virtual scores for strategies. This mean-reversion is amplied further by the presence of network connections which increases the crowding, thereby increasing the chance of strategy ties.

4 Im plem entation of C row d-A nticrow d Theory

Here we evalute the C row d-A nticrow d expressions, in the important limiting case of sm all m. Since there are m any m ore agents than available strategies, crow ding e ects will be important. Each element of has a mean of $N = (2P)^S$ agents per bin'. In the case of sm all m and hence densely-lled, the uctuations in the number of agents per bin will be sm all compared to this mean value { hence the matrix looks uniform or 'at' in terms of the occupation numbers in each bin. Figure 3 provides a schematic representation of with m = 2, S = 2, in the RSS. If the matrix is indeed at, then any reordering due to changes in the strategy ranking has no e ect on the form of the matrix. Therefore the num ber of agents playing the K 'th highest-scoring strategy, will always be proportional to the num ber of shaded bins at that K (see Fig. 3 for K = 3). For generalm and S, one nds



This derivation has assumed that there are no strategy ties { more precisely, we have assumed that the game nules governing strategy ties do not upset the identical forms of the rankings in terms of highest virtual points and popularity. Hence we have overestim ated the size of the C row ds using high-ranking strategies, and underestim ated the size of the A nticrow ds using low -ranking strategies. Therefore the analytic form for will overestim ate the num erical value, as is indeed seen in Figure 4.N otw ithstanding this overestim ation, there is remarkably good agreement between the num erical results and our analytic theory. In a similar way to the above calculation, the C row d-A nticrow d theory can be extended to deal with the important com – plementary regimes of (i) non- at quenched disorder matrix , at smallm , and (ii) non- at quenched disorder matrix , at large m .As shown in Figure 4, the agreement for these regimes is also excellent [2,7].

The C row d-Anticrow d theory has also been applied successfully to various generalizations of the M inority G am e. For example, excellent agreem ent between the resulting analytic expressions and num erical simulations has been dem onstrated for (i) A lloy M inority G am e [9], (ii) Therm al M inority G am e (TMG) [10,11], (iii) Therm al A lloy M inority G am e [12], and (iv) B-A-R system s with an underlying network structure [7].

5 Conclusion and Discussions

We have given an overview of the C row d-A nticrow d theory for competitive multi-agent systems, in particular those based on an underlying binary structure. Explicit analytic expressions can be evaluated at various levels of approximation, yielding very good agreement with numerical simulations. We note that the crucial element of this C row d-A nticrow d theory { i.e. properly accounting for the dominant inter-agent correlations { is not limited to one speci c gam e.G iven its success in describing a number of generalized B - A - R systems, we believe that the C row d-A nticrow d fram ework could provide a powerful approach to describing a wide class of C om plex Systems which

m in ic competitive multi-agent gam es. This would be a welcom e development, given the lack of general theoretical concepts in the eld of C om plex Systems as a whole. It is also pleasing from the point of view of physics methodology, since the basic underlying philosophy of accounting correctly for 'inter-particle' correlations is already known to be successful in more conventional areas of m any-body physics. This success in turn raises the intriguing possibility that conventional m any-body physics m ight be open to re-interpretation in terms of an appropriate multi-particle 'gam e': we leave this for future work.

O fcourse, som e properties of C om plex System s cannot be described using tim e-and con guration-averaged expressions as discussed here. In particular, an observation of a real-world C om plex System which is thought to resemble a multi-agent gam e, m ay correspond to a single run which evolves from a speci c initial con guration of agents' strategies. This im plies a particular

, and hence the time-averagings within the C row d-Anticrow d theory must be carried out for that particular choice of . How ever this problem can still be cast in terms of the C row d-Anticrow d approach, since the averagings are then just carried out over some sub-set of paths in history space, which is conditional on the path along which the C om plex System is already heading.

We have been discussing a Complex System based on multi-agent dynamics, in which both determ inistic and stochastic processes co-exist, and are indeed intertwined. Depending on the particular rules of the game, the stochastic element may be associated with any of ve areas: (i) disorder associated with the strategy allocation and hence with the heterogeneity in the population, (ii) disorder in an underlying network. Both (i) and (ii) might typically be xed from the outset (i.e., quenched disorder) hence it is interesting to see the interplay of (i) and (ii) in terms of the overall perform ance of the system [8]. The extent to which these two hard-wired' disorders might then com pensate each other, as for exam ple in the Parrondo e ect or stochastic resonance, is an interesting question. Such a compensation e ectm ight be engineered, for example, by altering the rules-of the-gam e concerning interagent com munication on the existing network. Three further possible sources of stochasticity are (iii) tie-breaks in the scores of strategies, (iv) a stochastic rule in order for each agent to pick which strategy to use from the available S strategies, as in the Therm alM inority Game, (v) stochasticity in the global resource level L [t] (e.g. bar seating capacity) due to changing external conditions. To a greater or lesser extent, these ve stochastic elements will tend to break up any determ inistic cycles arising in the game. We refer to Ref. [13] for a discussion of the dynam ics of the M inority G ame viewed from the perspective of a stochastically-perturbed determ inistic system .
