Luttinger liquid with strong spin-orbital coupling and Zeem an splitting in quantum wires

W e study a one-dimensional interacting electron gas with the strong Rashba spin-orbit coupling and Zeem an splitting in a quantum well. A bosonization theory is developed for this system. The tunneling current m ay deviate from a simple power law which is that in an ordinary Luttinger liquid. The m icroscopic interacting coupling and the spin-orbital parameter m ay be measured by varying the external magnetic eld in the tunneling experiment.

The realization of the quasi-one-dimensional conductor in quantum wires, carbon nanotubes and DNA molecules provided possible realization of Luttinger liquid systems [1]. Quantum wires fabricated from narrow gap semiconductors, e.g., InAs, are highly interesting objects in the spintronics due to their rich spin transport properties and their application as spin transistors.

The Rashba e ect [2], arising from the con ning potential which is necessary to fabricate the quantum wires, dom inates the behavior of the spin-orbit (SO) coupling in narrow gap sem iconductors with heavy and light hole bands. M oroz and Barnes have shown that in a strong Rashba spin-orbital coupling, the dispersion of the electron in the quasi-one dimensional quantum well is drastically deform ed [3]. The left and right Ferm ivelocities are not equal for a spin-s electron while the dispersions of the spin-up and down electrons have a m irror symmetry. Furtherm ore, a bosonization theory including such a strong Rashba spin-orbit coupling has been constructed [4]. It was found that, instead of the separated spin and charge excitations, two new branches of excitations with mixed spin and charge were found and the characteristic of the Luttinger liquid are modi ed by the SO coupling param eter [5].

To detect the SO coupling, an external magnetic eld was applied [6]. Moreover, reliable techniques to measure the SO param eter need to be further developed. On the other hand, the Zeem an splitting due to the externalm agnetic eld also modi es the transport behavior of the Luttinger liquid [7]. A further question raised here is what will happen if both the SO interaction and Zeem an splitting are considered simultaneously. We nd that a bosonization technique combining the methods used in Moroz et al [4] and Kim et al [7] can be employed to solve the present problem . It is seen that there are four independent chiral excitations with di erent sound velocities. In an interacting electron system, this leads to di erent power laws for the left and right moving single particle densities of states (DOSs) as a function of the energy from the Ferm i level. The tunneling current between a 3-dimensionalmetal(say, a STM tip) and the quantum wire may deviate from a simple power law and it m ay m easure this exponent asym m etry in DOSs, and

then the m icroscopic interacting coupling and the R ashba param eter.

M oroz and B armes have computed the band structure of this model with an external magnetic eld β]. The non-interacting electron H am iltonian under consideration reads

where m_b is the electron band m ass, g is the Lande g factor, and $_B$ is the Bohr magneton. The vector potential $A = B x \hat{y}$ which gives the magnetic eld $B \hat{z} = r - A$. The transverse con ning potential is approximated by a parabola. The SO Ham iltonian is given by

where takes 10¹⁰ 10⁹ eV cm [2]. The strong Rashba e ect appears if $l_1 = l$ 1:4 for $l = -2^2 = 2m_b$ and $l_1 = \frac{p}{2} = \frac{1}{2m_b}$ where ! is the frequency of the conning potential. In this case, M oroz et al found the linearized second quantized H am iltonian for B = 0 can be written as [4]

where the Ferm ivelocities $v_{1;2}$ are dependent on spin and chirality, which can be obtained by calculating the spectrum of the system. The di erence between the velocities, $v_{fr}(;!) = v_1$ v monotonically increases as is enhanced. The electron elds $c_{k; ;s}$ for = R; L and s =

relate to q_i ; (= #;") by q_i ; = a s(;!;k) c_k ; s, where a s(;!;k) is a spin rotation matrix which can be obtained by numerically solving the single particle Schrödinger equation corresponding to eq.(1) [3]. It may be expanded as a s = ;s + 0 ($v_F = v_F$) with the average Ferm ivelocity $v_F = (v_1 + v_2) = 2$. For a weak magnetic eld, its coupling to the orbital can be neglected if we consider the low-lying excitation. In the following, we only keep the Zeeman term with respect to the magnetic eld. Dene $k_F = m_b v_F$ and $v_{B_P} = g_{\ B} B = k_F$, the Zeeman term reads $H_Z = 2 v_B k_F$ ($_Z$) or $_s la l_0 r_{S^0} c_{k,s^0}^V c_{k,s^0} c_{k,s^0$

where $v^s = (v_F + s v_F = 2) + s v_B = 2$ are four dierent sound velocities.

Bosonized Hamiltonian: Using the above known result, we are going to the bosonized form alism . We take the electron interaction to be the SU (2) invariant form H_{int} = 2 U dy $^{y}(y)$ $(y) _{0}^{y}(y) _{0}(y)$ for the electron eld. At low energies, the interaction can be divided into the forward, backwordard, um klapp and oscillating terms. For the semiconduct quantum well, it is enough to only keep the forward scattering in low energies [9]. In the bosonization theory, the electron operators $_{j1}(x)$ are de ned by $_{j1}(x) / e^{i(-1)^{12}p^{p}}$, $_{j1}(x)$. A ssum ing q to be the low -lying excitation wave vector and q v_{f} y v_{F} , the bosonized form of the whole Hamiltonian is easily arrived at:

where the subindices ; are the charge and s-spin degrees of freedom; v; = $[(v \ U)^2 \ U^2]^{1=2}$ and K; = $v=(v \ 2U)$. Formally, the bosonized H am iltonian (5) is a direct generalization of the theory given in [4] or [7]. However, the physics included in such a generalization is richer.

Excitaions: A fler diagonalizing the H am iltonian (5), the theory cannot be written as that of a standard harmonic uid form of the Luttinger liquid [8]. We have four branches of the chiral excitations with the velocities u^1 , which are the absolute value of the solutions of the eigen equations. W hen v = 0 or = 0, one gets back the cases discussed in Refs.[4] and [7]: There are two excitations whose velocities are $u^R = u^L = [v^2 + (v_F = 2)^2 - 2v v U^2 + (v_F = 2)^2]^{1=2}$ or

Single particle correlation functions and tunneling current: The electron correlation function is a function of both the SO coupling and the external magnetic eld. We rst calculate the single particle correlation function , the Fourier transform at x = 0 of which corresponds to the single particle DOS.U sing the relation between the old and new elds, the s(=)-dependent correlation functions are given by

The chiral DOS is an experimental observable. For example, in a tunneling current measurem ent between a 3-dimensional metal (say, an STM tip) and a quantum wire, the tunneling current is given by Ferm i's golden rule:$

where $n_1^{(3)}$ is the single particle DOS of the Ferm i liquid. At zero energies, the di erential conductance is given by

For an ordinary Luttinger liquid, $_{\rm R} = _{\rm L}$ and dI=dV / n (eV), which has been recognized by M atveev and G lazman [12]. Now, due to $_{\rm R}$ \leftarrow _ while they are pretty close, the di erential conductance is not a simple power law. Such an asymmetry of the exponents in DOSs and the complex in the di erential conductance are a unique manifestation of the co-ordination between the Zeem an splitting and the SO precession in a Luttinger liquid. Furthermore, this di erential conductance and the exponents measurements also imply that the interacting coupling U and the SO parameter can be determined through the measured values of 2_1 as a function of the external magnetic eld. This may provide a reliable way to determine the SO parameter.

D ensity-density correlations: The density-density correlation functions describe the density uctuations of the system. The charge and s-spin density uctuations are given by

Transport in an in nitely long pure wire : The electron transport in the Luttinger liquid is a ected by the SO coupling and the external magnetic eld. From the continuity equation, the current operator is de ned by $j(x;) = \frac{p^{i}}{p^{i}} ((_{iR} + _{iL}))$ where = it. Here we only show the calculation of the conductance for a pure in nitely long quantum wire. It is also straightforward to calculate the conductance with in purity scatterings[13], although we shall not show it here. The conductivity is de ned by

Sim ilar to the charge current, we can de ne the s-spin current j (x;) = $\frac{p^{\perp}}{p^{\perp}} ($ (R + R). The same calculation gives rise to the s-spin conductance $G = 2K \frac{0}{h} \frac{e^2}{h}$. The spin current are given by $j_{\text{spin}}(x;) = (j_{\text{spin}}^2 + j_{\text{spin}}^2)$ $j_{a_{\#+}} f) j(x;)$. The spin conductance in the low energy lim it is given by $G_{spin} = 2(j_{a^{*}+} j^2) K_{spin} \frac{e^2}{b}$ and $K_{spin} = K^0$. The consequences arising from the above discussion are (i) For = B = 0, $j_{spin} = j$ and $G_{spin} = G \in 0$ because of the SU (2) invariance of the system. (ii) j_{spin} and G _{spin} portray the B-dependence of the system while j and G portray the dependence of the system on the SO coupling. For \neq 0 and B = 0, the spin conductivities $G_{*} = G_{\#}$, i.e., $G_{spin} = 0$ if B = 0. W hen U = 0, this agrees with previous work [10]. For = 0, $j_{spin} = j$. The SO e ect is rejected by G which increases as U goes up. This enhancement of the SO e ect has been observed for a two-dimensional electron gas [11]. (iii) W hen B > 0 and > 0, $j_{spin} < j$. On the other hand, G spin grows as the interaction becomes stronger because G grows. (iv) For given (B), the m agneto-polarization is given by

where a $_{\rm s}$ is a function of ;!; $k_{\rm F}$ and B; C is constant with order one. It is seen that the interaction can strongly enhance the polarization. The detailed num erical analysis will be given in further works.

In conclusion, we have built a low energy e ective theory when the Zeem an splitting and strong Rashba SO coupling in a Luttinger liquid are turned on simultaneously. Dierent from that in the ordinary two component Luttinger liquid, four chiral excitations with dierent sound velocities were found. An asymmetry of the single particle DOS has been found, which im plies a deviate from the single power law of the tunneling current between a 3-dimensionalmetal and the quantum wire. The variation of the dierential conductance as a function of the externalmagnetic eld also allowed for the determ ination of the interacting coupling and the SO parameter. The concrete numerical results will be given elsewhere.
