### K inetic m odels of ion transport through a nanopore

K inetic equations for the stationary state distribution function of ions moving through narrow pores are solved for a number of one-dimensional models of single ion transport. Ions move through pores of length L, under the action of a constant external eld and of a concentration gradient. The interaction of single ions with the con ning pore surface and with water molecules inside the pore are modelled by a Fokker-P lanck term in the kinetic equation, or by uncorrelated collisions with them alizing centres distributed along the pore. The tem porary binding of ions to polar residues lining the pore is modelled by stopping traps or energy barriers. A nalytic expressions for the stationary ion current through the pore are derived for several versions of the model, as functions of key physical param eters. In all cases, saturation of the current at high elds is predicted. Such sim ple models, for which results are analytic, may prove useful in the study of the current/voltage relations of ion channels through membranes.

#### I. IN TRODUCTION

The ow of uids through porous media is a classic problem which has many scienti c and industrial applications. For very narrow pores, with diam eters of the order of 1 nm or less, continuum descriptions become inapplicable and the transport of matter must be exam ined on the molecular scale. Exam ples include molecular or ionic permeation of zeolites [1], of carbon nanotubes [2, 3, 4] and of aquaporins [5] and ion channels [6] through cell membranes. The sim ple kinetic models exam ined in this work are meant to represent ion channels: they are, how ever, also more widely applicable - for exam ple, we shall present results for ions owing through an in nitely long pore that might represent a carbon nanotube or part of a zeolite.

Ion channels are pores through cell membranes, through which ions are transported under the in uence of a concentration gradient and a large electric eld. The permeability of the pores is highly selective for particular ions and the pores can also open and close to ion transport (a phenom enon known as \gating") in response to factors such as ligand binding or changes in the electric

eld or the membrane tension. M any channels contain a narrow region, the \selectivity lter", where ionic motion is essentially single- le [7, 8, 9, 10]. Some channels appear to transport only one ion at a time, while others use transport mechanisms involving multiple ions [8, 9, 11, 12]. M easurements of the current through individual channels have been possible for some time, and these have resulted in a large am ount of data, both on the gating characteristics of channels, and on their properties in the open state. These properties include the relationship between the ionic current and the electric eld applied across the membrane (current-voltage relations), as well as the conductivity of the channels as a function of the ionic concentration di erence, at

xed applied voltage (conductance-concentration relations). One of the challenges for theoreticians is to relate these functional characteristics to the geometric, physical and chem ical structure of the pores, which are becom ing increasingly well-known [13]. This goal may be achieved by detailed simulations of the motion of ions and molecules through speci c pores [14, 15], or using simpli ed models [16, 17, 18, 19]. Rates of ion transport can be predicted directly, or by application of barriercrossing theories such as K ram ers rate theory [20, 21, 22]. An alternative approach is the extension of continuum theories to the nanoscale. Goldman [23] and Hodgkin and Katz [24] (GHK), in their classic work, applied the one-dimensional di usion equation in a constant electric eld to predict current-voltage relations for ion channels. This work is generalized to speci c and multi-dim ensional ion channel models in the Poisson-Nemst-Planck (PNP) theory of ion channels [25, 26], where num erical solution

m ethods are used to obtain the current due to di usion in the presence of com plicated and self-consistent potential elds.

In this paper, we explore the possibility of applying simple, analytically solvable, kinetic models to the problem of transport in nanopores. Our approach is for the moment very general. We consider the motion of single ions through a one-dimensional pore of length L connecting two reservoirs at dierent ion concentrations, under the action of a constant electric eld (we shall also consider the case of an in nitely long pore). Ions are ex-

pected to experience friction due to collisions with the inside surface of the pore and with other particles, such as water molecules, inside the pore. We include this effect initially by a Langevin-like friction within the fram ework of a Fokker-Planck (FP) description, although we shall see that the FP approach presents som e di culties in the con ned geometry of the nite length pore, which we shall attempt to overcome by using an alternative description of the friction in terms of localized \therm alizing centres". We also consider that there may bem ore speci c binding interactions between the ion and the pore surface, for example with polar residues lining the surface. These are modelled by \stopping traps" - on encountering such a trap, an ions is stopped, and later released to continue its motion under the in uence of friction and the electric eld. The action of the stopping traps on the ion may or may not depend upon its velocity. In all cases, we attempt to nd general analytic solutions for the stationary state ionic current j, and som et in es also for the ion distribution function f(x;v)(de ned so that the probability of nding an ion between position x and x + dx with velocity between v and v + dv is f (x;v)dxdv). These solutions are functions of the applied eld, as well as of param eters such as the channel length, friction coe cient and probability density of stopping traps. We hope that these results may ultim ately be used to analyse the transport behaviour of speci c pores or channels, by adapting the above physical param eters to the known structure of the pore under consideration.

The general kinetic equation for the model is presented in section II. The kinetic equation is solved in section III for the case of a nite length channel with stopping traps but without friction, and in section IV in the case of a

nite channelwith friction but without traps; di culties arising from the use of the FP operator in a pore of nite length are discussed. These di culties do not arise in the case of an in nite (L ! 1) channel, for which a general solution is obtained in the presence of both friction and traps, in section V. Returning to a nite L channel in section VI, the FP friction is replaced by a distribution of them alizing centres throughout the pore, and an explicit expression for the current is obtained in the presence of such them alizing centres and stopping traps. C oncluding rem arks are m ade in the last section.

# II. MODELAND KINETIC EQUATION

O ur model channel is pictured in gure 1. The channel, of length L, is located along the x-axis (L=2 < x < L=2). The radius of the pore (which is assumed to be cylindrical) matches the ion radius, so that ionic motion inside the pore is strictly one-dimensional. The pore links two reservoirs containing ionic solutions of linear concentrations <sub>1</sub> (to the left) and <sub>r</sub> (to the right): <sub>1</sub> and <sub>r</sub> are related to the bulk concentrations c<sub>1</sub> and c<sub>r</sub> in the reservoirs by  $r_{r,1} = R^2 c_{r,1}$ , where R is the radius of the pore. The inner surface of the pore is lined with




FIG.1: Schematic view of the model channel.

stopping traps of local average density (x): we shall assume that the probability of nding n traps within the interval  $x_1 < x \leq x_2$  is given by the Poisson distribution with parameter  $x_1$  (x)dx.

If an ion encounters a trap, its velocity is set to zero, generally irrespective of its initial velocity (although we shall also consider in section III the case of traps which discrim inate between ions according to velocity). Inside the pore, the ion (of charge q and m ass m) is subjected to a uniform electric eld E, and hence undergoes an acceleration, towards the right, a = qE = m. A first being stopped by a trap, the ion is therefore re-accelerated by the electric eld. Ions also experience friction: this will initially be modelled by a force v, where v is the velocity of the ion, as well as the therm alizing e ect of a random force, although an alternative to this Langevin-like model will be presented in section VI. In sum mary, the ion undergoes a constant acceleration due to the electric

eld, is slowed down by collisions with m olecules inside the pore or on the pore surface (these processes being described by a friction process) and m ay be captured by traps along the channel, to account for tem porary binding to polar residues on the pore surface. We shall present results for stationary state ion ow only.

The general kinetic equation for the stationary state ion distribution function f(x;v), in the presence of Poisson-distributed stopping traps of average density (x) as well as a Langevin-like friction mechanism, with

friction coe cient, is:

The left-hand side (lh.s.) of (1) describes free ow of ions under the action of the constant acceleration a aris-

ing from the external edd. The rh.s. contains two collision terms. The rst accounts for the stopping traps: it is a balance between gain (in the population of zero velocity particles) and loss (of particles with velocity v). The second term is the Fokker-P lanck operator acting on the distribution function: it accounts for the e ect of the frictional and random forces. Note that the kinetic equation (1) is for a single ion: it does not account for interactions between several ions within the pore. This lim itation will be addressed in later work.

The reservoirs on the left (x < L=2) and on the right (x > L=2) of the channel are assumed to contain ions in them odynamic equilibrium at the same temperature T, but generally at di erent densities: 1 (to the left) and r (to the right). The ion distribution functions in the reservoirs (not including the contribution of any ions com ing out of the pore) are hence:

is the M axwell velocity distribution function.

For illustrative purposes, we rst consider the case where acceleration, traps and friction are all absent, and an ion which enters the pore at one end keeps the same velocity until it reaches the other end. The ion distribution function within the pore is then simply:

where denotes the Heaviside step function. The ion current is given by:

For a stationary state, continuity requires that the current be independent of position:

Substituting (4) into (5) one nds the result in the absence of acceleration, traps or friction:

while the number density inside the channel

is in this case given by  $n = (_1 + _r)=2$ . Note that discontinuities arise in n(x) at the pore boundaries, x = L=2: this rejects the fact that the regions close to the pore mouth are not modelled in detail in this simple theory.

In the subsequent sections, analytic solutions of the kinetic equation (1) will be derived for the limiting cases

= 0 (section III), (x) = 0 (section IV) and L ! 1 (section V).

### III. FINITE CHANNEL W ITH TRAPS

Consider a pore of nite length L, containing stopping traps but no friction mechanism. The traps have average local density (x) and are distributed according to a Poisson law as described in Section II: on encountering such a trap, the velocity of an ion is reduced to zero. In the absence of friction, the kinetic equation (1) for the stationary state ion distribution function f (x;v) simplies to:

Note that we obtain Equation (6) (constant current throughout the pore) on integrating both sides of (9) over all velocities 1 < v < +1. If the traps are on average uniform ly distributed ((x) = ), Equation (9) can be solved exactly for f (x;v) as shown in Appendix A. However, an expression for the ionic current j can be obtained for any (x) using simple arguments, without the need for an explicit solution for f (x;v).

We isst note that in the stationary state, the contribution to the current due to an ion which enters the channel at one end depends only on its incoming velocity and its probability of eventually arriving at the other end, since j does not depend on x (and there are no interactions between ions). For this model, all ions entering the channel from the left reservoir at x = L=2 will eventually reach x = L=2, since on being stopped by a trap they are reaccelerated by the eld towards the right (assuming a is positive). Thus the contribution of these ions to the current is:

Ions entering the channel from the right at x = L=2 will reach x = L=2 only if they are not stopped either by the opposing eld or by an encouter with a trap. An ion which is stopped is re-accelerated towards the right, so that it will exit the channel at L=2. The Poisson probability of encountering no traps between  $x_1$  and  $x_2$  is:

In order to overcome the opposing eld, ions must enter the channel with kinetic energy m  $v^2=2 > m aL$ , so that, assuming a M axwell distribution of velocities at L=2, the distribution function  $f_r(x;v)$  of particles which entered the channel at L=2 and which will eventually reach L=2

is:

from which Equation (5) leads to a contribution to the current:

Adding (10) and (13) leads to the result for j:

in agreem ent with the full solution derived in Appendix A. Equation (14) show sthat in thism odel, in the absence of friction, the current does not depend on the spatial distribution of the stopping traps, but only on the integral of (x) between x = L=2 and x = L=2. Note that Equations (14) and (15) were derived for a > 0. When a < 0, the roles of the right and left reservoirs must be interchanged.




FIG. 2: D in ensionless current  $2 \text{ m} = (k_B \text{ T}) \text{ j} = 0$  as a function of m aL =  $(k_B \text{ T})$ , where the reservoir densities are  $1 = C_{1 0}$  and  $r = C_{r 0}$ , for various values of the dimensionless stopping trap density L. Solid lines: L = 0, dotted lines: L = 1, dashed lines: L = 2. (a): Equal reservoir densities, r = -1;  $C_r = 1$ ,  $C_1 = 1$  (b): r = 2 -1;  $C_r = 2$ ,  $C_1 = 1$ . The insets show the currents  $j_1$  and  $j_r$  (in dimensionless form) due to ions originating in the left (circles) and right (squares) reservoirs, for the case L = 1. Values for the current in absolute units can be obtained by substituting absolute values for the physical parameters a, m, L, r, 1, and  $k_B T$ .

If the reservoir densities  $_1$  and  $_r$  are measured relative to an arbitrary \reference density"  $_0$ , such that  $_{1} = C_{1 0}$  and  $_{r} \equiv C_{r 0}$ , a dimensionless form of the current is given by  $2 \text{ m} = (k_B \text{ T}) \text{ j} = 0$ . This is plotted in Figure 2, for the cases where the reservoir densities are equal ( $C_1 = C_r$ ) or di erent ( $C_l < C_r$ ). Figure 2 shows that the current saturates for large jaj. For positive a, the current at saturation is due exclusively to ions from the left reservoir and  $2 \text{ m} = (k_B \text{ T}) = 0 ! C_1$ ; for nega-2 m =  $(k_B T) j = 0 ! C_r$ . For values of jajbelow tive a, saturation, the m agnitude of the current increases as the density of traps increases. This is because traps reduce the negative current contribution jr from the right reservoir (for a > 0), without a ecting the current j of ions moving from the left, as can be seen in the insets, where  $j_r$  and  $j_1$  (in dimensionless form) are plotted individually for the case where L = 1. The discontinuity in the current at a = 0, observed for nite concentrations of traps ( > 0), re ects the fact that the model is no longer valid in the absence of a eld, when there is no stationary solution (since ions that are stopped by a trap are not then re-accelerated). In the case of unequal ion densities in the two reservoirs, the current-voltage curves

are asymmetric, as shown in Figure 2b. The saturation value of jjjis now larger for negative a, and j is negative for sm all positive values of a.

Thus far, we have assumed that any ion which encounters a trap is stopped, regardless of its velocity. However, ions with low kinetic energy could be expected to be more likely to be bound by a polar residue lining a nanopore, than those with more energy. We now consider a variation on our previous model, in which a single trap is present at position  $x = x_0$  inside the pore (  $L=2 < x_0 < L=2$ ), which presents an \energy barrier" of height  $E_0 = m v_0^2=2$  to all ions crossing  $x = x_0$ . We shall consider two possible modes of action of this trap.

In model A, the trap at  $x = x_0$  stops all ions with kinetic energy below the barrier height:  $m v^2=2 < E_0$  (and subsequently releases them to be re-accelerated by the electric eld), but has no e ect on ions with energy

Equation (16) can be solved analytically, but we shall instead use simple arguments, as before, to obtain the current j without the explicit form of f(x;v). As above, any ion entering the channel at the left extrem ity (x =

L=2) with velocity v > 0 will eventually reach the right extrem ity (x = L=2), regardless of whether it is stopped by the trap. The contribution  $j_1$  of these ions to the current is therefore given by (10). However, ions entering the channelat x = L=2 with velocity v < 0 will only reach x = L=2 (and hence contribute to the current) if they are not stopped either by the eld or by the energetic trap at  $x_0$ . There are two possibilities, depending on the barrier height E<sub>0</sub>:

(1)  $E_0 > ma(x_0 + L=2)$ . In this case, any ion which reaches the trap with energy greater than  $E_0$ , and so is not stopped, must have su cient energy to overcome the remaining part of the opposing eld between  $x_0$  and L=2. In order to have energy  $E_0$  on reaching the trap at  $x_0$ , an ion must enter the channel at x = L=2 with velocity v such that:

so that, assuming an incoming M axwell distribution, the distribution function of these ions is:

U sing (5) we nd that in this case the contribution to the current due to ions from the right hand reservoir is:

(2) E<sub>0</sub> < m a ( $x_0$  + L=2). In this case, ions which pass through the barrier at  $x_0$  do not necessarily have su – cient energy to overcome the remaining part of the eld between  $x_0$  and L=2. The only ions which contribute to the current are those entering the channel with velocity v, such that:

Expression (23) is, of course, only valid for positive values of a. The equivalent expression when a < 0 can easily be shown to be:




FIG.3: D in ensionless current  $p = p = (k_B T) = 0$  for M odel A (Equations (23) and (24)) as a function of m aL=(k\_B T), ( $_0$  de ned as in Figure 2), for r = 0;  $_1 = 0$ . (a): Energetic trap xed at centre of pore,  $x_0 = L = 0$ . Solid line:  $E_0 = (k_B T) = 0$ , dotted line:  $E_0 = (k_B T) = 0.5$ , dashed line:  $E_0 = (k_B T) = 1$ . (b): Height of barrier xed,  $E_0 = (k_B T) = 1$ . Solid line:  $x_0 = L = 0.2$ , dashed line:  $x_0 = L = 0.4$ .

The current-voltage curves for model A are shown in Figure 3, in dimensionless form as in Figure 2. For clarity, we consider the case where only the right-hand reservoir contains ions: 1 = 0. In Figure 3a, the position of the trap is xed at  $x_0 = 0$  and the barrier height  $E_0 = k_B T$ is increased. W hen  $mal=k_B T$  exceeds the critical value, given by  $maL = E_0 = (1=2 + x_0 = L)$ , j no longer depends on  $E_0$  and all the curves become identical. However, in the regime where m aL <  $E_0 = (1=2 + x_0=L)$ , j depends strongly on E<sub>0</sub>, being increased on increasing the barrier height. This can be easily understood, since ions which come from the right-hand reservoir and are im peded by the barrier make a negative contribution to the current. An interesting general observation can be m ade here, that the presence of an energetic barrier can have the e ect of increasing the ionic current. In Figure 3b, the barrier height is xed ( $E_0 = k_B T = 1$ ) and the trap is moved towards the right-hand end of the pore. The current-voltage characteristics are seen to be rather sensitive to the position of the trap in the regime  $m aL < E_0 = (1=2 + x_0=L)$ , although there is no dependence for larger m  $aL = k_B T$ . As  $x_0$  increases, j decreases, although the value as a ! 0 rem ains unchanged.

We also consider an alternative energetic barrier m odel, m odel B. Here, ions encountering the trap with energy greater than the barrier height, m  $v^2=2 > E_0$ , do not continue unperturbed, as in m odel A, but instead lose energy  $E_0$ , being released by the trap with reduced velocity  $v^0$ , where  $jv^0j = v^2 v_0^2$ . Less energetic ions with m  $v^2=2 < E_0$  are stopped by the trap, as in m odel A.Follow ing a line of reasoning as form odel A, one nds

that the total current (when a > 0) is:

Note that form odelB, the current j does not depend on the position  $x_0$  of the trap. Comparing expression (25) with (14) and (15), we see that the current in modelB with energy barrier  $E_0$  is identical to that through the channelwith stopping traps investigated at the beginning of this section, if  $E_0 = k_B T = \frac{R_{L=2}}{L=2} (x^0) dx^0$ .

### IV. FINITE CHANNEL W ITH FRICTION

We now turn to a model where no stopping traps are present ((x) = 0), but ions undergo frictional collisions inside the pore (of nite length L). The thermalizing e ect on the ion of these collisions with the channel surface and with otherm olecules (e.g. water) is modelled by a Langevin mechanism, represented by a Fokker-P lanck operator, so that the stationary state kinetic equation (1) now becom es:

Expression (34) for the current simpli es greatly in the lim it of vanishing applied eld (a ! 0), when the only driving force is di usion under the action of the density gradient ( $_1$  r)=L. Substituting (31) into (34), one nds:

i.e. the friction reduces the current by a factor  $1=1+L^{T}(0)$  compared to the free ow result (7). The a ! 0 limit of the distribution function  $f(x;v)_{a! 0}$  and the resulting density pro leare discussed in Appendix B:  $f(x;v)_{a! 0}$  for a given L and turns out not to be everywhere positive, pointing to a fundamental dif-

culty in applying the Fokker-Planck equation (26) in a system of nite spatial extension L .

A nother interesting case is the lim it of strong friction (  $\ ! \ 1$  ). B then becomes:

and the resulting current, given by inserting (36) in (34), reduces to the classic GHK expression [23, 24], which arises from solving the 1-d di usion equation in a constant external eld [6].

GHK theory predicts that the current increases linearly with voltage across the channel for large voltages. However, the behaviour of j for large a in this model is considerably di erent: xing and taking the limit a ! 1 in Equation (31), we nd that the current saturates for large applied elds:

Equations (37), which are identical to the saturation values of the current for the models presented in section III, correspond to the situation where all ions crossing the channel in the direction of the eld contribute to the current and all ions attempting to penetrate the channel against the eld are turned back.

An important experimental quantity is the \reversal potential": the voltage across the channel for which the




FIG. 4: D in ensionless current  $p_{2m} = (k_B T) = 0$  as a function tion of maL=( $k_B T$ ), for values of dimensionless friction L  $m = (k_B T)$  of 0.1 (solid lines), 1.0 (dotted lines) and 10.0 (dashed lines). (a): Equal reservoir densities r = 1 = 0; inset shows results predicted by GHK theory. (b) Reservoir densities r = 0; 1 = 0 (above) and r = 0; 1 = 0 (below); again, inset shows results of GHK theory.

total ionic current is zero. In the case where the ionic species are the same in the two reservoirs, the acceleration  $a_0$  at which the current is zero is given by cancelling the num erator of (31), which yields:

Expression (38) is identical to the GHK prediction. How ever, if the reservoirs contain di erent species: for exam ple potassium on one side and sodium on the other, the model will no longer agree with GHK <u>theory</u>.

P bots of the dimensionless current  $2 \text{ m} = (k_B \text{ T}) \text{ j} = 0$ versus m aL =  $(k_B \text{ T})$  are shown in Figure 4, for values of the dimensionless combination L  $\text{m} = (k_B \text{ T}) \text{ of 0.1, 1.0}$ and 10.0. In both Figure 4a and Figure 4b, the insets show the results of G H K theory. Figure 4a shows the current through the channel when the ionic concentrations in the two reservoir are equal ( $_r = _1$ ). W hile G H K theory predicts linear asymptotic behaviour, the current given by Equation (34) shows saturation as jaj! 1 . As the friction coe cient decreases, the current-voltage relation becom es steeper and deviates further from the G H K results. In Figure 4b, the current shown in Figure 4a is divided into the contributions of ions originating in the right (shown above) and left (shown below) reservoirs. A s expected, for large positive a, the current is due only to ions from the left, and for large negative a, it consists only of ions from the right.

# V. INFINITE CHANNEL WITH FRICTION AND TRAPS

W e next address the full version of the model system described in section  $\Pi$ : single ions moving under the in-

uence of constant accelerating eld, a Fokker-Planck them alizing mechanism and stopping traps. We shall consider only the case where the velocity of an ion encountering a trap is set to zero, irrespective of its initial velocity, and where the average distribution of the traps is uniform ((x) =). An analytic solution of the kinetic equation (1) is presented in the limit of an in nitely long pore (L ! 1). This solution may prove useful in analysing ion ow through carbon nanotubes or the long pores found in zeolites.

We rst introduce dimensionless position and velocity variables y and u:

We were unable to solve the inhom ogeneous equation (41) analytically. An analytic solution may, however, be




FIG. 5: Current  $J = {p \atop m = (k_B T)} j$  as a function of , for values of of 0.0 (solid line), 0.25 (dotted line), 0.5 (dashed line) and 0.75 (dot-dashed line). Inset: Total J (dashed line) as well as components of J towards the right (circles) and towards the left (squares), for the case where = 0.5.

obtained in the in the limit of an in nitely long pore (L ! 1), when the ion distribution no longer depends on y and the problem is spatially hom ogeneous. Equation (41) then simpli es to:

where the D<sub>p</sub>(z) are parabolic cylinder functions. The constant A determ ines the number density of ions inside the channel (in a nite channel this would be set by the reservoir densities): here, we assume one ion per unit channel length, so that A can be obtained num erically from the norm alization condition  ${}_{1}^{R+1}$  F (u)du = 1.

In the limit ! 0, i.e. in the absence of traps, (44) reduces to the result (28) (noting that  $D_0(z) = \exp z^2=4$  and reverting to dimensional units), and the current is linear in . In the limit ! 0, i.e. in the absence of acceleration, the solution (44) is seen to be an even function of u, so that the current j vanishes, as expected for an in nitely long, spatially hom ogeneous channel.

In the general case, when both and  $\epsilon$  0, the current must be calculated by num erical integration, after substituting (44) in (5). Figure 5 shows the current

The inset shows the forward and backward components of J when = 0.5 (given by integrating over the coe cients of (u) and (u) in Equation (44)). There is a qualitative di erence in the behaviour of the current when = 0, where the relation between J and is linear, as noted above, and when

€ 0, where it is non-linear. Thus even a very small density of stopping traps (for example, due to defects or in purities) can have a dramatic e ect on the current

owing through the pore. On estimating typical values of the physical parameters a, , m and , we nd that and are in fact likely to be small, perhaps of order 0:01 0:1.

# VI. FIN ITE CHANNEL W ITH THERMALIZING CENTRES AND TRAPS

In Sections IV and V, the e ect of friction and therm alization on the motion of single ions was modelled by the Fokker-Planck collision operator. For the channel of nite length, this leads to the fundamental problem that imposing the incoming ion uxes from the reservoirs at both ends of the channel results in a stationary distribution function f(x;v) which is not positive de nite (see Appendix B). In this section, we therefore replace the Fokker-Planck mechanism by an alternative therm alization process. We consider a model in which the 1-d channel contains N \therm alizing centres", at positions  $x_i$ , such that:

W hen an ion reaches a therm alizing centre, its incoming velocity v is replaced by a new velocity v<sup>0</sup> drawn from a M axwell distribution <sup>T</sup> (v<sup>0</sup>), Equation (3). The channel also contains a series of \energy barriers", of the type denoted \M odelA " in section III: a barrier of height E<sub>i</sub> tem porarily stops an ion with kinetic energy m v<sup>2</sup>=2 < E<sub>i</sub> but has no e ect if m  $\sqrt[2]{2}$  > E<sub>i</sub>. An energy barrier of height E<sub>i</sub> is located between each pair of neighbouring therm alizing centres at x<sub>i</sub> 1 and x<sub>i</sub>: if E<sub>i</sub> = 0, this is equivalent to having no energy barrier present. In between encounters with therm alizing centres and energy barriers, ions move w ith constant acceleration a, which is taken to act towards the right.

W e now analyze the stochastic process de ned by this model, leading to an exact calculation of the stationary current j. The key quantity is the probability p(i! i+ 1) that an ion which is therm alized by the centre at  $x_i$ , subsequently encounters the next therm alizing centre at  $x_{i+1}$  (i.e. it reaches  $x_{i+1}$  before  $x_{i-1}$ ). We rest note that an ion which leaves the centre at  $x_i$ , moving towards the left, requires a minim alenergy e(i; i) to penetrate the

eld and energetic barrier and reach the centre at  $\mathbf{x}_{-1}$  , where:

We shall adopt the convenient notation  $x_0 = L=2$  and  $x_{N+1} = L=2$ , so that Equation (46) remains valid for i=1 and for i=N+1. Ions leaving  $x_i$  towards the left with energy less than e(i;i-1) will be stopped and reaccelerated towards the right, returning to  $x_i$ . Since ions leave the thermalizing centre with a M axwellvelocity distribution, the probability w (i;i-1), that an ion leaving  $x_i$  (in either direction) has energy less than e(i;i-1) is given by:

An ion that leaves  $x_i$  towards the right, on the other hand, will certainly reach the therm alizing centre at  $x_{i+1}$ , regardless of whether it is stopped by the energetic barrier  $E_{i+1}$ . Thus on leaving  $x_i$ , an ion m ay be sent to the right (with probability 1=2), and reach  $x_{i+1}$ , or it m ay be sent to the left, be stopped and return to  $x_i$  (with probability w (i;i 1)=2), or lastly it m ay be sent to the left and reach  $x_{i-1}$ .

The probability p(i ! i + 1) that an ion leaving  $x_i$ reaches  $x_{i+1}$  before  $x_{i-1}$  can be found by summing over all the possible ways that this might happen. The n-th term in the series corresponds to the scenario where an ion is sent n times to the left (i.e. towards  $x_{i-1}$ ) and returns to  $x_i$  before eventually being sent to the right (i.e. towards  $x_{i+1}$ ). We thus obtain a geometric series:

The probabilities (48) and (49) m ay now be used to determ ine the probability  $q_i$  that an ion starting from  $x_i$  eventually leaves the channel through the right end at  $x_{N+1} = L=2$ . The  $q_i$  satisfy the (detailed balance) equations:

The only ions which m ake a contribution to the current are those which come from the left reservoir, pass through the whole channel and exit at the right end, and those which come from the right reservoir and exit at the left end. The \e ective friction" introduced by the therm alizing centres is thus proportional to their density. Physically, (62) also means that the relaxation time  $^{-1}$  is of the order of the time taken by an ion to cover the average distance L=N between the therm alizing centres with velocity  $^{\rm P}$   $_{\rm k_B}$  T=m . This equivalence between the FP and therm alizing centre results does not hold, how ever, in the presence of an accelerating eld (a  $\leq$  0).

As in the case described by the FP collision term (cf. Equation (37)), the current j saturates for large applied

elds (a ! 1 ) at the value j. This is because all ions com ing from the left are driven through the channel by the strong eld, while no ions are able to cross the channel successfully from the right.

Formula (61) simpli es greatly when the therm alizing centres are evenly distributed and in the absence of energy barriers, i.e. when  $(x_i \ x_{i-1}) = L = (N + 1)$  and  $E_i = 0$  for all 1 i N. In that case:




FIG.6: D in ensionless current  $2 \text{ m} = (k_B \text{ T}) \text{ j} = 0$  as a function of m aL =  $(k_B \text{ T})$ , where the reservoir densities are  $1 = C_1 0$  and  $r = C_r 0$ , for channels containing an increasing number N of evenly spaced therm alizing centres. Energetic barrier heights  $E_1$  are all set to zero. Solid lines: N = 0, dotted lines: N = 1, dashed lines: N = 5, dot-dashed lines: N = 10. (a): Equal reservoir densities, r = 1;  $C_r = 1$ ,  $C_1 = 1$  (b):  $r = 2_1$ ;  $C_r = 2$ ,  $C_1 = 1$ . The insets show the currents  $j_1$  and  $j_r$  (in dimensionless form) due to ions originating in the left (circles) and right (squares) reservoirs, when N = 5.

spaced them alizing centres, when there are no energetic barriers (E<sub>i</sub> = 0 for all i). In Figure 6a, the reservoir densities are equal,  $_1 = _r = _0$ . As N increases, the current decreases, requiring larger values of m aL=(k<sub>B</sub> T) to approach its asymptotic value. The inset shows the contributions to the (dimensionless) current from the left and right reservoirs when N = 5. Figure 6b shows results for the same channel, when the density of ions in the right-hand reservoir is twice as large as that in the left:  $_r = 2_1 = 2_0$ . In this case, the negative contribution j<sub>r</sub> is increased and dom inates for sm all values of m aL=(k<sub>B</sub> T).




FIG.7: D in ensionless current p = p = 0 as a function of maL=(k<sub>B</sub>T), for equal reservoir densities 1 = r = 0. (a): Channel contains N = 5 therm alizing centres, even ly spaced in the range b=2 x b=2. All barrier heights E<sub>1</sub> are set to zero. Solid line: b = L, dotted line: b = L=2, dashed line: b = L=4. (b): Channel contains N = 4 therm alizing centres, even ly spaced in the range L=2 x L=2, and one energetic barrier E<sub>3</sub> 0, located between the central pair of therm alizing centres. Solid line: E<sub>3</sub>=(k<sub>B</sub>T) = 0, dotted line: E<sub>3</sub>=(k<sub>B</sub>T) = 1, dashed line: E<sub>3</sub>=(k<sub>B</sub>T) = 2.

We have also investigated the elect of changing the spatial arrangement of the thermalizing centres, once again in the absence of energetic barriers ( $E_i = 0$  for all i). In Figure 7a, the channel contains N = 5 thermalizing centres which are all located in the range

b=2 x b=2, where b L.W ithin this range the therm alizers are evenly spaced. Results are shown for equal reservoir densities,  $_1 = _r = _0$ . As b decreases and the therm alizers become more localized in the middle of the pore, the current increases, approaching its asymptotic value for smaller values of m aL=(k\_B T). However, the results for b = 0.5L (dotted lines) and b = 0.25L (dashed lines) are rather similar, indicating a limiting current-voltage relationship for smallb.

Interesting e ects are obtained on including energetic barriers. Figure 7b shows results for a channel containing N = 4 therm alizing centres, with a single barrier  $E_i$ , b-cated between the second and third therm alizers (i = 3), i.e. in the central one of the 5 possible positions. Once again,  $_1 = _r = _0$ . As the barrier height  $E_3$  is increased, the current increases, showing that inserting an impedance to ion passage can actually enhance the total ion ow through the channel. This apparently som ew hat counter-intuitive result can in fact be easily understood.

Let us consider an ion that is released by the therm alizing centre at  $x_i$ . If it is sent out towards the right, the ion will certainly reach  $x_{i+1}$ , while if it is sent to the left, it will be stopped and return to  $x_i$  with probability w (i; i 1), which is an increasing function of E<sub>i</sub>. Thus increasing E<sub>i</sub> increases the chances of an ion eventually arriving at  $x_{i+1}$ , and thus enhances the current. This phenonenon m ay be of interest for biological ion channels, where the selectivity liter m ight play the role of an energetic barrier.

# VII. CONCLUSION

In this paper, we have introduced som e sim ple kinetic models for the transport of independent ions through narrow pores, under the in uence of a constant acceleration, due to an applied external electric eld. W e consider only one-dimensional motion along the pore axis. Analytic results have been obtained for the stationary ion current j and, in som e cases, also for the stationary non-equilibrium distribution function f(x;v). Boundary conditions at the ends of the pore are consistent with the presence of reservoirs containing ions at equilibrium, which determ ine the ux of ions entering the pore. The m odels include traps or energy barriers, which represent the temporary binding of an ion to polar residues lining the pore surface, and they also account for the friction and therm alization due to collisions of the ions with molecules (e.g. water) inside the pore as well as with its inner, con ning surface. Initially, this friction and therm alization was included using a Fokker-P lanck operator in the kinetic equation. We were unable to nd a solution for a pore of nite length L when both traps and the Fokker-Planck description of friction are present. How ever, we have derived an explicit solution for the hom ogeneous case of an in nitely long pore. For pores of nite length, solutions are given form odels with stopping traps or energy barriers in the absence of friction. For stopping traps, the current does not depend on the spatial distribution of the traps, but for a single energy barrier, there may be a dependence on its position, depending on its mechanism of action. We have also solved the kinetic equation for the distribution function f(x;v), for a nite channel in the case where the Fokker-P lanck m echanism is present but there are no traps or energy barriers. In this case, on imposing the incoming uxes from the reservoirs at both ends of the pore, f(x;v) turns out not to be positive de nite for short channels and/or sm all values of the friction constant . This unphysical behaviour can be understood in term s of competing time scales for high velocity ions (which pass through the channel before they can be therm alized): the resulting ion current remains well-behaved, as does the number density pro le. In view of this de ciency of the Fokker-Planck mechanism in a pore of nite length, we have introduced an alternative model, whereby ions are instead therm alized by encounters with a series of \therm alizing centres", lo-

An important conclusion arising from all the models which were considered is that the current j invariably saturates as a function of the external eld (or equivalently the constant acceleration a), since it is limited by the incoming ux from the reservoirs. This saturation behaviour contrasts with the linear increase of jwith voltage predicted by the classic GHK result, which can be derived by solving the one-dimensionaldi usion equation in the presence of a constant external eld. A further interesting observation that emerges from this work is that the presence of stopping traps or energy barriers inside the pore can increase rather than decrease the ionic current. This is because the steady state ow of ions crossing the pore in the direction of the applied acceleration is una ected by the traps or barriers, while the ow of ions against the eld is reduced. When the form er contribution is the dom inant one, the current will be enhanced by the traps or barriers.

A question that arises is whether there is any correspondance between the two models of friction and thermalization considered in this work: the Fokker-Planck mechansim and the the model involving N thermalizing centres. In the absence of an applied eld and of energy barriers, when ionic motion is driven only by the concentration gradient across the pore, an equivalence can be established between the two models (c.f. Equation (62)). How ever, under more general conditions, we have found no one-to-one correspondance between the two descriptions of dissipation.

Future work will include a complete num erical analysis of the model involving both energy barriers and therm alizing centres. We also plan to extend the kinetic models to include the possibility of collective ion permeation through a pore, by including ion-ion interactions. These are believed to play an important role in ion transport through some biological channels [8, 9, 11, 12]. Appropriate selection of parameters such as the pore length L, the friction coe cient or the num ber and positions of the therm alizing centres and the positions and heights of the energy barriers, to correspond to the structure of realion channels, should allow the predictions of these kinetic models to be compared to measured current-voltage characteristics.

### APPENDIX A

### APPENDIX B

In section IV, we constructed the solution of the Fokker-Planck equation (26), satisfying the boundary conditions given in Equation (27). The solution consists of a linear combination of a non-equilibrium stationary hom ogeneous solution (28), which gives rise to a constant current, and an inhom ogeneous equilibrium state (29), which does not contribute to the current. W hereas n(x) is positive everywhere within the channel, the complete distribution  $f_{a=0}(x;v)$  is not positive de nite. For example, when  $_1 < _r$ ,  $f_{a=0}(x;v)$  turns negative for su ciently large velocities and thus loses its physical meaning. Hence it seems that a physically acceptable inhom ogeneous stationary state cannot be obtained from the FP equation.

Notice that one can de ne a characteristic velocity L, associated with the nite length channel: ions with velocities larger than this will cover the length of the channel in a time interval which is shorter than the FP therm alization time <sup>1</sup>. It turns out that when v < L the distribution function  $f_{a=0}(x;v) > 0$ , and so the di culty appears only for velocities larger than L.C learly, when the friction coe cient is large enough the unphysical region is quantitatively irrelevant because of the negligibly sm all probability weight com ing from the M axwell distribution. From a fundamental point of view, how – ever, the solution (B7) demonstrates that the FP equation is incompatible with the boundary conditions (27) for a channel of nite length.

# APPENDIX C

In this section, we describe the solution of the kinetic equation (43), for ions owing through a channel under the in uence of a uniform accelerating eld, a Fokker-Planck friction mechanism and stopping traps distributed on average uniform ly, in the limit where the channel is in nitely long and the problem is spatially hom ogeneous.

The integration constant C on the rh.s. of this relation is determined by the boundary condition  $\lim_{u \ge -1} F(u) = 0$ , which shows that
