A bstract

The purpose of this short paper dedicated to the 60th anniversary of Prof.C on stantin T sallis is to show how the use of mathematical tools and physical concepts introduced by Burr, Levy and T sallis open a new line of analysis of the old problem of non-D ebye decay and universality of relaxation. We also show how a nite characteristic time scale can be expressed in terms of a q-expectation using the concept of q-escort probability. The comparison with the Weron et al. probabilistic theory of relaxation leads to a better understanding of the stochastic properties underlying the T sallis entropy concept.

K ey words: T sallis entropy, non-D ebye relaxation, universality, Levy distributions.

1 Maximum entropy principle and probability distributions

M ost of the probability distributions used in natural, biological, social and econom ic sciences can be formally derived by maximizing the entropy with adequate constraints (maxS principle)[1].

A coording to the maxS principle, given some partial information about a random variable i.e. the know ledge of related macroscopic measurable quantities (macroscopic observables), one should choose for it the probability distribution that is consistent with that information but has otherwise a maximum uncertainty. In usual thermodynamics, the temperature is a macroscopic observable and the distribution functions are exponentials.

Quite generally, one maxim izes the Shannon-Boltzmann (S-B) entropy:

Both \lim its a and \lim ay be nite or in nite. The functions $g_i(x)$ whose expectation value have been usually considered [1] as constraints to build probability distributions are of the type

The maximum entropy probability density function (mepdf) depends on the choice of the limits of integration a and b and the functions $g_i(x)$ whose expectation values are prescribed.

One constructs the Lagrangian

and di erentiating with respect to f(x) the method of Lagrange multiliers leads to:

The factor C is a norm alization constant and the Lagrange param eters $_{i}$ are determined by using the constraints (3) When this cannot be achieved $\sin p \lg y$, the param eters $_{i}$ are param eters defined by the constraints. Most distributions derived from the constraints given in (3) posses nite second moments and hence belong to the domain of attraction of the normal distributions. Those which belong to the domain of attraction of the Levy (stable) distribution i.e. the Cauchy and the Pareto distributions are obtained with a characteristic Levy tail parameter (not to be confused with the exponent used in the constraints) defined by $Pr(_{i} xt) = x^{-1}Pr(_{i} t)$; in the range $1 < _{L} 2$:[1] indicating that only a nite expectation value (rst moment) can be defined.

The following example is relevant for non-Debye relaxations. If we derive the mepoff f(x) of the random variable X dended in the range (0;1) and if we maximize the S(B) entropy subject to the two constraints

using the Lagrange variational method, it can be shown easily that the following mepoff

maximizes the S-B-entropy [1] provided

In that case, if we chose $\langle x \rangle = 1$ as the natural scale of the problem the exponent is related to $\ln x$ as

The Weibull distribution function is given by

As it is well known the W eibull distribution which is used in m any physical problems exhibits a power law behavior F(x) = x for x ! 0: For < 1; The W illiams W atts formula (stretched exponential) used for decades to the non-D ebye relaxation function in the time domain [2].

2 Maxim ization with T sallis entropy

A generalization of the S-B entropy is appropriate when the phenomena (physical, biological, economical...) are described by distributions with a Levy characteristic parameter $_{\rm L}$ < 1: Here we will start from the T sallis non-extensive entropy

The function $f_q(x)$ is the so-called "escort" probability [3][4]. Both \lim its of integration a and b m ay be nite or in nite. To generalize what has been done with the standard S-B. entropy we can consider the constraints (3) using the generalized q-exponential and q-logarithm functions (q-constraints).

The mepoff depends on the choice of a and b and the functions whose expectation values are prescribed.

One constructs the Lagrangian

and di erentiating with respect to $f_q(x)$ one nds

The factors C_q are normalization constants and the Lagrange parameters $_{q;i}$ are determined by using the q-constraints (11). When this cannot be achieved simply, the parameters $_i$ are parameters dened by these constraints.

Here we will derive the mepdf $f_q(x)$ of the random variable X generalizing the two constraints (6) leading to the Weibull distribution

U sing the properties of $\ln_q(x)$ and $\exp_q(x)$, we obtain easily the generalization of the W eibull distribution as a generalized Pareto law (BurrX II: $B_{bx}(x) = 1 + x^b$) c , x > 0 [5][6]

which tends to (8) for q! 1: If the natural scale $\langle x \rangle_q = 1$; one can obtain for that case the following result:

If q! 1; $< \ln_q x >_q!$ which is the result (9) obtained for the W eibull distribution. For $\frac{2+1}{+1} < q < 2$ this distribution belongs to the domain of attraction of the one-sided Levy-stable law since we have

In the $\lim it q!$ 1; we recover the stretched exponential W illiam s-W atts formula.

3 Universality in non-Debye relaxation

This result can be used to represent non-Debye relaxation if we identify the random variable X with the macroscopic waiting time ~as de ned by Weron etal:[7][8][9]. We have:

The relaxation function (t) can be written as the survival probability of the non equilibrium initial state of the relaxing system. Its value is determined by the probability that the system as a whole will not make transition out of its original state until time t:

This expression has the form of one of the universal relaxation functions proposed in [7][8] as result of an elaborate study of the stochastic mechanisms underlying relaxation dynamics in non Debye complex systems.

The equivalence of the two formulas allows us to relate the parameter k with the non-extensive parameter q:

This relation was already derived in [10]. In the limit q! 1, we recover the stretched exponential Williams-Watts formula used to the time-domain relaxation data [11] [2].

The q-dependent scale parameter A which is related to the the peak frequency $!_p$ of the response function in the frequency domain is materials and q dependent and is now simply related to the escort probability average

and becomes the natural nite time scale in a physical system (for example the dipolar relaxation) which "choose" [7] the regime where the usual average of the waiting time is in nite i.e. =k 1:

We can write the response function

; $m = -k$ and $k = \frac{q-1}{2}$:

The h-m om ent of the BurnX II distribution diverges if m = =k < h:Therefore the expectation value of the random variable $^{\sim}$ diverges if m < 1 or $q > \frac{2+1}{1+}$.

In the case of dipolar system s, most of the empirical data for the power-law exponents n and m are in the range [0,1] and can be accounted for using the heavy-tailed BurrX II waiting-time distribution with =k 1 for which < $^{>}$ > = 1:

This presentation which avoids the usual weighted average of a D ebye response function over a relaxation time or relaxation rate distribution con rms the relation obtained between the empirical exponents n and m and the "fractal" exponent and the nonextensive exponent q derived by two of us [10] using more phenomenological arguments. In that model the cluster volume distribution was obtained from the max S_q principle and a "fractal" relation between the cluster volume and its relaxation time was assumed.

The BurnX II distribution can be obtained as a smooth mixture of Weibull distributions compounded with respect to a random scale parameter distributed with the gamma distribution [6]. Using this fact we can rewrite (25) as

is the generalized gam m a distribution with scale parameter k and form factor = 1 = k : [7]. It is however to be noticed that this procedure leads to a relaxation function with a A factor de ned as a usual (q = 1) expectation value. By contrast the max S_q principle allows to de ne A as a natural scale in a situation where the expectation value cannot be de ned.

4 Stochastic theory and T sallis entropy

The discussion of the equivalence of the two results obtained for the "universal" relaxation function (25) and (26) from the max S_q method and the W eron et al. stochastic theory [7][8] can lead to a better understanding of the stochastic properties underlying the T sallis entropy concept as well as its possible generalization for more complex spatio-tem poral dynamical systems.

The starting point is the observation of the fact that the relaxation function for the whole system is its survival probability is just the probability of its rst passage

The quantity $\tilde{\ }$ is a random relaxation rate corresponding to the whole (m acroscopic) system . The random relaxation rates $_{i,N}$ and random waiting times $_{i,N}$ are related to the relaxations of the local individual entities. N $_{i,N}$ is the number of total entities (atoms, molecules, dynamical clusters) able to relax, $_{N}$ is the number of relaxing entities participating electively in the relaxing process. It is important to notice that $_{N}$ can be a xed number or a random quantity.

The distribution of (38) can be approximated by the weak lim it

where a_N is the sequence of relevant normalizing constants. On the basis of limit theorems of probability theory, it is possible to dene the distribution of the limit (39) even if the distribution of the individual relaxation rates $a_{i,N}$ and the number of $a_{i,N}$ of entities participating electively in the relaxation process are known to a relatively limited extending.

The m acroscopic relaxing properties are clearly related to the probability distribution of the sum m and $^{\sim}$ (39) . In the case of a determ inistic xed number of relaxing entities, W eron etal. [7] [8] have demonstrated, using the extrem all value theorem , that if the $^{\sim}$ are distributed with a stretched exponential distribution, the only possible distribution for $^{\sim}$ is a one-sided stable Levy distribution with index 0 < < 1 and we have:

U sing an heuristic argum ent one can understand physically that if the sm allest local waiting time determines the macroscopic relaxation, this should correspond to the largest relaxation rate. It is not therefore surprising that the distribution dominated by the highest terms in (38) is for N! 1 the stable one-sided Levy distributions which has the property to be dominated asymptotically by the highest term [15] [14].

If the number $_{\rm N}$ is a random variable, the scale parameter is a random variable and the BurrX II distribution is obtained if the scale distribution is the generalized gamma distribution (34). It can be easily shown by random izing the scale parameter in (33) that

where F_{\sim} (b) is the M ittag-Le ler distribution. In that case \sim is a stable random variable and stochastic theory arguments show that this result is obtained if $_{\rm N}$ is distributed with a generalized negative binomial distribution [7].

5 Conclusions

In the case of non-D ebye relaxation, the short-range interactions, geometric and dynam ic correlations can be accounted for by maxim izing the S-B entropy with adequate constraints. The small clusters and short-time relaxation can be described by a stretched exponential relaxation function. The exponent

1 introduced in the constraints is a measure of the "non-idealness" of the relaxation processes at this scale (uctuations of the size and intra-cluster interactions). The system is extensive in the fractal time domain to and the distribution of the relaxation rates () is heavy-tailed with a Levy tailexponent equal to :

Larger clusters relaxation and long time power law relaxation can be obtained by the maxSq principle and depends on the exponent = k with k = $\frac{q-1}{2}$. The

q non-extensivity param eter and the heavy tail properties of the waiting-time () distribution are directly related to the random number of relaxing entities at the meso-or microscopic level which gives rise to uctuations of the usual extensive (i.e. corresponding to exponential distributions) time scale. In that sense the T sallis entropy can be viewed as a technique to de neal nite macroscopic scale when the number of entities participating to the spatio-tem poral dynamical process is statistically uctuating due to natural geometric and dynamical constraints. That scale can be de ned as a q-expectation value using the concept of escort probability. This situation is typical of "frustrated" systems like glasses, polymers and porous materials.

A lthough our discussion has been limited to dipolar relaxation, our conclusions are relevant to a great number of non-exponential decay phenomena observed in nature [16][17].
