# V iscosity of Suspensions of H ard and Soft Spheres

From a reanalysis of the published literature, the low-shear viscosity of suspensions of hard spheres is shown to have a dynam ic crossover in its concentration dependence, from a stretched exponential at lower concentrations to a power law at elevated concentrations. The crossover is sharp, with no transition region in which neither form applies, and occurs at a volum e fraction (ca. 0.41) and relative viscosity (ca. 11) well below the sphere volum e fraction and relative viscosity (0.494, 49, respectively) of the lower phase boundary of the hard sphere melting transition. For soft spheres { taking many-arm starpolymers as a model { with increasing sphere hardness () shows a crossover from random -coil polymer behavior tow ard the behavior shown by true hard spheres.

### I. IN TRODUCTION

An interesting theme in modern physics is the ow of granular preparations. While there is much interest in the ow of dry particulates (the 'sandpile' problem), an important issue in materials processing is the ow of solutions or suspensions of spherical or near-spherical particles. Solution ows are subject to rheological constraints, the simplest being the low-shear viscosity of the solution. depends very strongly on particle concentration. If an accurate functional form for the concentration dependence of were available, one could predict

at an arbitrary concentration via interpolation from a small number of precise measurements.

Theoretical treatments of of hard sphere suspensions at elevated make a range of predictions. Jones, et al.[1] note results of Russell, et al.[2], but this treatment underestimates for > 0:4. de Schepper, et al.[3] show agreem ent between measurem ents of and a theoretical treatm ent of de Schepper, et al.[4]. How ever, Ref. [4]'s treatm ent ignores solvent-m ediated hydrodynam ic interactions, so its relevance to the dynam ics of a hard-sphere suspension is not transparent. A Itenberger and D ahler [5] use the positive-function renorm alization group [6] to extrapolate from a low-concentration series, obtained from a hydrodynam icm odel, to elevated . W ith reasonable values for input param eters, the Altenberger-Dahler calculation works well for < 0.3, but gives an that increases much too slow ly with increasing volum e fraction for > 0:5.

It was recently demonstrated in a short note [7] for data [8, 9, 10] on polym ethylm ethacrylate spheres in cisdecalin and other organic solvents that the viscosity of a hard sphere suspension has an accurate functional approximant. At lower ( < 0:42) concentrations, one nds a stretched exponential

while at higher ( > 0:42) concentrations a power law

describes m easurements well. Here is the volume fraction of spheres, is a scaling prefactor, and x are scaling exponents, and  $_{0}$  and  $_{1}$  are prefactors with units of viscosity. For hard spheres, = 1.0 is unattainable; for hard spheres  $_{1}$  is therefore not the solution viscosity under physical circum stances. As seen in ref. [7], the transition between these two forms is sharp, with no signi cant crossover regime in which neither form is valid. This paper represents a substantial extension of the original note [7].

This paper explores the range of validity of eqs. 1 and 2. As shown below, these forms describe well the viscosity of a far wider range of system s and concentrations than reported in the preliminary note of ref. [7]. Particles considered here extend in size upwards from micelles or protein molecules, with concentrations ranging from near-dilute to the random packing limit. Some particles, such as silica nanospheres, are virtually incompressible; other particles are soft, permitting particle centers to approach to substantially less than twice the particle radius.

### II. BACKGROUND

Interpretation of experim entaldata on hard sphere suspensions arises in the stinstance from equilibrium statisticalm echanics. C lose-packed hard spheres have a volum e fraction  $_{cp} > 0.7$ , but random close-packed system s generally attain volum e fractions no greater than a nom inal lim it r 0:64. Hoover and Ree [11] interpret their com puter sim ulations as im plying (1) suspensions of neum = 0.494 are single (m elttralhard spheres having like) phase uids, (2) hard spheres having <sub>s</sub> = 0:55 occupy an expanded solidlike phase, and (3) at interm ediate volum e fractions m s the hard sphere system has an order-disorder transition, with an equilibrium between phases having volume fractions m and s. Hoover and Ree's interpretation requires that equilibrium hard sphere suspensions with 0:494 0:55 are biphasic.

The concentration-dependent low-shear viscosity of hard sphere suspensions has been measured by a variety of authors, including Jones, et al.[1], Segre, et al.[8], Phan, et al.[9], Meeker, et al.[10], Cheng and Schachm an [12], Marshall and Zukowski[13], van der W er and de K nui [14], and de K nuif, et al.[15]. These references are not in precise num erical agreem ent, perhaps because at large theological properties are sensitive to sm all deviations of the suspended particles from perfect m onodispersity and sphericity, and perhaps because sm allernors in determ ining lead to a large scatter in measured values of at a given nom inal . Most of these results involve nom ore than a few hundred tim es the solvent viscosity s.

Phenom enologically, at low concentrations the zeroshear viscosity of a hard sphere suspension can be described by a pseudovirial approxim ant

where  $k_i$  are expansion coe cients. Cheng and Schachmann[12] con med the classic result  $k_i = 2.5$  of E instein for 260 nm diam eterpolystyrene spheres in 0.098 M NaCl. They were unable to determ ine  $k_2$  unequivocally.

The viscosity of a hard-sphere solution increases markedly with increasing sphere concentration. Data in refs. [8]-[10] refer only to the meltlike phase m, but other references attained higher concentrations. The recent and extrem ely thorough studies of P han, et al.[9] and M eeker, et al.[10], both inform ed by the discussion between de Schepper, et al.[3] and Segre, et al.[16], nd = 45 3 and = 53 6, respectively, at volume fraction m = 0:494. M arshall and Zukow ski[13] report =  $_{s}$  1 10 at 0:6.

R oovers[17] provides extensive data on the viscosity of a m odel soft-sphere system, namely solutions of m anyarm ed polybutadiene star polym ers whose e ective hardness is m odulated by changing the num ber of arm s. The above references constitute a rheological phenom enology that can be com pared with theoretical predictions.

Interesting, related results that go beyond the scope of this paper include studies on the frequency-dependent linear viscoelastic behavior of hard sphere suspensions by van der W er , et al. [18] and on the rheology of zeroth-tosixth generation dendrimers by Uppuluri, et al.[19]. At elevated concentrations, shear thinning sets in at high shear rates \_. M arshall and Zukow ski[13] report shear thinning for spheres of diam eters 90, 210, and 286 nm above 02. Jones, et al.[1] record shear thinning for 50 nm spheres for > 0:3.W ith 301 nm spheres, Segre, et al.[8] observe shear thinning above 0:4. There is thus no obvious correlation between sphere radius and the concentration for the onset of shear thinning, consistent with expectations for hard sphere system s. M arshall and Zukow ski[13] report that for > 0:5 there is a m arked increase in the characteristic tim e scale for shear thinning, while for > 0.56 at elevated \_ shear thinning is replaced by shear thickening. How ever, shear thicken-




FIG.1: V iscosity [20] of 1M D a hydroxypropy bellu lose: water as a function of concentration, and ts to a low-concentration stretched exponential regim e (sm ooth curve, eq 1) and a highconcentration power-law regim e (straight line, eq 2).


ing was not observed by Jones et al.[1]. Jones, et al.[1] note that near the random -close-packed lim iting concentration their systems gained a non-zero yield stress, with the elastic modulus satisfying  $G^{0}(!)$  ! <sup>0</sup> at higher volume fractions.

### III. RATIONALE

The conjectured form for the concentration dependence of of a hard-sphere suspension, as successfully tested in ref. [7], arose from two sources. First, the form works empirically [20]-[24] to high precision in certain other complex uids involving the same fundam ental forces but having non-spherical particles. Second, an ansatz leading to the form and other results has been found on the basis of renorm alization group concepts [25].

Representative empirical data providing a rationale for the conjecture, namely measurements of Quinlan, et al.[20] on of high-molecular-weight hydroxypropyloellulose solutions, appear in Figure 1. The viscosity has a bifunctional concentration dependence, with two concentration regimes and a sharp crossover concentration. At low concentrations, follows eq. 1, while at higher concentrations the power law of eq. 2 is followed. The crossover from stretched-exponential to power-law behavior occurs at a well-de ned concentration <sup>+</sup>, with no indication near <sup>+</sup> of a crossover regime separating the stretched-exponential and power-law regimes.

This bifunctional concentration dependence of is not






FIG. 2: V iscosity of 205 nm sterically stabilized silica spheres, after ref [13], and ts to eqs 1 (sm ooth curve) and 2 (straight line) using parameters in Table I.

unique to hydroxypropylcellulose solutions. Lin, et al.[21] had previously reported that () in high-molecular-weight polyacrylic acid solutions had the same bifunctional concentration dependence. Similar transitions have since been identi ed [22, 23, 24] in data on some but not all solutions of high-molecular-weight polymers. The crossover concentration  $^+$  is not a uniform multiple of the intrinsic viscosity []. In di erent system s,  $^+$  variously appears[22, 23, 24] in the range 4  $^+$  [] 150, or not at all.

This author [25] has previously advanced a rationale for the observed concentration dependence of . The rationale appears as part of a larger ansatz that correctly [25, 26] predicts the frequency dependence of the loss and storage moduli of a polymer solution over a full range of frequencies. Ref. [25] proposed that the concentration dependence of out to high concentrations can be determ ined by applying the A Itenberger-D ahler Positive Function Renorm alization G roup [5] m ethod to the known lower-concentration series expansion for . The functional form of () is determined by the dominant xed point of the renorm alization group at each concentration , leading autom atically to a low-concentration stretched-exponential concentration dependence arising from a xed point at = 0 and a possible power-law concentration dependence at larger concentrations corresponding to a large-concentration xed point.

Polymer solutions are, of course, not identical to solutions of spherical colloids. However, the factor most likely to militate against the validity of the ansatz of ref. [25] for polymers is the hypothesized transition from

hydrodynam ic-dom inated dynam ics to entanglem entdom inated dynam ics. This transition m ight happen in polym er solutions, but suspended colloids cannot form entanglem ents. The apparent success of the ansatz in polym er solutions does not prove that the ansatz will succeed in colloid solutions, but the most obvious reason for a failure of the ansatz refers to polym er system s, where the ansatz appears to succeed.

## IV. HARD SPHERE SUSPENSIONS

A literature search uncovered an extensive series of studies reported below. Functional ts to the reported data were made to eqs. 1 and 2 using non-linear least squares based on the simplex algorithm. Most papers actually reported the reduced viscosity r = s rather than directly, so 。 1 often follows from ts to eq 1. M arshalland Zukow skistudied [13] sterically stabilized silica spheres, diam eters 82, 205, and 288 nm suspended in decalin, using a C ouette double concentric cylinder geom etry for sphere volum e fractions up to 0.592 and viscosities =  $_{s}$  up to alm ost  $10^{9}$ . M arshall and Zukow ski's results on the 82 and 288 nm spheres were con ned to the high-concentration power-law regime; the 288 nm data have a single point below the power-law regime. Figure 2 shows results on the 205 nm spheres, together with

ts of the low er and upper concentration regions to eqs 1 and 2, respectively. Fitting parameters appear in Table I. The proposed concentration dependences are seen from the Figure to describe each region well. Because the power-law line is so steep, even very sm all experimental errors in the concentrations lead to the large RMS fractional error reported for the t.

Jones, et al.[1] m easured the viscosity of 49-54 nm diam eter silica spheres (di erent physical m ethods gave slightly di erent average diam eters for the spheres) in Shellsol T (Shell Co.), using Ubbelohde capillary viscom eters and three di erent cone and plate instrum ents for volum e fractions up to 0.635 and relative viscosities as large as  $92 \quad 10^4$ . Figure 3 presents their results and ts to our equations. A s seen in Figure 3, shows a stretched-exponential concentration dependence up to

0:45 with a fractional RM S error of 1.3%, and a power-law concentration dependence for concentrations greater than approximately 0.55. In contrast to Figure 2, for 0:45 0:55 a transition regime is apparent in Figure 3: Several points do not quite lie on the lines describing the two functional form s.

A qualitative di erence between Figs. 1 and 3 and thus between polymer chains and hard spheres is seen in the relative position of the stretched-exponential and power-law curves. For a polymer solution (Figure 1) in the power-law regime the measured viscosities consistently lie below the viscosities predicted by extrapolating the stretched-exponential curve. For a sphere suspension (Figure 3) in the power-law regime the measured viscosities lie above the extrapolated stretched-exponential curve. In sphere suspensions, thus increases smoothly until the crossover. A bove the crossover the viscosity increases suddenly, far more steeply than expected from





FIG. 4: V is cosity of (a) 56nm and (b) 230 nm sterically stabilized silical spheres in decalin, after ref [14]. O ther details as in Fig 2.

() below the crossover. For polymers (Figure 1) the crossover between the stretched-exponential and powerlaw regimes is analytic (rst derivative continuous). For hard spheres (Figure 3) the rst derivative is not obviously continuous through the crossover.

van der W er , et al[14] m easured steady-shear viscosities of m onodisperse silica dispersions of diam eters 56, 94, 153, and ca.230 nm in cyclohexane, using an Ubbelohde capillary viscom eter as well as a rheom eter with C ouette and parallel-plate m easuring cells. Figures 4a and 4b show their results for the smallest and largest spheres, together with the tted curves. Table I includes

t parameters for all four sphere sizes. RMS fractional errors in the ts were 2-7% for the stretched exponential regime, and in most cases 8-9% for the power law regime. In Fig 4a, data points appear almost exactly at the intersection of the two curves. In these systems the crossover region between the two regimes, if any, must be extremely sm all.

D eK nuif, et al.[15] m easured shear stress against shear rate for 156 nm silica spheres in cyclohexane at volum e fractions 0.0006 0.6 and viscosities 200  $_{\rm s}$ . Their m easurem ents were con ned alm ost entirely to the stretched-exponential regim e. Fitting parameters appear in Table I.

Segre et al.[8] report the low -shear viscosity (obtained with a concentric-cylinder viscom eter) and di usion coe cient (from quasi-elastic light scattering) of 356 and 602 nm diam eter polym ethylm ethacrylate spheres in cis-

decalin. Phan, et al.[9] and Meeker, et al.[10] studied of 518 and 640 nm, and 602nm diameter, respectively, polym ethylm ethacrylate spheres in various solvents. These data have previously been analyzed in ref. [7]. Fitting param eters are included in Table I. These papers, which con ned them selves to concentrations  $_{\rm m}$  , found distinct stretched-exponential and power law regimes, the transition occurring at 0:41 0:43 and 10 15. The transition concentration is subr stantially less than  $\ _{\rm m}$  . The di erences between the sets of thing parameters appears to reect limits on measure-






FIG.5: D ata of Segre, et al.[B] on sterically-stabilized 602 nm polym ethylm ethacrylate spheres in cis-decalin. O ther details as in Fig 2.

m ent accuracy.

## V. SOFT SPHERE SYSTEM S

The above results refer to spheres that are e ectively non-deform able under the experim ental conditions cited. A comparison with properties of deform able spheres is allowed by the data of Roovers[17] on solutions of 32-, 64-, 128-, and 270-arm polybutadiene star polymers. Roovers[17] determ ined viscosities with C annon-Ubbelohde viscom eters, using multiple size viscom eters and very long ow times, e.g., 1-2 hours, to con rm the absence of shear thinning. D ata were reported as a function of = , where is the overlap concentration dened to be = 0:4=[].

Roovers' stars had a variety of arm lengths and molecular weights 0:4 M 11:2 M D a. Figure 5 shows Roovers' data for ca. 3M D a stars; t parameters appear in Table I. Fits were also made to data on stars of the otherm olecular weights. Roovers demonstrates that at

xed reduced concentration and arm number is independent of star molecular weight. Correspondingly, when eqs 1 and 2, written as functions of = , are applied to Roovers' data, the resulting t parameters are largely independent of molecular weight.

In Figure 5, and number f increases from the lower-right-hand corner toward the upper-left-hand corner of the Figure. For 0.25, is nearly independent of f. At any larger concentration, of a 32-arm star is less than

of a 64-am star, which is in turn less than of a 128-




FIG.7: V iscosity [17] of f-am ed polybutadiene star polymers in toluene, for f of 32 (), 64 (), 128 (), and 270 (), together with ts to eq 1 and (for the 32-am stars) eq. 2. For the 32-am stars the power-law curve falls under the stretched-exponential curve. For star polymers with f > 32 the power-law curve would be superposed on the displayed stretched-exponential curves. For hard spheres, the power-law curve lies above the stretched-exponential curve, as seen in Figures 1-5.




FIG.8: a. and b. as function of arm number f, based on ts to data of R oovers [17], with hard sphere results (Table I) plotted at f = 500, showing () of 128- and 270-arm stars, as characterized by and , has reached the asymptotic hard-sphere limit.

arm star. At xed = , increasing the number of arms from 128 to 270 has no further e ect on , consistent with R oovers' interpretation that his materials have reached the lim it of large f.

In the lower concentration regime, and describe (). Figures 6a and 6b show and as functions of arm number. Points refer not only to the 3M D a stars of Fig.5 but also to Roovers' other starpolymers. nd for true hard spheres (Table I) are plotted in Fig.6 as having a nom inal arm number f = 500. For f = 128, and both increase with increasing f; for f = 128, and are both approximately independent of f. From Fig. 6, for < + not only do f = 128 and f = 270 stars reach an asymptotic limit, but the limit is the hard-sphere limit.

of a 32-arm star shows a clear large- power-law regime, separated from the stretched-exponential regime via a crossover near 0:5. The crossover to this regime resembles that seen in Figure 1 for a polymer solution; the crossover is smooth and the measured in the power-law regime is less than the extrapolated from the stretched-exponential regime. If to larger Roovers' 128- and 270-arm polymers had reached their hard-sphere lim it in their viscom etric properties, they would show a stretched-exponential to power-law transition near = 0:4. Indeed, ts for these stars for = > 0.5 to a power law obtain exponents x of 5.9 and 6.8. These exponents are slightly less than the exponents of 8-12 typical of true hard spheres, but are much larger 2 found for 32-arm stars. than the x

### VI. DISCUSSION

In the above, the published literature on of solutions of hard spheres was re-exam ined. As seen in Table I, in alm ost all cases eqs 1 and 2 describe () very well. In each set of data, a transition in the functional form of is seen. For < +, on a log-log plot () is a smooth curve with a continuously varying slope. Above +, on the same log-log plot () appears as a straight line of large and unvarying slope.

It has long been recognized that the viscosity of a hardsphere suspension increases very sharply at elevated concentration. In prior discussions it was not always noted that there is a qualitative change in the form of () when begins its sharp increase. This apparent qualitative change in the functional form of () explains the observations of Jones, et al.[1], Russell, et al.[2], and A ltenberger and Dahler[5] that their low-volum e-fraction form s for () work for < 0:3 0:4, but fail badly when is taken to larger values.

Root-mean-square fractional errors in the ts are generally in the range 1-9%. For hard spheres, is consistently in the range 7-11, while is almost always between 1.4 and 1.8. The power-law exponent x is most offen around 10. No pronounced dependence on any of these parameters on sphere radius is apparent, consistent with expectations that particle size should enter only through the sphere volume fraction . Deviations from the proposed forms are seen in the high-concentration data of M arshall and Zukow ski[13] and Jones et al[1], in that their data scatters very substantially around the power law form.

Table I reports the crossover concentrations  $^+$  and crossover viscosities  $^+$  at which the stretchedexponential and power-law form s intersect. In most system s,  $^+$  is in the range 0.39-0.52, while 4:6  $^+_0$  18:3.

The transition in the concentration dependence of is not a dynam ic simply relection of the equilibrium phase boundary at  $_m$ . Phan, et al.[9] and Meeker, et al.[10] did precise measurements of () up to  $_m$ . On analysis, their data shows that the dynam ic transition occurs at  $^+$  0.42,  $^+$  10 12. Thus,  $^+$  is well below the carefully determined  $_m = 0.494$ , at which concentration 49, well above  $^+$  that we have determined. In alm ost all system s  $^+$  is in the range 8-18, well below the experimental ( $_m$ ).

W hile a system atic error in determ ining a ects the determ ination of  $^+$ , it has no e ect on  $^+$ . D isagreements between determ inations of  $^+$  thus cannot be related to di culties in determ ining . An alternative plausible explanation for the experimental variation in  $^+$  is that the crossover is sensitive to details of the interparticle potential, so that varying degrees of sphere polydispersity or non-sphericity a ect the crossover's location.

Severalphysical explanations for the apparent dynam ic crossover suggest them selves:

1) The crossoverm ight arise from a change in the static correlations in the system . While it appears that  $^+$  is less than the lower melting concentration  $_{\rm m}$ , dynamic e ects are typically more sensitive to three-body correlations than are static correlations. One cannot readily exclude the possibility that there are signic cant changes in g^{(3)}(r\_1;r\_2;r\_3) of hard spheres, as a precursor to the transition at =  $_{\rm m}$ , at some concentration such as  $^+$  that lies below  $_{\rm m}$ .

2) The crossover might result from additional dynamic correlations in the system at elevated . The offdiscussed form ation of sphere doublets in shear at large

would have this e ect. Such doublets could play the

same qualitative role in sphere viscosity that is played in some treatments of polymer viscosity by the transient tube of the reptation model. The doublets and the tube walls only appear at high concentration; each serves to obstruct lateralmotion of the translating species.

3) The crossoverm ight be a purely mathematical consequence of taking low -concentration interactions to high concentration. A Itenberger and Dahler [5, 6] have shown how a renormalization-group method can be used to calculate at elevated . Renormalization group methods involve series expansions around xed points. If a full renormalization group treatment of () were appropriate and if it had xed points at = 0 and also at elevated , then there would be a transition concentration at which one dom inant xed point replaces the other, for purely mathematical reasons.
