# C enter of $m$ ass rotation and vortices in an attractive B ose gas

#### Abstract

T he rotational properties of an attractively interacting B ose gas are studied using analytical and num ericalm ethods. W e study perturbatively the ground state phase space for weak interactions, and nd that in an anharm onic trap the rotational ground states are vortex or center of $m$ ass rotational states; the crossover line separating these two phases is calculated. W e further show that the $G$ ross $P$ itaevskii equation is a valid description of such a gas in the rotating fram $e$ and calculate num erically the phase space structure using this equation. It is found that the transition between vortex and center of $m$ ass rotation is gradual; firtherm ore the perturbative approach is valid only in an exceedingly sm all portion of phase space. We also present an intuitive picture of the physics involved in term s of correlated successive $m$ easurem ents for the œenter ofm ass state.


## I. INTRODUCTION

The rotationalproperties of atom in B ose condensed gases have been a m atter of intense scienti c interest recently. T hem ain role in these studies is played by vortioes, which are the $m$ anifestations of quantized circulation in the quantum gas in question. H ow ever, vortioes are by no $m$ eans the only possible rotational states.

By rotating a condensate in a harm onic trap with a certain frequency a vortex can be created; when rotating the condensate a bit faster a second vortex appears, and so

There is an upper $\lim$ 止, how ever, for the rotation frequency in a harm onic trap. This lim it is the trap frequency ! of the con ning trap, above which the center of $m$ ass of the condensate is destabilized [依]. Interesting physics has been done by the B oulder group w orking only slightly below this lim it [-్ָర-]. H aving prepared a condensate w ith a vortex lattice, atom sw ith low angularm om enta are then rem oved. R eaching the rotation rate $0: 95$ ! a m etastable giant vortex w ith a phase singularity on the order of 50 is observed.

O n the other hand, the trap lim it can be crossed if the trap is not purely harm onic but the potential has a quartic term also [Gַ]. T he steeper potentialm akes fast rotation possible and thus gives a tool to test theoreticalpredictions including m ultiply quantized vortiges [ī̄],
 studies have already been done at EN S [9̄ן ${ }_{[1}^{-1}$.

The rotation of a condensate in an anharm onic trap is especially interesting when the e ective interactions of the atom $s$ are attractive. It was shown by $W$ ilkin et al that for weak attractive interactions and a given angular mom entum, in the low est energy state the $m$ otion is carried by the center ofm ass (c.m.) [1"̄̄]. For this state the single-particle reduced density $m$ atrix has $m$ ore than one $m$ acroscopic eigenvalue in the laboratory reference of fram e. This $m$ ight indicate that the cm . rotational state is a fragm ented condensate, but actually, the state is B ose condensed if it is view ed in the c.m. fram e [1] 11$]$. U nfortunately, in a harm onic-oscillator trap this state is never therm odynam ically stable because the critical frequency for the excitation is equal to the frequency where the gas is destabilized. An anharm onic term in the trapping potential rem oves the instability and $m$ akes the state of c. $m$. rotation, as well as vortex states, attainable [1̄2̄].

In this paper we shall study the rotational states of an attractive zero tem perature B ose
gas con ned in an anharm onic trap. W e begin by discussing the nature of the relevant states ofm otion and perturbation theory in Sec. II. In Sec.inìi we discuss the validity of di erent equations ofm otion. The problem is approached w ithin the ordinary $G$ ross $P$ taevskii ( $G$ P ) $m$ ean eld theory in Sec. 'IVN. Section 捗' deals w th the correlation properties of the c. m . rotationalstate at the lim 进 ofsm allanharm onicity. C oncluding rem arks arem ade in Sec. $\bar{i}$ 근

## II. HAM ILTONIAN AND PERTURBATION THEORY

The H am iltonian for N atom s with binary s-wave interactions is
where the strength of the contact interaction $U_{0}=4 h^{2} a=m$ with the scattering length a which is here assum ed negative. The extemal eld $V$ consists of a cylindrically sym $m$ etric harm onic potential w ith a sm all quartic addition in the radial direction:

H ere the dim ensionless param eter describes the strength of the anharm onic term and the oscillator length $a_{\text {osc }}$ is de ned as $a_{\text {osc }}=(h=m!)^{1=2}$.

In Refs. tion energy perturbatively, in which case the $m$ any-body eigenstates are products ofnodeless harm onic-oscillator single-particle eigenstates. H ere we shall generalize this approach by including also the anharm onic potential $\overline{\underline{R}} \overline{\underline{Q}}]$. To this end, we rst pass to dim ensionless units, where lengths are scaled by $a_{o s c}$ and energies by h!. W e obtain

where we have de ned an e ective 2D interaction $g$ by integrating out the $z$-com ponent wave function to obtain $g=^{q} \overline{!_{z}=(2!)} a=a_{o s c}$ (this can be done because the radial-axial decoupling is exact in perturbation theory). In the attractive case, $g$ is negative. W e shall retain the symbols $r$, $H$ etc. for the dim ensionless quantities in this section, because no confusion can arise.

A general form for a m any-body state in two dim ensions is

where $\mathrm{mn}_{\mathrm{n}}(\mathrm{r})$ is the harm onic-oscillator single-particle eigenstate in two dim ensions $w$ ith angular $m$ om entum $m$ and radial quantum number $n$; only states $w$ ith $n=0$ participate in perturbation theory. In the unperturbed case $(=a=0)$, for a given total angular m om entum L all states which fullll $\mathrm{m}_{1}+:::+\mathrm{m}_{\mathrm{N}}=\mathrm{L}$ with all $\mathrm{m}_{\mathrm{j}} \quad 0$ (and have no radial nodes, i.e. $n=0$ ) are degenerate. Thus we have, in principle, to perform degenerate perturbation theory on a vast subspace of $H$ illbert space (the number of basis states is $\left.\left.(\mathbb{N}+\mathrm{L} \quad 1)!\mathbb{N}!\left(\begin{array}{ll}\mathrm{L} & 1\end{array}\right)!\right]\right)$. H ow ever, from physical argum ents and known exact results, we obtain guidance to what the relevant candidate states should be.

In the purely ham onic case with nite attractive interactions, the ground-state $m$ anybody wave function w ith angularm om entum $L$ and particle num ber $N$ was found to be hī 0 ]
$w$ here $z_{j}=x_{j}+i y_{j}$ are the particle coordinates. The quantity $w$ ithin parentheses is the c. m. coordinate; therefore, this wave function describes rotation of the c.m. as already $m$ entioned in the introductory paragraph. $W$ e consider this state as the idealc.m .rotational state.

W hen instead the anharm onicity is nonzero and the interactions vanish, it was show $n$ in Ref. [眊] that the ground state is the vortex state

which is just a B ose $\mp$ instein condensate containing an $m$-fold quantized vortex, thus having angular mom entum Nm . Vortex-array states do not come into question because they have a low er density on the average, and are therefore not favored by the attractive interaction.
 or anharm onicity are absent. In a m ore generalcontext wem ake the di erence betw een these states in term sof cylindrical sym $m$ etry. The vortex state is cylindrically sym $m$ etric and the ideal c. m. rotational state corresponds clearly to the nonsym $m$ etric case. Between these tw o states, how ever, there is a region of nonsym m etric cases, where the c.m. is in rotation although these states do not correspond to the idealc.m. rotational case of Eq. (5్) . The leading instability of the vortex state tow ards a nonsym m etric state was exam ined in $R$ ef. [ī̄]. W e include these cylindrically nonsym $m$ etric states into our general de nition of c.m. rotational states. O ther interpretations are possible, though, see [1] [i] $]$.
 interaction energies of the two states were calculated in R ef. [1] $\overline{1}]$ and am ount to

$T$ he absolute $m$ agnitude of the interaction energy in the vortex state is sm aller than that of the ideal c. m . state, and therefore the latter is favored by the attractive interactions (rem em ber that $\mathrm{g}<0$ ). The quartic energies, on the other hand, are proportional to

so that for equal angular $m$ om entum, the quartic energy of the vortex state is the low est.
In the vortex state the angularm om entum per particlem can only take on integer values. In contrast, in the ideal c. m . state, $\mathrm{q}=\mathrm{L}=\mathrm{N}$ is only quantized in quanta of $1=\mathrm{N}$, so when we pass to the in nite lim it $q$ is a continuous variable. At $x e d L$, it is easy to determ ine the boundary between the rotational phases: the ideal c.m. state is energetically favorable when

W e have discarded all term $\mathrm{s} O\left(\mathbb{N}^{1}\right)$. For $\mathrm{m}=\mathrm{q}=1$ the condition for c.m.rotation is $<\dot{g} \mathcal{N}$ and for faster rotation, the regin e where the ideal c. m . state is favorable is sm aller. Since the right-hand side of Eq. ( $(\underset{-1}{(9)}$ increases slow er than the left-hand side as $m$ increases, we conclude that for any given pair of param eters ( $; q \mathrm{~N}$ ) , there exists a sm allest angularm om entum L above which a vortex state is favorable.

We now change variables and work at xed angular velocity rather than $x e d$. In the ideal c.m. state we can sim ply di erentiate the energy:

For given gN, and it can now be determ ined which of the states ${ }^{\mathrm{C}}$ and ${ }^{\mathrm{v}}$ has the lower energy. W hen ${\underset{\mathrm{C}}{2}}_{\mathrm{v}}^{2}<\mathrm{C}_{\mathrm{C} 2}^{\mathrm{v}}$, we nd that the idealc.m. state is favorable if the follow ing equivalent conditions hold:

If
 then the ideal c.m. state is the favorable one in the whole interval $\underset{\mathrm{c} 1}{\mathrm{v}} \ll \mathrm{C}_{2}$ but the vortex state $m$ ay be favorable for higher frequencies, as discussed above. To sum $m$ arize the dependencies: (1) a sm all anharm onic term favors the ideal c.m.rotation state; (2) a sm all interaction term $\dot{g} \neq N$ favors the vortex state; (3) a large angular velocity favors the vortex state.

## III. EQUATIONSOFMOTION

The perturbative approach has, naturally, a lim ited range of validity; as we shall see, it is in fact accurate only for very $m$ all values of $g N$ and. There is thus need for a m ore
generalschem e and we shallnow discuss what kind of approxim ation can be used to describe the attractive gas.

In a purely harm onic potential the center of $m$ ass $m$ otion decouples from the intemal m otion. This is not the case in an anharm onic trap, but there is still an approxim ate decoupling for weak anharm onicity. By taking advantage of this, and the fact that the intemalm otion is B ose condensed, coupled equations of $m$ otion for the $c . m$. and intemal $m$ otion were derived in Ref.

Here, the c.m. is described quantum mechanically by the wave function $c(\mathbb{R})$, and the B ose E instein condensed intemalm otion is govemed by the condensate wave function ( $r$ ), $w$ here $R$ is the $c . m$. coordinate and $r$ is the particle coordinate relative to the $c . m$. The e ective potentials for the center-ofm ass and relative $m$ otion are

where $h R^{2} i={ }^{R} N^{3} d R R^{2} j c(R) j$ and $h r^{2} i=N{ }^{1}{ }^{R} d r r^{2} j(r) j^{2}$ gives the coupling betw een the two w ave functions. These equations are capable of describing both the (ideal) state of c. $m$. rotation and vortex states and were used in $R$ ef. [ $[1 \overline{2} \overline{2}]$ to $n d$ the param eter regim es for those two states ofm otion. The perturbative results of $S e c$. II em erge from these equations in the lim it ! 0; gN ! 0 if N is assum ed large.

Here, we shall take an altemative path to describing the $m$ otion of the attractive gases. N am ely, we argue that the ordinary $G$ ross $P$ itaevskii equation [19] can be used to describe these rotating system s . The reason is sim ple: as shown in $R$ ef. [ is Bose E instein condensed according to an observer co-m oving with the c.m. Therefore, if we transform to a coordinate system $m$ oving with the $c . m$, we should be able to use the $G$ ross $P$ itaevskii equation. But if the cloud is in its ground state, under a rotational force w th frequency , the c. m . is also rotating w th the frequency and the coordinate transform ation is e ected sim ply by going to a rotating fram e as usual intin:

where $\hat{L}$ is the angular $m$ om entum operator. Solving the $G$ ross $P$ itaevskii equation in the rotating fram e should thus allow us to describe stationary states of the cloud, both in the vortex and the c.m.states. This result com es as a bit of a surprise, considering that in Ref. $\left[\begin{array}{ll}{[1]} \\ 1\end{array}\right]$ the c.m. state was found not to be Bose E instein condensed. W e note also that working at xed is the correct description of the com $m$ on experim ental approach of letting the cloud equilibrate under the in uence of a rotational drive.

C om pared w ith the tw o coupled wave equations (1] is $m$ ore general: it lifts the restriction of sm all values of ,so that rotationalm otion in any trap can be described as long as one can $m$ ove to a reference fram $e$ in which the $m$ otion is B ose E instein condensed. On the other hand, the GPE approach describes the c.m .m otion classically instead of quantum $m$ echanically, but this is hardly an issue unless one $w$ ishes to speci cally study the quantum uctuations in the c.m.m otion. The quantum mechanical c. m . m otion w ill be illustrated in Sec.

IV . NUMERICALSIM ULATIONS

A s we argued in the preceeding section, the attractive B ose gas is well described by the single com ponent $G$ ross $P$ traevsk ii equation in a fram e rotating $w$ th frequency ,

To solve this num erically for the anharm onic potential of Eq. ( $\overline{\operatorname{G}})$, we choose $=0: 15$, $\mathrm{N}=1000,!=2 \quad 30 \mathrm{~Hz}!_{\mathrm{z}}=2 \quad 180 \mathrm{~Hz}$ and them ass of atom ic Li. For the harm onic trap frequency m uch stronger in $z$-direction, we $m$ ay assum $e$ the $m$ otion in this direction to be frozen in the ground state of the trap and the problem becom es two-dim ensional. The ground state is now found by num erically propagating the tim e-dependent counterpart of Eq. ( $(\underline{2} \overline{0})$ in im aginary tim e. The grid size varies from $128 \quad 128$ points up to 256256.

W ith the xed param eters $m$ entioned above, we $m$ ap the ground state phase-space w ith respect to the rotational frequency and the scattering length. T he resulting phase-space diagram is plotted in $F$ ig. '1 1.1 . The result of the decoupling approxim ation, Eqs. ( w ith a G aussian ansatz for the density is nonrotating below $=!$ 1:2. The cloud just stays at the bottom of the trap $w$ ith angular $m$ om entum $L=0$ (w ithin the num erical uncertainty). A s the rotation frequency is
increased the ground state depends on the interaction strength. For weak interactions the angularm om entum $L=N$ is quantized in integer values that increase w ith rotation frequency. The ground state is a (multiply) quantized vortex (see Fig. '(2ָi). On the contrary, stronger interactions break the rotational sym $m$ etry. The circulation is not quantized anym ore and
 con guration corresponds to the c.m.rotational state. For even stronger interactions, the density becom esm ore concentrated and the cloud attains an approxim ately ellipsoidalshape residing $\circ$ center.

Interestingly, the coupled equations ofm otion (15ing the wave function into c.m. and intemal parts, fail to describe the elongated shapes that the cloud attains form oderately strong attraction. The assum ptions behind those equations im ply, nam ely, cylindrical sym $m$ etry of the condensate wave function. The factorization ansatz thus fails precisely in the situation when the quartic potential has a strong e ect on the shape of the cloud, ie., when we are close to the phase boundary.

From the perturbative $m$ ethod we have an expression for $q=L=N$ in Eq. ( $1 \overline{1} \overline{0}$ ) as a function of and. We perform a com parison between this simple perturbative formula for the ideal c.m. state and the GP procedure by choosing the set of these pairs (; ) to be such that $q=1$. In $F$ ig. ${ }^{\text {G }}$ we plot the results from the GP simulations for the angular m om entum per atom as a function of . $W$ hen the anharm onicity gets sm aller $q$ seem $s$ to approach unity. Still, for the given param eter range the di erence betw een num erical and perturbative results is clear. This is som ew hat unexpected, so to verify the num erical results we also plot the corresponding values of $q$ for $G$ aussian trial wave functions in the coupled Eqs. (1] 1 perturbation theory can only be trusted in an extrem ely sm all portion of phase space.

That the anharm onic trapping potential is essential for stabilizing these states ofm otion can be seen from the follow ing argum ent. T he e ective potential seen by the rotating atom $s$ is the sum of the actualpotentialV ( $\mathrm{r} ; \quad ; \mathrm{z}$ ) and the centrifugal term :

For slow rotation, < ! , the prefactor of the $r^{2}$ term is positive and the e ective potential is just a m ore shallow anham onic potential. In that regim e there is no rotation for the attractive gas. For rotation faster than the trap frequency, how ever, the e ective potential

attains a M exican-hat shape and the ground-state density distribution lies along the bottom of this toroidal potential. If the trap bottom is deep and the e ective trap $w$ idth is $s m$ all the condensate is con ned in an e ectively one-dim ensional torus which has been studied analytically in two recent articles [ī1], 1 are found in this idealized geom etry, term ed the uniform-density state and the localized

density state (bright soliton). C learly, the uniform -density state can be identi ed w ith our vortex state, and the bright soliton $w$ th the $c . m$. state. The conclusion drawn from the GP analysis is thus that the crossover from vortex to cm . rotation is gradual, whereas the
 presented in Sec. 'III to the e ect that the GP equation provides a valid description of the gas, the correct conclusion is that the crossover is gradual. T his conclusion is supported by the exact ndings in the sim pli ed 1D m odel [1] approach can be ascribed to the fact that it is restricted to cylindrically sym $m$ etric density pro les and is thus unable to describe the elongated structures seen in Fig. $\bar{Z}$.

To check that the results are not speci c to two dim ensions, we have solved the GP equation in 3D also. B oth ground state con gurations are obtained in these sim ulations. As an exam ple we present a density plot of a c.m. state in Fig. $\overline{4}$. Unfortunately, the com putations are too tim e consum ing for a quantitative $m$ apping of the phase-space.

## V. CORRELATION ANALYSIS

It is instructive to visualize the dynam ics of the manyłoody wave function Eq. (5.1.) found by W ilkin et al. [1] $\overline{1}]$, to see the connection betw een the wave function and the result of the num ericalG rossP itaevskii calculations ( $F$ ig. $\left.{ }_{1} \overline{2}\right)$. W e therefore calculate the outcom e of tw o consecutive $m$ easurem ents, given by the correlation function

In this case, to $m$ in im ize the energy, the expansion ( $2 \overline{3} \overline{3}$ ) contains only term $s w$ here the radial quantum num ber $n_{r}$ is zero. $W$ e are interested in the dynam ics as a function of the polar angle $w$ th a xed distance $R$ from the center of the trap. Hence, we denote $z_{1}=R e^{i 1}$ and $z_{2}=R e^{i{ }_{2}}$. In addition we choose $t_{1}=0,1=0, t_{2}=t$ and $z_{2}=$. A fter doing some algebra, one gets

In the rst term $\mathrm{m}^{\infty} \mathrm{m}$ ust satisfy certain conditions, nam ely $\mathrm{m}^{\infty} \in \mathrm{m}, \mathrm{m}^{\infty} \in \mathrm{m}^{0}$ and $\mathrm{m}^{\infty} \in$ $m+m^{0} m^{\infty}$. By combining ( $\left.\overline{2} \bar{T}_{1}\right)$ and (2̄$\left.\overline{2}\right)$, we get a slightly com plicated expression for the correlation function (2̄2̄). To visualize, we plot an example in $F$ ig. 'i5y for $R=1$. The curves illustrate the conditional probabilities at two di erent values of $t$ when $N=6$ and $L=6$. As expected it describes a shape retaining a peaked structure $m$ oving clockw ise at an angular frequency $=$ ! (i. e. $=1$ in dim ensionless units).

## VI. CONCLUSIONS

In conclusion, we have studied the ground state properties of an attractively interacting zero tem perature B ose gas in the presence of an anharm onic trap and a rotational drive. The two di erent ground state con gurations, vortex and center of $m$ ass rotation were investigated at the lim it when both anharm onicity and interactions are weak. In this lim it, analytical conditions for these states to appear were obtained as functions of rotation frequency, anharm onicity and interaction strength. To go beyond the perturbation theory, we have dem onstrated that the ground state can be solved by using the ordinary G ross$P$ itaevskii equation co-rotating w ith the extemal drive. This treatm ent di ens from our previous work [1] $\overline{1}$ ] ] w here the coupled equations of $m$ otion were obtained by assum ing the $m$ any body wave function to be a product of a cm . wave function and a B ose condensed wave function of the $m$ otion relative to the $c m$. Here, we treat the $m$ otion of the $c m$. classically. T he G rossP itaevskii approach enables us to study any strength of the coupling or anharm onicity. W e note that the com parison between di erent approxim ative m ethods shows that the perturbation result is valid for only a very lim ited param eter range. The extension of the perturbative analysis perform ed in $R$ ef. 娮 $\overline{1} 4] m$ ay im prove the situation slightly. Finally, we have visualized the cm . dynam ics by studying the correlations of two consecutive m easurem ents.

The rotation of a B ose condensate w ith repulsive interactions in an anharm onic trap is already experim entally perform ed [9], ]. T he condensate was stirred w ith a laser in a trap

which was created by combining a harm onic $m$ agnetic potential with an optical potential of G aussian shape. In principle, by using a sim ilar technique for attractively interacting Bose gas one could be able to observe the rotational ground states we have studied. The possibility to tune scattering lengths with magnetic elds via Feshbach resonances ti-1, - ers another tool for probing the param eter space.
