Decoupling of orbital and spin degrees of freedom in Li_{1 x}N a_x N iO 2

In the Li_{1 x} N a_x N iO_2 solid solutions three di erent single phase regions exist: for x 0:9, for x 0:7 and for x 0:3. A lthough the interm ediate compound does not show the cooperative Jahn-Teller transition of N aN iO_2 , its magnetic properties remain very similar with, in particular, the low temperature 3D magnetic ordering. Therefore, the strong coupling between orbital and spin degrees of freedom, characteristic of other oxides like perovskites, and usually invoked to explain the absence of both long-range orbital and magnetic ordering in LiN iO_2 , does not to take place in these layered compounds with 90 super-exchange bonds. We also discuss the relevance of the O crystal eld splitting induced by the trigonal distortion, in generating AFM in-plane N i-N i interactions.

The interplay between orbital and spin degrees of freedom in transition metal (TM) oxides can yield peculiar magnetic structures and so is a subject under active research [1]. In this context, the absence of both long-range magnetic and orbital ordering in layered LiNiO₂, indeed clearly observed in isomorphic and isoelectronic NaNiO₂ [2, 3, 4], is especially puzzling. Recently there have been attempts to explain these curious di erent behaviours, but the situation is still unsettled. Most models [5, 6, 7, 8, 9] assume an in portant coupling between the spin and orbital states, considering that frustration or the particular orbital ordering in the triangular lattice of LiNiO2 inhibits the stabilization of a 3D m agnetic ordering. Here, our synthesis and study of intermediate Li_{1 x} Na_x NiO₂ compounds shows that the macroscopic Jahn-Teller (JT) transition observed in NaNiO $_2$ can be killed by a small amount of Li replacing Na ions. Paradoxically, the magnetic properties exhibited by Lidoped NaN iO $_2$ rem ain very close to those displayed by the pure N aN iO $_2$. Our experim ental observations support previous analysis [10] and recent theoretical calculations [11] showing that, in the 90 TM-O-TM systems, orbitals and spins are essentially decoupled. Departure from the ideal 90 angle, contribution from extra overlapings [9] or crystal eld splitting e ects [12] have been invoked to strengthen the coupling between spins and orbitals in these systems, but the results reported here indicate that those hypothesis are not appropriate in the case of LiNiO₂.

The $-N aFeO_2$ structure of LiN iO₂ has planes of N i m agnetic ions arranged in a triangular network. No long range magnetic ordering has been reported for this compound. The N i^{3^+} ions are in the low spin con guration ($f_{2g}^6 e_g^1$) with s= 1/2 on the doubly degenerate e_g level. The Goodenough-K anam ori-Anderson rules yield ferrom agnetic (FM) spin exchange couplings between nearest-neighbour N i ions in the same plane. The measured Curie-W eiss temperature indicates the predom inance of FM interactions. Interestingly, it has been recently pointed out [12] that the trigonal crystal

eld splitting of the 02p orbitals could induce also antiferrom agnetic (AFM) exchange integrals in the Ni planes. That would give a microscopic foundation for the coexistence of intra-layer FM and AFM couplings in LiNiO₂, as considered by some authors [9, 13]. Concerning the orbital occupation, no JT transition is observed.

On the other hand, N aN iO $_2$ undergoes a cooperative JT ordering of the N i³⁺ ions at 480K reducing its symmetry from rhom bohedral to monoclinic. It presents a long range AFM order below 20K [2, 3]. It has been then speculated that a di erent oxygen crystal eld splitting would inhibit these AFM in plane N iN i interactions in N aN iO $_2$, yielding its di erent magnetic properties [12].

We perform here a crystallographic and magnetic study of L1N iO₂, N aN iO₂ and the new Li_{0:3}N a_{0:7}N iO₂ [14]. Our main point is that samples with this intermediate composition do not undergo the JT transition of N aN iO₂, but keep a rhom bohedral structure like L1N iO₂ even at low temperature. In spite of this fact, they achieve the long range magnetic ordering of N aN iO₂. This shows the decoupling between orbital and spins for these oxides with 90 bonds. Furtherm ore, the quan-

It is not possible to synthesize single phase sam ples for arbitrary Li/Na ratio. As shown in Fig2 and reported by Matsumura et al.[14], the $LiNiO_2/NaNiO_2$ phase diagram contains 3 di erent single phase solid solution regions, in between which, two phase mixtures are observed. For x 0.3, the R3m -NaFeO₂ structure type of LiN iO₂ is found (R II phase), where Li, N i and O atom s occupy the 3a (0 0 0), 3b (0 0 1/2) and 6c (0 0 z 0.24) positions, respectively. For x 0.9, the monoclinic C2/m phase of NaNiO₂ is observed, with substitution of Li⁺ for Na⁺ ions. In this phase, the Na, Ni and O atoms occupy the 2d (0 1/2 1/2), 2a (0 0 0) and 4i (x 0.28 0 z 0.8) positions. In a small concentration range about x 0.8, a new rhom bohedral phase (RI phase) is obtained, which has the same structural arrangement as LiN iO2, but quite di erent cell parameters: the c/a ratio is 5.24 instead of 4.94 for LiNiO2. The exact cationic composition of this phase found both by Rietveld re nement of the x-ray data and atom ic absorption is Li_{0:30(1)}Na_{0:70(1)}. No structural phase transition could be detected by NPD for (Li_{0:3}N a_{0:7})N iO 2 down to 1.5K. Therefore, this phase remains rhom bohedral in this tem perature range and does not undergo a cooperative JT ordering. In this respect, it behaves like $LiNiO_2$ and not like NaNiO₂.

To better understand the magnetism of these com – pounds, it is interesting to compare the structural arrangements of the N iO $_2$ octahedral layers (Table I). The R 3m LiN iO $_2$ structure can be described by starting from the F-centered cubic N iO structure and replacing every




FIG .1: the trigonal distorted N iO $_6$ octahedra in L iN iO $_2$ with 0 -0 distances.

ti cation of the trigonal distortion in these 3 com pounds also allow us to discuss its relevance in generating in-plane AFM interactions in LiNiO₂, conjectured to suppress the magnetic ordering [12].

The products were obtained by classical hightem perature solid-state reaction. They were synthesized from Na₂O₂, NiO and LiOH H₂O powders. The starting materials were mixed in an argon atmosphere with a 10% excess of (Na+Li) to account for volatilization losses. The mixture was heated under owing oxygen at 680 C for 24h. Twelve samples with compositions $(L_{1/2} \times Na_x) \times D_2$ with 0 x 1 (x denotes the nom inal Na content) were prepared. Their cationic compositions were analyzed by atom ic absorption spectroscopy. The crystal structure was studied by x-ray powder di raction (XPD). In order to detect possible magnetic ordering, neutron powder di raction (NPD) data were collected down to 1.5K on the CRG-D1B instrument of the ILL. The x-ray and neutron di ractogram swere re ned by Rietveld technique using the Fullprof software [15].




FIG. 2: x-ray di ractogram s as a function of the nom inal composition Li $_{\rm x}$ N ax N iO $_2$.

other N iplane perpendicular to one of the 3-fold axes by a Liplane, form ing NiO₂ edge-shared octahedral layers separated by Li[†] cations planes. This is accompanied by a trigonal distortion of the N iO 6 octahedra brought about by the di erence of charge and size between L1 and N i^{3+} cations. These octahedra are compressed along the caxis as shown in Fig.1. The six Ni-O distances remain equal (1.98A), but the six 0-0 distances linking oxygen anions from the plane above and below the Ni cation, called $d(0-0)_c$, become shorter (2.72A) than those in the ab plane, $d(0-0)_{ab}$ (2.87A). At the same time, the O-Ni-O angles between oxygen anions from the same plane above or below the Nication opens to 93.2, while the ones between oxygen anions from the two planes close down to 86.8 . This distortion can be characterized by the ratio $= d(0 - 0)_c/d(0 - 0)_{ab}$, and is 0.945 for LiN iO₂.

A lthough the structural arrangement is the same for $Li_{0:3}Na_{0:7}NiO_2$, the interatom ic distances and angles are markedly modi ed because of the steric e ect due to the large size di erence between Na^{\dagger} and Li^{\dagger} cations (ionic radius=1.02A and 0.76A). Due to charge balance, the 6 N i-O distances are almost unchanged (1.98A), but the 2 O -O distances and angles de ned above become 2.94A, 2.64A, 96.1 and 83.9, respectively. = 0.899, indicates a much stronger trigonal distortion than for LiN iO₂.

Very similar Ni+O and O-O distances and O-Ni+O angles can be calculated in the isostructural high tem perature form of NaNiO2 from the NPD data of Chappel et al. [4] (at 565K:NiO : 6x1.98A; O-O : 6x2.96A, = 0.899 ; O-NiO : 6x96.8 , 6x83.2). At 6x2.63A, room temperature, in the monoclinic phase, the N iO $_6$ octahedra becom e JT distorted: 4 N i-O distances becom e shorter (1.93A) and 2 longer (2.17A). The average 0-0 distances becomed (0-0) $_{\rm c}$ ' 2.72 (0.1)A , and d (0 - O_{ab} ' 2.96(0.1)A, and the average O -N i-O angles ' 95 and '85. The same ratio can still be used to evaluate the trigonal distortion: = 0.919. By comparing these values with those of (L $i_{0:3} N \: a_{0:7}) N$ iO $_2$, one can conclude that in monoclinic NaNiO₂, the JT distortion is superim posed on the trigonal one without markedly changing the amplitude of the latter.




FIG.3: inverse of the susceptibility vs tem perature, showing the Curie-W eiss behaviour.

Having in m ind that NaN iO₂ undergoes a collective JT transition, while LiN iO₂ as well as $Li_{0:3}Na_{0:7}N$ iO₂ do not, we perform now a comparative study of their m agnetic properties. The positive C urie-W eiss tem perature for all of them (Fig.3 and Table I) rejects the predom inance of FM interactions. The elective moment in all the high temperature orbitally disordered phases is nearly the same ('2.1 B) while it is smaller in the orbitally ordered phase of NaN iO₂ (1.85 B). Deviation from the free electron value (1.75 B) is enhanced in the orbital contribution to the N i^{3+} m agnetic moment.

The 3 compounds show a maximum in the susceptibility at low temperature: 20K for NaNiO₂, 25K for $L_{10:3}Na_{0:7}NiO_2$ and 9K for $LiNiO_2$. In fact, $LiNiO_2$ is never stoichiom etric: the exact formula be-




FIG. 4: eld dependence (top) and eld derivative of the magnetization (bottom) at 4K, showing the 3 characteristics elds. Inset: blow up of the low eld results for $Li_{0:3}Na_{0:7}NiO_2$.

ing Li, Ni,+ O2 win extra Niions in the Liplane. This gives rise to frustrated m agnetic interactions between the Niplanes and prevents any long range magnetic order yielding instead spin glass behaviour [16]. In NaNiO₂ and Li_{0:3}Na_{0:7}N iO₂ which are stoichiom etric (no N i ions are present in the Na/Liplanes), the eld dependence of the magnetization at 4K indicates long range magnetic order for both compositions (Figs.4a and b). NaNiO₂ is considered as an A type antiferrom agnet with FM Ni layers coupled AF below T_N ' 20K [2, 3, 4]. However our NPD measurements failed to detect such a simple magnetic structure, in spite of the adequate sensitivity of the D1B spectrom eter. A careful analysis of the magnetization data reveals indeed a more complex ordering: when taking its derivative as a function of the applied magnetic eld (Fig.4b), clearly 3 characteristic elds are present: H $_{\rm c0}$, H $_{\rm c1}$ and H $_{\rm sat}$ instead of 2 expected for an A type antiferrom agnet (H $_{c0}$, and H $_{sat}$) [17]. The same behaviour is observed in $Li_{0:3}Na_{0:7}NiO_2$, with H_{c0} , H_{c1} lowered and H_{sat} enhanced (Table I). Sim ilarly no m aqnetic di raction peak was detected by NPD.So, we can conclude that both NaNiO₂ and Li_{0:3}Na_{0:7}NiO₂ undergo the same long range magnetic transition, this is the relevant point for our discussion concerning the decoupling of the orbital and spin degrees of freedom in these systems.

In a rst approach, this common magnetic structure can still be described as an AF stacking of FM planes as previously proposed [2, 3, 4]. Then only H_{sat} and H_{c0} are relevant and we can estimate H_{sat} ' 2H_E and H_{c0} = H_{sf} ' $2H_E H_A$, where H_E is the AF exchange eld (between the Ni layers) and H_A the anisotropy eld which aligns the magnetic moment in a given direction [17]. Table I yields all these measured and calculated quantities. Note the signi cant decrease of H_A: while NaNiO₂ is an easy plane antiferrom agnet, Li_{0:3}Na_{0:7}NiO₂ is more isotropic. This can be well explained by the presence or absence of orbital order in these compounds: the magneto-crystalline anisotropy

arises from spin-orbit coupling; in NaNiO₂ orbital order insures the presence of preferred orientations for the magnetic moment, whereas in $\rm Li_{0:3}Na_{0:7}NiO_2$ the disordered orbital occupancy gives rise to isotropic probability for the spins orientation. From H $_{\rm E}$ we deduce the AF interaction $J_{\rm AF}$: -1.3K for NaNiO₂ and -1.9K for Li_{0:3}Na_{0:7}NiO₂. Using also the Curie-W eiss temperature, we calculate the FM interaction $J_{\rm F}$: +13.3K for the

form er, + 15.2K for the latter. Both interactions increase slightly from NaNiO₂ to $Li_{0:3}Na_{0:7}NiO_2$. J_{AF} arises from super-super-exchange NiO-O-Nibonds across the Niplanes, and J_F from 90 NiO-Niin-plane bonds explained before.

To sum marize, while $Li_{0:3}Na_{0:7}N$ iO $_2$ and N aN iO $_2$ have very di erent orbital ground state, they present a sim ilar magnetic ground state with similar exchange energies. The orbital contribution can only be seen in the value of the magnetic moment and the anisotropy eld associated with N i^{3+} ions. A though we cannot conclude about the orbital occupation in the Li containing compounds, $N a N i O_2$ can most probably be the spin model for the magnetic ground state of pure $L \ge 0_2$ [16]. The exact m agnetic structure of N aN iO $_{\rm 2}$, m ost likely a m odulated one derived from the A-type antiferrom agnet, rem ains to be determ ined but this is out of the scope of this paper. In the calculation of D are et al.[12] a large enough trigonal distortion can generate AFM interactions in the Ni planes in addition to the FM interactions. This param eterhasbeen quanti ed in our structural analysis: LiNiO2 has the lowest trigonal distortion (=0.945) compared to $Li_{0:3}Na_{0:7}NiO_2$ (0.899) and to $NaNiO_2$ (0.89 for the high tem perature orthorhom bic phase, 0.92 for the m onoclinic phase). Then this mechanism should lead to a stronger AF contribution in NaN iO 2 and Li_{0:3}Na_{0:7}N iO 2 than in LiNiO₂ while the opposite occurs according to the measured Curie-Weiss temperatures (Table I).

In conclusion, this crystallographic and m agnetic study shows that the interm ediate com pound $\text{Li}_{0:3}\text{N}a_{0:7}\text{N}iO_2$ has the same m agnetic behaviour as $\text{N}a\text{N}iO_2$ while its orbital behaviour is di erent: like $\text{L}i\text{N}iO_2$ it does not undergo a collective Jahn-Teller transition. So, these experimental results establish that the orbital and spin degrees of freedom are decoupled in these system s.
