Quantum Fluctuation-Induced Phase Transition in S = 1=2X Y -like H eisenberg Antiferrom agnets on the Triangular Lattice

The selection of the ground state among nearly degenerate states due to quantum uctuations is studied for the S = 1=2 XY -like H eisenberg antiferrom agnets on the triangular lattice in the magnetic eld applied along the hard axis, which was rst pointed out by N ikuni and Shiba. We nd that the selected ground state sensitively depends on the degree of the anisotropy and the magnitude of the magnetic eld. This dependence is similar to that in the corresponding classical model at nite temperatures where various types of eld induced phases appear due to the entropy e ect. It is also found that the similarity of the selected states in the classical and quantum models are not the case in a two-leg ladder lattice, although the lattice consists of triangles locally and the ground state of this lattice in the classical case is the sam e as that of the triangular lattice.

1. Introduction

The ordering process in triangular lattice antiferrom agnets has attracted much interest because the frustration among antiferrom agnetic interactions causes complicated order parameters. In such systems, various spin congurations are nearly degenerate. Among them one conguration is selected as a result of a very subtle balance of the energy and the entropy. At nite temperatures, a structure that is entropically favorable would be chosen even if it is less favorable in energy. In such cases, we have a phase transition between the entropically favorable ordered phase and an energetically favorable ordered phase. Indeed, such uctuation-induced phase transitions have been studied in the magnetization process of antiferrom agnets on the triangular lattice.¹⁽⁷⁾

A similar selection of the states occurs also for the ground state of a quantum triangular lattice antiferrom agnets at zero tem perature; the classical ground state is not necessarily

m ost stable and som e other con guration m ay becom e the ground state when a contribution of quantum uctuations to the energy is taken into account. Am ong nearly degenerate classical con gurations, a certain state is selected, where quantum uctuations play a role sim ilar to them al uctuations in the classical case at nite tem peratures. In particular, such exam ple was pointed out by N ikuni and Shiba⁸⁽¹¹⁾ to understand the ground state phase transition of C sC uC \lg .^{12,14)} T his m aterial has a hexagonal lattice consisting of layers of triangular antiferrom agnets with a weak X Y anisotropy and ferrom agnetic couplings between the layers. It has also been pointed out that RbFeC \lg has qualitatively the sam e structure, and a sim ilar phase diagram has been obtained.¹³⁾

In the classical spin m odel, the ground state of the X Y -like H eisenberg antiferrom agnet on the triangular lattice consists of the 120 structure. This structure of the ground state causes the so-called chiral phase transition due to its two-fold discrete degeneracy.¹⁵⁾ W hen the eld is applied in the z-direction, the 120 structure is folded to be a shape of um brella which is the m ost energetically favorable in the eld.(F ig.1(a)) Them agnetization increases proportionally to the eld strength up to the saturation. There is no singularity in the m agnetization process. However, a jump of the m agnetization was found in the experiment of C sC uC l₂. N ikuni and Shiba have pointed out that this jump is due to a phase transition in the ground state. The quantum correction on the ground state energy can cause a ground state phase transition. By com paring energies of the um brella structure and a coplanar structure depicted in (F ig. 1(b)) which we shall call V-shape' structure,^{8,9,11)} they found that the um brella structure is favorable at low eld while the v-shape structure is favorable at high eld. That is, although the latter has higher energy in the classical system, it has the low est energy if the quantum correction of the energy is taken into account.




Fig. 1. Candidates for the ground state con gurations: (a) um brella structure, (b) v-shape structure.(c) Y -shape structure, and (d) collinear ferrim agnetic structure.

Recently, W atarai et al.⁷⁾ have pointed out that the role of quantum uctuations in the above scenario for the quantum case is very similar to that of them all uctuations in the corresponding classical spin system at nite temperatures. Moreover they have shown on the basis of the detailed temperature – eld phase diagram of the classical system that the structure of the phase diagram s is sensitive to the degree of the anisotropy. That is, no phase transition occurs when the X Y anisotropy is strong, and the phase transition from the um brella structure to the v-shape phase occurs when the system has a moderate anisotropy. In the H eisenberg lim it, the system shows a qualitatively di erent sequence of phases from that of the case of the moderate XY anisotropy. In the H eisenberg system, the ground state is continuously degenerate.¹⁾ In the low – eld region a coplanar structure, which we shall call a Y -shape' structure becom es the most stable state as in the case of the XY -like H eisenberg model. Between the low and high eld phases, a collinear phase (Fig. 1(d)) is present, which leads to the 1=3 plateau in the magnetization process. When the XY anisotropy becom es very

weak, a complex sequence of phases appears including phases in both of the above two cases. Then, it is an interesting question how such sensitive anisotropy dependence in the classical model can relect on the corresponding quantum spin system with various XY anisotropy.

A lthough from a view point of the spin wave theory, quantum uctuations should cause an e ect similar to that of therm al uctuations,⁰ it is still interesting to see how it appears in strongly uctuating quantum systems. In this paper, we study whether similar phase structure with strong dependence on the anisotropy appears or not by investigation of the ground state properties in the magnetic eld by various numerical methods. In the case of three-leg ladder system, which well represents the triangular lattice, the dependence is certainly similar to those found in the corresponding classical systems at nite temperatures as the entropy e ect. We also study the dependence of the ground state on the lattice shape. In the classical system, the ground state con guration of all the lattices consisting of local triangles is an assembly of local ground state con guration of three spins representing the three sublattices of the triangular lattice. Thus, the ground state con gurations of those lattices have the sam e spin con guration. By contrast, the interaction in quantum systems is not local because of the non-commutativity among the spins, and the ground state con guration depends on the lattice shape even if they locally consist of the same triangles. In fact, we demonstrate such dependence in a two-leg ladder system.

In order to study the quantum ground state of the present model, we cannot apply the quantum M onte C arbo simulation because of the negative-sign problem. Therefore, in this paper, we adopt kinds of diagonalization m ethod, i.e., exact diagonalization m ethod for a nite lattice of sm all num ber of spins, the product wave-function renorm alization group (PW FRG) m ethod which is a variant of density m atrix renorm alization group (DMRG) m ethod.^{16,17)} PW FRG has been developed to study the m agnetization process in the ground state.¹⁶⁾ W e also use the DMRG m ethod for nite lattices which gives com plem entary data for those from PW FRG.

This paper is organized as follows. We explain the model studied in the present paper and order parameters in x2, where corresponding data in the classical model are also reviewed. In x3, the dependence of the ground state conguration on the anisotropy and on the external eld is studied in a mite lattice. In x4, the dependence is studied in a two-leg ladder system which is an assembly of triangles. In x5, properties on a three-leg ladder with the same periodicity as the triangular lattice is studied. In x6, sum mary and discussion are given.

2. M odel and O rder param eters

For the study of $C \le C \le L_3$, three-dimensional XY-like Heisenberg model has been adopted. In the classical model, the anisotropy is usually introduced by the single-ion anisotropy

where hiji denotes the interaction in a triangular layer. The interaction in the layer is antiferrom agnetic, i.e., $J_{ij} = J > 0$, while the interaction for the interlayer interaction is ferrom agnetic, i.e., $J_{ij} = J^0 < 0$. For simplicity we take $J^0 = -J$.

In the case of S = 1=2 quantum system, however, the single-ion anisotropy does not exist. Therefore, we adopt an isotropic coupling as a source of the anisotropy. In this paper, we study only two-dimensional systems because of the limit of the capacity of numerical calculation. The Ham iltonian is given by

where $S_i = \frac{1}{2}_i$; (= x; y and z) where i is the component of the Paulimatrix. The magnetization of the system is measured by

Low energy con gurations of the model (1) in the classical case is depicted in Figs.1, where the angles are respectively, given by

For the conguration Fig. 1(b), we have to calculate numerically. Comparing energies of the congurations, we not that the umbrella conguration (Fig. 1(a)) gives the minimum energy for A < 1, corresponding to D < 0 in the classical spin model (2.1).

In order to characterize the phases, we de ne the following order parameters. The unit cell in the ordered phases consists of three sublattices. First, we introduce the chirality: $^{15)}$

where i; j and k denote sites on a triangle consisting of the sublattices A, B, and C of the triangular lattice, respectively. The presence of the um brella structure can be identi ed by

m easuring the z component of the chirality.

In the v-shape structure, the spins on the two of sublattices are parallel, and thus the chirality disappears. In order to identify noncollinear ordering structures of the v-shape structure, we measure the follow ing quantities:

We de ne the following order parameter to detect the non-collinearity

where = x;y; and z, and N is the number of spins. In particular, we use an order parameter

to detect the v-shape structure when the eld is applied in the z direction.

If the con guration is of the um brella type, the order param eters

and S_{xy} are nonzero in the lim it N ! 1 .0 n the other hand, in the v-shape structure, K _z is zero while S_{xy} remains non-zero.

The xy component of the chirality is good to detect the Y-shape structure. Therefore, we also observe the following quantity:

This order parameter is non-zero in the Y-shape structure, but it is zero in the v-shape structure.




Fig. 2. The eld dependence of (a) $_{z}$ and (b) S_{xy} at T = 0.5 for the weakly XY -anisotropic case (D = 0.1). (c) $_{xy}$ and (d) S_{xy} at T = 0.5 for the Heisenberg model (D = 0). The symbols, circle, square, diam ond, and (closed) triangle denote the size L = 12, 18, 24, and 30, respectively. (from the reference⁷⁾)

For the classical model (2.1), we can perform M onte C arb simulations in large systems and determ ine the therm odynamic stable state. In Figs. 2, the eld-dependence of the chirality and S_{xy} of a weakly X Y -like H eisenberg model, i.e., D = J = 0.1, at temperature T = J = 0.5, are depicted. There, as the eld increases, the structure changes from the umbrella to the v-shape discontinuously and nally to the eld-induced ferrom agnetic state. The data for the H eisenberg model are also depicted in Figs. 2 (c) and (d).⁷⁾ There the structure changes from the Y-shape, collinear up-up-down, and the v-shape, and nally to the eld-induced ferrom agnetic state.

3. Observation on a nite lattice

For the present quantum systems, M onte Carlo simulation is not available because of the negative-sign problem. Thus, the most naive approach to study the ground state is a diagonalization of the H am iltonian of a nite lattice of sm all num ber of spins. In this section,




Fig. 3. (a) The nite lattice for the diagonalization study. The correlation functions of the order parameters are obtained at the quantities on the positions denoted by crosses. The eld dependence of (b) CK_z and (c) CK_{xy} , and (d) CS_{xy} as functions of the magnetization M. Symbols denote the data for various values of A: (A = 0.0), (0.1), (0.2), (0.3), (0.4), (0.5), 5 (0.6), 4 (0.7), 3 (0.8), 2 (0.9), and (1.0)

we study system s in a lattice of 3 6 w ith the periodic boundary condition depicted in Fig. 3(a). For the nite size lattice, we study the property of the state w ith a xed magnetization M instead of the magnetic eld H. The change of M corresponds to that of H because the magnetization of the ground state monotonically increases with the eld. W e note that, in Refs.^{18,19)} magnetization processes of the similar systems have been also studied for nite size and/or ladder lattices.

In a nite lattice, we investigate correlation functions of the quantities corresponding to the order parameters, because the expectation values of the order parameters them selves may vanish in the quantum ground state. Here we observe the correlation functions of the z-component of the chirality (C K_z), the xy-component of the chirality (C K_{xy}), and the xy-component of the vector product of spins de ned in (2.7) (C S_{xy}), at the sites denoted in

Fig. 3(a). CK $_z$; CK $_{xy}$, and CS $_{xy}$ are given by

where 1,2,3 and $1^{\circ},2^{\circ},3^{\circ}$ are the lattice sites of the triangles denoted by crosses. We plot $C K_z; C K_{xy}$ and $C S_{xy}$ as functions of the magnetization for various values of the anisotropic coupling A (A = 0;0:1; ;1) in Fig. 3(b), (c), and (d), respectively.




Fig. 4. Two-leg ladder consisting of triangles. The correlation functions of the order parameters are obtained at the quantities on the positions denoted by crosses.

We nd a qualitative sim ilar dependence of the order parameters to those in the classical models. That is, CK_z decreases with the magnetization M sm oothly for the case of strongly anisotropy (A = 0), where no transition occurs until the saturation eld H_{c0}.

W hen the system has weak anisotropy, e.g. A = 0.9, then $C K_z$ decreases suddenly at an interm ediate value of the magnetization M, although $C S_{xy}$ is still large. This case corresponds to the classical case depicted in Figs. 2(a) and Figs. 2(b). At the H eisenberg case (A = 1), instead of $C K_z$, $C K_{xy}$ appears at sm all magnetizations, and it disappears at an interm ediate

eld where the collinear up-up-down state appears. For larger M, another non-collinear state appears. These dependences agree with those in Figs. 2 (c) and Figs. 2 (d). Thus, the anisotropy and eld dependence of the ground state property is similar to that in the classical systems, although number of data points are limited because only the nite lattice is studied. In the next section, we study system s consisting of in nite number of triangles.

4. Observation on a ladder system consisting of triangles

In this section, we study a two-leg ladder system with zigzag structure, which consists of triangles depicted in Fig. 4. The Ham iltonian of this case is given by

Heisenberg antiferrom agnets with A = 1 in this type of lattice have been studied in detail as the M a jum dar-G hosh m odel.²¹⁾ There, various interesting properties, e.g., energy gap between the ground state and the rst excited state, and cusp singularities in the m agnetic process, have been found.²²⁾ Here, we study properties of the XY-like antiferrom agnets on this lattice (A < 1).For this type of one dimensional lattices, m ethods of the DM RG type are very e cient. Here, we study the m agnetization process by PW FRG and DM RG. As in the exact diagonalization for a nite size lattice, the expectation values of the order param eters them selves m ay vanish in the quantum case. W e, therefore, m easure the correlation functions C K_z and C S_{xy} between two triangles near the center of the ladder, which are indicated by




Fig. 5. The eld dependence of the magnetization m , CK $_z$ and CS $_{xy}$ as functions of the eld H for (a) A = 0:9, (b) A = 1:0 and (c) A = 0:0

symbols in Fig.4.

In Fig. 5(a), we depict the magnetization for A = 0.9 obtained by PW FRG. In the present study we use a block H am iltonian of the dimension m = 48. We have conmediated that the results converge up to this value of m. In the magnetization process, we make a zero magnetization region at low eld, which implies the existence of energy gap. This gap is due to the dimering elect that brings the M ajum dar-G hosh solution in the H eisenberg lim \pm^{21} . In Fig. 5(a), the correlation functions of the order parameters C K_z and C S_{xy} are also plotted. They behave very dimerally from those expected in the classical lattice. This may be due to the fact that the zigzag chain does not have the three sublattice structure in the rung direction. For example C K_z takes a negative value for A > 0, for which there is no classical analogue. Thus, in the next section we study a lattice which is more close to the triangular lattice.




Fig. 6. The eld dependence of (a) the magnetization m , (b) $C K_z$ and (c) $C S_{xy}$ as functions of the eld at A = 1 obtained by PW FRG and DM RG.

Before proceeding to the next section, here we make a comparison between the results for PW FRG and DMRG. In PW FRG, we obtain the magnitude of the magnetization for the given eld. On the other hand, in the DMRG procedure,¹⁷⁾ we obtain a ground state energy for given values of the magnetization from which we can obtain the magnetization curve as a function of the eld because the magnetization commutes with the Ham iltonian for the present model. Both methods should give the same results. In Figs. 6, we demonstrate that the PW FRG and DMRG results agree with each other by showing the quantities for the Majum dar-Ghosh model of L = 128 system obtained by the DMRG with m = 64. In the gure we take spatial averages of CK_z and CS_{xy} for the comparison with the PW FRG results, since CK_z and CS_{xy} in a nite size system show position depending behavior due to the open boundary. 


Fig. 7. The 3-leg ladder. The correlation functions of the order parameters are obtained at the quantitles on the positions denoted by crosses.

5. Three-leg triangular lattice




Fig. 8. Procedures of PW FRG

In this section, we perform PW FRG on a 3 1 lattice with the periodic boundary condition depicted in Fig. 7.W e expect that the model on this lattice reproduces well properties of the model on the triangular lattice. Since this lattice contains the minimum length of the unit cell of the triangular lattice both in the rung and leg directions. The unit cell of the order parameter is 3 3, and therefore it had better take this unit cell as a unit of the renorm alization process. However, it is di cult to perform this process because of the limitation of the memory. Thus, we take a 3 1 cell as a unit cell of the RG process. In Fig.8, the procedure of PW FRG is illustrated. When we renorm alize the block H am iltonian by one step, the sublattice structure of the center spins shifts by one site along the leg direction. In order to take account of this miss m atch of the periodicity, we set up three type of the block H am iltonian. N am ely, we perform alm ost the same computation three times and keep the consistency of the sublattice structure in the renorm alization process by rotating the block H am iltonians.




Fig. 9. The eld dependence of (a) the magnetization m, (b) CK_{xy} , (c) CK_z , and (d) CS_{xy} as functions of the eld H for the Heisenberg model A = 1:0.

In Fig.9, we depict the magnetization for A = 1:0. Here, we damagnetization with a




Fig. 10. The eld dependence of (a) the magnetization m, (b) CK_{xy} , (c) CK_z , and (d) CS_{xy} as functions of the eld H for the Heisenberg model A = 0.8.

plateau at 1=3 of the full m om ent, which is sim ilar to what we found in the classical m odel. Here we nd that the xy-component of the chirality decreases with the eld, and disappears at the 1/3 plateau. When the eld further increases, $C S_{xy}$ appears again. This observation is the same as those we found in the section 3. Here we also nd the relatively large z-component of the chirality. This m ay be due to the fact that we observe the local correlation function instead of the order parameter itself. When we reduce A to 0.8 (see in Fig.10), qualitatively sim ilar behavior is observed. It should be noted that, how ever, the plateau width decreases,




Fig. 11. The eld dependence of (a) the magnetization m, (b) CK_{xy} , (c) CK_z , and (d) CS_{xy} as functions of the eld H for the Heisenberg model A = 0:7.




Fig. 12. The eld dependence of (a) the magnetization m, (b) CK_{xy} , (c) CK_z , and (d) CS_{xy} as functions of the eld H for the H eisenberg m odel A = 0:6.

and the z-component of the chirality increases. For A = 0.7, we nd a low eld phase with z-component of the chirality and it changes discontinuously to a high eld phase of the noncollinear structure without chirality. (Fig.11) This is similar to what we found in the classical model with a weak XY anisotropy. We also nd that the plateau disappears and a jump appears instead of the plateau. (Fig.11(a)) The magnitude of the anisotropy at which the plateau disappears obtained in this study is close to that obtained by A. Honecher et al.²⁰⁾ (A = 0.76 0.03), which is the result of the exact diagonalization study up to 36 sites. As the anisotropy becomes stronger, the um brella structure is stabilized even in higher eld region. For large anisotropy (A = 0.6), we have no phase transition as the classical case. (Fig.12)




Fig. 13. The ground state phase diagram in the (A;H) coordinate. The solid circles represent the boundary of the um brella phase and non-collinear phase. The triangles represent the upper and low er edges of the 1/3 plateau.

Sum marizing the dependence of the eld-induced phases on the degree of an isotropy, we illustrate in Fig. 13 a phase diagram in the (A;H) coordinate. In this gure, we nd very sim ilar structure to that found in the classical model.⁷⁾ The boundary between the um brella phase to the Y-shape phase is not determ ined. For this determ ination we have to study which of _z or _{xy} dom inates by studying the distance dependence of the correlation functions, although so far we obtained only correlation functions between the triangles denoted by crosses in Fig. 7.

6. Sum m ary and D iscussion

From the present observations we found that the ground state of the S = 1=2 X Y -like H eisenberg antiferrom agnetic m odel depends on the anisotropy sensitively, where the ground state con guration is selected by the quantum correction. Then we found that the e ect of quantum uctuations in the ground state is very similar to that of therm all uctuations at nite tem peratures. In fact, the result for the three-leg ladder shows that the structure of the phase diagram (Fig.13) is very similar to that of the corresponding classical m odel. In the case of two-leg ladder, how ever, quantum uctuations cause a special property which has no classical counterpart. This kind of change of the e ect of quantum uctuations with the width of the lattice is also an interesting observation. W e note that the dimension of the quantum and therm all uctuations is an important future problem.

Recently, a material with spin-tube consisting of alternate triangles has been found; it has the same lattice as the 3-leg ladder lattice studied in the present paper (Fig.7).²³⁾ W e expect that the properties found in the present paper, such as the successive phase transitions and also their dependence on the spin anisotropy, will be observed in the variety of such materials experimentally.
