Relative in uences of disorder and of frustration on the glassy dynam ics in m agnetic system s

The magnetisation relaxations of three di erent types of geometrically frustrated magnetic system s have been studied with the same experimental procedures as previously used in spin glasses. The materials investigated are $Y_2M o_2O_7$ (pyrochlore system), SrC r_{8:6}G a_{3:4}O₁₉ (piled pairs of kagom e layers) and (H 30)Fe3 (SO 4)2 (O H)6 (arosite com pound). Despite a very sm all am ount of disorder, all the sam ples exhibit m any characteristic features of spin glass dynam ics below a freezing tem perature T_q , much smaller than their Curie-W eiss tem perature \cdot . The aging properties of their therm orem anent m agnetisation can be well accounted for by the sam e scaling law as in spin glasses and the values of the scaling exponents are very close. The elects of tem perature variations during aging have been speci cally investigated. In the pyroch bre and the bi-kagom e com pounds, a decrease of tem perature after som e waiting period at a certain tem perature Tp re-initialises aging and the evolution at the new tem perature is the same as if the system were just quenched from above T_q. However as the tem perature is heated back to T_p, the sam ple recovers the state it had previously reached at that tem perature. These features are known in spin glasses as rejuvenation and m em ory e ects. They are clear signatures of the spin glass dynam ics. In the kagom e com pound, there is also some rejuvenation and memory, but much larger tem perature changes are needed to observe the e ects. In that sense, the behavior of this com pound is quantitatively di erent from that of spin glasses.

It was usually thought that both disorder and frustration were necessary to obtain spin glass dynam ics (e.g.[1], [2], [3]). How ever, several frustrated but non-disordered antiferrom agnets, rather than condensing into a spin liguid state as theoretically expected, were found to enter a glassy state below a well de ned freezing tem perature. As in usual Spin G lasses, below this temperature T $_{\rm g}$, their dynam ic response to a sm allm agnetic eld becom es very slow and depends on the time t_w spent below T_{a} ('aging', see e.g.[1], [2], [3]). The question thus arises of whether these glassy materials are really similar to standard spin glasses. We have addressed this question by investigating three exam ples of such antiferrom agnets using the sam e experim ental procedures as previously used in the detailed study of the dynam ical properties of spin glasses. The three examples correspond each to a different topology of the frustrated spin network. The rst one is $Y_2M o_2O_7$ (YMO') where the spins (S = 3=2) are on a three-dimensionnal (3d) pyrochlore lattice [4], [5]. The second one is SrC $r_{8:6}Ga_{3:4}O_{19}$, (SCGO') where the spins are located on bi-layers of 2d kagom e lattices, each bi-layer being well separated from the others [6], [7]. The third one is a Jarosite compound (H₃O)Fe₃ (SO₄)₂ (OH)₆ where the spins (S = 5=2) are located on genuine 2d kagom e layers, with sm all inter layer couplings [8].


At high temperature, all three compounds exhibit a Curie W eiss behaviour with a large negative value for the Curie-W eiss temperature , indicating strong antiferrom agnetic interactions between spins. The values of are much larger than the observed freezing temperatures T_g . The ratio $j = T_g$ is of order 10 for the (3d) YMO sample [4], about 140 for SCGO [6], and about 60 for

the (2d) kagom e sam ple [9]. This reveals that frustration plays a key role in the low-T physics.

Below T_g a clear separation between Zero F ield C ooled (ZFC) and F ield C ooled (FC) magnetisations is found. This is a standard indication suggesting that the low-temperature phase is a spin glass phase. The spin glass transition is further con med by other measurements: (i) in the kagom e sample an analysis of the critical dynamics was carried out over 10 decades in frequency (including M ossbauer experiments) and it yielded the critical exponents usually found in standard spin glasses [10]; (ii) in YMO [4] it was shown that the nonlinear susceptibility diverges at T_g , as expected for spin glasses. Besides, both in YMO [5] and in the kagom e sam ple [11], neutron di raction experiments do not detect any long range ordering.

The am ount of disorder is very sm all in all these m aterials. In YMO them ain source of disorder m ight be a few percents of M o M o bonds whose lengths are slightly di erent from the standard one [5]. In SCGO an obvious source of disorder could arise from the non stoechiom – etry of the com pound which leads to a Cr coverage of the m agnetic sublattice of x = 8:6=9 = 95%, i.e. to an am ount of disorder of 5%. However, since it was shown that T_g is an increasing function of x [6], one expects a spin glass phase even in the stoechiom etric com pound. Thus, the imperfect coverage of the m agnetic sublattice does not seem to trigger the spin glass phase. Last, in the K agom e sam ple [9], the coverage of the F e network is higher than 97\%, leading, as in the two other com pounds, to an upper bound of a few percents of disorder.

To further investigate the spin glass phase in these






FIG.1: Them o Rem anent M agnetization experiments carried out at T = 0.7 T_g (see text). >From top to bottom : YMO, SCGO, kagome sam ples. The longer the waiting time t_w, the slower the relaxation when the magnetic eld is switched o . Just as in standard spin glasses, the aging magnetization M (t;t_w) A ($_0$ =t) can be scaled (see the insets) as a function of =t_w, where = t_w [(1+t=t_w)¹ 1]=[1], i.e. =t_w ' t=t_w for t < t_w. The best t gives parameters very close to those found in standard spin glasses. For YMO = 0.85, = 0.05, A = 0.3; for SCGO = 0.85, = 0.10, A = 1.35; for the kagome sam ple = 0.90 and A ' 0.0.

sam ples, we rst perform ed Therm o Rem anent M agnetization (TRM) experiments. In the measurements described here, the sam ple is quenched from above $T_{\rm g}$ to $T_{\rm m}=0.7~T_{\rm g}$ in a magnetic eld of H=50 O e. A fier a certain waiting time $t_{\rm w}$ at $T_{\rm m}$, the eld is switched o and the magnetization M is recorded as a function of time t. The results are shown in Fig.1. They look very similar to those of standard spin glasses, displaying a very slow $t_{\rm w}$ dependent relaxation. The larger $t_{\rm w}$, the slower the relaxation, and the larger the rem anent m agnetization at a given time t. This indicates that m ore and m ore spin correlations develop as time $t_{\rm w}$ becomes larger. [1, 2, 3], [12].

As can be seen in Fig.1, the whole set of TRM experim ents yields results very sim ilar to those of spin glasses. M oreover, applying the standard scaling procedure used in spin glasses, (see, e.g. [2]) allows a perfect scaling of all the M $(t;t_w)$ data on a unique curve. This is obtained by thing the relaxation curves to an expression with two additive terms. The rst one is a stationary (tw independent) power law relaxation A ($_0$ =t) which is predom inant at very small times. The second term is a function $F(t;t_w)$ of t and t_w . This function is found to scale as t=t, at short t with being an exponent close to 1. In this short t region, two is approximately the age of the system i.e. the time spent at the measuring tem perature. At larger t, the real age must be taken as $t + t_w$, in other words, the system continues to age as one m easures its relaxation. It can then be shown that the correct scaling variable should be rewritten as $=t_{w}$ where $= t_{w} [(1 + t_{w})^{1}]$ 1]=[1]. N ote that one recovers $=t_w ' t=t_w$ for $t < t_w$, as expected. The insets of Fig.1 show the plots of the function F versus this reduced variable for the present sam ples. The scaling is shown to apply quite well. Setting the microscopic attempt time to $_0 = 10^{12}$ s, one nds thing parameters very close to those of the standard spin glasses (see the caption of Fig.1), especially for the aging exponent which is slightly below 1, indicating the usual 'sub-aging' phenom enon.

Beyond these standard TRM measurements which are performed at constant temperature (after the initial quench), experim ents involving tem perature variations during aging below T_q usually reveals very striking characteristic features in standard spin-glasses [13], [14]. For example, it is now well established that aging at any T_p < T_q has no apparent e ect on the state at all other tem peratures su ciently di erent from T p. This was found, for instance, in ZFC experiments in which m odi ed cooling protocols were applied [13], [14]. W hile in the usual ZFC protocol the system is cooled (at a constant cooling rate) in zero eld from above T_q down to the lowest tem perature, in the modied protocols, the cooling is interrupted at som e tem perature (s) Tp and resum ed after som e waiting tim e t_w . In both cases, a sm all dc eld is applied at the low est tem perature reached, and the magnetisation is recorded while the system is heated up at a constant rate. The ZFC m agnetisation, as m ea-

sured in the modied protocol clearly showed marked singularities ('dips') centered around the tem perature (s) $T_{\rm p}\,.$ Far enough from $T_{\rm p}\,,$ it recovered the values of the usual (reference) ZFC magnetisation ([13], [14]). This showed that aging at $T_{\rm p}$ during $t_{w}\,$ did not a ect the system at a tem perature T di erent from Tp. It also im plied that the system kept the memory of aging at T_p while it was at lower tem peratures and was able to retrieve the aged state previously reached at T_p . These results proved that in spin glasses di erent spin correlations are building up at di erent tem peratures and that the correlations built up at any tem perature rem ain im printed at lower tem peratures. In these experiments, the width of the dips gives an idea of the 'tem perature selectivity' of the spin correlations. The results of such ZFC experiments are displayed in Fig 2 for the three considered compounds. In this gure, the di erences between the modied ZFC and the reference ZFC data are plotted as a function of tem perature. C lear singularities are observed around the various chosen values of T_p exactly as in spin-glasses. The (3d)YMO sample as well as the SCGO material present narrow dips characterised by a value $T=T_q = 0.17$:03 very close to the values found in standard spin glasses: for instance, $T=T_q = 0.16$:03 in the C dC r1:7 In 0:3 S4 H eisenberg spin glass for com parable t_w , while $T = T_q = 0.21$:03 in the F $e_{0.5}M n_{0.5}T$ iO 3 Ising spin glass. This is in contrast with the results on the kagom e (2d) compound where $T=T_{q} = 0.39$:05 is rem arkably larger.




FIG. 3: $t_2^{eff} = t_2$ plotted versus T=T (see text): the data for F e_{0.5}M n_{0.5}T iO₃ and C dC r_{1.7}In_{0.3}S₄ are plotted as examples of, respectively, an Ising spin glass and an Heisenberg spin glass. The steeper the slope in this plot, the more temperature-selective' the aging (solid line: prediction assuming that aging occurs via therm all activation with an activation energy independent on T). In contrast to SCGO and YMO data which fall within the standard spin glass area, the kagom e data are well above this region, with a very small slope.

The temperature selectivity' has been studied more quantitatively by measuring the e ect at some tem perature T of aging at a slightly sm aller tem perature T Τ. This experim entyields a TRM m easurem entwith the following procedure : (i) after eld cooling from above T_{q} to T, the sample is kept for a short time $t_1 = 500$ s at constant T , (ii) it is then further cooled to T T and aged during $t_2 = 9000$ sbefore being re-heated to T where it stays for another short time $t_3 = t_1$, (iii) last, the eld is switched o and the TRM curve is recorded. >From these experiments, an elective time t_2^{eff} can be dened such as to superim pose the measured TRM with a purely isotherm alTRM recorded at tem perature T with waiting time $t_1 + t_2^{eff} + t_3$. In other words, t_2^{eff} is a measure of the e ectat T of aging at T T for a time t_2 . The actual quantitative results for the presently studied materials are reported in Fig.3 and compared to those obtained in Ref[15] for the C dC r_{1:7} In_{0:3}S₄ H eisenberg spin glass and for the F $e_{0.5}$ M $n_{0.5}$ T iO₃ Ising spin glass. The results for YMO and SCGO are clearly in agreement with those of spin glasses, the slopes of $t_2^{eff} = t_2$ versus T for these two systems are indeed within the values delimited by the Heisenberg and Ising cases. As for the Fe-jarosite, the e ective tim e t_2^{eff} does not vary much with the change of tem perature. The system ages almost as quickly at T than at T, and builds up the same pattern of Т spin correlations at both tem peratures.

The conclusion of this investigation is that, in spite of their very small amount of disorder, the two frus-

trated antiferrom agnets, the YMO pyrochlore and the bi-kagom e SCGO, behave exactly as the standard spin glasses. The Fe-jarosite kagom e com pound, though presenting many similarities in terms of the existence of a freezing tem perature and the presence of aging e ects, has quite di erent dynam ical properties as a function of tem perature. It appears, indeed, in Fig.3 that t_2^{eff} remains very close to t_2 even for larger T's, meaning that aging at T T contributes signi cantly to the age of the system at T. The behavior is not very tem perature selective in plying that the pattern of the spin correlations is not very tem perature dependent. The two-dim ensional character of the jarosite com pound m ay be at the origin of the observed di erences with the two other materials. [16].
