Aging in the glass phase of a 2D random periodic elastic system

U sing RG we investigate the non-equilibrium relaxation of the (Cardy-Ostlund) 2D random Sine-Gordon model, which describes pinned arrays of lines. Its statics exhibits a marginal (= 0) glass phase for T < $T_{\rm g}$ described by a line of xed points. We obtain the universal scaling functions for two-time dynamical response and correlations near $T_{\rm g}$ for various initial conditions, as well as the autocorrelation exponent. The uctuation dissipation ratio is found to be non-trivial and continuously dependent on T .

Trem endous progress has been achieved in recent years in the detailed understanding of the o equilibrium relaxational dynamics (e.g. coarsening) of pure systems. For instance the scaling forms of response and correlations are well characterized and several autocorrelation and persistence exponents have been computed using powerfulm ethods [1]. By contrast, analytical studies of aging properties of random and complex systems have been mostly achieved within mean eld theory [2]. These works have unveiled the existence of non trivial uctuation dissipation ratios (FDR), X. These generalize to non-equilibrium situations the uctuation dissipation relation between (disorder averaged) integrated response and correlation [2] and can be interpreted as an e ective tem perature $T_e = T = X \beta$]. These were later investigated beyond mean eld for pure systems. Although they appear to be trivial for some pure domain growth processes [4], they were later found to be novel universal quantities at pure critical points [5, 6].

The description of glassy states beyond mean eld needs to take into account very broad distribution of relaxation times originating from rare sample to sample uctuations and distribution of barrier heights [7]. In this context it is not obvious how (or whether) the o equilibrium dynamical scaling valid for pure systems extends to this case. A lso it is not obvious that various definitions of FDR (using dierent observables, or dierent con gurational averages) are equivalent and meaningful [8, 9, 10]. Some results were obtained for the random mass Ising critical point, via RG. The dynamical (z) and autocorrelation (c) exponent were computed [11]. A de nition of the FDR (for the zero mode) was found to be non trivial [12] and obtained to one loop.

W hether such results hold within a glass phase, away from a phase transition, is still an outstanding question. A prototype system which exhibits a glass phase, while analytically more tractable, is the disordered elastic manifold in a random potential [13]. It describes a variety of physical situations, both in or out of equilibrium, ranging from visualization of pinned domain wall relaxation in magnets [14, 15], non equilibrium transport in elec-

tronic glasses [16] to m esoscopic uctuations in vortex physics [17]. Here we investigate the case of a periodic m anifold, a case which can be m apped [18, 19] onto the so-called C ardy-0 stlund (CO), 2D - random Sine G ordon m odel, [20] de ned by the ham iltonian:

where (x) 2] 1;+1 [is an XY phase (excluded vor-(x) is a quenched gaussian random eld, i.e. a com plex variable, with random phase and (x) (x^0) = $g^{(2)}$ (x x^0). The statics of (1) has been extensively studied analytically and num erically, in the context of planar ux line arrays (with displacement eld u = a = (2)and mean spacing a) and solid on solid models with disordered substrates. It is known to exhibit a glass phase [21, 22] below T_q (= 4) described by a line of xed points perturbatively controlled by the small parameter T)= T_{cr} (see however [23]). By contrast, its = (T_{α}) (non driven) non equilibrium dynamics has only been studied within gaussian variational approximation GVA [24], known already in statics to yield unreliable results for some observables [25]. There is thus the need for a controlled study via RG.

In this paper we study the relaxation dynamics for the CO model in the glass phase $T < T_q$ starting from various initial conditions at $t_i = 0$ (e.g. with the same correlations as the pure model at equilibrium at temperature T⁰). We compute, to lowest order in along the xed line, the two time ($t^0 < t$) response R, as well as the connected C and, respectively, o -diagonal Ccorrelations. These are found to be characterized by (T 0 dependent) universal scaling functions of q^z (t t) and t=t0, q being the wavevector. We nd that an autocorrelation exponent can be consistently de ned, i.e. with $_{\text{R}}$ = $_{\text{R}}$, only from the connected correlation (while the decay of C is too slow). Sim ilarly, the associated FDR, found to be a scaling function, reaches at large time separation ($t=t^0$! 1) a non trivial (and to one loop, qindependent) lim it X 1 which is non zero only for the connected correlation. This sheds light on relevant de - nition of the FDR in a glass phase.

Let us start by a short discussion of the statics. The 2-point correlation function exhibits anom alous growth

The RG to one loop [26] yields the universal [27] A () = $2^{2} + O(^{3})$. Num erical simulations near T_c [28] and at T = 0 agree qualitatively, and yield A (= 1) = a_2 = 0.57 [29] and A (= 1) = $2(2)^2B = 0.51$ [30]. A recent work [31] claims an exact solution for the 2-point correlation using a conjectured mapping onto disordered free ferm ion model. The result, translated in the present variables would yield A () = 2^{2} (1 2). This how ever is clearly incompatible with numerics, showing that there is more (non perturbative?) physics to be understood even in the statics of this model. A more direct signature of the glassy nature of the phase is the sample to sample susceptibility uctuations [22] which are found (within one loop RG) to be universal and the xed line. The free energy exponent in this glass phase is = 0, indicating a free energy landscape with logarithm ic roughness. This is consistent with the ndings in the equilibrium dynam ics: an anom alous di usion exponent [32], continuously varying along the xed line has been computed in RG which indicates a logarithm ic growth of energy barriers with scale. These properties are caracteristic of a marginal glass (by contrast with the case > 0 described by a T = 0 xed point). It is rem in iscent of a related and simpler case of a vortex in a random gauge XY model where a freezing transition (at $z_c = 4$) was found along a line of xed points [33].

The relaxational dynam ics of the CO model (1) is described by a Langevin equation ${\bf CO}$

where ::, h::i and $[::]_i$ denote respectively averages w.r.t. disorder, thermal uctuations and initial conditions. We focus on the FDR X_{t+0}^q associated to the observable [2]:

de ned such that $X_{tt^0}^q = 1$ at equilibrium, i.e. when response and correlations depend only on t t^0 [35].

The dynam ics (3) of the CO m odel (1) is then studied using the standard M SR form alism [36, 37], using the Ito prescription. The correlations (4) and response (5) are then obtained from a dynam ical (disorder averaged) generating functional or, equivalently, as functional derivatives of the corresponding dynam ical elective action. This functional can be perturbatively computed [38] using the Exact RG equation associated to the multi-local operators expansion introduced in [39]. It allows to handle arbitrary cuto functions $c(q^2=2\ ^0_0)$ and check universality, independence w.r.t. c(x) and the ultraviolet scale 0. It describes the evolution of when an additional infrared cut-0 1 is lowered from 0 to its nal value 1! 0 where a xed point of order O () is reached. In this limit, one obtains R $^q_{tt^0}$ and $C^q_{tt^0}$ (for $t > t^0$) from

where the self-energy t_1t_2 and the noise-disorder kernel D $_{t_1t_2}^{c}$ are directly obtained from at the xed point [40]. One nds (for details see [38, 41]):

Up to a boundary term , the correlation C $_{\rm tt}^{\rm q}$ satisfies (8) setting the e $^{\rm C}$ $_{\rm tt}^{\rm (d)}$ term to zero in the above expression for D $_{\rm tt}^{\rm c}$.

Studying Eq. (7) (setting $t_i=0$), in the scaling regim e q= $_0$ 1, $_0^2 t_i^2$ $_0^2 t^0$ 1 and keeping:

xed, one nds a solution consistent with the scaling form:

sim ilar to the form obtained for the response for critical systems [11, 37, 42]. Here the two exponents z and $_{\rm R}$ are identi ed from the logarithm ic singularities of the scaling function, respectively at u ! 1 and u ! 1 . We not that z identi es with the equilibrium dynamical exponent z $2 = 2 {\rm e}^{z} + {\rm O} \left(^{2} \right)$ and is thus, as expected independent of initial conditions under study. The exponent $_{\rm R}$ in (12), characteristic of long time non-equilibrium relaxation is also independent of :

One also nds, with this choice of $_R$, that $\lim_{u \in I} F_R(v;u) = F_{R\,1}(v)$. The full scaling function $F_R(v;u)$ however depends on the initial conditions and is universal (up to a single overall non-universal length scale q! q). Its explicit expression, given in [41], contains both non-equilibrium and equilibrium (u ! 1) regimes. We have checked to this order that it naturally splits into $F_R(v;u) = F_R^{eq}(v) + F_R^{noneq}(v;u)$. Here we give the non-equilibrium scaling function only in the large time separation $\lim_{n \to \infty} \operatorname{time} u = 1$:

where the constant = ${R_1\atop 1}$ ${dt_2\atop 0}$ ${dt_1\atop 1}\atop t_1t_2$ is a monotonic decreasing function of . The large v behaviour is a power law . The form (14) is convergent due to the substraction of the pole at $t_2=t_1$. The logarithm ic divergence associated to this pole yields a non trivial z exponent. The substracted piece precisely gives the equilibrium scaling function for the response F_R^{eq} (v), up to 0 (2):

where Ei(v) is the exponential integral. The same result is also obtained if t_i is taken to be $t_i = 1$ from the outset (e.g. at large but xed system size), showing that the nonequilibrium regime of the scaling function merges smoothly with the equilibrium one [43].

We now turn to correlation functions. To obtain the equilibrium correlation one can simply use FDT which holds in this regime (i.e. $X_{tt^0}^q=1$) and $C_{tt^0}^{qeq}=T\,q^2\,F_c^{eq}(v)$, with $\theta_vF_c^{eq}(v)=F_R^{eq}(v)$. One nds that at equilibrium and to this order in ,C and C coincide.

The non equilibrium connected correlation is already non trivial in the absence of disorder [44]. It also

takes a scaling form $C_{tt^0}^q = Tq^2 F_{\mathcal{C}}^0(q^2(t-t^0);t=t^0)$ with $F_{\mathcal{C}}^0(v;u) = e^{jvj} = e^{v\frac{u+1}{u-1}}$, z=2. The FDR $X_{tt^0}^q = (1+e^{2\frac{v}{u-1}})^1$ interpolates between 1 and 1=2 as $u=t=t^0$ increases from 1 to 1 (for $q \in 0$), while $X_{tt^0}^{q=0} = \frac{1}{2}$ the \random walk" value. In presence of disorder one can solve (8) perturbatively in using the above solution for the response. One obtains that $C_{tt^0}^q$, in the scaling regime, is consistent with the scaling form [45]

The calculation [41] shows that $_{C} = _{R}$, yielding an autocorrelation exponent $_{C} = _{Z}(_{C} = _{R})$:

This value of $_{\mathbb{C}}$ is also such that $\lim_{u \in \mathbb{T}} uF_{\mathbb{C}}(v;u) = F_{\mathbb{C}^1}(v)$. We have obtained the complete expression of $F_{\mathbb{C}}(v;u)$ [41] from which we can extract the large u behaviour. We then discover the relation, valid for any

Having determined both response and correlation we now obtain, in the scaling regime, the FDR (6). It is also characterized by the universal scaling function

which also depends on and has a complicated form [41]. In the limit of large time separation i.e. q^2 (t t) xed, $t=t^0$! 1, using (14,18) it simplies into:

independently of v and $\,$, i.e. of (sm all) wavevector and initial condition. There is thus a non trivial asymptotic FDR in the CO glass phase, which similarly to the case of pure critical points is in the interval [1=2;0[. Here however it continuously depends on temperature T .

As in previous works [6, 10, 12] one can also exam ine the \di usive" mode q=0. It is possible to obtain a simple analytical form for any $u=t=t^0$ in the case =0 (at initial conditions (x;t=0)=0), up to order 0 (2)

A lthough this quantity depends on in general it reaches an —independent lim it for $u \,!\, 1$. It is also interesting to compute $X_{tt^0}^{x=0}$ in real space. In previous works [6], it was argued that

The v-independence found above (20) puts in the present case these heuristic arguments on mer grounds [6].

Following the discussion in [2], this X $_1$ leads to an effective tem perature $T_e = T = X_1$, that can be measured by a thermometer coupled to the eld (x;t). Indeed, Fourier transforming Eq. (12, 16), one checks that the local R $_{tt^0}^{x=0}$ and $C_{tt^0}^{x=0}$ are precisely of the form given in [47].

It turns out that it is crucial to consider the connected correlation to obtain a non trivial FDR.We have also performed the calculation [38] for the correlation function C_{t+0}^q (4). It exhibits a scaling form similar to (16) which decreases more slowly that $C^{\rm q}_{tt^0}$ for large u . If we im pose $\lim_{u \in I} uF_C(v;u) = F_{CI}(v)$ one $\inf_{u \in I} uF_C(v;u) = 0$ that $c = \frac{1}{2}$, leading to c = 1 e^{E} + 0 (2). The FDR is found to be $X_{tt^0}^{q=0} = (2 + e^{E} \frac{p}{u})^{-1}$ and thus does not seem to approach (uniformly in) a non trivial lim it at large u. Thus, although both correlations give the same equilibrium result to order O (), only the connected one, as de ned here, yields a non trivial asym ptotic FDR in the non equilibrium regime. For \ \ \ \ 0 \, the large u behavior is dominated by the initial condition and F_c (v;u) $F_{C,1}$ (v) [42, 48]. The present considerations are also of interest for pure systems when initial conditions are non zero, e.g. in a quench from an ordered phase (or correlated initial conditions € 0) [34, 42, 48]. Indeed, in that case one can distinguish connected and non-connected correlations (4) which can also lead to different behaviours of the FDR.

We have found a physically relevant glass phase in which one can show analytically the existence of a non trivial FDR. It is a robust quantity independent of the initial condition under study and, for some observables appear to be related to an elective temperature $T_{\rm e}$. Its continuous dependence on T rejects the marginal character of this glass phase. Our analytical predictions can be tested in numerical simulations [49]. They are in good agreement near $T_{\rm g}$ and it would be interesting to investigate the aging behaviour at lower temperature, where hints of some new physics already appear in the statics.
