Stripe order, depinning, and uctuations in $La_{1.875}Ba_{0.125}CuO_4$ and $La_{1.875}Ba_{0.075}Sr_{0.050}CuO_4$

We present a neutron scattering study of stripe correlations measured on a single crystal of La1:875 Ba0:125 CuO4. Within the low-temperature-tetragonal (LTT) phase, superlattice peaks indicative of spin and charge stripe order are observed below 50 K. For excitation energies h! 12 m eV, we have characterized the magnetic excitations that emerge from the incommensurate m agnetic superlattice peaks. In the ordered state, these excitations are similar to spin waves. Following these excitations as a function of temperature, we indicate there is relatively little change in the Q -integrated dynamical spin susceptibility for h! 10 m eV as stripe order disappears and then as the structure transforms from LTT to the low-tem perature-orthorhom bic (LTO) phase. The Qintegrated signal at lower energies changes m ore dram atically through these transitions, as it must in a transform ation from an ordered to a disordered state. We argue that the continuous evolution through the transitions provides direct evidence that the incommensurate spin excitations in the disordered state are an indicator of dynamical charge stripes. An interesting feature of the therm al evolution is a variation in the incom m ensurability of the magnetic scattering. Similar behavior is observed in m easurements on a single crystal of La1:875 B a0:075 Sr0:050 C uO 4; m aps of the scattered intensity in a region centered on the antiferrom agnetic wave vector and measured at h! = 4 meV are well reproduced by a model of disordered stripes with a temperature-dependent mixture of stripe spacings. We discuss the relevance of our results to understanding the magnetic excitations in cuprate superconductors.

I. INTRODUCTION

High-Tc superconductivity in lamellar copper oxides arises when a su cient density of carriers is doped into a parent M ott insulator. Upon doping, N eel order disappears but dynam ic antiferrom agnetic (AF) spin correlations survive and coexist with the induced superconductivity. Thus, the AF spin uctuations in a doped CuO2 plane are widely believed to have a fundam ental connection with the underlying mechanism of high-T_c superconductivity. Extensive neutron scattering measurements have revealed an intimate relationship between the incommensurate (IC) low-energy spin uctuations observed in La $_2$ x Sr $_x$ CuO $_4$ (LSCO) 2 , 3 , 4 and the superconductivity. On the other hand, the discovery of evidence for cooperative spin and charge order in La_{1:6 x} N d_{0:4}Sr_xCuO₄ (LN SCO) provides a new perspective on the charge distribution within the CuO₂ planes⁶; doped charge spatially segregates into stripes that separate antiphase AF domains. Such self-organized states of the strongly correlated electrons result in a variety of interesting phenom ena, and have attracted much attention due to their potential role in the mechanism of high-Tc superconductivity. 7,8,9,10,11,12,13,14

The physics behind the IC spin uctuations in LSCO

remains controversial. To us, the concept of uctuating stripes 15,16 provides an appealing explanation of the magnetic uctuations; however, there is an alternative school of thought that argues for an explanation in terms of Ferm i-surface-nesting e ects. 17,18,19,20,21,22,23 This controversy is tied to the issue of whether chargestripe order is incompatible with superconductivity. It is clear experimentally that static ordering of charge stripes is correlated with a depression of $T_{\rm c}$, 24,25 but are the excitations of the stripe-ordered state dierent in nature from those in a state without static stripe order?

To address these issues, we present a neutron scattering study of La $_2$ $_{\rm X}$ Ba $_{\rm X}$ CuO $_4$ (LBCO) with x = $\frac{1}{8}$. This is the material in which high-tem perature superconductivity was rst discovered and in which the anomalous suppression of $T_{\rm C}$ at x = $\frac{1}{8}$ was rst observed 27,28,29,30 . The dierence between the Ba-and Sr-doped systems is associated with a subtle transition from the usual low-tem perature-orthorhom bic (LTO) structure of LSCO to the low-tem perature-tetragonal (LTT) phase in the Badoped material 31 The connection between the structural transition and the appearance of charge and spin stripe order has been clearly demonstrated in the $\frac{1}{8}$ -doped La $_{1:875}$ Ba $_{0:125}$ $_{\rm X}$ Sr $_{\rm X}$ CuO $_4$ (LBSCO) system 32 ; however, up until now, the occurrence of stripe order in pure LBCO has not been con med due to the dieulty of

growing a crystal at the $x = \frac{1}{8}$ composition. 33,34

We begin our paper by presenting neutron di raction evidence for stripe order within the LTT phase of La1:875Ba0:125CuO4, obtained using a large single crystalgrown at K yoto University. On cooling, the transition to the LTT phase begins at $T_{d2} = 60 \text{ K}$, and the magnetic and charge-order superlattice peaks appear essentially simultaneously at $T_{st} = 50 \text{ K}$. We then turn to the central topic, which is an investigation of the spin uctuations for excitation energies in the range 2 h! 12 m eV .W e show that these low-energy excitations, which have some characteristics of spin waves within the stripe-ordered phase, 15,35,36,37,38,39,40 evolve continuously through the LTT-to-LTO transition. For h! 10 meV, there is relatively little change in the imaginary part of the dynam ic spin susceptibility, ${}^{0}(Q;!)$, through the transition, while at lower energies the Q -integrated ochanges from being independent of! in the ordered state to decreasing linearly towards zero as!! 0, as it must in the disordered state. These changes are similar to those observed for spin waves in undoped La2CuO4 as one warms through the N eel tem perature. In the latter case, the dynamical spin correlations in the paramagnetic state are viewed as evidence of instantaneous spin correlations with the character of the Nelstate but without the static order. 42,43 By analogy, we take the low-energy IC spin uctuations in the LTO phase of LBCO to be evidence of instantaneous stripe correlations of the sam e type that become ordered in the LTT phase. 16 G iven that the nuclear displacem ents induced by charge order represent a prim ary order param eter for the stripe-ordered state, 6,44 we conclude that IC spin uctuations in the LTO phase are evidence of dynam ic charge stripes. 16 The relevance to other cuprates will be discussed.

A surprising feature observed in the ordered state is a dispersion of the inelastic IC scattering towards the AF wave vector with increasing !. This is di erent from the behavior that is observed for spin waves in stripe-ordered La $_2$ x Sr $_x$ N iO $_{4+}$ 45,46,47,48 This mystery has been resolved in a separate study, 49 where we measured the spin excitations up to 200~meV and found that their dispersion is incompatible with semiclassical spin-wave theory. 36,37,38,39,40 Instead, it appears that the full spectrum can be understood in terms of a model of weakly coupled 2-leg AF spin ladders. 50,51,52

B esides dispersing with energy, the apparent incommensurability is temperature dependent. There is a sharp drop in at the LTT-LTO transition, and then a more gradual decrease with increasing temperature. (A similar result has been observed recently in LNSCO 53) Complementary reciprocal-space maps of the magnetic scattering at h! = 4 meV have been obtained at several temperatures for a sample of La_{1.875}Ba_{0.075}Sr_{0.050}CuO₄. We show that the latter results can be reproduced by a disordered-stripe model, with a temperature-dependent average stripe period. These results may be of interest for interpreting the charge ordering elects observed in Bi₂Sr₂CaCu₂O₈₊ by scanning tunneling spectroscopy

(STS).16,54,55,56

The form at of this paper is as follows. Sam ple preparation and experim ental details are described in Section II. The results of neutron scattering measurements and the simulations based on the disordered stripe model which reproduce the temperature dependences of observed inelastic signal will be presented in Sections III and IV, respectively. Then, we discuss the results and their relevance to understanding other cuprate superconductors in Section V.Finally, our results are brie y summarized in Section VI.

II. SAMPLE PREPARATION AND EXPERIM ENTAL DETAILS

Sizable single crystals of La_{1:875}Ba_{0:125}CuO₄ and La_{1:875}Ba_{0:075}Sr_{0:050}CuO₄ were grown by a travelingsolvent oating-zone method. The feed rod was prepared by the conventional solid state method. Dried pow ders of La_2O_3 , $BaCO_3$, $SrCO_3$, and CuO (99.99% purity) were mixed with the nominal molar ratio of La:(Ba,Sr): Cu = 1.875:0.125:1 and calcined at 860, 920 and 960 C for 24 h in air with intermediate grindings. After this procedure, we added extra BaCO3 and CuO of 0.5 and 1.5 m ol, respectively, into calcined powder in order to compensate the loss of these components during the following crystal growth. Mixed powder was formed into cylindrical rods 8 mm in diameter and 150 mm in length. The rods were hydrostatically pressed and then sintered at 1250 C for 24 h in air. We used a solvent with a composition of LaBaCu=1:1:4 (typically 350 mg in weight) and a $La_{1:88}Sr_{0:12}CuO_4$ single crystal (8 mmin diameter and 20 mm in length) as a seed rod.

The crystal growth was performed using an infrared radiation furnace (NEC Machinery Co., SC-N 35HD) equipped with two large focusing mirrors and smallhalogen lamps. This combination of mirrors and lamps yields a sharp temperature gradient around the molten zone, which helps to provide stable conditions during the growth. 57 Both the feed and seed rods were rotating (20/25 rpm and counter to one another) to ensure e cient mixing of the liquid and a hom ogeneous temperature distribution in the molten zone. We set the growth rate at 0.7 mm/h and owed oxygen gas with the owrate of 100 cm³/m in. These growth conditions are essentially the same as those used for the growth of LSCO crystals. In due time, we successfully obtained a 100 mm-long crystal rod. The initial part of the grown rods (60 mm for LBCO and 30 mm for LBSCO), however, broke into pow der, possibly due to the inclusion of an impurity phase such as La_2O_3 and/or $(La_1Ba)_2Cu_2O_5$. The sam ples for magnetic susceptibility and neutron scattering measurements were cut from the nalpart of the grown rod. Crystals were subsequently annealed to minim ize oxygen de ciencies in the same manner used for LSCO .58




FIG. 1: Zero-eld-cooled (ZFC) and eld-cooled (FC) susceptibility of $La_{1:875}Ba_{0:125}CuO_4$ single crystal measured at 10 Oe. ZFC susceptibility of $La_{1:89}Ba_{0:11}CuO_4$, taken from Ref. 34, is shown as a reference.

Figure 1 shows the magnetic susceptibilities measured

using a SQUID (superconducting quantum interference device) magnetometer. In the LBCO sample, the eldshielding e ect at low temperature is smaller, and the T_c of 4 K is lower, compared with those reported for La_{1:89}Ba_{0:11}CuO₄.34 (Here, T_c is de ned as the tem perature where the extrapolated slope of the low-tem perature susceptibility intersects zero.) These results demonstrate the suppression of superconductivity in the present LBCO crystal. For further sample characterization, we determined the structural transition temperatures by neutron di raction. With decreasing temperature, the crystal structure successively changes from hightem perature-tetragonal (HTT, I4=mmm symmetry) to low-tem perature-orthorhom bic (LTO, Bm ab sym metry) phase at 201 K, and LTO to low-tem perature-tetragonal (LTT, P 4_2 =ncm symmetry) phase at 60 K Fig. 4(a)], consistent with results obtained previously on powder sam ples. 31,59 The form er transition tem perature is especially sensitive to the Ba concentration; therefore, these results indicate that the Ba concentration in the present sample is approximately the same as the nominal concentration. The new ly grown La_{1:875}Ba_{0:075}Sr_{0:050}CuO₄ sam ple ($T_c = 9 \text{ K}$) shows the LTT-LTO phase transitions at 37 K, with spin and charge order disappearing with the structural transition upon warming. These results are identical to those for the sample used in our earlier elastic neutron scattering study.32

Neutron scattering measurements were performed on the Tohoku University triple-axis spectrometer, TOPAN, installed at the JRR-3M reactor in the Japan Atomic Energy Research Institute (JAERI). We selected nal neutron energies $\rm E_f$ of 14.7 meV with the collimator sequences of $15^{\circ}(30^{\circ})-30^{\circ}-30^{\circ}-180^{\circ}$, and 13.5 meV with $50^{\circ}-100^{\circ}-60^{\circ}-180^{\circ}$, for elastic and inelastic measurements, respectively. Additionally, pyrolytic graphite and sapphire liters were placed in the beam in order to eliminate higher-order neutrons. The columnar-shaped LBCO




FIG. 2: Scan geometry in the (hk0) tetragonal plane. C losed squares show nuclear B ragg peaks; open and closed circles denote nuclear and magnetic IC superlattice peaks, respectively.

crystal (8 m m in diam eter and 20 m m in length) was mounted with the (hk0) zone parallel to the scattering plane. The measurements were performed below 200 K using a $^4\mathrm{H}\,\mathrm{e}\text{-}\mathrm{closed}$ cycle refrigerator. The crystal of La_{1:875}Ba_{0:075}Sr_{0:05}CuO₄ (8 m m in diam eter and 15 m m in length) was studied on the thermal-guide tripleaxis spectrom eter IN 22, equipped with a double-focusing analyzer, at the Institut Laue Langevin. For those measurements, we used no collimators and a PG liter was placed after the sample, with E $_\mathrm{f}=14:7$ meV .

In this paper, since the crystal structure of both samples at low temperature is LTT, with in-plane lattice constant of 3.78 A (4 K), we denote the crystallographic indices by the tetragonal notation (1 rlu= $1.66\,\mathrm{A}^{-1}$). Most of the inelastic scans for La $_{1.875}\mathrm{B}\,\mathrm{ao}_{:125}\mathrm{C}\,\mathrm{uO}_4$ were done along Q = (0.5;k;0) (denoted as scan-A in Fig.2), which corresponds to a direction perpendicular to the spin and charge stripes. Therefore, the proles are expected to provide information on the stripe periodicity and correlation length.

III. RESULTS FOR LBCO

A. Static correlations




FIG.3: IC peaks from (a) SDW order (measured along the path labelled A in Fig. 2) and (b) CDW order (measured along path B) in $\rm La_{1:875}Ba_{0:125}CuO_4$. Closed (open) circles indicate measurements below (above) $\rm T_{st}$.

Before investigating the spin uctuations, we rst characterize the static stripe order in the LBCO sample with x=1/8. As shown in Fig. 3, both SDW and CDW superlattice peaks were observed at low temperature, consistent with the observations for LNSCO and LBSCO. 6,24,25,32,44,60,61,62,63 Both the SDW and CDW peak-widths are resolution limited, corresponding to correlation lengths $_{\rm m}$ 150 A for the magnetic correlations and $_{\rm ch}$ 60 A for the lattice modulations. We note that the SDW and CDW peaks

are found to be located at highly-symmetric positions of (0:5;0:5;0)/(0:5;0:5;0) and (2;0;0), respectively, where = 0:118 and = 0:236 = 2. Therefore, the SDW and CDW wave vectors are parallel/perpendicular to the Cu-O bond directions, as found for the tetragonal phases of Lal:48 N do:4 Sro:12 CuO $_4$ 6,24,25 and Lal:875 Bao:075 Sro:050 CuO $_4$ 60




FIG. 4: Temperature dependencies of (a) (100), (b) CDW and (c) SDW superlattice peak intensities in $La_{1:875}Ba_{0:125}CuO_4$.

Upon heating, the intensity of the (100) superlattice peak associated with the LTT structure decreases rapidly above 50 K and disappears at $T_{d2} = 60$ K because of the structural change into the LTO phase Fig. 4(a)]. On the other hand, both the CDW and SDW order param eters exhibit second-order-like behavior, and the peak intensities sim ultaneously vanish at T_{st}=50 K [Figs. 4(b)] and(c)] Coincident behavior of the two order param eters is sim ilar to the case of LBSCO but di erent from the result for LNSCO, where the SDW order rst disappears followed by the disappearance of CDW order just below T_{d2} upon heating. 6,25,44 In contrast with the onset of the SDW and CDW orders triggered im mediately by the LTT structure in LBSCO, 32,64 however, Tst is obviously lower than T_{d2} in the present sample. The apparently simultaneous on set of magnetic and charge order in ${\rm La_{1:875}B\,a_{0:125}C\,uO_{\,4}}$ indicates the strong correlation between these two types of order; however, we note that m uon-spin-rotation m easurem ents 65 on a polycrystalline sam ple suggest that true static magnetic order occurs only below 32 K.

B. Dynam ical correlations




FIG. 5: Inelastic neutron scattering spectra of La $_{1:875}$ Ba $_{0:125}$ CuO $_4$ at (a) 30 K, (b) 65 K, (c) 100 K and (d) 200 K with the constant energy of 3 meV. The solid lines are tted results with assuming four equivalent peaks at (0:5 ;0:5;0) and (0:5;0:5 ;0).

Next, we focus our attention on the spin uctuations. Figure 5 shows the constant-energy spectra for h! = 3 m eV measured at various temperatures. In the stripe-ordered phase at 30 K, the inelastic signal is peaked at the same wave vectors as in the elastic scan, and the width is resolution-limited width. With increasing temperature, the distance between the pair of IC peaks narrows and the peak-width grows.




FIG. 6: Inelastic neutron scattering spectra of La_{1:875}Ba_{0:125}CuO₄ at (a) 30 K, (b) 48 K, (c) 65 K and (d) 100 K with the constant energy of 6 m eV. The solid lines are tted results with assuming four equivalent peaks at (0:5 ;0:5;0) and (0:5;0:5 ;0).

Figure 6 shows a similar series of scans measured at an excitation energy of 6 m eV. Again, sharp IC peaks are observed at $(0.5;0.5\ 0.118;0)$ in the stripe ordered phase, while the peaks broaden and appear to merge with increasing temperature. Note that the IC peaks measured with h! = 6 m eV remain reasonably well-de ned at 100 K, while the 3-m eV scan yields something closer to a single broad peak at this temperature. We note that the Q-resolution at != 3 m eV and 6 m eV is comparable. Thus, the lower-energy IC spin uctuations more easily lose their coherence in the disordered state.

For quantitative analysis, we assume that the magnetic excitations consist of four rods running along the c-axis and parameterize ${}^{0}(Q;!)$, which is proportional to the magnetic cross-section via S (Q;!) = $(1 e^{h!-k_BT})^{1}(Q;!)$, as follows:

where Q in represents the four IC wave vectors, (0:5

;0.5;0)/(0.5;0.5 ;0); is the peak half-width at half-maximum; and $^{\odot}$ is proportional to the integral of $^{\odot}(Q;!)$ over Q in the (hk0) scattering plane. Measured spectra are tied to the above function while taking into account the experimental resolution and a background linear in k.




FIG. 7: Local spin susceptibility as a function of ! in $La_{1:875}Ba_{0:125}CuO_4$ at (a) 8 K, (b) 30 K, (c) 65 K, (d) 100 K, and (e) 200 K.D ashed lines are guides to the eye.

Figure 7 shows the frequency dependence of $^{00}(!)$ for a number of temperatures. In the stripe-ordered state (T = 8 K and 30 K), it is independent of !, just as one would expect for spin waves. In going from 30 K (below $T_{\rm st}$) to 65 K (just above $T_{\rm d2}$), there is little change in 00 for h! $^{>}$ 8 m eV, but there is a linear decrease towards zero at lower frequencies. At higher temperatures, there is a gradual reduction in the overall scale of 00 . The modest changes observed between 30 K and 65 K indicate that there is no signicant change in the nature of the uctuations between the ordered and disordered states. The linear variation of 00 with! for low frequency at 65 K is what one expects to see for spin uctuations in a disordered spin system. It is also quite similar to what is observed in the normal state of La_{1.85} Sr_{0.15} CuO $_4$. 66




FIG.8: Temperature dependencies of (a) local spin susceptibility 00 , (b) peak-width in half-width at half-maximum and (c) incommensurability at the energy transfers of 3 and 6 meV in La_{1:875}Ba_{0:125}CuO $_4$. Vertical lines indicate $T_{\rm st}$ and $T_{\rm d2}$. D ashed lines are guides to the eye.

Figure 8 sum marizes the results for $^{\circ 0}$, and the incommensurability as a function of temperature for h! = 3 and 6 meV. The temperature dependences of all parameters exhibit a sharp kink at $T_{\rm d2}$, rather than at $T_{\rm st}$, although $^{\circ 0}$ starts to decrease at $T_{\rm st}$ upon warming due to the disappearance of magnetic order. The changes are clearly larger at the smaller energy, where one is more

sensitive to the proxim ity to static order. The jump in incommensurability at $T_{\rm d2}$ suggests a lock—in elect, with the stripe spacing adjusting to be commensurate with the modulated lattice potential that pins the stripes in the LTT phase. 67 The general decrease in with increasing temperature was also seen in a recent study of $\frac{1}{8}$ -doped LNSCO. 53




FIG. 9: !-dependence of (a) incommensurability and (b) resolution corrected peak-width (halfwidth at halfmaximum) of IC peaks for La_{1:875}Ba_{0:125}CuO₄. Open circles denote 30-K data; lled circles, 65 K; open squares, 200 K.

Figure 9 shows the frequency-dependence of and evaluated at 30 K, 65 K and 200 K. At 30 K, in the stripe ordered phase, gradually decreases with increasing!. Even in the low-energy region, is slightly smaller than the value of 0.125 expected from the linear relation between the hole-density and 5,24 possibly due to the meandering of stripes and/or disorder in the stripe spacing 68,69 . Above $T_{\rm d2}$ there is a system atic shift in for all!. The dispersion of appears to have disappeared by the time one reaches 200 K.

The peak half-width, , shows di erent behavior. At 30 K, in the stripe-ordered state, increases roughly linearly in frequency. This behavior might result from unresolved dispersion of counter-propagating spin-wave modes. On warming into the disordered state at 65 K, grows by a large amount at low frequencies, but changes relatively little for h! $^>$ 8 m eV. Now, this measurement is just along a direction perpendicular to the stripes. To check for anisotropy, we also measured the Q-width of the inelastic scattering for h! $^=$ 4 m eV at 30 K and

65 K for a direction parallel to the stripes. At 30 K the peak widths are isotropic within experimental uncertainty; however, at 65 K the width perpendicular to the stripes is roughly twice as large as that parallel to the stripes. Such an anisotropy might result from uctuations in the stripe spacing. Time restrictions prevented a more comprehensive investigation of the peak-width anisotropy.

IV. DISORDERED STRIPES IN LBSCO

A. Experim entalm easurem ents




FIG. 10: Mesh scans about Q $_{\rm A\,F}$ for h! = 4 meV. (a),(c),(e) are raw data, after subtraction of background (see text) and correction for the C u magnetic form factor, at T = 45, 100, and 200 K, respectively; panels on the right [(b),(d),(f)] were obtained from those on the left by averaging over 4-fold symmetry operations. The white circles indicate the positions of the elastic magnetic peaks that appear below 37 K.

In studying the La_{1:875}Ba_{0:075}Sr_{0:050}CuO₄ crystal, we perform ed m esh scans at an excitation energy of 4 m eV, m apping out them agnetic scattering in the neighborhood of $Q_{\rm AF}=(0.5;0.5;0)$ for several tem peratures. A llof the m easurem ents were in the LTO phase, where there is no static stripe order. To present the results, it is convenient to change to the orthorhom bic coordinate system (the system in which the mesh scans were performed), which is rotated by 45 from the tetragonal one, with a change in the lattice parameter to $a_0=\frac{1}{2}a_t$. In this rotated system, $Q_{\rm AF}$ becomes (1,0,0). The data are shown in Fig.10 (a,c,e); a tem perature—independent background, monotonically varying in Q, has been subtracted, and the

intensities have been corrected for the Q dependence of the Cu²⁺ m agnetic form factor. In order to in prove the counting statistics, we have assumed 4-fold symmetry of the data about Q_{AF}, and have averaged the data over the corresponding rotations and rections to give Fig. 10 (b,d,e). (The spectrom eter resolution used was somewhat coarse, which reduced the data collection time but masked any anisotropy in the peak widths at 40 K.) As one can see, the four peaks shift in towards Q_{AF} on warming, eventually merging by 200 K.

B. M odel calculations

Given the shifts in the IC magnetic peaks with temperature, we want to test how well the measurements can be described within a stripe model, and what the data tell us about the nature of the stripe correlations. We will assume that the Q dependence of the low-energy uctuations rejects the correlations within an instantaneous con guration of disordered stripes. One source of disorder comes from the positions of the charge stripes that denethem agnetic domains. Given a particular instantaneous con guration of stripes, we also expect there to be a nite spin-spin correlation length. To combine these two types of disorder, we performed numerical calculations. We have also considered transverse uctuations

in the stripe positions, but found that the level of agreement with the measurements was not sensitive to this additional form of disorder, so we neglect it here.)

The num erical calculations were perform ed on an array of 128 128 sites. The site n was assumed to have either an up or down spin, denoted by $F_n = +1$ or 1, or a hole, denoted by 0. Stripes of holes were taken to be straight lines of unit width running in the y direction. The spacings between the stripes were random by selected to be jor j+1 (where j is an integer) with frequencies of the two choices set to give an average spacing d such that j d j+1. For a given con guration, the scattered intensity I (Q) was calculated as

where the exponential decay factor is intended to describe the spatial fall o of spin-spin correlations. The calculated intensity contains just a pair of peaks, since the model has a unique stripe orientation. To compare with the measurements, we have rotated the intensity pattern by 90 and added it to the original version.




FIG. 11: Simulations of the 4-m eV scans, as described in the text. (a), (c), and (e) are simulations of the mesh scans at T=45, 100, and 200 K, respectively. (b), (d), and (f) compare the calculated curves with the symmetrized data along Q=(1+h;h;0). The white circles are the same as in Fig. 10.

In simulating the measurements, we have not made any correction for the spectrometer resolution, which dominates the Q-width of the signal at 45 K. The nite resolution, which is convolved with the sample scattering in reciprocal space, eectively acts like another correlation decay factor in real space; in ignoring the resolution, we compensate by overestimating the inverse correlation length $_{\rm s}$. The simulations are shown in Fig. 11. At

each tem perature, the param eters d and $_{\rm S}$ were determined by a least-squares t to the data along the line Q = (1 + h;h;0); the comparison of the data and simulations along this line are shown in Fig. 11 (b,d,f). The param eter values for each tem perature are listed in Table 1. The disordered stripe model appears to give an adequate description of the data.

One key result of the modelling is that one must allow for a signi cant change in the stripe spacing from that in the ordered state in order to get a reasonable t to the data. A second important result is that the scattering becomes commensurate as the correlation length (= 1=(2 $_{\rm s}$) in lattice units) becomes smaller than half of the stripe spacing. Thus, instantaneous charge stripe

correlations are com patible with commensuratem agnetic uctuations.

The values of the average stripe spacing required to describe the measurements in the disordered state are signi cantly longer than the value of 4 that is characteristic of the ordered state. How can we understand this? Transverse uctuations of a given stripe increase its arc length. 80 If the hole density per arc length remains roughly the same as in the ordered state, then there must bemore holes within each stripe. That, in turn, im plies a lower density of stripes within a CuO₂ plane, and hence an increased stripe spacing. Repulsive Coulomb interactions between stripes would also tend to favor increased average stripe spacings when transverse uctuations are im portant. The fact that adequate simulations of the scattering measurements do not require explicit inclusion of the transverse meanderings may simply indicate that the spin-spin correlation length is shorter than the typical distance between transverse stripe displacem ents.

V. DISCUSSION

Our results indicate that the spin correlations in the LTO phase of $\rm La_{1:875}B\,a_{0:125}C\,uO_4$ are a dynam ic form of the ordered state found at lower tem peratures in the

LTT phase. The low-tem perature phase is characterized by charge-stripe order. While magnetic order appears to have the same onset temperature (50 K), a muon-spin-rotation study has shown that the true static order appears only below 30 K. 65 From the perspective of doped antiferrom agnets, stripe order involves a spatial segregation of doped holes that allows a persistence of hole-poor, AF-insulator regions. We have obtained direct evidence for the existence of a dynamic, uctuating stripe phase in LBCO. A related dynamic stripe phase has been detected previously in La2 $_{\rm X}$ SrxN iO $_{\rm 4}$ $_{\rm 4}^{46,48}$ so there is a precedent for such behavior.

The abrupt change in the incomm ensurability at T_{d2} m ay allow an improved understanding of the striking behavior of the Hall coe cient measured by Noda, Eisaki, and $U \cdot \text{chida}^{71}$ in $La_{1:4} \times N \cdot d_{0:6} \cdot \text{Sr}_x \cdot \text{CuO}_4$. For that system, the Hallcoe cient behaved \normally " (i.e., looked similar to comparably doped LSCO) in the LTO phase, but dropped rapidly towards zero on cooling through the transition to the LTT phase for x 0:13. The behavior in the LTT phase has been explained in terms of the response of charge stripes with a doped-hole concentration of 0.5 per Cu site. For such a condition, there is electron-hole sym metry within a stripe, and consequently the Hall coe cient should be zero. 72,73 The electron-hole sym m etry is quite sensitive to the hole concentration in the stripes, and hence it should be sensitive to the incom m ensurability, which will a ect the hole concentration. The jump in the incommensurability that we observe at the structural transition implies a jump in the hole concentration within the stripes, assuming that all holes remain in stripes. (Even if the average hole concentration within stripes remains roughly the same due to m eandering of the stripes in the disordered phase, there m ay still be enough change to elim inate the particle-hole sym m etry.) It is reasonable to expect sim ilar behavior in $La_{1:4} \times Nd_{0:6}Sr_xCuO_4$, so that the abrupt change in the Hall coe cient likely re ects the di erence in hole concentration for dynamic stripes versus that in static stripes.

Recent analyses of the Hubbard model using methods beyond Hartree-Fock have yielded stripe solutions that are quite similar to experimental observations. 74,75,76,77,78 A rst-principles calculation for $\frac{1}{8}$ -doped LSCO using the LDA+U method yields bond-centered charge stripes 79 ; the superexchange interactions calculated within the hole-poor ladders are comparable to what we have obtained from measurements of the magnetic excitations in LBCO at higher energies. 49 Thus, there is growing theoretical support for the concept of stripe correlations as a natural consequence of doping holes into an antiferrom agnetic insulator. Quantum uctuations (and the absence of a pinning potential) lead to the stripe-liquid state. 15,80,81,82,83

A. Relevance to LSCO

The low-energy magnetic uctuations found in the normal state of LSCO ⁶⁶ look quantitatively similar to what we have measured in the LTO phase of LBCO. Elastic IC magnetic peaks can be induced in underdoped LSCO at low temperature through Zn-doping ⁸⁴ or by applying a magnetic eldalong the c-axis ^{85,86}. The simplest explanation for all of the these observations is that dynamic charge stripes are present in LSCO and that they can be pinned by local defects. ⁸⁷

W eaknesses in the Ferm i-surface-nesting explanation for the IC spin uctuations in LSCO have been discussed by K ivelson et al. G iven the experimental evidence for the dynamic stripe phase presented here, we believe that the Ferm i-surface-nesting approach is no longer tenable for interpreting results in LSCO. Rather than trying to explain the IC spin correlations in terms of the shape of the Ferm i surface, one must strive to understand photoem ission measurements of the electronic spectral function near the Ferm i surface in terms of the slowly uctuating charge stripes.

The gapless spin uctuations in the normal state of LSCO indicate that the charge stripes must uctuate quite slow ly. This raises the question of whether there is some feature of LSCO that might control the uctuation rate. An old, but still plausible, idea is that the charge stripes may couple to the octahedral tilt mode that is associated with the transformation from the LTO to the LTT phase. This mode has an energy of just a couple of meV. ⁸⁹ It softens on cooling below 100 K, but the softening ends at T_c . ^{90,91} A hardening of the elastic constant (C_{11} C_{12})=2 below T_c was found to be reduced by the lowering of T_c through application of a magnetic eld. ⁹² Thus, it seems quite possible that charge stripes in LSCO are coupled to slow LTT-like uctuations of the lattice.

B. Relevance to YBCO

There has long been a recognition of similarities in the low-energy magnetic scattering of well-underdoped YBCO with that of LSCO, 93,94 and measurements to higher energies made clear similarities to antiferrom agnetic dispersions. The clear identication of incommensurate magnetic scattering at $24\,\mathrm{m}$ eV in YBa2Cu3O 6:6 by Mook et al. 96,97,98 made the connection to LSCO stronger. Recent studies have provided strong evidence for stripe-like spin excitations in detwinned crystals of YBa2Cu3O 6:5, 99 and for both charge and spin modulations in YBa2Cu3O 6:35. 100

Objections to the dynam ic stripe picture have come from studies of spin excitations in YBCO samples closer to optimal doping. There the excitations observed in the superconducting state are incompatible with semiclassical spin waves from stripes. 36,37,38,39,40 An interpretation of these features based on Fermi-surface-nesting

e ects has been preferred?^{1,101,102} Our study of the highenergy spin excitations in LBCO rem oves the objection to a stripe interpretation, as the results are quite dierent from the predictions of sem iclassical spin-wave models. In fact, our results for LBCO show striking similarities to recent measurements on YBCO samples with a range of dopings.^{103,104,105} Thus, it appears that the dynamic stripe scenario provides a universal approach for understanding most features of the magnetic excitation spectrum in the two most carefully studied systems, YBCO and LSCO. The magnetic resonance phenomenon is one feature that is not yet explained by this approach.

There is one apparent di erence between LSCO and YBCO that can be explained by the dispersion of the low-energy spin excitations. In LSCO, the incommensurability , measured at 3 meV, varies linearly with doping up to a hole concentration p $\frac{1}{8}$, and it saturates at $\frac{1}{8}$ for larger p. 5 In YBCO there is a substantial spin gap that grows with p, and hence one must measure at relatively high energies (> 30 meV near optimum doping). Daiet al. 106 found that saturates at $\frac{1}{10}$ for p > 0:10, which is dierent from the LSCO result. Taking the dispersion of the spin excitations into account should reduce this apparent discrepancy.

C. Relevance to STS studies

Scanning tunneling spectroscopy studies have identi ed spatial modula-B i₂ Sr₂C aC u₂O 8+ tions of electronic states at low energies (within the superconducting gap). 16,54,55,56 Some of the spatiallym odulated features disperse with bias voltage, and these appear to be associated with scattering of electronic excitations across the gapped Ferm i surface. 55,56 C ertain features, however, involve modulations oriented parallel to the Cu-O bonds with a period of approximately 4a, suggesting a connection with the type of charge-stripe order that we have discussed here. 16,54,55,107 The relevant STS modulations do not always have a period of exactly 4a. The period varies slightly from sample to sample, and may increase a bit with temperature. Here we point out that such behavior is quite consistent with the tem perature-dependent incommensurability in LBCO and with the doping dependent incommensurability in LSCO.5

VI. SUM M ARY

We have presented a neutron scattering study of stripe order and uctuations in single crystals of La $_{1:875}$ Ba $_{0:125}$ CuO $_{4}$ and La $_{1:875}$ Ba $_{0:075}$ Sr $_{0:050}$ CuO $_{4}$. Charge and spin stripe order are observed only within the LTT phase. The Q-integrated dynam ic susceptibility is frequency independent in the ordered state, consistent with spin waves; however, the spin excitations disperse inwards towards Q $_{\rm AF}$ with increasing energy in an

anisotropic m anner that is not expected in a sem iclassical m odel.

The IC spin excitations evolve continuously through the LTT-LTO transition. For h! 10 meV, there is essentially no change in the local susceptibility through the transition, indicating that the character of the excitations in the disordered state is the same as in the ordered state, where the spin incommensurability is tied to the presence of charge stripes. Our measurements provide clear evidence for dynamic charge stripes in the LTO phase. We have discussed the relevance of our results for interpreting the magnetic excitations observed in LSCO and YBCO.
