Quantum dynamics under coherent and incoherent e ects of a spin bath in the Keldysh form alism : application to a spin swapping operation

A bstract

We develop the Keldysh form alism for the polarization dynamics of an open spin system. We apply it to the swapping between two qubit states in a model describing an NMR cross-polarization experiment. The environment is a set of interacting spins. For fast uctuations in the environment, the analytical solution shows elects missed by the secular approximation of the Quantum Master Equation for the density matrix: a frequency decrease depending on the system -environment escape rate and the quantum quadratic short time behavior. Considering full memory of the bath correlations yields a progressive change of the swapping frequency.

1 Introduction

The characterization and control of spin dynam ics in open and closed spin systems of intermediate size remain a problem of great interest [1]. Recently, such systems have become increasingly important in the emerging eld of quantum information processing [2]. The quantum interferences of these systems become e damped by the lack of isolation from the environment and one visualizes this phenomenon as decoherence. Indeed, the inclusion of the degrees of freedom of the environment may easily become e an unsolvable problem and requires approximations not fully quantied. This motivates a revival of interest on previous

studies in various elds such as Nuclear M agnetic R esonance [3], quantum transport [4] and the quantum -classical correspondence problem [5, 6] with a view on their application to emergent elds like the quantum computation [7, 8, 9] and m olecular electronics [10, 11, 12, 13].

The most standard fram ework adopted to describe the system -environm ent interaction is the use of the Q uantum M aster E quation, derived from the Liouvillevon N ewm an equation [14, 15] in a fast uctuation approximation. Interactions with the environment occur at a rate given by the Ferm iG olden Rule (FGR) providing a dissipative mechanism that could induce a non unitary dynamics into the system. A n overall (conservation) balance condition is obtained by im posing a convergence into the thermal equilibrium state. W hile su cient form ost traditional applications, this approximation leaves aside in portant mem ory effects and interferences in the time dom ain produced by the coherent interaction between the system and the bath which are becoming of increasing interest [16].

The present work focuses on two spin correlation functions in small open system swith environm ental interactions under conditions where the dynam ical feedback e ects, that go beyond the Ferm iG olden Rule, becom e relevant. For this, we will resort to the Keldysh non-equilibrium form alism which leads to an integral solution of the Schrodinger equation. W hile this novel situation is presented here for the st time, the formalism already inspired original experim ental and theoretical developm ents in coherent spin dynam ics involving quantum interferences in the time domain. In particular, it was used to develop the notion of polarization waves leading to mesoscopic echoes [17, 18], to establish the in uence of chaos on time reversal (Loschm idt echoes) [19, 20] and to establish the possibility of a spin projection chromatography [21]. A rough account of many-body decoherence enabled the interpretation of anomalies in spin \di usion" experiments as a manifestation of the quantum Zeno e ect [22]. We now make a leap forward in the development of this formalism by showing how it deals with open systems. The application to a case with an exact analytical solution [23] and where more standard approximations can be obtained [3] will show the potential of our proposal.

2 The Keldysh form alism for open system s

In this section we make a brief introduction to the Keldysh form alism, sum marizing our results for closed systems of Ref. [21]. Our aim is to extend them to open systems. Let us start considering a system with M spins 1/2. The spin correlation function,

The Jordan-W igner transform ation (JW T) [24, 25] \dot{S}_n^+ = ${}_{m = 1}^{n - 1} b_m^+ b_m^- g$; establishes the relation between spin and ferm ion operb¦ expfi ators at site n: Sym bols b_h^+ and b_h^- ; stand for the ferm ion creation and destruction operators, and $\$_n$ are the rising and low ering spin operator $\$_n = \$_n^x$ ₿^y, where b_n^{u} (u = x;y;z) represents the Cartesian spin operator. The initial polarized state is described by the non-equilibrium state $j_{n:e} = b_n^{\dagger} j_{eq}$ form ed by creating an excitation in the n-th site at t = 0. Its further evolution is contained in the particle density function [26, 27] in the Keldysh form alism $G_{m,n}^{<}(t_2;t_1) = \frac{i}{2}h_{n:e:}ja_{m}^{+}(t_1)b_{n}(t_2) j_{n:e:}iwhich can be split into contributions$ $G_{m,n}^{< (N)}$ (t_2 ; t_1) from each subspace with N particles (or equivalently N spinsup). Considering that we are in the high temperature regime, i.e., $k_B T$ is much higher than any energy scale of the system, this enables us to rewrite Eq. (1)as [21]

Notice that the non-equilibrium density $G_{m,m}^{<}$ (t;t) depends in plicitly on the index n that indicates the site of the initial (t = 0) excitation. The expression for this initial condition is

Here the rst term is the equilibrium density and it can be seen that is identical for all the sites. The second term represents the non-equilibrium contribution where only the n-th site is di erent from zero. In general, this density function evolves under the Schrodinger equation expressed in the D anielew icz form [28], which becom es:

Here $G_{m\ ,k}^{R\ _{(N\)}}$; and $G_{k,m}^{A\ _{(N\)}}$ are the exact retarded $(t_{2}\ >\ t_{1}\ >\ 0)\$ and advanced $(0\ <\ t_{2}\ <\ t_{1}\)$ two particle propagators or G reen's functions of the m any-body system .

The rst term in the rhs of Eq. (5) can be seen as a generalization of the integral form of the (reduced) density matrix ((t) = $e^{iH t=-}$ (0) $e^{iH t=-}$) projected over a basis of single particle excitations in its real space representation. This term is all one needs to solve systems such as a nite or in nite one dimensional chain with nearest neighbors X Y interaction [21]. In contrast, system s with topological defects [23], long range interaction or Ising term s in the spin H am iltonian present com plex m any-body e ects in the particle description. These lead to mean-life, Im ^R; of the single particle states, producing the non-conservation of probability on the retarded and advanced propagators, $G^{\,R}\,$ and $G^{\,A}\,$. In this case, the second term $\,w\, {\rm ou}\, ld$ collect incoherent reinjections, given by \leq ; that compensate any eventual \leak" from the coherent evolution. They also can account for processes not conserving the spin projection. A key idea in this paper is that a similar e ect of density non-conservation appears when one attempts to reduce the whole X Y system into a \system " of 2 spins and an \environm ent" with M 2 spins. Under these conditions the sum in Eq. (3) will run only over the subspaces allowed within the \system ", N = 1;2:Thee ects of the \environm ent" will be included in the form of self-energy term s, $_{k:1}^{<}(t_{k};t_{1})$ and $_{k:1}^{R}(t_{k};t_{1})$ modifying the reduced \system ".

If we replace Eq. (5) into Eq. (3) and perform the summation in the N index only over the \system ", the result can be seen as the sum of two contributions reproducing the structure of Eq. (5). Then, the rst term will be called the coherent contribution because it is related to the initial condition within the \system ". The evolution of this initial density decays with time t as a consequence of its escape towards the region called the \environment".

The second term will account for the therm odynam ical nature of the \environment" when M ! 1 . It can be seen as a boundary condition that modi es the density of the \system ". If the mean occupation of the \environment" is lower than that of the \system ", there will be a ux of probability from the \system " to the \environment" included in the form alism through the retarded and advanced propagators. On the other hand, if the \environment" mean occupation were higher than that of the \system ", it would establish a probability ow from the \environment" to the \system " and this could be seen as if the \environment" were injecting probability into the \system ". The evolution of this injected probability is described by the second term in Eq. (3) which will be called the incoherent contribution. Thus, the probability within the \system " would be fed by the \environment".

In general term s Eq. (3) and (5) involve two time functions. In order to take protof the information hidden in the time correlations, it is convenient to use the new time-energy variables [t;"] [29]. This is inspired in the W igner co-ordinates that exploit the spatial correlations to dene the position-momentum variables $[x; p_x]$. Appendix A show show this procedure is performed. Applying this technique to Eq.(5) we obtain

We will apply this form alism to a system of M spins $\frac{1}{2}$ arranged in a chain. Their interaction through an X Y coupling enables the sw apping between nearest neighbor spins. In the presence of a magnetic eld, the Ham iltonian is

which has a Zeem an part, \dot{P}_z , proportional to \dot{S}_n^z with \sim_n the Zeem an energy; and a swapping (\dot{p} - op) term, $\dot{P}_{X Y}$; where $J_{n;n+1}$ is the coupling between sites n and n + 1.

This simplied model can be used as an approximation to real 13 C 1 H systems in an NMR cross-polarization (CP) experiment [30, 3]. We will model the 13 C and 1 H nuclei, close to the Hartmann-Hahn condition, as the rst two sites of the linear chain and the rest of the chain would represent the proton spin bath or \environment".

Instead of solving a high dimensional spin Ham iltonian (7) describing the \system " plus the \spin bath", the JW T provides a map into a ferm ionic system . For a one dimensional chain or ring with nearest neighbor interactions the dimension of the H ilbert space can be reduced from 2^{M} to M enabling the calculation of dimension of the H ilbert space can be reduced from 2^{M} to M enabling the calculation of dimension of the matrix of spin dynam ics [17, 18, 23] and quantum coherences [31]. Since the interaction is restricted to nearest neighbors, the only non-zero coupling term s are proportional to $b_{1E}^{+}b_{n+1} = b_{n}^{+}b_{n+1}^{-}$. Each subspace with $\binom{M}{N}$ states of spin projection $D_{1E}^{P}M_{n=1}b_{n}^{2} = N = M = 2$ is now a subspace with N non-interacting ferm ions. The eigenfunctions $\binom{N}{N}$ of these sub-spaces are expressed as single Slater determ inants built-up with the single particle wave functions ' of energy ". 3 A two-spin system connected to a spin bath

We label the system " sites with the numbers 1 for the ¹³C and 0 for the ¹H containing the initial excitation. Thus, we want to obtain an analytical

expression for the local polarization at each site of the \system " that, according to Eq. (2), is proportional to the particle density G reen's function $G_{i;i}^{<}(t)$ (for i = 1;0).

In these conditions, the e ective (reduced) H am iltonian is:

where E $_1 \sim _1$ and E $_0 \sim _0$, are site energies and V = $\frac{J}{2}$ represents the swapping strength. For simplicity we will take E $_1$ = E $_0$. The self-energy $_0^R$ renorm alizes the site energy of the 0-th site due to the action of the rest of the chain [32]. This procedure makes possible to trace out all the degrees of freedom of the environm ent without loss of inform ation. It satis es

where V_0 is the system -environment coupling through the 0-th site. In a nite chain $\frac{R}{2}$ (") can be calculated using the recurrence relations

stating with $\frac{R}{M}$ (") = 0: Here E_c is the center of the energy band of the hom ogeneous linear chain that is acting as the environment, V_c is the nearest neighbor hopping within the chain. In this case, $\frac{R}{0}$ (") is the ratio between polynomials of degree M 3 and M 2 on ": The roots of the denominator are the M 2 eigenenergies of the environment. This functional dependence accounts exactly for the memory elects in the \environment" and describes a variety of interference phenomena such as quantum beats and mesoscopic echoes. For the present problem we will work with the assumption that $j_{0} = E_{1} j_{j} V_{j} V_{0}$ V_{c} : This means that the temporal uctuations of the environment are faster than any characteristic time of the adopted model. This approximation allows us to consider that Im $\frac{R}{0}$ (") ' $\left(\frac{V_{0}}{V_{c}}\right)^{2} c(E_{0}) =$ and the level E_{0} becomes broaden according to the Ferm is olden Rule. Since typically, E_{0} ' E_{c} ; the corresponding shift Re $\frac{R}{0}$ (") ' $\left(\frac{V_{0}}{V_{c}}\right)^{2} c(E_{0})$ is a small correction that can be neglected.

In order to obtain the contribution of the coherent term in Eq. (6), we need to compute the Fourier transform of the product of two propagators




Figure 1: a) Schematic representation of the spin system at time t = 0: The shaded region stands for the therm odynamic equilibrium state at high temperature and establish a background probability level. The black lling represents the excess of probability over the equilibrium state which is responsible for the observed dynamics. In b) the same system as in a) after the JW T, that is, under the particle point of view. Note that in this situation the background contribution is removed and the dynamics is described by the excess of probability P. In c) we represent the complementary problem of the case b). Here the black lling stands for the hole that represent the excitation. In this representation

it is easier to calculate the m em ory e ects in the bath (see text).

The evaluation of the incoherent contribution requires some explanation about the model for the $c_{k,1}^{<}$ (";t_i) function. Following Eq. (3.15) in Ref. [29]

with $_0$ (") = as was previously presented and f_n (";t_i) = $\frac{1}{2}$ + P (t_i) stands for the occupation factor of the spin bath. Initially, all the ¹H nuclei

are equally polarized and this represents the initial condition at t = 0 for the environment. A schematic representation of this situation can be seen in Fig. 1 (a): All the dynamics arises from the excess of probability P at the ¹H sites. It is interesting to note, as will be explained later, that the background probability (shaded region) does not contribute to the dynamics of the system, neither in P_{0;0} (t) nor in P_{1;0} (t): Having this in mind, the initial condition, in the particle language can be expressed with a normalized occupation factor f_n (";t_i) = 1 (t) for the 0-th site (¹H nucleus) and the spin bath, while the

1-th site is empty of excitation f_1 (";t_i) = 0 (t), as can be seen in Fig. 1 (b). At t = 0 we allow the environm ent to interact with the system and starts injecting probability into the system through the 0-th site. Then we have

To evaluate Eq. (2) we need $G_{0;0}^{<}$ (t;t) from Eq. (6) which is determined by Eq. (11). Taking into account that for a two spin system the sum in eq. (3) has only two term s, N = 1 and N = 2, we obtain

For both, $P_{0;0}$ (t) and $P_{1;0}$ (t); the 1 term in the rhs of Eq. (2) cancels out with the sum of the coherent evolution of the rst term in Eq. (4) and the term corresponding to the injection in the N = 2 sub-space. This justi es Fig. 1 (b):

Note that for ! 0 the above expressions tend to the dynam ics in two isolated sites:

It is also interesting to note that the characteristic time for the decay of the probability, $_2 = \tilde{-}$; is exactly twice that of a single site with the same environment. The interpretation of this is that due to the symmetry adopted (E₀ = E₁) the particle is half of the time on each site being less a ected by the interaction with the spin bath.




Figure 2: The ¹³C polarization (solid line) is composed by the sum of a coherent part (dash-dotted line) and an incoherent contribution (dashed line). For comparison, the evolution obtained with the secular approximation of Ref. [3] (dotted line) is shown denoted as MKBE.Parameters: =V = 0.25

Figure 2 shows the behavior of the 13 C polarization. It can be seen that it reaches the value of 1 periodically, converging to the equilibrium value of 1 at

the exponential rate l = 2. The rst maximum occurs at a relatively short time compared with $_2$: This feature is used in the spin swap operation by stopping rfirradiation (and hence the interaction) at a maximal transfer. The maxima in our curves of P $_{1,0}$ (t) are always equal to one because of the symmetry adopted (E $_0 = E_{-1}$). However, only the rst maxima of the coherent component decaying as exp[$t=_2$]; i.e. about 0.7 for our choice of parameters, would be useful in quantum information processing. The incoherent component of the polarization, having no de nite phase relation with respect to the original state, bears no information on the quantum evolution. This can be observed by NMR interferom etry as done in R efs. [18, 19]. In this case the observed polarization at 13 C presents high frequency oscillations consequence of the interference between the polarization am plitude that survived at the 13 C and the component returning after wandering in the 1 H system. This interference would be diminished if, in the last CP, one uses the second maximum.




Figure 3: It is shown the short time regime for the Polarization function for the ^{13}C nucleous obtained within the Keldysh form alism (solid line) in contrast with the the evolution obtained with the seccular approximation (MKBE) of Ref. [3] (doted line). Parameters: =V = 0.25

A nother interesting feature of Eqs. (12) and (13) is that they have zero slope for t = 0 as can be seen in Fig 3. This expresses that the quantum nature of the problem has not disappeared within the present approximation, in contrast with the result obtained by using the secular approximation V, standard in NMR calculations [3]. Performing the same approximation as in Ref. [3], but considering X Y coupling between the system and the spin reservoir, we obtain for the normalized polarization of the 13 C nucleus

Both Eqs. (13) and (16) are obtained considering the fast uctuations approximation which leads to $_{\rm c}$ (") = constant. However, comparing Eqs. (13) and (16) it can be seen that the main di erences between them are the decrease of the swapping frequency and the extra phase that result from the K eklysh form alism. The frequency decrease is a natural e ect of the damping in an harm onic oscillator and hence its meaning is clear. The extra phase provides the correct quadratic behavior for short times. Both e ects would introduce corrections up to a 10% if one attempts an estimation of the dipolar frequency is evaluated from the FT of the signal it di ers from the dipolar one in a factor of $(1 \quad \frac{1}{2V})^2)^{1=2}$. This can have important consequences when one attempts to perform a quanti cation of the 13 C 1 H average distances [33].

4 Memory e ects of the spin bath

The ¹³C polarization, P_{1;0} (t), in the Keldysh form alism arises from the coherent evolution of the initial particle density, for which the environm ent is a \sink", and an incoherent contribution where the bath acts as a particle \source". This can be compared with the complem entary fram ework. Instead of dealing with a \particle" problem let us consider it as a \hole" problem (Fig. 1 (b) and (c) respectively). On these grounds, at t = 0; all the sites are occupied except for the

\hole" excitation at the 1-th site. See Fig. 1 (c) where the black color stands for the hole excitation. At later times this excitation evolves in the system and also propagates through the reservoir. The \environment" does not have holes to inject back into the \system " but those evolved coherently from the initial hole (i.e. < 0). Here the environment is a perfect \sink". Thus all the dynam ics would be coherent, in the sense previously explained. If we add the result obtained in this case with that of Eq. (13) we obtain a one for all times consequence of the particle-hole symmetry. This is a particularly good test of the consistency of the form alism because in each result the \environment" is set in a di erent fram ework. It also shows that the background polarization does not contribute to the dynam ics.

This \hole" picture can help us to get a very interesting insight on the dynam ics in a case where the memory on the environment becomes relevant. Consider, for example, the case $V = V_0 = V_c$ and $E_0 = E_1$. The nite version of this electrice H am illionian applies to the actual experiments reported in Ref. [34]. In this case, the simplifying approximations of the fast uctuations regime are not justified. However, the exact dynamics of the system can be analytically obtained if one considers an in nite chain. This enables the use of Eq. (10) to evaluate the propagator in the rst term of Eq. (6). The integration gives the rst B essel function, hence:

A rst observation is that the frequency above is roughly increased by a factor of two as compared with that in Eq. (15). Since the maxima of P $_{1;0}$ are zeroth of the Bessel function it is clear that the frequency increases slightly with time. These are memory elects of the environment that are dependent on the interplay between the spectral density of the bath and that of the system.

We notice that the memory e ect can also appear in other condition for the bath. For example, if the proton nuclei have random polarizations and the density excitation is at site 1, i.e. in Fig. 1 (a) $f_1(") = \frac{1}{2}$ for n = 0;1;::representing the ¹H sites led up to the shaded region; and the ¹³C site with an occupation $\frac{1}{2}$ + P. In this case the excitation propagates over a background level (shaded region) that does not contribute to the dynam ics. The schem atic view of this initial condition is equivalent to that of Fig. 1 (c) where now the black lling represents a particle excitation. The solution of the polarization is the rst Bessel function, P $_{1; 1}$ (t) = $\frac{1}{tV} J_1$ (2tV=~) 2 : A part from the nite size m esoscopic e ect, this is precisely the situation observed in Ref. [34], although without enough resolution for a quantitative com parison. The e ect of a progressive m odi cation of the swapping frequency is often observed in m any experim ental situations such as CP experim ents. Depending on the particular system, the swapping frequency can accelerate or slow down. Reported exam ples are Fig. 5 on Ref. [19] and Fig. 4 on Ref. [35]. This simple example solved so far shows that environm ental correlations have fundam ental importance in the dynam ics and deserve further attention.

5 Conclusions

Sum m arizing, we have solved the Schrödinger equation within the K eldysh formalism with a source boundary condition which results in an injection of quantum waves without de nite phase relation with the initial state. The model proposed allowed us to consider the e ect of the environment over the system via the decay of the initial state followed with an incoherent injection. We obtained analytical expressions for the polarization of each of the components of a $^{13}\mathrm{C}$ $^{1}\mathrm{H}$ system coupled to a spin bath, in proving the result obtained through the application of the secular approximation [3] in standard density matrix calculation.

O fparticular interest is the inclusion oftem poral correlations within the spin bath in a model which has exact solution. On one side, it enabled us to show a novel result: mem ory elects can produce a progressive change of the swapping frequency. On the other side, this results will serve to test approxim atem ethods developed to deal with com plex correlations.

In general, our analytical results based in the spin-particle m apping, allow a deeper understanding of the polarization dynamics. They may constitute a starting point for the study of other problem s, such as di erent topologies [23] with XY interaction and the extension to dipolar and isotropic couplings.
