## On The Existence of R oton Excitations in Bose E instein C ondensates: Signature of P roxim ity to a M ott Insulating P hase

W ithin the last decade, arti cially engineered Bose E instein C ondensation has been achieved in atom ic systems. Bose E instein C ondensates are super uids just like bosonic H elium is and all interacting bosonic uids are expected to be at low enough temperatures. One di erence between the two systems is that super uid H elium exhibits roton excitations while Bose E instein C ondensates have never been observed to have such excitations. The reason for the roton m inim um in H elium is its proxim ity to a solid phase. The roton m inim um is a consequence of enhanced density uctuations at the reciprocal lattice vector of the stillborn solid. Bose E instein C ondensates in atom ic traps are not near a solid phase and therefore do not exhibit roton m inim um . W e conclude that if Bose E instein C ondensates in an optical lattice are tuned near a transition to a M ott insulating phase, a roton m inim um will develop at a reciprocal lattice vector of the lattice. Equivalently, a peak in the structure factor w ill appear at such a wavevector. The sm allness of the roton gap or the largeness of the structure factor peak are experimental signatures of the proximity to the M ott transition.

In the present work we focus attention in the possible existence or nonexistence of roton excitations in arti cially engineered Bose Einstein Condensates (BECs) [1, 2, 3]. BECs are super uid as they posses a nite sound speed [4, 5, 6] and reduced long wavelength scattering [7, 8]. The other in portant bosonic super uid is  $He_4$  [5, 9]. Since BECs and He<sub>4</sub> are the same universal phase of matter, they share a large commonality. For example, they are both super uids whose elementary long wavelength excitation spectrum is phononic, their ground states spontaneously break gauge invariance[10], that is their ground states exhibit m acroscopic quantum coherence, and they both posses vortex excitations [11]. This is an example of universality of stable xed points of m atter. In these cases the super uid ground state is such a xed point. The sim ilarities will become ever more apparent as the low energy properties BECs are studied m ore carefully.

On the other hand, at shorter wavelengths Helium possesses a roton minimum [5, 6, 12] in its excitation spectrum leading to low energy excitations occurring at a speci c wavevector, which are gapped and are di erent than long wavelength sound. These excitations can make important contributions to the dynamics and therm odynamics of the system. In BECs no such excitation has been observed and the lack of a peak in the structure factor[7] leads to the conclusion that they do not posses roton excitations. We review some of the properties of rotons in Helium and determ ine under what conditions will they occur in BECs.

A llquantum many particle systems are described by a H am iltonian [5]

where m = 2 is the kinetic energy operator, U [] is the potential energy operator, which in general can be a functional of the density operator. The density operator in rst quantized notation is

with  $\mathbf{r}_i$  being the position of the ith particle. The velocity operator is in rst quantized notation

with commutation relations

The ground state of the H am iltonian (1) could be a quantum uid or solid depending on the interaction. W e will suppose it to be a uid as we have BECs and H elium in m ind.

We study the excitation spectrum of the bosonic uid on quite general grounds following Landau [5] and the Russian school[13] quite closely. We suppose the density to have a well de ned average which we take to be uniform for simplicity. This will not change the nature of the considerations, although in real life the density can be modulated by the lattice as for BECs in optical lattices. The average velocity is zero as we consider a system at rest. We Fourier expand the density and velocity operators about their averages:

where we are using the lattice norm alization, the num ber of sites N instead of the volume V. Quantum mechanically, the velocity is proportional to the gradient of the

local phase variable of the particle,  $\forall (r) = -m r$ , or in Fourier components

The density velocity commutation relation (4) imply the well known density phase commutation relation

i.e. ~  $_{\rm K}$  is the momentum conjugate to the density uctuation  $_{\rm K}$ . The H am iltonian (1) thus becomes

where  $U_{\tilde{k}}$  is the Fourier transform of the interaction. The interaction is completely general. The only requirements are that  $U_{\tilde{k}=0}$  is a constant, so that we can have a super-

uid, and that there is some short range repulsion analogous to a Hubbard term that can be turned up in order to stabilize a M ott insulating phase.  $(\sim^2 k^2) = (4m_0)j_k f$  is the elastic energy associated with changing the density. This last term comes from acting the H am iltonian on the wavefunction and making sure that one keeps careful track of both density and phase degrees of freedom [14] in the full quantum mechanical kinetic energy term. We have perform ed studies very near to these in the context of ferm ionic system s[15] which we follow very closely in the present note. Charged boson system s were studied previously [14] with the Q uantum H alle ect in mind.

The quantum liquid is thus a collection of harm onic oscillators in m om entum space for the density uctuations. The m ass and spring constant of the oscillators are

The density energy excitation spectrum of the quantum liquid is

The ground state energy is given by U ( $_0$ ) +  $_{k}^{P} \sim !_{k} = 2$ . We note that the V irial theorem in plies that

where the structure factor is de ned by

which is, of course, the Fourier transform of the densitydensity correlation function. For the quantum liquid we thus have

The ground state energy will have the density oscillators unexcited. Hence, if the ground state wavefunction of the bosonic system without density correlations is j  $_{G\,S}$  i, the ground state wavefunction with density correlations is

The factor in front appears because it is the ground state wavefunction of harm onic oscillators and the minimum energy condition is obviously to have the oscillators shaking as little as possible. We see that the factor suppresses density uctuations. The wavefunction is essentially exact to quadratic order in the density uctuations.

Since the H am iltonian and ground state wavefunction do not contain any periodic lattice e ects, they aptly describe system s with no external lattice such as liquid H elium, to which we turn our discussion now. The ground state wavefunction (16) does not contain any insulating crystalline order as  $h_{\rm K}i = 0$  for all K. When the system spontaneously solidi es, it will exhibit B ragg peaks at the reciprocal lattice vectors, Q, corresponding to the insulating crystal. These peaks mean that  $h_{\rm Q}i \in 0$ . We inquire into the behavior when the boson uid approaches a solidi cation transition.

Proximity to a solid phase with reciprocal lattice vector  $\mathcal{Q}$  for the incipient order softens the spring constant of the density oscillators of the liquid,  $\kappa_{\sigma}$  ! 0, which makes  $!_{\sigma}$  ! 0. This last condition means the mode becom es degenerate with the ground state and there will be enhanced density uctuations, hj  $\frac{2}{\sigma}$  ji ! 1 at the wavevector of the stillborn solid, i.e. the system is approaching a phase transition. The diverging uctuations follow because the position uctuations of a harm onic oscillator diverge as the spring constant vanishes due to the Heisenberg uncertainty principle. The softening of the density mode in plies that the interaction  $U_{\mu}$  has a minimum at  $\mathcal{Q}$  which in turn produces a peak in the structure factor, S (Q), that diverges as one approaches the point when the system solidi es. This peak in the structure factor in plies will drag the spectrum down according to the equation (13) creating a roton m in im um [12].




FIG.1: Structure factor vs. wavevector for a Bose uid near a solidi cation transition. The density uctuation peak at the wavevector of the incipient order is clearly visible.




FIG.2: Frequency dispersion for a Bose uid near a solidi – cation transition. The roton minimum at the wavevector of the incipient order is clearly visible.

W e thus have as a sim ple phenom enologicalm odel that captures the physics

where  $k_0$  is some m icroscopic scale that characterizes the interaction, nonzero makes a roton m inim um, and

 $\frac{-^2 Q^2}{4m_0}$  is the roton gap, which will collapse at the crystallization transition as the sm allness of the gap of such a roton is a measure of proxim ity to crystallization. The rst term in the potential represents the short range repulsion, chosen for sim plicity to have a Yukawa form. The parameter can be thought of as the long range repulsion. From the form of the interaction we get the structure factor and the density excitation spectrum for H elium, which we plot in F igures 1 and 2. We emphasize that the reason for the roton minimum in the excitation spectrum is the proximity of the liquid H elium ground state to a solid phase. H elium is an almost solid barely melted by quantum uctuations, i.e. it is a very strongly correlated liquid.




FIG.3: Structure factor vs. wavevector for a Bose uid far from a solidi cation transition. There is no peak.




FIG.4: Frequency dispersion for a Bose uid far from a solidi cation transition. The upper graph is the super uid dispersion and the lower one is a phononic linear dispersion in order to make aparent the linearity of the super uid dispersion at long wavelengths. There is no roton m inim um.

W e now turn our attention to BECs in optical lattices. These super uids do not exhibit roton m in im um in their excitation spectrum. The reason for this is that unless the wells of the optical lattice are made deep, the system is far from a solid or M ott insulating phase. In fact, it is an extrem ely good approximation to take the interaction potential to be a constant  $U_k = I$ . For such a case, we plot in Figures 3 and 4 the structure factor and density excitation spectrum. We see no peak in the structure factor or roton minimum in the excitation spectrum as observed experimentally [7].


So far we have neglected optical lattice e ects because even though they make quantitative changes to measurable parameters of the BEC super uid, they do not change the universal super uid physics. On the other hand, as one approaches a commensurate M ott insulating phase, the lattice will become ever more important. The presence of the optical lattice implies that there is an external potential  $V_{\rm g}$  that acts on the bosons thus adding to the H am iltonian (9) the term

The e ect of the extra term in the ground state wavefunction is to move the equilibrium position of the density oscillators from  $h_{*}i = 0$  to

The fact that there is  $h_{\tilde{K}} i \notin 0$  does not mean the boson uid in an optical lattice has solidi ed into an insulating phase. It just means that the boson uid is being modulated by the periodic lattice. It is true that in the insulating phase this expected value will be nonzero too. If there was not an external lattice,  $_{\tilde{K}} \notin 0$  for some  $\tilde{K}$ 's would imply an insulating phase as the only way this can happen is for the system to spontaneously break translational invariance. So the question of how to determ ine if one is in the M ott phase is delicate for lattice boson system s.

A way to know that the bosons in an optical lattice have solidi ed into a com m ensurate M ott phase is to look at the density excitation spectrum or the structure factor. W hen it has solidied, the excitation spectrum will have a gap at long wavelengths and the structure factor will go like k<sup>2</sup> at long wavelengths. This is not a violation of Goldstone's theorem [16] as the lattice was not generated spontaneously by the boson system but is provided by the external lattice potential, i.e. the sym m etry is explicitly broken. Our interest is what are the signatures of the incipient M ott insulating phase. A sm entioned above, one can know the transition is approaching by a softening of the excitation spectrum at appropriate wavevectors. In this case, the system will behave exactly as Helium, exhibiting roton minimum and its structure factor and energy excitation spectrum will be as shown in Figures 1 and 2. M oreover, from the form ula for the response of the lattice potential (18), we see that the density Fourier com ponent at the roton wavevector will grow as the roton gap collapses. W e plot the growth of such a Fourier component vs. size of the roton gap in Figure 5.

Sum m arizing, arti cially engineered BECs and liquid  ${\rm H}\,e_4$  are both quantum bosonic super uids. They share

a large similarity of intrinsically quantum behavior for their ground states and low energy states. One important di erence is that H elium possesses roton excitations while BECs appear not to have them. The reason for this is that BECs in the atom ic traps are far from being a solid. Helium posses a roton because it is a stillborn solid where quantum uctuations barely prevent solidi – cation.

On the other hand, BECs in optical lattices [17, 18, 19] can be tuned near a solidi cation or M ott transition by making the wells deeper. We thus predict that near a transition from a super uid BEC to a commensurate M ott phase in an optical lattice there will be roton excitations measurable by light scattering occurring at the reciprocal lattice vector of the lattice. Their experimental signatures will be a large peak in the structure factor or a roton minimum in the excitation spectrum. The sm allness of the roton gap or height of the structure factor to the incipient M ott order. The roton excitation adds to the list of intrinsically quantum mechanical excitations that exists in BECs and will be of importance to the dynam ics of the system s.
