Elastic scattering losses in the four-w ave $m$ ixing of $B$ ose $E$ instein $C$ ondensates

#### Abstract

W e introduce a classical stochastic eld $m$ ethod that accounts for the quantum uctuations responsible for spontaneous initiation of various atom optics processes. W e assum e a delta-correlated $G$ aussian noise in allinitially em pty modes of atom ic eld. Its strength is determ ined by com parison w ith the analytical results for tw o colliding condensates in the low loss lim it. O urm ethod is applied to the atom ic four wave m ixing experim ent perform ed at M IT $V$ ogels et. al, P hys. R ev. Lett. 89, 020401, (2002)], for the rst tim e reproducing experim ental data.

In recent years we observe a grow ing num ber of experim ents in which the atom ic Bose $£$ instein condensate evolves in a nontrivial way. A whole new area of nonlinear atom optics wasbom. T he m ost striking exam ple of such a nonlinear process is the atom ic four-w ave $m$ ixing (4W M). In close analogy to its optical counterpart, atom ic $4 \mathrm{~W} M$ consists of generation of the new atom ic beam in the nonlinear interaction of three overlapping $m$ atter $w$ aves. For the $m$ ain part atom ic $4 W M$ is an exam ple of a stim ulated process. H ow ever, during th is process there are also collisions between individual atom $s$ that lead to a population of initially unoccupied atom ic states. These processes have spontaneous initiation but by nature they are also exam ples of the four particlem ixing. They am ount to the elastic scattering losses from the coherently evolving condensates.

The standard tool used to describe dynam ics of the condensate $w$ thin $m$ ean eld approxim ation is the celebrated G ross $P$ itaevsk iiequation (GPE). A s it stands, it is capable of describing stim ulated processes but not the
ontaneous ones. H ow ever, at least in som e experim ents the elastic scattering losses $m$ ay becom e signi cant. I here are at least tw o theoretical attem pts to estim ate such - -esduring the collision ofcondensates. In the rst one the authors used $m$ om entum-dependent higher order correction to the nonlinear coupling constant in the GPE, ing com plex scattering length. In the second one the eld theoretical form ulation was used. To m ake $\mathbb{I}$ e ective, the authors approxim ate the second quantized ham iltonian by a quadratic form. B oth $m$ ethods give very sim ilar results but are applicable only if the elastic scattering losses are $m$ erely a sm all correction.

It is the purpose of this Letter to form ulate a generalm ethod of describing elastic scattering losses in the nonlinear atom optics processes. To this end we add to the GPE a classical gaussian noise, representing vacuum quantum uctuations of the atom ic eld and an auxiliary eld holding atom s scattered out from BEC. Such a technique has its roots in quantum optics.

Spontaneous optical processes have their origins in
quantum uctuations. The thown example is a process of super uorescence In this phenom enon a sam ple of atom $s$ is prepared in the intemal excited state. Spontaneously em itted photons create an avalanche of photon em issions. W hen the light eld becom es strong, it is well described by a classical electrom agnetic eld. H ow ever the intiation has a quantal nature. $T$ his quantum in intion was successfully im itated by a classical noise . There are also general $m$ ethods of $m a p-$ ping quantum uctuations into stochastic term in the evolution equations of ntum optics (generalised Prepresentation $m$ ethods)

In optics one can nd num erous other processes in itiated by spontaneous em ission and eventually upon populating em pty m odes tuming into wlated processes; eg. sponta s R am an scattering param etric down conversion etc. There lso sm ilar exam ples in atom ic and m olecularphysic: O urm ethod is general and is capable of treating $m$ any of these processes. H ere we dem onstrate the $m$ ethod using the $4 \mathrm{~W} M$ of coherent $m$ atter $w$ aves.

The rst experim ent dem onstrating 4 W M in a so Bose E instein condensate was perform ed at N IST This was follow ed by a thonel and num erical treat$m$ ent of the experim ent In the experim ent, a short tim e of free expansion of the condensate, after it was released from the m a trap, was followed by a set of two Bragg pulses which created moving wavepackets. These wavepackets, together w ith the rem aining stationary condensate, due to nonlinear interaction and under phase $m$ atching conditions created a new m om entum com ponent in the $4 \mathrm{~W} M$ process. The standard starting point for the description of atom ic $4 \mathrm{~W} M$ process is the $G$ ross $P$ itaevskiiequation

$H$ ere $N$ is the totalnum ber of atom $s, j j^{2}$ is proportional to the atom ic num ber density and is norm alized to one, $g=4 h^{2} a=m$ is the nonlinear interaction strength, $m$ the atom ic $m$ ass, $a$ is the scattering length and $V$ is a con ning potential. A com pact ground state wavefinc-
tion $(x ; 0)$ is created in harm onic trap potentialV and centered around $r=0 \mathrm{w}$ ith $(0 ; 0)=\mathrm{m}$, the m axim um value. O nce th is ground state is created, V is tumed. The developm ent of ( $x ; t$ ) is now described by Eq. w th $\mathrm{V}=0$. Later on, a set ofB ragg pulses is applied and parts of the condensate begin to $m$ ove. $W$ e can de netw o tim escales characterizing evolution of the condensate: a nonlinear interaction timent $=\left(\mathrm{gN} \mathrm{j} \mathrm{m} \mathrm{J}^{\mathrm{g}}=\mathrm{h}\right)^{1}$ and a collision time col. The latter is de ned as a time it takes tw o w avepackets uniform ly moving along $x$ to $m$ ove apart (so they just touch and cease to overlap), col $=2 r_{\mathrm{TF}}=\mathrm{V}$ $w$ here $r_{T F}$ is the initial radius of the condensate in the $x$ direction (Thom as - Ferm i approxim ation), and $v$ is the relative velocity. The ratio of these two tim escales determ ines the output of the $4 \mathrm{~W} M$ process.
$T$ he initial condition im $m$ ediately after application of the $B$ ragg pulses at $t_{1}$, can be approxim ated as being a com position of the BEC w avep $s$, identical in shape to $\left(x ; t_{1}\right)$ (for $m$ ore details see :

Here $f_{i}=N_{i}=N_{P}$ is the fraction of atom $s$ in the $i$-th wavepacket and ${ }_{i=1}^{3} f_{i}=1$. A new wavepacket $w$ ith $\mathrm{P}_{4}=\mathrm{P}_{1} \quad \mathrm{P}_{2}+\mathrm{P}_{3} \mathrm{w}$ ill build up, thanks to the nonlinear interactions accounted for by the last term in the $G$ ross $P$ itaevskii equation A fter a while, the fourth w avepacket w ill grow to the $m$ acroscopic level. U sing the de Broglie relations: $\widetilde{\mathrm{K}}_{\mathrm{i}}=\mathrm{P}_{\mathrm{i}}=\mathrm{h}$ and $!_{i}=\mathrm{hk}_{\mathrm{i}}^{2}=2 \mathrm{~m}$ we have:

where w e use the convention in which allindices are taken m odulo 4. To account for the elastically scattered atom s we introduce an additional com ponent of the wavefunction $\quad$. It is this part of the wavefunction which willbe in itiated by the classical stochastic eld. The stochastic old $i j(x ; t) m$ ust be added to the equation of $m$ otion to trigger the elastic scattering process of tw o particles from the condensate wavefunctions $i$ and $j$ to the

For num erical calculations we assum e that ${ }_{i j}(x ; t)$ is a gaussian stochastic process $w$ ith zero $m$ ean and the only nonvanishing second order correlation function equal to $h_{i j}(x ; t) i_{j}\left(x^{0} ; t^{0}\right) i=A_{i j}^{x ; x^{0}} t ; t^{0}$. H ere K ronecker delta functions are assum ed both in space and tim e since we refer to num erical sim ulations w ith spacial grid and discrete tim e steps. $N$ otice that we assign di erent stochastic process to each pair of colliding w avepackets, anticipating dependence on param eters like relative velocity.

of the atom ic eld operatops into condensate parts and initially em pty modes $={ }_{1}^{4} i^{+} \quad$ B in a way analogous to that presented in We do not how ever explicitly decom pose $B$ into plane waves but obtain it's $H$ eisenberg equation of $m$ otion assum ing only that it commutes $w$ th operators of $m$ acroscopically occupied modes $i$. Finally stochastic eld is added to $B$ in the source term $s$ for $4 \mathrm{~W} M$ as show $n$ above. These stochastic term s m im ic vacuum quantum uctuations leading to spontaneous elastic scattering loss. B ut as elastically scattered atom $s$ reside in $\quad$ B they $m$ ay eventually get am pli ed via bosonic stim ulation when population becom es signi cant. T his is an outline of on-oochastic $m$ ethod; details w illbe presented elsew hore

To fully determ ine equations we need to specify the value ofconstants $A_{i j}$. Just as II has been done in the case of super uorescence $m$ entioned above, we can nd $A_{i j}$ by the requ ent that it re duces known lim iting analytic results . In reference the elastic scattering losses w ere com puted analytically in perturbative regim e for tw o colliding gaussian-shaped w ave packets. Furtherm ore these w avepackets w ere assum ed to evolve w ithout losses and without spreading. T he num ber of elastically scattered atom s as a function of tim e was found in the form

where is a width of the gaussian wave-packets and $Q$ is the $w$ ave vector corresponding to the absolute value of the $m$ om entum of each of the $w$ ave-packets in the center of $m$ ass fram $e$. The sam equantity $m$ ight be calculated approxim ately under analogous assum ptions using the stochastic classicalnoise. The equation for $B$ in this case reads

where 1;2 are two counter-propaning gaussian wavefiunctions. The approxim ations o: am-unts in retaining on the right hand side of equatior only the last term. The approxim ate solution obtained this way gives the num ber of elastically scattered atom $s$ as a function of tim e in the form

Comparing with we obtain $A_{12}=\frac{m(2 Q)}{4 \mathrm{ht}}$. As we anticipated $A_{12}$ depends on the relative velocity of wavepackets 1 and 2 , which in our case is equal (2Q). $N$ ote that onœ $A_{i j}$ 's are determ ined our num erical anproach has no m ore adjustable param eters. In F ig. we are com paring the solution of w ith a num erical

solution of full equation N ote the grow ing discrepancy between perturbative and non-perturbative results for larger losses. T hey result from bosonic enhancem ent present in the non-perturbative regin $e$. $W$ e also stress that in the non-perturbative regim e the stochastic noise is crucial at the early stace of evolution. It $m$ ay even be dropped from equation when Bose enhancem ent takes e ect. This is why the strength of classical noise $m$ ay be determ ined in the perturbative regim e. Finally, we point out that som e analogies regarding the break down of perturbative approach were found in the study of atco - - ale conversion $w$ thin positive $P$ representation
$W$ ith the equations fully determ ined w our attention to the recent experim ent from M IT . This experim ent, due to the large value of the ratio of collision to nonlinear tim escales, had very large num ber of elastically scattered atom s. Experim ental con guration consists of tw o in itialw avepackets of equal strength ( $\mathrm{N}=2$ atom $s$ in each) and the third wavepacket of just a tiny fraction ofN .M agnetic trap used to generate the Sodium condensate had frequencies of 80,80 and 20 Hz in axial direction, hence it has a shape of a cigar. A pplied optical B ragg pulses to create $m$ oving $w$ avepackets propagated approxim ately at the sam e angle of $0: 5 \mathrm{rad} w$ ith respect to the long axis of the condensate corresponding to a relative velocity of $20 \mathrm{~mm} / \mathrm{s}$. In tw o series of 4W M $m$ easurem ents chem ical potential of the condensate was $2: 2$ and $4: 4 \mathrm{kHz}$, which we identi ed as corresponding to 5 and 30 m illion atom s respectively. In Figur ve plot the population of the third wave-packet (the one that was initially seeded) as a function of tim e. The cir-

Several theoretical curves are plotted. T he dashed line represents results neglecting all elastic scattering losses. The dotted line accounts the losses by m eans of the com plex scattering length We see that neither of the curves reproduces experim ental results. O ur stochastic $m$ ethod gives the solid line which is $m$ uch closer to the experim ental data. It has been com puted w th the param eters of the experim ent including the initial num ber of atom s infered from the paper as being equalto 5 m ln .

In Fi sim ilar com parison is $m$ ade for larger sam ple of 30 m m atom s . A gain our results reproduce the experim entaldata very well. W e feel that rem aining discrepancy (our results seem to be consistently under experim ental points) is due to indistinguishability of BEC and therm alatom $s$ in the region of the $m$ om entum space occupied by BEC.

In conclusion: $W$ e have form ulated the classical stochastic eld $m$ ethod that accounts for the quantum uctuations responsible for spontaneous initiation ofvarious atom optics processes. For instance we can treat oscillations betw een atom ic and molecula sates triggered by opticalorm agnetic eld e ects $\quad$ The m ethod is then applied to the atom ic $4 \mathrm{~W} M$. It gives for the rst tim e excellent agreem ent with the recent M IT experim ent, where the scattering losses where substantial.
