## E lastic scattering losses in the four-wave m ixing of Bose E instein C ondensates

W e introduce a classical stochastic eld m ethod that accounts for the quantum uctuations responsible for spontaneous initiation of various atom optics processes. W e assum e a delta-correlated G aussian noise in all initially em pty m odes of atom ic eld. Its strength is determ ined by com parison w ith the analytical results for two colliding condensates in the low loss limit. O urm ethod is applied to the atom ic four wave m ixing experim ent perform ed at M IT [Vogels et. al., Phys. R ev. Lett. 89, 020401, (2002)], for the rst tim e reproducing experim ental data.

In recent years we observe a growing number of experiments in which the atom ic Bose-Einstein condensate evolves in a nontrivial way. A whole new area of nonlinear atom optics was born. The most striking example of such a nonlinear process is the atom ic four-wavem ixing (4W M). In close analogy to its optical counterpart, atom ic 4W M consists of generation of the new atom ic beam in the nonlinear interaction of three overlapping matter waves. For the main part atom ic 4W M is an exam ple of a stim ulated process. How ever, during this process there are also collisions between individual atom s that lead to a population of initially unoccupied atom ic states. These processes have spontaneous initiation but by nature they are also examples of the four particle mixing. They am ount to the elastic scattering losses from the coherently evolving condensates.

The standard tool used to describe dynam ics of the condensate within mean eld approximation is the celebrated G ross-P itaevskii equation (GPE). As it stands, it is capable of describing stim ulated processes but not the spontaneous ones. However, at least in som e experim ents [1] the elastic scattering losses may become signi cant. There are at least two theoretical attempts to estimate such losses during the collision of condensates. In the rst one [2] the authors used m om entum -dependent higher order correction to the nonlinear coupling constant in the GPE, introducing complex scattering length. In the second one [3, 4, 5] the eld theoretical form ulation was used. To make it e ective, the authors approxim ate the second quantized ham iltonian by a quadratic form . B oth m ethods give very sim ilar results but are applicable only if the elastic scattering losses are merely a small correction.

It is the purpose of this Letter to formulate a generalm ethod of describing elastic scattering losses in the nonlinear atom optics processes. To this end we add to the GPE a classical gaussian noise, representing vacuum quantum uctuations of the atom ic eld and an auxiliary eld holding atom s scattered out from BEC. Such a technique has its roots in quantum optics.

Spontaneous optical processes have their origins in

quantum uctuations. The best known example is a process of super uorescence [6]. In this phenom enon a sample of atom s is prepared in the internal excited state. Spontaneously emitted photons create an avalanche of photon emissions. When the light eld becom es strong, it is well described by a classical electrom agnetic eld. However the initiation has a quantal nature. This quantum initiation was successfully in itated by a classical noise [7]. There are also general methods of mapping quantum uctuations into stochastic term in the evolution equations of quantum optics (generalised Prepresentation methods) [8].

In optics one can nd num erous other processes initiated by spontaneous em ission and eventually upon populating empty modes turning into stimulated processes; eg. spontaneous R am an scattering [9], param etric dow n conversion [10], etc. There are also similar examples in atom ic and molecular physics [11]. O urm ethod is general and is capable of treating m any of these processes. Here we demonstrate the method using the 4W M of coherent matter waves.

The rst experiment demonstrating 4W M in a sodium Bose-Einstein condensate was performed at NIST [12]. This was followed by a theoretical and numerical treatment of the experiment [13, 14]. In the experiment, a short time of free expansion of the condensate, after it was released from the magnetic trap, was followed by a set of two Bragg pulses [15], which created moving wavepackets. These wavepackets, together with the remaining stationary condensate, due to nonlinear interaction and under phase matching conditions created a new momentum component in the 4W M process. The standard starting point for the description of atom ic 4W M process is the G ross-P itaevskii equation

Here N is the total num ber of atom s,  $j j^2$  is proportional to the atom ic num ber density and is norm alized to one,  $g = 4 h^2 a = m$  is the nonlinear interaction strength, m the atom ic m ass, a is the scattering length and V is a con ning potential. A compact ground state wavefunction (r;0) is created in harm onic trap potential V and centered around r = 0 with (0;0) =  $_{\rm m}$ , the maximum value. Once this ground state is created, V is turned o. The development of (r;t) is now described by Eq. (1) with V = 0. Lateron, a set of B ragg pulses is applied and parts of the condensate begin to move. We can dene two timescales characterizing evolution of the condensate: a nonlinear interaction time  $_{\rm NL}$  = (gN j  $_{\rm m}$   $j^2$ =h)  $^1$  and a collision time  $_{\rm col}$ . The latter is dened as a time it takes two wavepackets uniform ly moving along x to move apart (so they just touch and cease to overlap),  $_{\rm col}$  =  $2r_{\rm TF}$  =v where  $r_{\rm TF}$  is the initial radius of the condensate in the x direction (Thom as – Ferm i approximation), and v is the relative velocity. The ratio of these two timescales determines the output of the 4W M process.

The initial condition immediately after application of the Bragg pulses at  $t_1$ , can be approximated as being a composition of the BEC wavepackets, identical in shape to  $(r;t_1)$  (formore details see [13]):

Here  $f_i = N_i = N_p$  is the fraction of atom s in the i-th wavepacket and  $\sum_{i=1}^{3} f_i = 1$ . A new wavepacket with  $P_4 = P_1$   $P_2 + P_3$  will build up, thanks to the non-linear interactions accounted for by the last term in the G ross P itaevskii equation (1). A fter a while, the fourth wavepacket will grow to the macroscopic level. Using the de Broglie relations:  $\tilde{k}_i = P_i = h$  and  $!_i = hk_i^2 = 2m$  we have:

Variation of the  $_{i}$  is assumed to be slow as compared to that of the exponential in equation (3). Four equations for this slow dependence are obtained from (1) and (3). We have, when V is turned o [2]:

where we use the convention in which all indices are taken m odulo 4. To account for the elastically scattered atom s we introduce an additional component of the wavefunction  $_{\rm B}$ . It is this part of the wavefunction which will be initiated by the classical stochastic eld. The stochastic eld  $_{\rm ij}$  (r;t) must be added to the equation of motion (4) to trigger the elastic scattering process of two particles from the condensate wavefunctions  $_{\rm i}$  and  $_{\rm j}$  to the




FIG.1: Number of elastically scattered atoms from the pair of counter-propagating condensate G aussian wavefunctions, with relative velocity 1.75 m = s, as a function of time. The lower curve corresponds to sm all number of scattered atoms  $(N = 10^4 \text{ and gaussian width } = 9:1 \text{ m})$ , when the bosonic stimulation does not occur. In this limit all three m ethods: com plex scattering length calculation [2], eld theory [3], and our stochastic m ethod give indistinguishable results. The upper pair of curves corresponds to higher number of atoms  $(N = 1:6 \ 10^5 \text{ and gaussian width } = 15:8 \text{ m})$  -dashed line was obtained using com plex scattering length m ethod and the solid line is a solution of eq.(8)

background eld  $_{\rm B}$ . It is a four particle process and it must be implemented for each pair of colliding wavefunctions i; j in such a way that the total number of atoms in colliding waves + background eld is still conserved. The resulting set of equations reads

For num erical calculations we assume that  $_{ij}(\mathbf{r};t)$  is a gaussian stochastic process with zero m ean and the only nonvanishing second order correlation function equal to  $h_{ij}(\mathbf{r};t)_{ij}(\mathbf{r}^0;t^0)i = A_{ij r;r^0} t;t^0$ . Here K ronecker delta functions are assumed both in space and time since we refer to num erical simulations with spacial grid and discrete time steps. Notice that we assign di erent stochastic process to each pair of colliding wavepackets, anticipating dependence on parameters like relative velocity.

Equations (5-6) may be obtained from multiatom system ham iltonian upon using Bogoliubov decomposition of the atom ic eld operators into condensate parts and initially empty modes =  $\int_{i=1}^{4} i + B$  in a way analogous to that presented in [3]. We do not however explicitly decompose B into plane waves but obtain it's Heisenberg equation of motion assuming only that it commutes with operators of macroscopically occupied modes i. Finally stochastic eld is added to B in the source terms for 4W M as shown above. These stochastic terms minic vacuum quantum uctuations leading to spontaneous elastic scattering loss. But as elastically scattered atom s reside in B they may eventually get am – pli ed via bosonic stimulation when population becomes signi cant. This is an outline of our stochastic method; details will be presented elsewhere [16].

To fully determ ine equations (5-6) we need to specify the value of constants  $A_{ij}$ . Just as it has been done in the case of super uorescence mentioned above, we can nd  $A_{ij}$  by the requirem ent that it reproduces known limiting analytic results [3]. In reference [3] the elastic scattering losses were computed analytically in perturbative regime for two colliding gaussian-shaped wave packets. Furtherm ore these wavepackets were assumed to evolve without losses and without spreading. The number of elastically scattered atom s as a function of time was found in the form

where is a width of the gaussian wave-packets and Q is the wave vector corresponding to the absolute value of the momentum of each of the wave-packets in the center of mass frame. The same quantity might be calculated approximately under analogous assumptions using the stochastic classical noise. The equation for  $_{\rm B}$  in this case reads

where  $_{1,2}$  are two counter-propagating gaussian wavefunctions. The approximations of  $[\beta]$  amounts in retaining on the right hand side of equation 8 only the last term. The approximate solution obtained this way gives the number of elastically scattered atoms as a function of time in the form

C om paring (7) with (9) we obtain  $A_{12} = \frac{m}{4} \frac{(2Q)}{4 h t}$ . As we anticipated  $A_{12}$  depends on the relative velocity of wavepackets 1 and 2, which in our case is equal (2Q). Note that once  $A_{1j}$ 's are determined our num erical approach has no more adjustable parameters. In Fig. 1 we are comparing the solution of (7) with a num erical




FIG.2: Population of the third wavepacket norm alized to the initial seed population as a function of time (continuous line). Param eters used in the simulation correspond to experiment performed in the Ketterle group [1]. Total number of atom s equal to 5m ln. A lso shown: circles - experimentally measured values, and dashed and dot lines - solutions of the Gross-Pitaevskii equation with real and complex scattering length respectively.

solution of full equation (8). Note the growing discrepancy between perturbative and non-perturbative results for larger losses. They result from bosonic enhancement present in the non-perturbative regime. We also stress that in the non-perturbative regime the stochastic noise is crucial at the early stage of evolution. It may even be dropped from equation (8) when Bose enhancement takes e ect. This is why the strength of classical noise may be determined in the perturbative regime. Finally, we point out that some analogies regarding the break down of perturbative approach were found in the study of atom-molecule conversion within positive-P representation [17, 18].

W ith the equations (5-6) fully determ ined we turn our attention to the recent experim ent from M II [1]. This experim ent, due to the large value of the ratio of collision to nonlinear tim escales, had very large num ber of elastically scattered atom s. Experim ental con guration consists of two initial wavepackets of equal strength ( N = 2atom s in each) and the third wavepacket of just a tiny fraction of N.M. agnetic trap used to generate the Sodium condensate had frequencies of 80, 80 and 20 Hz in axial direction, hence it has a shape of a cigar. A pplied optical Bragg pulses to create moving wavepackets propagated approximately at the same angle of 0:5 rad with respect to the long axis of the condensate corresponding to a relative velocity of 20 mm/s. In two series of 4W M m easurem ents chem ical potential of the condensate was 2:2 and 4:4 kHz, which we identied as corresponding to 5 and 30 m illion atom s respectively. In Figure 2 we plot the population of the third wave-packet (the one that was initially seeded) as a function of time. The cir-




FIG. 3: Population of the third wavepacket norm alized to the initial seed population as a function of time (continuous line). Param eters used in the simulation correspond to experim ent perform ed in the K etterle group [1]. Total number of atom s equal to 30 m ln. A lso shown: circles - experim entally m easured values, and dashed and dot lines - solutions of the G ross-P itaevskii equation with real and com plex scattering length respectively.

cles are the experimental data extracted from paper [1]. Several theoretical curves are plotted. The dashed line represents results neglecting all elastic scattering losses. The dotted line accounts for the losses by means of the com plex scattering length [2]. We see that neither of the curves reproduces experimental results. Our stochastic method gives the solid line which is much closer to the experimental data. It has been computed with the param eters of the experiment including the initial number of atom s infered from the paper as being equal to 5m h.

In Fig.3 similar comparison is made for larger sam – ple of 30m ln atom s. A gain our results reproduce the experimental data very well. We feel that remaining discrepancy (our results seem to be consistently under experimental points) is due to indistinguishability of BEC and therm alatom s in the region of the momentum space occupied by BEC.

In conclusion: We have formulated the classical stochastic eld method that accounts for the quantum uctuations responsible for spontaneous initiation of various atom optics processes. For instance we can treat oscillations between atom ic and molecular condensates triggered by opticalorm agnetic eld e ects [17, 18]. The method is then applied to the atom ic 4W M. It gives for the rst time excellent agreement with the recent M IT experiment, where the scattering losses where substantial.
