Quantum transport of non-interacting Fermigas in an optical lattice combined with harm onic trapping

Abstract. We consider a non-interacting Ferm i gas in a combined harmonic and periodic potential. We calculate the energy spectrum and simulate the motion of the gas after sudden replacement of the trap center. For dierent parameter regimes, the system presents dipole oscillations, damped oscillations around the replaced center, and localization. The behaviour is explained by the change of the energy spectrum from linear to quadratic.

1. Introduction

In solid state physics, electrons in an atom ic lattice are modelled by ferm ions satisfying the Schrodinger equation in a periodic potential. A lkali atoms in a periodic potential created by light have recently provided a new physical realization of the same mathematical model [1, 2, 3, 4, 5, 6]. Experimentally, optical lattices are highly controllable and open a wide range of parameters for study, also the dynamics. For bosonic atoms, quantum transport such as Bloch oscillations have been observed [2]. The rst such experiments on ferm ions in optical lattices have been realized very recently [3, 4, 5, 6].

Unlike electrons in bulk solids, the atom ic gases feel in addition to the lattice an overall con ning potential, usually of harm onic shape. This harm onic trapping can be chosen weak and the system considered nearly hom ogeneous. On the other hand, it can be made signi cant in order to induce interesting quantum transport experiments: shift of the trap center may cause oscillatory motion of the gas [3, 4, 5]. Single-particle states and spectrum in a combined harm onic and periodic potential have been studied in [7, 8], and the elect of the potential on quantum transport has been analyzed in [5, 9] using semiclassical analysis. We present here exact numerical treatment which gives a complementary point of view for understanding the problem, and provides a method applicable for a wide range of parameter values. Since we consider non-interacting fermions, the only physical assumptions we need are that the individual atoms obey the Schrodinger equation and that the equilibrium of the many-particle system can be described by the grand canonical ensemble. The physical model is considered in more

detail in Section 2. Details of the num erical implementation are discussed in Section 3. Finally, in Section 4 the results of the simulations are presented and discussed, and compared with the experiments.

2. Physical model

We consider a one-dimensional optical lattice combined with a three-dimensional quadratic potential. The quadratic potential is weak in the direction of the lattice (axial direction) and tight in the remaining two (radial) directions. The full three-dimensional Ham iltonian operator for a single particle is

where $!_a$ and $!_r$ are the axial and radial frequencies, respectively, U is the lattice height, and is the lattice wavelength. We shall consider the one-dimensional system in the axial direction rst and deal with the radial degrees of freedom later. Choosing the units of energy and length to be $\sim !_a$ and $\frac{P}{\sim -m} \cdot !_a$, respectively, and using the notation A = U = 2 and k = 4 = 1, the one-dimensional Hamiltonian can be written as a sum

of the lattice potential H $^{\rm L}$ = A $\cos(kx)$ and the oscillator H am iltonian

Let ($_n$) and ($_n$) be the eigenfunctions and eigenenergies of H , respectively. U sing the annihilation and creation operators a_n ; a_n^y associated to the eigenfunctions we m ay write the m any-particle H am iltonian in the ferm ionic Fock space as

Initially the system is in the statistical equilibrium and can be described by the grand canonical ensemble

where is the chem ical potential, $N=\frac{P}{n}\,a_n^y a_n$ is the number operator, and $=\frac{1}{k_B\,T}$. The time evolution of the system is given by

where H $^{\rm d}$ is the Ham iltonian governing the dynam ics of the system. Of course, H $^{\rm d}$ must be dierent from the Ham iltonian H used to calculate the initial equilibrium state (0), otherwise the system will be stable. In the experiment, the displacement d of the harm onic trap gives rise to the new Ham iltonian

which starts the time evolution of the system. D isplacement of the trap center in the absense of the lattice leads to the dipole oscillations characteristic for a harmonic potential.

We want calculate the time evolution of the expectation value of the position operator. The task is greatly simplified by the fact that we can represent any many-particle state by a single-particle state () when calculating expectation values of single-particle observables. This reduction is discussed in more detail in the Appendix. The single-particle state ((0)) corresponding to the grand canonical ensemble (0) is a diagonal operator in the energy eigenbasis. The diagonal elements are given by the Ferm i-D irac distribution

When the Ham iltonian operator is itself a single-particle operator, which is the case for non-interacting Ferm igas, the reduced state obeys the ordinary Schrodinger equation. Hence the nalformula for the motion of the Fermingas is simply

where X is the position operator.

As the nal step we consider dimensional reduction from three dimensions to one. Even though we are interested in the motion of the Fermigas only in one dimension, the physical system is naturally three-dimensional. However, we can simply trace out the radial degrees of freedom since they are independent of the observable which we are measuring. In practice, this is done by replacing the Fermie indicated in the ective one-dimensional energy distribution

where the multiples of \sim ! $_{\rm r}$ exhaust the energy spectra of the independent oscillators in the radial directions.

3. Num erical im plem entation

The time evolution of the center of mass of the non-interacting Fermigas trapped in an optical lattice was calculated using the formula (2). The rst task was to diagonalize the Hamiltonian. A ctually there were two Hamiltonians Hand Hdo to be considered corresponding to the two positions of the trap. However, we made the simplifying assumption that the displacement of the trap was a multiple of the lattice wavelength (this is justified when the latter is much smaller than the former). Then by a symmetry argument the two sets of eigenfunctions were obtained from each other by a simple translation. A coording to the formula (1) the initial equilibrium state (0) is diagonal in the eigenstate basis of the initial Hamiltonian H, and the diagonal elements are determined by the corresponding eigenvalues. The chemical potential was tred to match the particle number. By a change of basis, the state matrix was then transformed

to the eigenstate basis of the displaced Hamiltonian Hd. The position operator X was also expressed in this basis. By de nition, the Hamiltonian itself Hd is diagonal in this basis, so that the time evolution was easy to calculate using formula (2).

The main diculty was to nd a basis suitable for diagonalizing the Hamiltonian num erically. We used the Herm ite functions

where H_n is the nth Herm ite polynom ial. With this choice the harm onic oscillator Ham iltonian H $^{\circ}$ becomes diagonal with matrix elements

and even the matrix elements of the lattice part H $^{\rm L}$ can be calculated analytically. To

be exact, the m atrix elements are recovered as H

We were able to derive explicit closed expressions for I_{nm} (k) as nite polynomials of k. However, they are rather cum bersom e and not very useful in practice. In num erical calculations the integrals are most easily obtained from the formula

with the initial conditions $h_{00} = 1$ and $h_{nm} = 0$ if either of the indices is negative. We proved formulas (3) and (4) using generating function methods. The recursion formula is e cient but num erically unstable. Therefore high precision arithmetics had to be uæd.

Since Fourier transform F is a unitary transform on the space of square integrable functions and since H erm ite functions are eigenfunctions of F , F $_{\rm n}$ = $i^{\rm n}$, we can also use the above form ulas to calculate the convolutions $_{Z_{-1}}^{}$ (x) $_{\text{m}}$ (x - d) dx = $i^{n+\,\text{m}}$ I $_{\!\text{nm}}$ (d):

Apart from being interesting in their own right, these convolutions give the matrix elements of the change of basis from (n(x)) to the translated basis (n(x)), which is exactly what was needed to transform the state matrix from the eigenstate basis of H to that of H d. Hence form ulas (3) and (4) were in double use in the implementation.

For some values of the parameters it was bene cial to use the scaled Herm ite functions (x) with > 1 in the diagonalization to improve resolution. Even in this case the matrix elements needed are easily derived from the above formulas. In the simulations we used less than 3000 basis vectors and calculated typically a few hundred eigenstates. This was probably not enough for all the cases but at this point our com puter resources becam e a lim iting factor.




Figure 1. Time evolution of the center of mass of the ferm ion cloud at the lattice height s = 0 (grey line), s = 3 (black line), and s = 8 (dashed line).




Figure 2. Energy spectrum of a single atom in the combined one-dimensional potential at the lattice height s=0 (grey line), s=3 (black line), and s=8 (dashed line). The energy unit is the energy quantum of the axial harmonic oscillator. The ground state energies are set to zero. A transition from a linear spectrum (harmonic oscillator) to a quadratic one occurs when the lattice is imposed. The quadratic part of the spectrum corresponds to localized states. Non-localized states appear again for higher energies, see the black line which becomes linear for n>450.

4. Results

We used the above methods to simulate the motion of the free Fermigas of potassium atoms in an optical lattice connection and a magnetic potential and compared them to the experimental results described in [5, 3, 4]. The average temperature of the gas in the experiment described in [5] was T = 90 nK, the lattice wavelength = 863 nm, the axial and radial frequencies $!_a$ = 2 $24\ s^1$ and $!_r$ = 2 $275\ s^1$, respectively, and the average atom number 25000. Recall that k = 4 = . The depth U = 2A = sE_R of the lattice given in the units of recoil energy E_R = h^2 =2m 2 was varied. Initially the trap was replaced by 15 m to excite oscillations. The results of the simulation are shown in Figure 1. The energies of the lowest lying single-particle eigenstates are also plotted against the ordinal number in Figure 2 to give some qualitative insight to the system .

In the absence of the lattice potential (s = 0) the system is reduced to a harm onic oscillator and the average position oscillates freely showing the characteristic dipole oscillation in a harm onic potential. None of the eigenstates is localized and the corresponding energy spectrum is linear. The energy quantum or the di erence between the consecutive eigenvalues gives the frequency of the oscillations.

When the height of the lattice is increased to s=3, both localized and non-localized eigenstates play a role. The oscillations of the system are damped, which can be understood as follows. A coording to the formula (2), the center of mass of the cloud is a sum periodic term s whose frequencies are given by the dierences ($\mathbf{"}_n$ $\mathbf{"}_m$)=~ between the eigenvalues $\mathbf{"}_n$ of the dynamical H am iltonian. When the eigenvalues are not evenly spaced, destructive interference causes dephasing.




Figure 3. The two eigenstates (a) and (c) of the lowest energy associated to the potential (e) with parameters k=3 and A=10 form a quasidegenerate pair. In a superposition of such states, the particle is localized in one of the wells of the potential (e). Relating to Figure 2, such states correspond to a doubly degenerate pair of eigenvalues in a quadratic spectrum. The eigenstates (b) and (d) associated to the potential (f) with parameters k=12 and A=30 are not localized. They resemble the eigenstates of the harm onic oscillator, modulated by the lattice potential. They correspond to a linear spectrum and their energies are not degenerate.

Increasing the lattice height also increases the o set of the dipolar oscillations since more and more particles become becalized. When the height of the lattice is increased to s=8, localized eigenstates dominate. The system is almost frozen to its initial position. The energy spectrum becomes almost quadratic. The spectrum corresponds to states that are localized in individual lattice potential sites. Neighbouring sites are shifted in energy according to the superimposed harmonic potential, therefore the quadratic form of the spectrum (dierence in energy of two localized particles depends essentially only on their locations in the lattice). A ctually each energy is doubly degenerate (the symmetric and the antisymmetric states formed of lattice sites at opposite sides of the center) which can be resolved by a closer look at the spectrum. Therefore, to be accurate, localized particles correspond to a superpositions of these doubly degenerate states. Representative examples of localized and non-localized eigenstates are shown in Figure 3.

It is noteworthy that in the intermediary region lowest-lying states are not localized. This is indicated by the linear parts in the spectra near origin. Hence the atoms do not tend to localize when the system is cooled down to ultra-low temperatures, on the contrary. Note that also higher energy states may be unlocalized, i.e. have a linear spectrum, as is shown for one set of parameter values in Figure 2. This is associated with the existence of higher bands of the optical lattice potential. Such states may a ect the localization and oscillation behaviour of the gas signicantly in higher temperatures.

The results are in very good qualitative and quantitative agreement both with the experiment and the semiclassical approximation presented in [5]. We compared our simulations also to two earlier experiments [3, 4] by Modugno et al. In these cases the experimentalists observed oscillations with considerably larger amplitude and higher frequency than what was predicted by the simulations. We believe that this was simply because the physical parameters used in these experiments were much more demanding for our numerical method and would have required more eigenstates to be calculated than was currently possible. The larger the displacement and the particle number, and the higher the temperature, the more eigenstates are needed for reliable results. The computer resources at our disposal were rather modest so that we have hardly pushed the method to its limits.

5. Conclusions

We have analyzed the energy spectrum and motion of a Fermigas in a combined potential. The harmonic potential alone has a linear spectrum and shows dipole oscillations of the gas when the trap center is displaced. Introducing the periodic potential transforms the spectrum gradually into quadratic one and the gas becomes localized. Intermediate cases show damped oscillations around the displaced center position. Our approach is complementary to the semiclassical analysis presented in

[5, 9], and is in good qualitative agreement with the experiments. For the parameter values which are not too challenging from the numerical point of view the results agree also quantitatively with both the experiments and the semiclassical analysis.

It is important to note that the quantum transport in the combined harm onic and periodic potential is qualitatively rather dierent from the B loch oscillation or W annier–Stark ladder behaviour in tilted periodic potentials. The two cases approach each other only when the gas moves in a region where the harm onic trap can be approximated by a linear potential. This requires a much shallower trap than that used in the experiments [3, 4, 5]. Understanding the behaviour of the non-interacting Fermigas sets the basis for investigating elects of interactions [4, 10] and eventually super uidity [11, 12].

Appendix

In this appendix we formulate the reduction from many-particle to single-particle state in the language of symplectic geometry. This formulation may be helpful in using the reduction in a more systematic way and perhaps for more general purposes.

Let us rst recall some concepts of classical mechanics using a point-like particle moving in three-dimensional space as an example. The conquration space of the particle is just $C = R^3$ whereas the coordinates of phase space M ' R^3 R include the momentum p as well as the position x. In mathematical terms, the phase space is the cotangent space T C of the conquration space and it comes equipped with a canonical non-degenerate two-form

which is known as the sym plectic form while the pair (M;!) is referred to as a sym plectic manifold. The sym metries of the phase space are the dieom orphism sof M preserving!. A coordingly, in nitesimal sym metries are the vector elds A on M whose Lie derivative satisfy L_A ! = 0. Then each in nitesimal sym metry generates a one-parameter group of sym metries at least locally, where the correspondence is given by the ow of the vector eld.

Under some mild conditions we can associate a classical observable or a function H $_{\rm A}$ on the phase space M $\,$ to an in nitesimal symmetry A . The observable is dened by the equation

which is required to be valid for all vector $\ \ \, elds\,B$ on M . In particular, since the time-evolution of a classical mechanical system preserves the sym plectic form , it is generated by an observable, which is known as the H am iltonian. In the example above it is clear that both translations and rotations are sym metries of the phase space. An in nitesimal translation is just a three-vector t 2 R³, and the corresponding observable is

Similarly, an in nitesimal rotation can be given by a three-vector ras r R where the components of R are the in nitesimal rotations about the coordinate axes. The associated classical observable is then

$$H_r(x;p) = (x p) r$$

The general pattern emerging is that given a Lie algebra g of in nitesimal symmetries, the collection of associated observables is most conveniently expressed as a map from the phase space M to the dual g, that is, the space of linear maps g! R. In this way we associated the momentum p to the translations and the impulse moment x p to the rotations. Therefore the map : M! g de ned by the equation

$$((x);A) = H_A(x)$$

for all A 2 g and x 2 M is known as the moment map. The Lie group G corresponding to the Lie algebra g acts naturally on both g and g, and the moment map is equivariant in the sense that (gx) = g(x) for all g in G.

Returning to quantum mechanics, let H be a Hilbert space, on which a compact group G acts unitarily. This is the general fram ework for a quantum mechanical system with the symmetry group G. Now the projective space

$$P(H) = fv 2 H jkvk = 1q = U(1)$$

of pure states is canonically a symplectic manifold, on which G acts preserving the symplectic form. Hence from the point of view of symplectic geometry, all that we have said previously applies.

Let g be the Lie algebra of G. The observable associated to an in nitesimal symmetry A 2 g is calculated to be the expectation value $H_A(v) = hv j \hat{A}$ jvi where \hat{A} stands for the representation of A in H. There is also the moment map

from the projective space to the dual of g de ned by the equation

$$H_{A}(v) = ((v);A)$$

Hence the expectation value of \hat{A} in the vector state v is given by $\hat{hA}i = (v); A)$. We can extend the moment map to any state by linearity. Then the moment map image () is a kind of reduced state which can be used to calculate expectation values for all observables in g. The point is that () may be a much simpler object than the state we started with. Furthermore, the equivariance of the moment map means that

for every element U of G. In particular, if the Ham iltonian H itself belongs to g, then the time evolution of the reduced state () is given by the usual Schrodinger equation.

In the application we have in m ind G is the group of unitary transformations of the single-particle H ilbert space V and g may be identied with the single-particle observables or the Hermitian operators on V. U sing the pairing (B;A) = Tr(BA) we may identify g with its dual. Let H be the fermionic Fock space associated to V. Then G acts naturally on H and by the general theory

for any m any-particle state $\,$ and single-particle observable A . It is easy to check that $\,$ () is a positive operator with trace

since the number operator N is indeed the representation of I 2 g in the ferm ionic Fock space.

In conclusion, we can represent any many-particle state by a single-particle state () when calculating expectation values of single-particle observables. It is easy to calculate () explicitly in a given basis (v_n) of V using equation A 1. In terms of the annihilation and creation operators associated to this basis, the matrix elements of () are

Applying the above procedure to the grand canonical ensemble (1) yields

is the Ferm i-D irac distribution which is usually derived using the partition function approach. The preceeding discussion was not just for the sake of an appealing generalization but also to show that the reduction to the single-particle state form alism gives not only the energy distribution but a state matrix obeying the Schrodinger equation.
