## K inetic theory of uctuations in conducting system s

We propose an elective eld theory describing the time dependent uctuations of electrons in conducting systems, generalizing the well known kinetic theory of uctuations. We apply then the theory to analyze the elects of strong electron-electron and electron-phonon scattering on the statistics of current uctuations. We nd that if the electron-electron scattering length is much shorter than the transport mean free path the higher cum ulants of current are parametrically enhanced.

Fluctuations of electric current in time have been the subject of fundam ental and applied research since the time of Schottky. They have been a centerpiece in the study of systems ranging from vacuum tubes to quantum Hallbars (for a review see [1]). More recently noise has been recognized as an important diagnostic probe for the nature of disorder and interactions. Traditionally the number of electrons taking part in transport in m acroscopic system s is large; for that reason current uctuations obey nearly G aussian statistics. Under such circum stances it is the power spectrum which is the object of prim ary interest when addressing the uctuations. However, as the sample size shrinks down from a vacuum tube to a nano junction, and the currents involved becom e correspondingly smaller, the central lim it theorem does not apply any more, and information concerning higher current cum ulants m ay be needed. Various techniques have been applied to address this issue [1, 2, 3, 4, 5, 6].

There is an interesting and relevant class of system s out of equilibrium in which the e ect of quantum interference on transport quantities is negligible. Transport through such systems is often described by classical kinetic equations (e.g. the Boltzm ann equation). The intensity of the noise spectrum can then found employing a related approach, known as the kinetic theory of uctuations (KTF) [7, 8, 9]. The appeal of this approach is its intuitive transparency, yet traditionally it was constructed to describe pair correlation functions, hence was limited to nding the second current cumulant. In a recent insightfulwork Nagaev [10] has proposed a generalization of the KTF, expressing higher order cum ulants in terms of pair correlators. Using this idea (which was term ed the \cascade approach"), N agaev calculated the third and the fourth cum ulants of the current. W hile this approach was shown to successfully address a num ber of problem s, its (quantum -m echanical) m icroscopic foundations, as well as its form ulation in terms of an e ective eld theory (which would allow for further generalization, such as including interactions or calculating the full

tion, such as including interactions or calculating the full counting statistics (FCS)) were not fully understood. A n important step in the latter direction was an introduction of a stochastic path integral by Pilgram, Jordan, Sukhorukov, and Buttiker [11].

In the present paper we propose a phenom enological ef-

fective eld theory describing the time dependent uctuations in phase space of electrons in conducting system s. This is a eld-theoretical in plem entation of the Nagaev's regression scheme. This theory allows for various generalizations, including the e ects of electron-phonon and electron-electron interactions. In a number of instances, this theory is equivalent (up to small quantum corrections) [12, 13] to the non-linear -m odel form ulation of the problem [6]. In particular, for non-interacting electrons it reproduces the FCS [14] of current uctuations obtained earlier within quantum approaches. We apply the theory to systems with a strong electron-electron scattering (\hot electron regime"). We nd that (in the absence of um klapp processes), the current statistics changes dram atically depending on the relation between the electron-electron scattering length le e and the elastic m ean free path. Speci cally, in the regime  $l_{e,e}$ ltr, when the electrons form a weakly disordered liquid, the current cum ulants are param etrically enhanced due to the electron-electron scattering. We nd the scaling law governing the dependence of the FCS of hot electrons on the ratio  $l_{e e} = l_{tr}$ . Finally, we show that under strong electron-phonon interaction the statistics is G aussian.

The e ective action. The KTF can be cast as a Boltz-m ann equation with a Langevin-type noise [9, 15]

Here we have introduced the Liouville operator

$$\hat{\mathbf{L}} = \frac{\theta}{\theta t} + \frac{p}{m} \frac{\theta}{\theta x} + e E \frac{\theta}{\theta p}; \qquad (2)$$

while f(p;x;t)dxdp is the number of electrons in a unit cell centered  $a_p^{t}(p;x)$  in a phase space at time t. With  $(x;t) = e_p f(p;x;t)$  being the local density of electrons, the self-consistent electric eld satis es divE = 4 . 1 The operator  $\hat{1} = \hat{1}_{dis} + \hat{1}_{e ph} + \hat{1}_{e e}$ is the collision integral [8] with the respective contributions coming from disorder, electron-phonon and electron-electron scattering. The Langevin random source J (p;x;t) in (1) represents the uctuations of the net ux of particle in phase space at (p;x). These uctuations are the consequence of the scattering processes

described by the respective collision integrals, and should be treated consistently along with the collision integrals to account for the conserved quantities. For the physics considered here (and disregarding quantum corrections) the interplay among the various scattering channels can be neglected. Within the same e accuracy the Langevin ux is the sum of three uncorrelated random processes  $J = J_{dis} + J_{ee} + J_{e ph}$ . Its correlation function can be found employing sem iclassical considerations [9]. The random ux correlator can be written schematically as h J (p;x;t) J (p<sup>0</sup>;x<sup>0</sup>;t) = (x x<sup>0</sup>) (t the [p;p<sup>0</sup>;x], where H [p;p<sup>0</sup>;x] = H\_{dis}[p;p<sup>0</sup>;x] + H\_{ee}[p;p<sup>0</sup>;x] + H<sub>e ph</sub> [p;p<sup>0</sup>;x]. Explicit expressions for the collision integrals and the pair correlation functions of the random uxes are available [8, 15].

We consider a two-term inalsystem subject to an external voltage bias V; the am bient tem perature at the reservoirs is T. Transport through this system is a stochastic process. The charge transm itted over a time interval t is Q (t) =  ${}_0^{R_t} dt^0 I(t^0)$  where I(t) is the electric current. The number of particles n = Q = e is a uctuating quantity described by probability distribution function P (n). The Fourier transform of the latter ()  ${}_n e^{i n} P(n)$  is the characteristic function which provides a complete statistical description of the problem. Constructing a

eld theory it is natural to look for a characteristic function in a functional integral representation [6]

Here f; f are independent bosonic elds and the measure of integration is at. The eld f (p;x;t) is the phase space density operator within the KTF;  $\sim (p;x;t)$  is an auxiliary 'counting eld'. The eld f (p;x;t) accounts for uctuations of this 'counting eld'. The e ective action consists of two parts

The propagation of uctuations in phase space is described by the dynam ical part of the elective action:

The second part of the action accounts for the generation of uctuations:

The elective action, Eqs. (5) and (6), can be obtained by exponentiating the equation of motion (1) with a help of the Lagrange multiplier f (p;x;t) and averaging the resulting  $e^{iS}$  over the Langevin uxes. The counting eld, as a function of p, x, and t should be chosen accordingly to the problem one is interested in. It is illum inating to note that once the uctuations of counting eld are neglected in  $S_{N oise}$ , the elective action, (4) is equivalent to the standard KTF (i.e., it yields correctly the current-current uctuations but not higher cumulants).

So far our treatment has been general. We now assume that the electron gas is degenerate and consider a quasi one-dimensional di usive conductor, where the momentum relaxation length is much shorter than the system length  $(l_{tr} L)$ . The problem then simplies considerably. Additional important parameters are the di usion coecient, D, the single particle density of states at the Ferm i level and the cross section S. Together they de ne the O hm ic conductance  $G = e^2 D S = L \cdot W$  ithin the di usive approximation, (6) takes the form

where  $p^2=2m$  is the kinetic energy. Eq.(7) describes propagation of uctuations in di usive system in the presence of a long range C oulom b interaction. In the absence of the C oulom b interaction, one should set E = 0.

The noise-generating part of the action will also have three contributions, corresponding to elastic (in purity), electron-phonon and electron-electron scattering. The noise generated through elastic scattering is given by

One can check that the self-consistent eld E does

not a ect the low frequency current statistics. Indeed,

a static electric eld  $E = Q_x (x)$  can be eliminated from Eqs. (7), (8) by redening the energy, + e(x)! This implies that the counting statistics is the same in the interacting and non-interacting problems for frequencies much smaller than the inverse Thouless time, !  $D = L^2$ . We will consider this regime below and thus set E = 0.

W e are interested in the statistics of the number of particles traversing the system during a certain time w indow, irrespective of how this ow is distributed over that interval. W e thus select the counting eld to be

To analyze the counting statistics we use a saddle point approach, which is justilled by a large value of the dimensionless conductance g  $G = (e^2 = h)$  1. Note that this is the same condition which also allow s us to neglect the quantum corrections to the current statistics due to the weak localization and the interaction (A ltshuler-A ronov) elects. The boundary conditions for the distribution function are f(;0) = f<sup>L</sup>(); f(;L) = f<sup>R</sup>() where f<sup>L</sup>(R) are the equilibrium distribution functions of the electrons on the left (right) reservoir. The auxiliary eld f vanishes at the boundaries.

Current statistics and inelastic processes. When the inelastic processes can be neglected (which requires that the shortest inelastic length is longer than the sample size,  $l_{in}$  L), the saddle-point equations following from (7), (8) perm it an analytical solution [12, 19, 20]. In particular, in the shot-noise lim it (eV T) the resulting action reads (including a source term for the average current, is  $^{1} = iGV t$ )

The found characteristic function, () =  $expfis^{dis}g$ eq.(10), agrees with the known result for the counting statistics obtained earlier [5, 6, 14] within the quantum approaches. This demonstrates the equivalence [12], up to 1=g corrections, between our elective theory and the

-m odel form alism [6]. Indeed, in this case the above e ective action can also be obtained from a particular param etrization of non-linear -m odel [13].

In the opposite limit,  $l_{in}$  L, the collision integral plays a major role. There is only a small number of hydrodynamic modes (determined by the conservation laws) that propagate for a distances longer that  $l_{in}$ . For electron-electron collisions these are the uctuations of the electron density and the energy (or, in other words, of the chemical potential and the temperature). By the same token, one has to keep only these two modes in the noise part of the action,  $S_{N\,oise}$ , Eq. (8). In the presence of a strong electron-phonon scattering,  $l_{e\,\,ph}$  L, the collision integral  $\hat{l}_{e\,\,ph}$  conserves only the number of electrons. The role of the electron-phonon scattering

thus am ounts to projecting the action onto the mode of the density (chem ical potential) uctuations.

We consider now the case of a strong electron-electron scattering,  $l_{ee}$  L, in detail. A fler projecting the uctuating elds f (p;x;t) and f (p;x;t) in (5), (6) onto the relevant subspace, we are left with the elds and T that parametrize the uctuations of a chemical potential and the tem perature, respectively, and the conjugate elds and T. In terms of these elds the action (5), (6) takes the form

Here we introduced a thermal diusion coecient D (T) =  $v_F^2 \left( \frac{1}{tr} + \frac{1}{ee} \right)^{-1}$  (T))  $^1$  =3, where

with n;n<sup>0</sup> being the direction of the m omenta p;p<sup>0</sup> on the Ferm i surface. Physically, 1=  $_{ee}$  is the relaxation rate of the energy current due to the electron-electron collision processes. As we are going to show, there are two strikingly di erent cases. For  $l_{tr}$   $l_{ee}$ , which is the commonly considered hot-electron regine, the therm ald i usion and particle di usion constants coincide, D ' D  $\cdot$  O  $\cdot$  O  $\cdot$  D  $\cdot$  O  $\cdot$  C  $\cdot$  D  $\cdot$  O  $\cdot$  D  $\cdot$  O  $\cdot$  D  $\cdot$  O  $\cdot$  D  $\cdot$  O  $\cdot$  D  $\cdot$ 

The situation is qualitatively di erent in the regime of very strong electron-electron scattering (or, alternatively, of a very clean system),  $l_{ee} = l_{tr}$ , when the electrons form a liquid owing through a weak disorder potential. In the absence of um klapp processes, the electron-electron scattering conserves the total momentum, so that the density di usion is much faster than the therm al di usion,  $^2 = D = D$  (T) 1. The saddle-point equations following from (11), (12) and determining the FCS of hot electrons do not permit an analytic solution. To obtain a qualitative understanding of the problem we rst consider a simplied model, approximating D (T) by a constant D. In this case, the action (11), (12) allows us to determ ine the scaling dependence of the FCS on . By perform ing a rescaling of elds ! = , ! =

in (11), (12) we nd that ( ) has the following scaling form ,

where the function F (x;y) governs the FCS at = 1, () = expf GTtF(; eV=T)g. This implies that in the equilibrium limit, T eV, the cumulants  $S_n$  with n 3 in the electronic liquid are strongly enhanced compared to their values in the conventional hot-electron magin c (= 1). Specifically, the enhancement forther

regine ( = 1). Speci cally, the enhancement factor is  $^{2m}$  for the cumulants  $S_{2m+1}$  and  $S_{2m+2}$ . In the opposite limit (T ! 0 at nite V), the enhancement starts already from  $S_2$ , with  $S_n$  enhanced by the factor  $^{n-1}$ . Physically, the enhancement of higher moments of current uctuations is due to the coupling between the mode of electric conductivity and the slow mode of the thermal conductivity.

So far we have used a model of a temperature independent therm al di usion coe cient. On the other hand, in the Ferm i-liquid theory, D (T)  $_{\rm F} v_{\rm F}^2 = T^2$ . We argue now that in a realistic situation the above strong enhancement of the cumulants in the lee ltr regime remains parametrically valid, with  $^2$  replaced by  $D = D (T_e)$ , where  $T_e$  is the characteristic tem perature in the system. In particular, in the equilibrium situation (V = 0),  $T_e$  is simply given by the tem peratute T of the reservoirs,<sup>2</sup> tr = ee (T). In the non-equilibrium limit (T = 0, V nite), the elective tem perature is found to increase exponentially with V [16], yielding asymptotically  $expf(3=4^{2})_{tr} = ee(V)g$ 

Finally, we consider the case of a strong electronphonon scattering. The only soft modes allowed in this case ( $l_{e\,ph}$  L) are uctuations of chemical potential. The saddle point equations  $Q^2 = 0$ ;  $Q^2 = 0$  along with the boundary conditions lead to the trivial solution

represents G aussian uctuations, so that higher cum ulants are suppressed by the electron-phonon scattering. This is consistent with earlier predictions based on qualitative argum ents [1] and calculations of the third cum ulant [6]. How ever, to the best of our know ledge, it is the rst analytic derivation of this general result.

To summarize, we have proposed an elective theory describing the creation and evolution of uctuations in phase space for degenerate electron gases and liquids. W e have employed this theory to analyze statistical properties of noise in disordered conductors. We have reproduced known results for free ferm ion and con rm ed the prediction of Gaussian statistics for the case of strong electron-phonon scattering. We have analyzed the e ect of electron-electron scattering on the statistics of current uctuations and established a scaling relation governing the dependence of the FCS on the ratio  $l_{tr} = l_{ee}$ , showing that the statistics di eresparam etrically between the lee cases. Speci cally, in the latter, 1+r l<sub>ee</sub> and l<sub>tr</sub> when the electrons form a liquid owing through weak disorder, the current cum ulants are param etrically enhanced by electron-electron scattering. This is related to the coupling of the density mode to the slow mode of tem perature uctuations. The regime  $l_{tr}$ lee is thus m ost favorable for experim ental investigation of higher cum ulants of current.
