G eneralizing the wavelet-based multifractal form alism to vector-valued random elds: application to turbulent velocity and vorticity 3D num erical data

We use singular value decomposition techniques to generalize the wavelet transform modulus maxim a method to themultifractal analysis of vector-valued random elds. The method is calibrated on synthetic multifractal 2D vector measures and monofractal 3D fractional B rownian vector elds. We report the results of some application to the velocity and vorticity elds issued from 3D isotropic turbulence simulations. This study reveals the existence of an intimate relationship between the singularity spectra of these two vector elds which are found signi cantly more intermittent than previously estimated from longitudinal and transverse velocity increment statistics.

The multifractal form alism was introduced in the context of fully-developed turbulence data analysis and m odeling to account for the experim ental observation of som e deviation to Kolm ogorov theory (K41) of hom ogenous and isotropic turbulence [1]. The predictions of variousmultiplicative cascadem odels, including the weighted curdling (binom ial) model proposed by M andelbrot [2], were tested using box-counting (BC) estimates of the so-called f() singularity spectrum of the dissipation eld [3]. Alternatively, the intermittent nature of the velocity uctuations were investigated via the computation of the D (h) singularity spectrum using the structure function (SF) method [4]. Unfortunately, both types of studies su ered from severe insu ciencies. On the one hand, they were mostly lim ited by one point probe measurements to the analysis of one (longitudinal) velocity component and to some 1D surrogate approximation of the dissipation [5]. On the other hand, both the BC and SF m ethodologies have intrinsic lim itations and fail. to fully characterize the corresponding singularity spectrum since only the strongest singularities are a priori. amenable to these techniques [6]. In the early nineties, a wavelet-based statistical approach was proposed as a uni ed multifractal description of singular measures and multi-a ne functions [6]. Applications of the so-called wavelet transform modulus maxima (WTMM) method have already provided insight into a wide variety of problem s, e.g., fully developed turbulence, econophysics, m eteorology, physiology and DNA sequences [7, 8]. Later on, the W TM M method was generalized to 2D for multifractal analysis of rough surfaces [9], with very prom ising results in the context of the geophysical study of the interm ittent nature of satellite in ages of the cloud structure [10, 11] and the medical assist in the diagnosis in digitized m am m ogram s [11, 12]. Recently the W TMM method has been further extended to 3D analysis and applied to dissipation and enstrophy 3D num ericaldata issue from isotropic turbulence direct num erical simulations (DNS) [13, 14]. Thus far, the multifractal description has been mainly devoted to scalar measures and functions. In the spirit of a preliminary theoretical study of self-similar vector-valued measures by Falconer and O'N eil [15], our objective here is to generalize the W TMM method to vector-valued random elds with the specic goal to achieve a comparative 3D vectorial multifractal analysis of DNS velocity and vorticity elds.

Let us note V (x = $(x_1; x_2; ::; x_d)$), a vector eld with square integrable scalar components $V_j(x)$, j = 1; 2; ::; d. A long the line of the 3D W TM M method [13, 14], let us de ned wavelets $_i(x) = @(x) = @x_i$ for i = 1; 2; ::; d respectively, where (x) is a scalar sm oothing function well localized around jxj = 0. The wavelet transform (W T) of V at point b and scale a is the following tensor [14]:

where

In order to characterize the local H older regularity of V, one needs to nd the direction that locally corresponds to the maximum amplitude variation of V. This can be obtained from the singular value decomposition (SVD) [16] of the matrix (T $_{i}$ [V_j]) (Eq. (1)):

where G and H are orthogonalm atrices ($G^T G = H^T H = I_d$) and = diag(₁; ₂;::; _d) with _i 0, for 1 i d. The columns of G and H are referred to as the left and right singular vectors, and the singular values of T [V] are the non-negative square roots _i of the d eigenvalues of T [V]^T T [V]. Note that this decomposition is unique, up to some permutation of the _i's.

The direction of the largest amplitude variation of V , at point b and scale a, is thus given by the eigenvector G (b; a) associated to the spectral radius (b; a) = $\max_{i=1} (b;a)$. One is thus led to the analysis of the vector eld T; [V](b;a) = (b;a)G(b;a). Following the W TMM analysis of scalar elds [9, 13, 14], let us de ne, at a given scale a, the W TM M as the position b where the modulus M [V](b;a) = jT; [V](b;a)j= (b;a) is locally maximum along the direction of G (b;a). These WTMM lie on connected (d 1) hypersurfaces called maxim a hypersurfaces (see Figs 2b and 2c). In theory, at each scale a, one only needs to record the position of (W TMMM) along the maxim a the localm axim a of M hypersurfaces together with the value of M [V] and the direction of G. These W TM M M are disposed along connected curves across scales called maxim a lines living in a (d+1) space (x;a). The W T skeleton is then de ned as the set of maxim a lines that converge to the $(x_1; x_2; ::; x_d)$ hyperplane in the lim it a ! 0^+ (see Fig. 2d). The local Holder regularity of V is estimated from the power-law $a^{h(r_0)}$ along the maxim a line behaviorM [V] L_{ro} (a) $\mathrm{L}_{\,r_0}$ (a) pointing to the point $r_0\,$ in the limit a $!\,$ 0^+ , provided the H older exponent $h(r_0)$ be sm aller than the number n of zero moments of the analyzing wavelet [17]. As for scalar elds [6, 9, 13], the tensorial WTMM

method consists in de ning the partition functions:

where q 2 R and L (a) is the set of maxima lines that exist at scale a in the W T skeleton. Then by Legendre transforming (q), one gets the singularity spectrum D (h) = m in_q (qh (q)), de ned as the Hausdor dimension of the set of points r where h (r) = h. A lternatively, one can compute the m ean quantities:

where W [V](q;L;a) = M [V](r;a) $^{q}=Z$ (q;a) is a Boltzmann weight computed from the WT skeleton. From the scaling behavior of these quantities, one can extract h(q) = $\lim_{a! 0^{+}} h(q;a) = \ln a$ and D (q) = $\lim_{a! 0^{+}} D(q;a) = \ln a$ and therefore the D (h) spectrum.




FIG.1: First construction steps of a singular vector-valued measure supported by the unit square. The norm of the four sim illitude S_1 are $p_1 = p_4 = 1=2$, $p_2 = 2$ and $p_3 = 1$ [15].

As a test application of this extension of the W TMM m ethod to the vector situation, let us consider the selfsim ilar 2D vectorm easures supported by the unit square de ned in Ref. [15]. As sketched in Fig. 1, from step n to step n + 1, each square is divided into 4 identical subsquares and for each of these sub-squares, one de nes a sim ilitude S_i that transforms the vector V ⁽ⁿ⁾ at step n into the vector V ⁽ⁿ⁺¹⁾ for the sub-square i at step n + 1. The -additivity property of positive scalar m easures is

now replaced by the vectorial additivity condition V $^{(n)} = P_{\substack{i=1\\ j=1}}^{4} V_{i}^{(n+1)}$. A straightforward calculation yields the following analytical expression for the partition function scaling exponents (q) (Eq. (4)):

where p_i (i = 1 to 4), are the norm s of the sim ilitudes Si. Note that this formula is identical to the theoretical spectrum of a non-conservative scalar multinom ial m easure distributed on the unit square with the weights p_i [13, 14]. Indeed, if the construction process in Fig. 1 is conservative from a vectorial point of view, it does not conserve the norm of the measure: $_{i=1}^{4} p_i = 4 > 1.$ From Legendre transforming Eq. (6), one gets a D (h) singularity spectrum with a characteristic multifractal single-hum ped shape (see Fig. 3d) supported by the inter $val[h_{m in}; h_{m ax}] = [1 \log_2 (m ax_i p_i); 1 \log_2 (m in_i p_i)]$ and whose maximum $D_F =$ (0) = 2 is the signature that the considered vector-valued measure is alm ost everywhere singular on the unit square.




FIG.2: 2D W T analysis of the 2D vector-valued self-sim ilar m easure shown in Fig.1 but with system atic random permutation of the S_1 . is a rst-order analyzing wavelet ((r) is the G aussian). (a) 32 grey-scale coding of the central $(128)^2$ portion of the original $(1024)^2$ eld. In (b) a = 2^2 w and (c) a = 2^3 w, are shown the maxim a chains; from the local m axim a (W TM M M) of M along these chains () originates a black arrow whose length is proportional to M and direction is along T; [V]. (d) W T skeleton obtained by linking the W TM M M across scales. W = 7 (pixels) is the characteristic size of at the smallest resolved scale.




FIG.3: Multifractal analysis of the 2D vector-valued random m easure eld using the 2D tensorial W TM M m ethod () and BC techniques (). (a) $\log_2 Z$ (q;a) vs $\log_2 a$; (b) h(q;a) vs $\log_2 a$; the solid lines correspond to linear regression ts over w . a. 2^4 w . (c) (q) vs q; the solid line corresponds to the theoretical prediction (Eq. (6)). (d) D (h) vs h; the solid line is the Legendre transform of Eq. (6).

In Fig. 2 are illustrated the main steps of our tensorial W T m ethodology when applied to 16 $(1024)^2$ realizations of a random generalization of the vectorial multiplicative construction process described in Fig.1. Focusing on the central $(128)^2$ sub-square, we show the singular vectorvalued m easure (Fig. 2a) and the corresponding W TM M chains computed with a rst order analyzing wavelet at two di erent scales (Figs 2b and 2c). On these maxin a chains, the black dots correspond to the location of the W TM M M at these scales. The size of the arrows that originate from each black dot is proportional to the spectral radius (b; a) and its direction is along the eigenvector G (b;a). W hen linking these W TM M M across scales, one gets the set of maxim a lines shown in Fig. 2d as de ning the W T skeleton. In Fig. 3 are reported the results of the com putation of the multifractal spectra (annealed averaging). As shown in Fig. 3a, Z (q;a) (Eq. (4)) display nice scaling behavior over four octaves (when plotted versus a in a logarithm ic representation), for q 2] 2;4 [for which statistical convergence tums out to be achieved. A linear regression t of the

data yields the nonlinear (q) spectrum shown in Fig.3c, in remarkable agreem ent with the theoretical spectrum (Eq. (6)). This multifractal diagnosis is con rm ed in Fig. 3b where the slope of h(q;a) (Eq. (5)) versus $\log_2 a_1$ clearly depends on q. From the estimate of h(q) and D (q) (Eq. (5)), one gets the single-hum ped D (h) curve shown in Fig. 3d which m atches perfectly the theoretical D (h) spectrum. In Fig. 3, we have reported for com parison, the results obtained when using a box-counting (BC) algorithm adapted to the multifractal analysis of singular vector-valued m easures [14, 15, 18]. There is no doubt that BC provides much poorer results, especially concerning the estimates of (q), h (q) and D (q) for negative q values. This de ciency mainly results from the fact that the vectorial resultant m ay be very sm all whereas the norm s of the vector m easures in the sub-boxes are not small at all. The results reported in Fig. 3 bring the dem onstration that our tensorialW TMM m ethodology paves the way from multifractal analysis of singular scalarm easures to singular vectorm easures.




FIG. 4: Multifractal analysis of Levêque DNS velocity () and vorticity () elds (d = 3, 18 snapshots) using the tensorial 3D W TMM method; the symbols () correspond to a similar analysis of vector-valued fractional B rownian motions, B^{H = 1=3}. (a) log₂ Z (q;a) vs log₂ a; (b) h₁ (q;a) vs log₂ a and h_v (q;a) log₂ a vs log₂ a; the solid and dashed lines correspond to linear regression ts over $2^{1:5}$ w . a. $2^{3:9}$ w . (c) v (q), ! (q) and B¹⁼³ (q) vs q; (d) D v (h + 1), D ! (h) vs h; the dashed lines correspond to log-normal regression ts with the parameter values C^v₂ = 0:049 and C¹₂ = 0:055; the dotted line is the experimental singularity spectrum (C^v₂ = 0:025) for 1D longitudinal velocity increments [19].

In Fig. 4 are reported the results of the application of our tensorial W TM M method to isotropic turbulence DNS data obtained by Levêque. This comparative 3D

multifractal analysis of the velocity (v) and vorticity (!) elds corresponds to som e averaging over 18 snapshots of $(256)^3$ DNS run at R = 140. As shown in Figs. 4a and 4b, both the Z (q;a) and h (q;a) partition functions display rather nice scaling properties for q = 4 to 6, except at small scales (a . $2^{1:5}$ W) where some curvature is observed in the log-log plots likely induced by dissipation e ects [1, 19]. Linear regression t of the data (Fig. 4a) in the range $2^{1:5}$ w 2^{3:9} w а yields the nonlinear $_{v}$ (q) and $_{!}$ (q) spectra shown in Fig. 4c, the hallmark of multifractality. For the vorticity eld, ! (q) is a decreasing function similar to the one obtained for the singular vector-valued measure in Fig. 3c; hence h(q) = 0 (q) = 0 and the support of the D (h) singularity spectrum expands over negative h values as shown in Fig. 4d. In contrast $_{v}$ (g) is an increasing function which implies that h(q) > 0 as the signature that v is a continuous function. Let us point out that the so-obtained v (q) curve signi cantly departs from the linear behavior obtained for 18 (256)³ realizations of vector-valued fractional B row nian m otions B¹⁼³ of index H = 1=3, in good agreement with the theoretical spectrum $B^{1=3}(q) = q=3$ 3. But even more remarkable, the results reported in Fig. 4b for h (q;a) suggest, up to statistical uncertainty, the validity of the relationship $h_{!}(q) = h_{v}(q)$ 1. Actually, as shown in Fig. 4d, D_{\perp} (h) and D_{ν} (h) curves are likely to coincide after translating the later by one unit on the left. This

is to our know ledge the rst num erical evidence that the singularity spectra of v and ! m ight be so intim ately related: $D_v (h + 1) = D_i (h)$ (a result that could have been guessed intuitively by noticing that ! = $r \wedge v$ involves rst order derivatives on ly). Finally, let us note that, for both elds, the (q) and D (h) data are quite well tted by log-norm alparabolic spectra [19]:

D (h) = C_0 (h + C_1)^2 = 2C_2: (7)

Both elds are found singular alm ost everywhere: $C_0^v =$ $v(q = 0) = D_v(q = 0) = 3:02$ 0:02 and $C_0^! =$ 3:01 0:02. The most frequent Holder exponent h(q = C_1 (corresponding to the maximum of D (h)) 0) = takes the value C_1^v ' $C_1^! + 1 = 0.34$ 0:02. Indeed, this estimate is much closer to the K 41 prediction h = 1=3 [1] than previous experimental measurements (h = 0.39)0:02) based on the analysis of longitudinal velocity uctuations [19]. Consistent estimates are obtained for C_2 (that characterizes the width of D (h)): $C_2^{v} = 0.049$ 0.003 and $C_2^{!} = 0.055$ 0.004. Note that these values are much larger than the experim ental estim ate $C_2 = 0.025$ 0.003 derived for 1D longitudinal velocity increment statistics [19]. A ctually they are comparable to the value $C_2 = 0.040$ extracted from experimental transverse velocity increments [19b].

To conclude, we have generalized the W TM M method to vector-valued random elds. P relim inary applications to DNS turbulence data have revealed the existence of an intim ate relationship between the velocity and vorticity 3D statistics that turn out to be signi cantly more interm ittent than previously estim ated from 1D longitudinal velocity increments statistics. This new methodology looks very prom ising to m any extents. Thanks to the SVD, one can focus on uctuations that are locally con ned in 2D (m in $_{i}$ = 0) or in 1D (the two smallest i are zero) and then simultaneously proceed to a multifractal and structural analysis of turbulent ows. The investigation along this line of vorticity sheets and vorticity laments in DNS is in current progress. We are very grateful to E.
