W eak dynam ical localization in periodically kicked cold atom ic gases

Q uantum kicked rotor was recently realized in experiments with cold atom ic gases and standing optical waves. As predicted, it exhibits dynam ical localization in the momentum space. Here we consider the weak localization regime concentrating on the Ehrenfest time scale. The later accounts for the spread-time of a minimal wavepacket and is proportional to the logarithm of the Planck constant. We show that the onset of the dynam ical localization is essentially delayed by four Ehrenfest times and give quantitative predictions suitable for an experimental veri cation.

Unprecedented degree of control reached in experiments with ultra-cold atom ic gases [1] allows to investigate various fundam ental quantum phenom ena. A realization of quantum kicked rotor (OKR) is one such possibility that recently attracted a lot of attention [2, 3, 4, 5]. To this end cold atoms are placed in a spatially periodic potential $V_0 \cos(2k_L x)$ created by two counterpropagated optical beam s. The potential is switched on periodically for a short time p T, giving a kick to the atom s; here T is a period of such kicks. The evolution of the atom icm om enta distribution m ay be m on itored after a certain num ber of kicks. If the gas is su ciently dilute [6], one may model it with the single { particle Ham iltonian, that upon the proper rescaling takes the form [7] of theQKR:

Here $2k_{\rm L}x$ and time is measured in units of the kick period, T. The momentum operator is de ned as $\hat{1} =$ ik@, where the dimensionless Planck constant is given by $k = 8hT k_{\rm L}^2 = (2m)$. Finally, the classical stochastic parameter is $K = kV_0 \ p = h$.




FIG.1: The momentum dispersion for K = 6:1 and k = 0:6 { full line; the classical lim it (k ! 0) { dashed line, standard weak localization ($t_E = 0$) { dashed-dotted line; the lim it 2 ! 0, Eq. (3) { long-dashed line.

The classical kicked rotor is known to have the rich and complicated behavior [8]. In particular, for su ciently large K ($^{>}$ 5), it exhibits the chaotic di usion in the space of angular m om entum [8]. The latter is associated with the di usive expansion of an initially sharp m om enta distribution: $hl^2(t)i h(l(t) l(0))i = 2D_{cl}t$ (dashed line on Fig. 1). For su ciently large K, the classical di usion constant m ay be approxim ated by K 2 =4 [8]. The higher order correction is an oscillatory function of the stochastic parameter, i.e., D $_{cl}$ (K) $\frac{1}{4}$ K² (1 $3J_2(K) + 2J_2^2(K)$ [9, 10]. It was realized a while ago [11, 12] that quantum interference destroys the diusion in the long time limit and leads to localization: ² at t > t_L $D_{cl}=k^2 = {}^2=D_{cl}$, where the hl^2 (t) i ! localization length is given by = D_{cl}=k. For a large localization length k, there is a long crossover regime, $1 < t < t_L$, between the classical di usion and quantum

localization.

It was suggested in Ref. [13], that the QKR may be m apped onto the one{dim ensionalAnderson localization with the long range disorder. The universal long { time behavior of the latter is described by the non { linear sign a { model [14], resulting in the standard weak { localization correction [15, 16]: hl^2 (t) i = 2D_{cl}t (1) $0.75 t=t_{L}$) (dashed { dotted line on Fig. 1). Notice, that the correction is linear in k and non-analytic in time. In an apparent contradiction with this fact, explicit studies [17, 18] of the rst few kicks show only renormalization of the diusion constant starting from terms k^2 . The aim of this paper is to develop a quantitative description of the classical to quantum crossover for the QKR that, in particular, accounts for these con icting observations.

It is known in various contexts [19] that such crossover involves an additional time scale, t_E , called an Ehrenfest (or breaking) time. For a generic quantum mapping, it was rst shown by Berm an and Zaslavski [20, 21], that quantum corrections become comparable to the classical limit at the time t_E . This is the time needed for a minim alquantum wavepacket, $_0 l_0$ ' k, to spread uniform by over the angular direction. Due to the chaotic mo-

tion, trajectories diverge as $(t) = {}_{0}e^{t}$, where is the classical Lyapunov exponent. For K 1, = ln (K = 2) [8]. Estimating l_{0} K ${}_{0}$ { a typical momenta dispersion after one kick, one nds for the Ehrenfest time:

It is widely believed [12, 20, 21, 22] that this interm ediate, $1 < t_E < t_L$, time scale is indeed relevant for the quantum evolution of classically chaotic systems. This observation was put on the quantitative basis in Ref. [23] in the context of localization caused by classical scatterers. In this paper we adopt methods of Ref. [23] to the essentially di erent problem of the QKR.

In the leading order in k we found for the $m \mbox{ om entum dispersion}$:




FIG.2: The rst quantum correction to the density (density correlator: (a) one (loop weak localization diagram; (b) its im age in the momentum space; (c) sem iclassical H ikam ibox.

where (t) is the step function (long-dashed line on Fig. 1). At relatively large time, $t_E = t < t_L$ our result approaches the standard weak {localization, mentioned above. However, corrections of the order of k are absent for t $4t_E$. The delay is caused by the interference nature of the localization. Indeed, the rst correction originates from the interference of two closed { loop counter{propagating trajectories, see Fig.2. It takes time about t_E for classical trajectories passing through (alm ost) the same value of the momentum to diverge and take counter{propagating roots. As a result, the interference e ects are practically absent at smaller times and show up only after $4t_E$.

One may show that the time interval 0 t 4t. is protected from higher order weak localization corrections as well. For example, in the second order weak localization correction there are two diagram s [24] proportional to k^2 (t m t_E) (t m t_E)² with m = 6 and m = 8 correspondingly. This fact agrees with the perturbative studies of the QKR dynamics after a few kicks [2, 11, 12], where no localization e ects were seen. (Though the classical di usion coe cient, D_{cl}, is renorm alized as an analytic function of k^2 .) It is important to mention, however, that in reality there is no non{analyticity at the point $t = 4t_E$ as may seem from Eq. (3). The small localization corrections, non {analytic in k, do exist for t < 4t_E. They are associated with the uctuations of the Ehrenfest time. Since in the quantum mechanics the minimal separation between the trajectories is about ₀ k=K, it takes a nite time (te) for them to diverge. This time may uctuate depending on initial conditions. The uctuations are characterized by the time scale $t_E = _2 t_E = ^2$, where (cf. Eq. (2)) 0:82 for su ciently large K and $_2 = h^2 i h i^2$ the angular brackets denote averaging over the initial angle. The interference between rare trajectories, diverging

faster than the typicalones, leads to quantum corrections at t $^<$ $4t_{\scriptscriptstyle E}$ of the form :

where f(0) = 1 and $f(x) = 6^{D} \frac{2}{2} = \frac{5}{4} x^{5=2} e^{x^{2}=16}$ for x = 1. Localization correction including e ect of the Ehrenfest time uctuations is depicted on Fig. 1 by a full line. It is rather close to the prediction of Eq. (3) (long-dashed line), however the singularity at $t = 4t_{E}$ is rounded.

Having outlined our main results, we turn now to some details of the calculations. One starts from introducing the exact one period evolution operator as: $\hat{U} = \exp i(K = k) \cos^{\circ} \exp i\hat{I}^2 = (2k)$. All physical quantities may be expressed in terms of the matrix elements of \hat{U}^n , where n stays for the number of kicks (tim e). We shall be particularly interested in the four{ point density {density correlator, de ned as:

where jl i denote momentum eigenstates. First we note that averaging over $(!_+ + !_-)=2$ leads to $n = n^0$ [14]. Then performing the standard W igner transform, one passes to the variables $l = (l_+ + 1)=2$ and { the Fourier transform of $l_+ = 1$ (and similarly for the prime variables). Since the most unstable direction of the underlying classical dynamics is along the direction [8], any initially sm ooth distribution quickly relaxes in this direction. Thus, averaging over and 0 may be performed.

The resulting correlator depends only on the relative mom entum 1 $\hat{1}$ and frequency ! !₊ ! . Introducing nally angle ' as the Fourier in age of 1 $\hat{1}$, one ends up with D = D (';!). Its classical lim it, D₀ (';!), m ay be found e.g. by using the diagram m atic technique of R ef. 15, where in the large K lim it it corresponds to the fam ily of ladder diagram s. A Iternatively, one m ay show from Eq. (5) that D₀ satis es classical Liouville equation. Upon the proper regularization [9, 10, 25], that m ay be view ed as a coarse graining in the angular direction, one arrives to the classical di usion propagator:

This classical limit rejects the dijusion in the momentum space: hl^2 (t)i = 2D $_{cl}t$, with the dijusion coe cient, D $_{cl}$ (K), studied extensively in the literature [8, 9, 10].

The rst quantum correction to Eq. (6) is given by the one{bop weak{bcalization diagram, Fig. 2a. It describes the interference of the two counter{propagating trajectories, passing through (alm ost) the same point in the momentum space, Fig. 2b. In the W igner representation such correction takes the form :

where ! argument is om itted to shorten notations. The operator \hat{X} stays for the H ikam ibox [26], which is given by

where $_0$ $_0$ + $_1$ and l_0 (1 1)=2. It is clear from this expression that the quantum correction, Eq. (7), is non{zero as long as $l_0 = 0^{-1}$ k and, therefore, it is proportional to k. The sem iclassical Cooperon $C(l_0; 0; l_1; 1)$ gives the probability of return to (alm ost) the same momentum , h1, at (alm ost) the opposite 0. If these conditions were strict, such moangle, 1 tion would be forbidden by the tim e{reversal symmetry. The quantum uncertainty makes it possible. It takes, however, a long time to $\underline{m} \ \underline{agn} \ \underline{ify} \ the \ \underline{initially} \ \underline{sm} \ \underline{all} \ \underline{an-}$ gular variation $_0$ ' k=K (this estimate as well as $l_0 ' = kK$ follows directly from Eq. (8)) up to n 1, when the usual di usion takes place.

To take this fact into account we divide the C ooperon trajectory onto two parts: the Ehrenfest region, where $_{n}$ 1 and the di usive region with $_{n}$ > 1. We denote the corresponding propagators as W and C₀ and write in the time representation C (t) = $dt^{0}W$ (t^{0}) C₀ (t 2t⁰) (cf. Fig. 2b), where, as we show below, $t^{0} \neq .$ Notice that the di usive part of the trajectory is shortened by 2t⁰, leading to C (!) = W (2!)C₀ (!). The di usive

Cooperon, $C_0(l_0 \quad \frac{1}{K}!)$, has the same form as Eq. (6) and thus $C_0(0;!) \quad d' (D_{cl}'^2 \quad i!)^{-1}$.

To evaluate propagator W (2!) in the Ehrenfest regime, we de ne W (z;n) as a probability to reach the deviation $_{n}$ $\overset{e}{\in}$ during n kicks, starting from an initially small variation, $_{0}$ ' $\overset{e}{k=K}$. According to the classical equations (the standard map) $_{n} = _{n-1} + l_{n}$ and $l_{n} = l_{n-1} + K \sin_{n-1}$, the variation evolves as $_{n} = _{n-1} (1 + K \cos_{n-1}) + 2 l_{n-1}$. Since l_{0} ' K $_{0}$, in the leading order in K 1 the evolution of is given by $_{n} = _{0} _{j=0}^{n-1} K \cos_{j}$. Taking the logarithm of this expression, one obtains

where the averaging is perform ed over the initial distribution of $_0$ [with the typical scale $_0$] k=K, cf. Eq. (8)] as well as over dynam ics of the fast variable, that is $l_n = _n$. For K 1, one may treat \cos_j after successive kicks as independent random variables and em ploy the central limiting theorem to perform the averaging in Eq. (9). As a result,

where the Lyapunov exponent [8] and its dispersion $_2$ are de ned as:

the angular brackets imply integration over . The Ehrenfest evolution crosses over to the usual di usion at $_{n}$ 1, meaning z $_{p}$ 0. Performing nally the Fourier transform as W (!) $_{n} e^{i! n} W$ (0;n) and employing the de nition of the Ehrenfest time, Eq. (2), and the fact that $_{2}$, one nds:

D ue to the tim e{reversal invariance there is an exact sym m etry between divergence and convergence of the two classical trajectories involved in the weak { localization correction. This symmetry is illustrated on Fig. 2c. Therefore it takes an additional time $\frac{1}{2}$ for the two distinct sem iclassical di usons to arrive to the point l_0 $\frac{1}{2}$ and $_0$ $_1$, bringing, thus, another factor W (2!). In a slightly di erent language, one m ay de ne the H ikam i box for a classically chaotic system [23, 27] as $2kW^2$ (2!) $D_{cl}r_1^2$, where one factor W (2!) com es from the two legs of the C ooperon, while another originates from the two di usons. Finally, the quantum correction, Eq. (7), reduces to the renorm alization of the diffusion coe cient in the classical propagator, Eq. (6), as

Equations (12) and (13) constitute the main analytical results of this work. They describe quantitatively dynam ical weak { localization of the QKR with the account for the Ehrenfest time phenomena. One may nally express the time evolution of the momentum dispersion in terms of the frequency { dependent di usion coe cient. The exact relation reads as:

Neglecting uctuations of the Ehrenfest time ($_2$! 0 in Eq. (12)) and perform ing frequency and angle integrations in Eqs. (14), (13), one obtains Eq. (3) for the momenta dispersion. Notice that in this approximation the evolution is purely classical at t $4t_{\rm E}$. To account for the quantum corrections at t[<] $4t_{\rm E}$ one needs to keep the $_2$ term in Eq. (12). The straightforward integration leads to Eq. (4).

O ur results, Eqs. (3), (4), are expected to be quantitatively accurate if separations between the relevant time scales: $1 < t_E < t_L$ are large enough. This is the case when the two dimensionless constants satisfy inequalities: k < 1 < K. (In the experiments, we are aware of [2, 3], $k \geq 2$, and thus $t_E \leq 1$.) Another restriction has to do with the dephasing time, [28]. The later may originate from non{perfect periodicity of the kicks (noise) [29], spontaneous emission [3], as well as from many{body collisions between the atoms [6]. W hatever the nature of the dephasing time, one needs to ensure $t_E <$ to observe the weak localization.

This leads to the self(consistent estimate of the dimensionless dephasing time: $(1 k_L = K)^{2=3}$.

Such ux does not a ect dynamical localization, though averaging over l_0 helps to elim inate resonances [22].
