Random Multi-Overlap Structures and Cavity Fields in Diluted Spin Glasses

A bstract

We introduce the concept of R andom M ulti-O verlap Structure (R aM O St) as a generalization of the one introduced by M. A izenm an R. Sim s and S. L. Starr for non-diluted spin glasses. We use such method to nd generalized bounds for the free energy of the V iana-B ray m odel of diluted spin glasses and to form ulate and prove the Extended Variational Principle that in plicitly provides the free energy of the m odel. Then we exhibit a theorem for the limiting R aM O St, analogous to the one found by F. G uerra for the Sherrington-K irkpatrick m odel, that describes some stability properties of the m odel. Last, we show how our technique can be used to prove the existence of therm odynam ic limit of the free energy. The present work paves the way to a revisited Parisi theory for diluted spin system s.

Key words and phrases: diluted spin glasses, overlap structures, cavity elds, generalized bound, extended variational principle.

1 Introdution

The diluted mean eld spin glasses are in portant both for their correspondence to random optimization problems and for their sort of intermediate nature halfway from idealized mean eld models to short range realistic ones, thanks to the nite degree of connectivity.

A m ong the few rigorous results obtained so far in diluted spin glasses, two important examples are ref. [3, 5], where S.Franz and M. Leone found bounds for the free energy of diluted spin system s, considering the rst level of Replica Symmetry Breaking; while D. Panchenko and M. Talagrand

found a way to consider any level Broken Replica Symmetry Bound in a compact way, using a weighting scheme inspired by ref. [1]. In the high temperature region, rigorous results have been obtained for the K-Sat model of diluted spin glass by M. Talagrand^[7] and by F.Guerra and F.L. Toninelli for the V iana-Bray model^[4].

In the case of non-diluted m odels, M .A izenm an, R.Sim s and S.L.Starr recently introduced the concept of ROSt (R andom Overlap Structures) through which they found bounds for the free energy in a very elegant and easy manner. In the same important paper^[1], the authors expressed the solution through an Extended Variational Principle. An important restriction of the ROSt space has been done by F.Guerra^[2], exhibiting invariance of the limiting ROSt under certain transform ations.

A fter the introduction of the basic de nitions in section 2, we extend the ideas of ref. [1] to diluted spin glasses, in section 3. The nite connectivity requires that we consider M ulti-0 verlap as opposed to 0 verlap Structures (because the couplings are not G aussian). In section 4 we prove a generalized bound for the free energy of the V iana-B ray m odel, by m eans of an interpolation not based on the iterative approach of ref. [6] used to nd bounds in ref. [3, 5]. Rather, our interpolation is closer to the one used for non-diluted models in ref. [1]. As a consequence we can (like in ref. [1]) form ulate an Extended Variational Principle for the free energy. The next natural step we perform ed, in section 5, is the search for invariant transform ations of the optim al lim iting RaMOSt, and we found stability properties sim ilar to those found for non-diluted system s in ref. [2]. Appendix A is devoted to a calculation that plays a basic role throughout the paper, Appendix B contains a som ew hat new proof of the existence of the therm odynam ical lim it of the free energy, Appendix C reports some comments about optimal versus non-optimal RaMOSt's in terms of the phenom enon of overlap coalescence and generalized trial functions.

2 Model, Notations, De nitions

W e refer to ref. [4] for an introduction to the V iana-B ray m odel, a physical description, the role of replicas and multi-overlaps, the in nite connectivity lim it and the connection to the Sherrington-K inkpatrick m odel, the behavior in the annealed region.

W e will have in m ind a lattice with a large bulk of N sites (cavity) and M additional spins (N is large and M is xed).

Notations:

; ; h are non-negative real num bers (degree of connectivity, inverse tem - perature and external eld respectively);

P is a Poisson random variable of mean ;

fig;flg are independent identically distributed random variables, uniform ly distributed over the cavity points fl;:::;N g;

fj g;fk g are independent identically distributed random variables, uniform ly ditributed over the added points f1;:::;M g;

fJ g;fĴ g;fJ g;J are independent identically distributed random variables, with symmetric distribution;

J is the set of all the quenched random variables above;

: j ! j = 1; : i ! i = 1 are the added and cavity spin con gurations respectively; . will be used for the spins in the full lattice (the points of which are denoted by r;s) without distinguishing between cavity and added spins;

() is the Poisson measure of mean .

E is an average over all (or som e of) the quenched variables;

 $!_{\rm J}$ is the Bolztm ann-G ibbs average explicitly written below;

 $_{\rm K}\,$ is a product of the needed number of independent identical copies (replicas) of ! $_{\rm J}$, in a system with K spins;

h i will indicate the composition of an E-type average over som e quenched variables and som e sort of Boltzm ann-Gibbs average over the spin variables, to be speci ed each time.

W e will often drop the dependance on som e variables or indices or slightly change notations to lighten the expressions, when there is no am biguity. In absence of external eld, the Ham iltonian of the system of M sites is,

In absence of external end, the Ham intonian of the system of M sites is, by de nition

W hen there is an external eld h, the H am iltonian is $H_M + H_M^{ext}$, where we used the de nition $H_M^{ext}(;h) = -h_{j=1}^{M} j$. We follow the usual basic de nitions and notations of therm odynamics for the partition function and the free energy per site

W e are going to use the two following independent auxiliary H am iltonians:

where j is the Cavity Field acting on j de ned by

and the index j of $J^{\,j}$ and $_{\,\,i^{\,j}}$ de-num erates independent copies of the corresponding random variables.

The two expressions of dene the same random variable, but the rst is probably the most convenient for the calculations in next two sections, while the second describes better the physics of the model, and will be essential in section 5.

3 Generalized Bound for the Free Energy

Fort 2 [0;1], consider the following Interpolating Hamiltionian

Let us compute the t-derivative of $R_{\,M}\,$, keeping in m ind that its denom innator does not depend on t.

Now we have the sum of three terms, in each of which one of the 's is di erentiated with respect to t. As in Appendix A, we can substitute into the rst term the following relation

It is clear then that as in Lemma 1 of Appendix A we get an average ;t with weights consisting of the weights times the Boltzmann-Gibbs weights associated to H (t):

A coording to Appendix A we will get now some terms in cosh (J), such terms can be factorized out, but here they are cancelled since they sum up to zero. Since

Notice that we could obtain the same bounds using any other and leading to the bound (6). Even more is true, we could pre-assign the values q_h and forget that they are overlaps of congurations in a lattice with N spins, which therefore is not an essential setting. Such remark explains the introduction of the follow $ing^{[1]}$

Som etim es one considers the closure of , which is not discrete in general. For any R aM O St one takes a couple of auxiliary random variables com patible with the M ulti-O verlap K emel and with (6), and the previous theorem could be stated $^{[1]}$ as

The generality of the R aM O St allow sto take (which is not necessarily f 1;1g^N) as the set of indexes of the weights ; 2 constructed by m eans of R andom P robability C ascades of P oisson-D irichlet processes (see e.g. ref. [5]). A well known property of these C ascades (see e.g. equation 4.2 in ref. [5]) gives place to a chain of expectations of P arisi type (see e.g. equation 5.5 in ref. [5]), that coincides with the P arisi R eplica Sym m etry B reaking theory if one interpolates according to the iterative approach of ref. [6], like in ref. [3, 5]. Since we interpolate with di erent auxiliary H am iltonians, in our case (taking identical copies of and in (3) and sum ming also over) the chain of expectations is not equivalent to the

Parisi Replica Symmetry B reaking in the sense of [6]. This point will be deepened elsewhere^[8]. In order to get the Parisi Replica Symmetry B reaking theory in the traditional sense, one should take (like in ref. [1] for non-diluted models) a sequence of suitably chosen and such that the corresponding bounds would be the special realization of (7) with the Parisi RaM O St, like in ref. [1] for non-diluted models.

4 Extended Variational Principle

W e can express the free energy of the model in the form of the following

Theorem 2 (Extended Variational Principle)

In order to prove the Extended Variational Principle, we will nd, in Theorem 3 below, the opposite bound to (7), like in ref. [1]. Notice rst that the following C esaro limit can be easily computed

since, thanks to the cancellation of the common terms of the numerator and denominator

and the rst M term s, with the positive sign, tend to f; while the others, with the negative sign, vanish in the lim it.

The rest of the proof is very similar to the proof of Theorem 4 in the next section.

Recall that the sum of Poisson random variables is a Poisson random variable with mean equal to the sum of the means. So if we take

we see that the forth fraction is the sam $e as Z_N$ ()= Z_N (⁰). Furtherm ore, since ⁰(N + M) (N + M) = ⁰N N; ⁰!, in the limit the second and forth fractions cancel out thanks to Lemma 1 in Appendix A. We have seen that the third fraction tends to f.

Now we proceed with a key step of our approach. In the denominator of the rst fraction we can split the mean $^0(N+M)$ into the sum of three means such that H $_{N+M}$ splits into the sum of three H am iltonians with the rst depending only on cavity spins , the second containing interactions between the cavity and the added spins, the third has the added spins only. In other words, we are considering the fraction of the interactions (indexed by) within the cavity, between the cavity and added spins, within the added lattice respectively. Hence the new three means will be proportional to N 2 ;2N M ;M 2 respectively. M ore explicitly

The third Ham iltonian is thus negligible. This means that when the cavity is large the added spins do not interact one another.

The choice of 0 we made guarantees that numerator and denominator contain two (up to a negligible third in the denominator) identical H am iltonians with the same connectivities. As a consequence, the rst fraction in G_M vanishes in the lim it and the theorem is proven. 2

5 Limiting RaM OSt Invariance

As in Appendix A,

The proof is based on the comparison between the limit above and (9), similarly to the method of the previous section. More precisely, the left hand side of (12) can be rewritten (without the limit) as

If we now write

from which it is clear that each cavity eld (m ore precisely each $c_j)$ yields a contribution (f + $\,A$) in the lim it.

Notice that in the limiting structure not only the cavity elds are mutually independent, but they are independent of as well. We have thus obtained the analogy with the result of F. Guerra regarding the Sherrington-K irkpatrick model^[2].

Conclusions

It is important now to formulate in a complete manner the Parisi theory for diluted spin glasses^[8], and to deepen the analysis of the invariance properties of the optim al RaM OSt in order to characterize the solution. We plan to dedicate future work to this program .

A Connectivity Shift

t!. Therefore integrating back against t from 0 to 1 is the same as multiplying by 1. Thanks to the symmetric distribution of J we get the result, where the odd powers are missing. 2

B Thermodynam ic Lim it

Our new interpolation m ethod should allow one to prove the existence of the therm odynam ic lim it (already proven in ref. [3]), for otherw ise it would

be quite weak. As a matter of fact, this theorem turns out to be elementary with our interpolation.

It is well known that a su cient condition for the existence of the therm odynam ic lim it is the sub-additivity of the free energy. In our context we want to measure the changes caused by adding the M additional spins to the cavity of size N and make sure that

The natural start is therefore considering the following interpolation

We clearly proceed by splitting H $_{\rm N\,+\,M}\,$ in the usual way, and we get this time a total of ve Ham iltonians. In the t-derivative the parts in $\cosh(J)$ cancelout, since the sum of the vecce cients of is zero. The remaining terms are

which shows that the di erence f f_M is given in term softhem ulti-overlap distance averaged over any optim alR aM 0 St.

If we instead use the fundam ental theorem of calculus for $R_{\rm M}\,$ (t) de ned in section 3, we get another sum rule

which explains, when M goes to in nity, the role of G_M (R; ;) as trial function; m inim izing it means noting optimal RaMOSt's (and therefore the free energy) and the multi-overlap locking (coalescence) described by A izenm an in the case of non-diluted models^[9].
