New Universality classes for generic higher character Lifshitz points

We describe new universality classes associated to generic higher character Lifshitz critical behaviors for systems with arbitrary short range competing interactions. New renormalization-group arguments are proposed for an isotropic and isotropic systems. The usualm-axialLifshitz universality classes are obtained as a simple limit of this arbitrary competing critical behavior.

The universality classes characterizing the critical behavior of competing systems are natural generalizations of those describing ordinary short-ranged critical system s. In magnetic system s [1], the axial next-nearestneighbor Ising (ANNNI) model [2] explains this generalized critical behavior, as antiferrom agnetic exchange interactions between second neighbor spins are included along a single axis in a cubic lattice. The uniaxial Lifshitz point arises at the con uence of the disordered, a uniform ly ordered and a modulated phase. Second character Lifshitz points generalize the uniaxial one when the com peting axes occur in arbitrary space directions. Physical applications of this behavior include magnetic modulated m aterials [3,4], high-T_c superconductors, liquid crystals, am ong others [5]. The theoretical description of this criticality has been put forth using di erent eld-theoretic tools [6{8] and num erical M onte Carlo simulations for the ANNNIm odel [9].

The ANNNI model can be generalized by including further ferrom agnetic couplings between third neighbors along the competing axis. The phase diagram is characterized by two parameters varying with the temperature, namely, the ratio of exchange couplings between the second and the rst neighbors as well as the ratio of exchange interactions between the third and the rst neighbors. The projection of the temperature axis in the plane of these param eters results in a region of intersection where the dierent phases characterizing the system meet, known as a uniaxial Lifshitz point of third character [10]. Including m ore alternate couplings along the competing direction, the number of parameters in the phase diagram increases. Analogously, the uniaxial Lifshitz point of higher character is dened at the con uence of the distinct phases of the system . The m $_{\rm L}$ -fold Lifshitz point of character L arises when alternate couplings are perm itted up to the Lth neighbors along m I, directions and the ratios of the exchange interactions between different neighbors are kept xed at the associated Lifshitz

tem perature [11,12].

Lifshitz critical behaviors share at least two issues with a broad class of theories in other physical arenas. In som e phenom enologicalm odels of quantum gravity, the Planck scale and the speed of light are two observer-independent scales which induce modi cations of the usual energymomentum dispersion relations [13]. A nonlinear realization of Lorentz invariance is maintained and can be generalized to include more than two relevant scales [14]. Lorentz invariance can also be preserved in addressing the dark matter problem in cosmology by making use of a scalar eld with higher derivative term s, nam ed \kessence" [15]. Alternatively, Planck scale e ects may break Lorentz invariance in the ultraviolet regime due to them odi cation of the dispersion relations. E ective free quantum eld theories with modi ed cubic kinetic terms have just been proposed [16] to test this idea. Thus, a renorm alization group analysis with several independent length scales together with new perturbative techniques to solve interacting higher derivative eld theories are highly desirable to elucidating new e ects in a broader context.

In this letter, we introduce the most general ddim ensional competing system resulting in a new static critical behavior by permitting only nearest neighbor interactions along (d m₂ ::: m_I) directions, second neighbor competing interactions along m 2 directions, etc., up to L th neighbor com peting interactions along m $_{\rm L}$ directions. The new universality classes for this system generalize the higher character universality classes in a nontrivial way. Since each competing direction de nes distinct modulated phases, the generic higher character Lifshitz point arises at the con uence among the disordered, a uniform ly ordered and several modulated ordered phases. The universality classes for this arbitrary com peting exchange couplings Ising model, named hereafter CECIm odel, depend on (N;d;m2;:::;mL) where N is the num ber of com ponents of the order param eter. The

particular isotropic universalities (d = m $_{\rm n}$) are obtained independently. We nd multiscale scaling relations using a simple scaling hypothesis consistent with hom ogeneity. Then, we develop a new dimensional regularization procedure to calculate Feynm and diagram s and critical exponents for generic higher character Lifshitz points up to two-loop order.

We start with the following bare Lagrangian density:

At the Lifshitz point, the xed ratios among the exchange couplings explained above translate into this eld-theoretic version though the conditions $_{0n} = _{nn^0} = 0$. Alleven momentum powers up to 2L become relevant in the free propagator, realizing a situation considered by W ilson in the 1970's [17].

The critical space dimension d_c above which the classical (mean eld) behavior takes over the system is given by $d_c=4+\frac{P}{n=2}\frac{(n-1)}{n}m_n$. The small parameter for a consistent perturbative expansion is $_L=4+\frac{L}{n=2}\frac{(n-1)}{n}m_n$ d.

In m om entum space, the m $_n$ competing axes only possess the term $k_{(n)}^{2n}$ due to the Lifshitz condition. Thus, we can set $_n$ = 1 and perform a dimensional rede nition

of the competing momenta dening arbitrary competing axes. Hence, if the canonical dimension (in mass units) of the quadratic noncompeting momenta is given by [q]=, then $[k_{(n)}]=\frac{1}{n}$. Therefore, the volume element in momentum space for arbitrary Feynman integrals has canonical dimension $\frac{d}{n-2}\frac{(n-1)}{n}m_n$. Let $_1$, $_2$,..., $_L$ be the correlation lengths characterizing arbitrary spatial directions of the system . C lose to the Lifshitz critical temperature these quantities are related among each, but can be considered as independent relevant length scales in the problem as follows.

Consider L normalization conditions for the oneparticle irreducible (1P I) vertex parts. The renormalization of the vertices at the Lifshitz temperature is consistent in the infrared lim it if the theory is renorm alized at nonvanishing external m om enta. Let m be the external m om enta scale used to x the renormalized theory along arbitrary space directions. For instance, for n = 1 the nonvanishing components of the external momenta are $\sum_{n=2}^{L} m_n$)-dim ensional parallel to the noncom peting (d subspace. For n > 1, the nonvanishing components of the external m om enta occur only along the m_n -dim ensional com peting subspace. Let $p_{i(n)}$ be the external m om enta associated to a generic vertex part. We can choose several sym m etry points SPn along arbitrary directions dened by $p_{i(n)}$ $p_{j(n)} = \frac{2}{n} (4 ij)$ 1). The momentum scale of the two point function is xed by $p_{(n)}^2 = \frac{2}{n} = 1$. The 1P I renormalized vertex parts at the Lifshitz critical tem perature are given in terms of the bare vertices as [8,18,19](n = 1; :::;L):

where g_n are the renormalized coupling constants, $Z_{(n)}$ and $Z_{(n)}$ are the eld and temperature normalization constants and g_n are the corresponding momentum cutos along the noncompeting g_n and competing directions (1 < n g_n L). Notice that g_n are the insertion external momenta along the different spatial directions for vertex parts including composite g_n (x) operators.

Our dimensional rede nitions of the momenta components characterizing each type of competing axes implies

that the renormalized and bare dimensionful coupling constants can be expressed in term sofdimensionless couplings as $g_n = u_n \left(\begin{smallmatrix} 2n \\ n \end{smallmatrix} \right)^{\frac{1}{2}}$ and $_n = u_{0n} \left(\begin{smallmatrix} 2n \\ n \end{smallmatrix} \right)^{\frac{1}{2}}$. Since we are going to analyze the situation for $d < d_c$, we can suppress the cuto s_n in the argument of the bare vertices recalling, however, that the limit $_n ! 1$ is inplicit. The invariance of the bare vertex functions with the renormalization scales $_n$ in plies the renormalization group (RG) equation

The functions $_n$; $_{(n)}$ and $_{^2(n)}$ (u_n) are calculated at xed bare coupling $_n$. In term s of dim ensionless quantities, they read

At the xed points, under ows in the external momenta $p_{\text{i}(n)}\,\text{;}\,Q_{\text{i}(n)}$ along arbitrary space directions, the vertex parts $_{R\ (n)}^{(N\ ;L)}$ ($p_{i(n)}$; $Q_{i(n)}$; u_n ; $_n$) have a simple scaling property. As usual, de ne $_{n}$ = $_{(n)}$. The correlation length exponents are given by $n^{1} = 2n$ determination of the scaling relations above and below the Lifshitz critical temperature follows closely that for the second character Lifshitz points [8,20]. One nds

which imply the W idom $_{n}$ = $_{n}$ ($_{n}$ 1) and Rushbrook $_n + 2 _n + _n = 2$ relations for arbitrary competing or noncom peting subspaces, since n = 1; ...; L.

The isotropic cases are de ned by $d = m_n$, when all competing interactions not lying on the m n competing axes are switched o. The upper critical dimension is $d_c = 4n$ implying that the perturbative parameter is $_{4n} = 4n$ d. There is only one type of correlation length $_{4n}$. The canonical dimension of the momenta in mass units is rede ned to be $[k] = \frac{1}{n}$. The volume element of Feynman integrals in momentum space has canonical dim ension $[d^d k] = \frac{d}{n}$. Following similar steps as done in the anisotropic cases, we obtain the relations:

which imply the W idom $_{4n}$ = $_{4n}$ ($_{4n}$ 1) and Rushbrook $_{4n}$ + 2 $_{4n}$ + $_{4n}$ = 2 law s. N ote that they trivially reduce to the usual 4 theory for n = 1, after the iden-, etc.. These relations are the same ti cation 4

as those found by N icoll et al. [21], with the additional scaling relation for $_n$ obtained in the present work in a sim ple m anner.

Consider the exponents for the anisotropic cases obtained from the critical theory de ned by (2) at nonzero external m om enta. At this critical point the bare free gritical propagator (t = 0) is given by $G_0^1 = p^2 +$ $_{n\,=\,2}^{L}\,\,k_{n}^{\,2n}$, where p is a wave vector along the (d $\,$ m $_{2}$::: m $_{\rm L}$) noncom peting directions, and ${\it k}_{\rm n}$ are the wave vectors along the m $_{\rm n}$ distinct type of competing axes. Let $k_{i(n)}^0$ be the external m om enta along the m_n com peting axes in the contribution of an arbitrary 1P I vertex part, which at the symmetry points discussed above can be simply written as $k_{(n)}^{\,0}$. If the loop momenta is $k_{(n)}$, we can employ a generalized \orthogonal approxim ation" [8] to resolving the Feynman integrals up to two-loop level with arbitrary external momenta. Using the approximation $(k_{(n)} + k_{(n)}^0)^{2n} = (k_{(n)}^n + k_{(n)}^0)^2$, we can rede ne the loop m om enta as K $_{(n)} = k_{(n)}^n$. In each integration over the competing momenta we pick out only the contribution corresponding to a homogeneous function of the momenta. We absorb the geometric angular factor $[({\begin{array}{*{20}c} L \\ n=2 \\ \hline 2n \\ \end{array}} S_{m_n} ({\begin{array}{*{20}c} m_n \\ \hline 2n \\ \end{array}})) S_{(d)} {\begin{array}{*{20}c} P_L \\ \hline 2m_n \\ \end{array}})$ (2 in a rede nition of the coupling constant after perform ing each loop integral. Using (2), we not that the xed point is indepent of the scaling direction considered and the critical exponents $_n$ and $_n$ can be calculated diagram atically at two-and three-loop order, respectively. The other exponents are obtained from the scaling laws derived above. They are given by

Notice that the anisotropic exponents n; n; n and neasily reproduce those of the second character Lifshitz behavior when $m_3 = \dots = m_L = 0$ with $m_2 = m \in 0$, which turn into the Ising-like exponents for $m_2 = m = 0$. The generalized universality classes exposed here and the properties $_{n}=\frac{1}{n}$ and $_{n}=n_{1}$, when $m_{2}=$::: = m $_{\rm L}$ $_{\rm 1}$ = 0 w ith m $_{\rm L}$ $\stackrel{\leftarrow}{\bullet}$ 0, im ply that our anisotropic scaling relations are equivalent to those found in Ref. [12], except for the scaling relation of the magnetization exponent which was not obtained there. Strong an isotropic scaling [22] is exact at the loop order considered here in the most general anisotropic situation, and might be expected to hold at arbitrary loop levels.

U sing the same approximation scheme to perform Feynman integrals as outlined above, the isotropic ex-

ponents are even simpler to obtain. The angular factor to be absorbed in the loop integrals is simply the area of the m $_n$ -dim ensional sphere S_{m_n} . The critical exponents are given by [23]:

The isotropic exponents $_{4n}$; $_{4n}$; $_{4n}$ and $_{4n}$ depend explicitly on the number of neighbors coupled through competing exchange interactions n and labels the isotropic universality classes. These critical exponents reduce to those from the Ising-like (4) universality class for n=1. For n 2 , these exponents can never be obtained from those of the anisotropic cases described above, since the latter do not depend explicitly on n. This con m s that the isotropic universality classes are independent from the anisotropic universality classes for Lifshitz points of generic higher character.

In $\operatorname{sum} \operatorname{m} \operatorname{ary}$, the CECIm odel proposed here presents the most general sort of second order phase transition for arbitrary types of competition and realizes new universality classes for generic higher character Lifshitz critical behaviors. The scaling relations are obtained through a generalized scaling hypothesis which de nes independent renormalization group transformations in each competing (or noncompeting) subspace. The critical exponents are calculated up to two-loop level using a new analytical dim ensional regularization m ethod to com pute Feynm an integrals with arbitrary even momentum powers in the propagator, which may be fruitful in quantum eld theory applications. Universal quantities as am plitude ratios [24,25] can be pursued in this fram ework. We relegate the details of the results described here for a subsequent publication [26].

It is important to mention that a new anisotropic behavior emerges when $d=m_2+\dots+m_L$. The noncompeting directions which tend to favor the existence of the ferrom agnetic phase, are absent in this new situation. This particular behavior deserves a complete and careful

study for future investigations. The analysis of the most general crossovere ects as well as the tricritical behavior of the model are also worthwhile.
