Correlations in atom ic system s: Diagnosing coherent superpositions

W hile investigating quantum correlations in atom ic systems, we note that single m easurements contain information about these correlations. Using a simple model of m easurement | analogous to the one used in quantum optics | we show how to extract higher order correlation functions from individual "photographs" of the atom ic sample. As a possible application we apply the method to detect a subtle phase coherence in m esoscopic superpositions.

Correlation functions provide a useful tool for investigating complicated states, both classical and quantum . For example, measuring intensity-intensity correlations for photons has been a signi cant developm ent in astrophysics [1] and investigation of the second order correlation function has led to understanding of antibunching of photons [2]. For atom s, correlation functions m ight prove to be as useful as they have been for photons. There are certain in portant di erences, how ever. For light, if the underlying quantum state is unknown, the know ledge of a correlation function of a given order does not determ ine lower order correlation functions and a separate experim ent must be set up to measure the latter [3, 4]. This is not true in atom ic case. For atom s a superselection rule holds, which prohibits the atom ic state to exist in a superposition of Fock states with dierent number of atom s. This proves to be a very strong condition and im plies, as will be shown in m ore detail, that there exists a unique hierarchy of correlation functions. An important consequence is that it is possible to extract inform ation about higher order correlation functions, not only density, from typical measurem ents perform ed in atom optics. In this Letter we derive this hierarchy of correlation functions and provide a simple prescription for extracting correlation functions of interest from typical m easurem ents, which we model in an analogous way to quantum optics. As an illustration we use the method as a diagnostic tool to distuinguish a coherent superposition against a simple mixture.

There exists a number of possible detection schemes in atom optics { via resonance uorescence, non-resonant imaging or ionizing the atom s and detecting the resulting electron current, just to name a few { and each of them requires a slightly di erent theoretical approach [5]. In particular one cannot claim that all measurements of atom ic samples correspond to normarly ordered correlation functions and in that respect atom optics di ers from its photonic counterpart, in which all correlation functions are normally ordered since light is detected via absorption. On the other hand, how ever, the notion of coherence, that has been originally introduced for photons in the context of norm ally ordered correlation functions and their factorization [6], is a very useful tool and it would be desirable to classify atom ic systems in an analogousm anner. Therefore we will further assume that the measurement of the atom ic cloud is done in such a way that norm ally ordered correlation functions are relevant, even though it might be an idealization of an actual detection scheme.

Consider a state composed of N atom s and described by a ket j i for a system with a second-quantized eld $^{(x)}$. The diagonal part of the r-th order correlation function is then de ned as:

and, within the assumptions described above, is proportional to the joint probability of detecting r atom s: one at position x_1 , one at x_2 and so on (of course the positions need not be all di erent). T im e dependence has been dropped for simplicity: we assume that all atom s are measured at the same instant. In other words we neglect the state's dynam ics during the time of measurement.

Provided the system is in a Fock state, i.e. j i is an eigenstate of the total number of atoms operator $\hat{N} = dx ^{y}(x)(x)$, a simple algebra shows that the following relation holds both for bosonic and ferm ionic systems:

Thus, a correlation function of a given order contains all lower order correlation functions. Such a hierarchy exists for any given state, but only for Fock state is the coe – cient of proportionality so sim ple and general. A ssum ption that the state is in a Fock state is valid for most experiments performed with cold atom s, B ose-E instein condensates in particular, since they are almost perfectly isolated from the environment. M oreover, if one was to allow for interactions with the particle reservoir, the resulting state is a mixture of Fock states with di erent number of atom s: $^{-1}$ $_{n=0}^{-1}$ cn j n ih n j and the extension of Eq. 2 is straightforward: Z

O ther states, allowing for coherence between states with di erent number of atom s, violate the superselection law that stem s from the baryonic charge conservation [7] and thus are unphysical for atom ic system s.

Joint probabilities of detecting atom s at $x_1; x_2; ...; x_r$ form hierarchy analogous to Eq. 2 and therefore:

Let us now investigate the experiment in greater detail and concentrate on an ideal case rst, i.e. when the detectors have in nite spatial resolution and are able to detect individual atom s. We will also assume that the detectors' mesh is so tight that each and every atom gets detected. Then, photographing the state j i produces a collection of N positions $\frac{1}{1}$; $\frac{1}{2}$; :::; $\frac{1}{N}$ at which atom s were found at the i-th shot. Repeating the measurement W times follows the corresponding probability density and therefore yields a discrete estimate of the N -th correlation function:

Of course in the limit of repeating the experiment innitely many times the original correlation function is recovered:

To obtain the density out of these measurements one needs only to integrate the constructed correlation function over N 1 coordinates according to the Eq.2. (It is assumed that this equation holds true also for the discrete estimates of correlation functions.) Since it doesn't matter over which N 1 variables the integration is performed one obtains a very intuitive result:

The density is thus just a sum of -spikes at positions at which atom s were detected in all experiments. Note the self averaging phenomenon: typically the number of atom s N is of the order of hundreds of thousands and one does not need to repeat the experiments very many times to obtain a reasonable density approximation. However, in general it is not su cient to perform the experiment only once, no matter how many atom s there are. The "density" obtained in a single measurement, $G_{j i}^{(1,1)}(x)$, is {apart from the system s exhibiting coherence up to the N-th order{ dierent from a true density $G_{j i}^{(1)}(x) = G_{j i}^{(1;1)}(x)$, since the rst one also carries inform ation about correlations in the system [8].

Second order correlation function can be extracted from the measurements' outcome in an analogous way via integrating $G_{j\,i}^{(N,W)}(x_1;:::;x_N)$ over N 2 variables. A fler exploiting the symmetry trick, just as before, we obtain:

This idea has been already used in [9], in which the authors propose to look at spatial noise correlations in order to extract second order correlation function. Sim ilar m ethod can be applied to extract even higher order correlation functions.

To describe realistic experiments | with inevitably imperfect detectors | we will incorporate the following strategy: For each outcome of a realistic measurement, the set of all possible ideal realizations (discussed above) that are identical from the point of view of imperfect detectors, is found; then, for each of these realizations the correlation function of interest is calculated and nally averaging over these realizations takes place.

The outcome of the i-th experiment is modelled by a set of D numbers denoting how many atom swere found by each of the detectors: $\frac{1}{1}$; $\frac{1}{2}$;:::; $\frac{1}{D}$. Here, the detectors are assumed to have a nite spatial resolution (each of them covering a volume V) and to ll all available physical space. Furthermore, they are characterized by the conditional probability p(j) of the presence of atom swhile were actually detected. Denoting: $\frac{k}{(j)} = \frac{p(j)}{p}$ and $\frac{2}{(j)} = \frac{-(j)^2 + \frac{(+1)(l p)}{p^2}}{p}$, rst-and second-order correlation functions take the form :

Here, $j(x) = V^{-1}$ if x is within the j-th detector and zero otherwise. Note that the know ledge of the underlying quantum state is not required here and still lower order correlation functions can be extracted.

One more remark about experim ental reality. A typicalm easurem ent perform ed with cold atom s involves so called colum n averaging, in which inform ation about correlations in the direction along the propagation of the illum inating light pulse is lost. The scheme of extracting correlation functions presented above is not sensitive to whether the original high-order correlation function is column averaged or not, and in this sense this process is not an obstacle. But if one starts from a column averaged high-order correlation function one ends up with colum n averaged low-order correlation functions. In many situations this is not satisfactory, however, because such an averaging kills interesting phenom ena. Consider, for example, the recent experiment of collapses and revivals of matter wave eld of a Bose-Einstein condensate [10]. Only because of the column averaging were the collapses of the interference pattern observed in a single shot. If one repeated the experim ent with 2-dim ensional lattices, interference patterns would be observed at each measuerem ent no matter what the free evolution time was and they would vanish only when averaged over many realizations.

Let us illustrate this general method of extracting higher order correlation functions with an example of a coherent superposition of states composed of N atom s of the form :

Such a state provides a very important link between quantum and classical worlds, is essential in the theory of quantum information, and is currently being a subject of intensive research [11]. We will assume that the wavefunctions associated with the two modes are the ground states of spatially separated potential wells: ' $_{\rm L}$ (x) and ' $_{\rm R}$ (x). The r-th order correlation function is: (a) if r < N :

and (c) if r > N the correlation functions vahish indentically.

Explicit form ulas for correlation functions allow us to simulate the experiment easily. Since each measurement produces a set of numbers drawn according to the corresponding joint probability function, so can it be done in the computer with the help of random number generator. This is achieved step by step: the rst atom is drawn with




FIG.1: Low-order correlation functions for a superposition state j $i_{C\,O\,H}$ with N = 100 atom s: (a) density obtained in a single m easurement, (b) density averaged over 50 shots and (c) second order correlation function averaged over 50 m easurements. The wavefunctions ' $_{L\,,R}$ (x) were initially G aussian wavepackets centered at x_0 = (denotes the unit of length) with width = 0.035 to make them practically orthogonal, but they were allowed to expand freely for time t t = $0.01 \frac{m}{h}$ before the detection process. The solid line at (a) and (b) shows the expected density pro le, G $_{C\,O\,H}^{(1)}$ (x).

the probability density given by $G_{COH}^{(1)}(x_1)$, the second { with the probability density $G_{COH}^{(2)}(x_1 = _1;x_2)$, where for x_1 a num ber obtained in the previous step is substituted and so on [12]. In this way the full set _1; _2;:::; N is obtained.

Figure 1 shows density and second order correlation function obtained via the hereinbefore prescription from the num erically simulated m easurem ents. Fig. 1(a) shows a typical result of a single m easurem ent, in which all atom s are detected in one of the wells. A veraging over m any experim ents leads to the correct density pro le, as shown at Fig. 1(b). Fig. 1(c) shows the second order correlation function constructed from single m easurem ents and then averaged over m any shots.

It is instructive to consider another problem : suppose we want to distinguish between the coherent superposition de ned above and the m ixed state:

(Sim ilar problem for four ions in a trap was experim entally investigated in [13].) These states have all correlation functions identical apart from the one of the order of the number of particles: form ixed state the Eq.12 holds even when r = N. It follows im mediately that in order to distinguish between these states an experiment measuring all atom s must be performed in conditions in which the spatial wavefunctions overlap, otherwise the interference term in Eq. 13 will vanish. Since the correlation function of interest lives in the d N -dimensional space




FIG. 2: A bsolute value of Fourier transforms of histograms of the center-of-m ass variable for (a) coherent superposition and (b) mixed state for N = 20 atoms and 1 000 m easurements (histograms are shown in the insets). The spikes at $k = \frac{N}{t^2 + (m^{-2} = h)^2}$, which for our set of parameters correspond to k = 424, are ngenprints of the coherence between states N;0i and D;N i.

(d is the physical dim ension of the space), it is practically in possible to gather satisfactory statistics of experim ents to probe this space even for moderate number of atom s. Fortunately, there is a way around it. Our purpose is to di erentiate between two kinds of states and any quantity that does so is enough. A coording to what has been said, such a quantity must originate from the N -th order correlation function, but it does not need to be the correlation function itself. Simple calculations show that the density of the center-of-m ass is indeed such a quantity and a direct proof obtained from num erical simulations is shown in Figure 2. Note that all atom smust necessarily be detected to obtain a center-of-m ass density, which seems impractical at rst. However, when performing this kind of experiment a very precise control of the input state is required, in particular the know ledge of the total number of atoms, and thus it is natural to discard all m easurem ents that detected less than N atom s and this way to overcome nite detector e ciency.

This method of diagnosing the superposition has of course its lim itations. W hen increasing the num ber of atom s, the visibility of fringes in the center-of-m ass density decreases, as well as the separation between fringes and consequently better and better detectors are required. Moreover, the sensitivity to the phase uctuations from shot to shot increases: if we assume that the initial state is proportional to N; 0i+ exp(i) D; N i, where varies from experiment to experiment, it is required for the m ethod to work that the phase does not change m ore than over = (2N). The num ber of experim ents needed to distinguish between a coherent superposition and a mixed state grows rapidly with the num ber of atom s, but still yields a reasonable num ber of repetitions: under the condition that the peaks' height signifying the coherent superposition is 10 times the value of surrounding background, 500 runs are required for N = 20, while 5000 for N = 100 { and bigger coherent superpositions are not only di cult to diagnose, but even m ore, to prepare.

O focurse the m esoscopic superposition prepared even in the best experiments cannot be expected to be exactly of the form given by Eq. 11 but rather of the form $\sum_{k=0}^{N} c_k$; N ki, where the coe cients c k are peaked around k = 0 and k = N. The state we have discussed above has been chosen for its simplicity, but the analysis m ay easily be extended to m ore realistic states.

Sum m arizing: the fact that atom ic system s cannot exist in a superposition of Fock states with di erent num ber of atom s leads to a very simple hierarchy of correlation functions. Basing on that we have provided a prescription how to extract higher order correlation functions from typical measurements performed in atom optics. We have discussed both the idealized and realistic version of experiments and illustrated the method by applying it to a superposition of atom ic states. We have also proposed a method of diagnosing such a superpo-

sition (versus an incoherent mixture) via measuring the center-of-mass density pro le.
