B reakdown of the Luttinger sum -rule at the M ott-H ubbard transition in the one-dim ensional t₁ t₂ H ubbard m odel.

A b stract. { We investigate the momentum distribution function near the Mott-Hubbard transition in the one-dimensional $t_1 t_2$ Hubbard model (the zig-zag Hubbard chain), with the density-matrix renormalization-group technique. We show that for strong interactions the Mott-Hubbard transition occurs between the metallic-phase and an insulating dimerized phase with incommensurate spin excitations, suggesting a decoupling of magnetic and charge excitations not present in weak coupling. We illustrate the signatures for the Mott-Hubbard transition and the commensurate-incommensurate transition in the insulating spin-gaped state in their respective ground-state momentum distribution functions.

Introduction -M any aspects of the low-energy physics of an electronic system are in u-enced by the shape of its Ferm i surface and the occupation of nearby states. Finite temperature, disorder or strong correlations m ay change the Ferm i-surface geometry and or topology and induce magnetic and other instabilities.

The investigation of the interplay of magnetic interactions, in particular the existence of incommensurate phases, with charge excitations emerges as one of the central issues in the physics of low-dimensional electronic systems [1{7]. The nature and mechanism of the Mott-Hubbard transition, as one of its most striking manifestations, has been subject to intense investigation for many years. It is therefore important to study the renormalization of individual Ferm i-surface sections under the in uence of electron-electron correlations in competition with frustrating interactions.

Recent investigations suggested a spontaneous, interaction induced deformation of the Ferm i surface of the 2D (extended) Hubbard model close to half lling, indicating in part a violation of the Luttinger sum rule [8{10}]. The possibility of a relevant Ferm i-surface renormalization near the Mott-Hubbard (MH) transition in one-dimensional generalized Hubbard models has been raised on the basis of a DMRG-study [11], drawing on arguments from results obtained for the Ferm i-surface ow by RG [12,13].

In this letter we exam ine this M ott-H ubbard transition in one of the prototypical frustrated one-dim ensionalm odels: the half-lled zig-zag H ubbard ladder. For appropriate choices of the

param eters this model describes either the low-energy properties of Hubbard-ladders [12] or half-lled edge-sharing double-chain materials like $SrCuO_2$ [14] or LiV_2O_5 [15] for which the next-nearest neighbor hopping is expected to be substantial. The study of this system permits both the consideration of incommensurate phases and strong interactions. The former are discult to study in the limit of in nite dimensions, where part of our present understanding of the Mott-Hubbard transition orginates. The latter can now be treated adequately for one-dimensional systems using the density-matrix renormalization group (DMRG), which emerged in the last decade as a reliable tool to investigate the electronic structure of quasi one-dimensional systems [16,17].

We nd no renormalization to perfect-nesting of the Fermi-surface in the metallic state as the Mott-Hubbard transition is approached. We explicitly demonstrate that the dimerized state on the insulating side of the Mott-Hubbard transition has gaped incommensurate spin-excitations, which only later give way to an insulating phase with commensurate spin-excitations. Our results indicate that perfect-nesting is not a prerequisite for the Mott-Hubbard transition at nite values of the interaction. The opening of the charge gap decouples from changes in the nature of magnetic excitations, in stark contrast to the weak-coupling scenario, where Umklapp-scattering becomes relevant at perfect nesting and leads to the opening of a charge-gap. We report the characteristic signatures of the incommensurate insulating state in momentum-distribution function for future experimental analysis.

M odel-The Ham iltonian of the zig-zag Hubbard ladder is given as:

where the c_n^y , $(c_n,)$ are Ferm ion-creation (destruction) operators on site n and spin = ";# and n = c_n^y , c_n , .




Fig. 1 { Phase diagram for the half-led t_1 t_2 Hubbard model as explained in the text. Included are the DMRG-result for the Mott-Hubbard transition at $U=4t_1$ (led diamonds) and for the commensurate-incommensurate transition in the insulating state (open diamonds). The dashed-dotted lines are guides to the eye. The states CnSm predicted by weak-coupling RG are denoted at the bottom of the phase diagram.

Let us st discuss a few known properties of the phase-diagram at half lling, compare Fig. 1. We follow Balents and Fisher [18] and denote with

CnSm

a phase with n=m gapless charge/spin modes. A Mott-Hubbard transition of type C0S1{ C2S2 is predicted [12] by RG at half-lling for $t = t_1 = 2$. This prediction should be valid at in nitesimal U = t.

In the $\lim_{t\to\infty} it$ of large U the model (1) transforms to the J_1 J_2 chain

with J $_{\rm n}$ = 4t $^2{}_{\rm n}$ =U. The J $_{\rm 1}$ J $_{\rm 2}$ m odel spontaneously dimerizes [19] for big enough J $_{\rm 2}$. The critical value for = J $_{\rm 2}$ =J $_{\rm 1}$ can be determined by examination of the nature of the lowest-lying excitation for nite clusters [20]. In the spin-uid state C OS1 it is a triplet, in the dimerized state C OS0 it is a singlet (the dimerized state is doubly degenerate in the thermodynamic limit). One nds [20]: $_{\rm C}$ = 0.2411 = (0.491) 2 .

Torio et al. [21] have extended the level-crossing study used to determ ine $_{\text{C}}$ for the J_1 J_2 m odel to $_{\text{C}}$ nite U= $_{\text{L}}$ see the dashed line in Fig. 1. They propose that the dimerization line C 0S1-C 0S0 extends until U= $_{\text{L}}$! 0 and connects to $_{\text{L}}$ = $_{\text{L}}$ =2. This would consequently invalidate the weak-coupling RG-prediction of a M ott-H ubbard transition of type C 0S1-C 2S2. It seems, presently, more likely that the transition is of C 0S0-C nSm type, with n > 0.

The Majumbdar-Gosh point $J_2=J_1=2$, also called disorder-point, has an exact valence-bond dimer ground-state. For $>0.5=(0.707)^2$ the short range spin-spin correlations become incommensurable. Due to the absence of long-range order [22], the peak in the static structure factor S (q) moves away from q= only at the Lifschitz-point, which can be determined via DMRG [23] as $_{\rm L}=0.52063=(0.7215)^2$.

The classical spin-wave solution to (2) yields a long-ranged spiral ground-state for $\,>\,0.5$ [24,25]. A long-ranged ordered states is unstable towards quantum – uctuation in 1D , they become short-ranged. For the J_1-J_2 model the quantum – uctuations lead to a dimerized state with – nite dimerization and short ranged spiral (incommensurate) spin-spin correlations. They show up as a peak in S (q) for a incommensurate wavevector q and width 1= , where is the correlations length. There has been no study so far of the extension of the dimerized phase with incommensurate excitations, realized for $\,>\,0.5$ in the limit of large U=t $_1$ to – nite values of U=t $_1$. Here we propose that it connects to the metallic state.

A lso included in Fig. 1 are the predictions for the critical $U_{\rm C}$ for the M ott-H ubbard transition by Torio et al. [21] and by A ebischer et al. [26]. It has turned out to be very di-cult to determ ine num erically the location of this transition from estimates of the charge gap, extrapolated to the therm odynamic limit, due to the fact that the charge gap is exponentially small near the M ott-H ubbard transition. Here we indicate a quite accurate lower bound for the the M ott-H ubbard transitions can be obtained form the study of the momentum distribution function.

M ethod - In the last decade the density matrix renormalization group [16] emerged as a




Fig. 2 { Illustration of the momentum -distribution function n (k) for L = 48 sites, U = 4t₁ and t₂=t₁ = 0:6;0:8. DM RG results for N = L=2 (lled circles) and for N = L=2+2, N = L=2 (triangles-up: majority-spin, triangles-down: minority-spin). The lines are ts by Eq. (4).

reliable tool for the study of electronically one-dimensional models [17]. For strongly interacting ferm ionic systems, the evaluation of n(k) as the Fourier transform of the correlation function:

is numerically discult and costly in the framework of the DMRG [16,17], in particular for periodic boundary conditions [27]. Here we report results from DMRG calculations on half-led chains of length L=48, 80 using up-to 300 DMRG states, which we found su ciently accurate to determ ine n (k).

To obtain estim ates for the Ferm i wavevectors we have analyzed the momentum distribution function, see Eq. (3), obtained by DMRG, via two smoothed step functions at $k_{\rm F\,1}$ and $k_{\rm F\,2}$ with respective widths p_1 and p_2 [11]:

The quality of $\$ ts by (4) to n(k) is illustrated in Fig. 2. We will use the such obtained estimates for the Ferm i-wavevectors $k_{F\,1}$ and $k_{F\,2}$ in the further analysis.




Fig. 3 { For U = $4t_1$ and L = 48;80 sites the DMRG results for $k_{F\,1}$ and the di erence $k_{F\,2}$ $k_{F\,1}$ (both in units of) as obtained by thing the DMRG results for n (k) by Eq. (4), compare Fig. 2. The lines are guides to the eye. Below t_2 = t_1 0:74 two things happen: $k_{F\,1}$ renormalizes substantially with respect to its U = 0-value (dashed line) and $k_{F\,2}$ $k_{F\,1}$ deviated from its Luttinger-sum-rule-value of 0:5.

R esults – In order to elucidate the properties of the M ott-H ubbard transition [26] and of the incommensurate-commensurate transition in one dimensional frustrated systems, we studied them omentum-distribution function for a range of parameters that crosses all relevant phase transition-lines of the phase diagram of the 1D t_1 t_2 H ubbard model [28]. In Fig. 3 we present our estimates for $k_{\rm F}$ as a function of t_2 = t_1 for U = $4t_1$, in comparison with the

result for U = 0. We note a substantial renormalization of k_{F1} towards larger values below $t_2 = t_1 = 0.74$.

In the metallic state the Luttinger sum—rule states that the total volume of both Ferm is east ogether equals the number of electrons. At half—lling this statement is equivalent with $k_{F\,2}$ $k_{F\,1}$ = =2.0 urDMRG-data for $(k_{F\,2}$ $k_{F\,1})$ = presented in Fig. 3 indicates a violation of the Luttinger sum—rule below t_2 = t_1 0:74. We therefore conclude that the Mott-Hubbard transition occurs in the vicinity of this point (as indicated in Fig. 1 by the led diamond in Fig. 1) and that the system is insulating for t_2 = t_1 < 0:74. Due to the exponentially small gap in this region our result for the position of the Mott-Hubbard transition is in fact a lower bound (in terms of t_2 = t_1) for the exact transition point, as we would not be able to resolve numerically a possible exponentially small departure from the Luttinger-liquid sum—rule for t_2 = t_1 > 0:74.

Next we turn to an analysis of the nature of the spin excitation in the vicinity of the M ott-Hubbard transition. The spin-excitation in the insulating state correspond to renormalized particle-hole excitations with a spin- ip. They correspond therefore to states with N_" = L=2 + N=2 and N_# = L=2 N=2. Using for numerical convenience N = 2 we have calculated the respective Ferm i-w avevectors for the majority $k_{F\,1;"}$ and minority $k_{F\,1;"}$ spins. We denote the normalized shift for the Ferm i-w avevector as

The normalization in Eq. (5) is chosen such that $k_{F\,1}=1$, independent of system size L, for case of a single Ferm i-sea. In the lim it $t_2=t_1$! 1 the Hubbard zig-zag chain has two equally large Ferm i-seas, with equal Ferm i-velocities, and $k_{F\,1}$! 0:5 in this lim it, as we have veriled numerically for large $t_2=t_1$.




Fig. 4 { The normalized shift k_{F1} , see Eq. (5) for L = 48;80 sites and U = 4t₁. The lines are guides to the eye. For comparison, we have reproduced the results for k_{F2} k_{F1} from Fig. 3.

We have obtained k_{F1} by thing the respective momentum distribution functions for the majority and minority spins, see Fig. 2, by Eq. (4). The results are presented in Fig. 4.

We notice that $k_{F\,1}$ 1 for small $t_2=t_1$, in plying commensurated spin excitations. A well dened kink in $k_{F\,1}$ at $t_2=t_1$ 0:64 0:66 indicates a second-order transition to a state with incommensurate spin-excitations (denoted by the open diamond in Fig. 1).

These results imply that the M ott-H ubbard transition takes place for Ferm i-w avevectors at arbitrary, incom m ensurate values, and the Ferm i-w avevectors do not renormalize towards perfect nesting $k_{\rm F\,1}$! =2 and $k_{\rm F\,2}$!. In weak-coupling, U m klapp-scattering becomes relevant at perfect nesting and leads to the opening of a charge-gap. Our results indicate, that elective perfect-nesting is not necessary for the M ott-H ubbard transition for nite values of the interaction-strength.

D iscussion - The interplay between magnetic order and carrier mobility in strongly interacting systems, with the Mott-Hubbard transition as one important manifestation, has long been subject to intense investigation. For the two-dimensional (2D) case, important for experim ental realizations, exact analytical or num erical techniques are still lacking. It is known that in 2D the commensurate ordered phase for the nearest-neighbor Hubbard model is unstable with respect to helical uctuations [1,2] either upon doping or in the presence of frustrating next-nearest-neighbor interactions. Other, even more exotic phases [3,4] have also been proposed, in particular in the context of studies into the mechanism of high-tem perature superconductivity. Our investigation of the one-dimensional case of ers new insight into driving forces behind the M H transitions: nesting, i.e. the divergence of the m agnetic susceptibility due to special features of the Ferm isurface geometry emerges as su cient, but apparently not a necessary condition of the M H transition [29]. This result is inaccessible by weak coupling theory and indicates the existence of a generic mechanism for charge carrier freezing that is independent of dom inant Um klapp scattering processes. Spin-charge separation in Luttinger liquids m ay enhance this e ect in one-dimension, but similar strong-coupling scenarios must be present also in higher dimensions to explain the MH transition between incommensurate insulators and m etals in doped or frustrated 2D systems.
