Chapman-Enskog derivation of the generalized Sm oluchow ski equation

Abstract

We use the Chapman-Enskog method to derive the Smoluchowski equation from the Kramers

equation in a high friction limit. We consider two main extensions of this problem: we take into

account a uniform rotation of the background medium and we consider a generalized class of

K ram ers equations associated with generalized free energy functionals. We mention applications of

these results to system swith long-range interactions (self-gravitating systems, 2D vortices, bacterial

populations,...). In that case, the Smoluchowski equation is non-local. In the lim it of short-range

interactions, it reduces to a generalized form of the Cahn-Hilliard equation. These equations are

associated with an elective generalized thermodynamical formalism.

I. INTRODUCTION

The K ram ers (or K lein-K ram ers) equation [1, 2] and the associated Sm oluchow ski equation [3] are widely discussed in the physics of B rownian motion and stochastic processes. Initially, the K ram ers equation was introduced to describe the statistical evolution of a gas of B rownian particles in a potential well. It has been applied in dierent domains of physics such as colloidal suspensions, stellar systems, them ical reactions rate theory, nuclear dynamics, just to mention a few [4]. The K ram ers equation forms a particular class of Fokker-P lanck equations with a constant diusion coecient and a linear friction [5]. In the large time limit, the velocity distribution of the particles is close to the M axwellian distribution and the evolution of the spatial density is described by the Sm oluchow ski equation. The passage from K ram ers to Sm oluchowski equations has been the subject of many papers. In the early days, this passage was informal and qualitative [1, 4]. The derivation of the Sm oluchowski equation from the K ram ers equation is now a classical problem in many textbooks of statistical mechanics. In his monograph, van K am pen presents an expansion procedure similar to the Hilbert perturbation scheme [6].

In this paper, we propose another derivation of the Sm oluchow ski equation based on the Chapm an-Enskog expansion. U sually, the Chapm an-Enskog perturbation scheme is used to derive the hydrodynam ical equations (Euler, Navier-Stokes,...) from the kinetic Boltzmann equation [7]. In this context, the small parameter is played by the typical collision time. The Chapman-Enskog expansion allows to determine the expression of the diusion coecients (viscosity, heat conductivity,...) in the uid equations. In the context of the Kramers equation, the small parameter is played by the inverse of the friction coecient. We can therefore expand the distribution function in powers of $^{-1}$. To rest order in this expansion, we obtain the Smoluchowski equation. The diusion coecient is given by the Einstein relation $D = k_B T = m$ where T is the temperature.

We shall consider two main generalizations of this problem. First, we consider the situation in which the ambiant medium is uniformly rotating so that the velocity which appears in the Kramers equation is the relative velocity with respect to the background ow. Inertial forces appear in the rotating frame and the expression of the Smoluchowski equation is modied. Secondly, we consider a generalized class of Kramers equations introduced recently by Kaniadakis [8], Frank [9] and Chavanis [10, 11] (see also an early version in [12]). These

equations share the same properties as the ordinary K ram ersequation but they are associated with a more general form of free energy functional. This generalization encompasses the case of quantum statistics (fermions and bosons) and it can also not applications in the physics of complex media. In that context, they extend the nonlinear Fokker-Planck equation [13, 14] associated with the Tsallis entropy [15]. We derive here the generalized Smoluchowski equation from the generalized K ramers equation by using a systematic procedure. The dission coescient is given by a generalized E instein relation which depends on a function (x) in plicitely determined by a second order discretial equation.

The paper is organized as follows. In Sec. II, we recall the main properties of the (generalized) K ram ers and Sm oluchow ski equations. In Sec. III, we apply the Chapm an Enskog expansion to the generalized K ram ers equation. We account for a solid rotation of the background medium and calculate the new terms that appear in the Smoluchowski equation due to rotation. In Sec. IV, we derive a variant of the generalized Smoluchowski equation by using a moment method. Finally, in Sec. V, we shortly discuss the application of these results to the case of system s with long-range interactions (self-gravitating system s, 2D vortices, bacterial populations,...). In that case, the Sm oluchow ski equation becomes non-local and possesses a rich mathematical and physical structure [10]. We determine the Lyapunov functional associated with the generalized Smoluchowski equation and interpret this functional as a free energy. In the lim it of short-range interactions, this functional reduces to the Landau free energy and the non-local generalized Sm oluchowski equation reduces to a generalized form of the Cahn-Hilliard equation. In Appendix A, we consider the case of an isotropic BGK operator and in Appendix B, we consider a wider class of K ram ers equations with time varying Lagrange multipliers accounting for integral constraints (energy, angular m om entum and im pulse conservation).

II. GENERALIZED KRAMERS AND SMOLUCHOW SKIEQUATIONS

It has been noted recently that standard kinetic equations (Boltzmann, Landau, Kramers, Smoluchowski,...) could be generalized so that they increase a larger class of functionals than the Boltzmann entropy (or Boltzmann free energy) [11]. Such generalized kinetic equations appear when the transition probabilities have an expression dierent from the one we would naively expect [8] or when the system is described by a stochastic process involving

a multiplicative noise depending on the density [10, 16]. These generalized kinetic equations encompass the class of quantum kinetic equations (with exclusion or inclusion principle) already discussed in the literature. They can also be interpreted as \e ective equations" trying to take into account \hidden constraints" in the physics of complex media [11].

The generalized K ram ers equation can be written in the form [10]:

where f = f(r; v; t) is the distribution function, C is a convex function (i.e. $C^{(0)} > 0$), = 1=T is the inverse temperature and (r) is an external potential. Since the temperature T is xed, the above equation describes a canonical situation. We introduce the functional

where = R fd^3v is the spatial density. This functional can be interpreted as a free energy F = E TS, where S is a \generalized entropy" and E = K + W is the energy including a kinetic term and a potential term. When S[f] is the Boltzmann entropy, Eq. (1) reduces to the ordinary K ram ers equation. More generally, it is straightforward to check that F[f] plays the role of a Lyapunov functional satisfying F 0. This is similar to a canonical version of the H-theorem. Finally, a stationary solution of Eq. (1) is determined by the condition @f = @t = 0, in plying F = 0, and yielding

The equilibrium distribution $f_{eq}(r;v)$ m in im izes the free energy F [f] at xed m ass and tem perature. Similarly, the generalized K ramers equation (1) maximizes the rate of dissipation of free energy F at xed m ass and tem perature. We refer to Ref. [10] for a more detailed discussion of these results.

For large times t , where = D is the friction coe cient, the distribution function is close to the isotropic distribution function f(r;v;t) determined by the relation

This distribution function cancels out the di usion current in the generalized K ram ers equation (1). The pressure $p=\frac{1}{3}^R$ fv²d³v = p() and the density = R fd³v = () are related to each other by a barotropic equation of state p = p() which is entirely specified by the

function C (f). Taking the moments of the generalized K ramers equation (1), it is shown in [10] that the time evolution of the density (r;t) is governed by the generalized Sm oluchowski equation

This equation was initially obtained in [12] from a special form of K ram ers equation associated with the Ferm i-D irac entropy. The generalized Sm oludhowski equation decreases the functional

which is the simplified form of free energy (2) obtained by using the isotropic distribution function (4) to express F[f] as a functional of [0]. Thus, F 0, as can be checked by a direct calculation. At equilibrium, F = 0 and we obtain the condition of hydrostatic equilibrium

This relation also directly results from Eq. (3). The object of this paper is to present a form alderivation of the generalized Sm oluchow skiequation (5) from the generalized K ram ers equation (1), using a Chapman-Enskog expansion.

III. CHAPMAN-ENSKOG EXPANSION OF THE GENERALIZED KRAMERS EQUATION

We write the generalized Kramers equation in the form

where g and h are arbitrary (positive) functions [11]. We assume that our B rownian particles evolve in a background that is rotating and translating uniform by, so that w = v undenotes the relative velocity of the particles with respect to the background ow with u = r + U. The \generalized entropy" associated with this equation can be written

where the function C is determined by the relation

We consider the high friction $\lim_{x\to 0} ix = D$! +1 , where = O(1). We rewrite Eq. (8) in the form

where = D 1 is a small parameter, L = v 0 = 0 r r 0 = 0 v is the advective operator and Q (f) is the collision operator

Our aim is now to derive an equation for (r;t) to second order with respect to . For that purpose, we follow a Chapman-Enskog procedure and employ a formalism in the spirit of [17]. More precisely, we look for a solution f to (11) of the form $f = f_0 + f_1$ where f_0 is the equilibrium distribution function with the same density as f, that is, Q (f_0) = 0 and

Our aim now is to express f_0 and f_1 in terms of , so as to deduce from (18) a closed equation for . First, we note that $Q(f_0) = 0$ is equivalent to the condition

This relation, supplemented by Eq. (13), completely species f_0 .

We next determ ine f_1 . For that purpose, in view of (17), we need to investigate the invertibility properties of D Q (f_0). This is the subject of the following result.

P roposition III.1 The operator D Q (f_0) is a non-positive self-adjoint and closed operator on the H ilbert space H = L^2 (R^3 ; $C^{(0)}(f_0)d^3v$). The null space N of D Q (f_0) is given by

from which we readily deduce that DQ (f_0) is non-positive and self-adjoint in H . Also, its null space is given by Eq. (20). The closedness of DQ (f_0) nally follows by classical arguments.

We are now in a position to determ ine f_1 . Let be the orthogonal projection in H on N and denote by D Q $(f_0)^{-1}$ the inverse of the restriction of D Q (f_0) to N?. Then, applying successively Id and D Q $(f_0)^{-1}$ to (17), we obtain

Equations (37), (40) and (42) form ally solve the problem in the general case. We shall now consider simplied forms of the generalized K ram ers equation, corresponding to specic expressions of g and h [11]. First, we impose g(f) = f and $h(f) = fC^{0}(f)$. In that case, the collision operator takes the form

This equation was previously derived in [10] by working out the moments of the Kramers equation. The present method, in addition of being more rigorous, also provides the rst order correction to the distribution function. We have

There does not seem to be any simple solution to this equation. This implies that is probably not equal to 1= in that case.

IV. A MOMENT METHOD FOR THE GENERALIZED KRAMERS EQUATION

In this section, we use a m om ent m ethod to derive a variant of the Sm oluchow ski equation from the generalized K ram ers equation. This approach was previously developed in [12] for the ferm ionic K ram ers equation. We consider here a more general situation. We show in particular that the diusion coe cient obtained by the moment method has a dierent expression from that obtained by the above Chapman-Enskog approach. To simplify the presentation, we consider the case u = 0, that is

System (52) is not closed in the sense that it involves unknown quantities P(f) and q(f) that still depend on the distribution function f. It is well known that a maximum entropy principle can be used to specify f in terms of , u and e leading to a closed set of equations for these quantities. Under some suitable hypotheses on the entropy functional P(f), one can show that the distribution function f that maxim izes the entropy density P(f) with the prescribed conditions (51) is given by

V. LANGEVIN PARTICLES IN INTERACTION

A. A non-local Sm oluchow ski equation

The previous results remain valid when the force is related to the density by a relation of the form

where $(r^0 - r)$ is a binary potential of interaction depending only on the absolute distance $jr^0 - rj$ between the particles. In that case, the potential energy reads

where the 1=2 factor guarantees that the contribution of a particle is not counted twice. With this form of interaction, the generalized Smoluchowski equation (37) becomes non-local and takes the explicit form

where u = r + U . Equation (68) was introduced by Chavanis [10] (see an earlier version in [12]). It is valid for an arbitrary equation of state p() and an arbitrary potential of interaction (r^0 r). When the potential of interaction is long-range and attractive, this equation exhibits a rich variety of behaviors associated with canonical phase transitions and blow up phenomena. Among long-range potentials, the gravitational potential plays an important role. In this context, Eq. (68) has been studied in [18] for an isothermal equation of state p = T, in [19] for a polytropic equation of state p = KFerm i-D irac equation of state. In the isotherm alcase, Eq. (68) describes a gas of Brownian particles in interaction (this is the canonical counterpart of a Ham iltonian system of particles in interaction). In the non-isotherm alcase, it describes Langevin particles in interaction displaying anom alous di usion. A form al derivation of Eq. (68) is proposed in [21] starting from a generalized class of stochastic processes and using a mean-eld approximation. Equations similar to non-local generalized Fokker-P lanck equations also arise in the context of 2D turbulence and stellar dynamics [12, 22], and to describe the chemotaxis of bacterial populations [10, 23]. As explained in Refs. [10, 19], Eq. (68) can be used alternatively as a num erical algorithm to compute nonlinearly dynamically stable stationary solutions of the

Euler-Jeans equations in astrophysics. This can be particularly interesting in the case of rotating stars that are not spherically symmetric.

B. The Lyapunov functional

An additional interesting feature of the generalized K ram ers and Sm oluchow ski equations when the potential is given by Eq. (66) is the existence of a Lyapunov functional [10]. Indeed, let us write the generalized K ram ers equation in the form

This is the Cahn-Hilliard equation which has been extensively studied in the theory of phase ordering kinetics. Its stationary solutions describe \domain walls". We can view therefore Eq. (68) as a generalization of the Cahn-Hilliard equation to the case of long-range interactions and arbitrary free energy functionals. This is why its physical and mathematical richness is so in portant.

VI. CONCLUSION

In this paper we have derived the Smoluchowski equation from the Kramers equation by using a form al Chapman-Enskog expansion. We have shown furtherm ore that this derivation could be generalized to a larger class of K ram ers equations where the di usion coe cient and the friction term depend on the distribution function. The resulting Sm oluchowski equation takes a nice form where the usual term T is replaced by a pressure p(), as previously noted in [10, 12]. When the potential (r;t) is induced by the density of particles them selves, the generalized Smoluchowski equation becomes non-local and can generate a rich variety of phase transitions as discussed in [10], and more specically in [18, 19, 20]. In the limit of short-range interactions, it reduces to the Cahn-Hilliard equation widely studied in the context of phase ordering kinetics. It is interesting to note that these dierent equations are closely related to each other and that they are associated with an e ective generalized therm odynam ical form alism [10, 11]. An interest of this form alism is to unify di erent types of approaches. For example, it encompasses the case of quantum particles with exclusion or inclusion principle. On the other hand, our approach extends the nonlinear Fokker-Planck equations [13] associated with the T sallis entropy. Indeed, the T sallis entropy does not play any special role in our form alism and most of the properties of the nonlinear Fokker-Planck equation can be generalized to a wider class of entropy functionals [10]. The T sallis entropy form s, however, an important class of functionals associated with polytropic distributions and power-laws. These distributions generate a natural form of self-con nement that can be of interest in nonextensive systems. However, it was our interest here to show that a m ore general form alism could be developed consistently. A notion of \generalized therm odynamics", with a dierent presentation and a dierent motivation, has been developed independently by Kaniadakis [8], Frank [9] and Naudts [25].

where the param eters , and U depend on time so as to satisfy at each instant t, the conservation of energy, angular momentum and in pulse, and the potential is given by Eq. (66). Their evolution is obtained by substituting Eq. (B1) in the constraints E = E = P = 0. It can be shown that Eq. (B1) increases the generalized entropy (9) at xed mass, energy, angular momentum and in pulse (H-theorem). This corresponds to a microcanonical situation. Equation (B1) can be obtained from a variational principle called Maximum Entropy Production Principle (MEPP). In this context, , and U appear as time dependant Lagrange multipliers associated with the integral constraints. This type of equations were proposed in [12] as a small-scale param etrization of the gravitational V lasov-Poisson system in the context of the theory of violent relaxation. As explained in [10], these relaxation equations can also be used as numerical algorithms to compute nonlinearly dynamically stable stationary solutions of the V lasov-Poisson system. This would be particularly interesting in the

case of rotating stellar systems that are non spherically symmetric. They can have similar applications in other domains of physics with dierent types of interaction.

Considering the limit! +1, the Chapman-Enskog method of Sec. III can be implemented with only slight modications. Due to the time dependence of the Lagrange
