E ects of Short-Range Correlations on the Coulom b Screening and the Pairing Interactions in Electron-Phonon System s { Triplet Pairing M ediated by Phonons {

E ects of short-range correlations on the C oulom b screening, the phonons, and the pairing interactions are exam ined in electron-phonon system s. First, we derive a model H am iltonian of C oulom b interactions which includes both the long-range part v_q and the short-range part U. It is found from the expression of the dielectric function that the strong on-site correlations weaken the C oulom b screening. Secondly, we exam ine the screened phonons and the interaction m ediated by phonons. In a consistent picture, we derive an expression of the e ective interaction which includes (1) the screened C oulom b interactions, (2) the pairing interactions mediated by phonons, and (3) the e ective interactions mediated by spin and charge uctuations. It is rewritten in a form of a summation of (a) the e ective interactions of the pure H ubbard m odel without the long-range C oulom b interactions, and (b) the phonon-mediated interactions plus screened C oulom b interactions with corrections due to both U and v_q . Thirdly, we derive an e ective Ham iltonian analogous to the BCS Ham iltonian. Fourthly, for some typical values of param eters, we obtain the ground state phase diagram s. It is found that spin-triplet superconductivity mediated by phonons occurs when the short-range electron correlations are su ciently strong, and the C oulom b screening is su ciently weak. We estim ate the orders of the transition tem peratures when the triplet superconductivity occurs. The obtained values are realistic for existing candidates of the triplet superconductors as the order of the m agnitudes. The possible relevance of the phonon-mediated interactions to the heavy ferm ion superconductor UP t_3 and the layered superconductors such $(TMTSF)_2X$ and Sr_2RuO_4 are brie y discussed.

1. Introduction

It is widely known that overscreening of the repulsive C oulom b interactions between electrons by ions gives rise to attractive interactions for low frequencies j! j. $!_D$.¹⁾ This dynamicale ect is considered to be the origin of the pairing interactions mediated by phonons, which induce the superconductivity in metals. At the same time, the long-range C oulom b interactions are screened into short-range interactions, and consequently the energies of the optical phonons of short wavelengths are reduced into the accoustic type $!_q$ jrj.

On the other hand, the screening of electronic and ionic charges in uences the momentum dependence of the attractive interactions through the dielectric function. If there were not the screening, the coupling constant between electrons and optical phonons diverges as jrj! O due to the long-range nature of the C oulom b interactions. How ever, in actuality, such divergence is suppressed by the screening, but the coupling constant rem ainsm om entum dependent.

Owing to such momentum dependences of the electron-phonon coupling constant and the phonon energy, the resultant pairing interaction mediated by phonons depends on the momentum transfer. Hence, it includes the anisotropic components, when it is expanded in terms of appropriate basis functions. U sually, such anisotropic components are ignored, because they are considered to be much smaller than the isotropic com – ponent in most cases. In fact, the superconductivity in the ordinary metals, which are probably mediated by phonons, are considered to be of s-wave pairing.

However, as Foulkes and G yor y pointed $\operatorname{out}^{2}_{r}$ when the short-range C oulom b interactions are strong enough to suppress isotropic pairing, anisotropic pairing can be induced by the subdom inant anisotropic interaction. They have exam ined possibility of spin-triplet superconductivity by this mechanism in metals such as Rh, W, and Pd.

A brikosov discussed high- T_c cuprates, and proposed that such momentum dependence of the phononmediated pairing interaction could give rise to extended s-wave superconductivity,³⁾ although it seems from some experiments that the cuprates are d-wave superconductors. Following his theory, Bouvier and Bok calculated the superconducting gap function and obtained anisotropic momentum dependence.⁴⁾ Friedel and K ohm oto, and Chang, Friedel and K ohm oto exam ined the d-wave pairing interactions mediated by phonons in the cuprates.^{5,6} The present author and K ohm oto have proposed⁷ that in the presence of coexisting ferrom agnetic long-range order, a subdom inant triplet state occurs after the singlet states are suppressed by the strong exchange eld. We have discussed a possibility of this mechanism in UG e₂.^{8,9}

It is easily veri ed that the momentum dependence of the interaction is stronger for weaker screening. For example, in the Thom as Ferm i approximation, the coupling constant has a peak with the width of the inverse screening length in the momentum space. Therefore, in the interactions, the ratios of the anisotropic com ponents to the isotropic component increase¹⁰⁾ when the screening becom es weaker. There are som e possible factors which weaken the screening e ect, such as crystal structures, low density of charge carriers, and low density of states. The present author and K ohm oto have exam ined layer structures as the weakening mechanism $,^{11}$ because som e candidates of the triplet superconductors have layer structures as we shall discuss below. It was found that when the layer interval increases, the screening becomes weaker, and subdom inant triplet pairing interaction could more easily overcome the dominant s-wave pairing interaction with an asist of the on-site Coulomb repulsion.

It should be noted^{7,11)} that the on-site C oulom b interaction is speci c to the electron system s in solid, and does not appear in the electron gas m odel in the continuum space. The magnitude of the on-site C oulom b energy U depends on the prole of the W annier functions. Since such an on-site interaction is constant in the crystal m om entum space, it only suppresses isotropic pairing, and consequently it favors subdom inant anisotropic pairing.¹¹⁾

W ith respect to application, we are motivated by recently discovered exotic superconductors, such as Sr₂RuO₄, organic superconductors, and heavy ferm ion superconductors. In the Sr₂RuO₄ superconductor, spintriplet pairing has been suggested by a K night shift m easurem ent¹²⁾ and a SR experim ent.¹³⁾ M any theories have been proposed on this material, and there are some controversies especially on the momentum dependence of the superconducting gap function.¹⁴⁾ Particularly, som e nonphonon mechanisms have been considered, 14 but there has not been any evidence at present. On the other hand, the Sr₂RuO₄ superconductor exhibited the isotope e ect coe cients with unusual dependence on the impurity (or oxygen defect) concentration and a reverse isotope e ect in clean sam ples¹⁵⁾ The form ar can be explained by assuming internal transition of superconductivity,¹⁶⁾ if the phonon-mediated pairing interaction exists. For the latter result, it has been show n^{17} that within the weak coupling theory, the reverse isotope e ect indicates that the Coulomb interaction between electrons, in total e ect, works as repulsive interactions against the superconductivity, unless the system is in the very vicinity of any m agnetic instability. At present, any pure nonphonon theory could not explain these experimental facts of the isotope e ect.

Another candidate of the present mechanism of triplet superconductivity is the fam ily of (TM TSF)2X compounds. From the experimental results at the early stage after the discovery of superconductivity in these compounds, including nuclear magnetic resonance $(NMR)^{18,19}$ and the phase diagram s_r^{20} d-wave superconductivity mediated by antiferrom agnetic spin uctuation has been studied in these com pounds.^{21,22)} However, recent experim ental studies suggest spin-triplet superconductivity in (TMTSF)₂PF₆²³⁾ and $(\text{TMTSF})_2 C \log_4 e^{24,25)}$ although some of the experin ental results have not been explained by triplet pair ing^{26} . We will exam the this problem in a separate paper in details, applying the present mechanism of triplet pairing to these compounds.²⁷⁾ Only by the phonon mechanism, it might be di cult to reproduce the pressure dependence of the superconducting transition temperature T_c observed in these compounds.²⁰⁾ The pressure dependence m ay be explained by taking into account the contribution from the spin uctuations to the pairing interactions. The pairing interactions mediated by the spin uctuations include the attractive triplet com ponents.^{22,28)}

W e also consider the heavy ferm ion superconductors, such as UPt_3 , $2^{(9,30)}$ as candidates in which the pairing interactions m ediated by phonons m ay contribute to spintriplet pairing. Since the width of the e ective band is extrem ely narrow, s-w ave state could not avoid the onsite Coulomb repulsion by the retardation e ect. If one use the Thom as Ferm i approximation in the estimation of the screening length, it becomes much smaller than the lattice constant. However, it is not justi ed for a phenom ena of such a sm all length scale. In actuality, the dipole eld due to the charge distributions in the unit cell could not decay so rapidly within the scale of the lattice constant. Hence, the electron-ion interaction is not necessarily limited on the each lattice site. Therefore, it may contribute to the anisotropic pairing interactions. W hatever the pairing mechanism is, since the heavy mass renormalization signi cantly reduces the effective coupling constant of the pairing interaction, the bare pairing interaction needs to be very large for the observed T_c to be reproduced.

In general, it is reasonable that the phonon-m ediated pairing interaction could contribute to superconductivity to some extent in m ost cases, even when the resultant gap function is an isotropic. In fact, in alm ost all superconductors including exotic ones, non-vanishing isotope e ects have been observed. It is reasonable to take them due to attractive contributions from phonons to the pairing interactions. It is likely that the m om entum average like h $(k)V_{\rm ph}$ $(k \quad k^0) \quad (k^0)$ i is negative, since the phonon-m ediated pairing interaction $V_{\rm ph}$ (q) have a negative peak

around q = 0 and $j(k)_{j}^{2} > 0$, where (k) denotes the function that expresses the momentum dependence of the gap function (k) / (k). Further, it is likely that the isotropic component is dom inant, and the second and third-dom inant ones are anisotropic and of odd and even parities in the momentum space, respectively.

In particular, in the spin-triplet superconductors, the phonon-mediated pairing interaction can be the main mechanism of the anisotropic superconductivity, although another mechanism might assist it at the same time.³¹⁾ By an analogy to the super uidity in liquid ³He,³²⁾ the paramagnon mechanism is sometimes considered to be responsible for the spin-triplet superconductivity. However, the situation is very dienent from the electron systems in the solids. The liquid ³He does not have lattice vibrations, and its transition temperature is of the order of 1mK.³³⁾ Therefore, we should be careful when we use the analogy.

In the anisotropic singlet superconductors, the thirddom inant component of the phonon-mediated interaction may contribute to the superconductivity to some extent. However, we presume that it could not be the only origin of the pairing interaction. If the pairing interaction of nonphonon origin is negligible, the system should undergo a transition to triplet superconductivity at a higher tem perature, since the third-dom inant even-parity (spinsinglet) component is smaller than the second-dom inant odd-parity (spin-triplet) component.

In this paper, we examine the e ects of the shortrange (on-site) correlations on the Coulomb screening, phonons, and the pairing interactions, taking into account the long-range C oulom b interactions at the sam e time. The main purpose of this paper is to devolop a general theory, although we are motivated by the superconductors discussed above. In particular, we derive a general e ective Hamiltonian in a uni ed fram ework in which the short-range and long-range parts of the C oulom b interactions are treated consistently. The e ective Ham iltonian includes (1) the screened Coulomb interactions, (2) the phonon-mediated interactions by the screened electron-phonon interactions, and (3) the e ective interactions mediated by spin and charge uctuations. In appropriate lim its, it is reduced to the e ective Ham iltonians exam ined by many authors so far. $^{3(7,11)}$ In particular, in our previous papers, the on-site C oulom b energy U has been treated as a param eter independent of the phonon-m ediated pairing interaction, but in practice it also modi es the pairing interactions. W e w ill also clarify it in this paper.

In x2, we exam ine the model of the electron-phonon system. Starting from a basic model of the electron-phonon system, we derive a H am iltonian which includes both the short-range part U and the long-range part v_q of the C oulom b interactions. In x3, we apply the random phase approximation (RPA) to the H am iltonian obtained in x2, and exam ine the screening elects on the C oulom b interactions. The approximation is reduced

to that in the electron gas model if we put U = 0 and $v_q \in 0$, while that in the pure Hubbard model if we put $U \in 0$ and $v_q = 0$. In x4, we exam ine the two-particle vertex part which contributes to superconductivity. We derive the general form which includes corrections due to U as mentioned above. In x5, we derive an elective interaction within the weak coupling theory from the results of x4. We exam ine anisotropic superconductivity on the basis of the elective interaction. Expressions of the transition temperature and the isotope elective cient are derived. In x6, we apply the elective model to some typical cases to clarify essential aspects of the present mechanism. The phase diagram s and the transition temperatures are obtained. The last section x7 is devoted to sum mary and discussion.

2. A M odel of the E lectron-Phonon System

In this section, we derive a model that we will examine in this paper. We start with the general form of the coupled electron-phonon H am iltonian

Here, q_k denotes the electron operator of the B loch state with the crystalm om entum k and the spin in the relevant electron band, while b_q donotes the bare phonon operator of the phonon with the momentum q and the phonon-mode . Since we consider the longitudinal optical phonons in this paper, we om it the phonon-mode su x and the sum mation over it for simplicity. Thus, we put q = p, where p denotes the ionic plasma frequency. We consider the positive background charge of the atoms within the jellium model.¹⁾ Therefore, we put the matrix element of the electron-phonon interaction M kg = M g which satis es

where V_{cell} denotes the unit cell volume. The present model might not be very accurate, but since we need an order estimation at most for our purpose, we use this model in this paper for simplicity.

The coupling constant $V_{k_1k_2k_3k_4}$ is expressed as

2.1 An expression in the tight-binding model

Now, we rewrite the Coulomb interaction H $_{\rm C}$ in the tight-binding model.W hen the tight-binding approxim ation is valid and the electron wave function has a large amplitude only near the atom ic site, we may assume that

where we have om itted terms including the factor of the form (r R₁) (r R₂) with R₁ $\stackrel{f}{\bullet}$ R₂, since it is small from the assumption mentioned above. In the integrand of eq. (2.11), we could replace r and r⁰ in e²=jr r⁰j with R and R⁰, respectively, due to the factors of j (r R) fj (r⁰ R⁰) f, except when R = R⁰. We could not make this replacement when R = R⁰, because e²=jr r⁰j diverges when r ! r⁰. Therefore, we obtain

for q 6 0. It is obvious that the on-site C oulom b energy U depends on the prole of the W annier function, which expresses the charge distribution near the atom is site. Here, we put $v_{q=0} = 0$, taking into account the charge neutrality in the present jellium model. We call the onsite U and the inter-site v_q the short-range and long-range parts of the C oulom b interaction, respectively. If we put $v_q = 0$, the present model is reduced to the pure H ubbard model on a lattice, while if we put U = 0, it is reduced to the electron gasm odel in the continuum space except that the momenta are replaced with the crystal momenta.

2.2 Approximation for the long-range part

Now, we exam ine the long-range parts v_q in detail. For small $q ~ {\rm fo}$, we could approximate v_q by

Here, we note that a periodicity relation $v_{q+K} = v_q$ holds in the original expression eq. (2.14), where K denotes any reciprocal lattice vector, whereas it does not hold in the approximate expression eq. (2.18). Therefore, if one uses eq. (2.18) in calculating the gap function (k), the reciprocal lattice periodicity (k) = (k + K) of the gap function is broken.

Therefore, we note that the original expression of v_q , eq. (2.14), is large near q = K, not only near q = 0, for the lattice periodicity. In the gap equation, the momentum q corresponds to the momentum transfer k k^0 , where k and k^0 denote the electron momenta near the Ferm i surface. Even when k and k^0 are in the rst B rillouin zone, q K = k k^0 K can be small, for example when the Ferm i surface is open. For such




Fig. 1. Estimation of the nearest neighbor C oulom b interaction v_a calculated with the approximate equation (2.19) in the nite size system with the linear dimension N $_{sx}$. The broken line is the guide for eyes. The thin solid line shows the exact value $v_a = 1$.

k and k^0 , we should use the approximate expression $v_q = 4 e^2 = V_{cell} \dot{q}$ K², which is very di erent from eq. (2.18) near q = K. Therefore, a more appropriate expression of eq. (2.14) is

rather than eq. (2.18). This expression is appropriate not only near q = 0, but also near q = K. Near the B rillouin zone boundary of q, the derivative of the right-hand-side of eq. (2.19) jumps, but since v_q is very sm all there, it does not cause any di culty in practice.

Let us exam ine the error of the above approximation. Since eq. (2.19) becomes exact relation for long wavelengths, it is expected that the error of eq. (2.19) is larger for shorter wavelengths. Hence, the nearest neighbor C oulom b interaction

would have the largest error, where a = (a;0;0) denotes one of the unit lattice vectors, since the on-site C oulom b interaction U is not included in the denition of v_q , eq. (2.14). Figure 1 shows the result of eq. (2.20) calculated with the approximate equation (2.19) in the electron system on the cubic lattice with the number of the lattice sites $N = N_{sx}^3$, where N_{sx} denotes the num – ber of the lattice sites in one direction. It is found that as the system size increases, the value of v_a estimated by eq. (2.19) approach a value $1:05 \quad e^{-a}$, which is only 5% larger than the exact value. Therefore, the present approximation does not cost major error even in the short wavelength behavior.

3. Coulom b Screening

In this section, we exam ine the screening e ects on the Coulomb interactions between two electrons, the electron-phonon interactions, and the phonon propagators. For convenience, we de ne appropriately scaled functions of the charge and spin uctuations in the pure Hubbard model i.e., the model with U \leq 0 and $v_q = 0$, in the RPA by

with the unperturbed G reen's function $G^{(0)}$. Here, we have introduced the four-momentum notation such as $q = (q; i_m)$ and $k = (k; i!_n)$.

3.1 Fluctuations and Screened Coulom b Interactions

In this subsection, we derive an expression of the screened C oulomb interactions in the presence of both the short and long-range parts of the C oulomb interactions, U and $v_{\rm q}$.




Fig. 2. Assignment of the momenta and spins in the two body vertex part $(k;k^{0};q)$.




Fig. 3. Sum mation of the ring diagram s. The solid and broken lines denote the electron G reen's function and the C oulom b interaction eq. (2.12).

First, we consider the ring diagram s by the RPA as depicted in Fig. 3, where the momenta and spins are assigned as shown in Fig. 2. Since the dashed lines of the Coulomb interactions have the same momentum q in those diagram s, they become divergently large at the same time for sm all jrj. Therefore, this series gives a m a jor contribution for long wavelengths.

Here, we note that the rotational symmetry in the spin space is not retained if we take only the ring diagram s.³⁴⁾





Fig. 4. Sum mation of the particle-hole ladder diagram s. The definitions of the lines are the same as those in Fig. 3. The incoming and outgoing thin solid lines are to show how to apply the diagram s to the two-particle vertex in the self-energy and the superconductive gap equation.

In order to recover the rotational invariance, we need to take the particle-hole ladder diagrams depicted in Fig. 4, with respect to U. The second term in the braket of eq. (3.6) becomes divergently large for the momentum q near the nesting vector Q, when the Ferm i surface has a good nesting condition, as known in the Hubbard model.^{35,36)} It is also known that the contribution from the ladder diagrams in Fig. 4 is of the same order as that from the ring diagram s.

In contrast, in the RPA in the pure electron gasm odel with U = 0, the ladder diagram s are ignored. Since the momentum of the interaction lines do not always coincide as those in the ring diagram s, the contribution from the ladder diagram s is smaller than that from the ring diagram s. Hence, we om it v_q in the ladder diagram s also in the present m odel.

Thus, the contribution from the ladder diagrams is obtained as

Therefore, it is found that the screening length is lengthened by a correlation e ect due to the on-site C oulom b repulsion in comparison to the T hom as-Ferm i screening length $_{\rm TF}$. It is plausible that the local electron density less easily deviates from the uniform value in the presence of strong correlations. In other words, the charge uctuations are reduced ($\begin{bmatrix} 0\\ c \end{bmatrix}_{U \in 0} < \begin{bmatrix} 0\\ c \end{bmatrix}_{U = 0}$) and $_{\rm U} > 1$, when U > 0. It is interesting that the short-range part of the C oulom b interactions a ects the long-range behavior through a m any body e ect.

3.3 Corrections to the electron-phonon interactions

Now, let us exam ine renorm alization of the electronphonon interaction due to the Coulomb screening e ect as depicted in Fig. 5. As the screened Coulomb interaction, we take the series of the ring diagrams shown in Fig. 3. How ever, if we apply the ladder diagrams in thick dashed line in Fig. 5, the ring part consists of many electron lines. In such a ring, the integrand could be large only in a very small part of the phase space of the in-

3.4 Corrections to the phonons

In this subsection, we exam ine the phonon G reen's function.W e consider the renorm alization of the phonons due to the Coulomb screening through the electron-phonon interaction shown in Fig. 5. 


Fig. 7. The diagram equation for the polarization propagator. The solid line and thick dashed line denote the bare electron G reen's function and the screened C oulom b interaction.

4. Superconductivity

In this section, we exam ine the two-particle vertex part

, $(k;k^0)$, which induces superconductivity. We clarify the corrections to the vertex part due to the on-site C oulom b interactions.

4.1 De nition of the e ective interactions

The two-particle vertex part $_{1}(k;k^{0})$ is defined as one which scatters the pair of two electrons with (k;)and $(k; _{1})$ to that with $(k^{0};)$ and $(k^{0}; _{1})$. The gap equation of superconductivity is written as

In order to estimate T_c accurately, we need to solve the full set of equations. Especially when we consider the spin- uctuation-mediated superconductivity, since the attractive part of the interactions is much weaker than the repulsive part, the self-energy e ect is important.³⁷⁾ However, since in this paper we are mainly interested in the phonon-mediated pairing interactions, we om it the self-energy renorm alization of the electrons from now on.

We can improve the perturbation theory^{38,39)} by including renorm alization of the electron G reen's function and the vertex corrections in $;_1$ (k;k⁰). For example, we could take into account the correction to the spin and charge uctuations from the self-energy e ect by replacing $_0$ (q) with (q), as in the renorm alized RPA, although it requires heavy num erical calculations.

However, we expect that the most essential diagram s are taken into account in the RPA.W ithin the RPA, we could reproduce a physical situation that the strong charge and spin uctuations mediate the pairing interactions. This consideration is partially based on a phenom elogical view point. How ever, more or less, we could not avoid such a phenom enological consideration in the perturbation theories based on e ective Ham iltonians, such as the Hubbard model. In any perturbation theory, we need to ignore alm ost all diagram s in the in nite series of the perturbation expansion. Taking a particular series of the diagram s can be rigorously justi ed only in an appropriate lim it, but otherwise it is not quantitatively accurate very much. Furtherm ore, we need to use the e ective Hamiltonian, which is usually far simpler than the real materials. U sually, e ective H am iltonians are useful for qualitative study, but are not very precise quantitatively. Therefore, even if we develope a perturbation theory by purely theoretical e orts beyond the RPA, the applicability of the quantitative results to the real m aterials are lim ited, unless any qualitatively distinct result is obtained.

4.2 Expression of the e ective pairing interactions

In this subsection, we derive the expression of $_{_1}(k;k^0)$ from the results of the previous section x3. If we put $v_q = 0$, the spin and charge uctuation terms are reduced to the expressions obtained in m any articles.^{22,28,31,35,36)} D ue to the complicated m om entum dependence, it can work as an attractive interaction or as a repulsive interaction in the formation of the Cooper pairs, depending on the symmetry of the gap function and the shape of the Ferm i surface.

Since we have obtained the expressions of the vertex part eqs. (4.12) and (4.13), it is possible in principle to solve the E liashberg equations (4.1) and (4.3). However, we leave it for future study, and derive weak coupling e ective H am iltonian in the next section x5.

5. E ective Interactions for W eak C oupling

In this section, we derive the e ective pairing interactions along the scheme of the traditional weak coupling theory. The e ective interactions derived here are not suitable for accurate estim ations for the transition tem – perature, but useful for qualitative and sem i-quantitative arguments. For quantitative purpose, direct numerical calculations based on the e ective vertex eqs. (4.12) and J.Phys.Soc.Jpn.

(4.13) is more suitable.

5.1 The case of U = 0

First, we brie y review the standard derivation of the e ective pairing interactions for $U = 0^{1}$. In this case, the total two-particle vertex part $_{1}$ is given by eq. (4.21). In this equation, it is explicitly shown that the phonon-m ediated interaction is attractive for small! overcom ing repulsive C oulom b interactions. This e ect is called the overscreening e ect.




Fig. 8. Schematic gure of the two-particle vertex part (q) as a function of $!=!_{c}$. The solid, dashed, dot-dashed lines show (q) as functions of ! with di erent xed values of q. The thick dotted line shows a step function which is introduced to approximate (q) in eq. (5.1).

In the weak coupling theory, the frequency dependence of the two-particle vertex part (q) is simplied by a replacement with a step function as shown in Fig.8, that is,

where !_c and denote e ective constants which express the frequency range and the depth of the attractive part of the interactions. Here, the static approximation for the dielectric function has been introduced.

The elective constants and l_c are complicated quantities that relect the dispersion energy and the density of states of the dressed phonons. However, it is reasonable to consider that the constant l_c is of the order of the D ebye frequency l_D , i.e., the upper limit of the dressed (observed) phonon frequency l_q . A coording to the standard weak coupling theory, we regard those constants as parameters in this paper.

For isotropic superconductors, the prefactor $v_q = (q;0)$ is often replaced by an e ective constant V_0 .W e should note that V_0 is an averaged quantity of v_q and di erent from the on-site C oulomb interaction U derived in x2.^{7,11}

Further, in the weak coupling theory, the cuto $!_c$ in ! integral is taken into account by introducing the same cuto in integral, where denotes the electron energy measured from the Fermi energy. In other words, we replace the cuto function $(!_c j! j)$ with $(!_c j_k j)$ $(!_c j_k \circ j)$.

A fter these simplications, we could solve the gap equation along the scheme of the standard weak coupling theory. The Coulomb repulsion, i.e., the rst term in the braket of eq. (5.1), is taken into account through the elective Coulomb parameter de ned by

A nother di erence between eqs. (5.1) and (5.4) is the renorm alization of the second term of eq. (5.4) due to the on-site C oulom b interaction U. In this term, the prefactor v_q and the constants and l_c are modiled. The constants and l_c are modiled. The constants and l_c are usually treated as parameters in the weak coupling theory, and sometimes determined by experiments. Hence, we do not need to know the di erences from their original values, and them odil cations in and l_c do not need to be considered explicitly. Therefore, the important modil cation is in the prefactor v_q , because it a ects them omentum dependence. From eqs. (3.16) and (3.17), it is written as

C om paring eqs. (5.5) and (5.6), we note that q_s is replaced with a smaller quantity q_s in eq. (5.5). As discussed in x3.2, the screening length $_{scr} = q_T^{-1}_F = [q_s]_{q=0}^{-1}$ is lengthened into $_{scr} = [q_s]_{q=0}^{-1}$ because U > 0. Then, the peak of eq. (5.5) becomes sharper, and the anisotropic components increase.

In sum mary of this part, we nd two e ects of the short-range correlations: (1) The Hubbard term $^{(0)}_{U}$, which includes bare U, is added as pointed out in the previous section x4; (2) The short-range correlations change them om entum dependence of the phonon-m ediated pairing interaction. B oth e ects unfavor isotropic pairing, but favor an isotropic pairing of som e sym m etries.

It is also found that for this mechanism of triplet pairing, the existence of the on-site C oulom b interaction U is essential, but not the s-wave (isotropic) component of v_q , such as V_0 . We note in the second term of eq. (5.4) that the long-range part v_q of the C oulom b interaction and the phonon-mediated pairing interaction v_q (!_c j! j) have the same momentum dependence. Hence, it is not e ective for the change in the dom inancy of the coupling constants. In fact, when we put the dom inant isotropic component V_0 and the subdom inant anisotropic component V_1 , the di erence of the e ective coupling constants which include the negative contributions of the e ective C oulom b param eters is calculated as

Thus, when $V_0 > V_1$, the right-hand-side of eq. (5.7) is positive. Therefore, it is found that the long-range part v_q , which gives rise to the third and fourth terms in the left-hand-side of eq. (5.7), does not change the sign of eq. (5.7). In the rest of this paper, we investigate the change in the dom inancy of the coupling constants due to the C oulom b interaction m ore explicitly.

5.3 Interactions mediated by spin uctuations

In this subsection, we develope a weak coupling theory including interactions mediated by spin uctuations through $_{\rm U}^{(0)}$. In particular, when the spin uctuations are relevant, the vertex part $_{\rm U}^{(0)}$ (q;!) consists of two parts as a function of q and !: (a) A broad peak that re ects the energy scale of the band width W; (b) A sharp peak that re ects the energy scale of the spin uctuations !sf, as discussed in our previous papers.^{17,22} Hence, we write it in the form

where the st and second terms which correspond to (a) and (b) mentioned above, respectively. Obviously, $U_{\rm U}^{(0)}$ includes the on-site C oulomb repulsive interaction. Therefore, we obtain

6. Exam ples of the Application

Purpose of this section is to show examples of the application of the e ective H am iltonian derived in the previous section. For simplicity, we consider spherical symmetric system s. We have already examined a spherical symmetric system in our previous paper,⁷⁾ but the present treatment is based on a more basic model. Consequently, the corrections due to U are taken into account in more detail. The transition temperatures obtained in this section should be taken as crude estimations, because the model is simplified. Nevertheless, the qualitative results obtained here rejust estimation temperatures of the present mechanism.

6.1 Typical parameter values for ordinary metals




Fig. 9. The phase diagram on the plane of the on-site C oulom b energy U and the elective coupling constant g of the phononmediated pairing interaction, in the spherical symmetric system. The parameters are chosen as $q_{TF}^2 = 2k_F^2 = 0.5$ and W $_C = !_C = 100$. The abbreviation SC stands for superconductivity.

Figure 9 shows the phase diagram for the set of param eter values W_C =!_c = 100 and $q_{TF}^2 = 2k_F^2 = 0.5$. The form ar ratio W_C =!_c = 100 is typical of m ost m etallic systems since W_C W and !_c !_D. The latter ratio $q_{TF}^2 = 2k_F^2 = 0.5$ in plies the Thom as Ferm i screening length $_{TF} = 1 = k_F$ a= , which seem s typical of m etals, too. Because at $_C = U_CN(0)$ 1, the magnetic instability $_s$! 1 should occur, the results are plotted only for UN (0) < 1. It is found that the triplet state occurs for large U, which con m s one of our previous results.⁷⁾ It is also found that for large g, the s-wave state is m ore favored than the p-w ave state.




Fig. 11. The transition tem peratures as functions of the e ective constant g of the phonon-m ediated interaction for the narrow band case, in which we set $q_{TF}^2 = 2k_F^2 = 0.5$, W_C =! $_c = 5$.W e have put ! $_c = 300$ K as an example. The solid and dashed lines show the transition tem peratures T_{cp} and T_{cs} of the p-w ave and s-w ave states for UN (0) = 0.5. For each value of gN (0), the higher one of T_{cp} and T_{cs} is the nal result of T_c , i.e., the physical T_c . The this solid and dashed lines show those for UN (0) = 0.7.




Fig. 10. The phase diagram for a narrow band case, in which we set $q_{TF}^2 = 2k_F^2 = 0.5$ and W $_C = !_C = 5$. A long the vertical thin dotted line, the transition temperatures are plotted in Fig. 11.

Therefore, for the present set of parameter values, the resultant dimensionless coupling constant \sim_p for the p-wave state is quite small, where it overcomes the s-wave state. For example, when $_{\rm C}$ = UN (0) = 0.5, the highest transition temperature to the p-wave state occurs near the phase boundary at gN (0) 1.05. However, at $_{\rm C}$ = 0.5 and gN (0) = 1.0, we obtain \sim_0 0.031 and \sim_1 0.037, and such a small value of \sim_1 gives T_{cp} 10¹⁰ K, which is too low to be observed in practice. For gN (0) > 1.05, we obtain larger T_c, but there




Fig. 12. The dimensionless coupling constants \sim as functions of W_C=!_c. The solid and dashed lines denote \sim_p and \sim_s , respectively. The parameter values are taken as (a) gN (0) = 3, UN (0) = 0.5, (b) gN (0) = 3, UN (0) = 0.8, and (c) gN (0) = 2, UN (0) = 0.5.

the s-wave state occurs. This result is consistent with the experim ental fact that spin-triplet superconductivity has not been observed in the ordinary metals.

6.2 Narrow band system s

Next, we exam ine systems in which the ratio W $_{\rm C}$ =! $_{\rm c}$ is not so large. From eq. (5.29), since W $_{\rm C}$ =! $_{\rm c}$

р _F (W $_{\rm F}$)=! $_{\rm D}$, such a situation is realized, for exam ple, in sem i-m etals with extrem ely sm all $_{\rm F}$ and in narrow band system s with extrem ely sm all W . In such system s, since!_c Wor!_c $_{\rm F}$ does not hold, the approximation N () N (0) is not correct quantitatively, but it is not essential for our purpose. The phase diagram for $q^2_{\rm TF\,F}=\!2k_{\rm F}^2$ = 0.5 and W $_{\rm C}=\!!_{\rm C}$ = 5 is presented in Fig.10. Since W $> 2W_{\rm C} = 10!_{\rm c}$ $10!_{\rm D}$, if we put $!_{\rm D} = 300$ K, we obtain W > 0:3 eV. As the ratio W $_{c} = !_{c}$ becomes smaller, since the retardation e ect becom es weaker, swave pairing is suppressed more e ectively by the on-site Coulomb repulsion. As a result, the area for the p-wave state is enlarged in the phase diagram , and ${\rm T}_{\rm cp}$ becomes large enough to be observed in contrast to the result in the previous subsection x6.1.

In Fig. 11, the transition tem peratures for the param – eter values of Fig. 10 are plotted, where we have put $!_{\rm D}$ = 300 K as an example.For UN (0) = 0.5, it is found that the transition tem perature $T_{\rm cp}$ to the triplet state could reach 0.3 K at gN (0) 2.6, while for gN (0) $^{>}$ 2.6, s-w ave superconductivity occurs since $T_{\rm cs}$ > $T_{\rm cp}$. In contrast, for UN (0) = 0.7, since $T_{\rm cp}$ > $T_{\rm cs}$ upto gN (0) 4, because s-w ave pairing is strongly suppressed by the onsite U. Thus, $T_{\rm cp}$ could reach a rather larger value 2 K, where the triplet state occurs.

Figure 12 shows the dimensionless coupling constants as functions of W $_{\rm C}$ =! $_{\rm c}$. It is found that the p-wave state is favored for narrow er band widths W $(2W_{\rm C})_{\rm r}$ because the on-site U suppresses s-wave pairing m ore effectively. The coupling constants $\widetilde{\ }_{p}$ for p-wave pairing depend on W $_{\rm C}$ =! $_{\rm c}$ slightly. If we put ! $_{\rm c}$ $~!_{\rm D}$ = 300 K , we could estimate $T_{\rm cp}$ as $T_{\rm cp}$ = 0.015 K , 0.16 K , and 0.79 K, for $\sim_{p} = 0.1, 0.13$, and 0.165, respectively. Therefore, for $q_{TF}^2 = 2k_F^2 = 0.5$, which gives T_T 1=k > a= 0.3 a, the transition temperature $T_{\rm p}$ can be high enough to be observed in practice, where the s-wave state is suppressed by strong on-site C oulom b repulsion. For this mechanism , the sm allness of the ratio W $_{\rm C}$ =! $_{\rm c}$ is essential.

6.3 System s with weak C oulom b screening

Next, we exam ine system swith weak C oulom b screening. As exam ined in our previous $paper^{11}$ and brie y discussed in x5.5, the screening can be weak, for exam ple in layered system s with su ciently large intervals between the layers, although here we exam ine spherically symmetric system s.




Fig. 13. The phase diagram for a weak screening case, in which we set $q_{\Gamma_F}^2 = 2k_F^2 = 0:1$ and W_C =! $_{c} = 100$. A long the vertical thin dotted line, the transition tem peratures are plotted in Fig.14.

Now, let us exam ine the case with $q_{TF}^2 = 2k_F^2 = 0.1$ and $M_{C} = !_c = p_{\overline{5}=k_F} = 0.7$. For $q_{TF}^2 = 2k_F^2 = 0.1$, we obtain $TF = \overline{5} = k_F > p_{\overline{5}a=} = 0.7$ a. The short-range correlations lengthen the screening length by $P_{\overline{1}+c}$ as shown in eq. (3.18). In Fig.13, the area of the p-wave state ism uch larger than those in Figs. 9 and 10. Thus, we con m that as the screening becomes weaker, the anisotropic pairing interactions increase, as proposed in our previous papers.^{7,11}




Fig. 14. The transition tem peratures as functions of the e ective constant g of the phonon-m ediated interaction for a system with the weak screening, in which we set $q_{\rm T\,F}^2 = 2k_{\rm F}^2 = 0.1$, W $_{\rm C} = !_{\rm C} = 100$. We have put ! $_{\rm C} = 300$ K as an example. The solid and dashed lines show the transition tem peratures $T_{\rm CP}$ and $T_{\rm CS}$ for the p-w ave and s-w ave states.

In Fig. 14, the transition term partures are estimated for the parameter values of Fig. 13. It is found that $T_{\rm cp}$ for the p-wave state could reach 0.3K, which are practically observable.

6.4 Narrow band systems with weak screening

Lastly, we examine systems with weak Coulomb screening and narrow electron bands. We set param - eters as $q_{TF}^2 = 2k_F^2 = 0.1$ and $W_C = !_C = 20$. The formar corresponds to the Thomas-Fermi screening length




Fig. 15. The phase diagram for a system with weak screening and a narrow electron band, in which we set $q_{TF}^2 = 2k_F^2 = 0.1$ and W_C =! _c = 20. A long the vertical thin dotted line, the transition tem peratures are plotted in Fig. 16.

 $_{\rm TF} > 0.7$ a as mentioned in the previous case. The latter corresponds to $W = !_{D}$ $2W_{C} = !_{C} = 40.$ If we 400 K as a typical value, we obtain $put !_{D} = 200$ W = 0:81:6 eV, which is realistic for the organic superconductors and the ruthenate superconductors. In Figs. 15 and 16, the phase diagram on the U-q plane and the transition tem peratures are shown.Com paring Figs. 13 and 15, we con m again that the area of the triplet state is enlarged when the electron band width becom es narrower. In Fig. 16, we nd that the transition tem perature T_{cp} of the triplet state can reach 3 K 62, although for gN(0) > 62, the p-wave at gN (0) state is hidden behind the s-wave state $(T_{cs} > T_{cp}).W$ e shall discuss the application of this result to the real compounds in the last section.

7. Sum m ary and D iscussion

7.1 Summary of the results

Now, we shall sum marize the results. In x2, we have derived an elective H am iltonian which is written in terms of the short-range (on-site) C oulom b interactions U and the long-range C oulom b interactions v_q , from a basic H am iltonian. On the basis of this elective H am iltonian, we have examined the spin and charge uctuations and screened C oulom b interactions (x3.1), considering the two-particle vertex part within an RPA extended to the model including both U and v_q . The elective interactions between electrons are written in the simple forms as shown in eqs. (3.11) and (3.12). We have derived an expression of the dielectric function and the screening length (x3.2). It was found that the screening length is lengthened by the on-site correlations due to U.

In x3.3 and x3.4, we have examined the Coulomb




Fig. 16. The transition tem peratures as functions of the elective coupling constant g of the phonon-m ediated interaction for the system with the weak screening and the narrow electron band, in which we set $q_{T\,F}^2 = 2k_F^2 = 0.1$, W $_C = !_c = 20$. We have put $!_c = 300$ K as an example. The solid and dashed lines show the transition tem peratures T_{cp} and T_{cs} for the p-wave and s-wave states.

screening corrections to the electron-phonon interactions and the phonon G reen's function within the RPA consistent with those for the interactions between electrons. It was found that the sound velocity increases by the weakening of the screening due to the on-site correlations m entioned above.

In x4, we have exam ined superconductivity. W e have derived a general form of the e ective H am iltonian which includes the interactions mediated by the phonons and those mediated by the spin and charge uctuations, where the short and long-range parts of the Coulom b interactions and the screening e ects are taken into account. It was found in eq. (4.15) that the e ective interaction is written in a summation of two terms, that is, $_{\rm U}^{(0)}$ and the renormalized phonon-mediated pairing interaction.Here, we call $U_{\rm U}^{(0)}$ the Hubbard term , because it is nothing but the vertex part in the pure Hubbard model without the long-range Coulomb interaction v_q . In contrast, the latter term has the same form as the phonon-m ediated interaction in the absence of the shortrange C oulom b interaction U, but the prefactor and the phonon energy k_q include the corrections due to U .

In x5, we derived the e ective interactions along the same way as the traditional weak coupling theory of superconductivity. In particular, for the system away from any magnetic instability, we derived the e ective H am iltonian, with which we have exam ined anisotropic superconductivity in x6. The present m odel includes the m odels exam ined so far^{5(7,11)} in appropriate lim its except the corrections due to U.

In x6, we have applied our theory to some ideal sys-

tem s. The results are summarized as follows: (1) The triplet superconductivity occurs in the system with strong on-site correlations and weak electron-phonon coupling; (2) Spin-triplet pairing is favored when the band width is narrow and when Coulomb screening is weak;¹⁰⁾ (3) The transition temperature of p-wave pairing is limited, because s-wave pairing is favored if the electron-phonon coupling is strong. In the most favorable system , the transition tem perature $T_{\rm cp}$ can be only of the order of 1 K as a crude estimation. These results agree with our know ledge as follows: The triplet superconductivity has not been observed in the ordinary m etals, while there are candidates in the heavy ferm ion superconductors, and the layered superconductors with large layer intervals, such as $(TM T SF)_2 X$ and $Sr_2 RuO_4$, but their T_c's are not so high.

7.2 Narrow band width and triplet pairing

As mentioned in the above summary, we have found in Figs. 10 - 12 that p-wave pairing is favored in narrow band systems. This result can be explained as follows. The on-site C oulomb repulsion a ects only s-wave pairing, but it has a limit itself. The e ective C oulomb parameter $_0$ satis es an inequality

where we have used $1 > U_0$ (q;0) > UN (0), which is the necessary condition for the absence of the magnetic long-range order within the RPA. The upper bound max is determ ined only by the ratio W $_{\rm C} = !_{\rm c}$, which is usually of the order of $W = !_D$. Therefore, we obtain m_{ax} 0:18, 0.30, and 0.38, for $W_{\rm C} = !_{\rm C}$ 100, 10, and 5, respectively. The phonon-mediated pairing interaction originally has the anisotropic components, such as p, but they are much sm aller than the isotropic component $_{\rm s}$. For triplet pairing to occur only by phonon-mediated pairing interaction, it is needed that s-wave pairing is suppressed for some reason, and the dom inancy of the coupling constants, $_{\rm s}$ and $_{\rm p}$, changes. From the results shown in Fig. 12, the value m_{ax} $0:18 \text{ for } W_{C} = !_{C}$ 100 is too sm all to change the dom inancy, when $_{\rm T\,F}$ $1=k_{\rm F}$. In contrast, the large value of $m_{ax} = 0.30$ 0:38 for $W_{\rm C} = !_{\rm C} = 10$ 5 can be large enough to suppress the s-wave state.⁴¹⁾

7.3 Application to the heavy ferm ion systems

The value of $T_{\rm c}$ obtained in Fig.11 is consistent with $T_{\rm c}$ 0.5 K in the heavy ferm ion UPt system $,^{29,30)}$ if the set of the parameter values $q_{\rm T\,F}^2=2k_{\rm F}^2=0.5$ and W $_{\rm C}$ =! $_{\rm c}$ = 5 is regarded to be appropriate for this com – pound. In addition, as in UGe2, $^{8,9)}$ if singlet pairing is suppressed by the internal exchange eld due to the co-existing ferror agnetic long-range order, the p-wave transition tem perature $T_{\rm cp}$ can be of the order of 1 $_{\rm C}$ Z K, which is consistent with the experimental value and our

previous result.^{7,42)}

7.4 Conclusion and future study

In conclusion, we have examined a model of the electron-phonon system with both the long-range and short-range C oulom b interactions, which is derived from a more basic model. In particular, we have examined superconductivity, and shown that the phonon-mediated interaction could induce spin-triplet pairing, when the C oulom b screening is relatively weak and the on-site C oulom b interaction is strong. The transition temperature can be high enough to be observed in practice, and similar to the experimental values in the candidates of the spin-triplet superconductors. In the future, more quantitative study on the isotope e ect, in which the correlation e ects and the strong coupling e ects are taken into account, may give a direct evidence of the applicability of this mechanism.

For more precise estimations of T_{cp} in the application to Sr_2RuO_4 compound, we need to take into account the two-dimensionality. We have examined a two-dimensionale ectivemodel in our previous paper,¹¹⁾ and shown that a realistic value of T_{cp} can be reproduced. It is possible to derive the elective H amiltonian from the present H amiltonian with the interaction of eq. (5.4). The derivation will be presented in a separate paper.⁴³⁾

The application to the quasi-one-dimensional (Q 1D) organic superconductor (TM TSF)₂X is another interesting subject to study as discussed in x1. In particular, Suginishi and the present author found by detailed calculations based on the present theory that speci c features of the Q 1D system play an important role in the pairing symmetry. It will also be presented in a separate paper.²⁷⁾
