Interaction ow method for many-ferm ion systems

We propose an interaction ow scheme that sum sup the perturbation expansion of many-particle system s by successively increasing the interaction strength. It combines the unbiasedness of renormalization group methods with the simplicity of straight-forward perturbation theory. Applying the scheme to fermions in one dimension and to the two-dimensional Hubbard model we not that at one-loop level and low temperatures there is ample agreement with previous one-loop renormalization group approaches. We furtherm ore present results for the momentum -dependence of spin, charge and pairing interactions in the two-dimensional Hubbard model.

I. IN TRODUCTION

The competition between di erent Ferm i surface instabilities is a general feature of low-dimensional interacting lattice electron systems. In one spatial dimension a number of analytical and numerical methods are available, whereas in two and higher dimensions perturbative renormalization group methods are offen considered the least biased approach to study such systems at weak coupling and low energy scales. In recent years functional renormalization group methods^{1,2,3,4,5,6,7,8,9,10} have been devised, capable of capturing the interplay of various low energy scattering processes within certain approximations. They provide a basis for a qualitative comparison of the strengths of potential instabilities. For those RG schemes which are derived from an exact ow equation^{2,4,11,12,13}, the strategy is to reduce the degree of approximation step by step in order to achieve quantitatively more accurate results.¹⁴ How ever, the practical experience along these lines show s that each scheme e has pros and cons. While easily applicable, the one-loop momentum shell schemes have di culties describing ferrorm agnetic Stoner instabilities. ¹⁰ Schemes with frequency cuto obscure the analytical structure of correlation functions, and the tem perature—ow scheme¹⁰ needs to be adapted to the speci c type of the interaction. Thus, as long as an all-purpose weapon is not available, it is desirable to have a larger number of distinct approaches to tackle the problem from di erent angles.

Functional RG m ethods are extremely exible concerning the choice of the ow parameter entering the quadratic part of the fermionic action. The cuto RG schemes are constructed by multiplying this quadratic part with a scale-dependent cuto function. The derivative of this function with respect to the scale de nesmomentum or frequency shells, which are integrated out in the course of the ow. The temperature ow RG instead uses the temperature as the ow parameter, and the ow describes the change of the interactions as the temperature is low ered.

In this work we use the interaction strength as the ow parameter. It is instructive to switch on the interaction strength adiabatically and to follow the change in the correlations as the interaction is increased. This de nes an interaction ow (IF). Straight-forward perturbation theory could in principle do this to any order, but casting the idea in the form of the functional RG has the compelling advantage that all one-loop corrections are summed up consistently. Therefore the IF scheme combines the unbiasedness of one-loop RG methods with a straight-forward relation to perturbation theory.

In this paper we apply the F m ethod to ferm ions in one dimension and to the two-dimensional (2D) Hubbard m odel. In the latter numerous instabilities m ay compete, and we can compare the nature of the infrared instabilities suggested by F with results obtained from other RG approaches. Furtherm ore, the 2D Hubbard m odel is of general interest, in particular because of its potential relation to high- T_c and other unconventional superconductors. How ever, we emphasize that the F m ethod is rather general and should be widely applicable to m any kinds of interacting m any-particle system s.

The paper is organized as follows: In Sec. II we present the form alism for the F scheme. In Sec. III we apply it to interacting ferm ions in one spatial dimension. In Sec. IV we describe the implementation in two spatial dimensions for the H ubbard m odel on the square lattice and compare the results to those obtained in other one-loop RG schemes. Further more, we show new results for the detailed wave-vector dependence of spin and charge susceptibilities. In Sec. V we conclude, with remarks on the perspective of the new scheme concerning its applicability in quantum m any-body physics.




FIG.1: The coupling function V (k_1 ; k_2 ; k_3). W avevector k_4 is xed by wavevector conservation on the lattice.

II. THE METHOD

W e start with a grand-canonical H am iltonian of the form

The $c_{k,s}$ -operators annihilate electrons with wavevector \tilde{k} and spin projection $s_z = 1=2$. is the chemical potential, $\tilde{k} = \tilde{k}$ the free dispersion of electrons hopping on a 2D square lattice measured with respect to the free Ferm i surface, and V ($\tilde{k}; \tilde{k}^0; q$) denes the spin-rotationally invariant and wavevector-conserving interaction between electrons. For the Hubbard onsite-repulsion we have V ($\tilde{k}; \tilde{k}^0; q$) = U > 0.

The interaction ow scheme is derived using the functional renorm alization group form alism for one-particle irreducible (1P I) vertex functions.^{4,13} It describes the change of 1P I vertex functions exactly upon variation of a parameter ` in the quadratic part of the action $Q \cdot W$ riting G rassmann elds for the fermions and using a combined index $k = (ik_0; K)$ for M atsubara frequencies k_0 and wave vectors K, with the H am iltonian (1) the full quadratic part of the action reads

In the momentum -shell RG Q, is defined by supplementing Q with a cuto function depending on the running infrared cuto '. The temperature – ow scheme¹⁰ uses the temperature T appearing in front of the frequency sum and in the M atsubara frequencies as ow parameter. The change of all vertex functions with ' is determined by an in nite hierarchy of equations, obtained from the '-dependent Legendre transform

of the generating functional for connected, non-amputated m {point correlation functions W $^{(m)}$,

with S (c;c; ;) being the standard action used to generate correlation functions.

We condense the notation and use a combined index $p = (i!_n; k; s)$, moreover $dp = T P_{n;s} \frac{d^2k}{(2-)^2}$. The in nite hierarchy of equations is truncated in the usual way by setting the six-point function to zero for all '. The equations describing the evolution of the self energy (p) and the coupling function V, $(p_1; p_2; p_3)$ with $p_4 = p_1 + p_2 - p_3$ (from which the fully antisymmetric four-point vertex can be reconstructed⁴, see also Fig. 1) read




FIG.2: The particle-particle and particle-hole diagram s contributing to the one-loop RG equation for the interaction vertex.

In these equations, the product of the two internal lines in the one-loop diagram s is

with the so-called single-scale propagator

The one-loop diagram s corresponding to the term s (7), (8) and (9) are shown in Fig.2.

To obtain the desired interaction ow schemewe rst multiply Q with a scale factor 1=g and split it in two, yielding

g will be the ow parameter. We can absorb the factor 1=g in rescaled elds c; c de ned as $c = g^{1=2} c$. As a consequence the quartic interaction term

picks up an extra factor g^2 when written in terms of the new elds:

H igher order interactions V ^(2m) are rescaled according to $V_g^{(2m)} = g^m V^{(2m)}$, meaning that changing the scale factor 1=g in Q_g corresponds to changing the strength of the bare interactions. The rescaled ferm ions c, c describe a system with a bare interaction strength $g^2 V$. In particular, we can start at an in nitely small g, i.e. at in nitely small bare interaction, and use the RG form alism to integrate up to the desired bare interaction strength, reached at g = 1. We can also stop the two at any other value of g, with the functions g and g^2V_g (k;k⁰;k + q) being the self energy and interacting vertex function for the bare interaction g^2V (k;k⁰;k + q). M ost in portantly for practical purposes, the truncation of the RG hierarchy and the subsequent neglect of self energy feedback (see below) does not change this property.

We call this the interaction ow (IF) scheme. Compared to straight-forward perturbation theory, the advantage of the functional RG machinery in the one-bop approximation is that it intrinsically sum s up all one-bop diagram s contributing in perturbation theory. Therefore, allkinds of ladder and bubble sum mations, as well as the corresponding vertex corrections are included.




FIG. 3: Depiction of the di erent functional approaches in the parameter space spanned by interaction strength g, tem perature T and infrared cuto . The surface represents the critical manifold below which the perturbation theory diverges.

We note that, opposed to the cuto or T - ow RG schemes, singularities on the right hand side of the ow equation are not regularized by the ow parameter. For example, the particle-particle bubble appearing in the perturbation expansion will typically diverge logarithm ically when T ! 0. Thus, the IF scheme has to be performed at nite temperature when the individual one-loop diagrams are bounded. The strength of the interaction is increased continuously, and in the course of the interaction ow potential singularities are approached from below. Fig. 3 illustrates how the various methods detect perturbative singularities from different directions in parameter space. We further remark that the IF scheme does not correspond to viewing a system on different length scales. This im plies that, unlike in the cuto RG approach, phase transitions cannot be directly related to xed points of the ow, where the action becomes invariant upon rescaling of elds and spatial coordinates.

P ropagators: The one-loop diagram s consist of a single-scale propagator S_g (p) and full two-point G reen's functions $W_g^{(2)}$ (p). When we neglect self energy corrections they are given by

We have arrived at a compellingly simple prescription for the one-loop ow: we can compute the diagram s just as in perturbation theory and only need to multiply them with a scale factor g^{m-1} . This shows a striking advantage of the IF scheme concerning the computational e ort if self energy corrections are neglected: the one-loop corrections only depend on the ow parameter through a simple multiplicative factor g^{m-1} , and therefore the corresponding diagram s have to be calculated only once in the beginning of the ow. This is in contrast to the cuto or T - ow schemes, where, due to the absence of scale-invariance, the one-loop term s have to be recalculated in every RG step.

We note another crucial di erence between the IF scheme and the cuto or T - ow RG: in the latter the single-scale propagator receives its dominant contributions from a limited shell in the Brillouin zone, either de ned by the scale-derivative of the cuto function, or by the T-derivative of the Ferm i function. In the course of the ow this shell contracts around the Ferm i surface, such that at low scales or tem peratures only quasiparticles near the Ferm i surface can contribute. For weakly coupled or Ferm i liquid-like systems, these are expected to be su ciently well de ned. Hence, neglecting self energy e ects such as nite lifetime can be a good approximation.¹⁵ In the IF scheme, how ever, S_g (p) is only weakly con ned to a shell around the Ferm i surface by the band energy in the denom inator. This may lead to an overestim ate of the in uence of Brillouin zone regions away from the Ferm i surface and should

be corrected in future improvements of the method by inclusion of lifetime e ects.

Simple example: To see how infrared singularities are treated in the IF scheme, consider a simple C ooper instability for a local attraction $V_0 < 0$ between electrons. This coupling constant will be subject to one-loop corrections when the scale factor g is increased, starting from an in nitely small initial value. We restrict the ow to the particle particle channel for electrons with incoming momenta k and k. In this case the diagram corresponding to T_{PP} ; $(k; k; k^0; k^0)$ leads to a ow of the scattering vertex $V_g(k; k; k^0) = V_g^P$ given by

where $p_{P}(0) = \int_{\frac{1}{2}}^{1} dp \frac{1}{\frac{1}{2} + \frac{1}{2}}$ is the particle particle bubble for zero total momentum and frequency. This equation can be integrated from 0 to g, yielding

The Cooper instability occurs for $g^2V_0 = 1 = PP(0)$, corresponding to the usual criterion at g = 1. This illustrates how the instability is approached by increasing the bare coupling g^2V_0 . The critical bare coupling depends on temperature through the temperature dependence of the one-loop diagram s, which in the Cooper case is PP(0). Since PP(0) diverges logarithm ically for T ! 0, the critical coupling becomes in nitely small for T ! 0.

All other typical infrared instabilities due to sum mations of bubble or ladders are contained in the F scheme in a similar way. In particular, particle-hole instabilities at small wave vectors q, such as ferrom agnetism or Pomeranchuk Ferm i surface deform ations⁸, are treated on equal footing with C ooper and large-q instabilities. Thus, the F scheme com bines advantages of the tem perature- ow RG with a very lucid form alism closely related to standard perturbation theory.

E ective coupling constants in charge, spin and pairing channels: It is useful to de ne certain classes of coupling functions, which drive certain susceptibilities through one-loop corrections. If any of these classes diverges, it signals a potential instability in the corresponding channel. We de ne e ective couplings

in the pairing channel. The ow of these quantities can be analyzed, and their wavevector dependence contains information on the dominant tendencies of the system. For example, a $d_{x^2 \ y^2}$ -wave Cooper instability leads to a $d_{x^2 \ y^2}$ dependence of V_{SC} (K;K⁰;q=0) on K and K⁰, not necessarily of a separable form.

We have dropped the frequency by writing \tilde{k} instead of k, in anticipation of the following applications in which we neglect the frequency dependence of the interaction vertex.

C oupling to external perturbations, susceptibilities: W e introduce ferm ionic coupling terms to order parameters or static external elds corresponding to di erent symmetry breaking channels. Together with the ow of the interaction vertex we compute the one-loop renormalizations of these coupling terms and thereby obtain information on the growth of the corresponding uctuations during the ow. For details about this procedure see e.g. Ref. 16. A divergence of one of these external couplings signals a crossover to a region with a strong tendency to ordering. This could become an actual nite temperature phase transition if allowed, e.g. when coupling in a third spatial direction is added.

The d-wave pairing eld $\sim_{\rm d sc}$ (k), couples to the rescaled ferm ions at interaction strength g² and wavevector k via

with a coupling constant $h_{d sc}(k)$. The initial condition is taken to be a $d_{x^2 y^2}$ form factor $h_{d sc}(k) = (\cos k_x - \cos k_y) = 2$. As for the other coupling constants de ned below, the k-dependence of $h_{d sc}(k)$ will evolve through corrections of the Cooper coupling $V_{sc}(k;k^0;q=0)$ in the course of the ow, and higher harm onics of the same representation of the point group as well as a dependence on the distance to the Ferm i surface will be generated. Notice that we already wrote $\sim_{s;d sc}$, related to the source in the IF action via $\sim_{d sc} = g_{d sc}$. The susceptibility $\sim_{d sc}$ in this channel at interaction strength g^2 is obtained from the susceptibility d sc computed in the IF form alism as $\sim_{d sc} = d_{sc} = g^2$. One can check this relation by considering the non-interacting case, where g m erely rescales the free ferm ionic G reen's function.

We also de ne spin-density and charge-density wave elds \approx_{s}^{1} (k;q) and \approx_{c}^{1} (k;q) with point group symmetry 1. They are renormalized by one-loop corrections involving the spin and charge couplings V_s (k;k⁰;q) and V_c (k;k⁰;q), respectively. Due to spin rotation invariance it is su cient to consider spin elds in the spin quantization direction, coupling via

where in the s-wave channel the initial condition is taken to be $h_s^s(k;q) = 1$.

In the 2D H ubbard m odel the m om entum transfer q = Q = (;) between created and annihilated particles plays an important role. It corresponds to an alternating eld acting on electron spins on n.n. sites, and if the corresponding coupling $h_s^s(K;Q)$ becomes large, this signals a strong tendency towards antiferrom agnetic (AF) spin-density wave (SDW) order. We also consider couplings in the d-wave channels, in order to look for e.g. d-density wave uctuations, coupling to particle-hole pairs in the charge channel with momentum transfer Q:

with initial condition chosen as $h_c^d(k) = (\cos k_x - \cos k_y) = 2$. In addition to the (;) channels, the q = 0-channels will also be analyzed. The isotropic s-wave part contains inform ation about the compressibility of the Ferm i surface, while higher s-wave, d- and p-wave parts are important when estimating tendencies towards Ferm i surface deform ation.⁸

III. INTERACTING FERM IONS IN ONE DIMENSION

Here we brie y describe how the F scheme reproduces some well-known perturbative results for electrons in one spatial dimension. Consider the g-ology model with spin-independent interactions where left- and right-moving electrons around two Ferm i points k_F are scattered by coupling constants $g_1 = V(k_F;s; k_F;s^0! k_F;s;k_F;s^0)$, $g_2 = V(k_F;s; k_F;s^0! k_F;s;k_F;s^0)$ and $g_4 = V(k_F;s;k_F;s^0! k_F;s;k_F;s^0)$. For densities su ciently away from half lling Um klapp processes $g_3 = V(k_F;s;k_F;s^0! k_F;s;k_F;s^0)$ can be neglected. One-loop corrections in the particle-hole channel with wavevector transfer $2k_F$ and in the zero-total-m omentum particle-particle channel diverge at low tem peratures like log (M =T), where W denotes the band width. Focusing on these contributions, and writing s instead of the scale param eterg in order to avoid a g-m ess, the one-loop IF equations read (using N₀ = 1=(v_F) for the density of states)

 g_4 is not renorm alized by logarithm ic corrections. When we now integrate form zero to the desired bare interaction strength reached at s = 1, eq. 26 immediately yields (with the bare coupling $g_1 = g_{1;s=0}$)

This means that at low T $\,$ W $\,$ a repulsive g_1 is renorm alized away by one-loop contributions. The low-tem perature physics is thus determ ined by the remaining coupling constant g_2 which approaches a constant g_2 for T $\,!\,$ 0. The coupling to external spin- and charge density perturbations with wavevector $2k_F$, h_{SDW} and h_{CDW} , are given by the one-loop corrections

Here we inserted the low temperature xed-point values for the coupling constants $g_{1,s}$ and $g_{2,s}$. This is justified for low T, since then g_1 and g_2 are approached rapidly for smalls. For repulsive $g_1 > 0$ and $g_2 > 0$, the SDW coupling grows most strongly when the bare interaction strengths is increased. Integrating Eq. 29 from s = 0 to s = 1, we nd the T ! 0 power laws for the SDW -coupling and the corresponding susceptibility:

These powerlaws are in agreement with results obtained via bosonization¹⁷ by expanding the Luttinger liquid param – eter K up to rst order in the xed point coupling g_2 . Likewise, the leading susceptibilities in the g_1 - g_2 plane are reproduced correctly by the F scheme.

In repulsive Luttinger liquids the presence of a single in purity leads to universal power-law s and scaling functions in the low energy limit. U sing a M atsubara frequency cuto as ow parameter for a spinless ferm ion model with nearest neighbor interaction and a single static in purity, the computation of spectral properties of single-particle excitations and oscillations in the density prole induced by the in purity or a boundary was shown to provide remarkably accurate results even for moderate coupling strengths in comparison with exact asymptotic and num erical results.¹⁴ It turns out that within the IF approach these elects of a single static in purity in a Luttinger liquid are well captured and the respective predictions are commended on mediatively. A more detailed comparison is under way.

IV. APPLICATION TO THE TW O-D IM ENSIONAL HUBBARD MODEL




FIG. 4: Left: N -patch discretization for the cuto and T-ow RG schemes. Right plot: Box discretization used for IF. The open circles denote the N² points for which the coupling function is calculated. The shading indicates the band energy.

Here we apply the IF scheme to the two-dimensionalt-t⁰ Hubbard model on a square lattice and compare the results with those obtained in other RG schemes. The latter have been widely used to identify the leading low-temperature instabilities of the Hubbard model. Practically all numerical 2D implementations^{3,6,8,9,10,16} use a patch discretization introduced in this context by Zanchi and Schulz.³ The coupling function is calculated for two incoming and one outgoing wave vector near or on the Ferm i surface, and is taken to be constant within elongated patches that extend roughly perpendicular to the Ferm i surface (see Fig. 4). This approximation is believed to be good, since the leading

ow is typically given by the coupling functions connecting particles near the Ferm i surface, and because during the ow at least one of the internal lines in the one-loop diagram s is restricted to an increasingly narrow neighborhood of the Ferm i surface. A sm entioned in the previous section, the second "contraction" feature is absent in the IF, since no cuto function is used, and no derivatives of the Ferm i function occur in the one-loop diagram s. Therefore the full BZ contributes to the ow at all values of the ow parameter g, and if the couplings near the FS become a large it m ay not be a good approximation to also use them for BZ regions far away from the FS.W e are thus forced to use a di erent discretization of the BZ. This actually reduces the degree of approximation caused by the usual projection on the Ferm i surface.

We divide the BZ into N² squares and calculate the ow for wave vectors in the centers of the boxes, keeping the couplings constant within each box. With this prescription we can numerically treat up to N² = 18^2 = 324 boxes. Note that this discretization does not correspond to a nite-size system. The internal states in the one-loop diagram s are still taken as those of an in nite lattice and can lie arbitrarily close to the Ferm i level.

We focus on band llings close to van H ove lling and vary the nearest neighbor hopping t⁰. In the tem perature- ow RG the picture is the follow ing^{10} : For small t⁰ and near half lling the Ferm i surface is well nested, and the ow to strong coupling at low tem peratures is mainly of spin-density wave character. For larger j⁰ j and the FS xed at the saddle points, d-wave pairing tendencies become e stronger, while SDW tendencies are suppressed. For t⁰ < 0.2t d-wave pairing dom inates over SDW. For t⁰ ! t=3 the critical tem perature scale for the ow to strong coupling is dom inated by ferrom agnetic tendencies. The tem perature- ow RG thus suggests a quantum critical point at t⁰ t=3 between a d-wave paired and a ferrom agnetic ground state.




FIG. 5: Left: F low of the most attractive and most repulsive coupling constant as a function of the bare interaction strength $g^2 = U$ for the perfectly nested case $t^0 = 0$, = 0. Right: G row th of the coupling to static spin perturbations at q = (;) (spin-density wave channel). The two other degenerate lines that rise much slow er denote the elective couplings in the d-density wave (dD W) and d-wave pairing (dSC) channel.




FIG. 6: Data for half lling and $t^0 = 0$, T = 0.001t at the critical bare interaction strength U = 0.57t where the couplings diverge. Left: q-dependence of the interacting spin susceptibility. The peak is at q = (;). Right: q-dependence of the interacting charge susceptibility. Note the di erence in the scale.

At low tem peratures, the IF results show (roughly) the same regimes when t^0j is increased, and the FS is xed at the van H ove points. The results for $t^0 = 0$ are shown in Figs. 5 and 6. When the interaction strength is increased for xed tem perature, we ind a critical value $g_c^2(T) = U_c(T)$ at which the maximal coupling function diverges. This value corresponds to the critical interaction strength needed to destroy the weakly coupled state. For the perfectly nested case, i.e. $t^0 = 0$ and = 0, the SDW coupling grows strongest when the bare interaction approaches $U_c(T)$.




FIG.7: C om parison of the characteristic tem peratures for the SDW instability at $t^0 = 0$, = 0 for several perturbative RG-like schemes. The right plot shows the same data with di erent x-axis. Squares: RPA (360 360 lattice in the BZ), circles: T - ow (48 patches around the FS), triangles: momentum -shell-RG (1PI-scheme, 48 patches around the FS), crosses: IF for 144 patches in the BZ.

In Fig. 7 we compare the characteristic temperature for the spin-density wave instability as a function of the bare interaction U for several RG-like schemes with RPA values. In all cases $T_c(U)$ is a monotonically increasing function of U, due to its mean-eld character. The T- ow RG scheme yields the smallest values for $T_c(U)$, RPA the highest. The momentum-shell 1PI scheme lies slightly below the RPA values, and the IF data are roughly in the middle between RPA and T- ow.




FIG.8: Results for the d-wave Cooper instability at $= 1:1t, t^0 = 0:3t$ and T = 0:001t. Left: Flow of e ective coupling in d-wave pairing (solid line) and AF SDW channel (dashed line) for a 18–18 discretization. Right: Ratio of these two e ective coupling constants for dierent discretizations: solid line 18–18, dashed-dotted line 16–16, dashed line 14–14, dotted line 12–12.




FIG.9: The same for van Hove lling at = 12t, $t^0 = 0.3t$ and T = 0.001t. The (;) spin channelmay win for large patch numbers.

W hen we move away from perfect nesting by introducing a next-nearest neighbor hopping am plitude $t^0 < 0$, and change the band lling at low temperature T = 0.001t, there is an increasing tendency towards $d_{x^2 y^2}$ -wave superconducting pairing. For $t^0 = 0.3t$ this is shown in Figs. 8 and 9. In Fig. 8 the band lling is slightly above van H ove lling, and di erent discretizations show consistently that the elective coupling in the d-wave pairing channel grows m ore strongly than the leading magnetic component at wave vector Q = (;). Fig. 9 shows analogous data at the saddle point lling. With increasing patch number the leading divergence in the SDW channel seems to win over the pairing instability.




FIG.10: IF data for T = 0.001t and = 0.8t, $t^0 = 0.25t$ (mi = 0.9). Upper left plot: Flow of the average coupling to external $d_{x^2 \ y^2}$ -pairing elds, $h_{d \ sc}$ (solid line), and SDW elds, h_s^s (q = (;)) (dashed line), corresponding to the dom inant tendencies in this case. Upper right: d-wave coupling $h_{d \ sc}$ (k;q = 0) (solid lines with crosses) for $k = (k_x; 0)$ and $k = (k_x;)$ at the critical interaction strength. SDW coupling h_s^s (k;q = (;)) (dashed lines) for $k = (k_x; 0)$ and $k = (k_x;)$. Lower left/right: d-wave and SDW couplings for k varying through the full B rillouin zone. The scalebar depicts the strength of the coupling.

As already mentioned, ignoring lifetime e ects possibly makes us overestimate the in uence of excitations away from the Fermi surface. In Fig. 10 we see that the coupling function in the particle-hole channel at wavevector

transfer q (;), i.e. the SDW channel, is strongly enhanced in all BZ regions, and is largest at the top and bottom of the band. It is likely that in these regions with large band energy the lifetimes of quasiparticles will be short, and the ow without self energy corrections may overestimate the SDW tendencies. In contrast to this, the pairing interactions become large only in the vicinity of the Ferm i surface. Only a part of this K-dependence is due to the d-wave form factor. Due to the discretization scheme we might actually underestimate the growth of the pairing correlations, since the coupling function cannot be calculated arbitrarily close to the Ferm i surface using only 18 x 18 boxes. Hence, we cannot draw de nite conclusions about the leading divergence directly at van Hove lling. Slightly away from van Hove lling d-wave tendencies grow more rapidly than SDW tendencies. This trend is consistently reproduced for all discretizations we used. Keeping in mind that we presum ably overestim ate the SDW channel and underestimate the pairing tendencies, we nd that the dom inance of d-wave pairing over SDW (as shown in Figs. 8 and 10) is likely to be more robust than suggested by the ow without selfenergy corrections.




FIG.11: Cuto RG data, again for T = 0.001t and = 0.8t, $t^0 = 0.25t$, U = 2.5t. Upper left plot: Flow vs. infrared cuto of the average coupling to external $d_{x^2 y^2}$ -pairing elds, $h_{d sc}$ (solid line), and SDW elds, h_s^s (q = (;)) (dashed line), corresponding to the dom inant tendencies in this case. Upper right: d-wave coupling $h_{d sc}$ (k;q = 0) (solid lines with crosses) for $k = (k_x; 0)$ and $k = (k_x;)$ at the critical interaction strength . SDW coupling h_s^s (k;q = (;))) (dashed lines) for $k = (k_x; 0)$ and $k = (k_x;)$. Lower left/right: d-wave and SDW couplings for k varying through the full B rillouin zone. The scalebar depicts the strength of the coupling.

In Fig. 11 we show data obtained within the cuto RG for the one-particle irreducible vertex functions from Ref. 16, using the same discretization scheme as in the IF algorithm. There is good agreement with the IF data in Fig. 10. We notice, however, that the SDW channel is a little weaker, and the elective couplings to external SDW elds are now peaked (albeit very mildly) around the FS. Again, this di erence occurs because in the cuto scheme the modes contributing to the low are restricted to narrow shells around the Ferm i surface, meaning that at small scales only those couplings involving modes near the Ferm i surface grow most strongly.

Very close to van Hove lling the overallbehavior of the F ow resembles the so-called saddle point regime of Refs. 16 and 18. The dom inant scattering processes near the Ferm i surface are those connecting the saddle points, and SDW and d-wave pairing susceptibilities both become large. Furtherm ore, the charge compressibility is suppressed,




FIG.12: IF D ata for T = 0.001t and van H ove lling $= t, t^0 = 0.25t$. The left plot shows the coupling to external long-wavelength charge perturbations h_c (k;q! 0) for k varying through a quarter of the B rillouin zone. The tick lines in the right plot shows the ow of h_c (k;q! 0) at two points k. The solid line is for a point close to a saddle point k (;0) and the dashed line for k (1:3;1:3) in the BZ diagonal. The thin lines show analogous data for q = (;).

predom inantly in the Brillouin zone regions around (;0) and (0;), similar as in Ref. 16. This can be seen from the ow of the K-dependent couplings to external static charge perturbations at long wave lengths, h_c (K;q! 0) (see Fig. 12). A similar picture is found at half lling. Although at weak coupling these tendencies are rather sm all, they connect qualitatively well with much stronger e ects found by 0 tsuka et al.¹⁹ in Quantum M onte Carlo simulations for U = 4t and T = 0.2t.

U pon increasing the tem perature in this d-wave regime, the instability is pushed to larger bare interactions. For $t^0 = 0.25t$ and hni = 0.9 the d-wave instability occurs for tem peratures below T = 0.0035t at U = 2.75t. This is in reasonable agreement with tem perature- ow RG results (with a completely di erent discretization of the B rillouin zone), where the ow diverges at this tem perature for U = 2.6t. For higher tem peratures, the leading divergence appears to occur in the SDW channel at wave vector (;) again, and the interaction needed for the instability barely increases with rising T. This indicates that spin uctuations live on a larger energy scale than pairing tendencies. A similar change in the character of the ow to strong coupling with increasing tem perature has been observed in cuto RG schemes.¹⁶ A conservative interpretation suggests the presence of strong spin uctuations in the norm al state above the superconducting ground state (when 3D coupling is present such that long range order is possible). An im proved treatment including lifetime e ects will give further insights concerning the strength of these e ects. A general trend within the present approximations is that in the IF scheme the SDW tendencies seem stronger than in other RG approaches.

When $j^0 j$ is increased further, the critical interaction strength for the ow to strong coupling increases, and for xed U 3t the couplings remain bounded down to very low temperatures. For t^0 0.36t we nd that the main instability is in the ferrom agnetic channel. The change in the dom inant spin correlations can also be seen in Fig. 14, where we plot the spin susceptibility for di erent t^0 at van Hove lling along a trajectory in q-space. The results

agree qualitatively well with those of the tem perature - ow scheme, which nds the onset of the ferrom agnetic regime at t^0 0.33t for U = 3t.

V. CONCLUSIONS AND OUTLOOK

We have presented a perturbative method to study interacting fermionic systems, the so-called interaction ow (IF) scheme. Based on the functional renormalization group formalism^{2,4} it sums up all one-loop corrections in an unbiased manner using the bare interaction strength as a continuous ow parameter. We have applied the IF scheme to one-dimensional fermions and the two-dimensional Hubbard model and compared the results with those obtained by cuto RG and temperature-ow schemes. There is ample qualitative and in some cases reasonable quantitative agreement, even when very dimensional Brillouin zone discretizations are compared.

In agreement with other RG approaches the IF scheme yields an extended region in parameter space of the 2D t-t⁰ Hubbard model where d-wave superconductivity is the dominant low-temperature instability, though it is less prominent, and the tendencies towards SDW ordering appear to be somewhat stronger. This holds in particular for van Hove lling and t⁰ < 0.2t, where, opposed to temperature and cuto ow approaches, the IF scheme does not nd a d-wave dominated instability. We believe that this difference is due to the fact that in the IF scheme all parts of the BZ contribute to the ow to strong coupling. Neglecting self energy corrections may therefore lead to an overestim ate of the SDW channel, whose couplings grow over the whole B rillouin zone. In contrast to this, interactions driving d-wave superconductivity become large only in the vicinity of the Ferm i surface. This problem does not occur in cuto RG or temperature- ow schemes. In these approaches only modes in a contracting shell around the Ferm i




FIG.13: Sum mary of the ow at van Hove lling as a function of t^0 for T = 0.001t and a 12 12 discretization. U_c denotes the critical value of bare interaction strength U at which some components of the coupling function exceed the perturbative range when U is increased from below. With increasing t^0 ; for $t^0 < 0.2t$ the instability is of AF-SDW type, then it becomes a d-wave like C coper instability. Note that for larger system sizes the boundaries of the SDW -d-wave crossover shifts (see discussion in the text). For $t^0 > 0.36t$ the dominant instability is ferrom agnetic.




FIG.14: Interacting spin susceptibility $_{s}$ (q) at van H ove lling and T = 0.001t for di erent t⁰ and for the critical interaction strength where the couplings diverge, using a 12 12 discretization. For t⁰ > 0.35t, $_{s}$ (q) is peaked at q = (;) = M and for t⁰ 0.35t it is peaked at q = (0;0) = 0.

surface contribute in the nal stage of the ow. This way, the IF scheme sheds some light on the inner workings of the previous RG approaches. The inclusion of lifetime e ects in the IF scheme will clarify these issues further.

Furtherm ore, for large absolute values of the nearest neighbor hopping t^0 the leading instability is in the ferrom agnetic channel. This con m s results obtained within the tem perature ow RG and other perturbative approaches.²⁰

As new results we have presented detailed wave vector dependences of interactions and susceptibilities over the whole Brillouin zone.

We emphasize that we consider the interaction ow approach an additional tool for the analysis of interacting many-ferm ion systems. Its concept is as simple as perturbation theory, yet it captures many of the non-trivial e ects crucial for the understanding of interacting electron systems. Most importantly the IF scheme includes the coupling between the various one-loop channels. This provides an alternative practicable method to detect and gauge infrared instabilities of ferm ions in low dimensions. Having several viable techniques at hand may prove useful, as the character of di erent approximations can be analyzed more clearly. "True" renorm alization group methods like cuto RG schemes appear to have a broader range of applicability, and seem to be the wider concept. For example, RG

m ethods establish a relationship between systems on dierent length or energy scales in a quite general way, while the IF ow is by construction restricted to a perturbative regime.

Regarding future applications and extensions of the F scheme we note the possibility of comparing the results with Quantum M onte C arb (QMC) data in the 2D Hubbard m odel and on ladder systems. Bulut²¹ gives detailed results for the irreducible vertex function at U = 4t in the two-leg ladder and the 2D Hubbard m odel, including wave vector dependence. W ith the current F scheme we can easily achieve a comparable K-space resolution. Hence, it will be interesting to see how the perturbative m ethod compares with QMC. This can give new insights on how the QMC data extrapolate to lower temperatures, that cannot be reached by QMC due to the sign problem. Moreover, we believe that the inclusion of Ferm i surface renorm alizations and distortions, as well as lifetime e ects are better tractable in the F scheme, since complications due to a owing cuto do not occur. The example of an impurity in a Luttinger liquid described brie y at the end of Sec. III shows that the inclusion of selfenergy e ects in the F scheme e can lead to excellent results.

All in all, we hope that the F scheme will open new possibilities in the understanding of interacting many-body systems.
