Evidence for multiband superconductivity in the heavy ferm ion compound UN 12A 13

Epitaxial thin $\,$ Im s of the heavy ferm ion superconductor UN $i_2A\,l_3$ with $\,T_c^{\,m\,\,ax}\,=\,0.98K$ were investigated. The transition temperature T_c depends on the current direction which can be related to superconducting gaps opening at dierent temperatures. Also the in wence of the magnetic ordering at T_N '5K on R(T) is strongly anisotropic indicating dierent coupling between the magnetic moments and itinerant charge carriers on the multi-sheeted Ferm i surface . The upper critical eld H $_{c2}$ (T) suggests an unconventional spin-singlet superconducting state.




FIG. 1: X-ray =2 -scan of an UNi $_2$ A $_3$ thin $_2$ m on an YA $_3$ (010) substrate. Please note the alignment of the reciprocal (100)-axis of the hexagonal crystal perpendicular to the substrate surface. (UNi $_2$ A $_3$ rejections are labeled (H00), substrate S, in purities * (presum ably UO $_x$)). The inset shows a scan of the reciprocal (1KL)-plane of UNi $_2$ A $_3$. The x-ray intensity (linear grey scale) is plotted versus the momentum transfer in units of the reciprocal lattice vectors. From the observation of rejections at integer K and L values the in-plane order of the $_2$ m is obvious. The narrow rejections close to (1 1/2 -1) and (1 1/2 0) are substrate rejections.

Recently a clear progress concerning the superconductivity of the heavy ferm ion compound UPd2Al3 was reported. Due to combined experimental investigations based on tunneling spectroscopy on planarthin Im junctions [1] and inelastic neutron scattering [2, 3, 4] an unconventionalm echanism of superconductivity was identied. There is compelling evidence that the Cooper pair form ation in this compound is caused by the exchange of magnetic excitations. However, the question if these excitation are spin uctuations [5] or magnetic excitons [4, 6] is not nally answered. In this fram ework the investigation of the compound UN ½A ½, which is isostructural to UPd_2Ab_1 , is of great interest. Whereas UPd_2Ab_1 shows a simple antiferrom agnetic structure with relatively large ordered m agnetic m om ents of ord '0:85 B the compound UN i2A l3 is an incommensurately ordered antiferrom agnet [7] with smaller ordered moment ord $0.24 \, \text{B}$ [8]. In contrast to UPd₂Ak, for UNi₂Ak there is evidence for a spin-triplet superconducting state [9]. The preparation of the rst single crystalline bulk sam ples of UN 12A 13 [10, 11] was not possible until 5 years after the discovery of superconductivity in this compound [12]. This is due to a peritectical decomposition which result in the formation of an UAL impurity phase [13] and hence a strongly reduced sample purity compared to UPd2Al3. However, since thin lms are not prepared from the melt this typical problem can be avoided. We prepared superconducting single crystalline thin ImsofUNi2Al3 (typical thickness d' 200nm) by coevaporation of the elem entary com ponents in an MBEsystem. Orthorhom bical YA 10_3 cut in (010)-or (112)direction provides an epitaxial substrate for the (100)oriented UNiAk with lattice m is ts for the a-axis of +0.7% for the form er and -0.5% for the latter substrate cut. On these substrates high purity single crystalline thin $lm \ s \ w \ ere \ prepared$. In Fig.1 an x-ray = 2 -scan of an UN i_2Al_3 (100) Im on YA i_03 (010) is shown. Only a very weak UOx but no UA & impurity phase is visible. The inset shows a scan of the crystallographic (1KL)-

plane of UN $\frac{1}{2}$ A $\frac{1}{6}$. The observed x-ray re ections prove that the $\frac{1}{10}$ m is ordered in plane, i.e. single crystalline. From the positions of 14 x-ray re ections of an UN $\frac{1}{2}$ A $\frac{1}{6}$

thin lm the following lattice parameters were calculated: a = 0.5211(5)nm, b = 0.5221(8)nm, c = 0.4017(2)nm. These numbers are in agreement with the values obtained from polycrystalline bulk samples [12] and rule out any growth process induced stress of the lms.




FIG. 2: Speci c resistivity (T) of an UN i_2Al_2 thin lm for di erent current directions (black squares: I k a, grey dots: I k c). Inset: Photograph of a patterned UN i_2Al_2 lm (4 4mm). For R (T)-m easurem ents a current is send through the central conductor path (w idth d= 100 m), the thin strips are voltage probes (4-point dc m ethod).

Patterning the sam ples by a standard photolithographic process with ion beam etching made it possible to obtain well de ned geometries for the investigation of anisotropic transport properties (see inset of Fig.2).

M easurem ents of the temperature dependent resistivity R (T) of the samples were performed with the current direction parallel to the crystallographic a-axis as well as parallel to the c-axis of the same thin lm. A pronounced anisotropy, like reported previously from bulk single crystals [14] is observed (Fig.2). The residual re-

sistivities of the best sam ples are $_{\rm c}$ = 25 cm for I k c and $_{\rm a}$ = 20 cm for I k a. The residual resistance ratios RRR = R_{300K} =R_{1:1K} amount to RRR_{Ikc} = 6:6 and RRR_{Ika} = 8:3. This is approximately half of the RRR reported for bulk single crystals [10, 14] indicating a higher concentration of scattering centers in the thin lm s. However, these scattering centers are less e ective in destroying the superconducting state since the transition temperature T_c and width T_c of the lm s is as high and sharp as in the best bulk single crystals.




FIG. 3: Superconducting resistive transitions of an UN $\frac{1}{2}$ A $\frac{1}{2}$ thin Im for di erent current directions (black symbols: I k a, grey symbols: I k c). M easurem ents with di erent current densities are show to dem onstrate that the probe current does not in uence the T_c values (for j ' 10A /cm 2).

The $\,$ In s become superconducting at $T_c^{m\ ax}=0.98K$ with resistive transition widths $\,T_c\,'\,0.06K$. Large critical current densities of $I_c\,'\,10^4A/cm^2$ at T=0.32K for I k a and I k c show that the observed superconductivity is a property of the complete thin $\,$ In volume. The probe current employed form easurements of $T_c\,$ was adjusted to a current range were no in uence of its magnitude on the resistive transition was observed (Fig.3). All of our superconducting samples on both kinds of substrate show the superconducting transition for current direction I k c at a reduced temperature compared to I k a with $T_c\,$ (I k a) $\,T_c\,$ (I k c) ' $\,0.05K\,$ (Fig.3). The same behavior is visible at a close inspection of the only published R (T)-data of bulk single crystals by Sato et al. [10]. Thus there

is strong evidence that the directional dependence of the resistive T $_{\rm C}$ is an intrinsic property of UN i2A $\rm l_3$.

A possible explanation for this e ect is the existence

of two bands in UN i_2A l_3 with intraband pairing interactions but without superconducting interband interaction. Such a situation can result in two superconducting gaps on the Ferm i surface which open at dierent temperatures [15]. Up to now there is no Ferm isurface calculation of UN i_2A l_3 available but similarities to the Ferm i surface of the isostructural compound UP d_2A l_3 [17, 18] can be assumed based on early band structure calculations [16]. Thus a multi-sheeted Ferm i surface is expected with an increased anisotropy compared to UP d_2A l_3 as concluded from the stronger transport anisotropy of UN i_2A l_3 . On such a Ferm i surface superconducting gaps opening at dierent temperatures on dierent sheets could result in transitions temperatures which depend on the current direction.




FIG.4: Speci cresistivity (T) of an UN i_2A l_3 thin lm. Left axis: I k a (black squares). Right axis: I k c (grey dots).

A coording to ref. [15] a weak coupling between the two bands results in two gaps with a common $T_{\rm c}$. However, in one of the bands an initially tiny energy gap is expected which opens drastically at a reduced temperature compared to $T_{\rm c}$. In a transport experiment such a situation is presumably indistinguishable from the case of two different $T_{\rm c}$ values due to critical current elects hiding the tiny energy gap. However, the simple model of ref. [15] presents only a rst attempt to explain the directional dependence of $T_{\rm c}$ and does not consider the coupling between superconductivity and magnetism as well as Ferm i surface and order parameter anisotropies of UN $i_2A\,i_3$. At the magnetic ordering temperature $T_{\rm N}$ ' 5K a clear anomaly in the resistivity R (T) of the 1 h sis visible for

currents I k a but not for I k c (Fig.4). The in uence of

the m agnetic ordering on the resistivity of UN $^{i}_{2}A$ $^{i}_{3}$ is different from the behavior of UP $^{i}_{2}A$ $^{i}_{3}$ where a clear steepening of R (T) is observed on cooling beyond $^{i}_{3}$ for I k a as well as for I k c [19]. In contrast, in the UN $^{i}_{2}A$ $^{i}_{3}$ lm s we observe a attening of R (T) for I k a at $^{i}_{3}$ which is similar to the behavior of UR $^{i}_{2}S$ $^{i}_{2}$ [20]. This dependence can result from a change in the Fermi surface topology associated with the formation of a magnetization-density wave which opens a gap over a portion of the Fermi surface. Since R (T) of UN $^{i}_{2}A$ $^{i}_{3}$ is not a ected by the magnetic ordering for currents I k c we conclude that only the sheet of the Fermi surface providing the a-axis transport couples to the magnetic order parameter.

The observation that the higher superconducting T_{c} was observed on the Ferm i surface sheet which is more affected by the magnetic ordering provides evidence that the Cooper-pairing in UN $i_2A\ l_3$ is mediated by magnetic excitations. However, due to the dierent in uence of the magnetic ordering on the transport properties it is possible that the character of these excitations is dierent from the one discussed for UP $d_2A\ l_3$.




FIG.5: Resistive superconducting transitions of an UN $\frac{1}{2}A$ $\frac{1}{8}$ thin lm in magnetic elds $_0H$ from OT to 1.2T. Probe current I k a and elds H k c.




FIG. 6: Upper critical elds $_0H$ (T) of an UN $_2A$ $_3$ thin lm with di erent orientations relative to the eld direction (see inset). Current I k a-axis.

To investigate the superconducting order param eter concerning a possible spin triplet state the upper critical eld H $_{\rm C2}$ (T) of the UN i_2 A l_3 thin $\,$ Im s was determined by measuring resistive transitions R (T) in dierent magnetic elds using a midpoint criterion. Fig.5 shows the R (T) curves obtained for probe currents I k a and eld orientation H k c as an example. Please note that the width and shape of the transitions depend only weakly on the eld H as opposed to the behavior reported from bulk single crystals [10]. The upper critical eld was determined for eld directions parallel to the real space and c-axis as well as parallel to the reciprocala -axis of the hexagonal compound (Fig.6). The measured H $_{\rm C2}$ (T) curves are almost independent of the current direction.

Only a small shift to lower temperatures of the data obtained with I k c compared to I k a was observed as expected considering the reduced $T_{\rm c}$ in this direction. For

H ka the Implanewasperpendicular to the eld direction, whereas for H kc the thin Imshad to be mounted with the Imsurface parallel to the eld direction. In principle the parallel conguration allows the appearance of increased critical elds due to nite size e ects (thin Imand surface superconductivity) [21]. However, these

phenom ena should result in a pronounced angular dependence of H $_{\rm c}$ () which was not observed. For additional investigation of these possible e ects the $\,$ lm was rotated by 90° on the sam ple platform resulting in a con guration with H k a parallel to the $\,$ lm surface. Due to the hexagonal symmetry of UN $_{\rm b}$ A $_{\rm b}$ only a very weak anisotropy of the critical eld is expected within the ab-plane. Thus the observation of very similar H $_{\rm c2}$ (T)-curves for H k a parallel to the $\,$ lm surface and for H k a perpendicular to the $\,$ lm surface shows that nite size e ects do not in uence the critical eld.

For all investigated m agnetic eld directions a steep slope $_0H^{~0}_{\rm c2}(T_{\rm c})>5{\rm T/K}$ was observed in contrast to the much smaller slopes reported previously from investigations of bulk polycrystals [22] and single crystals [10]. A dditionally, the critical elds of the thin lms are much larger and less anisotropic than reported for the only available bulk single crystals [10]. Employing the conventional W HHM—theory [23] of the upper critical eld the authors concluded that orbital pair breaking limits H $_{\rm c2}$ of UN i_2 A i_3 . W ith the same approach [24] we obtain from

$$H_{c2}^{orb} = 0.693 ((dH_{c2} = dT)_{T_c})T_c$$

an orbital upper critical eld of $_{0}H_{c2}^{orb} > 3.5T$. However,

from our H $_{\rm c2}$ (T) curves we estimate $_{\rm 0}$ H $_{\rm c2}$ (0K) ' 1:6T only. This discrepancy provides evidence for a non-negligible paramagnetic pair breaking contribution and thus a spin singlet superconducting order parameter of UN $_{\rm 2}$ A $_{\rm 3}$ as opposed to the experimental evidence for spin triplet superconductivity of ref. [9].

A dditional conclusions concerning the order parameter symmetry can not be drawn from the B $_{\rm c2}$ (T) measurements. For a realistic description a concept which goes beyond the W HHM -theory considering the presum -ably multi-sheeted anisotropic Ferm isurface and strongly anisotropic order parameter of UN $i_2A\ l_3$ is needed.

W e arrive at the conclusion that epitaxial thin $\,$ Im s of UN $i_2A \; l_3$ allow the identication of superconducting transition temperatures T_c which clearly depend on the current direction. In conjunction with anisotropic signatures of the magnetic ordering these measurements provide evidence for a multiband superconducting state with a magnetic Cooper-pairing mechanism. Measurements of the upper critical eld indicate a spin singlet superconducting state of UN $i_2A \; l_3$.
