# M other wavelet functions generalized through q-exponentials

#### A bstract

We generalize som ewidely used mother wavelets by means of the q-exponential function  $e_q^x$  [1+ (1 q)x]<sup>1=(1 q)</sup> (q2 R,  $e_1^x$  =  $e^x$ ) that emerges from nonextensive statistical mechanics. Particularly, we dene extended versions of the mexican hat and the Morlet wavelets. We also introduce new wavelets that are q-generalizations of the trigonometric functions. All cases reduce to the usual ones as q! 1. Within nonextensive statistical mechanics, departures from unity of the entropic index q are expected in the presence of long-range interactions, long-term memory, multi-fractal structures, among others. Consistently the analysis of signals associated with such features is hopefully improved by proper tuning of the value of q. We exemplify with the WTMM Method for mono- and multi-fractal self-a ne signals.

#### 1 Introduction

The basic idea behind the analysis of a tem poralor spatial signal by a Fourier transform is similarity. For instance, the inner product  $h_n(x)$ ; f(x) is expresses how similar are the function f(x) and the  $n^{th}$  element of the basis  $f_n(x)$ g (the kernel of the transform). The kernel of Fourier transform is a plane wave and here lies its simplicity, but also its limitation. Rigorously speaking, a plane wave exists everywhere in the universe and at all (past and future) times. Hence there are no plane waves in nature. All physical signals are temporary and spatially  $\lim$  ited. As a consequence of the in nitely extended kernel, the Fourier transform is unable to satisfactorily determine when a burst has occured, or where edges of images are located, for example (the G ibbs phenomenon, see, for instance, [1, 2]).

The rst attempt to overcome limitations of Fourier analysis was that of G abor [3], who introduced a windowed Fourier transform [4]. He used a modulation function g(u t) in order to localize the signal in a time interval [t T;t] (supp g [T;0]). Translations in time would cover the whole signal. With this, he achieved time-frequency localization. But a problem still remains with the use of a xed scale window: signal details much smaller than the window width T are detected, but not localized. They appear in the frequency behaviour of the windowed Fourier transform in a similar way it would appear in the usual Fourier transform. Signal features much larger than T, on the other hand, appear in the time behaviour of the windowed Fourier transform (i.e., they are not detected).

To avoid this problem, it is su cient a scale free transform. We avoid a valet analysis was developed to accomplish this goal. The windowed Fourier transform uses a xed size window and lls it with oscillations of dierent frequencies (consequently, varies the number of oscillations within the window). The wavelet transform uses a function with xed number of oscillations and vary the width of the window. Dilations and translations generate a complete analysis of the signal. This procedure automatically uses small windows to identify high-frequency components of a signal, and large windows for low-frequency components. We avelet analysis provides a time-scale (instead of a time-frequency) localization.

W avelet analysis was developed more than a century and a half after the pioneering work of Fourier [5]. Since the 1980's it has grown so fast that it has already consolidated as a eld of research of its own.

A nother em erging science is nonextensive statistical mechanics, that also began in the 1980's, with the formulation of the concept of a nonextensive entropy [6], that generalizes the Boltzmann-Gibbs entropy, as a basis of a generalization of standard statistical mechanics itself. Here, it took also more than a century since the rst formulation of the concept of entropy. Nonextensive statistical mechanics [6, 7, 8, 9] seems to give an underlying form albasis for a variety of complex phenomena, such as anomalous diusion [10, 11, 12, 13, 14, 15, 16], self-gravitating systems [17, 18], turbulence [19, 20, 21, 22, 23, 24, 25] cosmic rays [26, 27], among others (for un updated bibliography, see [28]).

The de nition of the nonextensive q-entropy [6] is

The entropic index q characterizes the generalization and the Boltzmann-Gibbs-Shanon entropy,  $S_1 = k_i p_i \ln p_i$ , is recovered at q! 1. The canonical ensemble is obtained by maximizing (1) with the norm constraint ( $k_{i=1}^W p_i = 1$ ) and also imposing the constancy of the normalized q-expectation value of the energy [29]

where f  $_{i}g_{i=1}^{W}$  are the eigenvalues of the Ham iltonian of the system , and fP  $_{i}^{(q)}g_{i=1}^{W}$  are the escort probabilities, de ned by [30]

where is the Lagrange parameter associated with the constraint (2). The striking features of (4) are its power-law for q > 1, and the cut-ofor q < 1, which generates quite dierent behaviours when compared with the Boltzmann-G ibbs exponential distribution. The meaning of the word nonextensive can be easily understood if we consider a system composed of two independent subsystems (in the sense of probability theory,  $p_{ij}^{(A+B)} = p_i^{(A)} p_j^{(B)}$ ). A coording to (1), the q-entropy of the composite system is given by

C learly  $q \in 1$  yields nonadditivity, or nonextensivity. A system with q > 1 is said to be subadditive, and if q < 1, it is superadditive.

The functional forms of (1) and (4) inspired the de nition of generalizations of the logarithm and exponential functions [31, 32]:

It follows immediately that  $\ln_q(e_q^x) = e_q^{\ln_q(x)} = x$ . The original logarithm and exponential functions are recovered as the particular cases  $\ln_1 x$  and  $e_1^x$ . M any formal developments have been made concerning such functions. Among them we point out the generalization [33] of the celebrated Shannon's theorem. Obviously there are in nitely many ways of generalizing a given function. One commonly form of generalizing the exponential is  $\exp_q(x) = \sum_{n=1}^{n} (j)_q$  and  $(j)_q = (q^j - 1) = (q - 1)$  and also  $(0)_q! = 1$ . This particular expression have applications in quantum groups [34]. In this paper we won't explore this possibility, but rather that one given by Equation (9) above, that naturally emerges from nonextensive statistical mechanics. Relations between wavelet analysis and nonextensive statistical mechanics have already been reported, including applications in biophysics, as the analysis of EEG signals [35, 36, 37, 38, 39].

The purpose of this paper is to extend the use of such q-deform ed functions into wavelet analysis by generalizing some widely used wavelet functions. Particularly, we generalize the mexican hat (Section 2) and the modulated Gaussian (Section 3). Moreover, we introduce in Section 4 a pair of even and odd wavelets based on the generalization of trigonometric functions. Finally (Section 5) we exemplify, with the Wavelet Transform Modulus-Maxima Method form ono-and multi-fractal self-ane signals, the possible use of the introduced functions, and, lastly, we present our nalremarks (Section 6).

## 2 q-M exican H at

Before we discuss the properties of the wavelets based on de nitions (8) and (9), let us indicate some basic facts about continuous g-wavelet transform of a function f,  $T_g$  (a;b) f, which is defined by

In order that a given function  $g \ 2 \ L^2(R)$  can be considered as a mother wavelet, it must satisfy the so-called admissibility condition, that can be expressed in terms of its Fourier transform  $\hat{g}(!)$  by

It essentially means that g(x) has zero mean, ie.,

and ensures that the the original function f(x) can be recovered from its wavelet transform as

This expression shows that, if a mother wavelet g satis es (11), it generates, by its translations and dilations, a basis in the Hilbert space, so that any function f 2  $L^2$  (R) can be expressed in terms of its g wavelet components.

It is well known that orthonormal wavelet bases can only be dened within the discrete formulation, i.e., when b2 Z and  $a=a_0^j$ , with  $a_0>0$  and j2 Z. So, orthonormal bases can not be dened with the help of the functions we discuss below.

A simple and quite com m on example of continuous wavelet is the m exican hat (see, for instance, [40, 41, 42]), that is generated from the Gaussian distribution:

The normalization constant is given by  $A = 2 = (1-4)^{p} \overline{3}$ ). Generalization of Gaussian distribution within nonextensive scenario we are focusing here has already been m ade [15, 16]. The q-G aussian (/  $\rm e_q^{\ x^{\,2}}$ ) uni es a great variety of di erent distributions into a single fam ily, param eterized by q (see [15, 16] for details): Gaussian distribution is recovered, of course, for q = 1. Moreover, for q = 2, we have the Cauchy-Lorentz distribution. Besides, q! 3 yields a completely at distribution, and q! 1 yields Dirac's This unifying character of the q-Gaussian, as well as its empirically observed occurrence in a variety of complex phenomena (as cited in the Introdutcion) stimulate us to explore its potential use in wavelet analysis. One of the more simple applications that imm ediately come to ourm inds is to use it in order to generalize the mexican hat, a function that is proportional to the second derivative of a Gaussian. We could simply replace an ordinary Gaussian by a q-G aussian, which is a legitim ate choice. Instead of doing that, we prefer to adopt a variation of it, and take the second derivative of a power of a q-G aussian, according to the recipe

With this choice we arrive, according to the expression above, at a q-G aussian raised to the power q, resembling the escort probabilities, Equation (3), widely used in nonextensive formalism [29]. We call the attention of the

reader that  $[e_q^a]^b \in [e_q^{ab}]$ , except, of course, in the particular case q=1. Because of this, the sem igroup property is not satisfied, but it is exactly this that generates its nonextensive behaviour Equation (7). For some properties of the q-exponential and the q-logarithm, see [43, 44, 45, 46, 47].

If 1 < q < 1 and  $j_x j = [(1 \ q) \ ]^{1=2}$ , the cut-o of the q-exponential (see Equation (9)) in poses  $_q(x) = 0$ . It is easily proven that, for 1 < q < 3, Equation (11) holds, so that any  $_q(x)$  is a well-de ned mother wavelet. For q = 1 or q = 3,  $_q(x)$  does not satisfy the adm is sibility condition and can not be used to de ne a useful mother wavelet.

The normalization constant is given by




Figure 1: q-m exican hat with = 1=2. (a) Norm alization constant  $A_q$ ; (b)  $_q$ (x) for 1 < q < 3; (c) 0 < q < 1; (d) 1 < q < 0. The usual mexican hat (q = 1) is represented by a dotted line, for comparison.

The function  $_{\rm q}$  (x) satis es the adm issibility condition and consistently recovers the mexican hat,  $\lim_{{\rm q}!} {_1} {_{\rm q}}({\rm x}) = {_1}({\rm x})$ : The range of adm issible values for q (  $1 < {\rm q} < 3$ ) is divided in three regions. For  $1 < {\rm q} < 3$ ,  $_{\rm q}$ (x) is in nitely supported and presents a power-law tail  $1={\rm j}x\,{\it j}^{2-({\rm q}\,1)}$ , in marked contrast with the exponential tail of the original mexican hat. When q < 1, a cut-onaturally appears at  ${\rm j}x_{\rm c}{\rm j}=[(1-{\rm q})]^{1=2}$ . In the range  $0 < {\rm q} < 1$ ,  $_{\rm q}({\rm x}_{\rm c})=0$ , and when  $1 < {\rm q} < 0$ ,  $_{\rm q}({\rm x}_{\rm c})$  diverges. For q! 1,  $_{\rm q}({\rm x})$  coincides with the abscissa axis, except at the cut-opositions, where it diverges. These features introduce signicant differences from the original mexican hat wavelet. Figure 1 illustrates  $_{\rm q}({\rm x})$  with =1=2.

It is possible to have variations of the q-m exican hat by using = (q) (w ith  $(1) = \frac{1}{2}$ ), for instance, = 1=(3 q).

## 3 Modulated q-Gaussian

Now we turn to the Morlet's wavelet, or modulated Gaussian [49, 50, 51], a function associated with the birth of wavelet analysis [52, 53]. Within the context we are dealing with, we search for a wavelet that is a generalization of [40, 54]:

where  $k=(2=\ln 2)^{1=2}$ . So we simply modulate the usual trigonometric functions (e  $^{ik}$   $_{q}$ x) with a q-G aussian (e $_{q}$   $^{x}$ 2):




Figure 2: Normalized real part of the q-m odulated Gaussian ( $h_q^R(x)$ )  $\overline{2}$ Re  $h_q$ ). (a) q=1 (usual case); (b) q=2; (c) q! 1 (illustrated with q=100). Note that abscissa scale in (c) is different from the others.

 $(B_q)$  is an approximation, as  $B_1 = 1^{-4}$  of Equation (22) is also an approximation.) Figure 2 illustrates  $2Reh_q$  with (q) = 1 = (3 q). (The factor 2 is used to have the real part normalized.) We observe the long (power-law) tail for 1 < q < 3, in marked contrast with the rapidly vanishing tail for q = 1. The cut-o is present for q < 1. In the case q ! 1,  $h_q(x)$  reduces to a two-cycle function, the imaginary part of it is a variation of the one-cycle sine presented in [40].

### 4 q-T rigonom etric w avelets

The q-exponential function (9), expanded to the imaginary (or, more generally, complex) domain by analytic continuation, leads to q-trigonometric functions [32]:

We want to construct a wavelet based on such q-trigonometric functions. For this purpose, we recall that the derivative of a q-exponential may be expressed as




Figure 3:  $w s_q(x) vs. x.$  (a) q = 1.01; (b) q = 1.1 (solid) and q = 1.99 (dashed).

Some typical curves are shown in Figure 3 (for brevity, we only show the odd function wsq(x)). Note that the number of oscillations decreases as q goes from 1 to 2. The functions present in nite oscillations of vanishing amplitudes at q! 1 (Cq! 1! 0). wsq(x) presents only one root, at x0 = 0, for  $\frac{3}{2}$  q < 2, and wcq(x) presents only one pair of roots, at x0 =  $\frac{2 \cdot q}{q \cdot 1}$  tan (q 1)  $\frac{1}{2}$ ; for  $\frac{4}{3}$  q < 2. As q! 2, Cq! 1, and the wavelets become sharply localized (the roots of wcq(x) approaches 2= ). Let us also mention that the modulation of the functions is not G aussian, but rather a power-law decay. But they are essentially dierent from the modulated q-G aussian derived in the previous Section.

The Fourier transform of  $wc_q(x)$  and  $ws_q(x)$  are found with Equation (31) and (see Equations 3.382 6 and 3.382 7 of [48])

### 5 An Example

W avelet transforms constitute a multi-purpose tool that rapidly met widespread applications in many areas of pure and applied sciences. To exem plary dem on strate the reliability of q-wavelets, we brie y present how they can be used to reproduce several properties of well known fractal sets.




Figure 4: Self-a ne monofractal pro le. Inset: its generator.

Consider a self-a nepro le y = f(x) shown in Figure 4. Its construction starts with the generator shown in the Inset. The generator is recursively applied for each straight line segment. The self-a ne fractal prole is obtained in the limit of in nite iterations.

The resulting gure after in nite generations has a local fractal dimension D=2; where  $=\ln B_y=\ln B_x=0.5$  is the roughness exponent, and  $B_x$  and  $B_y$  are the scaling factors along the x and y axis respectively. To analyze the scaling properties of f (x) around an arbitrary point  $x_0$ ; we shift the origin and de ne

$$f_{x_0}(x) = f(x_0 + x) \quad f(x_0) \quad Ax^{(x_0)}$$

where  $(x_0)$ ; the Holder (or singularity) exponent of  $f_{x_0}(x)$ ; indicates how this function vanishes (or diverges) at  $x = x_0$ :

U sing a general wavelet transform of  $f_{x_0}$  (x); it is straightforward to show that the H older exponent follows im m ediately from the wavelet transform as




Figure 5: W avelet transform (Equation (41)) with two dierent values of b:  $x_0^1 = 0.25$  and  $x_0^r = 0.50$ . Note that the curves for the same values of q coincide, as it should be for a monofractal.

Figure 5 shows how the q-wavelet transform (Equation (41)) behaves for two points along the prole for some values of q: The curves clearly indicates that the value = 0.5 is accurately reproduced. We observe that the results for q > 1 show small irregularities. This is due to the fact that, as  $e_q^x$  decays only as a power-law when x : 1, the numerical integration in (41) must be performed over a wider interval than for q = 1: In order to make evident this elect, we have performed all integrals over a xed integration interval. On the other hand, results for q < 1 show good convergence, as the function naturally presents a cuto 0 scillations in the curves are typical for this kind of analysis, as shown in the same gure for the usual mexican hat (q = 1).




Figure 6: W avelet transform (Equation (41)) with two dierent values of b:  $x_0^1=0.25$  (upper curves) and  $x_0^r=0.75$  (lower curves). The slopes are clearly dierent, as a signature of the multifractal nature.

Results for a more complex situation can be explored if we consider a multifractal set. It is generated along a similar way used to obtain the rst set, where we choose two dierent scaling factors for the rst and second half of the prole in each generation of its construction. The plots for dierent values of  $x_0$  have dierent slopes (Figure 6), indicating that many scaling laws and fractal dimensions are found in the resulting prole.

q-W avelets also prove to be a reliable tool to analyze this much more complex situation that requires a multi-fractal form alism. This amounts to

evaluate the generalized fractal dimensions D  $_{\rm Q}$ ; or its Legendre transformed singularity spectrum f ( ) = (q) Q, where represents the Holder exponent. This analysis proceeds within the so-called W avelet Transform M odulus-M axima M ethod (W TM M M), that has been developed in recent years. We will not show the details that can be found, e.g., in [55].




Figure 7: f ( ) spectra for the multifractal pro le. For q=0.8 results are very sim ilar to those with q=1. q=0.6 yields spurious results.

Figure 7 shows the f ( ) spectra, for di erent values of q, corresponding to the multifractal prole. The graphs indicate that the spectra produced by q-wavelets, with q < 1, are comparable to the one obtained by the usual q = 1 m exican hat. As we ked the integration interval for all values of q; we observe major di erences in the spectra for values q > 1: This limitation to its practical use is expressed by larger numerical e ort to compute the integrals in the wavelet transforms with the same accuracy for values of q = 1.

#### 6 FinalRemarks

The functions here introduced generalize widely used mother wavelet functions by means of a single parameter. The q-wavelets present signi cant dierent behaviours, when compared with the original q=1 cases. The ngerprints of the generalized q-wavelets are the power-law decay (q>1), and the cut-o (q<1). The generalization was inspired in the nonextensive statistical mechanics and the q-exponential that emerges from it. Within this form alism, the entropic index q measures departures from the usual Boltzmann-Gibbs behaviour. There is a number of possible origins for such departures, like slow (power-law) mixing, long-range (spatial) interactions, long-term (temporal) memory or fractal nature of the phase space. When dealing with signals which exhibit some of these features, one can hopefully take advantage of the index q to tune the wavelet to the signal, as it is here brie y exemplied for the q-mexican hat. Other wavelets, as well as scaling functions, may be generalized along the lines here introduced, for instance, the Meyer wavelet or the sinc function.
