Spin screening of magnetic moments in superconductors

A bstract. { We consider ferrom agnetic particles em bedded into a superconductor and study the screening of their magnetic moments by the spins of the Cooper pairs in the superconductor. It is shown that a magnetic moment opposite to the one of the ferrom agnetic particle is induced in the superconductor. In the case of a small itinerant ferrom agnet grain and low tem peratures the full screening of the magnetic moment takes place, i.e the absolute value of the total magnetic moment induced in the superconductor is equal to the one of the ferrom agnetic particle. In type II superconductors the proposed screening by spins of the conduction electrons can be much stronger than the conventional screening by M eissner currents.

The phenom enon of screening is very common in physics. The best known example is the screening of an electric charge in metals due to a redistribution of free electrons in space. This charge screening is very strong and the length characterizing an exponential decay of the electric eld (the Thom as Ferm i length $_{\rm TF}$) is in most metals of the order of the Ferm i wave length, i.e. of the order of the interatom is spacing. The length $_{\rm TF}$ does not depend on whether the metal is in the norm allor in the superconducting state.

A nother fam ous example is the screening of a magnetic eld or a magnetic moment by superconducting currents in a superconductor (M eissner e ect) [1]. Due to this e ect the magnetic eld decays over the length $_{\rm L}$ (the penetration depth) and vanishes in a bulk superconductor. The same length characterizes the decay of the magnetic eld created by a ferrom agnetic (F) grain embedded in a superconductor. In contrast to the screening of the electric charge in norm almetals the screening of the magnetic eld and magnetic moments in superconductors is weaker and the penetration depth $_{\rm L}$ can be of the order of hundreds interatom ic distances or larger. The screening of the magnetic grain embedded in a norm almetal to the charge screening, is very small in a norm almetal. A lthough the stray eld created by a ferrom agnetic grain embedded in a norm agnetic (N) metalm ay induce a negative localm agnetization in some regions of the norm almetal due to the Pauli param agnetism, the susceptibility is rather small ($_{\rm B}^2$ 10⁶, $_{\rm B}$ is the Bohr magneton and the density of states at the Ferm i level) and the screening can be neglected.

For certain geom etries of a superconducting sample ($\ln s$, wires) the penetration length $_{\rm L}$ can exceed the transversal size and the screening of the magnetic moment of a ferrom agnetic particle due to the M eissner currents does not play an essential role. It is usually believed that in such a situation the total magnetic moment is just the magnetic moment of the ferrom agnetic particle and no additional magnetization is induced by the electrons of the superconductor. This common wisdom is quite natural because, at rst glance, a possible contribution into the screening of the electron spins in the superconductor is even smaller than in the norm alm etal. In conventional superconductors the total spin of a C ooper pair is equal to zero and the polarization of the conduction electrons is even smaller than in the norm alm etal. Spin-orbit interactions may lead to a nite magnetic susceptibility of the superconductor [2], but it is positive and anyway smaller than in the norm al state.

In this Letter we suggest a new mechanism for the screening of the magnetic moment of a ferrom agnetic particle embedded in a superconductor by spins of the superconducting electrons. This e ect is large and the magnetic moment of the grain can be completely screened. The characteristic length of the screening is of the order of the size of the Cooper pair $_{\rm S} = \frac{1}{D_{\rm S}=2} \frac{T_{\rm c}}{T_{\rm c}}$ (we consider the \dirty" limit) and can be much smaller than the penetration depth $_{\rm L}$ in type II superconductors. If the size of the superconductor in the transverse direction is smaller than the penetration length $_{\rm L}$, the mechanism we propose is the only one leading to the screening of the magnetic moment of the ferrom agnetic grain.

A lthough this e ect seem s very surprising and has been overlooked in all previous investigations of superconductivity, its origin can be understood without any calculations. This additional screening arises due to the exchange interaction between the spins of the conduction electrons and the magnetic moment of the F grain, and the possibility for the superconducting condensate to penetrate the grain.

If the size of the grain is much smaller than the size of the Cooper pair $_{\rm S}$ the probability that both electrons of a Cooper pair are located in the ferrom agnetic grain is small. Therefore one can assume that only one electron of the Cooper pair spends some time in the grain. Then, the exchange interaction enforces the spin of this electron to be parallel to the magnetization in the grain. This leaves no choice for the second electron in the Cooper pair but to be antiparallel to the magnetization of the grain. In this way an additional magnetization antiparallel to the one in the grain is induced in the superconductor. Of course, if the transparency of the S=F interface is small the induced magnetization is weak. However, if the transparency is high enough the induced magnetization is large and the magnetization of the grain can be completely screened.




Fig. 1 { Schem atic representation of a magnetic grain embedded in a superconductor. The arrows show the direction of magnetization. In the superconductor a negative magnetization is induced over distances of the order of $_{\rm s}$.

Below we support this qualitative discussion by an explicit calculation using quasiclassical G reen's functions and a proper U sadel type equation including the exchange edd. A l-though the calculational scheme is quite standard, it contains a new important ingredient: the superconducting condensate in the F region near the surface consists of a singlet and a triplet components [3]. Due to the proximity e ect the triplet component penetrates the superconductor over the length $_{\rm S}$ and, as it carries spin, polarizes the superconductor. The triplet component was not considered previously for this type of problem s. We consider a ferrom agnetic spherical grain of the radius a embedded in a superconductor S (Fig.1). The superconductor is assumed to be a conventional s-wave superconductor with singlet pairing. The H am iltonian describing the system can be written as

where H_0 is the one-particle electron energy including interaction with in purities, J is the exchange eld which is nonzero only inside the F grain, and is the superconducting order

parameter which vanishes inside F. The matrix 3 is the Paulimatrix in the spin-space and we have assumed that the magnetization of the grain is in the z direction. The notation p and s means inversion of momentum and spin respectively.

In order to calculate physical quantities of interest it is convenient to use quasiclassical G reen's functions g and write the proper quasiclassical equations for them. We consider the \dirty" limit, which means that the inverse momentum relaxation time ¹ is much larger than the exchange energy J and than the critical temperature T_c of the superconductor. The functions g are 4 4 matrices in the particle-hole and spin space and obey the U sadel equation which in the presence of the exchange interaction has the form

In the S region $D = D_S$, J = 0, $= i^2 a^3$ (the phase of is chosen to be zero). In the F grain $D = D_F$ and = 0. Eq. (2) should be complemented by boundary conditions at the S=F interface [4]

where $_{S,F} = _{S,F} R_b$, $_{S,F}$ are the conductivities of the F and S layers, R_b is the resistance per unit area, and n is the unit vector norm alto the S=F interface. Solving Eqs. (2, 3) for the G reen functions g, one can obtain the induced magnetization M

where is an e ective Bohrm agneton, is the density of states (DOS) and the sum is taken over the M atsubara frequencies ! = T(2n + 1).

The functions g can be represented in the form $g = i\hat{j}\hat{f} + \hat{j}\hat{g}$, where the condensate function \hat{f} and the norm al function \hat{g} are matrices in the spin space [3]. For simplicity we consider the case of a small grain when the condition a $F = D_F = J$; full led (this is

possible provided the exchange energy J is much smaller than the Ferm i energy $"_F$). In this lim it the solution can be found averaging Eq. (2) over the grain volume and we obtain for the G reen functions

The function $g_{3,3}$ determ ines the excess m agnetization. Solving Eq. (6) with the boundary condition, Eq. (3), we obtain

where ${}_{S}^{2} = 2^{p} \frac{1}{1^{2} + 1^{2}} = D_{S}$; $f_{F 0} = (f_{F + 1} + 1^{F}) = 2$ describes the triplet component mentioned above. One can see that the correction $g_{S,3}$ is small if the parameter $a = s_{S}$ is small. Note also that the function $g_{S,3}$, which according to Eq.(4) determines the induced magnetization, is proportional to the condensate function $f_{F,0}$. The latter function is the triplet component with zero projection of the magnetic moment on the z axis. U sing Eq.(7) one can easily calculate the total magnetic moment of the S region

It is not di cult to see that the magnetic moment M $_{\rm S}$ has the sign opposite to J (the magnetic moment of the ferrom agnetic particle M $_{\rm F\,0}$ is proportional to J), which means that the spins of the conduction electrons screen (at least partially) the magnetic moment M $_{\rm F\,0}$ of the ferrom agnetic grain.

Let us compare the total magnetic moment induced in the superconductor, Eq.(8), with the magnetic moment of the ferrom agnetic grain in the normal state M $_{\rm F0}$ = (4 a^3 =3)M $_{\rm F0}$: The sum in Eq.(8) can be computed num erically in a general case. For simplicity we consider here a limiting case that can be realized experimentally.

We assume that the transmission coe cient through the S=F interface is not small and the condition $\langle J \rangle_F = a^2$ is fulled. In this case the expression for $f_{F\,0}$ is drastically simplified. To estimate the energy $D_F = a^2$ we assume that the mean free path is of the order of a. For a = 30A and $v_F = 10^8 \text{ cm} = \sec w \text{ get } D_F = a^2$ 1000K; This condition is fulled for ferrom agnets with the exchange energy of the order of several hundreds K. In order to relate $M_{F\,0}$ to J, one has to make a certain assumption about the nature of the ferrom agnet. If the magnetic moment $M_{F\,0}$ is induced mainly by free electrons (an itinerant ferrom agnet), one gets $M_{F\,0} = F$ J: Then we obtain for low temperatures

Eq. (9) describes a remarkable phenom enon: at su ciently low temperatures and in the limit of a small grain (a $_{\rm F}$) the magnetic moment of the latter is screened over distances of the

order of $_{\rm S}$. This screening is complete if the magnetization of the F particle is due to the free electrons (itinerant ferrom agnet). It can be easily shown that at arbitrary temperatures this ratio is equal to $(1 \quad n_n (T)=n_e)$, where n_e and $n_n (T)$ are the density of total number of electrons and "norm al" electrons de ned in Ref. [1].

The compensation of the magnetization of an itinerant ferror agnet by the C ooper pairs is to some extent consistent with the result obtained by R usinov and G or kov some decades ago [5]. They studied the properties of a superconductor with paramagnetic in purities that were assumed to be ferror agnetically ordered. The free electrons interact with the magnetic in purities via the exchange interaction. Their approach (averaging over im purity positions) reduces the problem to noting the magnetization of a superconductor with an elective exchange interaction uniform by distributed in space. It was demonstrated in Ref. [5] that the total itinerant magnetization of the system was zero in the lim it of low tem peratures and not too large exchange energy.

Clearly, the screening obtained here is due to the appearance of the triplet component. So, if the latter is suppressed by other mechanisms the elect will be reduced. The spin-orbit interaction (SO I) and orbitale lects (M eissner currents) are such mechanisms. The other way of thinking of this reduction is that the spins of the electrons of the Cooper pairs are not necessarily antiparallel in the presence of e.g. SO I and are not as electent in inducing the magnetization.

In Ref. [3] we studied the e ect of the SO I on the triplet component penetration into the ferrom agnet. Here we can simply use these results to analyze the e ect of the SO I on the penetration of the induced magnetization into the superconductor.

If the SOI is taken into account, an additional term of the form (i= $_{sic}$) S³ g³S;g appears in the U sadelequation, where $_{sic}$ is the spin-orbit scattering time, S = ($_1$; $_2$; $_3$ 3) (see [6] and [3]). Due to this additional term the quantity $_{S}^{2}$ in the linearized U sadelequation is replaced by

where $\frac{2}{s_0} = 8D_S = \frac{1}{s_0}$. Therefore the length of the penetration of $f_{S\,0}$ and of M_S into the S region decreases if $\frac{2}{S} = \frac{2}{s_0}$: In principle, one can measure the spatial distribution of the magnetic moment in the S region (see e.g. [7]) and get an information about the SO I in the superconductors. With the help of Eq. (10), this would be an alternative method to measure the strength of the SO I in superconductors, complementary to the measurement of the Knight shift [8]. (The latter is based on the result of Ref. [2] that the Knight shift observed in superconductors is due to the SO I). Let us notice, that in the presence of SO I the linearized equation for the function $f_{S\,3}$ that determines a correction to the energy gap due to the proximity e ect remains unchanged.

The orbital e ects (the M eissner currents) also change the characteristic length of the penetration of the induced m agnetization M_S. Contrary to the case of bulk conventional superconductors, the M eissner currents in S=F structures arise spontaneously even in the absence of an external magnetic eld H_{ext} . This happens because an internal magnetic eld is induced by the ferrom agnet. These spontaneous currents were studied, e.g., in Refs. [9,10]. In Ref. [9] the spatial dependence of the M eissner current in the F Im was calculated, whereas the M eissner currents in the both S and F Im swere computed in Ref. [10]. It is of interest to know not only the spatial dependence and the magnitude of the M eissner currents, but also their e ect on the penetration length of the TC and on the induced magnetization. Here we study the in uence of the M eissner currents on the penetration length of M_S : For sim plicity we consider rst a planar geom etry, which allow s us to get a sim ple solution. For a spherical particle we estimate the e ect by order of magnitude.




Fig.2 { Spatial dependence of the vector potential A (x) or the supercurrent density. For low enough tem peratures the values of A at both outer surfaces (x = d_s and x = d_F) is nearly the same. The dot-dashed line shows the spatial dependence of the local magnetization in arbitrary units

Let us consider a bilayer S=F structure with the thicknesses $d_{S,F}$. We assume again that the thickness of the F layer is small ($d_F << F$) and the thickness of the S layer obeys the condition: $_S << d_S << L$: In this case the solution for g_F and f_F (Eq.(2)) remains unchanged provided one replaces a=3 with d_F . The solution for $g_{B,3}$ has the form $g_{B,3} = (_{S}g_{B,C,S}f_{B,C,S} = _{S})f_{F,0}\exp(_{S,X})$ and one can easily calculate the spatial distribution of the magnetization in the system M $_{S,F}$ (x). Note that again in the case of an itinerant ferrom agnet and low temperatures the total magnetic moment in S is equal to ($M_{F,0}d_F$). We display schematically the spatial dependence of the magnetization in Fig.2 alongside with the spatial dependence of the vector potential A (x) which is given by

with a constant A_0 determ ined from the condition that the total current through the system is zero (no external magnetic eld). We have assumed that the magnetization lies in-plane. The supercurrent density is expressed through A as

where $_0$ is the magnetic ux quantum. In the lim it $J << _{bF}$ the condensate functions f_3^2 are nearly the same in the S and F layers. Taking this into account and calculating the total current I, we get from the condition I = 0 for A_0

where $\underline{A}_{p} = 4 M_{F0}d_{F}$. At low temperatures the third term is approximately equal to 0:53 s $D_{s}=2$. The spatial dependence of the vector potential is shown in Fig. 2. Eq.(7) for q_{53} does not change in the presence of the M eissner current provided one replaces $\frac{2}{S}$ with $\frac{2}{S} + p_{0}^{2}$, where $p_{0} = A_{0} = 0$. It is clear that the orbital elects are negligible if $A_{0} = 0 = A_{m} = 0 << \frac{1}{S}^{1}$. For example, $A_{m} = 0 = 5:10^{3}$ cm⁻¹ for 4 M_F lkO e and $d_{F} = 50A$, and therefore s should be smaller than 2 m.

It is not di cult to estimate p_0 in the case of a spherical particle. The quantity p_0 in this case reaches the maximum at r = a and is of the order of $(4 M_F = _0)a$: As we have noted above, the magnetic moment in F is compensated by that in the superconductor. This means in particular that the total internal magnetic ux in the S=F=S Josephson junction may be zero even if the F layer is a single domain (see experiments of Ref. [11]).

In sum m ary, we have shown that the m agnetic m om ent M $_{\rm F\,0}$ of a ferrom agnetic particle embedded into a superconductor is screened by spins of the C opperpairs. A n induced m agnetic m om ent M $_{\rm S}$ aligned in the opposite to M $_{\rm F\,0}$ direction arises in the superconductor.

The induced magnetic moment in the superconductor can be observed experimentally. In a recent experiment [7] the spatial electron spin polarization was determined by means of muon spin rotation. Such a method may be used in order to determine M_S . Another possible method is the measurement of the Knight shift in superconductors that should be dependent on the magnetization M_S . One can also determine the totalm agnetic moment of a S/F structure performing magnetic resonant measurements as in Ref. [12].

At last, one can determ ine M $_{\rm S}$ m easuring the total magnetic m om ent of a superconductor with embedded ferrom agnetic particles sim ilarly to the work [13], where an enhancem ent of the magnetic m om ent of ferrom agnetic particles embedded into a nonmagnetic matrix has

been observed. A lthough the enhancement in the case of a normal metal matrix awaits its explanation, we suggest to measure the magnetization of the system of ferrom agnetic particles embedded in a superconducting matrix. W hen using a superconducting metal as the matrix, a reduction of the magnetic moment, instead of the enhancement, should be observed below the superconducting temperature T_c .
