# R ayleigh-Schrodinger-G oldstone variational perturbation theory for m any ferm ion system s

A bstract. We present a Rayleigh-Schrodinger-Goldstone perturbation form alism for many ferm ion systems. Based on this form alism, variational perturbation scheme which goes beyond the Gaussian approximation is developed. In order to go beyond the Gaussian approximation, we identify a parent Ham iltonian which has an elective Gaussian vacuum as a variational solution and carry out further perturbation with respect to the renormalized interaction using Goldstone's expansion. Perturbation rules for the ground state wavefunctional and energy are found. U seful commuting relations between operators and the Gaussian wavefunctional are also found, which could reduce the calculationale orts substantially. As examples, we calculate the rst order correction to the Gaussian wavefunctional and the second order correction to the ground state of an electron gas system with the Yukawa-type interaction.

# 1. Introduction

Field theories can be constructed from three kinds of pictures which are called Heisenberg, Interaction and Schrodinger pictures [1]. Am ong them, the Heisenberg picture is known to provide a convenient basis for the study of dynam ics of operators and system atic perturbative im provem ent on physical quantities. On the other hand, the Schrodinger picture approach focuses on the dynam ics of wavefunction, which allow s detailed study on time evolution. However, in this approach, it is known that system atic im provem ent on obtained result is rather di cult. Instead, it has a powerful technique which is called a variationalm ethod which allow s nonperturbative access to problem s, so that it could be applied to strongly correlated system swhere perturbative approaches break down.

There have been successful applications of the Schrödinger picture to eld theories [2-8] and later on to nonrelativistic many-particle systems [9-15]. While it has been proved useful, still the controlable range of trial wavefunctionals has been found to be narrow and further improvement from results of a trial wavefunctional dem ands much endeavor in eld theories. Therefore, recent investigations on the picture have focused on overcoming its drawbacks towards a more managable theory.

G aussian trial wavefunctional apporach in bose elds has been widely applied and proven to be an eldent and powerfulm ethod in the Schrödinger picture [3,8]. Further improvements beyond the G aussian approxiam tion have been investigated mostly in two directions. One is to try it with non-G aussian wavefunctionals [16,17], and the other is to perform appropriate expansions based on G aussian trial wavefunctional [18–24].

In ferm i elds, a convenient prescription for operators was proposed by F breanini and Jackiw [5]. It was shown that this approach gives successful results on G aussian approximations of ferm i elds as in bose elds. However, in contrast to the bosonic case [1], no successful Rayleigh-Schrödinger type perturbation form alism for ferm i elds has been proposed so far, although several alternative schemes including functional integrals [25] and background eld methods [8] have been reported using the F breanini-Jackiw representation (FJR). Since the Rayleigh-Schrödinger perturbation form alism is them ost familiar form of perturbation theories and especially suitable for the Schödinger picture representation in quantum mechanics, it is rather puzzling that it is not so in

eld theories. Indeed, the Rayleigh-Schrödinger perturbation scheme for bose elds was form ulated early [1]. However, for ferm i elds, Grassmann nature of functional variables has not allowed no such straighforward form alism as for bose elds.

In this paper, we present a successful perturbation form alism for ferm ionic m anybody system s com bining the Rayleigh-Schrodinger perturbation with G oldstone's (RSG) expansion. The scheme will be used to form ulate a variational perturbation scheme, which provides a system atic in provem ent beyond the G aussian approximation. In order to make the presentation compact, we directly form ulate a RSG perturbation scheme based on the variational G aussian wavefunctionals. The form alism is trivially reduced to the conventional perturbation scheme by using a true G aussian vacuum instead of an

e ective G aussian vacuum. This point will be made clear once the form alism is given. It will be shown that the FJR provides surprisingly simple expressions for ferm ion wavefunctionals. As examples, we calculate the rst order correction to the G aussian wavefunctional and the second order energy of an electron gas with the Yukawa-type interaction.

## 2. Floreanini-Jackiw representation

The action of ferm i eld operators on H ilbert space can be represented by product or derivatives of G rassm ann variables in the G rassm ann function space. Then, Schrödinger equations are transformed into functional di erential equations [1]. Am ong m any possible representations preserving the anticom m uting relations of ferm i eld operators, the sim plest one is generated from the ferm ion coherent states which are de ned as eigenstates of annihilation operators [26]. In this representation, annihilation operators faig are described by G rassm ann variables fuig, and creation operators faig , by G rassm ann derivatives f $\frac{\theta}{\theta_{11}}$ g. A representation without a complex conjugate notation

is also possible and has been used by D uncan et al. [4,9]. However, we nd that the representation proposed by F loreanini and Jackiw is more convenient to form ulate the present theory.

In the FJR, the creation and annihilation operators are given as follows [5];

where  $u_i$  and  $u_i$  are G rassm ann variables. In the FJR for free ferm isystem s, vacuum s are described by G aussian wavefunctionals just as for bosonic system s. However, the norm s between basis states for the FJR are not orthogonal since  $hu^0u^0$  juu  $i = e^{u_i^0 u_i u_i u_i^0}$ . It can be proven by the fact that four kinds of states relative to a quantum number i are possible. They are represented by 1,  $u_i$ ,  $u_i$  and  $u_i u_i$ . A ctually, only two kinds of physical states for i exist. O ne is the occupied state by a ferm ion and the other unoccupied. Thus, the FJR is a reducible representation and only a subspace of the total G rassm ann functional space can be used to describe physically well-de ned wavefunctionals. The subspace can be constructed only after a physical vacuum wavefunctional is chosen. The dual space wavefunctional for the wavefunctional is de ned as

where the norm is calculated by h j i = D [uu ]. It can be easily shown that the free ferm ion vacuum is described by G aussian wavefunctional [5] as

where  $G = G^{y^{1}}$  and we not the dual wavefunctional is also Gaussian. Gaussian expectation values of some norm all ordered operators are calculated as

where I is an identity matrix and J;J are source elds which are inserted into the G aussian wavefunctional as  $e^{G_{ij}u_iu_j+J_iu_iu_jJ_i}$  during the calculation. It allows that the G rassm ann integrals are represented by G rassm ann derivatives of source elds.

For the free eld H am iltonian, H  $_0 = h_{ij}a_i^ya_j$ , the functional Schrödinger equation in the FJR is

This equation contains second order derivatives and a quadratic term which are similar to the harmonic oscillator problem. Thus, we expect the Gaussian wavefunctional, Eq.(3), as a vacuum. In order for Eq.(3) to be an eigenfunctional with an eigenvalue  $E_0 = \frac{1}{2} Trh (I + G)$  in Eq.(6), G should satisfy the following condition;

Eq.(7) has trivial and non-trivial solutions. Trivial solutions are G = I and non-trivial ones,  $G = \frac{p h}{h^2}$ . Here, we note that the number of particles N is given by  $N = \frac{1}{2} Tr(I + G)$ . Therefore, G can be expressed as  $G = \frac{p h I}{(h I)^2}$ , where is a chem ical potential. D isgonalized, diagonal elements of G become 1 (-1) below (above) . In the case of free D irac elds, is zero and all the negative energy states are fully led in the D irac vacuum.

### 3. G aussian approxim ation and the state wavefunctionals

W hen interactions between ferm ions exist, exact eigenfunctionals are dierent from the above Gaussian. Variationalmethod or perturbation theory is applied in order to approximate true eigenfunctionals. A lthough the variationalmethod depends largely on intuition in contrast to the systematic perturbative approach, it could provide excellent results if trial states are chosen carefully.

In the Gaussian approximation, Gaussian wavefunctional with variational parameters is used as a trial functional. We now consider the case of interacting ferm ion system where the Hamiltonian has a general form,

Trialwavefunctional is chosen to be

where G is a variational parameter matrix. Then, the energy expectation value is readily calculated with the aid of Eq.(5).

Rayleigh-Schrodinger-Goldstone variational perturbation theory form any ferm ion system s5  $\frac{e}{e_{G_{ij}}}^{h} E \left(\frac{1}{2}Tr N\right)^{i} = 0$ , where , the chem ical potential, is introduced as a Lagrange's multiplier. Thus, the solution G should satisfy the following condition;

The equivalent condition for G is obtained by minimizing with respect to G, and is given by (I + G) (h + I) (I - G) = 0 which provides the same G as in Eq.(11). As in Eq.(7), the nontrivial solution G of Eq.(11) is given by

W ith this solution, the ground state energy  $E_0$  is given as  $E_0 = \frac{1}{2} Tr(h + )(I + G)$ . The parent H am iltonian  $H_0^{\circ}$  which has the above G aussian vacuum is easily found to be  $H_0^{\circ} = (h + )_{ij}a_i^{y}a_j$ . In order to obtain excitations based on the G aussian wavefunctional, we should have a unitary matrix U which diagonalizes G as UGU<sup>y</sup> = I, where I is a diagonal matrix with elements of +1 (-1) below (above) the Fermilevel . Thus, G can be rewritten as follow s;

Therefore, we obtain an expression for U ,

The G aussian wavefunctional is diagonalized by the new G rassmann variables  $\alpha_i = U_{ij}u_j$  and  $\alpha_i = u_j U_{ji}^y$ . We use capital(sm all) letters above (below) the ferm isse, so that

Excited wavefunctionals and their duals are obtained by these operations to the G aussian as

which has an excitation energy of  $\gamma_{A_1} + \frac{1}{A_n} \sim (\gamma_{a_1} + \frac{1}{A_n})$  where  $\gamma_i$  is the ith matrix element of U (h + )U<sup>Y</sup>. We note here that any physical wavefunctional in the FJR could be represented by multiplying only some combinations of  $w_A$  and  $w_a$  to the Gaussian, while in other representations, wavefunctionals should also contain G rassmann derivatives for describing hole states and, thus, are quite complicated in general. An important aspect of the present result is that Eqs.(17) and (18) have same structures to those in bose systems [1].

4. Rayleigh-Schrodinger-Goldstone Perturbation Form alism beyond the Gaussian approximation

In order to go beyond the G aussian approximation by a perturbative method based on the parent H am iltonian  $H_0$ , H am iltonian is rearranged as

where  $\tilde{h} = UhU^{y}$ ,  $\tilde{v} = UU^{y}$  and  $\tilde{v}_{ijkl} = U_{il}U_{jm}V_{lmpq}U_{pk}^{y}U_{ql}^{y}$ . Here, we note that the whole form alism simply reduces to the conventional perturbation if is set to zero. In the previous section, we have already obtained whole spectrum s of eigenvalues and eigenfunctionals of the parent H am iltonian  $H_{0}^{r}$ . Therefore, the Rayleigh-Schrödinger perturbation procedure [1] can be readily adopted for in proving the Gaussian approximation. However, in order to carry out the calculation, it is necessary to have a general rule for combination of Grassmann operations which is similar to W ick's theorem of the Green function approach. In the following, we show that another perturbative approach in the time independent form ulation, namely Goldstone's expansion [27], becomes an extrem ely useful tool in the present approach. Since nal results from Goldstone's expansion are same as from the Rayleigh-Schrödinger scheme order by order, we follow the Goldstone's approach to obtain the expressions for the Rayleigh-Schrödinger perturbation.

Goldstone's expansion is as follows. If  $H = H_0 + H_1$ ,  $H_0j_0i = E_0j_0i$  and  $Hj_0i = (E_0 + E)j_0i$ , then

where  $j_{0}i$  is norm alized as  $h_{0}j_{0}i = 1$ . The prime in sum m ation represents exclusion ofterm swith zero denom inators and subscripts L and C represent linked and connected diagram s respectively. The connected has the sam e m eaning as in other m any-particle theories. However, the linked diagram s in the Goldstone's usage are such that even when som e diagram s have unconnected parts, if unconnected parts all have external lines, then, the diagram s are treated linked.

Let's expand the exact ground state wavefunctional in terms of the renormalized interaction, H H<sub>0</sub>. It gives =  $P_n$  , where  $_0 = _G = e^{G_{ij}u_iu_j}$ . Then, the nth order wavefunctional is given by

In order to represent explicitly the G rassm ann wavefunctional, we use the following useful relations. When capital(small) letters are dened for states above (below) the ferm i see, that is, A; B;  $rac{1}{2}$  kind a; b;  $rac{1}{2}$ , kwe arrive at simple commuting relations as follows,

These commuting relations will be shown to reduce calculationale orts substantially in the FJR.W e further de ne i and i for notational simplicity as

The right-hand side above consists of combinations of G rassmann variables and G rassmann derivatives. We can easily see that if there is no  $u_i$  ( $u_i$ ) on the right-hand side of  $\frac{\theta}{\theta u_i}$  ( $\frac{\theta}{\theta u_i}$ ), it should be zero. C ontraction is de ned as a G rassmann derivative result which is expressed by

Self-contractions of bare interaction,  $\nabla_{ijkl}(ijkl)$  are canceled out by  $\sim_{ij}(ij)$  because  $\sim_{ij}(ij) = (V_{kijl} \quad V_{ikjl}) (U \quad U^{y})_{lk}(ij) = 2(V_{kijl} \quad V_{ikjl})_{lk} ((k_F \quad l) \quad (l \quad k_F))(ij)$ . where E  $P_{a=}^{P}$  ( $\gamma_{i_{a}} + \gamma_{j_{a}} - \gamma_{k_{a}} - \gamma_{i_{a}}$ ) means excitation energy. Each index in the second square bracket in Eq.(29) could be a Grassmann variable or a Grassmann derivative. Therefore, in order to be non-zero, all derivatives should be contracted out with corresponding variables and nally remaining elements should be Grassmann

variables only. They are sum marized as follows: (i) The following steps are repeated for each m = [0;2n 1]. (ii) A possible set of m pairs of bar and non-bar indices is selected. Self-contractions are forbidden and isolated parts fully connected by contractions are also excluded. (iii) Each contraction has the value given by Eq.(26) or Eq.(27). If odd numbers of permutations are performed for contraction, (-1) is multiplied. Remaining indices without contraction are converted by i!  $\frac{p}{2}u_i$  (i  $k_F$ ) and i!  $\frac{p}{2}u_i$  ( $k_F$  i). (iv) All other possible m contractions are performed. Then, n is calculated by multiplying the rst square bracket term of Eq.(29) to each contraction term and nally by sum ming out all indices.

The corresponding nth order energy  $E_n \ ( \ E \ = \ \stackrel{P}{\ }_n E_n \,)$  is calculated as

where subscript C means that we should perform fully connected contractions.

where G should be the variational solution, Eq.(12), and the notational abbreviations, Eq.(16) and (24) are also used. The third line of Eq.(31) is equivalent to the full contractions allowing unconnected ones.

As examples, we calculate the rst order wavefunctional  $_1$  and the second order energy  $E_2$ . If we use capital(sm all) letters above (below) the Ferm i see in the correction parts, they are represented as

Here, we note that  $E_1$  is always zero and  $_1$  has no terms like  $\alpha_A \alpha_a$  because self-contraction is forbidden.

In the case of electron gas, the quantum numbers are usual wavevector k and spin and the interaction has a form ,

For a hom ogeneous case, the Gaussian variational solution G of Eq.(12) is already diagonalized by k representation. Therefore, we can use the Grassmann variables  $u_k$ ;  $u_k$  as basis states instead of  $u_k$ ;  $u_k$ . The energy component of parent H am iltonian  $H_0$  is calculated as  $\gamma_k = (h + )_k$ ;  $k = {0 \atop k} P_q v(q) n_{k+q}$  where  ${0 \atop k}$  is the free electron energy band and  $n_k$  is the Ferm i distribution function at zero tem perature. Thus, we nally have

The rst order wavefunctional has a very simple form and higher order ones are also expected to have such simple forms in this variational FJR. We nd that the above ground state energy is same as the zero temperature limit of the variational perturbation theory [25] previously obtained from a functional integral representation, because G aussian approximations of both representations employed same variational basis. For a numerial energy value, we modeled an electron gas with a bare kinetic energy  $\frac{0}{k} = \frac{h^2 k^2}{2m_e}$  and a Yukawa-type interaction v(q) = 4  $e^2 = V(q^2 + (\frac{1}{a_0})^2)$  where m<sub>e</sub> and e are the bare electron mass and the charge, and V and  $a_0$  are the system volume e and the Bohr's radius respectively. ; , and are parameters to modulate the mass, charge and interaction range. In Fig.1, we plot the second order contribution to the ground state energy as a function of  $r_s$ , which is the average distance ratio between electrons de ned by  $V = \frac{4}{3} (r_s a_0)^3 N$ . We nd the second order contribution is much reduced in the present variation procedure than the conventional one which usually gives exceedingly negative result. This indicates much better convergence for the variational perturbation theory as expected.

# 5. Sum m ary

We have presented a Rayleigh-Schrödinger-Goldstone perturbation form alism using the F lorean ini-Jackiw representation on ferm ion systems. With the aid of Goldstone's expansion, form alexpressions for the ground state wavefunctional and the corresponding energy are obtained in terms of a renorm alized interaction. It is shown that this form alism can be used for both standard perturbation and variational perturbation schemes. Useful commuting relations between creation and annihilation operators with the Gaussian wavefunctional have been found. A sexam ples, we have calculated the rst order wavefunctional and the sencond order ground state energy of electron gas with Yukawa-type interaction.


