Soft lubrication

Abstract

We consider some basic principles of uid-induced lubrication at soft interfaces. In particular, we show how the presence of a soft substrate leads to an increase in the physical separation between surfaces sliding past each other. By considering the model problem of a symmetric nonconforming contact moving tangentially to a thin elastic layer, we determ ine the norm all force in the small and large de ection limit, and show that there is an optimal combination of material and geometric properties which maximizes the norm all force. Our results can be generalized to a variety of other geometries which show the same qualitative behavior. Thus they are relevant in the elastohydrodynam ic lubrication of soft elastic and porcelastic gels and shells, and in the context of bio-lubrication in cartilaginous joints. Lubrication between two contacting surfaces serves to prevent adhesion and wear, and to reduce friction. The presence of an intercalating "lubricating" uid aids both, but gives rise to large hydrodynam ic pressures in the narrow gap separating the surfaces and can thus lead to deform ations of the surfaces them selves. For sti materials such as metals the pressure required for noticeable deform ations is very large (1G Pa) and under these conditions the lubricating uid will exhibit non-N ew tonian properties [13]. However, if these surfaces are soft, as in the case of gels and thin shells, elastohydrodynam ic e ects can become in portant when the uid is still N ew tonian since the pressure required to displace the surface is appreciably less. This type of situation is also common in mammalian joints where the synovial uid serves as the lubricant between the soft thin cartilaginous layers which coat the much sti er bones. M otivated by these observations, in this letter we consider the coupling between uid ow and elastic deform ation in con ned geometries that are common in lubrication problem s.




FIG. 1: A rigid cylinder m oves at a velocity V a distance h_0 above a rigid substrate coated with an elastic layer of thickness H₁. H₁; h_0 $p_{\overline{h_0R}} = 1$. We illustrate the steps of the perturbation analysis: (b) an antisymmetric pressure distribution pushes down on the gel in front of and pulls the gelup behind the cylinder; (c) the fore-aft gap prole symmetry is broken; (d) the new pressure eld produces a norm al force. (a) and (b) correspond to an undeformed substrate, while (c) and (d) correspond to solutions of (7), (8) and (12) for $=\frac{h}{h_0} = 10$.

As a prelude to our discussion we consider the steady motion of a cylinder of radius R completely immersed in uid and moving with a velocity V, with its center at height $h_0 + R$ above a rigid surface (see Fig. 1). The dynamics of the uid of viscosity, and density are described using the N avier-Stokes equations

where v is the 2-D velocity eld (u;w) and p is the pressure. Comparing the ratio between the inertial and viscous forces in the narrow gap having a contact length 1 P_{Rh_0} [14], we nd the gap Reynolds number $Re_{g} = \frac{V^{2}-1}{V=h_{0}^{2}}$ $\frac{Vh_{0}^{3+2}}{R^{1-2}}$ $\frac{VR}{R} = Re$, the nom inal Reynolds number. The gap Reynolds number is small since h_{0} R and we can safely neglect the inertial terms and use the Stokes' equations (and the lubrication approximation thereof [2]) to describe the hydrodynamics. The temporal reversibility associated with the Stokes equations and the symmetry of the parabolic contact leads to the conclusion that there can be no norm al force due to the horizontalm otion of the cylinder. However, if there is a thin soft elastic layer on either the cylinder or the wall, the deform ation of the layer breaks the contact symmetry and leads to a norm al force. This then leads to an enhanced physical separation and a reduced shear so that it may be a likely cause for the low wear properties of cartilaginous pints.

C ontinuing our analysis in the context of a cylinder moving along a planar wall, we take the x direction to be parallel to the wall in the direction of motion of the cylinder and the z direction to be perpendicular to the wall; p is the uid pressure; h is the distance between the solid surfaces. Guided by lubrication theory [2] we use the following scalings

We consider steady motion in the reference frame of the cylinder, so that the boundary

conditions are

Integrating (4,5,6) leads to the dimensionless R eynolds equation [3]:

Since the gap pressure is much larger than the ambient pressure, we may approximate the boundary conditions on the pressure eld as

Next, we consider the deform ation of the elastic layer of thickness H_1 that rests on a rigid support. Balance of stresses in the solid leads to

where $u = (u_x; u_z)$ is the displacement eld and G and are the Lame constants for the solid, which is assumed to be isotropic and linearly elastic. To calculate the increase in gap thickness H (x) we use the analog of the lubrication approximation in the solid layer [4]. The length scale in the z direction is H_1 and the length scale in the x direction is $\frac{p}{h_0R}$. We take the thickness of the solid layer to be small compared to the thickness of the contact zone, $\frac{p}{h_0R}$ H₁, and consider a compressible elastic material, G , to not the vertical force balance: $e_{zz}u_z = 0$: The boundary condition at the solid-uid interface is n = pn, so that $(2G +)e_zu_z(x;0) = p(x)$. U sing the zero displacement condition at the interface between the soft and rigid solid, $u_z(x; H_1) = 0$ leads to the following expression for the displacement of the surface

Then the dimensionless version of the gap thickness, $h = h_0 + \frac{x^2}{2R}$ u_z (x;0), is

where = h=h₀ = $\frac{P_{2R_{1}V}}{h_{0}^{5-2}(2G_{+})}$ is the dimensionless parameter governing the size of the de ection. Inspired by the some recent experiments [5] in a similar geometry, we consider a cylinder of radius R = 10 cm coated with a nubber layer (H₁ = 0:1 cm, G = 1 M Pa) moving through water (= 1 m Pa s, V = 1 cm/s, b = 10³ cm). Then = 10² << 1, so that we may use the perturbation expansion P = P₀ + P₁, where P₀ is the anti-symmetric pressure distribution corresponding to an undeformed layer, and P₁ is the symmetric pressure perturbation induced by elastic deformation. Substituting (12) into (7) leads to the following equations for P₀; P₁:




FIG. 2: (a) The dimensionless pressure distribution, P, for several values of , a measure of the de ection of the elastic layer compared to the initial separation. (b) The dimensionless gap thickness pro le, $H = 1 + X^2 + P$. The gap thickness and asymmetry increase with , while the maximum value of the pressure decreases. (c) For small asymptotic analysis predicts a dimensionless lift force $F = \frac{3}{8}$, which matches the numerical solution. (d) F has a maximum at = 2.06 as a result of the competition between symmetry breaking and decreasing pressure.

In dimensional terms, $F = \frac{3^{p} \frac{7}{2}}{4} \frac{2 \sqrt{2} H_{1R}^{3-2}}{h_{0}^{7-2} (2G +)}$; whose scaling matches the result reported in [6], but with a dimensional term pre-factor. When is not small, we solve (7), (8) and (12) numerically. Figure 2 shows that as increases them ean gap increases and its prole becomes asymmetric, resembling the prole of a rigid slider bearing, a conguration well known to generate lift forces [2]. In addition, this increase in the gap size causes the peak pressure to decrease since $p = \frac{VR^{1-2}}{h_{0}^{3-2}}$. These two competing elects produce a maximum lift force when = 2.06.




FIG.3: Schem atic diagram s of two con gurations considered on the level of scaling: (a) a soft solid coats a rigid solid where H₁ $p_{\overline{h_0R}}$, i.e. the layer thickness is larger than the length scale of the hydrodynam ic interaction; (b) the cylinder is replaced by a cylindrical shell.

and therefore allows us to generalize these results to a variety of con gurations involving lubrication of soft contacts (Fig. 3; Table 1). Balancing the pressure gradient in the gap with the viscous stresses yields

Here p_0 does not contribute to the lift for the reasons outlined earlier, so that the the lift on the cylinder per unit length is

where h is determined by the solution of the elasticity problem.

For a thin compressible layer, the case treated above, the norm allstrain is $\frac{h}{H_1} = \frac{p_0}{G}$. Therefore,

In sharp contrast, a thin incompressible layer will deform via shear with an e ective shear strain $\frac{u}{H_1}$ $\frac{1}{H_1^2}$ [15]. Balancing the elastic energy $R G \left(\frac{R^{1=2}h_0^{1=2}}{H_1^2}\right)^2 dV$ $G \left(\frac{R^{1=2}h_0^{1=2}}{H_1^2}\right)^2 H_1 \frac{p}{Rh_0}$ with the work done by the pressure $p_0 h \frac{p}{Rh_0}$ yields h in terms of p_0 . Then, (17) and (19) give

A thick layer (H₁ $p_{\overline{h_0R}}$) may be treated as an elastic half space. The strain scales

as $\frac{h}{h_0R}$ and remains appreciable in a region of size h_0R . Balancing the elastic energy $R = \frac{h}{h_0R}^2 (\frac{p}{h_0R})^2 dV$ $G(\frac{h}{h_0R})^2 R h_0$ with the work done by the pressure $p_0 = h \frac{p}{R h_0}$ yields h in terms of p_0 . Then, (17) and (19) give

Finally, we consider the case of a cylindrical shell, of radius R and thickness h_s , moving over a rigid substrate. Since the shell is thin it can be easily deformed via cylindrical bending without stretching. The bending strain is $\frac{h_s}{R^2}$ so that the elastic energy $R = (\frac{h_s}{R^2})^2 dA$ $\frac{G h_s^3 h^2}{R^3}$. Balancing this with the work done by the pressure $p_0 (\frac{p}{R h_0})^2 \frac{h}{R}$ yields h in terms of p_0 . Then, (17) and (19) give

We note that the above scalings for cylindrical contacts can be trivially generalized to spherical contacts for the case of sm all deform ations, but space precludes us from discussing these in detail.

We conclude with a discussion of how our results may be applied to the lubrication of cartilaginous joints [7, 8], where a thin layer of a uid-lled gel, the cartilage, coats the stibones and mediates the contact between them. Here, electrostatic elects prevent physical contact of the surfaces under high static norm alloads, while elastohydrodynamic elects could enhance separation and thus reduce wear. Inspired by the treatment of cartilage using porcelasticity [7, 9], the continuum description of a material composed of an elastic solid skeleton and an interstitial uid [10], we treat the cartilage layer as an isotropic porcelastic material [16]. The gel can then be described by its uid volum elfaction 0 (1), drained shear modulus G and drained bulk modulus K G, thickness H_1 , permeability k, and interstitial uid viscosity . Using dimensional reasoning, we can construct a porcelastic time scale

which characterizes the time for the di usion of stress over the layer thickness H₁ due to uid ow. Then the response of the gel is governed by the relative size of $_{\rm p}$ to the time scale of the motion, $l=V = {}^{\rm p}\overline{h_0R}=V$. If $_{\rm p}$, the motion is so slow that the interstitial uid plays no role in supporting the load. If $_{\rm p}$, the uid supports some of the load transiently, thereby stiening the gel. Finally, if $_{\rm p}$ the response of the gel will depend on the size of the Stokes' length $l_s = .$ If $l_s = .$

To nd the scale of the de ection and lift force we use the same scaling analysis as for a thin compressible elastic layer but replace G with G_{eff} (), so that (20) yields

where $G_{eff} = 2$ [G; $\frac{h_0R}{H_1^2}$ G]. Inserting characteristic values V = 1 cm/sec, $G = 10^7$ g/sec² cm, $H_1 = 0:1$ cm, R = 1 cm, $h_0 = 10^4$ cm, $\frac{k}{2} = 10^{13}$ cm³ sec/g shows that p, but since H_1 signi cant m aterial stiening is prevented. Consequently, the elective m odulus is G and the scale of the delection is

which suggests that joints could easily operate in a param eter regime that optimizes repulsive elastohydrodynamic e ects. A lthough our estimates are based on non-conforming contact geometries; in realjoints where conforming contacts are the norm, we expect a similar if not enhanced e ect.
