## Quantum Hall fractions in ultracold ferm ionic vapors

We study the quantum Hall states that appear in the dilute  $\lim$  it of rotating ultracold ferm ionic gases when a single hyper ne species is present. We show that the p-wave scattering translates into a pure hard-core interaction in the lowest Landau level. The Laughlin wavefunction is then the exact ground state at  $\lim$  fraction = 1/3. We give estimates of some of the gaps of the incompressible liquids for = p = (2p - 1). We estimate the mass of the composite ferm ions at = 1 = 2. The width of the quantum Hall plateaus is discussed by considering the equation of state of the system.

The preparation and manipulation of ultracold atom ic gases has led to many interesting developments in the study of quantum uids undergoing fast rotation [1, 2]. The Bose-E instein condensates can be set in various rotation regimes with the characteristic response of a superuid. The condensate does not acquire angular m om entum below some velocity threshold. Then there is nucleation of one vortex and with increasing velocity more and m ore vortices are created. They have been observed form ing the Abrikosov triangular lattice [3, 4]. When the rotation frequency reaches the trapping frequency in the radial plane, it has been predicted that quantum Hall fractional states should become ground states of the system [5, 6, 7, 8] if the gas enters a two-dimensional regime. Trapped Fermigases may also exhibit super uidity if they undergo BCS pairing condensation. If the pairing strength is varied, it may be possible to observe the crossover from molecular condensation at strong coupling to BCS phase transition at weak coupling. A possible signature of the super uid paired phase of ferm ions is the peculiar response to stirring, leading again to vortex form ation. In the fast rotation limit, it is thus natural to ask if there is form ation of fractional quantum Hall states as in the Bose case and what are their properties.

In this Letter we investigate the fractional quantum Halle ect (FQHE) appearing in atom ic vapor made of a single hyper ne species of ferm ions. We show that the p-wave scattering between ferm ions can lead to the formation of the Jain principal sequence of FQHE fractions = p=(2p 1), in addition to the celebrated Laughlin wavefunction at = 1=3, as well as a Ferm isea of com posite ferm ions for half-lling of the lowest Landau level (LLL). We give estim ates of the gaps for the incompressible uids governed by the p-w ave scattering length and of the mass of the composite ferm ions. The equation of state of the system seen as the angularm om entum of the ground state as a function of the rotation frequency displays plateaus corresponding to the FQHE uids. Their widths can be estimated by taking into account the nucleation of quasiparticles.

We consider a gas of ferm ionic atoms and suppose that they are set in rotation for example by a stirring external potential [9] that can be applied for som e time to transfer angular m om entum to the gas and then is removed. We are then left with a rotating cloud and we assume that it attains thermal equilibrium in the rotating frame. If H stands for the H am iltonian in the laboratory frame then it becomes H  $_{\rm R}$  = H  $_{\rm L}$  L  $_{\rm Z}$  in the rotating frame where! is the rotation frequency and L  $_{\rm Z}$  the angular momentum along the rotation axis. The H am iltonian describing N particles of mass m in this frame can be written as:

where the xy trap frequency is  $!_0$ , the axial frequency is  $!_z$  and the angular velocity vector is  $!_z$ . For  $!_z$  close to  $!_z$ , the physics is that of charge-e particles in a magnetic eld  $!_z$  eld  $!_z$  corresponding to a magnetic length  $!_z$  h= $!_z$ . We assume the existence of a two-dimensional (2D) regime in which the wavefunction along the z-axis is the ground state of the z-axis harm onic potential.

If we consider a single hyper ne species of ferm ions, then the s-wave scattering is forbidden by the Pauli principle. The next allowed partial wave, the p-wave, leads to much weaker interactions [10] and this leads to diculties when cooling ferm ionic vapors. They can be evaded for example by sympathetic cooling [11] with a dierent atom. However it is also feasible to use a scattering resonance, such as a Feshbach resonance, to dram atically enhance p-wave scattering. This has been demonstrated with 40 K atoms [12]. The scattering even reaches values com parable to s-wave scattering. We will see that this means that FQHE gapped states will have characteristic energies in the same range as for similar bosonic states. At small wavevector, i.e. in the low-energy lim it, the p-wave phase shift of the two-body scattering problem behaves as:

where  $a_1$  denies the p-wave scattering length. As a consequence the scattering amplitude is no longer isotropic:

where is the angle between ingoing and outgoing wavevectors. We now use an elective potential which m im ics the behavior in Eq.(3) when treated in the Born approximation. It is given by:

where the quantities  $r=r_1$   $r_2$  and  $p=\frac{1}{2}(p_1 p_2)$  pertain to the relative particle. The use of such a potential is enough for our purpose since we will study the dynamics of the LLL only: the massive degeneracy is lifted at rst-order in the potential (higher orders involve Landau levelmixing).

We now turn to the quantum Hall regime for ferm ions when ! = !0 in Eq.(1). Assuming a 2D regime with 'z = h=m!z the connement length along z, the interaction potential can be written as  $g_f$  '4 p̂ (2) (r) p̂ where the vectors r and p are now 2D with:

The coupling constant  $g_f$  sets the scale of the FQHE phenom enon.

The interaction  ${\tt H}$  am iltonian in the LLL can be written as:

is an exact zero-energy ground state of the hard-core model. In fact this is the most spatially compact zero-energy state for the hard-core model. It has a well-de ned angular momentum L  $_{\rm Z}$  = 3N (N  $_{\odot}$  1)=2. It corresponds to lling 1/3 of the LLL and thus is the exact

ground state for ultracold ferm ions. This is analogous to the Bose problem [7] where s-wave scattering leads to the Laughlin ground state (with exponent 2) at lling 1/2. It is also known that the hard-core model exhibits the prominent Jain sequence [18] of incompressible uids for llings of the form = p=(2p 1). We have estimated the gaps at some of these fractions by performing exact diagonalizations in the spherical geometry [19, 20, 21]. A sphere of radius R is threaded by a ux 4 R 2B which is an integral multiple (2S) of the ux quantum by Dirac quantization condition. Incom pressible uids appear for special matching of the number of particle vs. 2S.We obtain the low-lying energy levels for a small number of particles and then perform nite-size scaling to obtain estim ations of the therm odynam ic lim it.




Figure 1: Energy gaps for neutral and charged excitations at = 1=3, = 2=5, and neutral gaps for = 3=7. The lines are our best ts and energies are in units of  $g_f$ .

For the most stable uid at = 1=3 the low-lying neutral excited states are dominated by a well-de ned collective density mode and we have obtained the corresponding gap by studying up to N=13 fermions. The gap can also be evaluated from the charged excitations, i.e. the Laughlin quasiparticles. For the p-wave problem, there is the peculiarity that the quasiholes are gapless at = 1=3. It is thus enough to study the quasielectrons that can be nucleated by removing one ux quantum from the reference = 1=3 situation. We not that both estimates scale nicely to a common value'  $0.8\,\mathrm{g_f}$ : see g.(1). For the fraction = 2=5 the gap is '  $0.5\,\mathrm{g_f}$  obtained by the study of systems for N=4...12 fermions. In this case there are the two types of charged excitations, quasiholes and quasielectrons, each having a nonzero gap and we no

that the sum of these gaps converges to a value com patible with the neutral gap. There are fewer available values of the number of particles as we go down the hierarchy and for the next fraction  $\,=\,3\text{--}7$  we estimate the gap to be  $'\,0.4\,g_{\rm f}$  and for 4/9 it is more dicult to give a reliable estimate, the gap is smaller and of the order of  $'\,0.3\,g_{\rm f}$ . For values of the parameters  $`_{\rm Z}$ , ` and  $a_1$  typical of present experiments [3,12] the gaps may be of the order of the nanoK elvin.

For llings less than 1/3, the ferm ion system does no longer display incompressibility because there are proliferating zero-energy states when we increase the angular momentum. Some of these are edge excitations of the droplet and for larger angular momentum they are quasiholes. Due to particle hole symmetry, these very same modes llany gap in the region 1 2=3. The Jain




Figure 2: Energy spectrum for N=9 ferm ions in the spherical geometry at lling = 1=2. The CFs feel zero ux and can be interpreted as form ing a closed shell. The inset shows the scaling of the gap of the closed shell states N=4,9,16. Energies are in units of g and the horizontal axis is total angular m om entum .

sequence has an appealing interpretation in term sofcom posite ferm ions (CF). These entities are naively a ferm ion bound to an even number of ux quanta of a ctitious eld. The total eld acting upon the CFs is then the sum of the external eld and the ctitious eld: when treated in a mean-eld manner this explains the FQHE of electrons as the integer quantum Halle ect of CFs. The Jain sequence has an accumulation point at = 1=2: at this lling the CF experience zero net ux and form a Ferm i liquid like ground state [22, 23]. These CFs have remaining interactions and also an e ective mass m which is entirely due to interactions. To estimate this mass, we use a special matching of the ux 2S = 2(N 1) giving zero net eld on the sphere [24, 25] for the CFs. In the Coulomb case, it has been shown that many features of

the spectrum can be successfully interpreted by reasoning with free CFs, eventually supplemented by second Hund's rule. There are closed shell con gurations when the number of ferm ions is a square:  $N = ('+1)^2$  and 'is thus the total angular momentum of the highest occupied orbital. It is the equivalent of the Ferm im om entum on the sphere and thus we call it  $\footnotemark$  . We expect that the closed shell sequence  $N = ({}^{\cdot}_F + 1)^2 = 4,9,16,...$  display ground states with zero total angular momentum and should have good scaling properties towards the therm odynam ic lim it, as is the case for Coulomb interactions [25, 26]. From a closed-shell con guration one can form particle-hole (ph) excitations: the lowest-lying such excitations is obtained by promoting a ferm ion from the shell with momentum F to the empty shell at momentum  $Y_F + 1$ , leading to a branch extending from L = 1 up to 2'F + 1. Above this branch we should not two-particletwo-hole states extending up to 4'F and so on. This is exactly what we nd for the hard-core model. The low-lying levels of N = 9 ferm ions are displayed in g.2. Above the singlet ground state we clearly identify the two branches predicted by the free CF model.

We can obtain an estimate of the CF mass at = 1=2by using the free CF model [25, 26]. A free CF on the sphere has an energy given by  $E = 1(1+1) = (2m R^2)$ where l is the angular momentum. As a consequence, the gap of the one ph branch is =  $({}^{\prime}_{F} + 1) = (m R^{2})$ . If we x the density the scaling law of the gap becom es N = 4 $N = (m \quad (N)$ 1)). In the spherical geometry we have to take into account the fact that there is a nontrivial shift between the ux 2S and the therm odynam ic  $\lim$  it value N = . For n ite numbers of particles the density is not exactly equal to the therm odynam ic lim it value. Better scaling properties [21] are obtained by rescaling the magnetic length by a factor N = (2S) (going to unity for N ! 1). We thus nd  $_{N} = 4 = m$ N). This scaling is obeyed for the sizes N = 4,9,16 (see inset of g.(2)) and this leads to an estim ate of the e ective m ass:

When the number of ferm ions lie between closed shell values we have checked that the ground state angular momentum is given by second Hund's rule (maximum L), as is the the case for Coulomb interactions [24].

Finally we discuss the width of the Hallplateaus in the case of trapped atom ic vapors. Contrary to the 2D electron systems in sem iconductor devices there is no source of disorder to pin the quasiparticles that are nucleated when we deviate from the ne-tuning of a quantum Hall fraction. The role of disorder is thus played by the nite number of particles of the system and the quantum Hall plateaus are expected to be of vanishingly small width in the therm odynamic limit. We can give precise estimates by considering the equation of state of the rotating sys-

tem, i.e. the value of the ground state angular m om entum as a function of the rotation frequency hLzi(!). At the critical frequency, the Hamiltonian is rewritten as a magnetic eld problem (see Eq.(1)). If the frequency is !, then we have the small eld slightly less, ! 0 acting upon the purely magnetic problem. It leads to a trivial shift of the energies of the FQHE problem that will change the ground state when increased. This is seen from the typical spectrum displayed in g. (3) in the condition of the critical rotation. The Laughlin state at  $L_{\pi}^{Laughlin} = 3N$  (N 1)=2 is the ground state and the rst excited state is the quasielectron at L<sub>z</sub> aughlin with a nonzero gap ge. When adding a the Laughlin will remain the ground state till the quasielectron energy becomes lower for a critical value equal to:

If we increase! beyond this value, quasielectrons are nucleated forming a uid that will condense into a new FQHE uid. We expect the result above in Eq.(9) to be generic. This picture is essentially dual to the nucleation of vortices at small rotation frequency [3].




Figure 3: Energy spectrum for N = 5 ferm ions in the disk geom etry as a function of the angularm om entum . The Laughlin state is the unique zero-energy state at  $L_{z}=30\,$ . The lowest-energy state at  $L_{z}=25$  is the quasielectron with a nite gap.

We have shown the appearance of the Jain principal sequence of quantum Hall fractions in ultracold rotating ferm ionic vapors. The composite ferm ion picture gives a successful account of the observed fractions as well as their collective mode excitations. The gaps we estimate from exact diagonalizations are of the order of  $h^2 a_1^3 = m \cdot_z v^4$ . At half-lling of the lowest-Landau level, there is a Ferm i liquid-like state of composite ferm ions and their elective mass m = m is controlled by  $v^2 \cdot_z = (a_1^3)$ .
