System atic study of the two band/two gap superconductivity in carbon-substituted M gB₂ by point-contact spectroscopy

Point-contact m easurements on the carbon-substituted M g(B₁ $_x$ C_x)₂ lament/pow der sam ples directly reveal a retention of the two superconducting energy gaps in the whole doping range from x = 0 to x = 0.1. The large gap on the -band is decreased in an essentially linear fashion with increasing the carbon concentrations. The changes in the the smallgap up to 3.8 % C are proportionally smaller and are more di cult to detect but for the heavily doped sam ple with x = 0.1 and $T_c = 22$ K both gaps are still present, and signi cantly reduced, consistent with a strong essentially linear, reduction of each gap with the transition temperature.

The MgB₂ superconductor [1] represents a challenge for both technological relevance and fundam ental science. Its relatively high transition tem perature is due to the interference e ect between the and bands with respectively strongly and weakly coupled Cooper pairs, and respectively large and small superconducting energy gaps. This theoretical two-gap scenario [2,3] has now been supported by m any experim ents [4{11]. P rospects for applications of M gB₂ depend on a success in increasing the critical parameters such as the upper critical eld and critical current. For that the material must be driven from the clean superconducting limit to the dirty one. The possibility of selective tuning the and intraband scatterings seems to be the way of accomplishing this [12,13]. This can be realized, for example, via the substitution of a constituent elem ent, such as boron by carbon. An undesirable side e ect m ay be a signi cant increase of the interband scattering, presum ably leading to m erging of the two gaps and, as consequence, to a substantial decrease of the transition tem perature [2]. P revious studies $[14\{16\}$ on the heavily doped M gB₂ by 10 % of carbon $(T_c = 22 \text{ K})$ have shown a presence of the small energy gap with 2 = $k_B T_c$ 1.6, the same relative strength as for the gap in the -band of the undoped system, incom patible with the single-gap scenario. + SR experiments have been performed on the carbon doped MgB2 with T_c's from 38.3 K down to 34.8 K [17]. The deduced gaps and showed a linear decrease with increasing the

carbon content and T_c , but for the samples with T_c 36.1 K the reduced value of the large gap 2 =k $_B T_c$ was below the BCS weak-coupling value 3.52.

Here we present a system atic study of the two-gap superconductivity in carbon-doped M g(B₁ $_{\rm x}$ C_x)₂ laments with the carbon content x = 0,0.021 and 0.038 and additional experiments on the powder sample with x 0.1. The Andreev rejection spectra on the laments show two very well resolved superconducting energy gaps. The

large gap on the -band is decreased with increasing the carbon concentrations, whereas the changes in the sm aller gap are proportionally sm aller and, for these low carbon concentrations, di cult to resolve. For the more heavily doped sam ple with x 0:1 and $T_c = 22 \text{ K}$, the broadening of the Andreev re ection spectra makes a direct detection of the large gap di cult but we succeeded in detecting it by careful measurement at 1.6 K.Our identication of the large gap was con med by the use of an in-magnetic eld experiment where the small gap contribution can be partially suppressed and the large gap revealed. The large gap can also be extracted from the analysis of the speci c-heat data [14]. In the 10 % C doped samples both gaps are detected and both gaps scale linearly with the suppression of T_c. The temperature dependencies of the large and sm all gaps indicate that the interband coupling is not signi cantly changed upon the doping in the whole concentration range.

W ire segments of carbon-substituted M gB₂ were synthesized from carbon doped boron laments made by chem ical vapor deposition. The boron and carbon were co-deposited to form a ber of about 75 m diameter. $M q (B_1 x C_x)_2$ laments were made by exposing the bers to M g vapor. M ore details about preparation are given elsewhere [12]. X-ray di raction shows the M gB₂ phase and Mg lines. No traces of MgO and B_4C have been found. No measurable changes in the c-axis lattice param eter were detected, whereas the measured changes of the a-axis lattice parameter a (x) were used to determ ine the carbon concentration by com parison to A vdeev et al. neutron diffraction [18] on x 0:1 samples of $M g (B_1 x C_x)_2$. The resulting carbon concentrations are x = 0, 0.021 and 0.038. The quality of the samples is evidenced by a single step and narrow transitions to superconducting state in m agnetization and resistivity with $T_c = 39,37.5$ and 36.2 K de ned at the onset of the superconducting state with T_c 0.3 K between 10 and 90

% of the norm al state resistivity. The resistivity of the wires increases from 0.5 cm for the undoped system to about 10 cm for 3.5 % C .M g (B $_{0:9}C_{0:1})_2$ with $T_c=22$ K in the form of pellets were prepared following the procedure described in Ref. [14] from magnesium lumps and B₄C powder. Traces of B₄C were not visible in the XRD patterns. Sm all am ounts of two in purity phases (M gO and M gB₂C₂) resulted even with optimization of the synthesis.

Point-contact measurements on the wire segments have been performed in a "reversed" conguration -with the Mg(B₁ $_xC_x)_2$ wire as a tip touching softly a bulk piece of electrochemically cleaned copper. In the experiments on bulk Mg(B_{0.9}C_{0.1})₂ samples a tip was (electro) chemically formed from copper, platinum or silver wires. A special point-contact approaching system with a negligible thermal expansion allows for temperature dependent measurements up to 100 K.A standard lock-in technique at 10 kHz was used to measure the di erential resistance as a function of applied voltage on the point contacts. The microconstrictions were prepared in situ. The approaching system enabled both the lateral and vertical movements of the tip by di erential screw mechanism.

The point-contact spectrum - di erential conductance versus voltage between a metal and a superconductor can be compared with the Blonder, Tinkham and Klapwijk (BTK) theory using as input param eters the energy gap , the parameter z (measure for the strength of the interface barrier with transmission coe cient $T = 1 = (1 + z^2)$ and a param eter for the quasi-particle lifetim e broadening [19]. In the case of the M gB $_2$ two-gap superconductor the overall conductance can be expressed as a weighted sum of the partial BTK conductances from the quasitwodimensional -bands (with a large gap) and the 3D -bands (with a small gap) + (1) The weight factor for the gap contribution can vary from 0.65 for the tunneling/point-contact current strictly in the M gB₂ ab-plane to 0.99 of c-axis tunneling [20]. Indeed, the tunneling experiments on single crystalline $M qB_2$ [10] have proved that the sm all gap on the -band is observed for any tunneling direction while

is observable only for signi cant ab-plane tunneling com ponent.

Extensive m easurements on tens of pieces of w ire segments and bulk doped M gB₂ have been performed. The point-contacts revealed di erent barrier transparencies from more metallic interface with z = 0.4 up to an intermediate case between metallic and tunneling barrier with z = 1.2. Crystallites in the wire segments have a size up to tens of microns. For such large crystallites, the point-contacts yield an information on a particular single crystal at the junction, but of unknown orientation. By trial and error we looked for the junctions where the both gaps would be present. A large number of the "two-gap" spectra on M g (B₁ $_x$ C_x)₂ w ires of x = 0,0.021 and 0.038 carbon concentrations have been recorded. For the pre-

sentation and analysis we have chosen those with a sm all broadening i, typically less than 10 per cent of respective gap i. In accordance with the previous report [15] the most of the spectra on M $q(B_{0.9}C_{0.1})_2$ revealed apparently only the small energy gap . The broadening parameter was in this case at least 20 per cent of the gap value. Larger scattering rates and inhom ogeneities in the heavily doped M g ($B_{0:9}C_{0:1}$)₂ are probably the main reason preventing as easy of a direct detection of the large gap, here. Since the point-contact spectroscopy is a surface sensitive technique it is sensitive to a possible surface proximity e ect with correspondingly suppressed T_c. Form ost of the junctions the particular T_c has been checked: in all cases the point-contact transition tem perature agreed with the bulk T_c . In addition, as it will be shown below, both gaps close near the bulk T_c .

Figure 1 shows characteristic examples of the norm alized conductance-versus-voltage spectra (full lines) obtained on the $Mg(B_1 x C_x)_2$ -metal junctions. All displayed point-contact conductances have been norm alized to the conductance in the norm alstate at $T > T_c$. The ts to the spectra by the two-gap BTK form ula are shown by open circles. As can be seen the spectra on the wires with the lower carbon-concentrations - up to 3.8 % C reveal very well resolved two superconducting energy gaps with small intrinsic broadening. The upper spectrum was obtained on the more heavily doped, 10 % C, powder sample. To achieve better resolution this spectrum is m easured at 1.6 K, whereas the others were m easured at 4.2 K.A one-gap t to this spectrum is shown as well (by the open triangles). O by iously, the two-gap form ula ts the spectrum better. Thus, the spectrum represents one of a few examples indicating a presence of the large gap in M qB_2 with 10 per cent of carbon.

W hereas we are able to detect the larger gap in the 1.6 K tunnelling spectra of the M g (B $_{0:9}C_{0:1}$)₂ sam ple, it is not as unambiguously resolved as in the lower doped sam ples. Our identi cation of the larger gap is strongly supported by in-eld tunneling measurements. In the Fig. 2 the spectrum on the 10 % C M gB₂ sample is shown in magnetic eld. In the spectrum recorded at zero magnetic eld the shoulder originating from the second large gap is not very pronounced and we have to rely on the t showing that the two gap form ula works better than the one-gap t. But a nite magnetic eld partially suppresses the contribution from the -band, with a sm aller gap, and m akes a presence of the large gap from the -band more conspicuous. This is a well known effect in MgB₂ which we detected in our original paper on the two-gap superconductivity in pure M gB₂ [6]. Here, in a very sim ilar way it helps to further reveal the existence of the large gap : appearing as m ore and m ore clearly de ned shoulder, best seen in the spectrum taken at B = 0.7 Tesla. At even higher elds the intensity of the -band contribution is suppressed so that the and peaks interfere to the single maximum, which is located

indeed at higher voltages [21] than the original maximum of the prevailing band spectrum at B = 0. Data such as these are further evidence of the clear persistence of two superconducting gaps in Mg(B₁ _xC_x)₂ even at x = 0.1 levels.

To obtain further information on the large energy gap

in the heavily doped M g(B_{0:9}C_{0:1})_2, an analysis of the electronic speci c heat on the data from R ibeiro et al. [14] was performed within the frame work of the -m odel as proposed for M gB_2 by Bouquet et al. [4]. A typical jump at $T_{\rm c}$ from the large energy gap was seen as well as an excess weight at low tem peratures as a hint of the small energy gap -. Even, if this is an indirect m ethod the resulting gaps are indicated as asterisks in Fig. 3 and are in good agreement with the direct point-contact determ ination of the gaps.

Figure 3 shows the overall statistics of energy gaps which have been obtained from analysis done on about 15 best resolved spectra for each carbon concentration, except for the 10 % C substituted M gB₂ sam ple, where we only two junctions revealed the large gap. The widths of the bars indicates the error in determ ination of the energy gap associated with the thing to the BTK model. The double peak distribution of the large and sm all gaps well covers the gap sizes given by most of the tunneling and point contact data on the pure $M gB_2$ [6,8{10,22}]. Due to distribution of the two gaps better com parison can be made with the sim ilar histogram s obtained from the M gB₂ point-contact data by N aidyuk et al. [23] and Bugoslavsky et al. [24]. Good agreem ent is found am ong those m easurem ents. There is also a possibility to m ake comparison with the distribution of the gaps on the Ferm i surface calculated by Choi et al. within the fully anisotropic E liashberg form alism [3]. Matrinez-Samper et al. [9] even tted directly their particular tunneling spectra with a distribution of gaps showing two maxima around 2.5 and 7 m eV. But recently M azin et al. argued that to see directly more than two gaps in the spectrum or even whole distribution would require extrem ely sm all, unrealistic and intraband scattering rates [25]. Thus, this particular question of the gap distribution around two maxim a asks for further studies. Nevertheless, even with the presented gap distributions one can see clearly the e ect of the carbon doping on the gaps.

In Fig. 4 the gap energies as a function of T_c are presented. The circles are positioned at the averaged energies of the gap distributions in Fig.3 and the error bars represent the standard deviations of the distributions. Broadly, the tendency of the evolution of two gaps in M gB₂ with carbon doping seems to be almost linear with both gaps disappearing (as extrapolated) simultaneously at $T_c = 0$. M ore data is needed to address possible non-linearity at low carbon content and to more precisely determ ine the point where two gaps merge to one or disappear (the error bars on the data presented in Fig. 4 support a merging of the two gaps for 0 K T_c 10

K). The inset to Fig. 4 with the reduced gaps 2 =k $_{\rm B}$ T $_{\rm c}$, shows that already for the small carbon concentrations there is a tendency to merge both gaps. Despite this tendency, on the samples with 10 per cent of carbon doping and T $_{\rm c}$ = 22K the two-gap superconductivity is still clearly retained as presented by the norm alized gaps 2 =k_B T_c ' 3:6 and 2 =k_B T_c ' 1:6.

The tem perature dependence of the large and sm all energy gaps and from the point-contact spectra on Mg ($B_{1} \times C_{x}$)₂ samples with di erent carbon concentrations are shown in Fig. 5. One can notice that the shape of the tem perature dependence of both gaps does not show any obvious change due to a di erent carbon concentration. As m entioned already by Suhlet al. [26], the shape of the tem perature dependence of the sm all gap is related to the measure of the interband coupling. If it was too small the small energy gap would tend to close at tem peratures much below the bulk T_c with a tail to T_c . In the case of pure M gB2 the tem perature dependence of the sm all gap slightly undershoots the BCS line [6] in line with the predictions of Liu et al. [2]. Within the shown error bars in Fig. 5 we can conclude that the interband coupling is not changed by the carbon doping.

The theoretical calculations have shown that due to a very di erent k-space distribution of the and bands, the only route to increase the scattering is via interlayer hopping, from a p_z orbital (-band) in one atom ic layer to a bond orbital (-band) in another layer [27]. But no changes in the c-lattice parameter which could help the interlayer charge transfer in carbon substituted sam ples in comparison with the pure M gB₂ were detected [12]. Recent theoretical modelling also corroborates that carbon doping is not favorable for increased interband scattering [28]. W hat is then the reason for a signi cant decrease of the transition tem perature to $T_c = 22 \text{ K}$ at 10 % C doping? The transition tem perature is determ ined by the characteristic phonon frequency, the strentgh of the electron-electron coupling and the density of the conduction electrons. Due to hole -band lling the density of states can be decreased by carbon substituting boron. M asuiet al. have detected hardening and narrowing the E_{2q} phonon modes by R am an scattering [29] which can have a dram atic e ect on the strength of the cooper pairs coupling in the -band. Decrease in the density of states at the Ferm i level was suggested by band structure calculations [30] and observed through m easurem ents of heat capacity [14]. A lso a signi cantly low eranisotropy in H _{c2} [14] in heavily carbon doped com pound in plies that the -band Ferm i surface is not nearly so 2D as in the pure $M q B_2$.

In conclusion, we have obtained an experimental evidence for existence of the two-gap superconductivity in the carbon-substituted M gB₂ for all C concentrations from 0 to about 10 per cent with $T_c^{0}s$ from 39 down to 22 K. The both gaps are closing near the bulk critical tem perature of the respective sample. The tem perature

dependence of the gaps indicates no changes in the interband coupling which could eventually lead to de nite m erging of the gaps.




FIG.1. Full lines $-Mg(B_1 x C_x)_2$ point-contact spectra at T = 42 K (except for the top spectrum recorded at 1.6 K).0 pen circles - tting for the therm ally sm eared BTK model for two gaps. Open triangles for x = 0.1 curve - t to the one-gap BTK form ula. The upper curves are vertically shifted for the clarity. The arrows indicate a development of the gaps with increasing carbon content.




FIG.2. Mg($B_{0:9}C_{0:1}$)₂-Cu point-contact spectrum at 1.6K (shown in Fig.1) recorded at di erent magnetic elds. Partial suppression of the small gap contribution helps in revealing the large gap (see the text). The curves at nite eld are shifted down for clarity.




FIG.3. D istribution of the superconducting energy gaps of M g (B_{1 x}C_x)₂ as obtained from num erous point-contact junctions on di erent samples of the particular C concentration. A sterisks – the gaps obtained from analysis of the speci c heat [14].




FIG.4. Superconducting energy gaps from point-contact experiments at lowest temperature as a function of T_c . The points – average energy of the particular gap distribution shown in Fig.3. The error bars – the standard deviations in the distributions. A sterisks – deduced from analysis of the speci c heat measurement (see text). Lines are guide for the eye.




FIG.5. Tem perature dependence of the energy gaps of M $g(B_1 \ _x C_x)_2$ determ ined from the tting of the point-contact spectra. Full lines represent the BCS prediction scaled to the and gaps.
