Dynamical Exchange E ects in a Two-D im ensional Many-Polaron

Abstract

We calculate the in wence of dynam ical exchange e ects on the response properties and the static properties of a two-dimensional many-polaron gas. These e ects are not manifested in the random-phase approximation which is widely used in the analysis of the many-polaron system. Here they are taken into account by using a dielectric function derived in the time-dependent Hartree-Fock formalism. At weak electron-phonon coupling, we not that dynamical exchange e ects lead to substantial corrections to the random-phase approximation results for the ground state energy, the e ective mass, and the optical conductivity of the polaron system. Furthermore, we show that the reduction of the spectral weight of the optical absorption spectrum at frequencies above the longitudinal optical phonon frequency, due to many-body e ects, is overestimated by the random-phase approximation.

I. IN TRODUCTION

A lthough the static and dynam ic properties of a single polaron have been [1,2] (and still are [3]) extensively studied, the properties of an interacting polaron system, e.g. their optical absorption [4,5], are less well understood. Thus far, the many-polaron system has been studied mainly in the Hartree-Fock approximation and in the random-phase approximation (RPA) [6{9], even though in Ref. [10] it was shown that in three dimensions (3D) the polaron energy and elective mass are in uenced by screening elects beyond RPA. In this paper, we investigate dynamical exchange elects in both static properties (energy and elective mass) and response properties (optical absorption) of the two-dimensional (2D) polaron system.

However, although our form alism is appropriate for the description of an interacting electron (or polaron) gas, it does not allow to investigate the 2D W igner solid phase form ed for example by electrons on a helium surface. Also the study of the many small-polaron gas and bipolarons in quasi-2D systems such as the copper oxide planes in high- $T_{\rm c}$ cuprate superconductors [11{14} lies beyond the scope of our approach in its current form.

A convenient form alism to take into account many-body e ects in the polaron system relies on containing these e ects in the structure factor [6]. This approach, rem iniscent of the Feynman-Bijl treatment of super uid helium -4, was rst developed to calculate the ground state energy of a many-polaron system [6], and has later been applied to the optical absorption of this system [15]. The 2D dynam ic structure factor can be written as

with $v_q = e^2 = (2 \, \text{"}_1 \, \text{q})$ the Fourier transform of the bare Coulomb interaction in 2D, n the surface density of charge carriers, "_1 the dielectric constant at high frequency, and "(q;!) the dielectric function of the system of charge carriers. Previous work [6{9,15] relied on the RPA dielectric function:

where Q_0 (q;!) is the 2D Lindhard polarizability and is known in closed form [16]. A more accurate result for the dielectric function is obtained by introducing the frequency dependent local eld correction G (q;!):

In the 3D case, the local eld correction was derived in the framework of the dynamical exchange decoupling (DED) method [17]. This method, based on the time-dependent Hartree-Fock formalism, was recently extended to the 2D case in Refs. [18,19]. This leads to an improved dielectric function, "DED (q;!), that can be used to include dynamical exchange e ects in the analysis of the many-polaron system. The DED result for the dielectric function is markedly dierent from the results obtained in the RPA formalism, Hubbard's formalism [20] and the formalism of Singwiet al. [21]. In 3D these dierent approaches can be compared to experiment: measurements of the dynamic local eld correction by Larson and co-workers [22] have shown that the 3D DED approach [17] leads to superior results.

In this work, we use the DED dielectric function in combination with the formalism describing the many-body e ects in a polaron system through the structure factor. In section II, we investigate the dynamical exchange e ects on the optical absorption of the many-polaron system. From the optical conductivity the e ective mass of the polaron as a function of the density is derived through a sum-rule in section III. Finally, in section IV, the ground state energy of the interacting polaron system is calculated beyond RPA. As we shall show, including dynamical exchange e ects leads to non-negligible corrections to all these quantities.

II.OPTICAL ABSORPTION OF THE INTERACTING 2D POLARON SYSTEM

The optical absorption of an interacting system of Frohlich polarons in the weak-coupling regime was investigated in [7,15]. The optical conductivity in 2D is given by [15]

where e is the electron charge, !LO is the longitudinal optical (LO) phonon frequency and is the dimensionless Frohlich coupling constant determining the strength of the electron-phonon interaction. Note that a delta-function peak at ! = 0; om itted in (4), is present in the optical absorption. The in wence of the Fermi statistics and the screened Coulomb interactions between the electrons are taken into account through the structure factor S_{2D} appearing in expression (4). Thus far, the electron-electron interactions on the optical absorption of a many-polaron gas has been investigated only in the fram ework of RPA [7,15,23]. Nevertheless, expression (4) is not restricted to the RPA approximation: any form of the dynamic structure factor can be introduced in the integrand. Here, we will use the results obtained for the dielectric function in the DED formalism [19] instead.

U sing expression (1) and the DED result for the dielectric function, we can rewrite (4) as

where now $k=q=k_F$ and $v=h!=(2E_F)$ are dimensionless wave numbers and frequencies based on the Ferm iwave vector k_F and the Ferm ienergy E_F , respectively. The prefactor

contains m aterial constants (the band m ass m $_{\rm b}$, the LO phonon frequency ! $_{\rm LO}$ and the high-frequency perm ittivity $^{\rm u}_{\rm l}$) and has dimensions of optical conductivity. Expression (5) for the optical absorption allows to easily substitute available results for the dielectric function.

The DED structure factor can be interpreted as a sum of two contributions, namely a contribution from the single-particle excitations (the Landau continuum) and a contribution from the plasm on excitations. We can write

where $_{\rm LO}$ is the LO phonon frequency in units of $2E_{\rm F}$ =h and $_{\rm pl}(k)$ is the plasm on dispersion de ned by " $(k;_{\rm pl})$ = 0. The plasm on excitations in our approach lead to delta-functions, with a strength $A_{\rm pl}(k)$, in the frequency dependence of the structure factor. A lso the optical conductivity can be separated in a contribution due to the single-particle excitations and a part coming from the plasm on branch:

Here, k_0 is the wave vector at which $k_0 = k_0$, and k_0 = k_0 = k_0 is the derivative of the plasm on frequency with respect to the wave vector. In the 2D electron gas, the plasm on branch k_0 lies close to the edge of the Landau continuum, k_0 =2 + k_0 . Figure 1 compares the plasm on dispersion in the DED approach to the dispersion in the RPA approach for several values of k_0 . For small k_0 values the plasm on frequency in DED is lower than in RPA. Furthermore, in DED longer wave length plasm ons are present. The oscillator strength k_0 of the plasm on branch can be obtained straightforwardly using the f-sum rule. If we substitute (7) in the f-sum rule,

we can indian expression for the oscillator strength of the plasm on branch:

is the rst frequency moment of the Landau continuum contribution only. In Figure 2, we compare the oscillator strength of the plasm on branch in RPA and DED for several values of r_s . At small k the dierence between the strength of the plasm ons in RPA and DED is negligible. As k increases, a dierence appears: the maximum oscillator strength for the plasm on branch in DED is reached at a smaller wave vector. Compared to RPA, the oscillator strength of the DED plasm ons shows a long tail as a function of k.

In Figure 3 the optical absorption due to the plasm on contribution is shown for several relevant values of the density n of a two dimensional polaron gas, using the material param eters for GaAs (" $_1$ = 10.8, m $_b$ = 0.0657 m $_e$, h! $_{LO}$ = 36:77 meV, $a_{B\,\rm ohr}$ = 8:78 nm). The presence of the shorter wave length plasm ons in DED as compared to RPA shifts the spectral weight to higher frequencies. Nevertheless, both in RPA and DED the contribution of plasm ons to the optical absorption of the many-polaron gas is small in comparison with the contribution of the single-particle excitations. The total optical absorption is shown in Figure 4, again for dierent surface densities of polarons in GaAs. Although the Landau continuum occupies the same region of the fk; g-plane in the DED and RPA approaches, the spectral weight of the structure factor is distributed dierently. As can be seen in Figure 4, this leads to a measurable dierence between the DED and RPA results. Comparing both the DED and RPA optical absorption with the single-polaron absorption [24], we not that the RPA result overestim ates the damping due to many-body elects.

III.EFFECTIVE MASS OF THE POLARON IN DED

From Figure 4, it is clear that the spectral weight of the optical absorption in the region beyond the single-phonon gap (! > $!_{LO}$) is different for each of the approaches (DED, RPA and single-polaron). This may seem surprising at rst glance, since the f-sum rule imposes that the total spectral weight is a constant:

It is important to keep in m ind that the optical absorption of the polaron system shows a delta-function in the origin (! = 0), not shown in Figure 4. The total spectral weight is distributed between this delta-function peak and the optical absorption spectrum beyond the single-phonon gap [25]. The spectral weight of the delta-function is related to the polaron e ective mass m in such a way that [25]

Thus, a change in the spectral weight allotted to the ! > ! LO region of the optical conductivity indicates a change in the electron mass of the polarons. The electron-phonon coupling increases the electron assofa single polaron by m = m m_b . The well-known single-polaron result for this electron mass increase in 2D is $m = m_b = -8$. In Figure 5, we show the electron assoincrease $m = (m_b) = (m_b) = (m_b) = as a function of the surface density of polarons in G aAs. Both the RPA result (dashed curve, cf. [7{9,26}) and the DED result (full curve) approach the one-polaron result in the limit of small density. As the surface density of polarons increases, <math>m_b = -8$. The vertex of polarons in C aAs. Both the RPA result in the limit of small density. As the surface density of polarons increases, $m_b = -8$.

The fractional change $\,$ m $\,_{D\,ED} = \,$ m $\,_{R\,PA}$ is shown in the inset of Figure 5, and indicates that there is roughly a 15% di erence between the e ective mass increase predicted by DED and that predicted by RPA. This is consistent with the increase in spectral weight of the

optical absorption at ! > $!_{LO}$ in DED as compared to RPA: if less spectral weight is present in the region ! > $!_{LO}$, the delta-function in the origin must carry more spectral weight, indicating an increase in elective mass.

IV.GROUND-STATE ENERGY OF THE INTERACTING 2D POLARON SYSTEM

A general expression for the ground state energy per particle of an interacting polaron gas at weak coupling was derived in Ref. [6]:

In this expression $E_{\rm el}$ is the energy contribution per particle of the system of charge carriers, without electron-phonon coupling, and the second term is the polaron contribution. The 2D Frohlich interaction amplitude appearing in this expression is

with A the surface of the 2D system. Whereas the optical conductivity depends on the dynamic structure factor, the ground state energy depends on the static structure factor

Expressed in dimensionless variables for the wave number and the frequency, this is

A comparison between the static structure factor in RPA and DED is shown in Figure 6. A round k=2; the DED static structure factor shows a transition to the long wave length behavior [18,19].

The shift in ground state energy perparticle due to the electron-phonon coupling $E_{pol} = E()$ E(=0) is given by [6]:

with $= k_F = k_{LO}$ and $k_{LO} = \frac{q}{2m_b!_{LO} = h}$. The result for the polaronic shift in the ground state energy per particle, as a function of the W igner-Seitz radius r_s , is shown in Figure

7 for di erent approaches. The material parameters for GaAs were used for this gure. If no many-body elects are taken into account, the 2D polaronic energy per particle is (=2) h! $_{\rm LO}$ in the weak coupling regime. If many-body elects are taken into account on the level of the Hartree-Fock approximation, we get a monotonous decreasing energy as $r_{\rm s}$ increases, while the RPA approximation leads to a minimum in the polaronic energy at $r_{\rm s} = 1.59$, with E=N = 0.70 h! $_{\rm LO}$. We not that including dynamical exchange elects lowers j E $_{\rm Pol}$ jw ith respect to RPA, and shifts the energy minimum to slightly lower density: $r_{\rm s} = 1.61$, where E=N = 0.77 h! $_{\rm LO}$. So, using an improved dielectric function as compared to RPA leads to a change of ca. 10% in the ground state energy.

V.CONCLUSIONS

E orts to describe m any-body e ects in the polaron system have thus far relied strongly on the RPA approach [6{9,23,15}], even though there have been indications that inclusion of a static local eld correction modi es the ground state energy and the e ective mass of the polarons [10]. In this paper, we use a dielectric function that includes a frequency-dependent local eld correction derived in the time-dependent Hartree-Fock formalism [17{19}]. We not that taking into account dynamical exchange e ects reveals important corrections at weak coupling to the optical absorption of the polaron system, the elective mass of the polarons and the ground state energy of the polaron system. In GaAs, estimates of the elective mass based on RPA are roughly 15% of from the improved results, estimates of the ground state energy dier roughly 10%. Furthermore, we show that in the optical absorption, RPA considerably overestimates the reduction of spectral weight due to the many-body elects.
