A Generalized Epidem ic Process and Tricritical Dynam ic Percolation

The renowned general epidem ic process describes the stochastic evolution of a population of individuals which are either susceptible, infected or dead. A second order phase transition belonging to the universality class of dynamic isotropic percolation lies between endemic or pandemic behavior of the process. We generalize the general epidem ic process by introducing a fourth kind of individuals, viz. individuals which are weakened by the process but not yet infected. This sensibilization gives rise to a mechanism that introduces a global instability in the spreading of the process and therefore opens the possibility of a discontinuous transition in addition to the usual continuous percolation transition. The tricritical point separating the lines of rst and second order transitions constitutes a new universality class, namely the universality class of tricritical dynamic isotropic percolation. U sing renormalized eld theory we work out a detailed scaling description of this universality class. We calculate the scaling exponents in an "-expansion below the upper critical dimension $d_c = 5$ for various observables describing tricritical percolation clusters and their spreading properties. In a rem arkable contrast to the usual percolation transition, the exponents $\,$ and $\,$ 0 governing the two order param eters, viz. the m ean density and the percolation probability, turn out to be di erent at the tricritical point. In addition to the scaling exponents we calculate for all our static and dynam ic observables logarithm ic corrections to the mean-eld scaling behavior at $d_{\text{c}}=$ 5.

I. INTRODUCTION

The form ation and the properties of random structures have been a major them e in statistical physics for many years. In case the form ation of such structures obeys local rules, these processes can often be expressed in the language of population growth. It is well known that two particular growth processes lead to random structures with the properties of percolation clusters. The so called sim ple epidem ic process (SEP) leads to directed percolation (DP) [1, 2, 3, 4]. The SEP is also known as epidem ic with recovery, Gribov process [5, 6], as the stochastic version of Schlogls rst reaction [7,8] or in elementary particle physics as Reggeon eld theory [9, 10, 11]. The so called general epidem ic process (GEP) [12, 13, 14], also known as epidem ic with removal, generates isotropic percolation (IP) clusters [15, 16, 17, 18] and models therefore the universality class of dynam ic isotropic percolation (dIP).

Epidem ic models like the SEP and the GEP are relevant for a wide range of systems in physics, chem istry, biology, and sociology. Undoubtedly, the potential of such simple models has its limitations because they rely on strong simplifying assumptions such as the homogeneity of the substrate [19], isotropy of the infections, in mobility of individuals and so on. However, the transition between population survival and extinction of these processes is a nonequilibrium continuous (second order) phase transition phenomenon and hence is characterized by universal scaling laws which are shared by entire classes of systems. Near these transitions, simplistic

epidem ic models like the SEP and the GEP are of great value, because they are powerful workhorses to study the mutual properties of their entire universality class which also should include more realistic models.

The universal properties of DP and dIP are well known today thanks to numerous studies of the SEP and GEP, respectively. Relatively little is known, on the other hand, whether and under what modi cations these stochastic growth processes allow for rst order phase transitions between their endem is and pandem is states, and by the same token, for tricritical behavior at the phase-space boundary between rst and second order transition. In the context of DP, these questions where addressed to some extend by Ohtsuki and Keyes [20]. In this paper we will study this intriguing topic in the context of dIP by generalizing the famous GEP.

The standard GEP, assumed for simplicity to take place on a lattice [15], can be described with help of the reaction scheme

with reaction rates and .S, X, and E respectively denote susceptible, ill, and dead (or im m une) individuals on nearest neighbor sites n and m. A susceptible individual m ay be infected by an ill neighbor with probability [reaction (1.1a)]. By thism echanism the disease (henceforth also called the agent) spreads di usively. Ill individuals die with a probability [reaction (1.1b)]. There is no healing of infected individuals and no spontaneous infection. In a nite system the manifold of states without

any infected individual is inevitably absorbing. Whether a single infected site leads to an everlasting epidem ic in an in nite system depends on the ratio = . With xed there is a certain value = $_{\rm C}$ that for all > $_{\rm C}$ an etemal epidem ic (a pandem ic) occurs. The probability P () for the occurrence of a pandem ic as a function of goes to zero continuously at the critical point $_{\rm C}$. The behavior of the model near this critical point is in the universality class of dIP .

Of course, one can conceive many alterations of the GEP. Som e m odi cations will lead to m odels which still belong to the dIP universality class whereas other alterations will produce models belonging to other universality classes. As an example for the latter, one might think of mobile susceptible or immune individuals which, say, di use through space. The resulting models are reactiondi usion type models which have nothing to do with dIP [21]. We are not interested in this kind of alterations. Rather, we are interested in modi cations of the GEP that preserve the dIP universality class and which, for certain param eter values, allow for tricriticality and rst order percolation transitions. To be more specic, we are interested in the most relevant mechanism leading to tricritical and rst order d.P. In spirit our model is closely related to the canonical model for tricriticality in eqilibrium systems, viz. the 4 model with an additional 6 term where the free energy density is of the form $f = {}^{2} + g_{4} + g_{6}$ [22]. If g_{4} is positive then higher order terms including the $\,^{6}$ term are irrelevant and one has in mean eld theory a second order transition when passes through zero. O therwise, however, one has an instability and higher order terms are required for stabilization of which the 6 term is the most relevant one. For $q_4 < 0$ one has a stronger transition at a critical value of that depends on quand quand the point $= g_1 = 0$ constitutes a tricritical point. Our model to be de ned in the next paragraph is so that it introduces a sim ilar instability in the GEP and via this instability it allows for tricriticality and st order percolation. In its eld theoretic description our model features, compared to the standard GEP, an additional higher order term which becomes the most relevant stabilizing term when the usualGEP coupling vanishes.

Our modi cation of the GEP can be de ned in simple terms. The basic idea is to enrich the reaction scheme (1.1) by introducing weak individuals Y. Instead of being infected right away by an ill neighbor, any susceptible individualm ay be weakened with a reaction rate

by such an encounter. When the disease passes by anew, a weakened individual is more sensitive and gets sick with a rate $\,>\,$. In the following we refer to this model as the generalized GEP (GGEP). In addition to the reactions (1.1), the GGEP is described by the reactions

As we go along, we will show that the occurrence of the

weak individuals gives rise to an instability that can lead to a discontinuous transition and compact (E den [23,24]) grow th of the epidem ic if is greater than a critical value $_{\rm c}(\ ;\)$. In the enlarged three-dimensional phase space spanned by , , and with xed , there exists a critical surface associated with the usual continuous percolation transition and a surface of rst order transitions characterized by a nite jump in the probability P (;;) for the occurrence of a pandem ic. These two surfaces of phase transitions meet at a line of tricritical points.

The focus of this paper lies on the universal properties of the GGEP near this tricritical line. By using the methods of renormalized eld theory we work out a scaling description of the new universality class of tricritical dynamic isotropic percolation (TdIP) to which the tricritical GGEP belongs. We study a multitude of static and dynamic observables that play important roles in percolation theory. In particular we calculate the critical exponents describing the scaling behavior of these observables below 5 dimensions as well as logarithmic corrections to the mean-eld scaling behavior in 5 dimensions.

The outline of our paper is as follows. In Sec. II we consider the GGEP in a mean-eld theory. As the main result of Sec. II, the mean-eld analysis will reveal the structure of the phase diagram. With the aim of studying the elects of uctuations, we condense the principles de ning TdIP into a eld theoretic model in Sec. III. In Sec. IV we work out the scaling properties of static aspects of TdIP. Section V treats the dynamic scaling properties. Concluding remarks are provided in Sec. VI. There is one Appendix in which we sketch the calculation of a parameter integral that is helpful in computing Feynm an diagrams.

II. M EAN FIELD THEORY

A mean-eld description of the GGEP can be form ulated by treating the reaction equations (1.1) and (1.2) as determ inistic equations without uctuations. This determ inistic approximation leads to the system of dierential equations

Thus, S, X, Y, and E can be interpreted as the probability of nding the corresponding state at a site n. Note that the processes can only proceed at places where the probability to nd ill individuals in the neighborhood is not zero. We use the canonical initial condition that all sites of the initial state are susceptible except for the site at the origin which is ill, $X_0(n) = n_{10}$ and $Y_0(n) = E_0(n)$

with = $_{\rm c}$ = 1=z determ ining the second order phase transition corresponding to ordinary isotropic percolation. For < $_{\rm c}$, Eq. (2.9) has only the solution E = 0 which means that the disease does not percolate, i.e.,

is endem ic. In the other case, > c, a stable solution E > 0 arises, signalling the percolative pandem ic character of the disease. These types of solutions exist also in the full equation of state (2.8). Using , one demonstrates easily that f(E) increases monotonically from zero to one in the interval 0 E < 1 . Thus, E = 0 is always a solution of Eq. (2.8). It follows from the equation of motion (2.7) that only solutions of Eq. (2.8) with $f^0(E) < 1$ are stable. Because $f^0(0) = z$, a stable percolating solution E > 0 exists always for > c. The existence of more than one nontrivial solution requires necessarily that $f^0(E) = 0$ at least for one value E > 0. From Eq. (2.8) we derive the inequality

as the necessary and su cient conditions for the existence of a second locally stable solution E > 0 besides E = 0 with a discontinuous transition between the two. The line of tricritical points where the rst and the second order transitions meet in the -- phase space is determined by $1=\ =\ 1=\ +\ 1=\ =\ z$.

In the following we focus on the phenomena arising near the tricritical line. In this region of the phase space, E (n,t) is, except for a microscopic region around the origin n=0 of the position space, smalland slow ly varying. Hence, we may approximate Eq. (2.7) by the deterministic reaction-diusion equation




FIG.1: The mean-eld phase diagram.

Holding the positive coupling g constant, Eq. (2.12) comprises only two tunable parameters, viz. and f and hence the dimensionality of the phase diagram is reduced to two. As follows from the dierent types of solutions of Eq. (2.12) to be discussed in a moment, this two-dimensional phase diagram features a line of second order transitions (—line), a line of rst order transitions and a tricritical point determined by = f = 0 separating the two lines of transitions. In addition, there are 2 spinodal lines. The entire phase diagram is depicted in Fig. 1.

Equation (2.12) has besides the trivial solution E = 0, which is stable for > 0, a nontrivial locally stable

which is physical only if A>0. For f>0 one has therefore a continuous transition from E=0 (> 0) to E=A 2 j j=f (< 0). However, for f < 0 there is a certain value = $_{\rm d}$ between the spinodals = $3f^2=8g$ and = 0 for the discontinuous transition from E=0 to E=A. The values of $_{\rm d}$ m ay be determined by studying a travelling wave solution of the equation of motion (2.12) that describes the infection front of a big expanding sherical cluster of the epidemic. Such a solution is given by

III. FIELD THEORETIC MODEL

In this section we will derive a dynam ic response functional [25, 26, 27] for the GGEP based on very general arguments alluding to the universal properties of TdIP. First we will distill the basic principles of percolation processes allowing for tricritical behavior. Next, we cast these principles into the form of a Langevin equation.

Then we re ne the Langevin equation into a minimal eld theoretic model.

As an alternative avenue to a eld theoretic model for the GGEP one might be tempted to use the so-called \exact" approach which, as a rst step, consists of reform ulating the m icroscopic m aster-equation for the reactions (1.1) and (1.2) as a bosonic eld theory on the lattice. The next and pivotal step in this approach is to take the continuum lim it. A lbeit the \exact" approach with a naive continuum limit leads to a consistent dynam ic functional for the GGEP (after deleting several irrelevant term s) this approach must be cautioned against. Strictly speaking, one has to use W ilson's statistical continuum lim it [28] in the renorm alization theory of critical phenomena. This procedure consists of successive coarse graining of the mesoscopic slow variables (order param eters and conserved quantities as functions of m icroscopic degrees of freedom), the elim ination of uctuating residual microscopic degrees of freedom, and a rescaling of space and time. In general, microscopic variables do not qualify as order param eters. A lam ing examples are the pair contact processes (PCP and PCPD), where a naive continuum limit of the microscopic master-equations leads to untenable critical models. Therefore, we devise our eld theoretic model representing the TdIP universality class using a purely mesoscopic stochastic formulation based on the correct order param eters identi ed through physical insight in the nature of the critical phenomenon. Hence, our dynamic response functional stays in full analogy to the Landau-G inzburg-W ilson functional and provides a reliable starting point of the eld theoretic method.

A. Langevin equation

The essence of isotropic percolation processes can be sum marized by four statements describing the universal features of the evolution of such processes on a hom ogeneous substrate. Denoting the density of the agents (the infected individuals) by n (r;t) and the density of the debris (the immune or dead individuals) which is proportional to the density of the weakened substrate by m (r;t), these four statements read:

- (i) There is a manifold of absorbing states with n and corresponding distributions of m depending on the history of n. These states are equivalent to the extinction of the epidem ic.
- (ii) The substrate becomes activated (infected) depending on the density of the agents and the density of the debris. This mechanism introduces memory into the process. The debris ultimately stops the disease locally. However, it is possible that the activation is strengthened by the debristhrough somemechanism (sensibilization of the substrate).

- (iii) The process (the disease) spreads out di usively. The agents (the activated substrate) become deactivated (converted into debris) after a short time.
- (iv) There are no other slow variables. M icroscopic degrees of freedom can be summarized into a local noise or Langevin force (r;t) respecting the rst statement (i.e., the noise cannot generate agents).

The general form of a Langevin equation resembling these statements is given by

The rst row in Eq. (32) represents time-local reaction noise. The second row describes noise originating from di usion and the last row shows an example of possible time-non-local noise (quenched noise) that may be acquired through random disorder or through the elimination of microscopic slow variables, e.g., uctuations of the debris. The structure of the 3 terms is so that they respect the absorbing state condition. Of course many further contributions to Eq. (32) are conceivable (hence the ellipsis in the third row) including non-Markovian and also non-Gaussian noise. We will see below, that all these terms turn out being irrelevant, and that only the simplest form of reaction noise contributes the minimal eld theoretic model.

The dependence of the rate R (n;m) on the density of the debris m (r;t) describes memory of the process m entioned above. We are interested primarily in the behavior of the process close to the tricritical point, where n and m are small allowing for polynomial expansions R(n;m) =an fm $q^2 = 2 + ..., Q (n; m) = +$ and $Q^{0}(n;m) = {}^{0}+$ tion of the expansions will be given later by IR relevanceirrelevance arguments. As long as f > 0, the second order term gm² of the rate R is irrelevant near the transition point and the process models ordinary dynamic isotropic percolation [16, 17]. We perm it both signs of f so that our model accounts for sensibilization (weakened substrate) and allows for compact (Eden) spreading. Consequently we need the second order term for stabilization purposes, i.e., to limit the density n to nite values.

B. Dynam ic response functional

In order to apply the renormalization group (RG) and eld-theoretic methods [29, 30], it is convenient to use the path-integral representation of the underlying stochastic process n (r;t) [25, 26, 27]. With the imaginary-valued response eld denoted by ne (r;t), the generating functional of the Green functions (connected response and correlation functions) takes the form

The generating eld H (r;t) corresponds to an additive source term for the agent in the equation of motion (3.1). Therefore, the response function de ned by a functional derivative with respect to H (r;t) describes the in uence of a seed of the agent at (r;t). The dynamic functional Je;n and the functional measure De;n / $_{\rm x,t}$ de (r;t)dn (r;t)=2 i are de ned using a prepoint (Ito) discretization with respect to time [27]. The prepoint discretization leads to the causality rule (t 0) = 0 in response functions. This rule will play an important role in our diagram matic perturbation calculation because it forbids response propagator loops (see below). Note that the path integrals are always calculated with the initial and nal conditions n (r; 1) = e(r;1) = 0.

The stochastic process de ned by Eqs. (3.1) and (3.2) leads via the expansions of R , Q , and Q $^{\rm 0}$ to the prelim inary dynam ic response functional

As we have rem arked above, the term proportional to g rate R (n;m) on the density may be neglected only if the coupling f is positive deribles memory of the process needed primarily in the best terms arily in the best terms are proportional to g may be neglected only if the coupling f is positive dentite. In this case Eq. (3.4) reduces to the response functional of usual dynam ic percolation [16, 17]. As in all models with an absorbing state transition, the functional J^0 includes a redundant variable which has to be rem oved before any application of relevance—irrelevance arguments are given later by IR relevance—

For the steps to follow, we need to know the naive dim ensions of the constituents of J 0 after the rem oval of the redundant variable. As usual, we introduce a convenient external length scale 1 so that r 2 . Exploiting that J 0 has to be dim ensionless, we readily nd

The highest dimension dat which any of the nite and positive couplings becomes marginal (acquires a vanishing naive dim ension) corresponds to the upper dim ension do of the theory. This dim ension separates trivial meaneld critical behavior for d > dc from non trivial behavior in the regime where $d < d_c$ and where the relevant variable is small. Thus, if f is nite and positive it follows that $d_c = 6$. Then g, a, 0 , and have negative naive dim ensions and are therefore irrelevant. The corresponding terms in the response functional (3.4) vanish at the critical xed point, and the response functional displays the asymptotic symmetry $f^{-1=2}\mathbf{e}(\mathbf{r};t)$ \$ [16]. The resulting response functional is that of the GEP [16, 17].

However, if f is zero as it is at the tricritical point, we must use g to x the upper critical dim ension which leads to $d_c = 5$. The dim ensions of a, $\frac{0}{1}$, and are negative near d. Thus, di usional and quenched random ness of the noise is irrelevant here as they are for the GEP. D im ensional analysis also justi es the truncation of the expansions of P; Q, and Q 0 , as well as the elim ination of other term s. All higher order term s are irrelevant in the IR renormalization group approach because they carrying a negative naive dim ension near d = dc. Collecting, we obtain the dynam ic response functional

as our minimal eld theoretic model for the TdIP universality class. We shall see as we move along, indicating the consistency of our model, that the proper elim ination of IR irrelevant terms has led to an UV renormalizable theory at and below ve dim ensions.

Note that, contrary to dP, the functional (3.7) does not have an asymptotic symmetry that relates the two elds m and n. Thus, these elds will get independent di erent anom alous dim ensions leading to two di erent order param eter exponents.

Before we go on, we extract the diagram matic elements im plicit in J. These elem ents will play a central role later on when we calculate the G reen functions perturbatively. As usual, the Green functions are the cumulants of the elds n and a which correspond in graphical perturbation expansions to the sums of connected diagrams. Their




FIG. 2: The diagram matic elements implied in the dynamic functional J.

actual calculations are performed most economically in a time-momentum representation. To this end we will use the spatial Fourier transforms of the elds n and e de ned via

C. Quasi-static m odel

Asm entioned earlier, we are interested in the dynamic as well as the static, i.e. t! 1, properties of tricritical percolation. Of course, we could base our entire RG analysis on the full dynamic functional J as given in Eq. (3.4). Then we could extract the static behavior from the dynam ic behavior in the end by letting t! 1. This would mean, however, that we had to determ ine all the required renormalizations from dynamic Feynm an diagram s com posed of the diagram m atic elements listed in Fig. 2. Fortunately, there is a much more econom ic approach possible here which is based on taking the so-called quasi-static lim it. W e will see shortly, that the perturbation theory simplies tremendously in this lim it. All but one renormalization factors can be calculated using this much simpler approach. Only for the one remaining renormalization we have to resort to the dynam ic response functional J. Taking the quasi-static lim it am ounts to switching the fundam ental eld variable from the density of the agents to the density of the debris m (r) = m (r;1) = $\frac{1}{1}$ dtn (r;t) left behind by the epidem ic. Then, the static properties of TdIP can be studied via the Green functions of the debris density. In




FIG. 3: The diagram m atic elements implied in the quasistatic H am iltonian H .

IV. STATIC SCALING PROPERTIES

Now we will study the static properties of TdP, that is the properties of TP. The dynam ic properties of TdP will be addressed later on.

A. Diagram matics

of the correlation functions via Legendre transform ation of their generating functionals [30]. G raphically, the vertex functions consist of am putated one-line irreducible diagram s. As usual in determ ining the renorm alizations, we can restrict ourselves to the super cially divergent vertex functions, i.e., those vertex functions that have a non-negative -dimension at the upper critical dimension d_c. A simple dimensional analysis shows that only the vertex functions that correspond to the dierent terms of the Ham iltonian (3.11), viz. $_{1;1}$, $_{1;2}$, $_{2;1}$, and $_{1;3}$, are primitively divergent. Thus, the theory is renormalizable by additive and multiplicative renormalization of the elds and the parameters of the theory.

Throughout, we will use dimensional regularization to calculate the Feynm an diagram s constituting the required vertex functions, i.e., we will compute the diagram s in dimensions where they are nite for large momenta and then continue the dimension analytically towards $d_{\rm c}$. This procedure converts the logarithm ic largemom entum singularities of a cuto regularization into poles in the deviation " = $d_{\rm c}$ d from $d_{\rm c}$. However, polynomial largemomentum singularities that require additive renormalizations are unaccounted for in dimensional regularization. In order to discuss such additive renormalizations, we will occasionally use a cuto regularization with a largemomentum cuto .

At this place it is worth stressing that real critical systems not involve any UV-divergencies because all inverse wavelengths of uctuations have a physical cuto

. On the other hand, critical systems su er from IR-divergencies. However, if and only if we use a reliable eld theory, we can formally transform IR-divergencies into UV-divergencies by a simple rescaling. This way we can learn about IR-scaling properties of the critical system indirectly via the UV-renormalizations. A correct




FIG. 4: O ne-loop diagram s contributing to the renormalization of $_{1,1}$ and $_{1,2}$ if a momentum-cuto regularization is used. In dimensional regularization, these diagrams are nite.

and reliable statistical eld theory constitutes what W ilson [28] calls a logarithm ic theory free of length scales. Only within such a theory it makes sense to apply the techniques of renormalized eld theory to critical systems.

1. Divergent One-Loop Diagram s

Two divergent one-loop diagrams can be assembled from the diagram matic elements listed in Fig. 3. These diagrams, which contribute to the vertex functions $_{1;1}$ and $_{1;2}$, are shown in Fig. 4. It is easy to see that they are linearly divergent for d = d_c = 5 (i.e., the dimension is 1). No logarithm is divergencies arise at one-loop order. Thus, the theory can be renormalized to one-loop order by additive renormalizations

Next we will switch to dimensional regularization for convenience. In this method all polynomial divergencies arising from the large cuto are formally set to zero, and hence the two diagrams in Fig. 4 become nite at d_c. Thus, the additive renormalizations Eq. (4.3) becom e form ally super uous in dim ensional regularization. However, it has to be emphasized that dimensional regularization is only a formal trick. Physically the additive renorm alizations are always present and we need the interaction term proportional to the coupling constant f to renormalize the theory contrary to the claim of Ref. [20]. U sing dim ensional regularization we have to keep in m ind that these additive renorm alizations do exist and that the critical \tem perature" is shifted by a term linear in the crossover variable v: $_{c} = a \ v \ ab^{2} \ ^{2}$ "g+0 (g²). This $_{\text{c}}$ is form ally set to zero in dim ensional regularization.

2. Two-Loop calculation

Since there are no "poles at one-loop order, we have to proceed to higher orders in perturbation theory to nd non-trivial critical exponents. We will see that "poles do




FIG. 5: Two-loop diagrams contributing to the renormalization of $_{1,1}$.

occur at two-loop order and that the two-loop diagram s will lead us to anomalous contributions to the critical exponents of order ".




FIG. 6: Two-loop diagrams contributing to the renormalization of $_{1;2}$.




FIG. 7: Two-loop diagrams contributing to the renormalization of $_{2:1}$.




FIG.8: Two-loop diagrams contributing to the renormalization of $_{1:3}$.




FIG. 9: Two-loop diagrams that contain insertions of the one-loop diagram shown in Fig. 4(b). In dimensional regularization, these two-loop diagrams are nite.

For com pleteness, we conclude our quasi-static perturbation theory by brie y returning to a cuto regularization. In cuto regularization there are two additional singular two-loop diagram s, see Fig. 9. These diagram s have divergent insertions of the singular one-loop diagram (4b). 2. Scaling behavior of various percolation observables

Now we will exploit our know ledge about the correlation functions of the elds to extract the scaling behavior of various observables that play an important role in percolation theory. First we will consider the case that the process starts with a single seed at the origin r=0. Second we will look at the case that the density of the initial state is hom ogeneous.

Let us start by considering clusters of a given nite size S, i.e. clusters with a nite mass S of the debris given that the process started with a seed, a single agent, at the origin r=0. In principle, any reasonable initial state can be prepared by choosing the appropriate seed density $_0$ (r). In the Langevin equation (3.1) this general initial condition corresponds to an additional source term $^1q(r;t) = _0(r)$ (t). At the level of the dynamic response functional J (3.7) such an initial state translates into a further additive contribution




FIG. 10: D ynam ic two-loop diagram s which provide us with the renorm alization factor of the kinetic coe cient $\,$.

VI. CONCLUDING REMARKS

In sum mary, we have generalized the usual GEP by introducing a further state in the live of the individuals governed by the process. Our GGEP has a multidim ensional phase diagram featuring two surfaces separating endem ic and pandem ic behavior of the epidem ic. One of the surfaces is a surface of rst order phase transitions whereas the other surface consists of critical points representing second order transitions. The two surfaces meet at a line of tricritical points.

The second order phase transitions belong to the universality class of dynam ic isotropic percolation (dIP). In the vicinity of these transitions, the asymptotic time limit of the GGEP is governed by the critical exponents of usual percolation. The debris left behind by the process form s isotropic percolation clusters.

Mainly, we were interested in the tricritical behavior of the GGEP.We set up a eld theoretic minimal model in the form of a dynamic response functional that allowed us to study in detail the static and the dynam ic scaling behavior of the universality class of tricritical dynamic isotropic percolation (T dIP). In particular we calculated the scaling exponents for various quantities that play an im portant role in percolation theory. As expected, these exponents are dierent from the exponents pertaining to $d\mathbb{P}$. For example, we computed the exponents and 0 respectively describing the two dierent order parameters, viz. the density of the debris and the percolation probability. Whereas and oare identical in dIP, they are dierent in TdIP. Although TdIP is described by scaling exponents di erent from those of usual percolation, we learned that its spreading as well as the statistics of its clusters behave in many ways like conventional dynam ic percolation. For example, TdIP has meaningful cluster numbers, fractal dimensions etc. Thus, we propose to refer to the static properties of the TdIP as tricritical isotropic percolation (TIP).

The surface of rst order transitions is characterized by a compact cluster growth, i.e., the fractal dimension of the clusters is identical to the their em bedding dim ension. We hope that our ndings trigger num erical work with the aim to verify the predicted rst order percolation transitions. A promising strategy that avoids a cum bersom e detection of jum ps in the order param eters m ight be to measure directly the fractal dimension of clusters near the rst order surface.
