Projective Dynamics in Realistic Models of Nanom agnets

The free-energy extrem a governing the magnetization-reversal process for a model of an iron nanopillar are investigated using the projective dynamics method. Since the time evolution of the model is computationally intensive, one could question whether su cient statistics can be generated, with current resources, to evaluate the position of the metastable con guration. Justi cation for the ne-grained discretization of the model that we use here is given, and it is shown that tractable results can be obtained for this system on realistic time scales.

M agnetic nanopillars can be fabricated¹, which o er interesting opportunities for direct comparison with num ericalm odels. In the application discussed here, the pillars are grown perpendicular to a surface. For an applied

eld parallel to the long axis of the pillar, there exists a stable free-energy minimum when the eld is parallel to the average magnetization of the pillar, and a metastable minimum for the antiparallel orientation. Magnetization reversal involves a transition from the metastable minimum to the stable minimum across a saddle point in the free energy. It is the free-energy di erence between the saddle point and the metastable minimum that determines the switching time of the pillar. While determining the magnetization of the metastable minimum is comparatively easy, the magnetization of the saddle point is a technique that has proven capable of nding the saddle point in other magnetization-reversal system $s^{2,3}$.

II. MODELAND NUMERICAL RESULTS

In order for the proper dynam ics to emerge, the magnetization of the simulated pillarm ust be discretized on a su ciently ne scale. Pillarm odels that have previously been studied by projective dynam ics consisted only of a one-dimensional chain of spins³. This model lacks richer dynam ics, such as magnetization curling modes, that are seen in experiments and in more realistic models. In addition, the dependence of the switching eld on the angle of m isalignment between the pillar axis and the applied

eld observed in the one-dimensional model does not correspond to that seen in the experimental pillars^{5,6,7}.

To achievem ore realistic dynam ics, a model pillar with physical dimensions 10 nm 10 nm 150 nm was discretized onto a 6 6 90 cubic lattice. The model parameters were chosen to be consistent with bulk iron: exchange length of 2.6 nm and magnetization density of 1700 em u/cm 3 . The tem perature was $\,$ xed at 20 K .

The dynamics of the system are governed by the Landau-Lifshitz-Gilbert (LLG) equation $^{8}\mbox{,}$

which describes the time evolution of the magnetization in the presence of a local eld. Here $_0$ is the electron gyrom agnetic ratio with a value of 1:67 10^7 H z/O e, and is a phenom enological damping parameter, chosen as

0.1 to give underdam ped behavior. M (\mathbf{r}_i) is the m agnetization density at position \mathbf{r}_i , with a constant m agnitude M_s, and H (\mathbf{r}_i) is the total local eld at \mathbf{r} . The latter contains contributions from the dipole-dipole interactions, exchange interactions, and the applied eld.

A reversal simulation begins with the magnetization oriented along the long axis of the pillar in the + z direction. It is allowed to relax in the presence of a eld + $B_0 \hat{z}$ before the eld is quickly switched to $B_0 \hat{z}$, where $B_0 = 11250$ e has been chosen sm aller than the coercive eld.

Projective dynamics involves analyzing the probability of growing toward the stable equilibrium or shrinking away from it, as a function of a single variable that m easures the progress of the reversal process. To collect grow ing and shrinking statistics here, the z-com ponent of the total magnetization of the pillar, M $_z$, was recorded at each integration step. In addition, the change in this value from the previous integration step, M_z , was also recorded. The magnetization axis was discretized into bins into which the collected data were sorted. The bin size was determ ined such that the discretized M_z would only involve changes between ad jacent bins. The growing and shrinking probabilities were calculated by counting the number of times that M_z would cause the magnetization to change bins. De neG as the num ber of times the magnetization hopped to the next bin in the direc-




FIG.1: G rowing and shrinking probabilities versus the magnetization along the z-axis for a 6 6 90 pillar. G row/shrink data were collected into 6000 bins, which span the entire magnetization axis, [-1,1]. The simulation was run at 20 K, 1125 0 e, and the applied eld was directed along the long axis of the pillar, antiparallel to the initial magnetization. The continuous curves represent nine-point running averages

tion toward equilibrium, and S as the number of hops in the direction back toward the metastable state. If N is the total number of visits to the starting bin, then the growing and shrinking probabilities for each bin, P_G and P_S , can be written respectively as

$$P_{G} = \frac{G}{N}; \qquad P_{S} = \frac{S}{N}: \qquad (2)$$

The crossings of the growing and shrinking probabilities give information about the locations of the metastable free-energy minimum and the saddle point. Where the two probabilities are equal, the system has no preferred direction of magnetization evolution, indicating that the free-energy landscape is at in this region. This is the location of an extrem um. The right-hand intersection in Fig. 1 corresponds to the metastable free-energy minimum, where the system spends most of its time. At the saddle point, the growing and shrinking probabilities are also equal, as indicated by the left-hand crossing. The region between these two crossings shows a higher probability for shrinkage than grow th, corresponding a preference for moving toward the metastable minimum.

P revious simulations perform ed on a one-dimensional chain of æventæen spins exhibited Stoner-W ohlfarth behavior for the angular dependence of the switching eld. This is not representative of experimental data^{5,6,7}. How – ever, a full three-dimensional model qualitatively produced the proper angular dependence⁴. This is not surprising, given that the full three-dimensional model allows for magnetization curling modes which are simply not allowed in the one-dimensional model. PD has previously been applied to the one-dimensional spin chain³, but several thousand switches had to be performed in order to accumulate su cient statistics to reveal the freeenergy extrem a³. W ith typical switches taking around 1500 CPU-hours for the full three-dimensional model, it was not clear that su cient statistics could be generated.

Figure 1 shows the results collected from only 20 switches for the full model. The estimated $P_{\,G}\,$ is shown as circles, and P_S as crosses. Scatter in these data is primarily due to the counting statistics and the small num ber of sam ples in each bin. N ine-point running averages are used to reduce the scatter and in prove estim ates of the crossings of P_{G} and P_{S} . The running averages are represented by curves and are su cient to determ ine the locations of the extrem a with an uncertainty of about 1 10^{3} in the magnetization. For the one-dimensional m odel the estim ated curves representing P_G and P_S are alm ost parallel near the saddle point, making it di cult to locate crossings of the growing and shrinking probabilities (see Fig. 1 of Ref.³). Since they cross at a signi cant angle for the model studied here (see Fig. 1), it is possible to nd an estimate for the magnetization of the free-energy saddle point from far fewer switches than were needed for the one-dimensionalm odel.

III. SUMMARY AND CONCLUSIONS

The projective dynam ics method was used to produce growing and shrinking probabilities during the magnetization reversal of a realistic model nanopillar. These probabilities can be used to locate the magnetization of the free-energy extrem a. In particular, the magnetization of the saddle point is revealed. Compared to the one-dimensionalmodel, far fewer switches are needed to

nd the location of the extrem a in the three-dimensional model. In the future, a study of the dependence of the saddle point on tem perature and m isalignment between the pillar and the applied eld are planned.
