## Irreversible M agnetization D eep in the Vortex-Liquid State of a 2D Superconductor at H igh M agnetic Fields

The remarkable phenomenon of weak magnetization hysteresis loops, observed recently deep in the vortex-liquid state of a nearly two-dimensional (2D) superconductor at low temperatures, is shown to reject the existence of an unusual vortex-liquid state, consisting of collectively pinned crystallites of easily sliding vortex chains.

M any potentially important superconductors, such as som e of the high-T<sub>c</sub> cuprates, as well as the ET -based organic conductors, are extrem ely type-II superconductors with small in-plane coherence lengths and nearly 2D electronic structure. Thereby, ET (or BEDT-TTF) stands for bisethylenedithio-tetrathiafulvalene. Drastic deviations from the predictions of the mean-eld theory for these materials, due to strong uctuations in the superconducting (SC) order parameter, are therefore expected, in particular under strong perpendicular magnetic eld [1]. The great interest, from a fundam entalpoint of view, in the latter class of materials stem s from their relatively low upper critical elds, which enable to investigate the virtually unexplored phase diagram and vortex dynam ics of strongly type-II superconductors at low tem peratures and high magnetic elds.

Of special interest is a recent striking observation in  $^{O}-(ET)_2SF_5CH_2CF_2SO_3$  of sm all, but very clearm agnetization hysteresis loops appearing well above the 'm a pr' inreversibility eld at low tem perature, where signi cant de H aas{van A phen (dH vA) oscillations are observable as well [2] (Fig. 1). It should be stressed that the occurence of such high eld hysteresis tail is not peculiar to this particularm aterial. It can also be observed at low tem peratures in  $-(ET)_2Cu(SCN)_2$  [3].

The unusual feature of this inneversibility e ect is associated with its appearance deep in the vortex-liquid phase, where one usually expects unrestricted motion of ux lines through the entire SC sample, ensuring the establishment of thermodynamic equilibrium. In the present letter we argue that the observed hysteresis effect is a general feature which rejects the unusual nature (namely the nem atic liquid-crystalline structure) of the low-tem perature vortex-liquid state in 2D superconductors well above the vortex-lattice melting point, which was recently predicted theoretically [4].

A coording to thism odel the vortex state above the major inversibility eld, H  $_{\rm irr}$ , (which is found to be close to the vortex-lattice melting eld, see below) is not an isotropic liquid but som e mixed phase containing SC domains of easily sliding parallel vortex chains, which are stabilized by a small number of strong pinning centers.

This model resembles the sluggish vortex uid picture, proposed by W orthington et al [5] to describe the intermediate vortex liquid phase in defect-enhanced YBCO singel crystals, and applied more recently by Sasaki et al [6] to account for a similar behavior in the organic superconductor  $-(ET)_2Cu(SCN)_2$ . As shown below, a simple B ean-like model for the magnetic-induction proles, associated with the injected vortex chains into the

SC sample, yields very good quantitative agreem ent with the measured eld dependence of the magnetization hysteresis.

O ur model consists of independent 2D SC layers in the x-y plane under the in uence of an external uniform magnetic eld H = H b, H > 0, perpendicular to the layers (Fig. 2). The SC sample is in contact with a normal metal at two parallel planes, x = 0, and  $x = L_x$ . H is varied, at low temperatures, from above  $H_{c2}$  to the irreversibility eld  $H_{irr} < H_{c2}$ , where magnetic quantum oscillations can be detected. The dHvA e ect is

m easured by m eans of the torque m ethod, in which the signal is detected during steady (upw ard and dow nw ard) sw eeps of the external m agnetic eld. N ote that, for the sake of sim plicity, the sm all in-plane com ponent of the external m agnetic eld, required for this high-resolution m easurem ent, is neglected in our analysis.

The in vence of a steady increase (or decrease) of the magnetic eld on the distribution of magnetic ux lines within the SC region is determined by the pinning forces acting on quantized SC vortex lines near the normal-superconducting (N-S) boundary planes. The pinning-force resistance against ux injection leads to the establishment of a ux-density gradient perpendicular to the magnetic eld direction along the normal of the N-S boundary plane (along x). A ssum ing the ux injection to be uniform along y, the current density j = jp and the eld gradient,  $\frac{\theta B}{\theta x}$ , are connected by Ampere's law:

where the Lorentz-force density (per unit volume), exerted on the vortex current by the magnetic eld, is

For magnetic elds below H<sub>irr</sub>, the pinning force,  $F_{pin} = \frac{\ell U_{pin}}{\ell x}$ , is su ciently strong to balance the action of the driving Lorentz force,  $F_L = \frac{1}{c} jB = \frac{\ell U_L}{\ell x}$ , with  $U_L(x) = \frac{1}{8} [B(x)]^2$ , so that  $\frac{\ell U_{rot}}{\ell x} = 0$ , with

U<sub>tot</sub> (x)  $U_{\text{pin}}$  (x) +  $U_{\text{L}}$  (x). Consequently, the static m agnetic-eld gradient,  $\frac{\partial B}{\partial x}$ , established across the sam ple, is followed by a dissipation less current parallel to the surface. This static equilibrium situation persists under the increasing local magnetic potential  $U_{I}(x)$  near the surface, up to the 'elastic lim it' of the pinning potential, Upin (x), above which bundles of vortices, accum ulated near the N-S boundary, can jump over (or tunnel through) the U<sub>tot</sub>-potential barriers to neighboring potential wells. Such collective vortex jumps into the SC region quickly reduce the local Lorentz force by relieving the large local eld gradient, so that the movem ent stops after a few steps. The observed sharp m agnetization jumps in this eld range [2, 7] seem to be associated with this e ect.

The vortex-vortex correlations in this eld range are relatively strong and long ranged, so that the e ective pinning force is long ranged as well. The e ect is particularly signi cant at low pinning-center density, where these correlations can dram atically enhance collectivepinning processes, since m any vortices are involved in the interaction with a single pinning center. Furtherm ore, due to the strong anisotropy of the vortex-vortex coupling [4], this collective-pinning mechanism is also very anisotropic. Thus, the magnetic-ux injection should encounter di erent resistances at di erent locations of the N-S boundary, depending on the local orientation of the vortex crystallite with respect to the surface. The most favorable orientation is that of crystallites having their principal lattice vector aligned perpendicular to the N-S boundary, i.e., along x, where a weak driving force can inject many vortex chains into the SC region.

As the external magnetic eld approaches H  $_{\rm irr}$  from below and the strength of the pinning potential is decreasing (because  $U_{\rm pin}$  is proportional to the local super uid density, which decreases with increasing B), the increasing Lorentz force can exceed the maximal value of the pinning force, i.e., the highest maximum of  $U_{\rm tot}(x)$  turns into an in ection point. Above this critical eld,  $U_{\rm tot}(x)$  has no barriers and the motion of vortices in the entire SC region becomes a continuous ow . This vortex movement with velocity v is opposed by a dynamic friction force,  $F' = v = F \, b$ , which balances the action of the driving Lorentz force at the critical velocity  $v^{\rm c}$ :

In the corresponding steady state the motion of ux lines generates an electric eld [8]

with  $E = \frac{1}{c}Bv^{c}$  parallel to the current density j. Consequently, the system develops a nite electrical resistivity to the critical-current ow,  $j_{c} = cv^{c}=B$ , namely

(B) = E = j = B<sup>2</sup>=c<sup>2</sup> . Now, the Bardeen-Stephen (BS) relation [9, 10],  $BH_{c2}=c^2$ , which is equivalent to the simple linear magnetoresistivity [8] = (B=H<sub>c2</sub>), together with Eqs. (1) and (4), lead to:

The Faraday induction law together with Eq. (4) yield the ux-line conservation law,  $\frac{0}{0t} + \frac{0}{0t} = 0$ , which may be combined with Eq. (5) to obtain the nonlinear di usion' equation for the magnetic-ux density:

In the highwith the diusion coe cient D eld lim it of interest here, when the range H of a single eld-sweep cycle is much smaller than the initial eld of the hysteresis loop, H<sub>0</sub>, the nonuniform part of the magnetic induction associated with the ux ow is very small, i.e., p(x;t) j p(x;t) H (t) j H (t) ' H0. Under this condition the second term on the RHS in Eq. (6) can be neglected, and the equation m ay be linearized to  $\frac{H_0}{H_{c2}}$  D  $\frac{\theta^2 B}{\theta x^2}$ . The solution of this equation, sat-<u>0B</u> 0t isfying steady upward and downward eld-sweep boundary conditions,  $\frac{\partial B}{\partial t}(x = 0;t) = \frac{\partial B}{\partial t}(x = L_x;t) = -\frac{H}{H}$ , and  $\frac{H}{1}$  for < t2 , takes the for 0 t 2 form s:  $B_+$  (x;t) =  $H_0 + \frac{Ht}{} + B$ <u>2x</u> L x 1 1, and  $(x;t) = H_0 + H_2 \frac{t}{T} = B \frac{2x}{T}$ 1, re-

spectively, with half the period of the eld-sweep cycle. Note the spatial rigidity of the induction proles B (x;t), which is assured, in the high-eld limit p(x;t)j H, by the nearly instantaneous propagation of any local uctuation of the magnetic-ux density. Indeed, the propagation velocity of such a uctuation,  $v_f = \frac{@B}{@t} = \frac{@B}{@x}$ , is found by Eq. (6) to be:  $v_f = \frac{c^2 n}{4 H_{c2} @c} \frac{@}{@x} B \frac{@B}{@x} = \frac{@B}{@x}$ , so that the ux-line velocity v (see Eq. (5)) satis es: jv j' jv<sub>f</sub> j  $\frac{@B}{@x} ^2 = B \frac{@^2B}{@x^2} jv_f j$ .

The resulting Bean-like induction prole can now be exploited to evaluate, for each small hysteresis loop, the jump, M "#, of the magnetization occurring at a point where the eld sweep is reversed (Fig. 2). The corresponding jump, M "# =  $\frac{1}{3}$  B, is determined by the spatial average of the induction di erence,  $\beta$  (x; ) B<sub>+</sub> (x; )], where the (eld-sweep rate-dependent) parameter (1) is an elective volume fraction of the SC domains in the sample. This simple Bean-likem odelm ay be tested by estimating the parameter n, which should be identied with the in-plane resistivity at H<sub>c2</sub> of the 2D conductor under study. This can be done by using the experimental values: 4 M "# 4 10 <sup>7</sup> T (see below), L<sub>x</sub> 0:1 cm, and <u>H</u> 0:005 T/s

[2], in the relation (H = ) = 8D (H<sub>0</sub>=H<sub>c2</sub>)  $B = L_x^2$ , which yields  $n = \frac{L_x^2}{3c^2 M_{**}} = 0.4 = 0.4 = 10^6 \text{ cm}$ . A ssum ing that is of the order unity, this is a reasonable result, (i.e., of the order of a typical metallic resistivity), which cannot be easily veried experimentally, since for the very anisotropic metal under study here, measurements of the in-plane resistivity are extremely sensitive to out-of-plane scattering by a minute amount of defects.

It is interesting to estimate the characteristic energy scale corresponding to the friction of moving vortices in the liquid state above H <sub>irr</sub> against the e ective pinning force. This can be done by estimating the total spatial variation of the magnetic induction within the SC sample,  $L_x \frac{\partial B}{\partial x}$ B, with the bar indicating spatial averaging, and comparing it to the experimental value of M "#. Thus, the work (per unit volume) done by the driving Lorentz force against the friction force,  $E_{fric} = \frac{1}{c} j_c B L_x = \frac{1}{4} B \frac{\theta B}{\theta x} L_x = \frac{1}{4} B \theta, m ay$ be rewritten in units of the maximal SC condensation-energy density,  $E_{cond} = \frac{H_{c2}^2}{16}$ , that is for B  $H_{c2}$ ,  $E_{fric} = E_{cond} 4^{2} B = H_{c2}$ . Using the experimental value of the magnetization jump at 2 T, we nd  $B = 3 M_{"\#} 4 10^7 T$ , so that  $e_{fric} 1:7 10^3$ , 46 is used [11]. This estimate is smaller then where the characteristic energy associated with the melting of the vortex lattice in 2D superconductors, which is about 2% of the SC condensation energy. It may indicate that m ost of the vortex crystallites are aligned with their principal lattice vector along the direction of the ux-line motion [12], so that the ux ow is dominated by easily sliding vortex chains, which are subject only to the residual shear resistance characterizing the vortex-liquid state above the melting transition [1]. This picture is very similar to the moving smectic state found recently in many num erical simulations of 2D vortex lattices in

the presence of random pinning centers [13].

The value of  $\mathbf{e}_{\mathrm{fric}}$  estimated above may also re ect the correlation between the onset of irreversibility and the vortex-liquid freezing transition. This may be veried by calculating the tem perature-dependent melting eld, H  $_{\rm m}$  (T), and comparing it to the irreversible eld, H irr (T), extracted from the experim ental data. Sim ilar to Ref.  $[\beta]$ , H <sub>irr</sub> (T) is determ ined here by the onset of the m a pr hysteresis in the magnetization curve (see Fig. 1 ). W ithin the G inzburg (Landau (GL) approach,  $H_m$  (T) has been derived by several authors [4, 14]. It can be obtained from  ${}^{2}$  (H  $_{\rm m}$  ;T) =  $g_{\rm m}^{2}$  , where  ${}^{2}$  (H ;T) "0=k<sub>B</sub> T, with  $"_0 = ^2 = 2$  being the SC condensation energy per unit vortex, and and are the GL parameters [1]. Here we estimate j  $_0 f = - = (1.76k_B T_c)^2 \ln \frac{H_{c2}}{B}$ , and =  $\frac{1:38}{E_{\rm E} (h!_{\rm c})^2}$ . Using our estimate,  $g_{\rm m}^2$  $1=4^2$ , with

' 0:066 the e ective m in im al shear energy relative to  $"_0$  [4], and neglecting the weak temperature dependence of H  $_{\rm c2}$  at low T , we obtain the simple equation for  $h_m$  (t) =  $H_m$  (T)= $H_{c2}$  (0):  $\ln (h_m) = k_0^{-1} th_m$ , where  $t = T = T_{c}(0)$  and  $k_{0}$  is a single dimensionless parameter depending on the properties of the superconductor through  $k_0^2$  ' 0:15g<sub>m</sub><sup>2</sup> E<sub>F</sub> (h!<sub>c2</sub>)<sup>2</sup>=(k<sub>B</sub> T<sub>c</sub>)<sup>3</sup>. The function  $h_{m}$  (t) for  $^{00}\text{-(ET)}_{2}\,\text{SF}_{5}\,\text{CH}_{2}\,\text{CF}_{2}\,\text{SO}_{3}\text{,}$  with  $\text{T}_{c}\left(0\right)$  = 4:4 K and  $H_{c2} = 2 T$  is shown in Fig. 3(a). The experimental irreversibility line agrees rather well with the calculated melting curve. A similar procedure is applied to  $-(ET)_2Cu(SCN)_2$ . The parameter H<sub>c2</sub> 4:7 T was determ ined by thing the additional dam ping am plitude of the dH vA oscillation in the mixed SC state, as calculated from our SC uctuations theory [1], to the corresponding experim ental data [3]. Again, the calculated melting curve is found close to the irreversible line obtained in Ref. [3] [Fig. 3(b)]. It is interesting to note that at T = 0the resulting melting eld coincides with the mean-eld

H $_{\rm c2}$ . The sharp increase toward H $_{\rm c2}$ , characterizing H $_{\rm m}$  at T  $\,!\,$  0, is sim ilar to that of H $_{\rm irr}$  observed experim entally in both m aterials.

The relation H<sub>irr</sub>  $H_m$  motivates us to exploit our uctuating-vortex-chain m odel above H m in calculating the magnetic-eld dependence of the jump M "# above H<sub>irr</sub>, and compare it to the experim ental result (Fig. 1). Combining Eq. (1) with Eq. (3), we may rewrite the critical gradient as  $\frac{1}{2}B = 0xj = 4 \frac{1}{2} \frac{1}{2}B = 4 E_{fric} = L_x B$ . Since the generators of the friction force, i.e., the pinning force and the vortex-vortex interactions, all originate in the existence of local SC order at the vortex position, the friction energy E<sub>fric</sub> should be proportional to the mean-square SC order parameter, hj  $_0$  (H )fi, and so the magnetization jump can be written as M  $_{"\#}$  =  $\frac{L_x}{3} \frac{@B}{@x}$  /  $\frac{1}{B}$  hj 0 (B) fi. Using the lim it of  $\frac{1}{3}$  B independently uctuating vortex chains in the GL theory [1] to describe the vortex-liquid state above H irr, ie., writing: hj  $_0$  (B) fi = $\frac{2k_{\rm B}T}{2}$  (), where () =  $+\frac{\exp(2)}{2}$ ,  $\det(2)$ , we not that  $M_{\#} / \frac{1}{B} hj_{0} (B) fi/ ()$ (7)

is a universal function of the dimensionless parameter (B;T). Employing them aterial parameters,  $T_c = 4.4$  K,  $\frac{M_{\odot}}{m_{\odot}} = 2.0$ ,  $E_F = k_B = 133$  K at the temperature of the experiment, T = 40 mK, so that  $31(1 \text{ B} = H_{c2}) = B$ , and treating  $H_{c2}$  and the proportionality factor in Eq. (7) as adjustable parameters, the best t is obtained for  $H_{c2} = 2$  T (Fig. 4). The resulting curve relects the crossover between the vortex-crystal state below  $H_{c2}$ , which is well described by mean-eld theory, and the normal state far above  $H_{c2}$ , with the long tail of the eld-dependent magnetization hysteresis corresponding to the enhanced in uence of 2D SC uctuations.

In conclusion, we have shown that the striking phenom enon of the weak m agnetization hysteresis loops, observed deep in the vortex-liquid state of a nearly 2D superconductor can be reasonably explained as arising from shear viscous ow of easily sliding vortex chains, which are clustered around a sm all number of strong pinning centers.
