## M ulti-Scaling C om parative A nalysis of T im e Series and a D iscussion on \Earthquake C onversations" in C alifornia

T in e series are characterized by com plex m em ory and/or distribution patterns. In this letter we show that models obeying to di erent statistics m ay equally reproduce som e pattern of a time series. In particular we discuss the di erence between Levy-walk and fractal G aussian interm ittent signals and show that the adoption of com plem entary scaling analysis techniques m ay be useful to distinguish the two cases. Finally, we apply this methodology to the earthquake occurrences in C alifornia and suggest the possibility that earthquake occurrences are described by a colored (= long-range correlated') G eneralized P oisson m odel.

Herein we introduce a method of multi-scaling com parative analysis (MSCA) for the study of interm ittent signals. We show that to distinguish between fractal Gaussian interm ittent noise and Levy-walk interm ittent noise the scaling results obtained using di usion entropy analysis (DEA) should be compared with those obtained from both nite variance scaling methods (FVSM) and probability distribution functions (pdf) [1, 2]. Finally, we apply MSCA to the seism ic data of California and suggest that, instead of being described by a statistics according to which the waiting times between Omori's earthquake clusters are uncorrelated from one another, as the traditional G eneralized P oisson m odel [3, 4] or a recent Levy-walk like model assume [4], the data may also be characterized by intercluster 1/f long-range correlations that m ay disclose the earthquake conversations recently suggested by Stein [3].

Hurst, in his pioneering work [5], introduced the notion of rescaled range analysis of a time series that takes the scaling form of (R = S) (t)  $/ t^{H}$  (H is now called the Hurst exponent). This stimulated M andelbrot to introduce the concept of fractional Brownian motion (fBm) [6]. In a random walk context the value H = 0.5 indicates uncorrelated noise, 0 < H < 0:5 indicates anti-persistent noise and 0.5 < H < 1 indicates persistent/long-range correlated noise [6]. A Iternative scaling m ethods applied to a time series  $f_{ig}$ , where  $i = 1; 2; \dots$ , focus on the auto correlation function C (t) / h  $_{\rm i}$   $_{\rm i+t}$  i /  $t^{\rm 2H}$  ; on the power spectrum representation  $P_{s}(f) / f^{1 2H}$  [7] and on the evaluation of the variance of the di usion generated by f  $_{i}$ g [8] (V (t) /  $t^{2H}$  ). All such scaling m ethods are related to the original Hurst's analysis and yield his H-exponent. These techniques, referred by us as FV SM, assume a nite variance and according to the central lim it theorem (CLT) [9] the underlying statistics are G aussian.

Recently, Scafetta et al. [1] introduced a complem entary scaling analysis, the DEA, that focuses on the scaling exponent evaluated through the Shannon entropy S (t) of the di usion generated by the uctuations f  $_{ig}$  of a time series [1, 2]. Here, the pdf of the di usion process, p(x;t), is evaluated by m eans of the subtrajectories  $x_n(t) = \int_{i=0}^{t} f_{i+n} w$  if n = 0;1;::: The pdf scaling property for a fractal anom alous di usion takes the form  $p(x;t) = t R_1^F x t$ ; and its entropy increases in time as  $S(t) = \int_{1}^{t} p(x;t) \ln [p(x;t)] dx = A + \ln (t); w$  here A is a constant. O ne can also exam ine the scaling properties of the second m om ent for the same process using the FV SM . O ne version of FV SM is the standard deviation analysis (SDA) [2] which is based on the evaluation of the standard deviation D (t) of the same variable x and pdf p(x;t), and yields D (t) = \int\_{1}^{1} f\_{x}^{2}; ti hx; ti^{2} / t^{H} [2, 6].

Note that the entropy S (t) does not require the variance of the pdf p(x;t) to be nite [2]. The existence of scaling for a process with a diverging second m om ent in – plies that DEA is complementary to and not simply an alternative to FVSM. So, the scaling exponent is conceptually di erent from the Hurst exponent H m easured by m eans of the FVSM. This suggests that the scaling exponents and H m ay full llmultiple relations according to the process under study and, therefore, the combined use of DEA, SDA and pdf analysism ay increase our understanding of complex phenom ena through a M SCA.

Herein we focus on the statistics of interm ittent noises. The simplest way to represent interm ittent noise f  $_{\rm i}$ g is through a dichotom ous representation in which the value

= 1 indicates the occurrence of an event and the value

= 0 represents no-event [10, 11, 12, 13]. An interm ittent noise is characterized by the correlation properties of the waiting time sequence f  $_{\rm j}$ g between consecutive events and by its waiting time distribution (). There are two basic distinct form s of interm ittent noises:

1) Fractal Gaussian interm ittent noise is characterized by a long-range correlated waiting time sequence,  $h_{i \ i+t}i/t^{2H}^2$ , and by a nite variance waiting time distribution () whose form may be, for example, that of a Gaussian, exponential or Poisson distribution. The di usion generated by a fractal Gaussian interm ittent noise is a particular type of fBm and satis es the asymp-




FIG.1: DEA end SDA of A]a fractalG aussian interm ittent noise with ()/ exp( =) with = 25 and H = = 0:75; the fractalG aussian relation (1) of equal exponents is fullled; B]a Levy-walk interm ittent noise with ()/ and = 2:5; note the bifurcation between H = 0:75 and = 0:67 caused by the Levy-walk relation (2).

totic scaling realtion between indices

$$= H : (1)$$

W e refer to (1) as the fractal G aussian di usion relation. If the long-range correlations of f  $_{i}$ g are destroyed via shu ing, the new interm ittent sequence is characterized by the value H = = 0.5 of random time series. Fig. 1A shows the scaling properties of a computer generated fractal G aussian interm ittent noise with an exponential waiting time distribution and H = = 0:75.

2) Levy-walk interm ittent noise is characterized by an uncorrelated waiting time sequence,  $h_{i}_{ji}/i_{ji}$ , and a Levy or an inverse power law waiting time distribution () / (T + ); with 2 < 3 that ensures that although the rst moment of is nite, the second moment diverges. The presence of a Levy-walk process in a given time series can be detected [2, 10] by mean of the following asymptotic relation among the three exponents

W e refer to (2) as the Levy-walk di usion relation. Interesting applications of this type of noise have been found in several Levy phenom ena including the distribution of solar ares [10, 11, 12, 13, 14]. In the particular case in which the sequence f ig is correlated the scaling exponents and H are larger than the values predicted by Eq. (2). Fig. 1B shows the scaling properties of a computer generated random Levy-walk interm ittent noise with = 2:5 that has H = 0:75 and = 0:67.

We stress that the Levy-walk relation (2) is fulled if the waiting times f  $_{i}$ g are uncorrelated, in which case any shu ing off  $_{i}$ g would not alter the scaling exponents H and . In fact, the super-di usion scaling exponents 0:5 < < H < 1 of a Levy-walk interm ittent noise are related to the fatness of the waiting time inverse power law tail, as measured by the exponent . Contrary to a fractal G aussian interm ittent noise, this Levy scaling does not imply a temporal correlation, or a historical m em ory, am ong events because the occurrence of future events is independent of the frequency of past events.

We also observe that there exist particular interm ittent sequences obtained by mixing Levy and Gaussian noises [12], with a Levy memory beyond memory [15] or by substituting an event with a cluster of events [4]. In these cases the asymptotic properties of the scaling exponent H and are expected to depend on the component, Gaussian or Levy, with the strongest persistence.

The relations (1) and (2), and the correlation/shu ing e ects indicate that the DEA should be jointly used with the FVSM and/or pdfs. The adoption of a single technique can lead to a m isinterpretation of the characteristics of a phenom enon, because Levy-walk interm ittent noise can be confused with fractalG aussian interm ittent noise, and uncorrelated noise of one kind of statistics can be m istaken for correlated noise with another kind of statistics. Figs. 1A and 1B clearly show that the determ ination of only one of the two exponents H and is not su cient to conclude whether a phenom enon is characterized by a Levy-walk interm ittent statistics or by a fractalG aussian interm ittent statistics. So, we suggest a M SCA by com bining com plem entary techniques.

Recently, DEA has been applied by Mega et al. [4] to study the time distribution of earthquakes in Southern California (20°-45° N latitude and 100°-125° W longitude) from 1976 to 2002. The catalog [16] is complete for local events with m agnitude M 3 since 1932, for 1:8 since 1981 and for M 0 since 1984. The М tim e intervals between large earthquakes was studied in Ref. [4] by setting a tem poralvariable (t) = 1 at the occurrence of an earthquake with a magnitude larger than a given threshold M  $_{t}$ , and by setting (t) = 0 when no earthquake of the speci ed m agnitude occurs. W e refer to f ig as the waiting time sequence between consecutive earthquakes with M Mt. So, the intermittent sequence (t) was analyzed by m eans of the DEA and the m easured scaling exponent was = 0.94 0.01. The authors of Ref. [4] concluded that the time intervals, <sup>[m]</sup>, between two consecutive Om ori's earthquake clusters [17] is modeled by an inverse power law  $\binom{[m]}{}$  /  $\binom{[m]}{}$  with an exponent = 2:06 calculated via Eq. (2). This calculation was based on the traditional assumption [4] that the waiting tim es between such clusters are uncorrelated  $(h_{i} \begin{bmatrix} m \\ j \end{bmatrix}^{m}) = i_{j}$ , in plying that the observed superdiffusion is induced by a Levy-walk between the Omori's clusters. Finally, M eqa et al. [4] showed that a synthetic sequence produced with Om ori's uncorrelated clusters,  $h_{i}^{[m]} i_{j}^{[m]} = i_{j}$ , tem porally distributed according to an inverse power law (<sup>[m]</sup>) / (<sup>[m]</sup>) with = 2:06, generates a superdi usive process with = 0.94.

However, the authors of Ref. [4] did not m ake the in – portant distinction between Levy-walk and fractalG aussian interm ittent noises such as we did above. We showed that a scaling exponent in the range 0.5 < 1 can be




FIG.2: pdf of the waiting times  $_{i}$  of earthquakes with a magnitude M M  $_{t}$  = 1, 2, 3 and 4. The initial P () / 1= is the Omori's law [17].

associated with either a correlated fractal G aussian interm ittent noise or with an uncorrelated Levy-walk noise. Consequently we apply a M SCA to determ ine which of the two statistics better describes the data.

Fig. 2 shows the waiting time pdfs between earthquakes using four magnitude thresholds  $M_t = 1, 2,$ 3 and 4. The pdfs show an initial Omori's law [17]  $(\mathbb{P}() / 1 = )$ , but the pdf tails present a large inverse power law exponent > 4 and m ay even approach an exponential (or Poisson) distribution asymptotically. The Om ori's law is determined by the short-range correlated aftershocks [17] and lasts for a time that increases with the magnitude threshold. If the waiting time distribution between 0 m ori's clusters were an inverse power law with = 2.06 it might be expected that by increasing the magnitude threshold, most of the aftershocks could be cut o and the tail of the distribution could converge to an inverse power law with = 2.06. This does not seem to happen. Therefore, such an = 2.06 inverse power law, if it is real, cannot be observed in this way.




FIG. 3: DEA and SDA of the interm ittent time signal (t) for magnitude M  $M_t = 1$ . The data are tted with scaling exponents = 0:944 0:008 and H = 0:943 0:004. The upperm ost solid line with H = 0:97 corresponds to the expectation of H if the Levy-walk condition (2) holds true.

Fig. 3 compares the DEA and SDA applied to the interm ittent sequence (t) of earthquakes with M 1. Dierent magnitude thresholds give similar results. If these data corresponded to a random interm ittent Levywalk and if the curves shown in the gure corresponded to the asymptotic regime, the condition (2) interrelating the exponents should hold. A rigorous DEA t in the range  $2^7: 2^{15}$  gives = 0:944 0:008 im plying a Levy-walk H = 0.97 0.005. Instead, the same-range SDA t gives H = 0.943 0.004: The error analysis seems to con m better the Gaussian relation of equal scaling exponents (1) because and H overlap within the statistical error as in Fig. 1A, while the di erence between the measured H and the Levy-walk H is statistically signi cant (p < 0:01). By shu ing the earthquake waiting time intervals  $f_{ig}$  we get H = 0.5. Finally, by directly applying DEA

and SDA to the waiting time series f  $_{i}$ g, we again get = H = 0.94. These notings suggest that the data do not full the Levy-walk relation (2) and that it might be more likely that the Californian earthquakes are longrange temporal correlated according to the persistence of a fractal G aussian interm ittent noise with H 1 known as 1=f or pink noise [7].




FIG. 4: DEA applied to a 1=f long-range correlated Generalized Poisson model (circle) for earthquakes for M 1. The intercluster waiting time pdf ( ${}^{[m]}$ ) is exponential and  $h_i^{[m]} \stackrel{[m]}{}_{i^+t}$ i /  $t^{2H}$  with H 1. The curve with triangles refers to the case in which the intercluster waiting time sequence f  ${}^{[m]}_{i}$ g is random ized such that  $h_i^{[m]} \stackrel{[m]}{}_{i^-}$ i /  ${}^{ij}$ .

The curve with circles in Fig. 4 shows the DEA applied to a synthetic earthquake catalog obtained by coloring a kind of Generalized Poisson model for earthquakes. First we generated several Omori's clusters exactly as done in Ref. [4], that is, by assuming that the number of earthquakes in a cluster follows an inverse power law distribution with exponent equal to 2.5 and that the events within the same cluster are temporally distributed according to the Om ori's law, that is, an inverse power law with exponent equal to p = 1. We generated a total number of events equal to the total number of earthquakes in the catalog with a magnitude threshold  $M_t = 1$ . How ever, contrary to what was done in Ref. [4], we do not random ly (h  $\begin{bmatrix} m \\ i \end{bmatrix}$   $\begin{bmatrix} m \\ j \end{bmatrix}$  i / ij) position these clusters according to an inverse power law intercluster waiting time distribution  $\binom{[m]}{1} / 1 = \text{with} = 2.06$ . Instead, we distribute the clusters according to a 1=f fractal G aussian intermittent noise f  $\int_{i}^{m}$  g that is, with  $h_{i}^{[m]}_{i+t}$  i/  $t^{2H}^{2H}_{2}$  and H 1. The intercluster waiting time distribution  $\binom{[m]}{} / \exp(\frac{[m]_{=}}{})$  shown in the insert of Fig. 4 could be substituted with any other distribution with nite variance. Fig. 4 show that them odel is able to reproduce the sam e superdi usion pattern shown by the data. Finally, the curve with triangles shows the reduction of long-range persistency of a synthetic catalog obtained with the same clusters of above but tem porally distributed after having shu ed, to random ize, the sam e

intercluster waiting time sequence  $f_{i}^{m}$ g.

However, Eqs. (1) and (2) are fulled only asymptotically where the Central L in it Theorem for Gaussian processes or its generalization for Levy processes apply [9]. There m ight be the possibility that Fig. 3 as well as gure 2 in Ref. [4] do not show the asymptotic lim it but a transition regime that is strongly superdiusive 1) because of the Om ori's intracluster short-range ( correlations. A long transition regime is also evident in the curve with triangles shown in Fig. 4 that refers to an uncorrelated intercluster waiting time sequence and should asymptotically converge to = 0.5. In fact, also a random Generalized Poisson modelor an \ETAS" model [18] with appropriate param etersm ay generate a synthetic catalog showing superdi usive properties similar to the realdata within a time range [19]. However, we observe that such a result m ay depend too strongly on the particular param eters used in the models.

In conclusion, we have discussed som e of the di culties that can be encountered in interpreting interm ittent sequences and shown that models with alternative statistics can reproduce som e pattern of a tim e series equally well. This fact suggests the need of an analysis involving com plem entary tests. In particular we showed how to distinquish fractalG aussian interm ittent noise from Levy-walk intermittent noise using MSCA. This methodology has in portant application in the analysis of phenom ena having interm ittent signals because di erent statistics in ply di erent dynam ics. Our analysis supports the idea that earthquakes generate strain di usion, whose propagation over hundreds of kilom eters induces rem ote sism ic activity [3, 20]. This propagation according to our statistical analysis produces correlations in the time intervals between earthquake clusters. In fact, the thesis that earthquakes are assembled into uncorrelated 0 m ori's clusters,  $h_i^{[m]} j_j^{[m]} i = i_j$ , as both the standard G eneralized P oisson m odel [4] and the Levy-walk m odel [4] require, seem s unrealistic. We suggest that it is more plausible that earthquake clusters are 1=f long-range correlated and, perhaps, they are subclusters of a larger 0 m ori cluster. In fact, a 1=f noise can be generated by the superposition of relaxation processes within a wide range of energies [7] that m ay well describe the coexistent stress alterations caused by old and recent, as well as large and sm all shocks. Thus, the 1=f long-range correlations m ay im ply that earthquake occurrences m ay strongly depend on the geological history of a vast region.
