Bose-Einstein Condensation Temperature of a Homogeneous Weakly Interacting Bose
Gas: PIM C study

U sing a nite-tem perature Path Integral M onte C arib simulation (P IM C) method and nite-size scaling, we have investigated the interaction-induced shift of the phase transition tem perature for B ose-E instein condensation of hom ogeneous weakly interacting B ose gases in three dimensions, which is given by a proposed analytical expression  $T_c = T_c^0 f 1 + c_1 a n^{1-3} + [c_2^0 \ln (a n^{1-3}) + c_2^0 l a^2 n^{2-3} + O(a^3 n)g$ , where  $T_c^0$  is the critical tem perature for an ideal gas, a is the s-wave scattering length, and n is the number density. We have used smaller number densities and more time slices than in the previous P IM C simulations [G nuter et al., P hys. R ev. Lett. 79, 3549 (1997)] in order to understand the difference in the value of the coefficient  $c_1$  between their results and the (apparently) other reliable results in the literature. Our results show that  $f(T_c = T_c^0) = T_c^0 g = (a n^{1-3})$  depends strongly on the interaction strength an  $c_1 = 1.32 = 0.14$ , in agreement with results from recent M onte C arib methods of three-dimensional O (2) scalar  $c_1 = 1.32 = 0.14$  eld theory and variational perturbation theory.

## I. INTRODUCTION

Since the recent achievem ent of experim ental observation of Bose-Einstein Condensation (BEC) in magnetically trapped atom ic vapors[1], these inhom ogeneous systems have attracted considerable interest from experim entaland theoretical sides. In dilute or weakly interacting gases, the G ross-P itaevskii (GP) theory, a mean-eld theory, for the condensate wave function has been enormously successful in describing the extraordinary properties of the condensate. (For a recent review of num erous successful applications of mean eld theories in Bose-Einstein condensation in atom ic gases see Ref. (2).) However, the determination of the e ect of repulsive interactions on the transition temperature of a homogeneous dilute Bose gas at a xed density has had a long and controversial history [3, 4, 5, 6, 7, 8, 9, 10, 11, 12, 13, 14, 15, 16, 17, 18, 19, 20, 21, 22, 23, 24, 25, 26, 27, 28, 29]. This non-trivial problem has been treated by dierent methods with dierent results. One of the reasons for the multitude of results and methods stems from the fact that the phase transition is second order, and perturbation theory typically breaks down for physical quantities sensitive to the collective long-wavelength modes close to the transition due to infrared (IR) divergences. Moreover, the interaction, no matter how small, changes the universality class of the phase transition from the Gaussian complex-eld model to that of the XY-model.

In the weak interaction (or dilute)  $\lim$  it, the strength of the interatom ic interactions can be characterized by the s-wave scattering length a. The shift T  $_{\rm c}$  (T  $_{\rm c}$  T  $_{\rm c}^0$ ) of the BEC transition temperature of a homogeneous Bose gas away from its ideal-gas value

where m is the particle mass,  $k_B$  is the Boltzmann constant, n is the number density, (s) is the R ismann zeta function,  $\frac{2}{2}$ ) 2:612, and  $c_1$  is a numerical coecient. Additionally, M. Holzmann et al. [13] have argued that a logarithm is term appears at order- $a^2$  in Eq. (2), and they have shown that this term is of the form  $c_2^0 a^2 n^{2-3} \ln{(an^{1-3})}$ . They also estimated the value of the numerical coecient  $c_2^0$  using large- $N_s$  arguments in the three-dimensional O  $(N_s)$  eld theory. Later, A mold et al.[17] were able to show that the transition temperature for a dilute, hom ogeneous, 3D Bose gas can be expressed to leading order as

where  $c_2^0$  ' 19:7518 can be calculated perturbatively, whereas  $c_1$  and  $c_2^{00}$  require non-perturbative techniques. W ith the help of M onte C arlo data they estim ated  $c_2^{00}$ 75:7; however, a strong debate concerns the values of the other num erical coe cients, especially c1 which has been com puted using various non-perturbative m ethods and M onte Carlo techniques. There are num erous estimates for the parameter c1 describing the leading deviation of the BEC temperature due to a small repulsive interaction, and the range of variation of di erent predictions is from 0.34 (Ref. 6) to 4.66 (Ref. 21); these have been sum marized for instance in Refs. (10, 16, 30). It appears that the most reliable results so far are obtained by M onte Carlo (MC) simulations of three-dimensional 0 (2) scalar  $^4$  eld theory,  $c_1 = 1.29$  0.05 determ ined by Kashumikov et al.[24] and  $c_1 = 1.32$ 0.02 determ ined by A mold et al.[16], and by variational perturbation theory (VPT),  $c_1 = 1.27$  0.11 determ ined by

K astening [29]. In particular, G ruter et al. [6] investigated the dependence of T c num erically using Path Integral M onte Carlo m ethods. They obtained the value of  $c_1$  = 0.06 after num erical extrapolation of the calcu-0.34 lation to the limita! 0. This value is about 4 times sm aller than the above results. Holzmann et al.[13] arqued that the di erence in these results is attributable to a nonanalytic structure, a<sup>2</sup> In a, of the transition temperature in a, and that this correction gives rise to a strong dependence on a, even in the very dilute lim it. A mold et al. [16] believed that one likely problem with the PIMC simulation of Gruter et al.[6] is inadequate system size. K ashumikov et al.[24] stated that the PIMC simulation did not reach the universality region because the m in im al value of  $na^3$  was 10  $^5$ .

In this paper, we attempt to understand the dierence in the value of the coe cient  $c_1$  between results from PIMC and the above results. We have used a nite-temperature path-integral Monte Carlo (PIMC) method [31] to study the dependence on interaction strength of the phase transition temperature for Bose-Einstein Condensation of weakly interacting Bose gases in three dimension. Although our PIMC method is the same as that used by Gruter et al., we have used smaller number densities and more time slices than in the previous PIMC simulations, as motivated above.

## II. SIM U LATION M ETHOD AND DEFINITION OF THE PHYSICAL QUANTITIES

We wish to study the problem of a quantum N-particle system in order to compute the phase transition temperature  $T_{\rm c}$  for dilute or weakly interacting Bose gases in three dimensions. We assume that the interparticle interaction can be described by a positive scattering length a, equivalent to the interaction of hard spheres of diameter a (see, e.g., Refs. [2,3]). The Hamiltonian for this system may be written as

where v(r) is the hard-sphere potential de ned by

The statistical mechanics of quantum systems is governed by the density matrix. For a system of N bosons at an inverse temperature , the Bose-sym metrized density matrix is given by

where R and R  $^{0}$  are two con gurations of N hard spheres. P denotes a permutation of particle labels among hard spheres, and PR is one such permutation. Evaluating the density matrix for interacting systems at very low temperatures is complicated by the fact that the kinetic and potential terms in the exponent of the density matrix cannot be separated. We can aviod this problem by inserting M 1 intermediate congurations into Eq.(5) to obtain the path-integral formulation of the density matrix.

where =  $1=k_B T$  and = =M is the imaginary time step. The problem of evaluating the density matrix at a low tem perature 1 has been replaced by the problem of multiple integration of density matrices at a higher tem perature 1. The sum overpermutations in Eq.(5) com bined with the integration in Eq.(6) can be evaluated in path-integral M onte Carlo (PIMC) by a stochastic sam pling of the discrete paths fR ;R 1;R 2;  $_{M}$ R<sub>1</sub>;PR $^{0}$ g using multilevel Monte Carlo sampling [31], an extension of the standard M etropolis m ethod [32]. The P IM C m ethod is essentially exact, the only necessary input being the interparticle potential or equivalently the scattering length a. In order to use M onte Carlo sampling, we must rst provide a pair-product form of the exact twobody density matrices for the high-tem perature density m atrices that appear in the integrand Eq.(6). We used the high-tem perature approximation for the hard-sphere propagator derived by Cao and Beme[33]. In order to choose the value of M , we perform ed consistency checks by varying M to see that the results have converged. We used up to freen time-slices (M = 15). We performed PIMC in the continuum. The particles were con ned to a cubic box with volume V and edge length  $L = V^{1=3}$ , to which periodic boundary conditions were applied. We em ployed the canonical ensemble, i.e. in each simulation we xed the tem perature T, the number of particles N, and the dimensions L of the simulation cell. 20,000 -30,000 M C steps are required for equilibration depending on the number density. Statistical averages are collected from 30,000 MC steps after this. In each MC step, we attempted 50 -800 trialm oves at each time slice. We perform ed these calculations partly on IBM SP2 and partly on PC at the University of Georgia. The smallest-density simulations took about 350 CPU hours on IBM SP2.

The scaling functions for the condensate density and the super uid density are similar and imply that in the (dilute) interacting 3D Bose gas condensation and super uidity occur at precisely the same temperature. Super uid density can be calculated using the winding number W for simulations that have periodic boundary conditions  $\beta 4$ ]. Nonzero winding numbers occur when particles, through a series of permutations, are permuted with periodic images of them selves. The winding numbers

ber is directly related to  $_s$ , the super uid density. The super uid density is given by [34]

where the winding number W is de ned by

In order to obtain an estimate of the super uid transition temperature  $T_{\rm c}$ , we perform a nite-size scaling analysis. Near the critical temperature  $T_{\rm c}$ , the nite-size behavior of the super uid density obeys the scaled form [35]

is the critical exponent of the bulk superw here uid fraction, s(t)=t, t = T $T_{c}$ )= $T_{c}$ the correlation length exponent, (t) t , and the universal function f (tL1=) must be analytic for nite argument. It is assumed that is indicated by experiment [36], renormalization-group calculation [37], and the Josephson hyperscaling relation = (d 2) . In obtaining an estim ate of the critical tem perature  $T_c$ , we did not use Eq. (9) directly because of large statistical errors in our data (see Fig 2(a)). Instead we tour data for dierent temperatures T and several values N of the total number of particles to a linear form for f

where the dimensionless N  $^{1=3}$  has replaced the length L . From the tting, we determined four tting parameters f (0), f\_0, , and  $T_{\rm c}\,.$ 

## III. SIM U LATION RESULTS AND DISCUSSION

The main goal of this paper is to determ ine the critical temperature  $T_c$  of a 3D hom ogeneous system of hardsphere bosons by path-integral M onte C arlo simulations and nite-size scaling. We have calculated the super uid fraction  $_s(T;N)=$  for various number densities n at a xed hard-sphere diameter a.

In order to check the program carefully, we determ ined the critical temperature  $T_c^{\,0}$  and the total energy density in the noninteracting case, both of which are known exactly. Fig. 1(a) shows the scaled super uid fraction N  $^{1=3}$   $_{\rm S}$  (t;N )= , scaled temperature tN  $^{1=3}$  , and the resulting linear t (solid line) to Eq. (10) for the noninteracting hard spheres. The best t parameters are the




FIG. 1: Results for the noninteracting case. (a) The scaled super uid fraction N  $^{1=3}$   $_{\rm S}$  (t;N )= as a function of scaled tem – peratures tN  $^{1=3}$  . The solid line is a linear tto Eq. (10). The best t parameters are the critical tem perature of  $T_{\rm c} = T_{\rm c}^{\,0} = 1.000\,(1)$  and the correlation length exponent of = 0.90(6). (b) The total energy density as a function of the number of particles with a straight line t to Eq. (14). From the twe obtain the energy density in the therm odynam ic lim it (N ! 1).

critical tem perature of  $T_c = T_c^0 = 1.000$  (1) and the correlation length exponent of = 0.90 (6), in agreement with the theoretical exact values, namely  $T_c = T_c^0 = 1$  and = 1.

From the expression for the specic heat c(t;L),

we obtain the energy density E (t;L), via integration, up to a constant

where  $t = (T T_c) = T_c$ . De ning dD (x)=dx = g(x), we write the speci c heat as follows:

where g(x) is a universal scaling function for the speci c heat. For t! 0 we obtain




FIG. 2: Determ ination of the critical temperature  $T_c$  at a xed number density n=5 10  $^3$  for the interacting case. (a) The scaled super uid fraction N  $^{1=3}$   $_s$  (t;N )= as a function of scaled temperatures  $T=T_c^0$ . The four lines cross at the critical temperature. (b) Result of our linear t (solid straight line) to the data from Eq. (10). Our estimated critical temperature is  $T_c=T_c^0=1.078$  (1).

The result of the tof the energy density data to Eq. (14) is shown in Fig. 1(b). In the twe used = 1 and = 1 for an ideal Bose gas. If we exclude the data




FIG.3: Scaled super uid fraction N  $^{1=3}$   $_{\rm S}$  (t;N )=  $\,$  vs tN  $^{1=3}$  at the sm allest number density n = 1  $\,$  10  $^{7}$  we used in this study. Our estimated critical temperature is  $T_{\rm c} = T_{\rm c}^{~0} = 1.0061\,(14)$ .

corresponding to the smallest lattice, we obtain an estimate for the energy density in the thermodynamic limit (N  $\,!\,$  1 ) which agrees with the exactly known value within an errorbar.

In the interacting case, we have calculated the super uid fraction and estimated the critical temperatures for various hard-sphere diameters a at a xed number density. We can see that the critical temperature approaches  $T_c = T_c^0$  as the hard-sphere diameter decreases (not shown), as expected.

In order to study the e ect of interactions on the transition temparature, we calculated the super uid fraction  $_{\rm S}$  (t;N )= and determ ined the critical temperatures  $T_{\rm c}$  (n) for various number densities 1  $\,$  10  $^{7}$   $\,$  n 5  $\,$  10  $^{3}$  .

G ruter, Ceperley, and Laloe [6] investigated the dependence of  $T_c$  num erically using P IM C (to be referred to here as PRL97). In order to compare our estimated critical tem perature with PRL97 data, we have calculated the super uid fraction  $_{s}=$  (T;N) for N = 27, 64, 125, and 216 as a function of temperature  $T = T_c^0$  at a xed num ber density n = 5 10  $^3$  . Fig. 2 shows our data (Fig. 2(a)) and our result of a linear t (solid straight line) to the data (Fig. 2(b)) using Eq. (10). Our calculated super uid fractions s(t;N) = are signi cantly larger than PRL 97 data (cf. Fig. 1 of Ref. 6) and our estim ated critical tem perature is  $T_c = T_c^0 = 1.078$  (1), which is higher than PRL97 data,  $T_c=T_c^0=1.057$  (2) (cf. Fig. 2 of Ref. 6). We don't understand the reason for this large di erence. In Fig. 3 we also show the scaled data and the resulting linear tat the smallest number density n  $= 1 ext{10}^{7}$  we used in this study. Our estimated critical tem perature is  $T_c=T_c^0=1.0061(14)$ .

The resulting dependence of the transition tempera-




FIG. 4: Our calculated dependence of the interaction-induced shift of the transition temperature of a dilute homogeneous Bose gas on the scattering length an  $^{1-3}$ : (a) (  $T_{\rm c} = T_{\rm c}^{\, 0}$ )=an  $^{1-3}$  (b)  $T_{\rm c} = T_{\rm c}^{\, 0}$ . Whenever not shown, the error bars in our simulation data are smaller than the symbol sizes. We also plotted the PRL97 data (Open circles) and Eq. (3) using A mold's results[16] (Solid line). (a) (  $T_{\rm c} = T_{\rm c}^{\, 0}$ )=an  $^{1-3}$  depends on the interaction strength an  $^{1-3}$  while the PRL97 data are considerably atter and smaller than our results. (b) The linear behavior is seen only at small value of an  $^{1-3}$ . The dashed straight line is a too ur four smallest data points. We found that the slope (c<sub>1</sub>) is 1.32 (14).

ture (a) ( T  $_{\rm c}$ =T $_{\rm c}^{\rm 0}$ )=an $^{\rm 1=3}$  (b) T  $_{\rm c}$ =T $_{\rm c}^{\rm 0}$  on an $^{\rm 1=3}$  is shown in Fig. 4. W henever not shown, the error bars in our sim ulation data are smaller than the symbol sizes. We also show com parisons between our results (Filled circles), the PRL97 data (Open circles), and Eq. (3) using A mold's results[16] (Solid line). We see that the ( T  $_{\rm c}$ =T $_{\rm c}^{\rm 0}$ )=an $^{\rm 1=3}$ depends on the interaction strength an 1=3 while the PRL97 data are considerably atter and smaller than our results (see Fig. 4(a)). Our calculated data approach to A mold's results. The linear behavior is seen only at small value of an 1=3 (see Fig. 4 (b)). Our calculated data are slightly larger than Eq. (3) using A mold's results[16] (Solid line) in the linear region. The dashed straight line is a t to our data points for the four smallest values of n. We found that the slope  $(c_1)$  is 1.32 This is in agreem entwith the recent MC values of threedim ensional O (2) scalar  $^4$  eld theory,  $c_1 = 1.29$  0.05 (Ref. 24) and  $c_1 = 1.32$  0.02 (Ref. 16), and the result by variational perturbation theory (VPT),  $c_1 = 1.27$ 0.11 (Ref. 29).

In sum mary, we have determined the interaction-induced shift of the phase transition temperature for Bose-Einstein condensation of hom ogeneous weakly interacting Bose gases in three dimensions using PIMC and nite-size scaling. Our results show that f( $T_c$   $T_c^0$ )= $T_c^0$ g=(an<sup>1=3</sup>) depends on the interaction strength an<sup>1=3</sup> while the previous PIMC results[6] are considerably atter and smaller than our results. We obtain  $c_1$  = 1.32 0.14, in agreement with results from recent Monte Carlo methods of three-dimensional O(2) scalar <sup>4</sup> eld theory [16, 24] and variational perturbation theory [29].
