We consider the random lasing from a weakly scattering medium and dem onstrate that the distribution of the threshold gain over the ensemble of statistically independent nite-size samples is universal. Universality stems from the facts that: (i) lasing threshold in a given sample is determined by the highestquality mode of all the random resonators present in the sample, and (ii) the areal density of the random resonators decays sharply with the quality factor of the mode that they trap. We nd analytically the shape of the universal distribution function of the lasing threshold. The shape of this function is governed by a single dimensionless parameter, . This parameter increases as a power law with ln S, where S is the sample area (length, volume), and decreases as a power law with disorder strength. The powers depend on the microscopic mechanism of the light trapping. As a result, the distribution of the thresholds narrow s with S and broadens with the disorder strength.

### I. Introduction

During the last ve years the phenom enon of coherent random lasing has been observed in a wide variety of disordered media. These include sem iconductor pow ders<sup>1</sup>, In ŝ, dye-in Itrated opalŝ, etc. The fact, that beyond a certain optipolvm er cal excitation threshold, the random media em its a coherent light (this fact was dem onstrated in the photon statistics experim ents<sup>3;4</sup>) suggests that certain disorder con gurations in the medium (random resonators) are capable of \trapping" the light, thus assuming the role of the conventional Fabry-Perot resonators. These con gurations are sparse, since on average the light propagation in the media is di usive, i.e. the condition kl 1 is met, where k is the wave number and 1 is the m ean free path. As it was dem onstrated analytically,<sup>5</sup> even for a given kl{value, the ability of the medium to form resonators depends strongly on the character of the disorder. For example, from the point of view of trapping the light, sm ooth disorder is much more favorable than the point-like scatterers<sup>5</sup> (see also Ref. 6). It is also clear on the general grounds, that two statistically identical disordered samples of nite size have di erent thresholds for coherent lasing. This is because the most \capable" random resonators, that are present in each sam ple and determ ine its lasing threshold, have di erent quality factors. Therefore, the study of the threshold dependence on the sam ple size requires a statistical description.

Consider for concreteness a polymer Im. Then the role of the sample size is

simply played by the area, S, of the excitation spot. Quantitatively, the change of the threshold excitation intensity, I, with S should be characterized by the evolution of the distribution function,  $F_S$  (I), of the thresholds over m any non-overlapping spots. N am ely, the position of m axim um of  $F_S$  (I), that describes the threshold of a typical sample, should shift towards lower I with increasing S, whereas the width, that carries the inform ation about the spread of the thresholds in dimension gamples, should decrease with S.

The main message of the present paper is that the shape of the function  $F_S$  (I) is universal and is given by

where the typical value,  $I_{\rm S}$  , is related to the sam ple area S  $% I_{\rm S}$  as follows

where the parameters > 1 and G are determined by the intrinsic properties of the disordered medium and are independent of S; the area S<sub>0</sub> is a typical area of a random resonator. These two parameters play a dierent role: while is determined exclusively by the shape of the disorder correlator, G is a measure of the disorder strength. The dependence of s on S is logarithmical, namely, s / [ln (S=S<sub>0</sub>)]<sup>(1)=</sup>. M ost importantly, parameter s decreases with the disorder parameter (kl)<sup>1</sup> as a power law, i.e. for a weakly scattering medium we have s 1. The concrete value of the exponent @ ln =@ ln (kl) depends on the microscopic properties of the disorder.

Experimentally, establishing the form of the distribution function amounts to dividing of the measured values of I into \bins" and constructing a hystogram from these bins. In this regard, it is convenient to the data to the theory using the momenta of the distribution, calculated with the help of experimentally determined hystogram. In particular, as it easily follows from Eq. (1), the rstmoment is given by

where (x) is the -function. It can be also shown from Eq. (1) that the average logarithm of I=hIi is given by

Here 0:5772 is the Euler's constant. The dependence (u) is shown in Fig. 1. It diverges as  $\ln(u - 1)$  in the limit u + 1 and approaches zero as (u)  $\frac{2}{12u^2}$  for u - 1. The relations Eq. (3) and Eq. (5) are su-cient to restore the parameters  $I_S$  and  $_S$  from experimentally measured hystogram. Indeed, calculating from the data the values of hI i and hln I i, allows rst to determ ine the parameter  $_S$  from Fig. 1, and subsequently, the parameter  $I_S$  from Eq. (3). C on parison of the experimental distribution with theoretical prediction Eq. (1) allows to test the basic underlying assumption about the statistical independence of dimensional resonators. On the quantitative level, it allows to determ ine , which is strongly sensitive to the microscopic arrangement of the disorder-induced resonator.

The distribution function Eq. (1) is plotted in Fig. 2 for three values of  $_{\rm s}$ . Firstly, we observe that for smallest  $_{\rm s}$  the distribution  $F_{\rm s}$  (I) is broad and strongly asymmetric. It has a long tail towards the high thresholds and falls o abruptly towards low thresholds. Our main qualitative prediction is that in experiments on random lasers the distribution of thresholds over samples must have a distinctive shape similar to that of the curve 1 in Fig. 2. Indeed, experimentally, the lasing is observed only when the disorder is strong enough. The realistic values<sup>5</sup> of the disorder parameter klare 5. On the other hand, strong disorder translates into the values of the parameter  $_{\rm s}$  that are 1.

As disorder decreases, leading to the rise of the average threshold, the distribution  $F_S$  (I) becomes progressively narrow and symmetric. For highest  $_{s} = 6$  (qurve 3 in Fig. 2) this distribution is close to gaussian,  $F_S$  (I) / exp  $\frac{2}{2}$   $\frac{1}{L_S}$   $E^2$ . We emphasize, that the distribution Eq. (1) is derived under the assumption that all samples (excitation spots) are statistically independent. Therefore, experimental observation of a strongly asymmetric distribution of thresholds over samples would be a conmation that the underlying disordered medium is hom ogeneous on average, i.e. it does not contain large-size uctuations of technological origin (larger than the sample size). The remaining part of the paper is organized as follows. In Sect. II we demonstrate that, with accuracy of a numerical factor, the basic characteristics of the distribution Eq. (1) can be found from a simple reasoning. In Sect. III we provide a rigorous derivation of Eq. (1). In Sect. IV we justify the validity of the basic assumption behind Eq. (1) concerning the functional form of the density of the distribution of Eq. (1) we discuss the tests of the applicability of the

distribution (1) based on the relations between the di erent cum ulants. The details of the calculation of these cum ulants are presented in the Appendix.

# II. Qualitative consideration

The position of maximum and the width of the distribution function  $F_s$  can be found following the qualitative consideration of Refs. 8{10. Denote with (Q) the areal density of disorder-induced resonators with the quality factor Q. This density represents the statistical weight of disorder con gurations that are capable of trapping a mode with an anom alously sm all relative linewidth, Q<sup>1</sup> 1. According to the de nition, (Q) is the characteristics of an in nite medium. It describes the ability of the medium to trap the light wave for anom alously long time (namely, for Q wave periods). Note, that (Q) is a meaningful characteristics of the medium in two and three dimensions, where the light propagation is di usive on average.

The function (Q) was calculated analytically for certain models of disorder in Refs. 5,11,12. The related quantity was also invoked in Ref. 13 for the analysis of simulation results. Similar function was studied in relation to current relaxation in disordered conductors<sup>14{17</sup>. All analytical results obtained within di erent approaches and for di erent models of disorder yield the same general form of the density (Q) in the large-Q limit, namely

where, within a num erical factor, G is related to the average \conductance", kl, of the disordered m edium as G = (kl), with being a model-dependent exponent. The power, , of the lnQ in Eq. (6) does not depend on the kl-value. It is determined exclusively by the form of the correlation function of the disorder.

The position of the maximum of the threshold distribution follows from a simple observation that the number of highest-Q resonators, responsible for lasing in a typical sample, is 1. This observation can be expressed analytically as

Eq. (7) can be viewed as an equation for  $Q_s$ , which is the quality factor of the highest-Q resonator present in a typical sample. Substituting the form (6) of (Q) into Eq. (7), we obtain

In order to estim ate the width of the distribution, we introduce the auxiliary quantity  $Q_s$ , de ned as the maximal Q-factor of a resonator which is present in alm ost all the samples. Since the density (Q) grows rapidly with Q, the de nition of  $Q_s$  can be quantized by the condition

meaning that if the number of resonators is 2 on average, even with uctuations

Finally, it is reasonable to assume that maximal Q-factors within the ensemble of samples lie within the interval between  $Q_s$  and  $Q_s$ , which yields the following estimate for the distribution width in the logarithm ic scale

### III. D erivation of Eq. (1)

The disorder con gurations constituting high-Q resonators are sparse, so that di erent resonators are statistically independent. Then the distribution function of the number, N (Q;S), of resonators with quality factor in the interval [Q;Q + dQ] within the area S is Poissonian

where  $n_{\circ} = S$  (Q)dQ is the average num ber of resonators. Then probability,  $F_{S}$  (Q), to nd the resonator with the maximum quality factor in the interval [Q;Q + dQ] is determined by the expression

so that there is one resonator with quality factor from Q to Q + dQ and there are no resonators with the higher quality factor. Substituting Eq. (13) into Eq. (14), we obtain

It is easy to see that  $F_s(Q)$  is norm alized. To evaluate the integral in Eq. (16), we take into account that the density of resonators is a rapidly decreasing function of Q. Then the main contribution to the integral in Eq. (16) com as from low limit,  $Q_1 = Q \cdot W$  ith (Q) given by Eq. (6), the integral (16) can be rewritten as

Substituting Eq. (17) into Eq. (16), we obtain the following expression for  $F_S$  (Q)

As it follows from the qualitative considerations (Sect. II), the distribution function,  $F_{S}(Q)$ , has a sharp maximum at  $Q = Q_{S} = \exp f [\ln (S=S_{0})=G]^{1=} g$ . For this reason we present  $\ln Q$  in Eq. (18) as  $\ln Q = \ln Q_{S} + \ln (Q=Q_{S})$ , where  $\ln (Q=Q_{S}) = \ln Q_{S}$ . Then Eq. (18) takes the form

Since we have G 1, the second term in the lh.s. can be considered as a small correction. Neglecting this correction, we immediately realize that  $Q_s$ , determined from the qualitative consideration, indeed satis as the relation (22). Upon substituting the value of  $Q_s$ , given by Eq. (8), into Eq. (20) we arrive to the nal expression (12) for parameter s.

As the threshold gain, I, is proportional to Q<sup>1</sup>, the distribution of thresholds over the samples follows from Eq. (21) upon transform ation  $F_S(Q)dQ = F_S(I)dI$  with  $Q = Q_S = (I = I_S)^{-1}$ . Then  $F_S(I)$  takes the form Eq. (1).

Since the distribution  $F_S$  (I) is broad, it is best characterized by the moments of  $\ln I$  de ned as

rather than by the moments of I. In Eq. (24) the value hIi is the average threshold, calculated from the distribution (1). It is given by Eq. (3). As it is shown in the Appendix, the moments  $M_n$  can be calculated analytically. They are expressed through the derivatives of the digamma function  ${}^{(k)} = d^k (x) = dx^k_{x=1}$ . The rst three moments are given by the following expressions

## IV . D iscussion

In our consideration we have assumed that the areal density of resonators with anom alously large Q -values of the eigenmodes (sometimes in the literature they are called quasim odes<sup>19</sup> or quasistates<sup>3</sup>) has the form (Q) / exp G (lnQ). Below we argue that this form is generic. More precisely, the arguments leading to Eq. (6) are applicable to all the models of the two-dimensional disorder<sup>5;17;20;21</sup> considered in the literature. These arguments are the follow ing<sup>11;22</sup>

(i) Denote with A the characteristic area occupied by the disorder conguration that traps the light during the time  $! \, {}^{1}Q$ . The fact that the resonator mode is conned, while its frequency, !, is degenerate with the continuum inevitably results in the evanescent losses and corresponding limitation on the quality factor

where we have roughly estim ated the curvature of the perimeter of the uctuation as A  $^{1=2}$ ; the functional ff (r)g describes the actual uctuation of the dielectric constant, (r), within the resonator. It is important that regardless of the form of ff (r)g, it decreases with overall magnitude of the uctuation, .

(ii) The phase volume of the uctuation trapping the light form one than Q periods is zero. Sm all statistical deviations of the dielectric constant from (r) would couple the trapped mode to the propagating modes and cause its very fast leakage. Therefore, in order to maintain the high quality factor, these statistical deviations must be suppressed. The probability of such a suppression can be estimated as follows. There are  $M = A \cdot e^2 = 4^2 c^2$  squares with a side equal to the light wavelength within the area of the resonator. Each square couples to the propagating modes independently. Thus the resonator mode would leak out of a typical square during the time  $_1 = 1 = c$ , where 1 is the mean free path. Hence, the probability that for each square this time exceeds !  $^1Q$  is given by

(iii) the rest of consideration is model dependent. This is because in order to obtain the density of resonators that \survive" the statistical uctuations, one has to average Eq. (30) over the model-dependent distributions (r) of trapping con gurations with some weight exp [ F f (r)g]. Important is, how ever, that P increases sharply with due to the factor f, whereas the probability of a trapping con guration, exp [ F f (r)g], drops exponentially with increasing . Hence, we conclude that the density of resonators

is determ ined by the saddle point of the functional integral Eq. (31). Finally, any reasonable form s of f and F (say, power-law) yields Eq. (6), since in course of taking the saddle point, the power of  $\ln Q$  in the exponent reduces com pared to Eq. (30) and the large factor G (kl) emerges in front of the logarithm.

# V.Conclusions

#### A.GeneralRemarks

(i) In the present paper we argue that the dependence of a typical threshold on the sample size is given by Eq. (2), and thus falls o with S slower than the power law, in contrast to conclusion drawn in Ref. 13 on the basis of num erical simulations. As follows from Eq. (2), the dependence of  $I_S$  on S turns into a power law only ! 1. In the most advanced analytical calculation<sup>11</sup> for the model in the lim it of a smooth spatial uctuations of the dielectric constant, the value of parameter was found to be = 11=8. Existing experimental results<sup>23</sup> on the dependence of the threshold on the sample area were tted to the power-law. If we neglect the di erence between 1 = 8 = 11 and 1, then the power-law dependence emerging from Eq. (2) will assume the form  $I_S / (S=S_0)^{1=G}$ , where the disorder parameter 1 is de ned through Eq. (6) and decreases with the concentration of scatterers, G n. A nalytical consideration of R ef. 11 yielded G  $^{1}$  /  $n^{3=4}$ . The results of num erical simulations of R ef. 13 also suggest that the exponent G  $^{-1}$  increases with n, how ever it is impossible to extract the actual dependence of  $G^{-1}$  on n from the num erics.

(ii) Consideration in the present paper was based on the assumption that all random resonators, corresponding to a given disorder conguration, have the same quality factor, Q, regardless of their position within the sample. This is by nomeans the case, if a periodic modulation of the dielectric constant is present in the sample along with the disorder. In particular, if the modulation is strong enough to create the photonic bandgap, then Q-values for resonators located at the center of the sample would be exponentially higher that for resonators close to the perimeter. For this reason it is not surprising that in simulations reported in Ref. 24 the dependence of the threshold on the sample size was found to be much faster than Eq. (2). However, aside from expression (2) for  $I_S$ , the general distribution (1) should apply to the disordered samples with underlying periodicity considered in Ref. 24.

On the qualitative level, experimental veri cation of the distribution (1) of the random lasing threshold, predicted in the present paper, would be an observation of the characteristic asymmetry of the measured hystogram (long tail towards high thresholds and abrupt cuto towards low thresholds). On the quantitative level, after parameters  $hI_s i$  and  $_s$  are determined from the hystogram, there still remains a question how accurately a strongly asymmetric distribution Eq. (1) describes the experimental data. There exists a regular procedure to test quantitatively the agreement between the theoretical and experimental distributions, when both are broad. This procedure is based on the comparison of dimensional relation, which we derive below.

We de ne the cum ulants of the distribution  $F_S$  (I) as follows

Expressing disorder parameter  $_{\rm s}$  through C<sub>2</sub> and substituting the result into the expression (35), we obtain the universal relation between the cumulants of the distribution (1)

In particular, for n = 3 Eq.(36) yields the following relation between the third and the second cumulants

which are easiest to extract from the experim ental data.

In conclusion of this subsection we note that  $C_2^{1=2} = 0.76 = s$ , which characterizes the width of the distribution (1), is close to the estimate Eq. (11) obtained from qualitative consideration in Sect. II.

#### C.Relation to the Statistics of the Lyapunov Exponents for the Fluctuation Tails in 1D

There are two major physical arguments that determ ine the shape of the distribution Eq. (1). (i) The occurrence of a mode with anomalously high Q is a rare event; (ii) D i erent random resonators are statistically independent. Using these arguments, and the very general form Eq. (6) of the average density (Q) leads directly to the distribution Eq. (1), as was demonstrated above.

Generality of the distribution Eq. (1) suggests that it m ight be applicable to the di erent situations when the net property of the nite-size sample is governed by the rare events. One such situation is the coherent transm ission of a disordered 1D chain of a given length, L. For electron energy in the \body" of the band the distribution of log-transm ission, reduces to the sum of random num bers, and, thus, is gaussian. Deep in the tail of the density of states this distribution is also close to gaussian, since the transm ission, T, is dom inated by \under-barrier tunneling" with a decrement weakly changing in space. Interference processes do not play a role in this energy interval. There exists, however, a range of energies close to the band-edge, where the central lim it theorem is already not applicable, but the interference processes are still relevant. The distribution of the log-transm ission becomes strongly asymmetric in this \underlog uctuation region  $\frac{26}{28}$ .

It m ight be conjectured that, sim ilar to random lasing, the electron transm ission within the uctuation region is governed by the rare events. It is easy to identify these events, which are accidental form ation of a \m inibands" by dimensions of a lm ost even-spaced tail states<sup>10;25</sup>. One can also assume that dimensions of a given are statistically independent. Unlike random lasing from the samples of a given area, this assumption is by no means trivial. However, if we adopt this assumption, then we immediately come to the conclusion that the transmission distribution is governed by Eq. (21), and thus can be described in a universal manner<sup>27</sup>. The analogy between the random lasing from a nite-area sample, and transmission of a long enough chain is based on the fact that lasing threshold is governed by the

highest-quality resonator present in the sam ple, whereas the electron transmission occurs through the \m ost even-spaced" sequence of resonant tail states.

The validity of the conjecture about statistical independence of rare events within a long disordered chain can be checked by comparison of the consequences of this conjecture to the num erical results. Recently, the statistics of log-transmission coef-

cients (m ore precisely, of the Lyapunov exponents ~ / jln T j) in the uctuation tail of the Anderson m odel was studied num erically in Refs. 27,28. where  $l_{loc}$  is the average localization length for an in nite chain,  $= l_{loc} \sin [N(E)]$ is the scaling parameter, and D, D<sub>3</sub>, , and <sub>3</sub> are numerical constants; N(E) is the number of states per unit length between the energy E < 0 and the boundary E = 2 of the spectrum in the absence of disorder. Upon excluding from Eqs. (38) and (39), we obtain

A ssume now that the full distribution of the Lyapunov exponents is given by Eq. (21). This assumption suggests that the relation Eq. (40) is nothing but a dimension of the relation Eq. (37). To check whether this is the case, we express

On the other hand, the simulations of Ref. 28 yielded the following values of the parameters = 0.27,  $_3 = 0.52$ ,  $D_3 = 0.73$ , D = 1.27. Then for the ratio  $_3 =$  we

get  $_3$  = 1:93, whereas the combination D  $_3$ =D  $^{3^{=}}$  is approximately equal to 0:46. We conclude that the numerical results of Ref. 28 satisfy the analytical relation (37) with high accuracy, suggesting that the distribution Eq. (21) might indeed describe the statistics of the coherent transmission coe cients through the tail of 1D A nderson chain. More conclusive judgment could be made if the moments higher than third were extracted from numerics of Ref. 28. In particular, the following analytical prediction for the fourth cumulant follows from the distribution (21) and Eqs. (A 1), (A 2) obtained using this distribution

Note in conclusion, that according to Eq. (21) the cumulants,  $_{i}$  should exhibit a logarithm ical dependence of the length chain, L, through the parameter  $_{s}$  /  $[\ln L]^{(1)=}$ . No such dependence was revealed in the simulations<sup>27;28</sup>. On the other hand two orders of magnitude change of L in the simulations<sup>28</sup> m ight be insu cient to uncover the above weak dependence, especially if is close to 1.




FIG.1. D in ensionless function (u) is plotted from Eq. (5).




FIG.2. Distribution function of the lasing thresholds over samples (excitation spots) calculated from Eq. (1) is plotted for di erent values of parameter s. Solid line: s = 2; dashed line: s = 4; dotted line: s = 6.
