# Double Exchange in a Magnetically Frustrated System

### A bstract

This work examines the magnetic order and spin dynamics of a double-exchange model with competing ferrom agnetic and antiferrom agnetic Heisenberg interactions between the local moments. The Heisenberg interactions are periodically arranged in a Villain con guration in two dimensions with nearest-neighbor, ferrom agnetic coupling J and antiferrom agnetic coupling is solved at zero tem perature by perform ing a 1=S expansion in the rotated reference frame of each localm om ent. W hen exceeds a critical value, the ground state is a magnetically frustrated, canted antiferrom agnet. With increasing hopping energy torm agneticeld B, the local moments become aligned and the ferrom agnetic phase is stabilized above critical values of t or B. In the canted phase, a charge-density wave form s because the electrons prefer to sit on lines of sites that are coupled ferrom agnetically. Due to a change in the topology of the Ferm i surface from closed to open, phase separation occurs in a narrow range of parameters in the canted phase. In zero eld, the long-wavelength spin waves are isotropic in the region of phase separation. Whereas the average spin-wave sti ness in the canted phase increases with tor , it exhibits a more complicated dependence on eld. This work strongly suggests that the jump in the spin-wave sti ness observed in  $Pr_1 \times Ca_x M \times mO_3$  with 0:3 Х 0:4 at a eld of 3 T is caused by the delocalization of the electrons rather than by the alignment of the antiferrom agnetic regions.

#### I. INTRODUCTION

The persistence of antiferrom agnetic (AFM) short-range order in the ferrom agnetic (FM) phase of the manganites has been recognized for many years [1]. In metallic manganites like La<sub>0.7</sub>C a<sub>0.3</sub>M nO<sub>3</sub> that contain a preponderance of AFM -coupled polaronic regions [2, 3], the Curie temperature  $T_C$  is suppressed but the magnetoresistance is strongly enhanced. C lose to but below  $\rm\,T_{C}$  , the spin dynam ics of  $\rm La_{0:7}C\,a_{0:3}M$  nO  $_{3}$  contains both a propagating spin-wave (SW) branch from the FM regions and a di usive component from polaronic regions with suppressed FM interactions [4]. The low-tem perature insulating phase of the manganite Pr<sub>1 x</sub>Ca<sub>x</sub>M nO<sub>3</sub> with 0:3 0:4 was originally believed 5, 6, 7] to be a canted Х AFM (CAF) but may actually contain regions with both FM and AFM short-range order [8, 9, 10, 11, 12, 13]. When an applied eld B exceeds about 3 T, the resistivity drops by several orders of magnitude [6], the AFM regions shrink [12], and the SW sti ness  $D_{sw}$  jumps by a factor of 3 [11]. Despite the central role played by AFM interactions in the manganites, little is known theoretically about how they a ect the propagating SW dynamics. As rst shown by Anderson and Hasegawa [14], the e ective electron-hopping energy between two local moments making a relative angle is proportional to cos = 2 in the limit of large Hund's coupling. So AFM interactions may suppress the contribution of electron-mediated double-exchange (DE) to the SW dynamics [15]. By aligning the local moments, a magnetic eld or electron hopping will alter the DE contribution to the SW dynamics. This paper exam ines the e ects of AFM interactions on the ground-state properties and SW dynam ics of electrons coupled to the local m om ents of a generalized V illain m odel [16, 17, 18, 19].




FIG. 1: (a) The generalized Villain model with Heisenberg couplings J or  $\,$  J, (b) the local moments in the xz plane subtend angles  $\,$  and  $\,$  b with the z axis, and (c) the electron spins also lie in the xz plane but subtend angles  $\,$  a and  $\,$  b <  $\,$  b with the z axis.

The generalized V illain m odel is one of the sim plest periodic m odels to exhibit m agnetic frustration. As described in Fig.1(a), the local moments  $S_i$  are coupled by the FM interaction J along the y direction and by either the FM interaction J or the AFM interaction J along the x direction. The CAF phase is stable when exceeds the critical value  $_c$ , which is 1=3 when B=B 2=0 but increases as B increases. Due to the different environments of the a and b sites, the angle  $_b$  at the b sites is always larger than  $_a$  at the a sites, as shown in Fig.1(b).

In the hybrid model considered here, the Heisenberg interactions between the local moments are in the Villain conguration while electrons with density p = 1 x are FM coupled to the local moments by Hund's coupling  $J_H$  and hop between neighboring sites with energy

t. The DEV model (so called because it combines the DE and Villain models) provides several advantages as a basis for understanding the elects of AFM interactions and non-collinearity on the spin dynamics. First, except in a narrow range of parameters, a homogeneous CAF phase is stable against phase separation when the AFM control parameter exceeds  $_{\rm C}$ . By contrast, the well-studied hybrid model with AFM interactions. J between all neighboring local moments phase separates before the AFM exchange J is large enough to cant the spins [20, 21, 22, 23]. This phase instability is caused by a \site-local continuous degeneracy" [21, 23, 24] that is absent in the DEV model. Second, unlike the case in a hybrid model with AFM exchange only, the ground state of the DEV model contains a FM component even when t=0 and b=0. So it can be used to evaluate the change in SW stiness  $b_{\rm SW}$  as the electrons become mobile. Third, because the DEV model contains both FM and AFM Heisenberg interactions, it can be used to study insulating manganites like  $b_{\rm C}$   $b_{\rm$ 

For sim plicity, we have constructed a model that is translationally symmetric in two dimensions. Since this model is solved at zero temperature, the qualitative results will be unchanged in three dimensions. More problem atically, the AFM interactions are arranged periodically rather than in clusters. In the low-temperature phase of  $Pr_{0.67}Ca_{0.33}M$  no 3, the FM interactions may be connect to two-dimensional sheets with widths of roughly 25A in a red cabbage" structure [12, 13]. Neutron-scattering results [11], on the other hand, suggest that the FM clusters in the insulating phase are about 40A is diameter. So for wavelengths much longer than 40A, the SW 's will average over the FM and AFM regions. Hence, the DEV model will provide qualitatively accurate predictions for the average SW sti ness  $D_{sw}^{av} = (D_{sw}^{x} + D_{sw}^{y}) = 2$  defined in the long-wavelength limit.

The Hamiltonian of the DEV model is given by

where  $c_i^y$  and  $c_i$  are the creation and destruction operators for an electron with spin at site i,  $s_i$  =  $(1=2)c_i^y$   $c_i$  is the electronic spin, and  $S_i$  is the spin of the local moment with magnitude S. Nearest-neighbor Heisenberg interactions  $J_{ij}$  take the values J (FM interaction) or J (AFM interaction), as described in Fig.1(a). This model is solved at zero temperature by expanding the Hamiltonian in powers of  $I=\frac{p}{S}$ . To guarantee that the contributions to the SW frequencies from hopping and from the Heisenberg interactions are of the same order in  $I=\frac{p}{S}$ , t is considered to be of the same order in  $I=\frac{p}{S}$  as  $J_HS$ ,  $JS^2$  and  $J_H=JS$ . To lowest order in  $J_H=JS$ , the magnetic eld B only couples to the local moments and not to the electrons. While the theory developed below can be extended to treat all values of the Hund's coupling, we shall for simplicity consider the limit of large  $J_HS$  or in dimensionless terms,  $J_H=JS$ . 1 and  $J_HS=t$ .

This paper is divided into ve sections. The Villain model is discussed in some detail in Section II, where we provide new results for the SW sti ness. The ground-state properties of the DEV model are presented in Section III. In Section IV, we evaluate the SW frequencies of the DEV model. Section V contains a discussion and summary. A short version of this work [27] is in press.

#### II. GENERALIZED VILLAIN MODEL

This section presents, for the rst time, a Holstein-Primako expansion for the generalized Villain model. In an equivalent approach, Saslow and Erw in [19] numerically evaluated the mode frequencies by linearizing the equations of motion for the spins. However, a formal Holstein-Primako expansion is required to lay the foundation for the solution of the full DEV model in Section IV.

The Ham iltonian of the generalized Villain model is given by Eq.(1) with t = 0 and  $J_H = 0$ . The spin dynamics is immensely simplied in the rotated reference frame for each spin:  $S_i = \underbrace{U_i^{\text{rot}}}_i S_i$ , where  $\underbrace{U_i^{\text{rot}}}_i$  is the unitary rotation matrix for site i. A Holstein-Primako expansion is performed within each rotated reference frame:  $S_{iz} = S = a_i^y a_i$ ,  $S_{ix} + iS_{iy} = \frac{p}{2S} a_i$ , and  $S_{ix} = \frac{p}{2S} a_i^y$ . Then the zeroth-order term (in powers of  $\frac{p}{2S}$ ) in  $H_v$  can be written as

which is of order  $JS^2$ .

M in im izing  $E_h$  with respect to  $_a$  and  $_b$  yields the relations




FIG. 2: The SW sti nesses versus for  $t^0 = 0$  and various values of the eld B  $^0$ . In the inset are plotted the equilibrium angles  $_a$  and  $_b$  versus for the same set of elds.




FIG. 3: (a) Equilibrium angles and (b) SW sti nesses versus applied eld B  $^0$  for several values of and  $t^0 = 0$ . Inset in (b) are the SW sti nesses when = 1 for very small elds and k = 0.015.

In zero eld, it is easy to show that  $_b = 3$   $_a$  for all . The equilibrium angles are plotted versus for several dierent values of  $B^0$  ranging from 0 to 3 in the inset to Fig.2. In the limit of large with  $B^0 = 0$ ,  $_b ! = 2$  and  $_a ! = 6$ . For nonzero eld,  $_b$  still approaches = 2 but  $_a$  approaches an angle smaller than = 6. In Fig.3 (a), we plot the equilibrium angles versus  $B^0$  for several values of .

A fter linearizing Eqs.(3) and (4), we not that the phase boundary between the CAF and FM phases satis es the relation

which was rst obtained by G abay et al. [18]. While  $_{c} = 1=3$  in zero eld,  $_{c}$  increases with the eld  $B^{0}$  as seen in the inset to Fig 2 and in Fig 3 (a).

Expanded as  $H_v = E_h + H_{v1} + H_{v2} + \dots$  in powers of  $1 = \frac{p}{S}$ , the rst-order term  $H_{v1}$  vanishes provided that the angles a and b satisfy Eqs.(3) and (4). In term s of the Fourier-transform ed spin operators  $a_k^{(r)}$  and  $a_k^{(r)y}$  on the r = a or b sublattice, the second-order term  $H_{v2}$  can be written as

The Ham iltonian of Eq.(6) is easily diagonalized by applying the method of Walker and Walstedt [28], which was originally developed for spin glasses. The resulting spin excitation frequencies are given by

The SW frequency  $!_k = _k$  satis es the condition  $!_{k=0} = B$ . Our results for  $_k$  agree with the mode frequencies numerically evaluated by Saslow and Erwin [19]. In the long-wavelength limit, the SW still nesses in the x and y directions are obtained from the expression  $\lim_{k \to 0} !_k = B + D_{sw}^x k_x^2 + D_{sw}^y k_y^2$ .

In the FM phase, the SW frequency can be solved analytically:

So for  $k_x = 0$ ,  $!_k = B + 2JS$  (1  $cosk_y$ ) is independent of . The SW sti nesses in the FM phase are given by the simple results  $D_{sw}^x = (JS=2)$  (1 ) and  $D_{sw}^y = JS$ , independent of eld. The FM phase becomes unstable when  $!_Q = 0$ , where Q = (0, 0) is the AFM B ragging vector. This yields the same condition for the CAF-FM phase boundary as Eq.(5).

In the CAF phase, analytic results for the SW sti nesses were found only when B = 0:

When ! 1,  $D_{sw}^{x}$  !  $JS^{p} \overline{2}$  and  $D_{sw}^{y}$  !  $JS^{q} \overline{2}$  . For B > 0,  $D_{sw}^{y}$  tends to a nonzero limit but  $D_{sw}^{x}$  still diverges as ! 1. So the average SW still ness always diverges when ! 1 regardless of the eld.

As shown in Fig 2,  $D_{SW}^{\times}$  is a linearly decreasing function of in the FM phase below c. In the CAF phase above c,  $D_{SW}^{\times}$  increases and  $D_{SW}^{\times}$  decreases with . Long-wavelength SW 's become isotropic when  $D_{SW}^{\times}$  and  $D_{SW}^{\times}$  cross. For B=0,  $D_{SW}^{\times}=D_{SW}^{\times}$  when =1. This crossing point moves to progressively larger values of with increasing eld.

The SW sti nesses are plotted versus eld in Fig.3(b) for four dierent values of . In the FM phase above  $B_c$ , the sti nesses are independent of eld. But in the CAF phase below  $B_c$ , the dependence on eld is more complex. For > 1,  $D_{SW}^{\times} > D_{SW}^{Y}$  at zero eld and the sti nesses cross as the eld increases. If the SW sti ness in the direction is de ned




FIG. 4: The SW frequencies for p = 0.66, = 1,  $t^0 = 0$ , and various elds  $B^0$ .

at xed k by D  $_{sw}$  (k ;B) = (!  $_k$  B)= $k^2$ , then D  $_{sw}$  (k ;B) increases rapidly near the eld B  $^2$  = D  $_{sw}$  (k ;0) $k^2$  as shown in the inset to F ig 3 (b) for k = 0:015 . As discussed in detail elsewhere [29], this behavior is typical of any CAF with a quadratic SW dispersion. Since the drop in D  $_{sw}^{x}$  is then steeper than the rise in D  $_{sw}^{y}$ , D  $_{sw}^{av}$  decreases with eld for B B  $^2$ .

Surprisingly, Fig.3 (b) indicates that the sti ness in the x direction becomes negative for su ciently large. To understand this behavior, we have plotted the SW frequencies versus k for = 1 and several elds in Fig.4. Since  $\frac{1}{9} = 0$  and  $\frac{1}{9} = 0$  in the CAF phase, the SW sti ness in the x direction must decrease as the eld B becomes comparable to JS.




FIG. 5: The SW frequencies for B $^0$  = 0,  $t^0$  = 0, and several values of .

Both Figs. 4 and 5 indicate that the SW velocity at Q softens as the CAF phase becomes

unstable. In the FM phase, d! $_k$ =d $k_x$  vanishes at Q for all B > B $_c$  or <  $_c$ . The softening of the SW velocity at the CAF-FM phase boundary is a quite general result discussed by Rom an and Soto  $\{1\}$ .

## III. GROUND-STATE PROPERTIES OF THE DEV MODEL

In this section, we discuss the ground-state properties of the DEV model, which is constructed by placing electrons with density p on the Villain lattice. An electron on site i is coupled to the local moment at that site by Hund's coupling  $2J_i s_i$  Sand is allowed to hop to neighboring sites with hopping energy t, as specified by the DEV Ham iltonian of Eq.(1).

W ith the Ferm ion creation and destruction operators  $c_k^{(r)y}$  and  $c_k^{(r)}$  de ned in the reference fram es of the local m om ents, the band H am iltonian of the electrons can be written

Notice that the  $^{y}$  terms couple the up and down spin states. Like  $E_h$  of Eq.(2),  $H_b$  is also of order  $JS^2$ .

The potential  $V^{ij}$  (k) is treated within degenerate perturbation theory. Second-order perturbation theory with corrections of order  $t=J_HS$  will be required to obtain the SW frequencies in the next section. The upper and lower signs in  $\gamma_k^{(r)}$  refer to the r=a and b bands, respectively. W ith H  $_{b}$  in diagonal form ,  $E_b = hH_bi$  is easy to evaluate.

It is straightforward to m in im ize the zeroth-order energy E  $_0$  = E  $_{\rm h}$  + E  $_{\rm b}$  w ith respect to the angles  $_{\rm a}$  and  $_{\rm b}$  in the lim it of large J  $_{\rm H}$  S . The relations that generalize Eqs.(3) and (4) are

For a xed and  $B^0$ , the equilibrium angles decrease with increasing  $t^0$ . The phase boundary between the CAF and FM phases is now given by the condition




FIG. 6: (a) The angles  $_a$  and  $_b$  of the local moments, the total local magnetization M =S, the fraction  $f_a$  of the electrons on the a sites, and (b) the spin-wave sti nesses (both in the x and y directions and their average) for p=0.66, =2, and  $B^0=0$  versus  $t^0$ .




FIG. 7: (a) The angles  $_a$  and  $_b$  of the local moments, the total local magnetization M =S, the fraction  $f_a$  of the electrons on the a sites, and (b) the spin-wave sti nesses for p=0.66,  $t^0=10$ , and  $B^0=0$  versus .




FIG. 8: (a) The angles a and b of the local moments, the total local magnetization M =S, the fraction  $f_a$  of the electrons on the a sites, and (b) the spin-wave sti nesses for p=0.66,  $t^0=3$ , and =2 versus  $B^0$ .

where  $K = (h_{\widetilde{k}}^{(a)} i + h_{\widetilde{k}}^{(b)} i) = 2$  0 is the average kinetic energy of the electrons in the FM phase. This reduces to Eq.(5) when K = 0. For p = 0.66, = 2, and  $B^0 = 0$ , the dependence of the equilibrium angles on  $t^0$  is plotted in Fig.6(a). Also shown is the average spin  $M = S(\cos_a + \cos_b) = 2$  of the local moments. When  $t^0 = 10$  and  $B^0 = 0$ , the equilibrium angles and M = S are plotted versus in Fig.7(a). Their dependence on eld  $B^0$  is plotted in Fig.8(a) for  $t^0 = 3$  and = 2.

Surprisingly, the electronic occupation of the a and b sites on the Villain lattice are dierent. For p < 1, the occupancies of the a and b sublattices are given by

From the relation  $u_k^{(a)2} + u_k^{(b)2} = 1$ , it follows that  $(n_a + n_b) = 2 = p$  is just the average number of electrons per site.

In the CAF phase, electrons prefer to sit on the a sites of the V illain lattice. The fraction  $f_a = n_a = 2p$  1=2 of such electrons is plotted in Figs.(6-8). For = 2 and B = 0 in Fig.6(a),  $f_a$  has a maximum of 0.574 as  $t^0$ ! 0 and approaches 1/2 as  $t^0$ !  $t^0$  13.2. Sim ilar behavior is found in Figs.7(a) and 8(a), where  $f_a$  is shown to be an increasing function of and a decreasing function of B  $^0$ . This behavior is easy to understand: the largest angles between neighboring spins are along the x axis between b sites with angles di ering by 2  $_b$ . When an electron hops onto a b site, it cannot easily hop to other b sites and so quickly moves onto a neighboring a site, where it can readily travel between other a sites with angular difference 2  $_a$  2  $_b$ . Hence, the non-collinearity of the local moments quite naturally produces a charge-density wave (CDW) with a substantial amplitude. As ! 1 ,  $_b$  approaches = 2 and  $f_a$  approaches 0.593. So even when the electrons are unable to hop between sites on the b sublattice (since the angles on neighboring b sites difference yields), roughly 40% of the

electrons can still be found on b sites at any one time. Because neither the CAF nor FM densities-of-states contain a gap, both phases are metallic within the DEV model for  $t^0 > 0$ .

Due to short-range orbital ordering, a CDW with the same period as the one predicted

here has in fact been observed in the AFM regions of  $Pr_{0.7}Ca_{0.3}M$  nO  $_3$  [7, 32]. However, the observed charge ordering is perfect: all of the M  $n^{3+}$  ions lie on one sublattice and all of the M  $n^{4+}$  ions lie on the other. Such perfect charge ordering is never achieved within the DEV model.




FIG. 9: The lling p versus them ical potential  $\sim$  for various values of  $t^0$ , = 3, and  $B^0$  = 0. P hase separation appears as discontinuities in p.

Another surprising result is that phase separation occurs within a narrow range of  $t^0$ . In a plot of lling p versus chemical potential , phase separation appears as a jump p in p(). For the parameters = 3 and B = 0 in Fig.9, p reaches a maximum of about 0.0028 when  $t^0$  10:0 and shrinks as  $t^0$  increases. If p is xed at 0.66, then phase separation

occurs within a very narrow range of  $t^0$  between about 9.98 and 10.02. For xed p, phase separation appears as jumps in the equilibrium angles  $_{\rm r}$  and in the electron fraction  $f_{\rm a}$ , as seen in Figs.6(a) and 7(a) for zero eld.




FIG. 10: The FS is plotted for = 3,  $B^0 = 0$ , p = 0.66, and  $t^0 = 9.8$ , 10.2, 12, 16, or 21.2. For  $t^0 > 10$ , the a FS develops necks around k = 0.

Like the Pom eranchuk instability [33, 34] in the two-dimensional Hubbard model, the phase instability in the DEV model occurs close to but slightly above the Van Hove lling and is marked by a change in Ferm i surface (FS) topology from closed to open. In the usual Pom eranchuk instability, however, the change in FS topology spontaneously breaks the square symmetry of the lattice. Square symmetry is already broken in the DEV model by the Villain arrangement of the Heisenberg interactions. The FS of the DEV model is sketched in Fig.10 for = 3, B = 0, p = 0.66, and for values of  $t^0$  on either side of the phase-separated range. For  $t^0$  just above 10.0, the extra electrons in the neck of the a FS around k = 0 are o set by the holes in the bFS around k = (r = 2). A lithough phase separation occurs for any  $t^0$  around some value of the lling, it becomes significant only if the bFS is already present when the necks in the a FS develop. For the parameters in Fig.9, this requires that  $t^0 = 9.9$ .

A magnetic eld very quickly narrows and then elim inates the region of phase separation. For  $t^0 = 3$  and = 2, phase separation does not occur with increasing eld. The small kinks in the equilibrium angles and electron fraction seen in Fig.8 (a) correspond to points of Van Hove lling (where the necks in the a FS rst appear) but not to a phase-separated region.

### IV. SPIN DYNAM ICS OF THE DEV MODEL

In this section, we evaluate the SW frequencies for the DEV model by following the general formalism developed by Golosov [23]. While introducing some new physics, the presence of non-collinear spins also complicates things a bit.

When  $J_H$  S=t is nite, the relationships given above for  $\stackrel{(r)}{k}$  in terms of  $d_k^{(s)}$  must contain admixtures of the opposite-spin terms  $(t=J_H\,S\,)d_{k+Q}^{(s)}$ , . As sketched in Fig.1 (c), this implies that the equilibrium angles  $_r$  of the electrons are smaller than the angles  $_r$  of the local moments because the electrons try to align their spins as much as possible. For large H und's coupling,  $_r$   $_r$  /  $t=J_H\,S$  and the electrons always exert a small torque on the local moments. the  $J_H S$  ! 1 lim it. Indeed, these torque terms are required to obtain sensible results for the SW frequencies.

which can also be obtained by m in im izing the classical energy  $E(a;b) = J_H S_i^P n_i \cos(a) + E_h(a;b)$  with respect to a or b. Hence, the torque exerted by the electrons on the local moments opposes the tendency of the local moments to return to the angles that m in im ize  $E_h$ .

In term s of the Ferm ion operators  $d_k^{(r)}$  and  $d_k^{(r)y}$  that diagonalize H  $_b$ , the full H am iltonian can be expanded in a power series in  $1=\frac{p}{S}$  as H = H  $_0$  + H  $_1$  + H  $_2$  + . The rst-order term m ay be written

Since  $J_H$  = JS and t=JS are of order S<sup>0</sup>, H  $_1$  = JS<sup>2</sup> is of order 1 =  $^p$  S and H  $_2$  = JS<sup>2</sup> is of order 1 = S.

To elim inate the st-order term in H and to express the Ham iltonian in terms of the true SW operators for the total spin  $S_{i;tot} = S_i + s_i$ , we perform the unitary transform ation [23] H  $^0$  = e  $^U$  H e  $^U$  where U is constructed to satisfy [U;H $_0$ ] = H $_1$ . This transform ation produces a modil ed second-order term  $H_2^0 = H_2 + [U;H_1]=2$ . The anti-Herm it ian operator U that full lls these requirements is

Perform ing the unitary transform ation and taking the lim it  $J_HS$ ! 1 produces a rather complicated expression for H  $_2^0$ . This expression can be considerably simplified by tracing over the Ferm ion degrees of freedom, thereby replacing the combination of Ferm i operators  $d_{k}^{(r)y}d_{k}^{(s)}$  by its expectation value  $_{rs}k_{jk}^{0}f(\gamma_{k}^{(r)})$ . Then H  $_2^0$  can be written as an elective H am iltonian for the SW operators  $a_q^{(r)}$  and  $a_q^{(r)y}$  that takes the same form as the harmonic H am iltonian of Eq.(6) but with revised coexcients  $A_k^{(r;s)} = A_k^{(r;s)} + C_k^{(r;s)} + D_k^{(r;s)}$  and  $B_k^{(r;s)} = B_k^{(r;s)} + E_k^{(r;s)}$ . Spin excitation frequencies  $_{q}$  are given by Eq.(13) with  $K_{k}^{(r;s)}$  and  $E_{k}^{(r;s)}$  replacing the harm onic coe cients. Note that the torque terms in H  $_{1}$  produce D  $_{q}^{(r;s)}$  and E  $_{q}^{(r;s)}$ , both of which vanish in the FM phase. In the CAF phase, these terms are required to preserve rotational symmetry and the relations  $!_{0} = 0$  and  $!_{0} = B$ .

An analytic expression for the SW frequency is possible in the FM phase:

which generalizes Eq.(15) for the Villain model. The FM phase becomes unstable when  $!_Q = 0$ , which yields the same condition for the CAF-FM phase boundary as Eq.(30). In the FM phase, the SW sti nesses are the sum of DE and Heisenberg contributions:  $D_{SW}^{\times} = K = 8S + JS$  (1) =2 and  $D_{SW}^{Y} = K = 8S + JS$ , both independent of eld. For J = 0, these results agree with the SW frequencies of the DE model rst obtained by Furukawa [35]. When = 1, the SW 's are isotropic because all nearest-neighbor interactions equal J.




FIG. 11: The SW frequencies for p = 0.66, = 3,  $B^0 = 0$ , and various values of  $t^0$ . Dierent frequency scales are used on either side of k = 0.

In the CAF phase, the SW frequency and sti nesses are solved numerically by integrating over the rst Brillouin zone to obtain  $C_k^{(r;s)}$ ,  $D_k^{(r;s)}$ , and  $E_k^{(r;s)}$ . Results for the SW frequency are plotted in Fig.11 for =3,  $B^0=0$ , and several values of  $t^0$ . For all  $t^0=21.2$ , the SW frequency vanishes at both the FM and AFM Bragg vectors. Above the phase separation region around  $t^0=10.0$  but below  $t^0$ ,  $t^0$ , develops kinks that correspond to transitions across the neck of the aFS ( $t^0$ ,  $t^0$ , and across the length of the bFS ( $t^0$ ,  $t^0$

 $k_2$  is much weaker than the one at  $k_1$ . As  $t^0$ ! 10:0,  $q_i$ ! 0 so the kinks at  $k_1$  and  $k_2$  m erge with Q. W hereas! k is a non-monotonic function of  $t^0$  along the x direction, it is a monotonically increasing function of  $t^0$  along the y direction.

As plotted in Fig.6(b) for = 2, the SW sti ness in the x direction reaches a minimum at  $t_c^0 = 13.2$ , above which both  $D_{SW}^x$  and  $D_{SW}^y$  are linearly increasing functions of  $t^0$ . The sti nesses in the x and y directions cross in the region of phase separation, where the SW 's become isotropic. Notice that  $D_{SW}^{av}$  increases by about 65% as  $t^0$  increases from zero to  $t_c^0$ . For = 3,  $D_{SW}^{av}$  doubles in this interval [27]

With increasing , the SW sti nesses plotted in Fig.7(b) for  $\hat{t}=10$  and B = 0 again cross in the region of phase separation around = 3:0. For larger ,  $D_{sw}^{x} > D_{sw}^{y}$ . Due to the strong increase in  $D_{sw}^{x}$  with , the average SW sti ness actually grows as the local moments become more non-collinear. Similar behavior was found when t = 0 in Fig.2, where  $D_{sw}^{av}$  was also found to be an increasing function of .

The e ect of a magnetic eld is shown in Figs.8 (b) and 12 for = 2 and  $\ell$ = 3. Absent from Fig.8 (b) is the region of very low elds, where the behavior of the SW sti ness is complicated by the dependence of the function  $D_{sw}$  (k;B) = (!k B)=k² on the ratio  $\frac{p}{B^0}$  [29]. For larger elds, there is a gradual increase in  $D_{sw}^y$  and a decrease in  $D_{sw}^x$  as B grows from 0 to  $B_c$  4:8JS. The drop in  $D_{sw}^x$  with eld is caused by the growth of the




FIG. 12: The SW frequencies for p = 0.66, = 2,  $t^0 = 3$ , and various values of B<sup>0</sup>.

SW gap  $!_0$  = B at k = 0 while the SW frequency continues to vanish at Q = (;0) for B < B<sub>c</sub>, as seen in Fig.12. Hence, the average SW sti ness drops from roughly 1.2JS at B = 0 to 0.54JS at B<sub>c</sub>. Because a magnetic eld very quickly destroys the region of phase separation, the crossing point of the x and y sti nesses does not coincide with a region of phase separation. As expected, the SW sti nesses are independent of eld above B<sub>c</sub>. Notice from Figs.11 and 12 that the SW velocity at Q softens within the CAF phase as tapproaches t<sub>c</sub> or B approaches B<sub>c</sub>. This behavior is quite general and occurs at the CAF-FM phase boundary of any magnetic system [31].

# V. DISCUSSION AND CONCLUSION

Applying the results of this work to the manganites requires an estimation of the relevant parameters. Using S = 3=2, JS = 8.6 meV, 136], and t 200 meV for the metallic phase gives  $t^0 = 32$  and  $B^0 = 0.028B$  (T). When = 1, the critical values of the DEV model are  $t_c^0 = 5.3$  in zero eld and  $B_c^0 = 2.5$  for  $t^0 = 0$ . Hence, the metallic value for the hopping energy is more than su cient to stabilize the FM phase but an applied eld of 3 T cannot align the local moments when  $t^0$  is much below  $t_c^0$ .

M etal-insulator transitions in m any of the m anganites have been successfully interpreted within the framework of percolation theory [37, 38]. When the FM fraction f exceeds a critical value  $f_c$ , a FM backbone spans the sample and the system becomes metallic.

The percolation threshold  $f_c$  in those manganites lies between 0.17 and 0.19. But it is rather di-cult to explain the jump in the SW sti ness observed in  $Pr_{0.7}Ca_{0.3}MnO_3$  [11] within the fram ework of percolation theory. Assuming that the metal-insulator transition in  $Pr_{1-x}Ca_xMnO_3$  is produced by the percolation of metallic FM clusters [10], there is no reason why the SW sti ness should change when a FM backbone spans the sample. Within percolation theory, one would more naturally expect the SW sti ness to gradually increase with eld as a growing fraction of the sample becomes metallic.

Estimates of the FM fraction f in  $Pr_{1}$   $_x$ C  $a_x$ M  $nO_3$  manganites also pose a disculty for percolation theory. The accepted range for the percolation threshold  $f_c$  within continuum models falls between 0.15 and 0.22. While one experimental estimate of  $f_c$  0.08 [10] at the metal-insulator transition lies well below this accepted range, a recent estimate of  $f_c$  0.6 [13] based on more complete magnetization data lies well above this range. At zero eld and low temperatures, estimates for f range from 0.3 [13] to 0.5 [9]. If those estimates are correct and the FM regions are metallic, then the percolation threshold would already be exceeded and the low-temperature phase would be metallic in zero eld.

On the other hand, our results clearly indicate that the jump in the SW sti ness at a eld of 3T cannot be produced by simply aligning the AFM regions while keeping the bandwidth

t xed. As found in Fig.8 (b), a magnetic eld would act to suppress rather than enhance the average SW sti ness under those conditions. Moreover, a eld of 3 T corresponding to  $B^0$  0:086  $B_c^0$  will have little a ect on the alignment of the local moments. Whereas experiments indicate that the AFM regions begin to shrink under a magnetic eld greater than 3 T, a sizeable fraction of the sample remains AFM even above the metal-insulator transition [10, 11, 13].

The large increase in the SW sti ness predicted by our work as  $t^0$  increases from 0 to  $t^0_t$  suggests an entirely di erent scenario: at the critical eld, electrons in the insulating and possibly canted FM regions delocalize as the hopping energy t sharply increases. Since the integrated optical weight is just K t, the jump in the hopping energy at 3 T should be observable in optical measurements. Indeed, measurements by 0 kim oto et al. [7] on  $Pr_{0.6}Ca_{0.4}MnO_3$  reveal a rapid rise in (!) and a rapid drop in the CDW gap near the critical eld. If the percolation threshold for the FM regions is exceeded when the electrons delocalize, as suggested by the measurements discussed above, then the jump in the SW sti ness will coincide with the metal-insulator transition. O therwise, the metal-insulator

transition will occur at a slightly larger eld.

Supporting this picture are the plethora of probes that can produce a metal-insulator transition in  $Pr_{1}$   $_{x}Ca_{x}M$   $nO_{3}$  (0:3 x 0:4). Besides a magnetic eld, application of an electric eld  $\beta$ 9], high pressure [40], exposure to x-rays [41], and exposure to visible light [42] all induce a metal-insulator transition. The identical resistivities produced by application of a magnetic eld or exposure to x-rays [41] suggest a common mechanism: the excitation of charge carriers out of polaronic traps produced by the electron-lattice coupling. The subsequent relaxation of the lattice [9, 41] m ay prevent retrapping of the electrons.

The jump in the SW sti ness as a function of eld in  $P_{K,7}Ca_{0,3}M$  nO $_3$  [11] also bares a striking resemblance to the jump in the SW sti ness observed in  $La_{1} Ca_{x}M$  nO $_3$  at the metal-insulator transition with x 0.22 [43]. In fact, the sizes of the SW sti nesses on either side of the doping-induced transition in  $La_{1} Ca_{x}M$  nO $_3$  are almost exactly the same as on either side of the eld-induced transition in  $P_{K,7}Ca_{0,3}M$  nO $_3$ . This suggests that there are also large increases in the hopping energy and electronic kinetic energy in  $La_{1} Ca_{x}M$  nO $_3$  at the critical concentration of x 0.22.

Compare the jump in the SW sti ness across the metal-insulator transition with the smooth dependence of the spin-di usion coe cient [4,43], which gives the lifetime  $(k)=1=k^2$  of paramagnetic spin uctuations. Measurements [43] of the spin-di usion coe cient were performed just below  $T_C$ , where paramagnetic spin relaxation occurs within polaronic regions of the FM phase. While  $D_{SW}$  is a linear function of the electronic kinetic energy in the FM phase, depends only on doping and is independent of the electronic bandwidth W in the low-temperature limit T W [4]. So long as the bandwidth of the polaronic regions remains large compared to the temperature, the spin-di usion coe cient will not change across the metal-insulator transition.

Except in a very narrow range of param eters, phase separation is absent in the DEV model. Phase separation appears quite commonly in DE models with AFM Heisenberg interactions [1] and even occurs near p = 1 in a DE model without Heisenberg interactions [44]. Results for the DEV model contrast with both a DE model with AFM interactions between all neighboring local moments [20, 21, 22, 23] and a DE model with FM interactions in plane but AFM interactions between neighboring planes [45]. Due to the high symmetry of both models, AFM order is not frustrated when t = 0. But in both cases, phase separation occurs before the AFM interactions become strong enough to cant the spins. Work by

Golosov [21, 23] indicates that the canted phase is destabilized by the presence of local degeneracies [24] that are absent in the DEV model. Our results suggest that phase separation only occurs within a very narrow range of parameters when the AFM Heisenberg interactions are frustrated and local degeneracies are absent. For doping concentrations away from multiples of a quarter—lling, long-range orbital ordering is impossible and magnetic frustration may be present in a wide range of manganites. Therefore, the DE model may not provide as straightforward a pathway to phase separation in the manganites as believed. A much more important rolem ay be played by the quenched disorder associated with chemical inhom ogeneities [46].

Rom an and Soto \$1] pointed out that the nature of the FM and AFM regions can be probed by measuring the SW spectrum about the AFM Bragg vector Q. In a CAF, the SW 's are not gapped for any eld B below B<sub>c</sub>, as shown in Figs.4 and 12. By contrast, the SW 's of a collinear AFM contain a gap at Q that grows linearly with eld. So measurements of the SW spectrum about Q may be used to determine whether local regions are canted. As discussed elsewhere [29] and seen in the inset to Fig.3(b), the rapid increase in the SW sti ness for elds near B<sup>2</sup> is another signature of a canted phase. The absence of this behavior in Pr<sub>1 x</sub>Ca<sub>x</sub>M nO<sub>3</sub> for 0:3 x 0:4 strongly suggests that the local AFM regions are not canted.

Since CE-type AFM ordering occurs at half-lling, the local charge ordering observed in the manganites  $Pr_{0.6}Ca_{0.4}MnO_3$  [7, 32] and  $La_{0.7}Ca_{0.3}MnO_3$  [2, 3] would be simplified if the polaronic regions were rich in holes and poor in electrons compared to the bulk. Our model provides a natural explanation for this behavior, since the electronic fraction on b sites is substantially smaller than the fraction on a sites as the electrons avoid regions with more pronounced AFM order.

This paper has studied the general e ects of AFM interactions and non-collinearity on the magnetic ordering and spin dynamics of DE systems. The competition between DE and AFM interactions is responsible for several interesting properties. In a narrow region of hopping energies, weak phase separation occurs as the FS topology changes from closed to open. Because electrons prefer to occupy sites that are coupled by FM interactions, a CDW appears in the absence of a CDW gap. For nite Hund's coupling, the electron spins are more closely aligned than the local moments of the CAF. The CAF becomes unstable above critical values of eld and hopping energy and below a critical value of . Perhaps

the most surprising result is that DE changes none of the qualitative features of the CAF state. The SW gap  $!_0$  at k=0 remains equal to B and the gap  $!_Q$  at the AFM Bragg vector Q continues to vanish for any hopping energy below  $t_c$ . The average SW sti ness still softens with magnetic eld and hardens with strengthening AFM interactions; the SW velocity at Q still vanishes at the CAF-FM transition. Clearly, a great deal can be learned about the general properties of CAF's, even of the more complex variations that appear in many manganites, by considering simple models such as the DEV model.
