# Single Super eld $R$ epresentation for $M$ ixed $R$ etarded and A dvanced C orrelators in D isordered System s

## I. IN TRODUCTION

The physics of electronic localization is one of the $m$ ost interesting issues in the context of disordered quantum system s [1]. The localization/delocalization transition has been intensively studied by follow ing the eld theoretical approach of $W$ egner [2], and the $m$ ore form al developm ents by M CK ane and Stone [3]. Universal aspects of this transition and related topics like transport phenom ena in disordered $m$ edia can also be studied in the fram ew ork of random $m$ atrix theory (for a review see, for instance, ref. [4]).

In an integer quantum $H$ all system, electron localization plays a fundam entalrole [5], nam ely, the e ect of disorder is that of localizing the states of energy $E$ aw ay from the Landau energy $E_{n}=(n+1=2) h!c$. Near this value, the localization length (E) diverges like (E)/ (E $E_{n}$ ) . A though this behavior is consistent w ith experim ents [6] and w th several num erical [7] and renorm alization group calculations [8], to the best of our know ledge, there is no sim ple analyticalm ethod to evaluate this scaling [9] nor it is clear why, in the therm odynam ic lim it, just one state for each Landau band rem ains extended.

The electronic properties are encoded in the system 's correlators; for instance, the density of states (localized or not) can be obtained from the retarded $G$ reen's function,

where h:: i denotes the ensem ble average over the random variable. On the other hand, the analytical structure of the density of localized states , ( $E$ ) is m ore com plex since it involves the $m$ ixed product of retarded and advanced G reen's functions,

In fact, any quantity encoding som e inform ation about localization or transport properties is related with this $m$ ixing. For this reason, we concentrate oure orts in studying the representation of the ensem ble average for these im portant quantities.
$T$ here are essentially tw o $m$ ethods to calculate averages: the replica [10] and the supersym $m$ etric $m$ ethod [11]. $T$ he rst one is based on the introduction of a num ber of copies to represent each type of $G$ reen's function. In order to com pute the average density of states one set of $n$ eld copies is needed. In this case, a generalized $n$ com ponent Landau-G insburg m odel is obtained [12], where the lim it $\mathrm{n}!0 \mathrm{~m}$ ust be im plem ented. For the density of localized states tw o sets of copies are used, containing $n_{+}$and $n$ eld copies, respectively. The disorder average,

[^0]after integrating out allm assive $m$ odes, leads to a generalized nonlinear sigm a $m$ odelw ith sym $m$ etry group $O\left(n_{+}\right.$; $n$ ) $[2,3]$, describing the critical properties near the $m$ obility edge.

In the supersym $m$ etric $m$ ethod, the $G$ reen's function denom inator is exponentiated by $m$ eans of $G$ rassm an variables, thus avoiding dangerous continuations in the num ber of copies. In order to com pute the density of states a super eld is needed, this also applies to other quantities that can be com puted from correlators just involving a retarded prescription. This $m$ ethod has been used by B rezin, G ross and Itzykson [15] to study the density of states in $H$ all system s. They showed that the reason behind the exact expression previously calculated by W egner [2] is an exact boson-ferm ion sym $m$ etry in the $G$ reen's function representation, when the projection to the rst Landau level is considered. H ow ever, the problem is not so sim ple when one tries to extend these ideas to understand localization. A s occurs in the replica $m$ ethod, a doubling is used to represent the density of localized states, that is, a super eld is introduced for each prescription in eq. (12). A s a consequence, the boson-ferm ion sym $m$ etry is lost, thus prechuding the possibility of obtaining exact results (see the discussion in ref. [15]).

Therefore, it is interesting to look for altemative representations form ixed correlators, thus opening the possibility to advance the understanding of disordered system s.

The aim of th is paper is to propose a new representation form ixed correlatorsbased on the introduction ofessentially just one super eld. O ur m ethod is general and can be applied to any noninteracting disordered system. It is based on the introduction of a single operator, quadratic in the system 's H am iltonian, that perm its to encode the nontrivial inform ation about retarded-advanced $m$ ixing by using a single prescription. Then, the basis of the $m$ ethod is in fact quite general and could be useful outside the supersym $m$ etric fram ew ork.

O urm ethod willibe tested in the sim pler context of random $m$ atrix theory where the supersym $m$ etric $m$ ethod has been introduced by the pioneering work of E fetov [13]. W e w ill also show how the boson-ferm ion sym metry can be restored when considering m ixed correlators in H all system s .

In section II, we outline the general single super eld $m$ ethod for $m$ ixed correlators. In sections III and IV we com pute the corresponding averages for the G aussian U nitary Ensemble, while in section $V$ we study level spacing correlators and com pare w th well know n universal asym ptotic behavior. In section VI we brie y discuss quantum H all (Q H) system S. F inally, section V II is devoted to present our conclusions and discuss possible perspectives.

## II. $\quad$ SINGLE SUPERFIELD/SUPERVECTOR REPRESENTATION

W e start by considering the operator,

O ur strategy is based on rst using a single super eld to com pute four-point correlators associated with the $O_{m}$ operator. Then, from $W$ ick's theorem and eq. (2.7), we can relate this correlator to the sum of three term s
involving only retarded, only advanced or $m$ ixed products of two-point $G$ reen's functions, respectively. The rst tw o term $s$ are in general sim pler to study and well know $n$ in $m$ any di erent disordered system $s$. T hen, we see that the four-point correlators for $\mathrm{O}_{\mathrm{m}}$ operators encode im portant inform ation about m ixed products. M oreover, as the retarded-retarded and advanced-advanced term $s$ also adm it a single super eld representation, the ensem ble average for the $m$ ixed prescriptions could be perform ed on independent single super eld representations.

In particular, in the random $m$ atrix case, this procedure $w$ illbe tested by calculating nite $N$ correlation functions and com paring w th well known large $N$ universal results for the G aussian Unitary Ensemble (GUE), given by the probability distribution,

$W$ hen goes to zero, the rst $m$ ember in eq. (2.10) is a mixed retarded and advanced four-point correlator at energies $\mathrm{E}_{1}$ and $\mathrm{E}_{2}$, respectively.
$O n$ the other hand, in the second $m$ em ber, we have the sum of three four-point correlators for the operators $\mathrm{O}_{1+}$, $\mathrm{O}_{2}$ and $\mathrm{O}_{\mathrm{m}}$, respectively. For each correlator we can introduce a single supervector representation of the type,

$T$ hen, the idea is using three independent single supervector representations of the type given in eq. (2.11) to com pute the average for the $m$ ixed correlator. $T$ his is in contrast $w$ ith the usual supervector doubling to represent a typicalterm in the rst $m$ em ber of eq. (2.10),

III. AVERAGESFOR THE FOURTOINT CORRELATORSOFOm OPERATORS

W hen averaging over the unitary ensemble in the second $m$ em ber of eq. (2.10), the $m$ ore involved part of the calculation com es from the $O_{m}$ correlator, as it is associated $w$ ith an exponent which depends quadratically on $H$. $T$ hen, in this section we w ill concentrate on this part, providing a detailed derivation of the correlator,

IV. ANALYTICALDETERMINATION FOR THECORRELATORSOFOm OPERATORS

H ere, wew ill study the analyticalproperties of the four-point $O_{m}$ correlators. Recalling that is a sm all param eter (we will take the lim it ! 0), we can drop ${ }^{2}$ in the exponent $\frac{2}{2}(r=2+i)^{2}$, in eqs. (3.10) and (3.11). W e w ill suppose $r=E_{1} \quad E_{2}>0$; then, for the integral representation (3.15) be well de ned, we m ust take $=$ i. P recisely, this choice produces an associated factor in the bosonic integral,

In this section, in order to test our single super eld $m$ ethod, wew ill rst obtain an approxim ate relationship betw een the $O_{m}$-correlators and the DOS-DOS correlators, which becom es exact in the $N$ ! 1 lim it. Then, we will com pare the nite $N O_{m}$-correlators, as $N$ becom es large, w th the well known universal results for DOS-DOS correlations.

In gure 1, we display, in the range s 2 [0;12], the $N$ ! 1 universal law in eq. (5.11) and our $N=10$ and $N=70$ correlator $\left(2 \mathrm{~N}^{2}\right)^{1}<$ (C ( )) in eq. (5.12). W e see that the correlators approach the correct asym ptotic form as $N$ increases for all values of the scaled variable $s$. For sm all values of s the asym ptotic law is well approxim ated even $w$ ith sm all values of $N$. AsN increases, larger values of s progressively $t$ the $N!1$ behavior.

To show this e ect in more detail we present in gure 2 a set of gures in the range s 2 [2;12] where we display a detailed view of the universal law and the convergence of our nite $N$ correlator, by considering $N=10,30,50$ and 70. W e can see that for larger values of N m ore oscillations are accom m odated, clearly show ing the onset of the asym ptotic universal law. We also note in this gure, that in a region close to the origin the convergence is very fast. The param eter , that characterizes the GUE, has been taken equal to one, how ever, the sam e $m$ atching has been also veri ed when is changed. In this set of gures, we have also displayed the corresponding nite N D OS-DOS correlators obtained in term s of orthogonal polynom ials, as given in M ehta's book [18]. Of course, the tting of these polynom ials w th the universal law is also im proved as N increases. A though both curves converge to the asym ptotic universal law, the nite N results for $\left(2 \mathrm{~N}^{2}\right)^{1}<(C())$ do not coincide w ith the nite N exact DOS DOS correlators. This is expected; as we have seen in section $V$, both quantities di er by term $s$ which only becom e zero in the N ! 1 lim it.

## VI. BOSONFERMION SYMMETRYAND FOURTOINTOM CORRELATORS IN QH SYSTEMS

In this section, we w ill consider a planar system of electrons in the presence of a magnetic eld B and im purities represented by a random potentialV (x). The corresponding $H$ am iltonian operator is,

A s discussed in that reference, if the traditional approach to treat $m$ ixed retarded and advanced correlators is follow ed, the boson-ferm ion sym $m$ etry is lost because of the super eld doubling used to represent each prescription. $H$ ere, we have seen that this in portant sym $m$ etry is restored if the single super eld representation form ixed correlators is instead considered.

## VII. CONCLUSIONSAND PERSPECTIVES

In this work we have introduced a new representation for $m$ ixed retarded and advanced four-point correlators. $T$ hese quantities are the relevant ones when studying localization and transport properties in disordered system $s$. On

the other hand, these are precisely the kind of correlators which are m ore dicult to dealwith. This com es about from the $m$ ixed prescription involved, which leads to a doubling of the eld copies or the super eld representation in the traditional approaches.

H ere, we have considered a single $G$ reen's function $G_{m}$ for an operator $O_{m}$, quadratic in the system 's $H$ am iltonian, $w$ hich already contains the abovem entioned $m$ ixing. In this $m$ anner, we have been $a b l e$ to encode the nontrivial inform ation in four-point correlators essentially using a single prescription. In general, th is $\mathrm{O}_{\mathrm{m}}$ correlator di ers from the $m$ ixed four-point correlator or the density-density correlator by only retarded and only advanced term s , which can be com puted by standard procedures.
$T$ hese ideas have been tested in the sim pler context of $R$ andom $M$ atrix theory. For this aim, we have obtained in
section $V$, in the $N!1$ lim it, a direct relationship betw een the density-density correlator,

and our four-point correlator for $O_{m}$ operators, whose GUE average has been com puted in section III. O ur closed expression (5.12) for the ( nite $N$ ) $O_{m}$ correlator clearly show $s$ the onset of the well known asym ptotic level spacing correlation.
$T$ hen, we have seen that the single super eld $m$ ethod is an interesting altemative to be considered when studying disorder. In particular, in the context of quantum $H$ all system $s$, we have show $n$ in section $V$ I that the boson-ferm ion sym $m$ etry is restored for correlators encoding inform ation about $m$ ixed retarded and advanced $G$ reen's functions, thus opening the possibility of im proving our understanding of localization [19].
