# The Four-Boson System with Short-Range Interactions

# Abstract

We consider the non-relativistic four-boson system with short-range forces and large scattering length in an elective quantum mechanics approach. We construct the elective interaction potential at leading order in the large scattering length and compute the four-body binding energies using the Yakubovsky equations. Cuto independence of the four-body binding energies does not require the introduction of a four-body force. This suggests that two- and three-body interactions are su cient to renorm alize the four-body system . We apply the equations to  ${}^{4}\text{H}\,\text{e}$  atom s and calculate the binding energies similar to the T jon line in nuclear physics. Over the range of binding energies relevant to  ${}^{4}\text{H}\,\text{e}$  atom s, the correlation is approximately linear.

#### I. IN TRODUCTION

E ective theories are ideally suited to describe the low-energy properties of physical systems in a model-independent way. They can be applied to any system that has a separation of scales, which can be a fundamental property of the underlying theory or simply a kinematical suppression. The long-distance degrees of freedom must be included dynamically in the elective theory, while short-distance physics enters only through the values of a few coupling constants, often called low-energy constants. Elective theories are widely used in m any areas of physics. Recently, a considerable elective s of these programs, see e.g. Refs. [1, 2] and  $\beta$ , 4]. If there is no exchange of m assless particles, any interaction will appear short ranged at su ciently low energy. One can then use a very general elective theory with short-range interactions only to describe the universal low-energy properties of the system. Such a theory can be applied to a wide range of systems from nuclear and particle physics to atom ic and molecular physics.

Most previous work in this area was done using a non-relativistic e ective eld theory (EFT) with contact interactions. Particularly interesting are few boson systems with large scattering length. They are characterized by an unnaturally large two-body scattering length a which is much larger than the typical low-energy length scale l given by the range of the interaction. Such system s display a number of interesting e ects and universal properties that are independent of the details of the interaction at short distances of order 1. If a > 0, e.g., there is a shallow two-body bound state with binding energy  $B_2 = h^2 = (M a^2) + O (l=a)$ , where M is the mass of the particles. Low-energy observables can generally be described in a controlled expansion in 1= a.j. In the two-boson system, the e ective theory reproduces the e ective range expansion (cf. Refs. [5, 6]) but the structure of the three-boson system with large scattering length is richer. In Refs. [7, 8], it was found that both two-and threebody contact interactions are required at leading order for the consistent renorm alization of the three-body system. Interestingly, the renorm alization group behavior of the threebody interaction is governed by an ultraviolet limit cycle. This implies that at leading order in 1= in i the properties of the three-boson system with large scattering length are not determ ined by two-body data alone and one piece of three-body inform ation (such as a threebody binding energy) is required as well. In the EFT, this inform ation can conveniently be param eterized by the three-body param eter introduced in Refs. [7, 8]. These general ndings con m and extend previous work by E mov who derived m any general features of the three-body problem with large scattering length [9, 10].

W hile the EFT formulation has been very successful, it is not the only possible formulation of an elective theory for this problem. Lepage has advocated the fram ework of non-relativistic quantum mechanics with an elective interaction potential [11]. The contact operators in the eld theory are the replaced by an lelective potential" built from sm eared out -function potentials and derivatives thereof. In the case a > 0, this approach has been applied to the three-boson system by W ilson [12] and M ohr [13]. They con rm ed the results of R efs. [7, 8] and were able to calculate the binding energies for the three-boson system to extrem ely high accuracy.

In this paper, we consider the four-body system with short-range interactions. The fourbody problem has previously been studied in variety of approaches. Early studies include the Yakubovky equations for local potentials using the Hilbert-Schm idt expansion [14], the Schrodinger equation with separable two-body potentials [15], and eld-theoretical models with separable expansions of the three-body T-m atrix [16]. The four-body problem of  ${}^{4}\text{H}e$  atom s was investigated by Nakaichi-Maeda and Lim using the Yakubovsky equations with a unitary pole approximation for the S-wave (2)+ (2) and (3)+ (1) subamplitudes [17]. For a review of these and other early studies see, e.g., Refs. [18, 19]. For an overview of recent calculations for the four-body system of  ${}^{4}\text{H}e$  atom s, see Refs. [21, 22]. A general review of theoretical studies of small  ${}^{4}\text{H}e$  clusters can be found in Ref. [23]. In Ref. [24], a benchmark calculation comparing various modern calculational approaches to the nuclear four-body problem was carried out.

The purpose of this paper is to study the four-boson system with short-range interactions and large scattering length in an elective theory. We will work at leading order in l=jajand use the fram ework of non-relativistic quantum mechanics to construct an elective interaction potential. This approach has the advantage that one can immediately start from the wellknown Yakubovsky equations for the four-body system [25]. The four-boson binding energies are obtained by solving the Yakubovsky equations for the elective interaction potential. The solution of the four-boson problem in elective theory is important in several respects:

First, it can immediately be applied to the atom ic problem of  ${}^{4}\text{H}e$  atom s and is a rst step towards the four-body problem in nuclear physics which is complicated by spin and isospin. The scattering length of  ${}^{4}\text{H}e$  atom s a 100A is much larger than its e ective range  $r_{e}$  7A which can be taken as an estimate of the natural low-energy length scale 1.  ${}^{4}\text{H}e$  atom s are therefore an ideal application for our theory. The three-body system of  ${}^{4}\text{H}e$  atom s has been investigated in Refs. [8, 26, 27] using e ective eld theory. W hile the universal properties of the three-body system of  ${}^{4}\text{H}e$  atom s were discussed in Refs. [26], this has not been done for the four-body system.

Second, the renormalization of the four-body system in an elective theory is an open question. It is clear that low energy four-body observables must depend on a two-body parameter and a three-body parameter. However, it is not known whether a four-body parameter is also required to calculate low energy four-body observables up to corrections suppressed by l=jaj.

The theoretical situation concerning this question appears confusing. On the one hand, there is a renormalization argument for -function pair potentials that indicates that a new four-body parameter is required to calculate four-body binding energies [28]. On the other hand, Am ado and G reenwood have evaluated the trace of the four-body kernel and concluded that the E move ect is absent in the four-body system [29]. This result suggests that a four-body parameter should not be necessary at leading order in l=jaj. There is som e circum stantial evidence in favor of the latter possibility from the four-body problem in nuclear physics. There is a correlation called the T jon line" between the binding energy  $B_{t}$ of the triton and the binding energy B of the particle [14]. Calculations of these binding energies using modern phenom enological nucleon-nucleon interaction potentials give results that underestim at both binding energies but cluster along a line in the  $B_t$ -B plane. By adding a three-body potential whose strength is adjusted to get the correct value for  $B_{+,}$ one also gets an accurate result for B (cf. Ref. [30]). This conclusion also holds for chiral nuclear potentials derived from an e ective eld theory with explicit pions [31]. The aim of the present work is to study the question about the requirem ent of the four-body interaction by an explicit calculation in the controlled environment of an elective theory.

The paper is organized as follows. In Sec. II, we will review the description of the twoand three-body bound state problem in elective theory and extend this framework to the four-body bound state problem. In Sec. III, we will discuss the renormalization and present num erical results for the case of  $^4{\rm H\,e}$  atom s. F inally, we close with a sum m ary and outlook in Sec. IV .

# II. FEW -BODY BOUND STATE EQUATIONS IN EFFECTIVE THEORY

The elective low-energy interaction potential generated by a non-relativistic EFT with short-range interactions can be written down in a momentum expansion. In the two-body S-wave sector, it takes the general form

where k and  $k^0$  are the relative three-m on enta of the incoming and outgoing particles, respectively. Because of G alilean invariance, the interaction can only depend on the relative m on enta. Sim ilar expressions can be derived for three- and higher-body interactions. The exact form of the potential depends on the speci c regularization scheme used. The low - energy observables, how ever, are independent of the regularization scheme (up to higher order corrections) and one can choose a convenient scheme for practical calculations.<sup>1</sup>

In a momentum cuto scheme, the potential in Eq. (1) can be regularized by multiplying with a Gaussian regulator function, exp [ $(k^2 + k^2) = 2$ ], with the cuto parameter . This factor strongly suppresses high-momentum modes in the region  $k_i k^{0}$  where the elective potential is not valid. The cuto dependence of the coelectents  $_2()$ ,  $_{2i}()$ , ::: is determined by the requirement that low-energy observables are independent of . Of course, the expansion in Eq. (1) is only useful in conjunction with a power counting scheme that determines the relative in portance of the various terms at low energy. In the case of large scattering length a, the leading order is given by the  $_2$  term which must be iterated to all orders, while the other terms give rise to higher-order corrections that can be included perturbatively [5, 6]. In this paper, we will work to leading order in the large scattering length a and include only the  $_2$  term.

In the three-body system, a m on entum -independent three-body interaction term  $_3$  m ust be included together with  $_2$  already at leading order [7, 8]. W ithout this three-body interaction low energy observables show a strong cuto dependence and the system can not be renorm alized. E ective range e ects and other higher-order corrections can be included as well [34, 35, 36].

The power counting for the four-body system has not been formulated yet. In order to see whether the minimal set of interactions  $_2$  and  $_3$  is su cient, we will calculate the bound states in the four-body system and study their cuto dependence. We will use a momentum cuto regularization scheme as described above. A strong cuto dependence of the binding energies would indicate that a four-body interaction term is required. If the four-body binding energies are stable under variations of the cuto , this would suggest that the four-body interaction is a subleading elect.

In order to set up our conventions and form alism, we will rst review the bound state equations for the two- and three-body system and then set up the four-body equations.

A. The Two-Body Sector

We write the leading order two-body e ective potential in momentum space as:

where  $_2$  denotes the two-body coupling constant and q (p) are the relative three-m om enta in the incoming (outgoing) channel. The regulator functions

suppress the contribution from high m om entum states. In the few-body literature, they are often called form factors".

Our normalization for plane wave and spherical wave states is

For convenience, we will work in units where the mass M of the bosons and P lanck's constant h are set to unity: M = h = 1.

The interaction (2) is separable and the Lippm ann-Schwinger equation for the two-body problem can be solved analytically. The two-body t-m atrix can be written as [37]:

where E denotes the total energy. The two-body propagator (E) is then given by

A two-body bound-state appears as a simple pole in the two-body propagator at energy  $E = B_2$ . Thus the two-body coupling constant  $_2(B_2; )$  can be xed from the two-body binding energy  $B_2$ , which is directly related to the scattering length by  $a = 1 = B_2$  at leading order in l=jaj. The integrals appearing in the propagator can be expressed through the complementary error function

A similar expression for the propagator can be obtained for positive energies by adding a sm all imaginary part to E, but will not be required for our purposes.

# B. The Three-Body Sector

The low-energy properties of the three-body system for a given e ective potential can be obtained by solving the Faddeev equations [38]. Faddeev's idea was to decompose the full three-body wave function into so-called \Faddeev components" in order to avoid the problem of disconnected contributions in the three-body scattering problem. For the three-body problem with two- and three-body interactions, the full wave function can be decomposed into four components [39]: one for each two-body subcluster and one for the three-body cluster.<sup>2</sup> For identical bosons, the three-body wave function is fully symmetric under exchange of particles and the Faddeev equations simplify considerably. In this case, one only needs to solve equations involving one of the two-body Faddeev components and the three-body component. The two remaining two-body components can be obtained by permutations of particles. For more details on the Faddeev equations, we refer the reader to the literature [37, 40].

W e follow G lockle and M eier [39] and decom pose the full three-body wave function as

is a permutation operator that generates the two not explicitly included Faddeev components from  $\cdot$ . The operator P<sub>ij</sub> simply permutes particles i and j. The Faddeev equations for and  $_3$  in operator form are then

where  $G_0$  denotes the free three-particle propagator.t is the two-body t-m atrix for the twobody subsystem described by the component  $t_3$  is the three-body t-m atrix de ned by the solution of the three-body Lippm ann-Schwinger equation with the leading order three-body e ective interaction

only. Since  $V_3$  is separable, we can solve for  $t_3$  exactly and obtain

The three-body regulator function j i will be specified later. Note that  $t_3$  is only a technical construct that is generally cuto dependent and not observable. The physical three-body t-m atrix always includes both two- and three-body forces. Since we are interested only in the binding energies and not in the wave functions, we can eliminate the component  $_3$  and obtain

The component  $_3$  can easily be recovered by using the second line of Eq. (11).

We now derive an explicit representation of Eq. (14) in momentum space. We will illustrate this procedure by showing some details for the rst term on the right-hand side of Eq. (14). The extension to include the second term containing three-body interaction is

straightforward and we will only quote the nalresult. Furtherm ore, in order to understand the renorm alization of the three-body problem it is instructive to consider the case without a three-body force rst. The natural Jacobim on enta are given by:

Here and in the following sections, we will only take S-waves into account. Hence, we can project all operators accordingly and de ne the S-wave projection operator:

Using the denition  $hu_1u_2ji$  ( $u_1;u_2$ ), we can write the Faddeev equation in momentum space as:

where the factor of 4 arises from our normalization of the S-wave projected two-body t-m atrix. The free propagator for three particles in their center of mass is given by

where  $E_{kin}$  denotes the kinetic energy. Furtherm ore, it should be noted that the two-body propagator in Eq. (17) is evaluated at the energy in the corresponding two-body subsystem :  $E = \frac{3}{4}u_2^{0^2}$ . The permutation operator P can be written as:




FIG.1: The shallowest three-body binding energies indicated by the solid, dashed, and dashdotted lines as a function of the momentum cuto . The vertical dashed line indicates the cuto range in which the three-body system has exactly two bound states. The horizontal solid line shows the energy at which the shallowest three-body state is xed.

The three-body binding energies are given by those values of E for which Eq. (24) has a nontrivial solution. By expressing the two-body coupling constant  $_2$  in term softhe binding energy of the shallow two-body bound state in Eq. (9), we have already renorm alized the two-body problem.

The three-body system is stabilized against the Thom as collapse by the presence of the momentum cuto . No three-body force is required for this purpose. A fler the cuto is introduced, there are no bound states with binding energies  $B_3 > 2.3$  However, the three-body binding energies depend strongly on the value of the cuto . This is illustrated in F ig. 1 where the shallowest three-body binding energies are indicated by the solid, dashed, and dash-dotted lines. The three-body system has exactly two bound states in the cuto range indicated by the two vertical dashed lines.

We now include the second term on the right-hand side of Eq. (14) which contains the three-body force. The derivation of an explicit representation in momentum space proceeds

as for the st term . The full equation including both terms then reads

Note that the term in the exponent is the kinetic energy of the three-body system. Thus, it is exactly the kinetic energy owing through the three-body interaction which is limited by the cuto parameter. This choice of the cuto function satis es Bose symmetry explicitly. The factors of 4 and (4)<sup>3</sup> arise from our normalization of the S-wave projection of t and  $t_3$ .

The value of the three-body force is determined by the renormalization condition that the shallowest bound state energy is xed as the cuto is varied. This value is denoted by the horizontal solid line in Fig.1. Depending on the value of the cuto, the three-body force then must provide additional attraction or repulsion in order to keep the shallowest bound state energy xed as the cuto is varied. Thus, one three-body datum (in our case the shallowest bound state energy) is required as input while all other low energy three-body observables can be predicted. Once the shallowest bound state is xed, the binding energies of the deeper bound states will also be cuto independent. When the cuto is increased and a new bound state appears at threshold, the three-body force must turn from strongly repulsive to strongly attractive to satisfy the renormalization condition for the shallowest bound state. The additional state is then added as a deep state rather than at threshold. Low energy three-body observables are not a ected by the additional deep bound states. A s a consequence, the cuto can be made arbitrarily large in the three-body system.

The renormalization procedure determines three-body coupling constant  $_3$  (B<sub>3</sub>; ) uniquely. It was used in Refs. [7, 8] to renormalize the three-body equation derived from nonrelativistic e ective eld theory with an auxiliary eld for the interacting two-particle state. See Ref. [28] for an earlier discussion of this renormalization method. W hile the part of Eq. (24) resulting from two-body interactions only is very similar to the corresponding part of the eld-theoretical equation, the part containing the three-body force (in form of




FIG. 2: The three-body coupling constant  $_3$  as a function of the cuto parameter . The solid blue line shows a tofEq. (26) with c = 0.076 and  $L_3 = 23.3^{\circ} \frac{p}{B_2}$  to the points for  $245^{\circ} \frac{p}{B_2}$ .

 $_3$ ) is more complicated. The simplicity of the eld-theoretical equation is due the special form of the three-body interaction using an auxiliary eld in Refs. [7, 8].<sup>4</sup>

We now explicitly verify the renorm alization of the three-body system as described above. By varying the cuto parameter and tuning the three-body coupling  $_3$  such that the shallowest three-body binding energy stays constant, we can determ ine the renorm alization group evolution of  $_3$  num erically. For the dimensionless coupling constant  $_3$ <sup>4</sup>, we con mether results of Refs. [7, 8, 12, 13]:  $^4$   $_3$ () shows a limit cycle behavior and is single-valued.<sup>5</sup> This limit cycle is shown in Fig.2. For large values of the cuto the dimensionless three-body coupling constant  $^4$   $_3$  ows towards an ultraviolet limit cycle. For ! 1, it has the limiting behavior

where  $s_0$  1:00624 is a transcendental number that determ ines the period of the limit cycle. If the cuto is multiplied by a factor exp (n = s<sub>0</sub>) (22:7)<sup>n</sup> with n an integer, the threebody coupling <sub>3</sub> is unchanged. L<sub>3</sub> is a three-body parameter generated by dimensional

transmutation. One can either specify the dimensionless coupling constant  ${}^4$  <sub>3</sub>() and the cuto or the dimensionful three-body parameter L<sub>3</sub>. The constant c is universal and independent of L<sub>3</sub> within our numerical accuracy. We have determined c numerically by tting  ${}^4$  <sub>3</sub>() for dimension three-body parameters L<sub>3</sub> to Eq.(26) and found:

where the error has been estimated from the observed variation in the tresults for c. The three-body parameter  $L_3$  can be determined by xing a three-body binding energy  $B_3$ . Of course, one could also use a three-body binding energy directly to characterize the value of the three-body coupling  $_3$  at a given cuto . However, it is advantageous to use  $L_3$  because Eq. (26) takes a particularly simple form in terms of  $L_3$ .

One might expect that the smooth G aussian regulator function we use would had to better behaved numerical solutions of the three-body equations than the sharp cuto-used for the eld-theoretical equation in Refs. [7, 8]. However, it turns out that the convergence of the three-body coupling to the ultraviolet limit cycle is significantly slower than in the eld theory formulation. This is due to the more complicated structure of the part of Eq. (24) containing the three-body force. For very large bop momenta, the three-body part of Eq. (24) simplifies considerably and has a similar form as in the EFT formulation. In this limit, it is possible to derive the general form of Eq. (26).

In general, we recover the results for the three-body binding energies from Refs. [7, 8, 12, 13]. However, we note that som ewhat higher cuto s are required to reach convergent results for the deeper three-body bound states. The numerical e ort for the solution of the three-body equations becomes larger as the value of the three-body coupling  $_3$  is increased. This is also related to the relatively complicated structure of the part of Eq. (24) containing the three-body force.

#### C. The Four-Body Sector

We now turn to the four-body sector. The four-body binding energies are given by the non-trivial solutions of the Yakubovsky equations [25] which are based on a generalization of the decom position into Faddeev components for the three-body system. The full four-body wave function is rst decom posed into Faddeev components, followed by a second decom – position into so-called \Yakubovsky components". In the case of identical bosons, one ends up with two Yakubovsky components  $_{\rm A}$  and  $_{\rm B}$ . We start from the Yakubovsky equations including a general three-body force in the form written down by G lockle and K am ada [41]. The full four-body bound state wave function is decomposed into the Yakubovsky components  $_{\rm A}$  and  $_{\rm B}$  via

where  $t_{12}$  denotes the two-body t-m atrix for particles 1 and 2 and  $V_3$  is the three-body force de ned in Eq. (12). Note that the three-body force couples to the full four-body wave function . The factor of one third in front of the three-body force term arises because we insert the full three-body interaction for  $V_3$ . This is possible since we consider three-body contact interactions which are symmetric under the exchange of any pair of particles.

In order to describe the four-body system at rest, three Jacobim om enta are required. The structure of the four-body equations is more complex than that of the three-body equations because both (3)+ (1) and (2)+ (2) fragm entations can occur. As a consequence, two di erent sets of Jacobim om enta are required. The (3)+ (1) fragm entation is described by the vector

D epending on which Y akubovsky component and operator in Eq. (30) is concerned, one of the two sets of coordinates will be more convenient than the other.

As in the previous subsection, we will only display the derivation of the analytic expression for the Yakubovsky equations without the three-body force. It is natural to evaluate the Yakubovsky component  $_{\rm A}$  as a function of  $u_1; u_2$ , and  $u_3$ :

The inclusion of the three-body force term is straightforward but lengthy and the corresponding expressions are given in the appendix.

In order to obtain the four-body binding energies, we have to solve the Yakubovsky equations with the three-body force term. The binding energies can be found by discretizing the above equations and calculating the eigenvalues of the resulting m atrix. They are given by the energies at which any eigenvalue of the m atrix is equal to one. The wave function is then given by the corresponding eigenvector.

The renorm alization analysis of the four-body system is complicated by the cuto dependence of the number of bound states in the three-body subsystems. The further the cuto is increased, the more three-body bound states appear. While the spurious deep three-body states have no in uence on low energy three-body observables, they create an instability in the four-body system which can collapse into a deep three-body bound state plus another particle. This lim its cuto variations to an interval  $_0 < 22:7_0$  for some  $_0$ , in which the number of three-body bound states remains constant. Since the cuto can still be varied by more than a factor of ten, we are nevertheless able to study the renorm alization properties and obtain converged num erical results. A lternatively, one could explicitly subtract out the spurious bound states from the three-body t-m atrix. We will come back to this question in the next section.

# III. RENORMALIZATION AND NUMERICAL RESULTS

In this section, we will discuss the renorm alization of the four-boson system and present som e num erical results for the four-body system of  ${}^{4}\text{H}\,\text{e}$  atom s. For convenience, we will set B oltzm ann's constant to unity: k = 1. Since the scattering length of  ${}^{4}\text{H}\,\text{e}$  atom s is much larger than their e ective range, they are an ideal application for our theory and a leading order calculation should be accurate to about 10% (since l=a ' 10%).

The quantitative experimental information on low-energy <sup>4</sup>He atoms, however, is rather limited. Using diraction of a molecular beam of small <sup>4</sup>He clusters from a transmission grating, the bond length of the <sup>4</sup>He dimer has been measured to be hri =  $(52 \quad 4)$  A [42]. This value is an order magnitude larger than their elective range  $r_e = 7A$ , which can be taken as an estimate of the natural low-energy length scale 1. The scattering length  $a = 104_{18}^{+8}$  A and the dimer binding energy  $B_2 = 1.1_{0.2}^{+0.3}$  mK were derived from the measured bond length using the zero range approximation [42]. The <sup>4</sup>He trimer, tetramer, and several larger <sup>4</sup>He clusters have been observed [43, 44], but no quantitative experimental information about their binding energies is available to date.

However, there is a large number of theoretical calculations using realistic  ${}^{4}\text{H}$  e potentials for the trim er ( ${}^{4}\text{H}\,\text{e}_{3}$ ). These calculations typically predict a trim er ground state with an energy of about 120 m K and one excited state with a binding energy of about 2 m K [45, 46, 47, 48]. The ground and excited states of the tetram er ( ${}^{4}\text{H}\,\text{e}_{4}$ ) and larger clusters have been calculated by B lum e and G reene (BG) [21]. They have used the LM 2M 2 potential [49] and a combination of M onte C arlo m ethods and the adiabatic hyperspherical approxim ation. Their results for the trim er energies agree with the exact three-body calculations of R efs. [45, 46, 47, 48].

In the absence of quantitative experimental information on the three-body clusters, we take the binding energy of the  ${}^{4}\text{H}e$  trimer excited state from theoretical calculations using the LM 2M 2 potential as input to  $x L_{3}$ . We use the value of BG : B $_{3}^{(1)}$ =B $_{2}$  = 1:767 for this purpose [20, 21]. We can then calculate the trimer ground state and the tetramer binding energies for the LM 2M 2 potential based on low-energy universality. Before we present our numerical results for the  ${}^{4}\text{H}e_{4}$  system, we discuss the renormalization of the four-body problem.




FIG. 3: Binding energies of the three- and four-body system as a function of the cuto  $B_n^{(0)}$  and  $B_n^{(1)}$  denote the ground and rst excited state of the n-body system.

In Fig. 3, we have plotted the three-body ground state energy  $B_3^{(0)}$  and the four-body energies as a function of the cuto As in the case of the trim er, the <sup>4</sup>H e tetram er has a ground state  $B_4^{(0)}$  and one excited state  $B_4^{(1)}$ . The cuto dependence of  $B_3^{(0)}$  must atten out

and reach a plateau as is increased since the three-body system was renorm alized by xing the trim er excited state binding energy  $B_3^{(1)}$  (cf. subsection IIB). However, Fig. 3 shows that the four-body binding energies  $B_4^{(0)}$  and  $B_4^{(1)}$  also reach a plateau as is increased. The excited state energy  $B_4^{(1)}$  has a negligible cuto dependence already at fairly small cuto s. For the ground state  $B_4^{(0)}$ , the situation is somewhat more complicated and the cuto dependence of  $B_4^{(0)}$  reaches a plateau only at the largest cuto values calculated. The residual cuto dependence is about 2% for the excited state and 5% for the ground state. A slower convergence for the ground state is expected since the value for  $B_4^{(0)}$  is a factor four larger than for the excited state and nite cuto e ects of the order 1E†= aremore important. The residual cuto dependence for both states is at least a factor 2 sm aller than the corrections from higher orders in the expansion in 1-a which are expected to be of the order 1=a 10%. We speculate that higher precision could be achieved by increasing the cuto further. As already noted earlier, this would create unphysical three-body bound states which create an instability in the four-body system . These states would have to be subtracted explicitly. W hile such a subtraction is possible, this is beyond the scope of our paper and we will not attem pt such a subtraction here.

Taken together, the above observations provide strong num erical evidence that the fourbody binding energies are cuto independent up to higher order corrections in l=a. In particular, a four-body force with lim it cycle behavior would lead to a much stronger cuto dependence of the binding energies (cf. Fig. 1) and can be excluded. The occurrence of the plateaus for  $B_4^{(0)}$  and  $B_4^{(1)}$  in Fig. 3 suggests that a four-body force is not required for renorm alization of the four-body system at leading order in l=a. Renorm alization of the three-body system autom atically generates cuto -independent results for the four-body binding energies. As a consequence, the four-body binding energies can be predicted from two- and three-body input alone.

We now turn to our numerical results for the four-body system of <sup>4</sup>He atom s. From the plateaus in Fig. 3, we can read o the values of the binding energies. A comparison of our results with the values obtained by BG [21] is shown in Table I. The results of their calculation for the trim er and tetram er are given in the two right columns of Table I, while our results are given in the two left columns. In general, our results are in good agreement with the values of BG. For the trim er ground state and the tetram er excited state energies, we obtain the values B<sub>3</sub><sup>(0)</sup> = 127 m K and B<sub>4</sub><sup>(1)</sup> = 128 m K, respectively. For the tetram er ground state, we obtain B<sub>4</sub><sup>(0)</sup> = 492 m K. W hile the value of B<sub>4</sub><sup>(0)</sup> is already relatively large, it is still a factor three smaller than the natural four-body energy scale 1.5 K where the e ective theory description is expected to break down.

The natural energy scales can be estimated as follows: For two particles, it is directly determined by the natural length scale land the mass M of the particles:  $e_2 = h^2 = (M - l^2)$  250 m K. For three and four particles, this estimate should be scaled according to the number of pairs available,<sup>6</sup> leading to the values  $e_3 = 750$  m K and  $e_1 = 1.5$  K. This estimate can be made for cuto values at which the three-body force vanishes. Since all observables are independent of the cuto, how ever, it is valid for arbitrary cutos. Our short-range elective theory can describe n-body bound states with binding energies  $B_n = e_n$ . For deeper bound states closer to the natural energy scale the errors are expected to increase.

The values in Table I have been computed at a cuto of  $= 235^{P} \overline{B_2}$  which is close to the largest possible value with only two three-body bound states. Our values for  $B_4^{(0)}$ and  $B_4^{(1)}$  agree with the BG values to within 12% and 3%, respectively. The dominant correction to our results is due to e ective range e ects which are not included in our leading order calculation. These deviations are within the expected accuracy of the e ective theory. We expect the elective range corrections to the leading order result to be of the

order  $r_e=a$  10%. From the residual cuto dependence, we estimate the numerical error of our calculation to be of the order of 2% for the excited state and 5% for the ground state. For xed value of the cuto , our calculations are numerically accurate to 3 signi cant digits.

The large scattering length of <sup>4</sup>H e atom s also leads to universal properties in the four-body problem. A typical example is the existence of correlations between di erent observables. These correlations become manifest in universal scaling functions relating dimensionless combinations of observables. Various scaling functions for the three-body system of <sup>4</sup>H e atom s were studied in Refs. [26, 50, 51]. Here, we consider the four-body binding energies as a function of the three-body binding energies. In phenom enological calculations of the four-nucleon system, an approximately linear correlation between the three- and four-nucleon binding energies for various nucleon-nucleon potentials is observed: the T jon line [14]. This correlation is approximately linear for the relevant range of binding energies [30]. Since the <sup>4</sup>H e trim er and tetram er have both a ground state and an excited state, there are four \T jon lines" in this case.




FIG. 4: The correlations between the ground and excited state energies of the  ${}^{4}\text{H}$  e trim er and tetram er. Upper row : the four-body excited state energy  $B_{4}^{(1)}$  (left panel) and ground state energy  $B_{4}^{(0)}$  (right panel) as a function of the three-body excited state energy  $B_{3}^{(1)}$ . Lower row : the same quantities as a function of three-body ground state energy  $B_{3}^{(0)}$ . The solid line shows the leading order elective theory result and the cross denotes the calculation for the LM 2M 2 potential by B lum e and G reene [21]. The triangles show the results for the TTY, HFD-B, and HFDHE2 potentials [17, 20].

In Fig. 4, we show the correlations between the ground and excited state energies of the  ${}^{4}\text{H}\,\text{e}\,\text{trim}\,\text{er}$  and tetram er. The two plots in the upper row show the energies of the tetram er excited state  $B_{4}^{(1)}$  (left panel) and ground state  $B_{4}^{(0)}$  (right panel) as a function of trim er excited state energy  $B_{3}^{(1)}$ , while the lower row shows the same equantities as a function of the trim er ground state energy  $B_{3}^{(0)}$ . The solid line is the leading order result of our e ective theory calculation and the cross denotes the result of the calculation by BG for the LM 2M 2 potential [21]. For the ground states of the trim er and tetram er, calculations with other  ${}^{4}\text{H}\,\text{e}$  potentials are available as well. As an exam ple, we show the results for the TTY, HFD-B, and HFD HE2 potentials taken from Refs. [17, 20].

Similar to the nuclear sector, we nd an approximately linear correlation over the range of binding energies relevant to  ${}^{4}\text{H}\,\text{e}$  atom s. The calculations for the realistic  ${}^{4}\text{H}\,\text{e}$  potentials fall close to the universal scaling curves from our elective theory. For the correlation between the ground state energies, the \T jon line" is directly evident in the potential model calculations shown in Fig. 4. If calculations with other potentials were performed for the excited state energies, they would also fall on a line parallel to the universal scaling curve from elective theory. The deviation of calculations using realistic potentials from the universal line is mainly governed by elective range corrections which are expected to be of the order 10% for  ${}^{4}\text{H}\,\text{e}$  atom s. For the tetram er ground state, this deviation is about a factor four larger than for the excited state.

W hile the correlations in Fig. 4 are approximately linear over the range of binding energies calculated, we expect them to become nonlinear for a su ciently large range of binding energies. Similar nonlinearities were observed for correlations between three-body observables in Refs. [8, 26]. Our results suggest that the T jon lines" are universal properties of few-body systems with short-range interactions and large scattering length. They do not depend on the details of the short-distance physics which are very di erent in atom ic and nuclear systems. It is interesting to note that in nuclear physics only a correlation between the ground-state energies of the three- and four-body systems has been observed. We expect this correlation to hold for all S-wave states that are within the range of validity of an elective theory with contact interactions. It would be interesting to see whether such a correlation also holds for the excited  $J^P = 0^+$  state of the particle above the p+ <sup>3</sup>H threshold.

We have tted the scaling functions shown in Fig. 4 with linear expressions and obtained:

These relations can be used to predict the tetram er ground and excited state energies for any potential for which one of the trim er energies and the dim er binding energy are known. The expressions (39)-(42) are of the sam e accuracy as our explicit calculations (see the discussion above). They are expected to be most accurate for the excited states.

### IV. SUMMARY AND OUTLOOK

In this paper, we have studied the four-body system with short-range interactions and large scattering length. We have concentrated on the bound state problem of four bosons starting from the Yakubovsky equations [25]. We have constructed an elective interaction potential including both a two- and three-body contact interaction. This is the minimal set of contact interactions required for renorm alization of the three-body problem [7, 8]. The two parameters of the elective potential were determined from matching to the binding energy of the dimer and the excited state of the trimer. We have then solved the four-body bound state problem under the assumption that no four-body interaction is required for renorm alization at leading order. We found that after renorm alizing the two- and three-body subsystems, the four-body binding energies were automatically independent of the ultraviolet cuto . This result suggests that the four-body interaction is not of leading order and the low-energy four-body observables are determined by properties of the two- and three-body systems up to corrections suppressed by l=jaj. A lthough we have considered only the four-boson bound state problem with large scattering length explicitly, we expect this result to hold for all low-energy four-body observables.

We have applied thise ective theory to the four-body system of <sup>4</sup>H e atom s and calculated the ground and excited state energies of the <sup>4</sup>H e tetram er. In the absence of experimental information on the <sup>4</sup>H e trimer, we have taken the excited state energy of the <sup>4</sup>H e trimer as calculated by B lume and G reene for the LM 2M 2 potential [21] as input to determ ine the three-body parameter L<sub>3</sub>. For the binding energies of the trimer ground state and the tetram er ground and excited states, we not the values B  $_{3}^{(0)} = 127 \text{ m K}$ , B  $_{4}^{(1)} = 128 \text{ m K}$ , and B  $_{4}^{(0)} = 492 \text{ m K}$ , respectively. The latter energy is still about a factor three sm aller than the natural four-body energy scale 1:5 K where the elective theory is expected to break down. Our values for B  $_{4}^{(0)}$  and B  $_{4}^{(1)}$  agree with the calculation by B lume and G reene to within 12% and 3%, respectively. These deviations are consistent with the expected accuracy at leading order in the large scattering length of about l=jaj 10%.

The large scattering length of  ${}^{4}\text{H}$  e atom s leads to universal properties such as universal scaling functions. We have calculated the universal scaling functions relating the tetram er energies to the trim er energies. The correlations are approximately linear in the region of binding energies relevant for  ${}^{4}\text{H}$  e atom s. As expected from low energy universality, the results of various calculations using realistic  ${}^{4}\text{H}$  e potentials fall close to the universal scaling curves. C orrections to the scaling functions with linear expressions (39)-(42) that can be used to obtain the tetram er binding energies at leading order in l=jajfor any potential if one of the trim er binding energies is known.

There are a number of directions that should be pursued in future work. While we have demonstrated that a four-body force is not necessary to renormalize the four-body system to leading order, the general power counting for four-body forces is still not understood. At which order does the leading four-body interaction enter? In the three-body system, e.g., the rst order correction is due to the two-body elective range. If a similar situation holds in the four-body system, it would be possible to predict low-energy four-body observables up to corrections of order  $(l=a)^2$  from two- and three-body information alone.

The extension of the elective theory to calculate four-body scattering observables would be very valuable. The knowledge of the dimerdimer scattering length, for example, is important for experiments with ultracold atoms. For the simpler problem of fermions with two spin states (where the three-body parameter  $L_3$  does not contribute), the dimerdimer scattering length was recently calculated [52].

W hether this e ective theory can be applied to the nuclear four-body system like the pionfultheory [31] is an open question. W hile it is straightforward to generalize the e ective theory to include spin and isospin, it is not clear whether an e ective theory w ithout explicit pions will be adequate for the particle ground state with a binding energy of about 28 M eV. This question deserves further study. The e ective theory m ight also help to shed som e light on the renewed speculations about the existence of a shallow tetraneutron bound state [53].
