## Equilibrium magnetization in the vicinity of the rst order phase transition in the mixed state of high- $T_c$ superconductors.

W e present the results of a scaling analysis of isotherm alm agnetization M (H) curves measured in the mixed state of high- $T_c$  superconductors in the vicinity of the established rst order phase transition. The most surprising result of our analysis is that the di erence M between the magnetization above and below the transition may have either sign, depending on the particular chosen sample. We argue that this observation, based on M (H) data available in the literature, is inconsistent with the interpretation that the wellknown rst order phase transition in the mixed state of high- $T_c$  superconductors always represents the melting transition in the vortex system.

M easurements of the magnetization of a type-II superconductor in the mixed state provide valuable inform ation about di erent param eters characterizing the superconducting state of the investigated material. The irreversible magnetization re ects the pinning strength of vortices, and by analyzing the reversible magnetization, di erent equilibrium parameters of the superconducting material, such as critical magnetic elds and characteristic lengths may be evaluated. This is why magnetization measurements are often used to investigate conventional and unconventional superconductors. For instance, the well-known st-order phase transition in the m ixed state of high-T $_{\rm c}$  superconductors (HTSC), which is usually attributed to the melting of the vortex lattice, was discovered and con med by magnetization measurements.<sup>1,2,3</sup> In this work we apply a recently developed scaling procedure<sup>4</sup> for an analysis of M (H) curves above and below this phase transition and we nd inconsistencies that indicate that the transition is not always related to a melting of the vortex lattice.

Our scaling procedure (see Refs. 4,5,6,7) is based on the fact that, if the Ginzburg-Landau parameter is temperature independent, the magnetic susceptibility in the mixed state of a type-II superconductor may be written as

$$(H;T) = (H = H_{c2});$$

where  $H_{c2} = H_{c2}$  (T) is the upper critical eld. A coording to Eq. (1), the tem perature dependence of is solely determ ined by the tem perature variation of  $H_{c2}$ . Eq. (1) is su cient to derive a relation between the m agnetizations M at two di erent tem peratures T and  $T_0$ , which m ay be written as

$$M (H = h_{c2}; T_0) = M (H; T) = h_{c2}$$

where  $h_{c2}$  (T) = H  $_{c2}$  (T)=H  $_{c2}$  (T<sub>0</sub>) is the ratio of the upper critical elds at T and T<sub>0</sub>. This equation is valid if the diam agnetic response of the m ixed state is the only significant contribution to the sam plem agnetization. It is well know n, how ever, that m any superconducting m aterials, including the HTSC's that we consider in this work, exhibit sizable param agnetic susceptibilities in the norm al state. In order to account for this additional contribution to the sample m agnetization, the following modi cation of Eq. (2) needs to be m ade<sup>4</sup>

As is discussed detail in Ref. 4, Eq. (3) may be used for the scaling of equilibrium magnetization M (H) curves measured at di erent temperatures, to obtain M (H; T<sub>0</sub>). The scaling parameters  $h_{c2}$  (T) and  $c_0$  (T) are determined by the condition that the M (H; T<sub>0</sub>) curves, calculated from the magnetization data measured at di erent temperatures, collapse onto the same master curve. In this way the temperature dependence of the normalized upper critical eld  $h_{c2}$  (T) and the equilibrium magnetization curve M eff (H) = M (H; T<sub>0</sub>) are obtained. W hile in Refs. 4,5,6,7, the main goal was to establish the  $h_{c2}$  (T) curves, in the present work we analyze the scaled M (H) curves in the vicinity of the scale phase transition.

In our previous work we discussed in detail the conditions under which our scaling procedure is valid and we showed that these conditions are considerably less restrictive than those that were chosen in previously presented analyses of M (H;T) curves in the mixed state of HTSC's.<sup>4</sup> Our only assumption, the validity of Eq. (1), is rather general and the scaling procedure can be used for the analysis of the equilibrium m agnetization data independent of the sam ple geom etry, the pairing type, or of the particular con guration of the mixed state.

B ecause the validity Eq. (3) is restricted to equilibrium m agnetization, only M (H;T) curves collected above the irreversibility line can be used for the evaluation of the scaling parameters  $h_{\rm c2}$  (T) and  $c_0$  (T). Nevertheless, some additional information may also be gained from the analysis of scaled M <sub>eff</sub> (H) curves calculated from m agnetization data below the irreversibility line. It was argued in Ref. 8 that, if the calculated M <sub>eff</sub> (H) curves collapse onto a single curve also below the irreversibility line, this may be regarded as strong evidence that the corresponding branches of the m easured M (H;T)

curves represent the equilibrium magnetization. It was indeed demonstrated in Ref. 8 that for many Bibased HTSC's, the M (H) data collected in increasing magnetic

elds follow the equilibrium m agnetization curve  $M_{eq}$  (H) even in elds well below the irreversibility line. Below we show that this is also true for an optimally doped YBa<sub>2</sub>Cu<sub>3</sub>O<sub>7 x</sub> (Y-123) sample, while in La<sub>2</sub>CuO<sub>4</sub> (La-214) based cuprates, this e ect is practically unobservable and both branches of the measured M (H) curves deviate from M<sub>eq</sub> (H) just below the irreversibility line.

W e apply the scaling described by Eq. (3) to results of m agnetization m easurements in the vicinity of the st order phase transition that are available in the literature. It turns out that some of the results of our analysis are in contradiction with the vortex-lattice-melting hypothesis. For this reason, we use the more general nom enclature of "high-eld" and "low-eld phase", instead of the commonly used notations of vortex liquid and vortex solid.




FIG. 1: The M  $_{\rm eff}$  (H =h<sub>c2</sub>) curves for two La-214 samples studied in Refs. 9 and 10. For one of the samples, only reversible m agnetization data are shown.

First, we consider the experim ental data for two sim ilar (La0:954 Sr0:046)2CuO4 (La-214) single crystals. The scaling results for these samples, calculated for  $T_0 = 14 \text{ K}$ , are shown in Fig. 1. In these two experiments, the magnetization is reversible down to magnetic elds well below the phase transition. The collapse of the data points m easured at di erent tem peratures is achieved with the same values of  $h_{c2}$  (T) and  $c_0$  (T) both below and above the transition, in complete agreement with the expectation outlined above. The results displayed in Fig. 1 may be interpreted as evidence for the existence of two di erent modi cations of the mixed state with two different equilibrium M eff (H;T0) curves above and below the transition. In the following we use M  $_{\rm eq}^{\rm (lp)}$  and M  $_{\rm eq}^{\rm (hp)}$ to distinguish the equilibrium M  $_{eff}$  (H ) curves at T = T<sub>0</sub> for the low-and the high-eld modi cations of the mixed state, respectively. As may be seen in Fig. 1, the low-




FIG. 2: The M  $_{\rm eff}$  (H =h\_c2) curves for an optimally doped B  $\rm i_2Sr_2C\,aC\,u_2O_{8+\,x}$  sample.<sup>11</sup> Only the magnetizations measured in increasing elds are shown. The dashed line indicates the most likely extrapolation of the M  $_{\rm eq}^{\rm (lp)}$  curve.




FIG. 3: The M  $_{eff}$  (H =h $_{c2}$ ) curves for an optimally doped YBa<sub>2</sub>Cu<sub>3</sub>O<sub>7 x</sub> sample, experimentally investigated in Ref. 12. Only the data collected in increasing elds are shown. The inset shows M  $_{eff}$  (H =h $_{c2}$ ) for T = 86 K; the dashed straight lines denote the linear extrapolations of M  $_{eq}^{(lp)}$  (H) and M  $_{eq}^{(hp)}$  (H).

eld modi cation corresponds to som ew hat higher values of the diam agnetic moment (sm aller vortex density). The di erence  $M = M_{eq}^{(lp)} M_{eq}^{(hp)}$  is positive. A nalogous results for optim ally doped B i<sub>2</sub>Sr<sub>2</sub>C aC u<sub>2</sub>O<sub>8+x</sub> (B i-2212) and Y-123 sam ples are shown in Figs. 2 and 3, respectively. The behavior of the magnetization in the vicinity of the phase transition for these two sam ples is milar to that presented in Fig. 1. The  $M_{eq}^{(lp)}$  and  $M_{eq}^{(hp)}$  curves are readily identi ed, in spite of a pronounced peak e ect observed for the Y -123 sample at the low est tem perature. The di erence  $M = M_{eq}^{(lp)} M_{eq}^{(hp)}$  is again positive in both cases.




FIG. 4: The M  $_{\rm eff}$  (H ) curves for a La-214 sample studied in Ref. 13. The dashed line indicates M  $_{\rm eq}^{\rm (lp)}$  (H ). The inset shows the original magnetization data. The vertical arrows m ark the phase transition, as claim ed in Ref. 13.

The M  $_{\rm eff}$  (H ) curves in the transition region for another La-214 sam ple, which are displayed in Fig. 4, are quite di erent from those shown in Figs. 1-3. The easily distinguishable M  $_{\rm eq}^{\rm (lp)}$  (H ) and M  $_{\rm eq}^{\rm (hp)}$  (H ) curves indicate that the di erence  $M = M_{eq}^{(lp)}$ M eq (hp) is negative. The original magnetization data are shown in the inset of Fig. 4; the only di erence to Fig. 1 of Ref. 13 is that we use a log-scale for H . The arrows indicate the m iddle-points of the phase transitions at the corresponding tem peratures, as claim ed in Ref. 13. Our plot reveals no evidence for phase transitions at these magnetic elds. W e argue that the natural curvature of the M (H ) curves that were plotted on linear scales, emphasized by a real change of slopes at lower elds, lead to a questionable identi cation of the phase transitions.




FIG. 5: The M<sub>eff</sub>(H) curves for an overdoped Bi-2212 sample.<sup>14</sup> The dotted lines indicate M<sub>eq</sub><sup>(lp)</sup>(H) and M<sub>eq</sub><sup>(hp)</sup>(H). Because of rather strong uctuations of the magnetization m easured in decreasing elds at 48 K T 52 K and T = 57 K (see Fig. 2(a) of Ref. 14), the corresponding branches of the M<sub>eff</sub>(H =h<sub>c2</sub>) curves for these tem perature are not displayed in this plot.

Finally we show the result of the scaling procedure for an overdoped  $B_{12}\,Sr_2\,C\,aC\,u_2O_{8+\,x}$  sample in Fig. 5. Although only M (H) data in magnetic elds above the transition were used for the evaluation of  $h_{\rm c2}$ (T) and  $c_0$ (T), the magnetization curves measured in increasing magnetic elds collapse onto a single  $M_{\rm eff}$ (H) curve also below the irreversibility line and thus, as argued above, represent the equilibrium magnetization for  $T=T_0$ . The equilibrium M (H) curves for the low and high eld modie cations of the mixed state are such that the di erence  $M=M_{\rm eq}^{\rm (lp)}$  M  $_{\rm eq}^{\rm (hp)}$  in the transition region is again

negative. The width of the transition from one modi cation of the mixed state to the other, which is quite large at higher tem peratures, is considerably reduced with decreasing tem perature. Also in this case we disagree with

the interpretation of the magnetization curves given by the authors of the original publication. A coording to R ef. 14, the di erence M changes its sign at T 50 K, while from Fig. 5 it is clear that M is always negative and its absolute value m on oton ically decreases with decreasing tem perature.

The most unexpected result of our analysis is that the magnetization di erence M across the transition may adopt either sign. This result is di cult to reconcile with the vortex-lattice-melting hypothesis. In case of vortex lattice melting, the external magnetic eld acts as pressure does in traditional solid-liquid melting transitions. Therm odynam ics requires that the phase corresponding to the higher pressure must have a higher density, independent of whether this high-pressure phase is a liquid or a solid. In relation with the mixed state of type-II superconductors, the vortex liquid necessarily has to adopt a higher vortex density, i.e., the di erence  $M = M_{eq}^{(lp)}$  $M_{eq}^{(hp)}$  must always be positive. Since negative values of M are identi ed form aterials belonging to two di erent fam ilies of HTSC's, this can hardly be refuted as an accidental result.

In the bulk of the existing literature, the st order transition in the mixed state of HTSC's is viewed as a melting transition in the system of vortices. In this scenario, the mixed state above the transition represents the vortex liquid, while the vortex solid below the transition is described as a lattice or B ragg glass of vortices, depending on the particular experimental conditions. Numerous experimental observations in the literature are in agreement with this interpretation. However, if the vortex lattice melting is indeed always responsible for the

rst order transition, all experim ental results must nd their explanation from this point of view. Apparently, this is not the case. We see no way in which the negative values of M, clearly demonstrated in Figs. 4 and 5, may be explained by invoking the vortex-lattice-melting hypothesis.

W e also note that in the case of the Y-123 sam ple, the slope dM  $_{eq}$ =d (ln H ) in the low - eld phase is substantially smaller than that in the high- eld phase (see inset of F ig. 3). Because an order-disorder transition, such as the vortex lattice melting, cannot signi cantly change the eld dependence of the sam ple magnetization, such a change of dM  $_{eq}$ =d (ln H ) is not expected at a vortex lattice melting-transition.

If there is a storder phase transition in the mixed state of HTSC's which is not related to vortex lattice melting, it must be of di erent origin. Below we present several possible scenarios. We do not argue in favor of one or the other possibility and we do not even claim that all these scenarios are indeed realistic. Of course, we cannot exclude other possibilities which are not considered here.

1. The change of the sym m etry of the vortex lattice. It is well known that with increasing m agnetic eld a triangular vortex lattice m ay change to a square one via a

rst-order phase transition. In general, such a transition reduces the density of vortices. It is also possible, how – ever, that a combination of this transition and a melting of the vortex lattice has to be considered. It is indeed possible that the position of the melting line  $H_m$  (T) depends on the symmetry of the vortex lattice and two di erent melting lines  $H_m^{(tr)}$  (T) and  $H_m^{(sq)}$  (T) exist for

the triangular and square con gurations, respectively. If  $H_{m}^{(sq)}(T) < H_{sym}(T) < H_{m}^{(tr)}(T)$ , where  $H_{sym}(T)$  denotes the symmetry transition, we have, with increasing

eld or tem perature, a transition to a square vortex lattice which immediately melts down. In this case, there are two contributions to M with opposite signs and the resulting value of M may be positive or negative depending on the experimental conditions.

2. A magnetic eld induced transition in the superconducting material which is not directly related to the mixed state but changes the superconducting parameters of the sample. It is dicult to imagine, how ever, that the temperature dependence of such a transition follows that of the rst order phase transition in the mixed state of HTSC's.

3. It was suggested in Ref. 15 that in high magnetic elds, the mixed state of high- superconductors is form ed by superconducting lam ents in a norm al-state matrix, instead of A brikosov vortices in a superconducting background. The transition to the vortex state with decreasing magnetic eld occurs via a topological transition with all generic features of a rst order phase transition. The sign of M would depend on particular experim ental conditions.

In conclusion, the most important result of our analysis is that the di erence  $M = M_{eq}^{(lp)} M_{eq}^{(hp)}$  between the equilibrium magnetization curves below and above the transition in the mixed state of HTSC 's may be negative as well as positive. The negative sign of M is in serious con ict with the interpretation that this transition relates the melting of the vortex lattice.
