Lattice D ynam ics in P bM $g_{1=3}N$ $b_{2=3}O$ 3

Lattice dynam ics for veordered PbM $g_{1=3}N$ $b_{2=3}O$ 3 supercells were calculated from rst principles by the frozen phonon method. Maximal symmetries of all supercells are reduced by structural instabilities. Lattice modes corresponding to these instabilities, equilibrium ionic positions, and infrared reectivity spectra were computed for all supercells. Results are compared with our experimental data for a chemically disordered PMN single crystal.

I. INTRODUCTION

Lead magnesium niobate PbM $g_{1=3}Nb_{2=3}O_3$ (PMN) is an ABO3-perovskite that exhibits relaxor ferroelectric (RFE) properties, such as a broad, frequency sensitive, dielectric permittivity peak at T_{max} near room tem perature. 1,2 It was originally suggested that RFE properties are associated with a \di use phase transition" that re ects a random spatial distribution of Curie tem peratures, originating from chemical inhomogeneities; however, the implied chemical segregation of and $\mathrm{N}\,\mathrm{b}^{5+}$ ions on perovskite B-sites has not been observed. Rather, transmission electron microscopy (TEM) indicates chemical short-range order (SRO) such that 1:1 ordered domains, 20-50 A across, are embedded in a disordered matrix.3 Thus, the microstructure is characterized by uctuations of a 1:1 chemical order param eter on the 20-50 A length scale, and not by com positional uctuations about M q N b= 12, as previously suggested.4,5

The \random site model (RSM)" for the ordered domains, 6,7,8,9,10 has NaCl+type Mg/Nb ordering with one B-site occupied by Nb⁵⁺, and the other by a random mixture of 1/3 Nb⁵⁺ + 2/3 Mg²⁺. Note that the phrase \random -site model" is only used for an idealized model. The phrase \1:1 phase" is used for real crystals that presum ably have some SRO them ical correlations which are deviations from random ness on the Mg²⁺-rich sites.

Burns and D $acol^{11}$ observed that the refractive index of PMN departs signi cantly from a linear temperature dependence below a characteristic temperature, $T_{\rm B}$ 630K (Burns temperature). They interpreted these data as indicating that polar nanoclusters (PNC) condense at T < $T_{\rm B}$; and $T_{\rm B}$ is now generally ac-

cepted as the crossover between RFE and paraelectric (PE) states. Recent TEM studies 12,13 have attempted to correlate chem ical SRO with PNC.

Chemical SRO makes PMN inhomogeneous at a length-scale that a ects vibrational mode activities. Mode activities in inhomogeneous media are determined by the range of interatomic forces, typically a few lattice parameters, and they do not depend on the wavelength of the probing radiation. However, the probing radiation wavelength does determine the volume in which the spectroscopic response is averaged. If, as in PMN, the inhomogeneities are smaller than the wavelength, an effective medium approach is justied.

Room—tem perature IR re ectivity spectra of PMN single crystals were rst published in the $1970s^{1.1,14}$ K aram yan reported three polar modes, characteristic of cubic perovskites. Burns and Dacol, however, reported many more modes, which they explained as \two-mode behavior". Subsequent studies of PMN ceram ics 16 agreed with K aram yan's spectrum, but the resolution was poor.

The interpretation of Ram an spectra from PMN is also controversial (e.g. 17,18). The Ram an spectra of PMN and PST are similar, 17,19 and it was assumed that the main features of both relect Fm $\overline{3}m$ symmetry (locally for PMN) as in the 1:1 phase. In Fm $\overline{3}m$, the Ram an active modes are A_{1g} , E_g , and $2F_{2g}$: A_{1g} and E_g modes are observable in parallel (VV) geometry; $2F_{2g}$ modes are observable in crossed-polarized (VH) geometry. Polarized Ram an studies and Ram an spectral intensities support TEM results in suggesting that PMN has 1:1 chemical SRO in a disordered matrix.

The objectives of this study are: (1) to perform a comparative supercell stability analyses in PMN, including symmetry-breaking relaxations [i.e. nding ground

states (GS) with symmetries that are lower than those dictated by chemical ordering]. (2) to compute the lattice dynamics for the same set of ordered PMN supercells, and to compare the results with experimental data, e.g. by comparing simulated IR rejectivity spectra with the experimental one. The goal is to individual ordered supercellmost closely approximates the experimental case of local 1:1 order.

II. IN FRARED SPECTRA

IR and THzm easurementswere performed on a PMN single crystal, down to liquid helium tem peratures, where all polar modes are well distinguished. A disk of 9 mm diameter and 3 mm thickness was cut from a PM N single crystal, and polished for specular IR re ectivity measurements. A time-domain THz spectrometer was used to determ ine the complex dielectric response " () in the subm illim eter and near-m illim eter ranges. This spectrom eter uses fem to second laser pulses to generate THz radiation via optical rectication on a ZnTe single crystal, with an electro-optic sampling detection technique. Low-tem perature spectra were taken in transmission conguration from 100-900 GHz, where the thin (100 m thick) plane-parallel plate was sem i-transparent. Room tem perature dielectric response up to 2.5 THz was calculated from the THz re ectance data. The unpolarized near-normal re ectivity spectra were taken with a Fourier transform IR (FTIR) spectrom eter Bruker IFS 113v at 20 T 300 K in the spectral range 20-650 om 1; room tem perature spectra were measured up to 4000 cm^{-1} .

IR re ectivity spectra were tted together with complex dielectric T H z spectra using a generalized-oscillator model with the factorized form of the complex dielectric function:

 $_{\text{TO}\,j}$ and $_{\text{LO}\,j}$ are the transverse optic and longitudinal optic (LO) frequency of the j-th m ode, respectively; $_{\text{TO}\,j}$ and $_{\text{LO}\,j}$ the corresponding damping constants. The high-frequency (electronic) perm ittivity " $_{1}$ was obtained from the frequency-independent 300K re ectivity above the phonon frequencies. The temperature dependence of " $_{1}$ is usually very small and was neglected in our ts. The TO1m ode was to them ore accurate FTIR reectivity. Below 30 cm 1 , the THz data are more accurate than the FTIR data, so it was given greater weight in

the t. The results are shown in Table I. In particular, the TO1 phonon frequency shifts from 88 cm 1 at 20 K down to 54 cm 1 at 300 K . Therefore we can call it soft mode (SM).

The low-frequency part [so called central mode (CM)] of the 300K spectrum, below polar phonon frequencies, was to an overdam ped three parameter oscillator model. This todoes not explain the experimental low-frequency permittivity which is one order of magnitude higher, owing to broad dispersion between the audio—and microwave-frequency ranges. It is well known that the distribution of relaxation frequencies in this dispersion reaches up to the submillimeter range at room temperature. At 20 K, a new heavily damped excitation appears near 30 cm.




FIG. 1: Tem perature dependence of R am an intensity (corrected for the tem perature factor).

III. RAMAN SPECTRA

Ram an spectra were excited with polarized light from a coherent INNOVA 99 A $\rm r^+$ laser (= 514.5 nm) and analyzed with a Jobin Y von T 64000 spectrom eter, that was equipped with a charge coupled device (CCD). Polarized Ram an spectra were measured in backscattering geom etry on the (1 2 3 m m 3) sample.

Incident light was focused to a spot size of 3 m in diam eter, as measured by optical microscopy. Low-

and high-tem perature m icro-R am an m easurem ents were m ade with a Linkam FDCS 196 cryostat and Linkam TS1500 hot stage, respectively. M easured R am an spectra were corrected for the Bose-E instein temperature factor.

Fig. 1 shows the temperature dependence of parallel (VV) and crossed (VH) polarized R am an spectra in the temperature interval 77–700 K . The main feature is that the frequencies of all observed peaks are only weakly temperature-dependent. Below 270 K, a partial depolarization occurs, due to the leakage of intense peaks from the VV spectrum to VH.

All peaks are best resolved at low tem perature, though most of them can be traced up to 1000 K. As shown in Fig. 1 the VV spectrum exhibits: a band at 54 cm⁻¹; an envelope of strongly overlapping bands between 100 and 350 cm 1 ; a very weak broad band at about 430 cm 1 , that is clearly seen only at low temperature; strongly overlapping bands in the 500-600 cm⁻¹ range; and a very intense band at 780 cm $^{\,1}$. In the V H spectrum the low-frequency band is a doublet (45 and 62 cm $^{\mathrm{1}}$) and interm ediate bands in the 100-350 range cm 1 are also strongly overlapping. The intensity of the 780 cm $^{-1}$ band increases abruptly at about 270 K, just below $T_{m ax}$. The 780 cm ¹ band was interpreted as a fully symmetrical (A 1g) stretching vibration of oxygen octahedra that originates from 1:1 chem ically ordered regions. The 500-600 cm 1 wide band, usually associated with E $_{\alpha}$ Raman active vibration, increases splitting when T decreases 18 below 350 K, and $splits^{24}$ in I4mm symmetry but not in R3m. Actually, any monoclinic distortions split this mode either. Perfect 1:1 chemical ordering implies four R am an-active m odes: $A_{1q} + E_{q} + 2F_{2q}$. The m easured Ram an spectra are much more complicated, however, which suggests that both chem icalSRO, and local sym metry reductions from lattice instabilities, activate R am an modes that are inactive under $F = \overline{3}$ selection rules.

IV. COMPUTATIONAL METHODS

Density functional theory (DFT) calculations for PMN were done with the Vienna ab initio simulation pack— $^{\circ}$

age (VASP). 25,26 A plane wave basis set was used for electronic wavefunctions and ultrasoft pseudopotentials were employed. Exchange and correlation energies were calculated with the local density approximation (LDA). Lattice-dynamical force constants were calculated via the frozen phonon method. Berry's phase analyses were used to compute dynamical charges, as implemented in VASP by M.M. arsman.

A. Ordered Supercells




FIG. 2: PMN supercells: $[001]_{N N M}$ (a), $[110]_{N N M}$ (b), $[111]_{N N M}$ (c), $[001]_{N C C}$ (d), $[111]_{N T}$ (e)




FIG. 3: Filling the M $g_{2=3}\,N\,b_{1=3}$ layers in the [111]_{N T} structure with M g (black circles) and N b (open circles) in the direction of (a-b) [111], (c-d) [001], and (e-f) [110].

Ordered supercells with PMN stoichiometry require 15n atom s (n = 1, 2...). The calculations presented here are for three 15 atom cells, and two 30 atom cells (Fig. 2): a) $[001]_{NNM}$; b) $[110]_{NNM}$; c) $[111]_{NNM}$; d) $[001]_{NCC}$; e) $[111]_{N}$. Here: subscript N = a Nb-layer parallel to (h;k;l);M = aMg-layer parallel to (h;k;l);C = a chessboard ordered layer, i.e. a M $g_{1=2}Nb_{1=2}$ -layer or $(001)_{1:1}$ layer; C^0 = a chessboard ordered (001)_{1:1} -layer that is displaced by [1/2,0,0] relative to an adjacent C-layer; T = a $(111)_{2:1}$ -layer of composition M $g_{2=3}Nb_{1=3}$, which is triangularly-ordered (Fig. 3a). The [001]_{NCC0} structure (d) has (001) $_{\mbox{\scriptsize N}}$ b layers that alternate with CC 0 double layers (NaC Ltype blocks). This structure was proposed²⁸ as a possible cation ordering GS for PMN, however the stability analyses reported below indicate that the [111] $_{
m N}$ structure is lower in energy. The [111] $_{
m N}$ structure has $(111)_{N b}$ layers alternating with $(111)_{M q_{2=3}N b_{1=3}}$ layers, and, as such, is an ordered approximate of the 1:1 \random -site model". Although labeled \NT" for Nb layer/triangular layer alternation, the cation arrangem ent in the 2:1 layers depends on the layer's orientation. In Fig. 2e, there are triangularly-ordered layers perpendicular to [111] and [111] and striped layers (Fig. 3b) perpendicular to [111] and [111].

For each ordered supercell, two space group symmetries, and two corresponding energies, are given in Table II: G_{Chem} indicates the space group symmetry dictated by chemical ordering without additional displacive instabilities; G_{SSS} is space group of the lower symmetry \structurally stable state." The SSS was determined by

applying random perturbations to the atom ic positions, and then relaxing the system until the absolute values of all force constants are less than 0.001 eV/A 2 . The di erence E $_{\rm SSS}$ E $_{\rm C\ hem}$ is referred to as the relaxation energy.

In general, $G_{\rm SSS}$ $G_{\rm Chem}$ $Pm\overline{3}m$, and $E_{\rm SSS} < E_{\rm Chem}$. Random ness of the initial perturbation does not guarantee that the SSS is in fact the ground-state of the system ($G_{\rm SSS} = G_{\rm GS}$), but it does guarantee that it is, at least, metastable.

B . Short-R ange O rder and Lattice A veraged Spin $P \ \text{roducts}$

Chem ically ordered, disordered and random con gurations can be quantitatively analyzed with respect to their short-range order (SRO) correlations, and one can answer such questions as: which con guration is most similar to the random state 29,30,31 or, more relevant for this work, which is most similar to the random site model (RSM)? The procedure is to calculate a lattice averaged spin product, $(r;t)_s$, for each structure (S) and cluster (r;t):

Here, (r;t)s is the product between multiplicities, M (r;t), for r-body clusters of type t and correlation functions, (r;t), for the clusters. and their subclusters, are included. Indices in column 1 identify sym m etrically distinct subclusters of the cube in space group P $\overline{3}$ m, labeled as in gure 6; column 2 lists the M (r;t); columns 3-9 list the (r;t) for the random state, R SM, and the [001], [111], [110], and [111] $_{N C C}$ $^{\circ}$ supercells, respectively.

The f (r;t)g sets for the [001], [111], [110], and [111], $_{\rm C\,C}$ structures were calculated by counting the distributions of distinct cube-cluster congurations in each structure, and the distribution of subclusters therein. Correlation functions for the random conguration were calculated using

That is, $x(1)_i = 2=3$ when Nb occupies site—i, and $x(1)_i = 1=3$ when Mg occupies site—i. C luster algebra [relationships between the x(r;t) and (r;t)] for a two component system was fully described by Sanchez and de Fontaine³², and the extension to multicomponent system swas described in Sanchez et. al.³³.

The set f (r;t)g, for the RSM, was approximated numerically by generating a 399x399x399 site simulation box with ideal NaC Hype ordering of Nb and Mg, ran-

dom ly changing 1/3 of the M g ions to N b, and counting cube, and cube-subcluster, correlations in the simulation box.

Because $(r;t)_S$ for any ordered state or random ensemble is a vector, one can unambiguously (except for truncation errors) compare average Pythagorean distances between $(r;t)_S$ for dierent states of ordered. The last two rows of Table XIII list average Pythagorean distances relative to the random conguration, $R_{S-R-andom}$, and the RSM, R_{S-R-SM} :




FIG. 4: 8-cite con guration.

V. STRUCTURALLY STABLE STATES AND LATTICE DYNAM ICS

Lattice dynam ical force constants were calculated by the frozen phonon method; i.e. in turn, displacing each ion by 0.01 A in each of the three orthogonal (Cartesian) directions; the force matrix is R_i;_j; where i and j index ionic positions, and are the Cartesian directions. The dynam ical matrix DM is D_i;_j = R_i;_j = (M_iM_j)¹⁼², where M_i is the i-th ionic mass. Vibrational mode frequencies were found by diagonalizing the DM, and used to compute IR rejectivity spectra (2):

Here V is unit cell volume, M $_{\rm i}$ is atom ic mass, m $_{\rm 0}$ = 1a $\,{\rm e}\,{\rm m}$; " $_{\rm 1}$ = 5:83, the experimental electronic dielectric permittivity, is the frequency of the incident radiation, $_{\rm i}$ is the frequency of mode i, and a $_{\rm i}$ the component





FIG .5: C om puted potential relief for the Last-type soft m ode in the [001] $_{\text{CC}}\,_{\text{C}}\,_{\text{C}}$ structure.




FIG. 7: Computed pair distribution function in the $[001]_{N\text{ CC}}{}^{\circ}$ and $[111]_{N\text{ T}}$ structures of PMN.PDF's are compared with experimental results of Egam i. 37

A. Ionic relaxation

W e $\,$ rst consider the relaxation of ions with respect to ideal perovskite positions in the G $_{\text{C hem}}\,$ structures. In every structure except [111] $_{\text{N N M}}\,$, the largest displacements involve Pb. In [001] $_{\text{N N M}}\,$, the Pb-ions with 4 M g neighbors displace by 0.47 A toward the (001) $_{\text{M g}}\,$ layers in which the 0-ions are underbonded (coordinated by two

M g²+ $ions^{34,35}$). In $[110]_{N\ N\ M}$, the Pb-ions with 2 M g neighbors displace by 0.47 A toward the underbonded 0-ion between the 2 M g. The other structures do not contain nearest neighbor M g-M g pairs; nonetheless, each Pb-ions in an asymmetric environment of M g and Nb is displaced o -center by a nonzero \local eld". The magnitude of these displacements ranges from 0.25 A to 0.27 A for the $[001]_{N\ C\ C^0}$ and $[111]_{N\ T}$ structures, but is only 0.04 A for the $[111]_{N\ N\ M}$ structure. The small Pb displacements in the $[111]_{N\ N\ M}$ structure result because of a special local environment of Pb in this structure. The largest ionic motion is by the Nb-ions, which shift 0.09 A towards nearest neighbor $(111)_{M\ g}$ planes. In the $[111]_{N\ T}$ structure, Pb deviates from the [111] axis; a net displacement of (0.17,0.17,0.08) A occurs.

Next, we consider the nature and result of sym m etry-breaking relaxations leading to the $G_{\rm SSS}$ structures. All the 15-ion supercell have multiple instabilities. While

the di erent shapes of the supercells studied prevents direct comparison of the modes between the di erent cells, there are both ferroelectric instabilities of the Last type (Pb motion against the other ions), and antiferrodistortive (tilting) instabilities dominated by 0 motion. Fig. 5 shows the potential barrier for the Last mode in $[001]_{N\ C\ C^0}$ structure. With respect to the primitive perovskite cell, every supercell shows wide dispersion of Pb-and 0-dominated instabilities across the Brillouin zone. Nb motion opposite 0 in Nb-0-Nb... chains and planes also plays a role in the FE instabilities. We note, however, that long Nb-0-Nb... chains and planes are unlikely to form experimentally.

G iven the existence of multiple instabilities in PMN supercells, it is not surprising that the G_SSS states involve the freezing of multiple modes. Figure 6 shows the complexity of the local structure in fully relaxed [111] $_{\rm M}$. Pair distribution functions (PDF) for the [001] $_{\rm N}$ cc $^{\circ}$ in

P 4=nm m (dotted) and P 1 (solid) structures are shown in Fig. 7. The peak at 2.8 A is already split by the dierent Pb-displacements in the $G_{\rm Chem}$ structures, and the splitting is signicantly enhanced in the $G_{\rm SSS}$ structures. The agreement between the predicted and experimental PDF is quite good.

We estimate the polarizations of our stable structures by using the displacements of each ion from its position in G_{Chem}, and estimated Borne ective charges determined from averaging the calculated Borne ective charges for the [001]_{NCCO} structure^{38,39}: Z_{Pb} 4.0; Z_{Mg} 2:6; Z_{Nb} 7:4; Z_{Ok} 4:8; Z_{Og} 2:5. The results are shown in Table V A. The estimated polarization magnitudes are similar in magnitude, though about 10 % smaller than the zero-temperature polarizations estimated from rst principles for PbT iO₃ 40 and PbSc₁₌₂Nb₁₌₂O₃.41 Remarkably, three of the vestructures have SSS polarizations that are pseudomonoclinic (close to an [aab]-type direction).

B. IR spectra and lattice dynam ics of relaxed structures






FIG. 8: Computed (a-e) and experimental (fg) IR rejectivity of PMN: a) $[011_{N\,N\,M}$; b) $[011_{N\,N\,M}$; c) $[111_{N\,N\,M}$; d) $[001_{N\,C\,C}^{\,\,0}$; (e) $[1111_{N\,T}$; f) 20 K; g) 300 K. Dotted lines are damped oscillator model to (see Table I) to the experimental IR rejectivity spectra (solid lines) and THz spectra (solid points).

The IR re ectivity spectra are shown in Fig. 8, and com pared with our experiment. It is seen that the best agreem ent between the theory and experiment is for $[111]_{N}$ structure. The complex dielectric spectra in the phonon frequency range are plotted in Fig. 9 together with experim ental data obtained. We have qualitative agreem ent for high frequencies. At low frequencies, experim ent shows very high values of perm ittivity connected with relaxations of PNC. These frequencies are below phonon's. Relaxation contributions to dielectric perm ittivity were not included into our theoretical consideration (we discussed these problems in a previous publication 42,43). Notice di erent scales in the experim ental and theoretical plots. The total zone-center phonon density of states of the [111] N C C $^{\circ}$ and [111] N T structures are shown in Fig. 10. It is seen from this plot that the high energy phonon band is not very dispersive com pared to the low frequency bands and com pared to the bands known for ABO 3 perovskites. This can be explained by folding the bands due to ordering of M g and Nb.

M ode assignments were then made at several levels of approximation by averaging the [l11] $_{\rm N}$ T DM 44 The low est-frequency modes of the supercellar related to the folded acoustic modes of the parent 5-atom cell: excluding zero frequency zone center acoustic modes, eigenvectors of the low-frequency modes in the frequency interval 19-100 cm 1 are signicant only on Pb. This corresponds to extremely low-frequency acoustic antiphase Pb displacements, which arise due to a very small diagonal element of DM for Pb.

Next, to understand how local 1:1 order may a ect the phonon properties, the [111] $_{\rm N}$ T dynamical matrix was averaged with respect to a 1:1 ordered structure. The [111] $_{\rm N}$ T structure is the only one studied which is commensurate with such averaging. E ectively, the [111] $_{\rm M}$ G₂₋₃N b₁₋₃ layers were treated as though they contained only one average T-cation, T= (M g₂₋₃N b₁₋₃). Symmetry analysis of [111] $_{\rm N}$ T in Fm $\overline{\rm 3m}$, yields the following




FIG. 11: Com parison of low-tem perature experim ental data and com putational results: a) 12 K neutron scattering data 45 (full triangles and squares correspond to the longitudinal and transverse phonon dispersion branches; the bands show the frequencies of continual neutron scattering); b) R am an scattering data in two geometries (VV, solid line, and VH, dotted line) recorder at 77 K; c) dielectric loss 00 () obtained from the t of IR and THz spectra at 20 K; d) Results of rst principles computations in Fm 3m symmetry; e) M ode assignments for PMN [111]_{NT} structure in space group Immm: two last columns correspond to dierent polarization of R am an spectra.

lowing modes: $A_{1g}(R) + E_g(R) + F_{1g}(s) + 2F_{2g}(R) + 4F_{1u}(IR) + F_{2u}(s)$. Here, IR and R indicate IR-and R am an-active modes respectively, and s indicates silent. C om puted eigenvectors of the $[111]_{N}$ P 1 structure were projected onto vectors of the averaged computation to obtain the modes expected to have the highest infrared and R am an activity. The results are shown in Fig. 11, and compared with experimental data from inelastic neutron scattering, 45 R am an scattering and FIR reectivity measurements (this study).


Polar TO modes $[F_{1u}]$ (IR)] are labeled TO1, TO2, TO3, and TO4. The relative contributions from Pb, T, Nb,O_k, and O_? in the TO1 mode (100 cm⁻¹) are: -0.16, 0.21, 0.27, 0.32, and 0.41 A; where: O_k is displaced along B-O bonds; O_? is displaced perpendicular to B-O bonds.

The TO2 m ode at 270 cm 1 , is predom inately of the Slater type. Neutron 45 and our IR m easurements (Table I) exhibit bands near this frequency. The TO3 m ode near 340 cm 1 is from Nb moving opposite to T.Experimental evidences for this band is not de nitive, although a mode is found near this frequency in the to room temperature IR data. The TO4 mode near 580 cm 1 originates from Ok-(T,Nb) stretching, and it is

clearly observed in the IR and neutron data.

In rst-order R am an scattering from F m 3m crystals, A $_{1g}$ and E $_{g}$ m odes should be visible in VV geom etry, while F $_{2g}$ m odes should be visible in VH geom etry. The calculated A $_{1g}$ R am an active mode at 810 cm 1 m atches quite well the intense peak that is observed experimentally at 780 cm 1 in VV spectra. In [111] $_{N\,T}$ F m 3m, this mode corresponds to a fully symmetrical, IR inactive, 0 - breathing mode. The calculated R am an active E $_{g}$ asymmetrical breathing mode near 590 cm 1 is broadened due to local symmetry breaking, and corresponds with experimentally observed bands at 500 and 600 cm 1 . In all cases, we had some frequency intervals (and even a multipeak structures) when projecting the modes obtained for GSS onto the modes derived from symmetrized DM.

The calculated R am an active F_{2g} (2) mode near 360 cm 1 involvesmostly symmetricalO $_2$ displacements. A wide envelope of the bands is seen in our R am an experiment at this frequency. The calculated low-frequency F_{2g} R am an mode near 80 cm 1 is mostly from Pb-displacements. In the VH spectrum, the low-frequency band is a doublet (45 and 62 cm 1). Both components are close to the zone-boundary frequency of the

TA branch (50 cm 1) according to neutron scattering data 45 (Fig. 11).

Experim entally, there are strong Ram an peaks near $150~{\rm cm}^{-1}$ and $250~{\rm cm}^{-1}$. These peaks probably arise from local sym m etry breaking (octahedral tilting and/or polar distortions), and not from Nb-T ordering.

VI. DISCUSSION

All the PMN supercells studied here (Fig. 2) are unstable with respect to lower energy structurally stable states, ie E_{Chem} > E_{SSS} . Relaxation ener- E_{Chem} , are large relative to the gies, E_{SSS} therm al vibrational energy, which suggests that local displacive symmetry breaking should persist to high tem peratures, generating local strain elds. Some instabilities, however, have barriers of the order of therm alenergy, especially Last-type m odes corresponding to Pb-BO₆ stretching vibrations in nite-size chemically ordered regions. The softest vibrations are exhibited by Pb-ions that are coordinated by a highly sym m etric array of Mg- and Nb-ions, or Pb-ions surrounded by Nb-ions only. Such Pb-ions have diagonal Pb-frequencies (the ra-80 cm 1 . tio of the spring constant and mass) of only

Of the supercells studied here, [111] $_{\rm N~T}$, in $G_{\rm SSS}$ = P1, has the lowest energy, and with re-

spect to chem ical SRO, it is the best approxim ate of the RSM . This suggests that it is also a good approxim ate for chem ically ordered domains in a PMN crystal with Pm $\overline{3}m$ global symmetry. Egam i 46 and Naberezhnov et al 47 reported that the local ferroelectric instability in PMN below Burns temperature is associated with Pb-displacements in opposition to the other ions and this is essentially what occurs in the [l111]N $_{\rm T}$ Last-mode dominated FE instability, Immm ! P1. Note, however, that Last-type instabilities occur in all ve supercells. Computed distributions of the interatom ic distances in the 30-ion supercells show that Pb-O distances split into two main groups at 2.5 A and 3.2 A , in agreement with experiment.

C om puted dynam ical charges in PMN are not as large as is typical for simple ABO $_3$ perovskites 39 : the Nb charge varies from 6.0 to 9.1. An FE-active ion that is surrounded by less FE-active ions, e.g. Nb surrounded by M g, typically has a reduced dynam ical charge, e.g. relative to Nb surrounded by Nb; and the dynam ical charge of the less FE-active ion increases (cf. 38). This happens because charge transfer is reduced when an ion of relatively low electronegativity is surrounded by ions with higher electronegativities. 48

Computed phonons for all the structures shown in Fig. 8 exhibit three similar features: (1) B-O-B stretching modes at 500-900 cm 1 ; (2) mixed B-O-B bending and 0 - B - 0 stretching modes at 150-500 cm 1 ; (3) Pb-BO $_6$ stretching modes at < 150 cm 1 . Di erences between the computed IR spectra for di erent supercells (Fig. 8) are purely quantitative, not qualitative. The [111] $_{
m N}$ $_{
m T}$ spectrum is most similar to the experimental one: the 500-900 cm 1 band is relatively narrow, as in the experim ent (Fig. 8); but the other computed bands are less intense than their experimental counterparts. This is an artifact of using the same damping constant for all computed modes (60 cm 1 is an average of the experim ental values). The 60 cm $^{-1}$ dam ping constant, which we used in our computation, is signi cantly larger than the usual value for pure perovskites, 20 cm⁻¹. A large value for disordered PMN is expected

because the random elds caused by chem ical disorder broaden the phonon density of states. Experimentally, however (c.f. Sec. II), some modes exhibited extremely small damping constants, which implies sharper features in the rejectivity spectrum.

One can see in Fig. 11 that the number and distribution of the modes in Immm group over frequencies are much richer than in Fm 3m geometry. For example, the single A_{1g} peak in Fm 3m group can be connected with three A_g modes in Immm group (857, 800, and 759 cm 1), in agreement with Raman spectra. The distribution of the frequencies of these peaks in Immm group is due to dierences in frequencies for oxygen ions in different Wycko positions: the stretching vibrations of the oxygen ions in Nb-O-Nb-chains are harder than other oxygen stretching vibrations, due to ferroelectric instability in these chains (combined with nearest Pb ions)

and a large shift of oxygen ions in the equilibrium state (see Table IX). There is also a dierence between ionic vibrations in M g-O-Nb bridges and in Nb₄O $_4$ squares in xy plane.

Ideally, A_g modes should be seen only in VV geometry. The presence of some intensity in VH geometry can be regarded to local elds and distortions. Notice the existence of an IR active mode (704 cm $^{-1}$) in the same frequency interval which is due to a large (minimal) size of the supercell in comparison with the unit cell at Fm3m symmetry.

At the frequency of E $_g$ mode of Fm 3m group, there are several Ram an active symmetrical breathing A $_g$ (663, 601, and 534 cm $^{-1}$) and one antisymmetrical breathing (599 cm $^{-1}$) modes. The splitting and the absence of large intensity in VH geometry in experimen-

tally measured spectra in this frequency interval testies against E $_g$ mode in Fm 3m group but agrees quite well with the computed splitting in Immm group and with A $_g$ symmetry of three of the four modes. In the same frequency interval there is a wide distribution of IR active modes that well corresponds to the wide peak in the FIR spectrum (TO4 mode in terms of Fm 3m symmetry).

The F m $\overline{3}$ m group assignment can hardly explain the presence of a peak in R am an and IR spectra at a frequency a little bit higher than 400 cm 1 . The computation within Im m m symmetry does give both R am an active (A $_{g}$, 443, and B $_{2g}$, 423 cm 1) m odes as well as IR active modes (412, 418 cm 1).

The position of F_{2g} (2) mode in Fm 3m group is noticeably higher than the position of the intensive peak in Raman spectrum in VH geometry. The Immm group

gives a few suitable modes in the right place and gives a wide distribution of these modes over frequencies that corresponds to a large width of the R am an lines observed. However, at the present time, we cannot prove that the peak of the R am an intensity in the computation corresponds to the peak in the experiment, because we did not compute the intensities.

Finally, we want to notice that there are a few low frequency modes spread over the frequency interval 25–96 cm 1 (below the frequency of the soft mode) which are Ram an and IR active. These modes appear because of comparatively low symmetry of the supercell. All they are in the range of the acoustic modes in the reduced (5-ions) unit cell and are connected with antiphase Pb displacements.

Taken together, the rst principles results, and experimental data from neutron scattering, 45 R am an, and IR re ectivity enables assignments of specic vibrational modes to experimental phonon peaks. Following A kbas and D avies PMN is approximated as the RSM. Positions of IR-active, R am an-active and silent modes, were calculated, and distribution functions for all these modes have nite width, and some are split.

There are a few low frequency modes in the range 25-96 cm⁻¹ (below the frequency of the soft mode) which are both Raman and IR active. They re ect antiphase Pb-displacements⁴⁹ that are allowed by the low supercell symmetry, and are all in the acoustic-mode range for the reduced (5-ion) unit cell.

VII. CONCLUSIONS

We studied ve ordered supercells of PMN. Instabilities involving Pbo -centering are observed in all super-

cells and instabilities involving the tilting of 0 octahedra centered on M g ions are observed in most. W hen fully relaxed, the [111] $_{
m N\ T}$ structure described here has the lowest known rst-principles energy for an ordered PMN structure. It is commensurate with the random site m odel (RSM) of PMN 8 , and has short-range Mg-Nb correlations that are most comparable to the RSM. Its Ram an and IR spectra and pair distribution functions are in qualitative agreem ent with experim ent, allowing mode assignm ent of the dom inant features of the spectra. In its lowest-energy state, it is polarized in approximately along an [bbc] type direction, yielding pseudom onoclinic sym m etry. Unphysical aspects of this perfectly ordered $[111]_{N}$ supercell as an approxim ant for the 1:1 ordered regions in experim ental PM N, include the lack of a disordered matrix, the fact that there is no experimental evidence for ordering on the M $g_{2=3}$ N $b_{1=3}$ sublattice, and the presence of in nite Nb-O-Nb... chains (which in uence the lattice dynamics).
