# Shift of BEC Tem perature of Homogenous Weakly Interacting Bose Gas

We report on the computation of the shift of the Bose-E instein condensation temperature for a hom ogenous weakly interacting Bose gas in leading order in the diluteness parameter an  $^{1-3}$ , where a is the scattering length and n is the particle density. The perturbative series, which is a icted by infrared divergences, is resummed by means of variational perturbation theory. Using coecients through seven loops, we arrive at  $T_c=T_c=1.27$  0:11 an  $^{1-3}$ , which compares favorably with recent Monte-Carlo data.

#### I. INTRODUCTION

The Bose-Einstein condensation (BEC) temperature  $T_{\rm c}$  of an ideal gas of spin-0 Bosons is given by

$$T_0 = \frac{2}{m} - \frac{n}{(3=2)}$$
; (1)

where m is the mass of the bosons, n their number density and we work throughout in units where  $k_{\rm B}=h=1$ . Infrared (IR) divergences prevent the perturbative evaluation of the shift of the BEC temperature due to a small repulsive interaction, parameterized by the corresponding s-wave scattering length a. Physically, these IR divergences correspond to critical uctuations that change the universality class from Gaussian to that of a three-dimensional scalar 0 (2)-symmetric eld theory.

Although it is clear that  $T_{\rm c}$  changes by a small am ount if the dimensionless diluteness parameter an  $^{1-3}$  is small (for small momenta, a is the only relevant parameter of the two-body interaction potential), it was for a long time unclear, what the leading power in terms of this parameter or the coecient in front of it would be. Many attempts on the problem have provided dierent powers and coecients [1{24}]. Recently, however, it has been shown that the leading and next-to-leading behavior is given by [7, 8, 15]

$$\frac{T_c}{T_0} = c_1 an^{1=3} + [c_2^0 \ln (an^{1=3}) + c_2^{00}] (an^{1=3})^2 +$$

In the work presented here, we determ ine  $c_1$  num erically (while  $c_2^0$  is known exactly,  $c_2^{00}$  m ay be determ ined by a non-perturbative calculation analogous to the one presented here for determ ining  $c_1$ ; for the exact value of  $c_2^0$ 

and a M C estimate of  $c_2^{0}$ , see Ref. [16]). Results for  $c_1$  in the literature range from 0.93 [9] to 4:7 [2], see Refs. [14,17] and the review [25], also Fig. 1 below. In [7] it was shown that  $c_1$  is exclusively generated by infrared uctuations and that consequently three-dimensional eld theory is su cient for the determination of  $c_1$ . It appears that the most reliable results for  $c_1$  before our work have been obtained by M onte-C arlo (M C) simulations in three-dimensional eld theory [13,14].

Here we expand T  $_{\rm c}$  in a perturbative series, which is subsequently resummed to obtain the physical non-perturbative lim it. While simple schemes such as Pade approximants may slowly converge towards the correct value, our scheme of choice is K leinert's eld theoretic variational perturbation theory (VPT, see [26{28}] and Chapters 5 and 19 of the textbooks [29] and [30], respectively; improving perturbation theory (PT) by a variational principle goes back at least to [31]), which has proven very useful for the investigation of critical phenomena.

## II. FELD THEORY

The therm odynam ic equilibrium properties of a homogenous gas of spin-0 Bosons may be described in the grand canonical ensemble with the help of a non-relativistic (3+1)-dimensional eld theory in imaginary time, given by the Euclidean action

$$S_{3+1} = \int_{0}^{Z} d d^{3}x \qquad \frac{e}{e} \frac{1}{2m} r^{2} + \frac{2a}{m} ( )^{2};$$

where is the chem ical potential. This assumes that the momenta of the particles are small enough so that their interaction potential is well described by just one parameter, the s-wave scattering length a. It also assumes that three- and more particle interactions are rare, i.e. that the gas is dilute. It turns out that the leading perturbative contribution to  $T_{\rm c}$  is /  $a^2$ . In consequence,

the leading contribution to T  $_{\rm C}$  arises exclusively from terms that are infrared divergent in the framework of PT. This is why, for the determ ination of  $c_{\rm l}$ , we can set all M atsubara frequencies to zero or, equivalently, work with a three-dimensional eld theory [7]. Denoting the zero-M atsubara modes by  $_{\rm 0}$ , we denote the elds and parameters of this theory by  $_{\rm 0}=$  mT (  $_{\rm 1}+$  i  $_{\rm 2}$ ),  $r_{\rm bare}=$  2m , u= 48 amT, and obtain the three-dimensional Euclidean action

$$S_3 = {\stackrel{Z}{d^3}} \times {\frac{1}{2}} \dot{r} + {\frac{r_{\text{bare}}}{2}}^2 + {\frac{u}{24}} ({^2})^2 : (4)$$

For the determ ination of quantities that are not governed by the leading IR divergences, one may still use a three-dimensional eld theory which, however, is obtained by a more complicated matching procedure, which introduces corrections to the above relations of the parameters of the (3+1)-dimensional and the three-dimensional theory and also necessitates the inclusion of more interaction terms. This matching is described in detail in [16].

From the ideal-gas result (1) one obtains, in leading order, the relation [7]

$$\frac{T_c}{T_0} = \frac{2}{3} \frac{n}{n}; \tag{5}$$

where T  $_{\rm c}$  is the shift of the condensation temperature for xed n and n is the shift of the critical particle density for xed condensation temperature. In our eld-theoretic setup, n is given by

$$n = h$$
  $i = m T h^{2} i$ ; (6)

Combining (1), (2), (5) and (6),  $c_1$  is given by

$$c_1 = \frac{h^{-2}i}{Nu} \tag{7}$$

with =  $256^{-3}$ =[  $(3=2)^{4=3}$  2206:19 and the remaining task is to compute the critical lim it of

where G and G<sub>0</sub> are the interacting and the free propagator, respectively. In (7) and (8) we have conveniently generalized the model (4) to an O (N) eld theory, where = ( $_1$ ;:::;  $_N$ ),  $_2$  a . This allows to make contact with the exactly known large-N result for  $c_1$  [8] and with the M C results for N = 1 and N = 4 [32].

The theory (4) is supermenormalizable. A convenient and popular renormalization scheme is given by dening a renormalized parameter  $r=r_{\text{bare}}$  (0), where (p) is the self-energy. Now all Feynman diagrams can be computed without regularization. The critical limit is obtained by letting r! 0, as can be seen from the structure of the full propagator, which reads now G (p) =  $1=fp^2+r$  [ (p) (0)]g. For the free propagator follows G (p) =  $1=(p^2+r)$  [20].

In a scheme used in [12, 18, 19, 22, 33], the free propagator is taken always critical,  $G_0$  (p) =  $1=p^2$ . This generates an unnatural non-zero one-loop contribution to h  $^2$ i, even in the absence of interactions. Although this contribution vanishes as  $r \,! \, 0$ , it strongly in uences resumm ation and is responsible for the small value of  $c_1 = 0.92 \, 0.13 \, [34]$  in Ref. [22].

#### III. PERTURBATIVE SER IES FOR C1

In PT, h  $^2$  i=N u m ay be written as a power series in  $u_r$  N u=4  $r^{1=2}$ . De ning a function  $c_1$  ( $u_r$ ) with  $c_1 = \lim_{u_r \, ! \, 1} \, c_1$  ( $u_r$ ), we have

$$c_1 (u_r) = \int_{l=1}^{x^2} a_l u_r^{1/2} :$$

The inclusion of N in the de nition of  $u_r$  is motivated by the fact that then the  $a_1$  remain nite even in the limit N ! 1 , facilitating the comparison with the exactly known large-N result [8]. The successful application of VPT to the large-N limit has been demonstrated in [23].

The perturbative series can be represented by Feynman diagrams and then becomes a loop expansion. The subtraction of the zero-momentum part of the self-energy in the full propagator has to be performed recursively for all subdiagrams. We denote this procedure by an operator R [23, 24]. The rst non-zero perturbative coecient arises at the three-loop level, since the lowestmomentum dependent self-energy contribution has two loops. The perturbative coecient at L loops is given by

where  $n_{\rm L}$  is the number of contributing diagram s in L-loop order and D  $_{\rm L}$   $_{\rm k}$  is the k-th L-loop diagram . There are  $n_{\rm L}=0;0;1;1;5;12;56$  diagram s at one-through seven-loop order (see [35] for a convenient way of constructing all necessary diagram s together with their weights) and the expansion for  $c_{\rm l}$  (u $_{\rm r}$ ) starts out as

E.g., the coe cient a 3 is given by

The results for diagram s through six loops in the renormalization scheme employed here can be found in [36]. The seven-loop diagram s have been computed in 1991 and used for the determination of critical exponents for N = 0;1;2;3 in [37]. They were provided to the author by B. Nickel [38] and may be found in [24]. The resulting perturbative coe cients for N = 2 are a  $_3$  = 1:01209  $_3$  10  $_4$  , a  $_4$  = 2:99626  $_3$  10  $_5$  , a  $_5$  = 1:19872  $_3$  10  $_5$  , a  $_6$  = 5:85519  $_3$  10  $_6$  , a  $_7$  = 3:30467  $_3$  10  $_6$  .

#### IV. RESUM MATION AND RESULTS

For obtaining the  $u_r$ ! 1 lim it of  $c_l$   $(u_r)$ , the series (9) needs to be resum m ed. For critical uctuations phenom ena, VPT is an appropriate tool, since it is designed to accomm odate the large- $u_r$  behavior of physical quantities in the critical lim it, given in our case by

$$c_1 (u_r) = \int_{m=0}^{x^2} f_m u_r^{m!}^{0}$$

with an irrational exponent  $!\,^0$ . The leading class of corrections of a physical quantity that remains nite in the critical lim it are integer powers of  $t^!$  [30, 39, 40], where t (T $_{\rm C})=T_{\rm c}$ , is the critical exponent of the correlation length and  $!={}^0(g)$  in a renormalization group approach. In our renormalization scheme, the propagator obeys G (p=0)=1=r/t . Using the universal scaling relation = (2), where is the anomalous dimension of the critical propagator, i.e. G (r=0)/1=p^2 in the small-p lim it, we see that we have to set

$$!^{0} = \frac{2!}{2} \tag{14}$$

in (13).

The ansatz (13) does not account for so-called conuent singularities which cause the true large- $u_r$  expansion to also contain other negative powers of  $u_r$ , which are subleading at least compared to  $u_r^{!}$ . We can expect methods that can accommodate the leading behavior in (13) correctly to converge faster to the true result than methods having the wrong leading behavior such as e.g. Pade approximants or the linear expansion (LDE), the latter being used extensively for the current problem [12, 18{21}. On the other hand, convergence will be slowed by the fact that we do not make an ansatz reecting the full power structure in  $u_r$ , but the expansion (13) will try to mim ic the neglected subleading powers.

The alternating signs of the  $a_L$  suggest that the perturbative series for  $c_l\ (u_r)$  is B orelsum mable. In the context

of critical phenom ena, such series have been successfully resum med using K leinert's VPT. A ccurate critical exponents [27, 28, 30] and amplitude ratios [41] have been obtained. For a truncated partial sum  $\frac{L}{l=1} a_1 u_r^{1/2}$  of (9), the method requires replacing

(note that this is an identity for t=1), reexpanding the resulting expression in through  $t^{L-2}$ , setting t=1 and then optim izing in  $\hat{\mathbf{u}}$ , where optim izing is done in accordance with the principle of minimal sensitivity [42] and in practice means noting appropriate stationary or turning points. That is, we replace

and optim ize the resulting expression in  $\hat{u}$  . For  $u_r$  ! 1 , we obtain the L-loop approximation of  $f_0$  ,

Results are only available starting at four loops, since two non-zero perturbative coe cients are necessary for VPT to work. E.g., in four-loop order the optim ization yields

as the best attem pt at determ ining  $f_0$  and thus  $c_1 = f_0$ . For N = 2, we have ! = 0:79 0:01, = 0:037 0:003 (see, e.g., [30]) and thus, using (14), !  $^0$  = 0:805 0:011. The four-through seven-loop results are  $c_1$  = 0:948, 1:062, 1:126, 1:161.

 $!^0$ m ay also be determ ined self-consistently [27,29,30]. A ssum ing a behavior of  $c_l$  ( $u_r$ ) as in (13), the quantity  $d \ln c_l$  ( $u_r$ )= $d \ln u_r$  has an expansion of the same type with the same  $e : ^0$  as  $c_l$  ( $u_r$ ), but with a vanishing large- $u_r$  lim it (i.e. its large- $u_r$  expansion starts out with  $f_0 = 0$ ).  $!^0$  is tuned such that the value VPT gives for  $d \ln c_l$  ( $u_r$ )= $d \ln u_r$  is zero in a given loop order. This  $!^0$  is then used as an input for the determ ination of the approximation of  $c_l$  ( $u_r$ ) at the same loop order. The vethrough seven-loop results are  $c_l = 1:399, 1:383, 1:376$ .

From the fact that the xed-! of results monotonically rise with the loop order, while the results with self-consistent! of fall, we estimate that the true value lies inbetween and conclude from the resummed results through seven loops that

$$c_1 = 127 \quad 0:11:$$

Our treatm ent for N = 2 m ay easily be repeated for arbitrary  $N \cdot E g_{\bullet}$  for N = 1 one obtains

$$c_1 = 1:07 \quad 0:10;$$
 (20)

while for N = 4, the result is

$$c_1 = 1.54 \quad 0.11:$$
 (21)

#### V. DISCUSSION

M any di erent results have been obtained for  $c_1$ ; see [24] and corresponding references therein for criticism s of m ost of them . A comparison of our results through seven loops with most other results found in the literature is given in Fig. 1.0 ur result (19) is in agreem em t with the




FIG. 1: C om parison of  $c_1$  from VPT as a function of the number of loops L for N = 2 w ith most results from other sources. Upper dots: self-consistent (sc) !  $^0$ . Lower dots: !  $^0$  = 0:805. LDE  $^2$  indicates use of LDE w ith a resummation method for accelerated convergence. The label VPT  $^2$  indicates the inclusion of a non-zero one-loop term in Ref. [22], which is absent in the present treatment, labeled by VPT.

apparently m ost reliable other sources available, namely the MC results from the three-dimensional theory:  $c_1 = 1.29 + 0.05$  by K ashumikov, P rokof'ev and Svistunov [13] and  $c_1 = 1.32 + 0.02$  by A mold and M oore [14].

M C results for N = 1 and N = 4 are also available. X. Sun has computed h  $^2i_{crit}$ :=u for these cases [32]

which translate to  $c_1=1.09~0.09$  for N = 1 and  $c_1=1.59~0.10$  for N = 4. Our values (20) and (21) agree well with these results. This provides additional con dence that in fact both MC and our VPT results are trustworthy estimates for  $c_1$ .

We would like to emphasize that the coe cient  $c_1$  is of physical relevance not only for the case of a strictly hom ogenous gas, but also for a trap that is su ciently wide to allow for critical uctuations [10, 43]. If expressed as a function of the total number of particles Np, the leading e ect on the shift of the condensation temperature is obtained from mean eld theory and only in second order the in ucence of critical uctuations can be felt [43, 44]. In contrast, if expressed in terms of the central density n of particles, the leading e ect is determ ined by critical uctuations as we have seen here. It would therefore be desirable to know not only the total number of particles  $N_p$  (as in a recent experiment [45]) but also the central density of particles in experim ents that m easure the condensation temperature. In this context we would also like to stress that it is no contradiction that the sign of the change of T<sub>c</sub> is di erent in both cases, since di erent physical quantities N  $_{\rm p}$  and n are kept xed, respectively. Let us turn this around: For a given condensation tem perature, a small repulsive interaction causes the corresponding central density in a wide trap to be lowered and the total number of particles to be raised compared to the ideal gas case.
