# Slow ing dow $n$ of spin relaxation in two dim ensional system $s$ by quantum interference e ects.

#### Abstract

The e ect of weak localization on spin relaxation in a two-dim ensional system with a spin-split spectrum is considered. It is show $n$ that the spin relaxation slow s dow $n$ due to the interference of electron waves $m$ oving along closed paths in opposite directions. As a result, the averaged electron spin decays at large tim es as $1=\mathrm{t}$. It is found that the spin dynam ics can be described by a Boltzm ann-type equation, in which the weak localization e ects are taken into account as nonlocal-in-tim e corrections to the collision integral. The corrections are expressed via a spindependent retum probability. The physical nature of the phenom enon is discussed and it is shown that the "nonbackscattering" contribution to the weak localization plays an essential role. It is also dem onstrated that the $m$ agnetic eld, both transversal and longitudinal, suppresses the pow er tail in the spin polarization.

## Introduction

The relaxation of non-equilibrium spin polarization is the central phenom enon in spin-dependent transport in sem iconductor nanostructures ${ }^{\frac{1}{2}}$ ' O ne of the most e cient mechanism $s$ of electron spin relaxation in III-V sem iconductors is the well-known D yakonov $P$ erelm echanism' ${ }^{2}$ b based on the classical picture of angular di usion of the spin vector in a random magnetic eld. The eld originates from the $m$ om entum -dependent spin-orbit splitting of the conduction band in the crystals $w$ ith zincblend structure $3^{3} \mathrm{~W}$ hile passing through the crystal, the electron is scattered by im purities and its m om entum changes random ly w ith time. A s a consequence, the e ective $m$ agnetic eld also changes random ly with a correlation time of the order of the $m$ om entum relaxation time. The spin relaxation time $s$ is a characteristic time of the spin angular di usior $h^{1} \quad 1=s \quad{ }^{2}=\quad{ }^{2}$, where

1 is the typical angle of the spin precession for the $m$ om entum relaxation time and is the frequency of precession in the e ective magnetic eld proportional to the conduction band splitting. For a two-dim ensional (2D ) case, when the electron $m$ otion in one direction is con ned by the quantum well, thp, spin splitting and, hence, the precession frequency are proportional to the in-plane
 spin relaxation rate for a 2 D electron with a given energy $\mathrm{E}=\mathrm{m} \mathrm{v}^{2}=2$ is proportional to the particle di usion coe cient

The e ects of localization on the particle di usion have been discussed in a great num ber of publications. The rst-order term in a series expansion of $D$ in $1=k l\left(l=V_{1}\right.$ is the $m$ ean free path, $k$ is
 com ing from the coherent enhancem ent of the backscattering am plitude. A rem arkable feature of this correction is the logarithm ic divergence at low tem peratures in the 2D case. Equation (11) im plies a sim ilar divergence of the spin relaxation rate. Such a divergence was rst predicted by Singhin in spin correlation functions for a system with spin-dependent im purity scattering. It was show $n$, how ever, that the quantum correction to the spin relaxation rate is not proportional to the quantum correction to the di usion coe cient, as onem ight expect from Eq. ${ }^{\prime}(\underline{1})$. A sim ilar result was obtained in Refiling for a system with a spin-split spectrum. It was found in Ref. '10' that the weak localization slows down the spin relaxation of excitons in quantum wells, which leads to a $1=\mathrm{t}$ power tail in the spin orientation. A sim ilare ect was also predicted for electrons in 2D sem iconductors w ith a zinc-blend crystal structure.

In this paper, we consider the e ects of localization on the spin relaxation for a 2D sem iconductor with a spin-split spectrum. We show that the spin dynam ics is described by a Boltzm ann-type equation. In the rst order in $1=k l$; the localization e ects can be taken into account by a nonlocal-in-tim e correction to the Boltzm ann collision integral. This correction is expressed in term $s$ of the spin-dependent retum probability. W e discuss the role of coherent retums at di erent scattering angles and show that the "nonbackscattering" contribution to the collision integralplays a key role. W e solve the generalized kinetic equation and dem onstrate that, at large tim es, the spin polarization decays as $1=\mathrm{t}$ : $T$ he $m$ agnetic eld, both transversaland longitudinal, is found to suppress the long-living tail in the spin-relaxation.

## D erivation of the $k$ inetic equation

The conventional approach to the, qalculation of the correlations, finctions in weakly localized system $s$ is based on the $K$ ubo form ula equation to include weak localization e ects in the kinetic description. This approach $m$ ay tum out to be $m$ ore convenient when studying nonlinear and strongly nonequilibrium phenom ena. To describe quantitatively the weak localization phenom enon in the kinetic picture, one has to m odify the

Boltzm ann equation by introducing a nonlocal-in-tim e correction to the collision integrall 1 corrections can be derived $1^{13}$ from the diagram $m$ atic structure of linear-response functions. $D$ iagram $m$ atically, the inclusion of a weak localization, correction to the e ective collision integral requires the
 scattering, shown in Fig. I'11a. The crossed-ladder diagram $s$ ( 1 b ) are usually considered to describe the coherent backscattering of the electron wave. A physical interpretation of the diagram $s(1 b, c)$ in term sofa sm allchange in the e ective di erentialcross-section for a single im purity was suggested in Ref. $14_{1}^{\prime \prime}$. It w as based on an analysis of the interference contribution of tra jectories propagating in the opposite directions along closed paths in term s of the phase stationarity requirem ent. This analysis show $s$ that the diagram $s$ (1b) correspond to a process shown in $F i g .{ }^{1}{ }^{1} 0^{0}$, which is indeed a coherent backscattering. D iagram $s$ (1c) were found to describe coherent scattering processes w ith arbitrary scattering angles, shown in $F$ ig. ${ }_{1}^{111} c^{0}$ :

Next, we discuss the key points of a quantitative description of the weakly localized regim e w ithin the kinetic approach. W e start with a brief discussion of the zero spin-orbit coupling. A s can be seen from $F$ igs. ${ }_{1}^{111^{1}}{ }^{0}, c^{0}$, the relevant processes contain the sam e closed paths, so the e ective change in the

Physically, $l$ is the characteristic area of the region around the origin into which the di using electron should retum for the e ective interference to occur. The calculations show that the contributions of $\left(1 b^{0}\right)$ and ( $1 c^{0}$ ) have di erent signs. The positive contribution represented in Eq. (5) by ( ) com es from the process (1B), while the negative one (the term $1=2$ ), from the process (1d). In other words, the enhancem ent of the di erential cross-section at the angle due to the coherent backscattering is accom panied by a reduction of the scattering in other directions, the total cross-section rem aining unchanged (see Fig. $\bar{i}$ ) . W e see that the correction to the e ective im purity cross-section is!-dependent. Therefore, the correction to the collision integral in the tim e representation tums out to be nonlocal in tim e:

Next, we consider the in uence of the extemalm agnetic eld on the long-living pow er tail in the spin polarization. N ext we discuss brie $y$ the physicalm eaning of the results obtained. O ur calculations were based on the interpretation of the weak localization phenom ena in term s of tw o scattering processes: coherent
 of the long-living spin polarization can be explained as follow $s$. B oth coherent scattering processes were shown to be nonlocal in time. In other words, the transition of a spin $s$ to a spin $s^{0}$; caused by coherent scattering, takes a certain tim e t; which $m$ ay be relatively long: $t \quad s: T$ he coherent scattering events do not change the direction of the electron spin. Indeed, as seen from Eq. (2G), $W_{i k}(0 ; t) \quad i k$ and, as a consequence, $s^{0} \mathrm{k}$ s: Therefore, the electrons involved in such a scattering can keep $m$ em ory about the in itialspin polarization during the tim emuch longer than $s: T$ he power law $1=t$ is due to the proportionality of the probability of coherent scattering to the probability of di usive retum.

Neglecting this contribution, we have $\hat{J_{S}} \in 0$ : It can be easily show $n$ that this leads to a physically $m$ eaningless result for the spin relaxation rate. $T$ herefore, the correct treatm ent of the e ect of weak localization on the spin relaxation is only possible when the nonbackscattering coherent processes are taken into account (the role of such e ects for particle di usion was discussed in Ref. 1 _1 ( $)$. It is worth noting that the weak localization e ects are usually considered to be due to the coherent backscattering only. The point is that the quantum correction to the conductivity is usually calculated by $m$ eans of the $K u b o$ form ula, which expresses conductivity in term s of the current-current correlation function. This approach focuses on the calculation of the velocity correlation function, which depends on the anisotropic part of the distribution function $f_{a}$; so, there is no need to know corrections to $f_{i}: T$ he situation is quite di enent for spin relaxation which is due to the relaxation of the isotropic part of the distribution function $2^{33}$

To conclude, we have discussed the long-tim e dynam ics of the spin polarization in a 2D disordered sem iconductor. It is show $n$ that, at large tim es, the spin relaxation slow sdown due to w eak localization e ects. An analytical expression for the long-living tail of the spin-polarization has been derived. $T$ he $m$ agnetic eld, both transversal and longitudinal, suppresses th is tail, restoring the exponential relaxation.
