# V elocity D istribution in a V iscous G ranular G as

#### Abstract

We investigate the velocity relaxation of a viscous one-dim ensional granular gas, that is, one in which neither energy nor $m$ om entum is conserved in a collision. $O f$ interest is the distribution of velocities in the gas as it cools, and the tim e dependence of the relaxation behavior. A Boltzm ann equation of instantaneousbinary collisions leads to a tw o-peaked distribution w ith each peak relaxing to zero velocity as $1=\mathrm{t}$ while each peak also narrow s as $1=\mathrm{t}$. N um erical sim ulations of grains on a line also lead to a double-peaked distribution that narrows as 1=t. A $M$ axw ell approxim ation leads to a single-peaked distribution about zero velocity $w$ ith power-law wings. This distribution narrow s exponentially. In either case, the relaxing distribution is not of $M$ axw ell-B oltzm ann form .

## I. INTRODUCTION

Velocity distributions in dihute granular gases are generically aw ay from equilibrium because the collision processes in such gases are dissipative. Even in the dilute lim it the velocities of di erent particles $m$ ay be strongly correlated $\left[\begin{array}{ll}{[1]}\end{array}\right]$, and therefore the usual description in term $s$ of single particle distribution functions $m$ ay not be su cient to determ ine all the properties of the granular gas. Nevertheless, the single particle distribution $P(r ; v ; t)$ contains im portant inform ation, and is particularly interesting because in a granular gas it typically deviates from the $M$ axw ell-B oltzm ann distribution. Q uite aside from possible spatial inhom ogeneity e ects such as particle clustering, even the single particle velocity distribution $P(v ; t)$ in generaldi ers from the $M$ axw ell-B oltzm ann form . T he deviations of these single particle distributions from the usual \universal" behavior in ordinary gases has been a sub ject of intense interest
 observed in granular gases that achieve a steady state because extemal forcing balances the dissipative collisions am ong particles $[\underline{1}, 1,1,1,1,1$, or they can be observed in un-


Typically, gases equilibrate or achieve a steady state via collision processes. C onservation of energy and mo $m$ entum imply $M$ axw ellian velocity statistics in three di$m$ ensions [1]. In low er dim ensions the situation is $m$ ore com plicated; for exam ple, a gas of hard spheres in one di$m$ ension sim ply retains its in itial distribution forever. In granularm edia the situation is in any case $m$ ore com plex because energy is certainly not conserved [17]. M ost w ork on relaxation in granular $m$ aterials, in any dim ension, has focused on the interesting consequences of energy non-conservation. A particularly interesting behavior of granular gases induced by energy non-conservation is the so-called \inelastic collapse," whereby the energy of the gas goes to zero in a nite tim e $\left[1-10^{1}\right]$. In the \quasi-elastic lim it" the inelastic collapse is avoided, and one obtains non-trivial asym ptotic velocity distributions $\overline{\underline{1} 1 / 2}$
w ith features sim ilar to the ones obtained in this paper.
In the presence of friction, not only is energy not conserved, but m om entum is not conserved either, leading
 fact, we have recently show n [-d] that in the absence of conservation laws random linear m ixing can lead to velocity distributions $w$ ith algebraic or exponential tails, with nontrivialcharacteristic exponents. In general, conservation law splay a crucial role in the universality of the usual velocity distribution properties.

Our focus here is the e ect of viscosity, and consequently, of $m$ om entum non-conservation, on the velocity distribution as a one-dim ensional dilute granular gas cools dow $n$. The m odel consists of $N$ grains on a line (or a circle, since we w illuse periodic boundary conditions). T he grainsm ove freely except during collisions, govemed by the H ertz potential,

Here ${ }_{k ; k+1} \quad Y_{k+1} \quad Y_{k}, Y_{k}$ is the displacem ent of granule $k$ from its equilibrium position, and $a$ is a prefactor determ ined by Y oung's m odulus and P oisson's ratio. $T$ he exponent $n$ is $5=2$ for spheres, it is 2 for cylinders, and in general depends on geom etry. In this paper we only consider cylindrical grains, which leads to considerable sim pli cation while still capturing im portant general features of the non -M axw ellian distributions. W e stress that the one-sided (only repulsion) granular potentialeven w th $\mathrm{n}=2$ is entirely di erent from a two-sided (repulsion and attraction) harm onic potential.

The displacem ent of the $k$-th granule ( $k=1 ; 2$;: : : ; $N$ ) ofm ass $m$ in the chain from its equilibrium position in a frictionalm edium is govemed by the equation ofm otion

$H$ ere $\sim$ is the friction coe cient and $(y)$ is the $H$ eaviside function, $(y)=1$ for $y>0,(y)=0$ for $y<0$, and $(0)=1=2$. The $H$ eaviside function ensures that two particles interact only when in contact, that is, only when the particles are loaded. N ote that for periodic boundary conditions $y_{k+N}=y_{k}$. A dot denotes a derivative w ith respect to $t$. $T$ he velocity $\mathrm{v}_{0}$ is an arbitrary choice in term sofw hich other velocities are now expressed, i.e., it settles the energy scale of the system.

A though the problem m ight appear relatively sim ple because it is one-dim ensional and quasi-linear, the onesidedness of the potential leads to analytic_com plexities even in the dissipationless case $\left[1-1,21,21_{2}^{1}, 2\right]$, and even greater com plexities in the presence of dissipation [1], [191]. O ur purpose in this paper is to explore analytic approxim ations appropriate for low densities. The low density feature of these approxim ations is im plem ented via the assum ption that the collisions are alw ays binary, that is, that only two granules at a tim e are $m$ em bers of any collision event, and that at any $m$ om ent of tim $e$ there is at m ost one collision.

W e explore tw o low-density analytic approxim ations. O ne is based on the Boltzm ann equation for binary col-
 and the other is an even sim pler model that we call the M axw ell m odel, presented in Sec . ' $\mathrm{IV}_{1}$. T The detailed description of a binary collision that $m$ ust be used as an input in either of these $m$ odels is also presented in Sec. To assess the success of each analytic $m$ odel, a com parison of the approxim atem odel results $w$ ith num ericalsim ulations of the entire chain is carried out in Sec. ${ }^{\mathrm{V}} 1 \mathrm{l}$. In that section we also sum $m$ arize the outcom e of our analysis.

## II. BOLTZMANNEQUATIONAND

COLLISIONS
O ur analytic starting point in the follow ing sections is the Boltzm ann equation for binary collisions in a spatially uniform gas, which describes the rate of change of the probability distribution of velocities, $P(v ; t)$. If $u_{1}$ and $u_{2}$ are the initial velocities of a pair of particles just before a collision and and $u_{1}^{0}$ and $u_{2}^{0}$ their velocities just

Since the problem is one-dim ensional, one can keep track of the precise conditions under which a collision betw een tw o particles of gíven velocities willorw ill not occur, and how these events $w i l l$ change the distribution function.
$T$ he binary collision approxim ation im plies that at any one time there is at most one pair of loaded grains, so we need to consider in detail the fate of a colliding pair from the beginning to the end of a collision [1d]. At the $m$ om ent of the start of the collision, which we call $t=0$, the velocities of the grains are $u_{1}$ and $u_{2}$. The collision ends at the time $=2=\overline{8{ }^{2}}$, when the grains lose contact. It is im portant to notioe that for $n=2$ the collision tim $e$ is independent of the initial condition. This is a feature that $m$ akes the cylindrical granule geom etry $m$ uch sim pler than other shapes. W thout loss of generalIty we take $u_{1}>u_{2}$, since we can alw ays relabelparticles to $m$ ake it so. The velocities at the $m$ om ent of separation are found to be [1\%]

In our further analysis we think of the distance traveled by the granules during a collision as negligible. For $s m$ all dam ping this distance is $\left(u_{1}+u_{2}\right)=\overline{8}$, which is to be com pared to the $m$ ean distance betw een particles. The latter can be m ade arbitrarily large by low ering the density. We also take the collision tim e betw een two granules as instantanneous. This collision tim e for sm all damping is $\quad=\overline{2}$, to be com pared $w$ th the typical $m$ ean free tim ef ight of a particle betw een collisions. $W$ ith these approxim ations, the only role played by the viscosity is dictated by the collision rule (G). These as sum ptionsm ight conceivably be problem atic for them ost energetic particles that $m$ ay travel a relatively long distance during a collision and a relatively short distance betw een collisions, but explicit analysis of these extrem e events is di cult and probably not im portant at su ciently low densities.

## III. BOLTZMANN PROBLEM

W e now start w ith the Boltzm ann equation ( which the collision rate depends on the di erence in the velocities of the colliding pair. To write the explicit Boltzm ann equation for our system, we m ust collect all the instances that lead to a collision, that is, all the instances for which one or another of the -functions in Eq. (5) can be satis ed. There are six possible events that contribute to a change in $P(v ; t)$. W e list the contribution to $@ P=@ t$ from each event:

De ning $z=\frac{2 x}{2} \quad \frac{\left(^{2}+\right) y}{2}$ and recognizing that the dum $m y$ variable $z$ can be relabeled as $y$ after the transform ation, one nds that the third term on the right hand side of this equation becom es proportional to the fourth, and the fth to the sixth, so that these pairs can be com bined to yield the sim pler expression

Since the only explicit tim e dependence resides in the $\frac{-(t)}{2^{2}(t)}$ term, this term $m$ ust be constant. Integrating this term leads to $(t)=\frac{(0)}{1+c t}$, where $c$ is a constant. Therefore, asym ptotically,

W e have not found an analytic solution to E q. ( $\left.\overline{1} \overline{\bar{\sigma}_{1}}\right)$. W e therefore sim ulate the equation num erically (next subsection) and im plem ent a further approxim ation that leads to an analytic solution that we can com pare w th the num erical results (subsequent subsection).
A. Sim ulation of the Boltzm ann equation

W e directly sim ulate the B oltzm ann equation using the follow ing algorithm :

1. W e start w ith N grains whose velocities are independently assigned accordingly to an initialdistribution $P(v ; 0)$.
2. W e choose one pair of grains $w$ th probability proportional to the $m$ odulus of their relative velocity and let them collide, using the collision rule',
3. Time is increm ented by tw ioe the inverse of the m odulus of the pre-collisionalrelative velocity. T he factor of 2 accounts for picked pairs that do not collide, since our algorithm forces a collision at each step.
4. W e iterate steps ${ }_{1}^{11}$, to $\frac{1}{13} \mathrm{~m}$ any tim es and for $m$ any sam ples.

In our sim ulations we took $N=100$ and averaged our results over 1000 sam ples. In $F$ ig. '1'1 we show the resulting velocity distribution for $=0$ 0:9 at di erent tim es. It is clear that the initial sym $m$ etric and single peaked distribution develops two distinct peaks as it starts to collapse to the ultim ate equilibrium distribution, a function at $v=0$. M oreover, in $F$ ig. we show that the width of the distribution and the w idth of each peak both decay as $1=t$. In the sim ulation underlying this $g-$ ure the in itialdistribution w as a double peaked G aussian, chosen because it converges quickly. W e nd the same asym ptotic behavior for the in itially exponential distribution, nam ely, that each peak $m$ oves inw ard as $1=\mathrm{t}$ and also shrinks as $1=t$. The validity of the scaling solution Eq. (13) is clearly evident in the scaled rendition of the velocity distribution show in F ig.

> B . T wo-particle m odel

W hile the Boltzm ann equation (1-G) does not appear am enable to analytic solution, we can form ulate a sim pler $m$ odel that $m$ ay inconporate the $m$ ain e ects of the

system. In this $m$ odel we have an ensem ble of rings of size 1 each containing only two particles. In each ring, the dynam ics is perfectly determ in istic: the tw o balls w ill keep colliding w th each other, back and forth, m oving tow ard each other w ith ever decreasing velocities. For each one ring, after n collisions, the velocities, which we call $u_{n}$ and $v_{n}$, are obtained by repeated application of the collision rule (G),

Since the grains are in a ring, the distance they have to travel between two collisions is 1 . The travel time is $l=j u$ vj where $u$ and $v$ are their current velocities betw een collisions. H ence,

The sign altemation of the velocities in Eq. ( $(1-\overline{2})$ is not im portant in the e ort to understand the long time behavior of the distribution. W e can approxim ate the
velocities by envelope functions A (t) (upper curve) and B (t) (low er curve), as illustrated in Fig. ${ }_{2}^{\prime 2}$

The initial velocities $u_{0}$ and $v_{0}$ are arbitrary, and have only been chosen of equalm agnitude for purposes of illustration in the gure. T he envelope functions can be found by solving Eq. (19) for ${ }^{n}$, substituting this into Eq. (18-1) ignoring the $m$ inus signs in the ()$^{\mathrm{n}}$ factors, and setting $t_{n} \quad t . O$ ne nds

H ence, if in itially the particles had a velocity distribution P $(v ; 0)$; then the velocity distribution as a function of time is

Therefore, $P(u ; t)$ consists of two -peaks, one at positive and one at negative velocities. If the initial distribution is sym m etric about zero velocity and is properly norm alized, then

$T$ he peaks thus $m$ ove tow ard the nal velocity $u=0$ as $1=\mathrm{t}$. T his t im e dependence is in agreem ent w ith the Boltzm ann equation analysis.

The two -peaks here re ect the fact that the $m$ agnitude of the velocity di erence betw een the colliding particles eventually becom es independent of the $m$ agnitude of the initial velocity di erence. C learly, in the Boltz$m$ ann equation analysis this is not quite the case and the peaks have a nitew idth as they converge. H ow ever, th is w idth decreases in tim e as 1=t, approaching the behavior of the two-particle ring $m$ odel asym ptotically.

## IV. MAXW ELLPROBLEM

In the Boltzm ann equation, the rate of collision of a pair of particles depends on their relative velocity. The \M axw ellproblem " further assum es that the pair of colliding grains is chosen random ly, all pairs colliding with the sam e probability at unit rate. The evolution equation (5) for the distribution of velocities is then replaced by the even sim pler form

This problem with a com pletely general linear collision rule (ofwhich Eq. (G) is a special case) w as analyzed in $\left[20_{1}^{\prime}\right]$. In the language used here, if we assum e a scaling form as in Eq. (1]), we arrive at an equation parallel to Eq. (5) but now w th the tim e-dependent factor
$-(t)=(t)$. A gain, we argue that this term must be a constant, and integration leads to an exponential decay of the width of the distribution instead of the pow er law found in the Boltzm ann case,

T he decay constant depends on the friction coe cient . In [201] we described in detail how to evaluate, and in Fig. in [201] we also analyzed the shape of the distribution. We found that (regardless of the initialdistribution provided that the initial average velocity is zero) F ( x ) has a single peak around $x=0$ instead of the double-peaked structure that we nd for the Boltzm ann problem and its tw o-ring sim pli cation, and that it has algebraic tails that decay as $F(x) \quad x \quad{ }^{1}$. The exponent is also a function of , as shown in F ig.

## V. NUMERICALSIMULATIONSAND CONCLUSIONS

The tw o approxim ations presented in the previous sections lead to very di erent results for the velocity relaxation behavior of a dam ped one-dim ensionalgranular

system. O ne (Boltzm ann problem) leads to a velocity distribution that is double-peaked, $w$ ith one at positive and one at negative velocities, the peaks $m$ oving inw ard as $1=$ t tow ard a zero nalvelocity. T hew idth ofthe peaks also decreases as $1=t$. T he second $m$ odel $(M$ axw ell problem ) leads to a distribution that is single-peaked, w th a width that decreases exponentially in tim e and distribution tails that decay algebraically. Neither of these approxim ations considers the possible e ects of the spatial distribution of granules.

In order to assess the validity of these approxim ations, and also to get a sense of the possiblee ects of the spatial distribution of granules, we have carried out num erical sim ulations of a fullchain ofparticles. O ur collision rules are still as indicated in Eq. ( $\overline{6})$, and, as before, we assum e collisions to be instantaneous, but now we actually place the granules on a line and keep track of their positions so that spatial inhom ogeneities can occur if the system is so inclined. Results for 10000 granules averaged over 100 sim ulations are show $n$ in $F$ ig. 16.1 . The particle density is $10^{3} \mathrm{w}$ th the particles in itially distributed uniform ly. $T$ he initialdistribution is taken to be a sym $m$ etric exponential, and $=0: 9$. A s tim e proceeds, the in itial single peak splits into two peaks which $m$ ove inw ard and becom e narrow er, as predicted in our Boltzm ann analysis. B oth the inw ard $m$ otion of the peaks and the $w$ idth of the peaks change as $1=\mathrm{t}$, as in the Boltzm ann approxim ation (see Fig. ${ }^{1} \overline{1}_{1}$ I) .

W e also tested the scaling hypothesis Eq. 1 sim ulations. In Fig. . 1 m ann approxim ation, the scaling w orks quite well. M oreover, in this case, the data can be tted by a double -distribution

$N$ ote that this distribution has only two ( -dependent) free param eters, $b_{1}$, which sets the scale, and $b_{2}$, which

sets the shape. In $F$ ig. . ${ }_{1}^{1}$, we plot this distribution for
$=0: 9$ ( $\mathrm{b}_{1}=0: 046$ and $\mathrm{b}_{2}=2: 637$ ) together w ith the sim ulation data obtained w ith a double $G$ aussian initial velocity distribution. W e have tested the double distribution $t$ for other values of,$w$ ith equal success.

Com paring the velocity distribution for the Boltzm ann
 line ( $F$ igs. ${ }_{1}^{-1}$ and ${ }_{2}^{\prime}$ ) we note that the Boltzm ann model converges to the scaling distribution $\mathrm{m} u \mathrm{ch} \mathrm{m}$ ore rapidly. In itially the sim ulation results exhibit the sam e behavior as the Boltzm ann $m$ odel, but for longer tim es the behav-

ior of the two distributions for sm all velocities begin to di er. In the Boltzm ann case, the probability of nding a slow granule is much greater than in the sim ulation.

W e conclude from these results that

1. The M axw ell problem is an inadequate representation of the velocity relaxation properties of the granular chain described in Eq. (4). T he predicted shape of the distribution does not agree $w$ th that of the physical chain.
2. The Boltzm ann problem in which we have disregarded spatial dependences captures $m$ any of the essential features of the velocity relaxation, the most im portant and new feature being the appearance of two peaks in the velocity distribution. The Boltzm ann problem and even the sim pler tw oparticle simpli cation of the problem also capture the time dependence of convergence of the two peaks into a single one at zero velocity. The slow ( $1=\mathrm{t}$ ) convergence is due to the fact that the collision rate in the Boltzm ann picture slow $s$ dow $n$ as the gas cools. By w ay of contrast, the collision rate in the $M$ axw ellproblem does not, leading to an exponential relaxation in tim e.
3. The Boltzm ann approxim ation does not correctly capture the late time distribution of the slowest particles. This is probably due to spatial correlations that have been ignored in this approxim_ation and that are currently under investigation [23'1].

O ne-dim ensional $m$ om entum-conserving granular gases $m$ ay exhibit \inelastic collapse," whereby the energy of the gas goes to zero in a nite tim e [1] or not this occurs depends on the num ber ofparticles $N$. $T$ here is a m onotonically increasing relation betw een $N$
and the coe cient of restitution $r$ for the critical value of $\mathrm{N}_{\mathrm{C}}(\mathrm{r})$ above which collapse occurs, with $\mathrm{N}_{\mathrm{c}}$ ! 1 as $r$ ! 1. The \quasi-elastic lim $\mathbb{t}^{\prime \prime}$ is the $\lim$ it $r$ ! 1 and N ! 1 , but in such a way as to always rem ain below the collapse threshold. In this lim it, a double-peaked
 presence of friction there is no inelastic collapse, and we always observe a double-peaked distribution. A com parison betw een those results and ours requires an understanding of spatial correlations. This analysis w ill be presented elsew here [2]].

Finally, we point out again that even in our most com plete sim ulations we have approxim ated the collision events as instantaneous. W hile we do not believe this
to be a perceptible source of error, it would be interesting (but extrem ely tim e consum ing) to carry our fill sim ulations of the m odelE q. ( (4, ${ }^{1}$ ) w th no further approxin ations.
