## Resonant photon absorption in the low spin molecule V $_{15}$

A bstract. { Resonant photon absorption in the GHz range was observed via low temperature micro-SQUID magnetization measurements of the spin ground state S=1=2 of the molecular complex  $V_{15}$ . A simple single-molecule interpretation is proposed. The line-width essentially results from intra-molecular hyper ne interaction. The results point out that observing Rabi oscillations in molecular nanomagnets requires well isolated low spin systems and high radiation power.

It is widely adm itted that single-molecule magnets (SM M s) have a great potential for quantum computation [1], in particular because they are extremely small and almost identical, allowing to obtain, in a single measurement, statistical averages of a larger number of qubits. Each spin being carried by a big molecule of  $1 \text{ nm}^3$ , these magnets are naturally diluted (with  $10^{19} \quad 10^{20} \text{ molecules/cm}^3$ ), which is highly desirable to minimize dipolar interactions and thus preserve quantum coherence. Despite such natural dilutions, dipolar interactions remain rather important (0.1 0.5 K) in large spin SM M s such as M  $n_{12}$  or Fe $_8$  (S = 10) [2] displaying resonant quantum tunneling of magnetization [3, 4, 5, 6, 7, 8]. Reductions of dipolar interactions can easily be achieved by decreasing the value of the spin S. At a given concentration, the dipolar energy scales with the square of S. Thus, decreasing the spin from S = 10 to 1=2 leads to a reduction of dipolar energy by a factor of (1=20) $^2$  10  $^3$  [9]. At rst glance, low spin systems seem more suitable for quantum computation than large spin systems.

In this paper we report the rst study of the micro-SQUID response of a low-spin molecular system,  $V_{15}$ , to electrom agnetic radiation. The advantages of our micro-SQUID technique in respect to pulsed electron paramagnetic resonance (EPR) techniques consist in the possibility to perform time-resolved experiments (below 1 ns) [10] on submicrometer sizes samples (about 1000 spins) [11] at low temperature (below 100 mK). Our rst results on  $V_{15}$  open the way for time-resolved observations of quantum superposition of spin-up and spin-down states in




Fig. 1. { Equilibrium  $\,$ m agnetization curves  $\,$ m easured  $\,$ w ith or  $\,$ w ithout irradiation. The cryostat temperature  $\,$ w as 40  $\,$ m K . The electrom agnetic radiation  $\,$ w as pulsed  $\,$ w ith a period of 10  $\,$ m s and a pulse length going from 0 (no radiation) to 3  $\,$ m s.

SM M s. O ther results obtained in sim ilar system sbut with large spins concern for exam ple EPR m easurem ents [12], resonant photon-assisted tunneling in a Fe $_8$  SM M [13] and non-resonant m icrow ave absorption in a M  $_{12}$  SM M [14].

The molecular complex  $V_{15}$  forms a lattice with space group  $R_{3c}$  containing two molecules per unit cell [15, 16]. The third order symmetry axis of the unit cell is also the symmetry axis of the two  $V_{15}$  clusters. In each molecule the freen  $V^{\rm IV}$  ions (S = 1=2), are placed on a quasi-spherical layered structure formed of a triangle sandwiched between two non-planar hexagons. Each hexagon contains three pairs of strongly coupled spins and each spin at a comer of the inner triangle is coupled to two of those pairs (one belonging to the upper hexagon and one belonging to the lower hexagon) [16]. In principle, this molecule should be discussed in terms of the entanglement of the 15 spins 1=2, with a Hilbert space dimension of  $2^{15}$ . However, considerable  $\sin pli$  cations occur at low temperature where the molecule can be described by a S = 1=2 spin ground state and a S = 3=2 excited state. The energy separation of both spin states of 3:8K was accurately determined by susceptibility and higheld m agnetization m easurem ents [17] and by inelastic neutron scattering experim ents [18]. M agnetization m easurem ents perform ed down to  $30 \, \text{m}$  K showed that the  $S = 1=2 \, \text{spin}$  ground state is split in zero eld by 80 m K [9, 19]. The origin of this splitting for a half-integer spin is interpreted by the interplay between intra-molecular, hyper ne and Dzyaloshinskii-Moriya interactions [9, 19]. Inter-molecular interactions (dipolar or/and residual exchange interactions) can be evaluated from the low temperature Curie-Weiss law associated with the spin ground state, giving the Curie constant C = 0.686 BK/T and the paramagnetic tem perature  $_{\rm p}$  12 mK, corresponding to a mean internal eld of 12 mT. This value, one order of magnitude larger than calculated dipolar interactions is nevertheless much smaller than usual super-exchange interactions; it is attributed to non-trivial exchange paths.

The measurements were made at a cryostat temperature of 40 mK using a 50 m sized single crystal of  $V_{15}$ . The magnetic probe was a micro-SQUID array [20] equipped with three coils allowing to apply a eld in any direction and with sweep rates up to 10 T/s.




Fig. 2. { Equilibrium magnetization curves similar to Fig. 1 but at several frequencies (pulse length 1 m s). Inset: calculated energy levels for a spin 1/2 w ith and g=2.02.

The electrom agnetic radiation was generated by a frequency synthesizer (Anritsu M G 3694A) triggered with a nanosecond pulse generator. This setup allows to vary continuously the frequency from 0.1 Hz to 20 GHz, with pulse lengths from 1 ns to 1 s [21]. The ac radiation eld B  $_{\rm ac}$  was directed in a plane perpendicular to the applied static eld B  $_{\rm 0}$ .

M agnetization versus applied eld curves M (B  $_0$ ) were measured in the quasi-static regime with a eld sweep rate slow enough (1 m T/s) to keep the system at equilibrium. The phonon-bottleneck regime has a characteristic spin-phonon relaxation time to the cryostat  $_{\rm S}$  of few seconds [9]. A c radiation pulses of 0.1 to 0.3 m s were applied every 10 m s. Due to the large value of  $_{\rm S}$  the relaxation in the intervals between pulses is negligible. A s a consequence the e ects of each pulse are additive leading to an equilibrium magnetization after a time being larger than  $_{\rm S}$ .




Fig. 3. { Spin temperature  $T_s$  obtained by inversion of expression (1) where M ( $T_s$ ) is given by the magnetization curves of Fig. 1. The resonant absorption near 0.491 T is superimposed to a non-resonant background absorption corresponding to a nearly constant spin-temperature.

M (B<sub>0</sub>) curves for several pulse lengths, measured at = 14 GHz, are reported in Fig. 1. Two symmetrical dips are clearly visible at B = 0.491 T. They result from resonant absorptions of photons associated with m  $_{\rm S}=1$ =2 to 1=2 spin transitions, as indicated in the inset of Fig. 2. Typical measurements at other frequencies are presented in Fig. 2. A part of the resonant absorptions, a small absorption is also seen at all applied elds. In order to understand better the origin of this absorption, Fig. 3 presents the same data as in Fig. 1 but the magnetization M is converted into a spin temperature  $T_{\rm S}$  using the equation [22]:

$$M (T_s) = M_s = \tanh (q_B SB_0 = k_B T_s)$$




Fig. 4. { Measured linear variation of the resonance frequency, corresponding to absorption maxima, with applied magnetic eld. The slope gives g = 2.02. Inset: similar variation obtained for the quality factor G = B = L representing a lower bound of the coherence time of molecule spin precession.

with S = 1=2 and g = 2.02 (see below). Fig. 3 shows clearly the increase of the spin tem perature  $T_s$  because of resonant absorptions and a nearly eld independent increase of  $T_s$ . Before going into a deeper discussion, we show in Fig. 4 the experimental conem ation of the linear evolution of the resonant eld with frequency = B predicted by the inset of Fig. 2. The measured slope d =dB =  $28.3 \, \text{GHz/T}$  yields a gyrom agnetic ratio g =  $2 \, \text{h} = \frac{1}{2} \, \text{m} = \frac{1}{$ 

In order to analyze the resonance lines we will consider the well known Rabim odel for a

spin 1=2, which stipulates that the probability P of nding the system in the state  $m_s = 1=2$  at time t, if it was in the state  $m_s = 1=2$  at t = 0, is given by [24, 22, 25]:

where  $!_{Rabi} = 1=2^p \frac{p}{(B)^2 + (B_{ac})^2}$ , B is total eld seen by the spin, and  $B_{ac}$  the




Fig. 5. { Examples of eld dependence of  $_{\rm L}$  s obtained from the measured magnetization curves and Eq. 4, at 6 and 14 GHz, after subtraction of the non-resonant absorption background (nearly eld independent). The dots represent the tof these curves using Eqs. 3 and 5 (G aussian distributions) yielding  $_{\rm L}$  33 - 38 mT.

am plitude of the electrom agnetic eld. In the lim it of long times, Eq.2 becomes proportional to the time, P =  $(B_{ac}=2)^2t$  (B), and the transition rate =  $dP=dt=(B_{ac}=2)^2$  (B) turns out to be a constant. Integrating over a distribution of local elds F (B<sub>L</sub>) and considering that B = B<sub>0</sub> + B<sub>L</sub>, where B<sub>0</sub> is the applied eld, we obtain the eld-dependent spin-photon transition rate:

$$_{L} = \frac{1}{4} B_{ac}^{2} F (B_{L} = B B_{0})$$

This expression shows that the eld-dependence of the transition rate is given by the distribution function of local elds. Below, we analyze the results in terms of two limiting distributions, a Gaussian distribution and a Lorentzian one.

The m easured magnetization dips corresponding to resonant power absorption (Figs. 1-3), result from the balance between the induced transition rate =  $_{\rm L}$  +  $_{\rm 0}$  and  $_{\rm s}$ .  $_{\rm 0}$  is taking into account smallheating electrofthe environment.  $_{\rm s}$  can be determined using the measured equilibrium magnetization with and without irradiation, M  $_{\rm RF}$  (B  $_{\rm 0}$ ) and M  $_{\rm 0}$  (B  $_{\rm 0}$ ) respectively, and is given by [22]:

$$_{s} = \frac{1}{2} \frac{M_{RF} (B_{0})}{M_{0} (B_{0})} 1$$

Fig. 5 shows  $_{\rm L}$   $_{\rm S}$  obtained from the data in Figs. 1 and 2. Taking the example of the resonance at = 14 GHz, B  $_{\rm 0}$  = 0.491 T, we yield  $_{\rm L}$   $_{\rm S}$  0.2 (Fig. 5). As mentioned above  $_{\rm S}$  1 s is rather large due to the phonon bottleneck e ect. This allows to obtain su ciently large values of  $_{\rm L}$   $_{\rm S}$  to observe signi cant radiation absorption even if the rate  $_{\rm L}$  0.2 s  $^{\rm 1}$  is relatively sm all. U sing expression (3)we yield B  $_{\rm ac}$  1 T. Sim ilar values were obtained for all measured frequencies.

The resonant absorption lines of Fig. 5 were well twith a Gaussian distribution:

$$F (B_L) = \frac{1}{\sum_{L=0}^{p} \frac{B_0 - B_0^2}{2}}$$

yielding T 35 m T for frequencies between 2 and 20 G Hz.

The Gaussian and Lorentzian distributions essentially dierwhen  $\beta_0$  B j>  $_{\rm L}$ , that is the Gaussian distribution is more localized (non correlated elds) than the Lorentzian one (correlated elds). Our result suggests therefore that the line-broadening is due to uctuations of non-correlated intra-molecular nuclear spins and not to correlated inter-molecular interactions.

This is con m ed by several features:

- (i)  $_{\rm L}$  35 m T (Fig. 5) is much larger than the mean dipolar eld seen by the molecules (< 1 m T);
  - (ii)  $_{\rm L}$  is also larger than interm olecular interactions (12 m T);
- (iii)  $_{\rm L}$  is close to the hyper ne coupling in V  $_{15}$  (  $40\,{\rm m\,T}$ ) [9,17,19]. This value is derived from the hyper ne eld of 11.2 T/ $_{\rm B}$  obtained in di erent systems of V  $^{\rm IV}$  [26] and giving a eld of about 20 m T for a single V  $^{\rm IV}$  spin;
- (iv) nally,  $_{\rm L}$  is very close to the levelwidth (40 mK) obtained from magnetic relaxation experiments near the m  $_{\rm S}$  = 1=2 avoided level crossing. Its origin was mainly attributed to hyper ne and weak D zyaloshinskii-M oriya interactions [9, 17, 19].

This hyper ne broadening of resonant absorption is consistent with theoretical investigations according which the main dephasing mechanism of magnetic molecules is connected with nuclear spins [27, 28, 29, 30, 31, 32].

The inset of Fig. 4 presents the eld dependence of the quality factor  $G=B={}_{L}$  that gives a lower bound of the precessional coherence of  $V_{15}$  m olecule spins. A linear increase of G is observed reaching G=20 at 0.7 T that is rather far from values of  $10^4$  needed for quantum computation.

Finally, we discuss the possibility of observing Rabi oscillations with the present set-up. Due to inhom ogeneous broadening only a low bound of the coherence time can be estimated from the resonance lines:  $_{\rm c}^{-1}=_{\rm L}$ . The corresponding number of coherent ips of the spin system is given by N =  $_{\rm c}=_{\rm Rabi}=$  B  $_{\rm ac}=(2_{\rm L})$  (Rabi coherence). Using the values of B  $_{\rm ac}$  and  $_{\rm L}$  obtained from the tof the resonance lines, we get  $_{\rm c}$  2 ns (comparable to recent EPR measurements [33]) and N = 10  $^{6}$ , showing that there is no hope to see Rabi oscillations in the present conditions. In order to get N >> 1, it will be necessary to increase the radiation eld B  $_{\rm ac}$  by orders of magnitude. Note that  $_{\rm L,Max}$  = B  $_{\rm ac}^2=4_{\rm L}$  increases with electromagnetic power and decreases for broader distribution of local elds. An important consequence of intra-molecular inhomogeneous broadening is the possibility to signicantly longer coherence times that can be evidenced using spin-echo techniques. This should lead to a transverse relaxation time  $_{\rm 2}$  >>  $_{\rm c}$  which will be necessary for quantum computation.

In conclusion, we presented a new technique for studying radiation absorption in the molecular system  $V_{15}$  constituting a rst step towards the observation of Rabi oscillations in molecular magnets. The main results are the observation of relatively narrow resonant absorption lines that are dominated by hyper ne interaction. In order to observe Rabi oscillations in a magnetic system, an important requirement is a large ac eld amplitude.
